(57) **CLAIM**

The ornamental design for a takeout box, as shown and described.

DESCRIPTION

FIG. 1 is a first perspective view of a takeout box with a lid of the takeout box open.

FIG. 2 is the first perspective view of the takeout box with the lid of the takeout box partially closed.

FIG. 3 is the first perspective view of the takeout box with the lid of the takeout box fully closed.

FIG. 4 is a front view of the takeout box with the lid of the takeout box open.

FIG. 5 is a back view of the takeout box with the lid of the takeout box open.

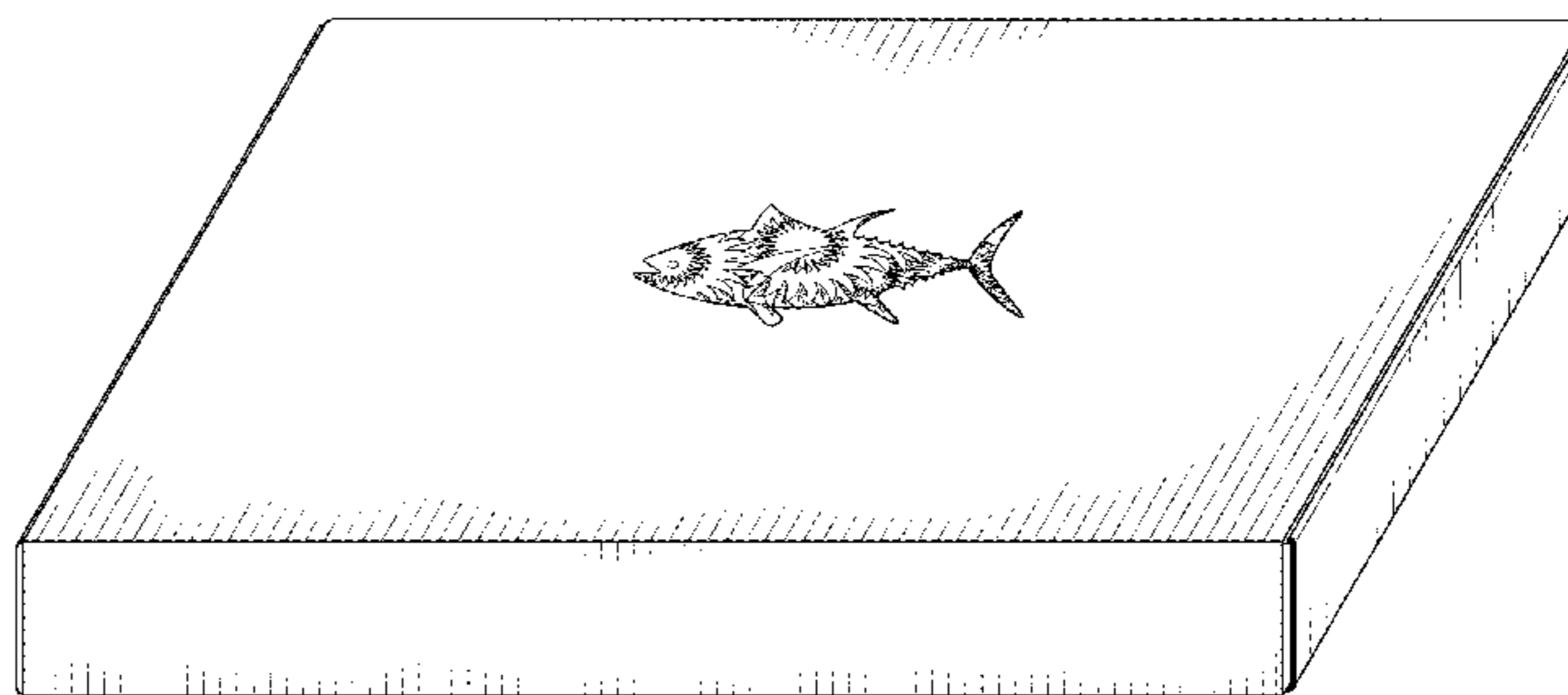
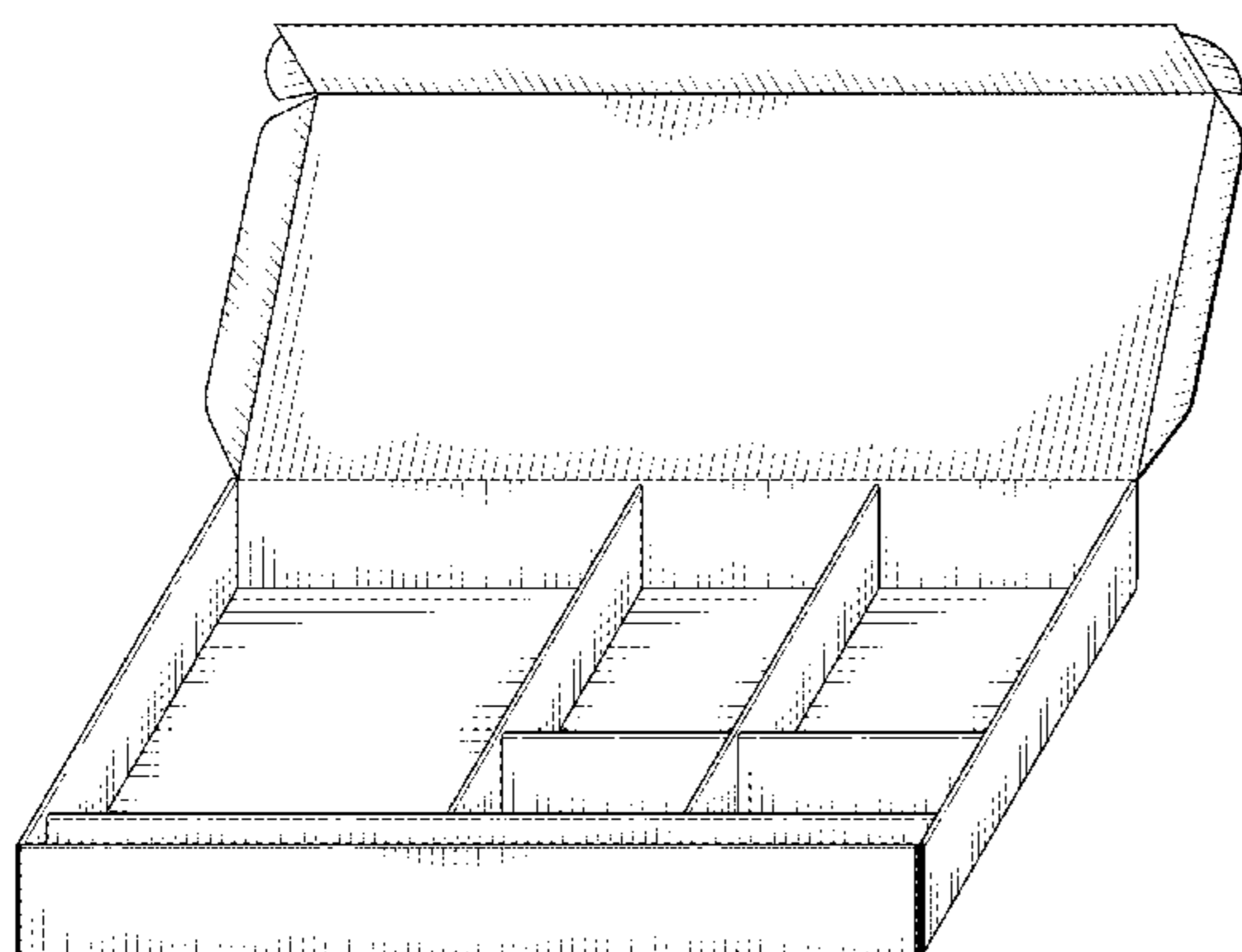
FIG. 6 is a left side view of the takeout box with the lid of the takeout box open.

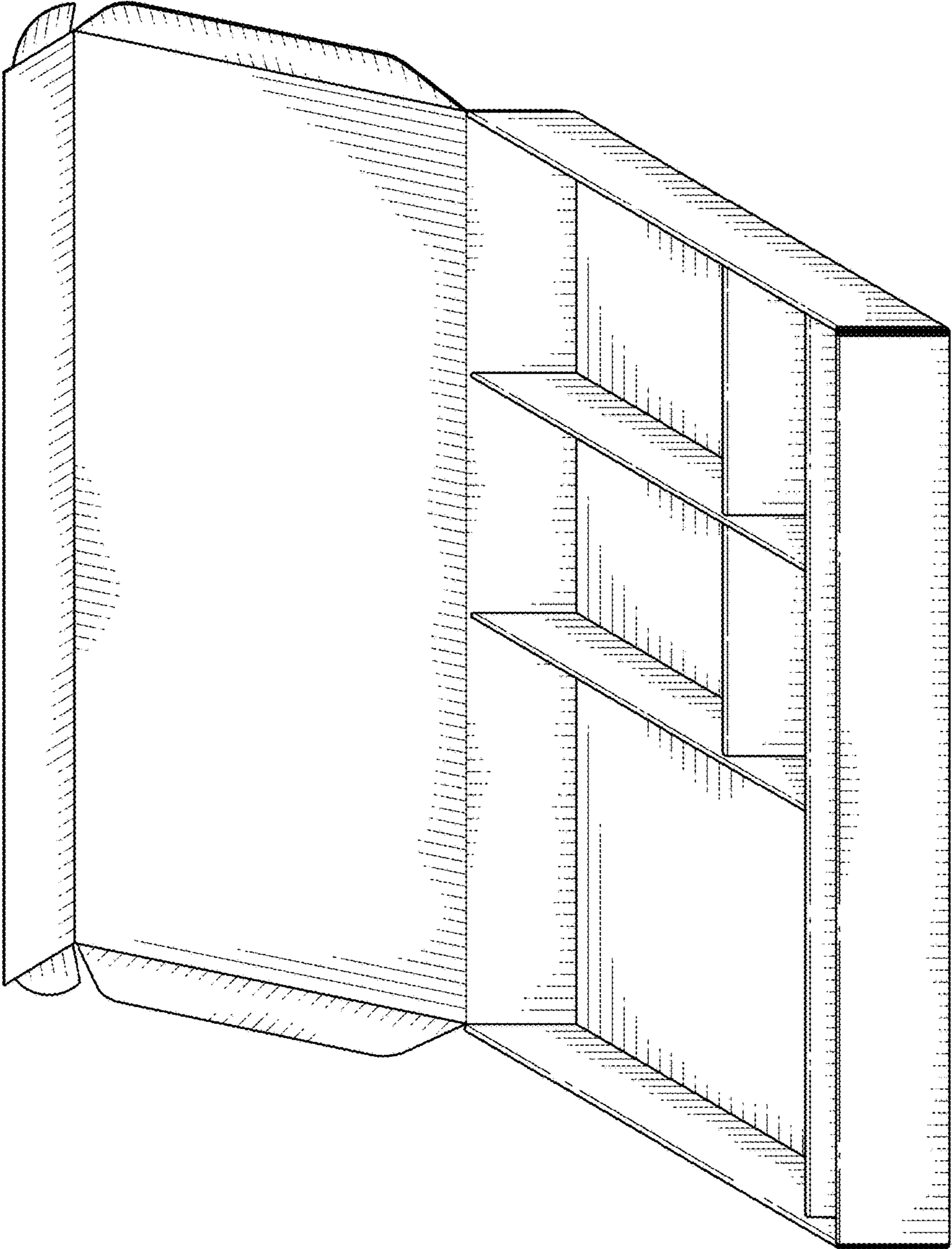

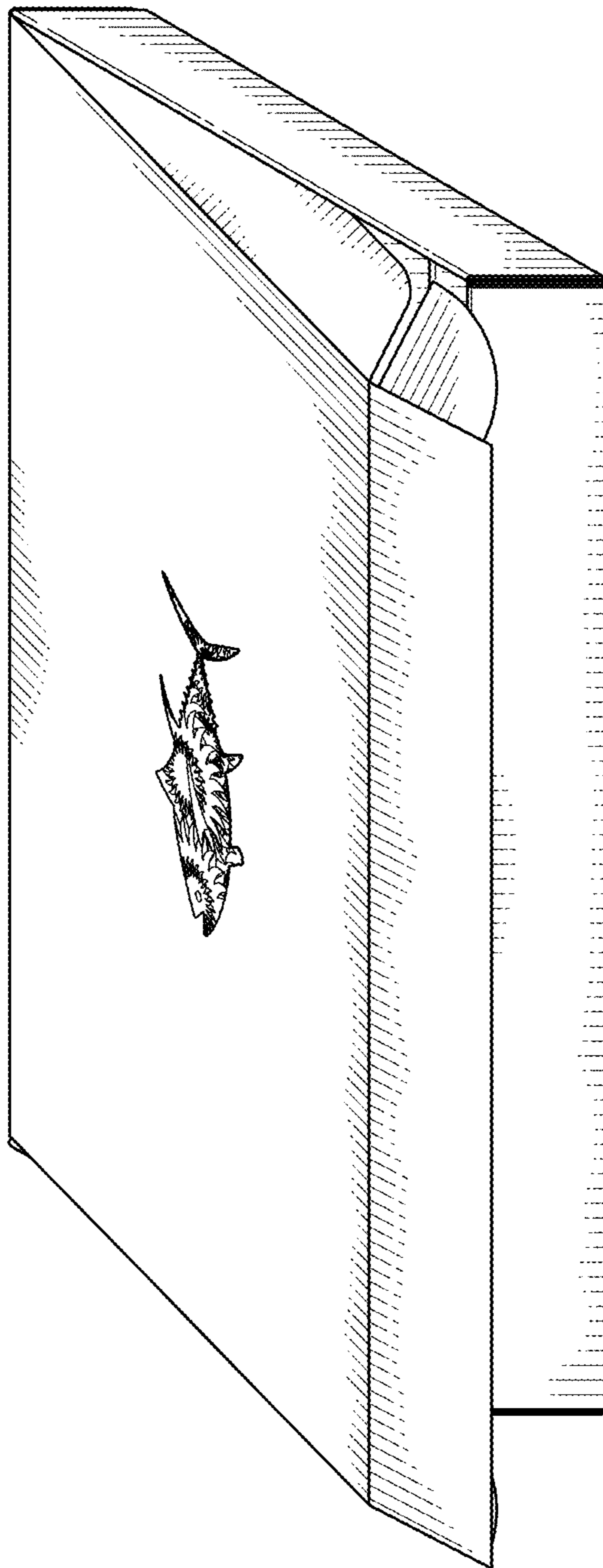

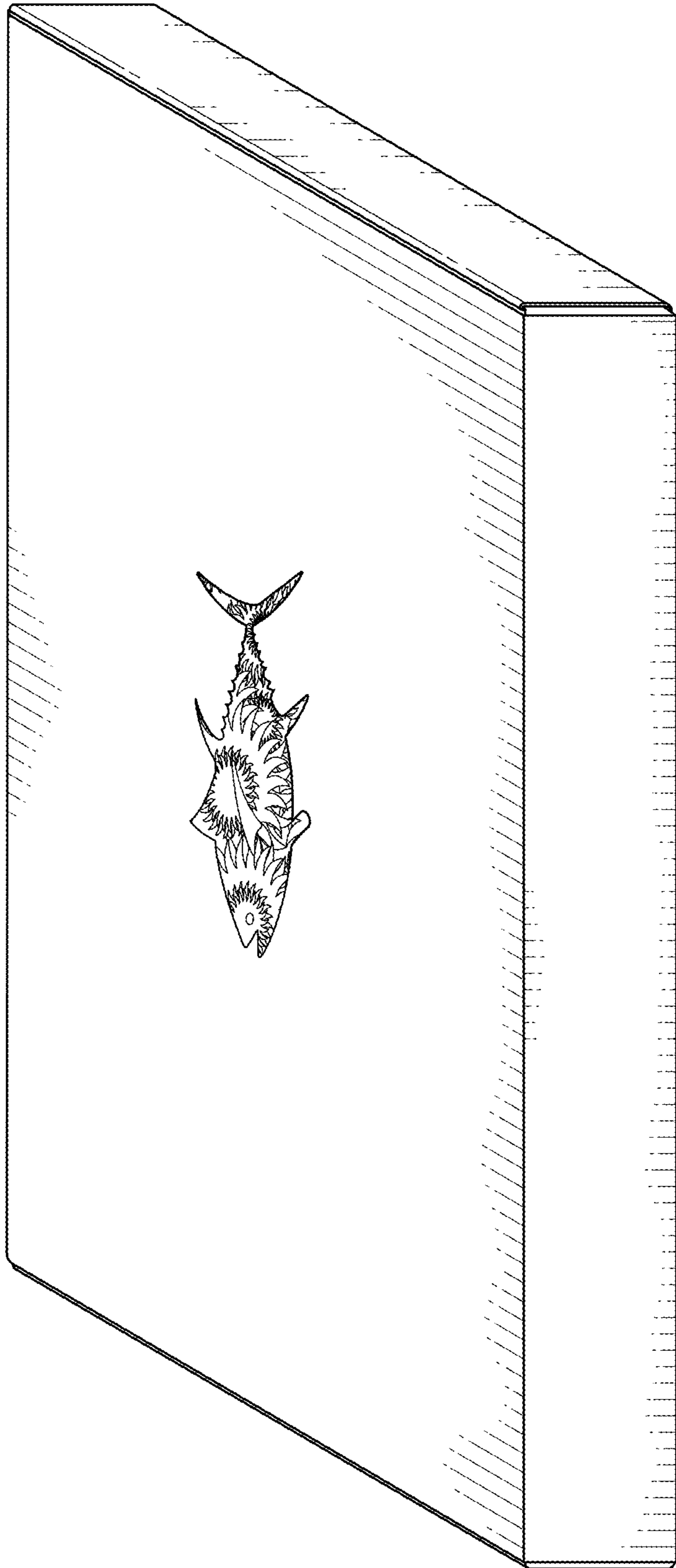

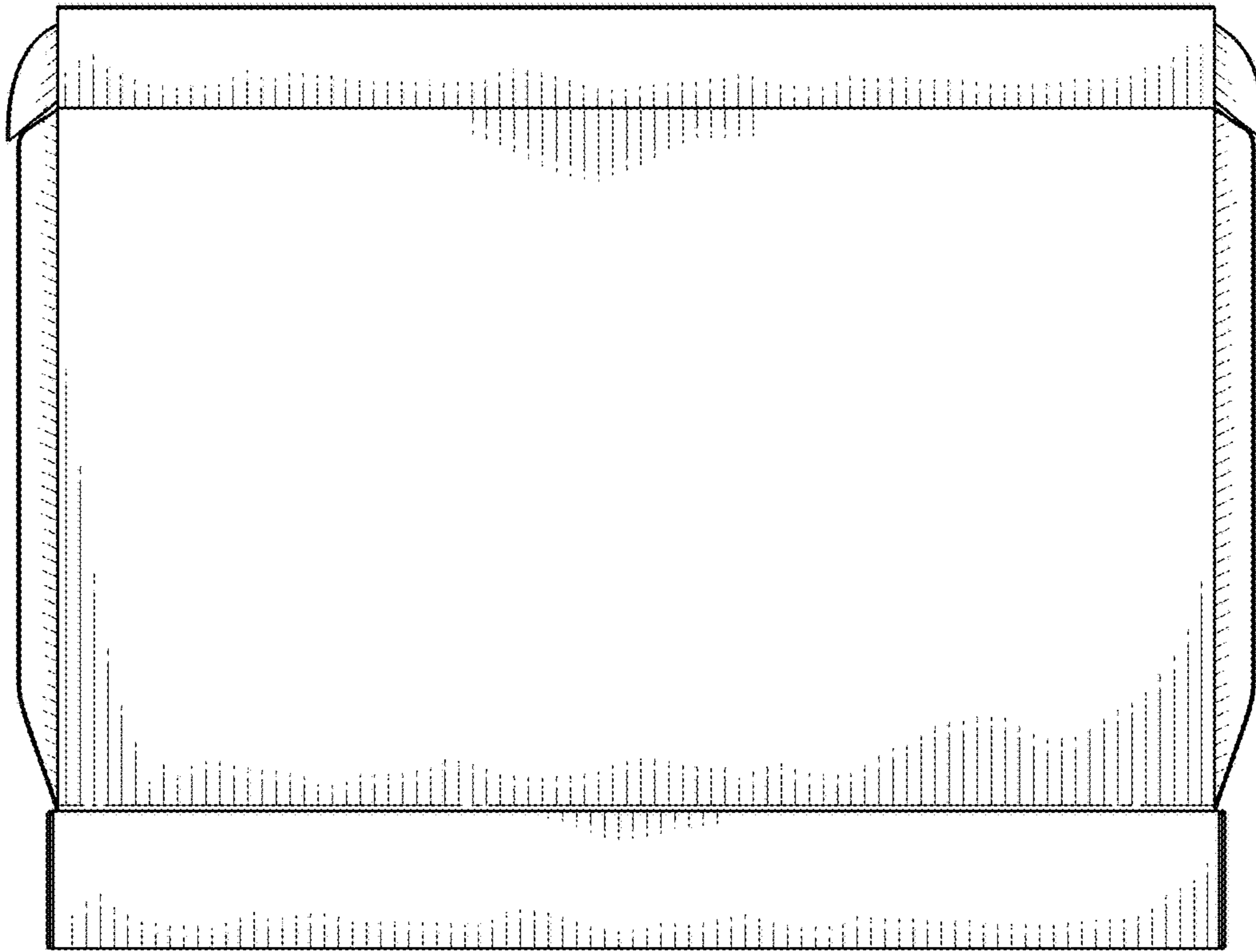

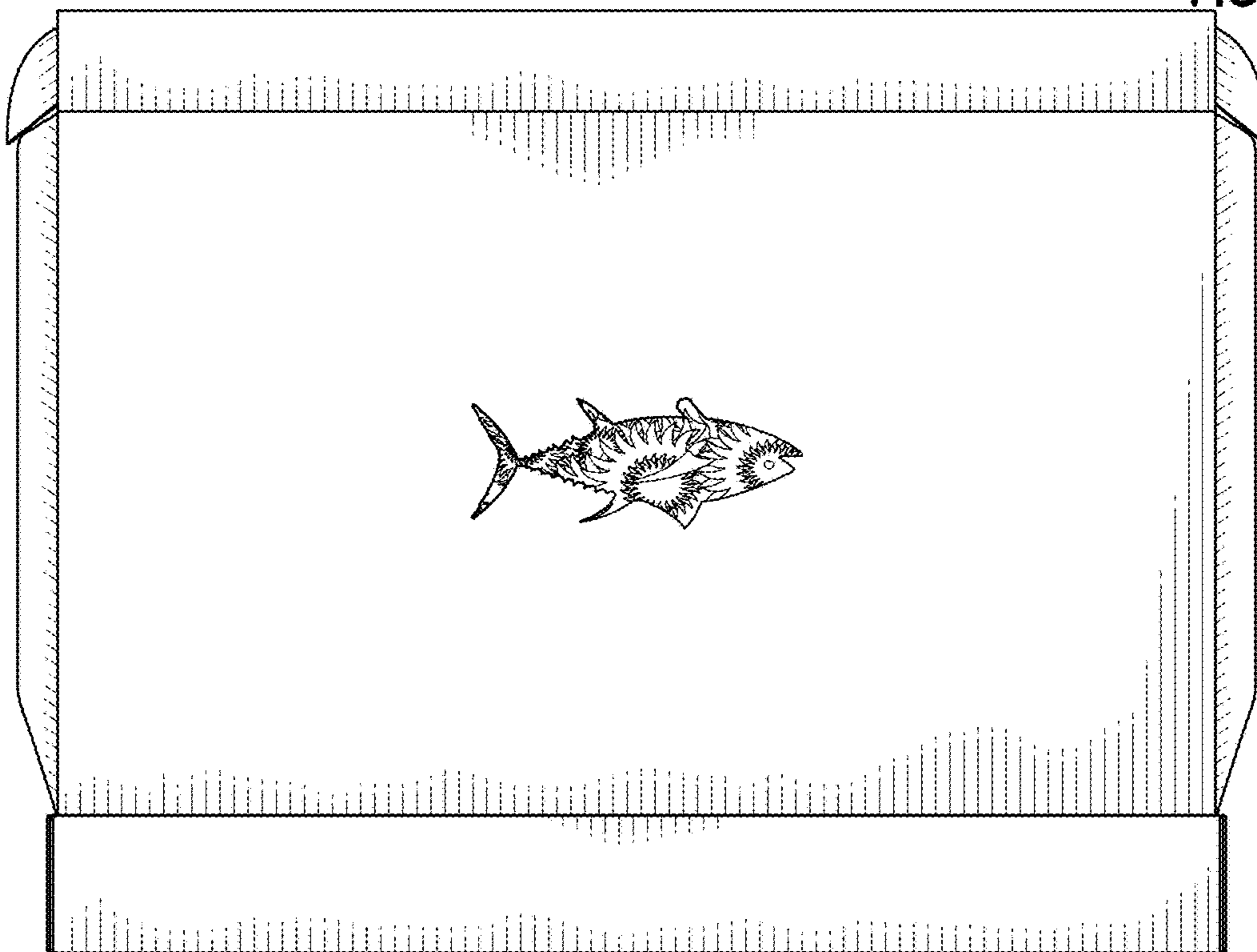

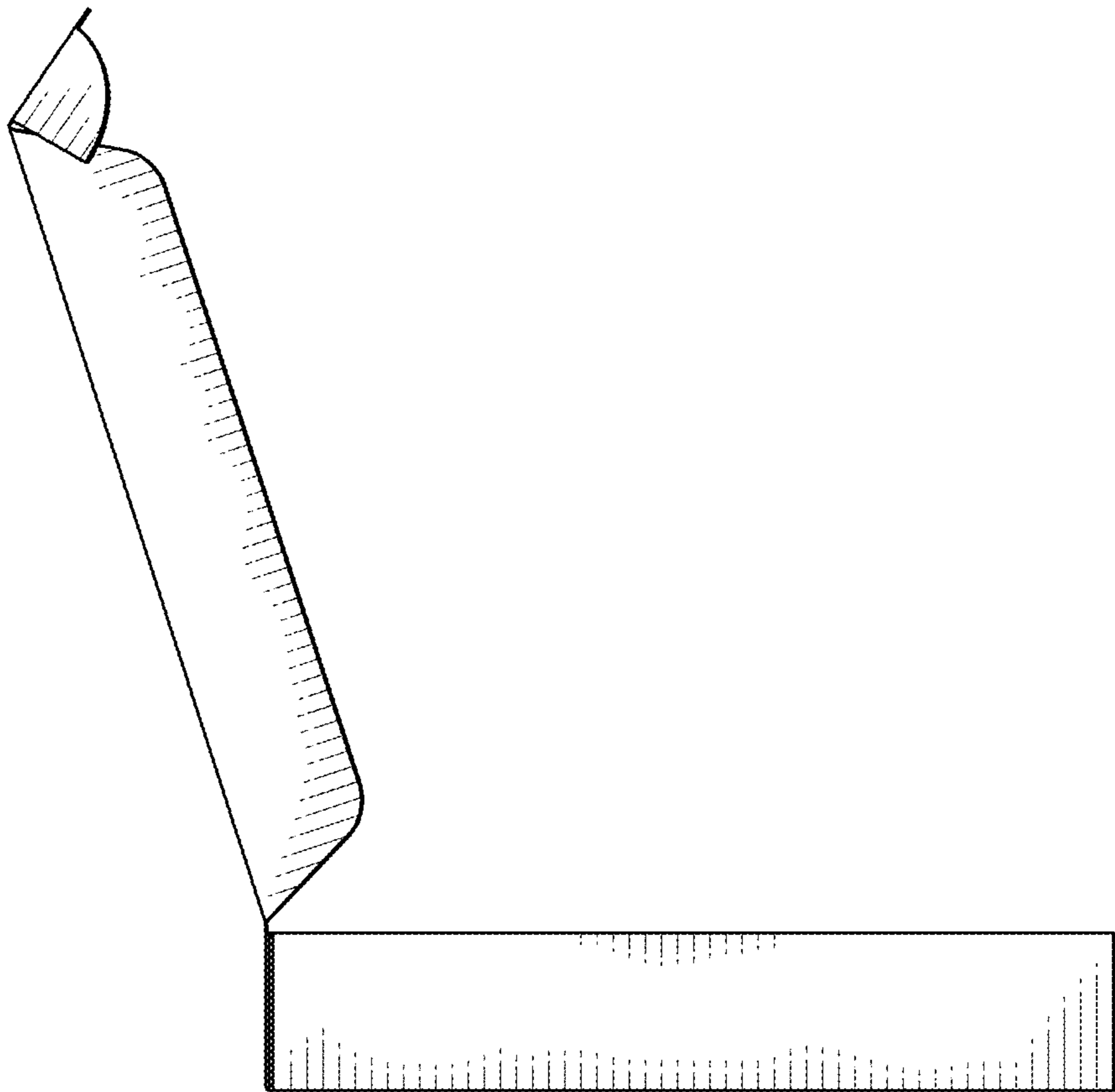

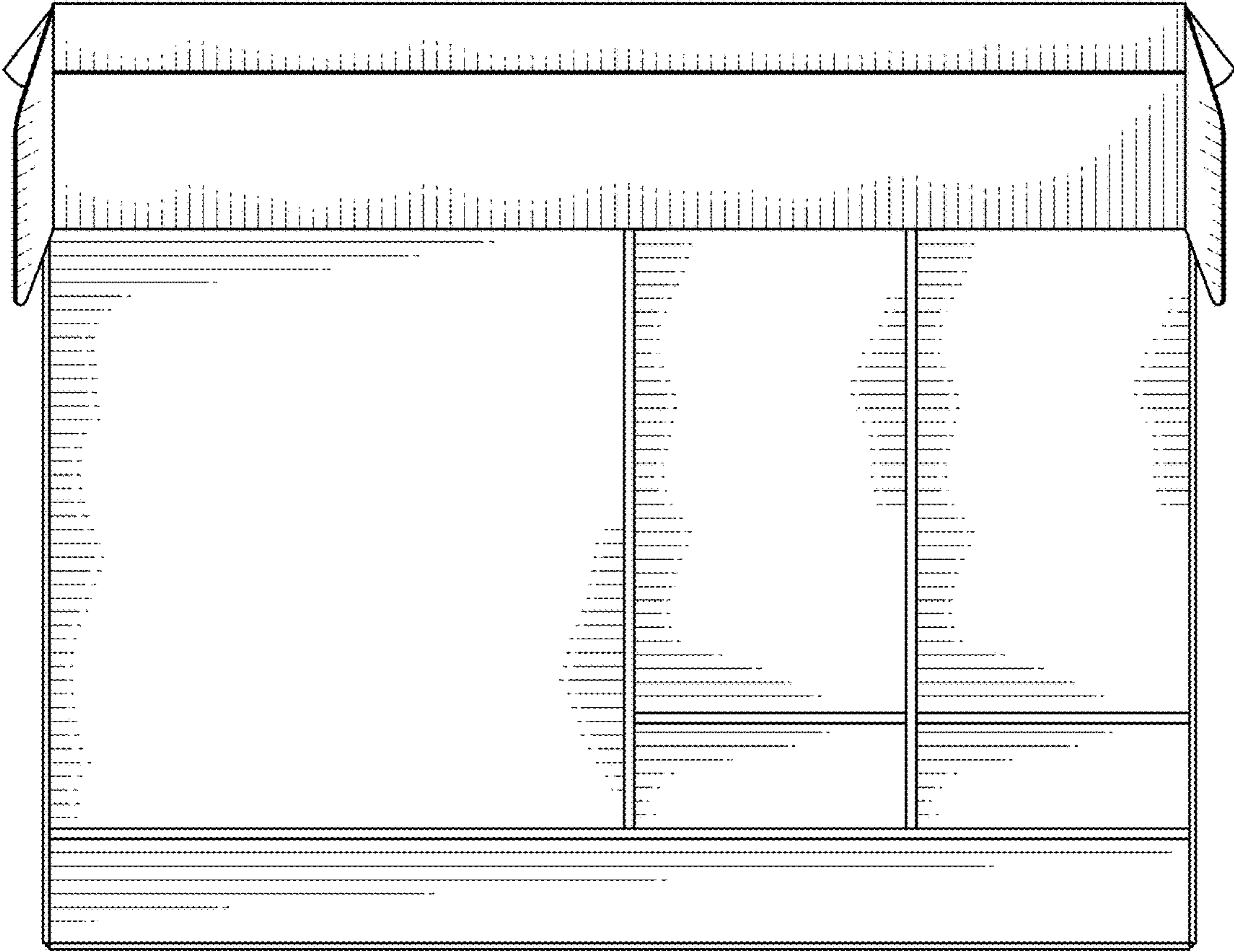

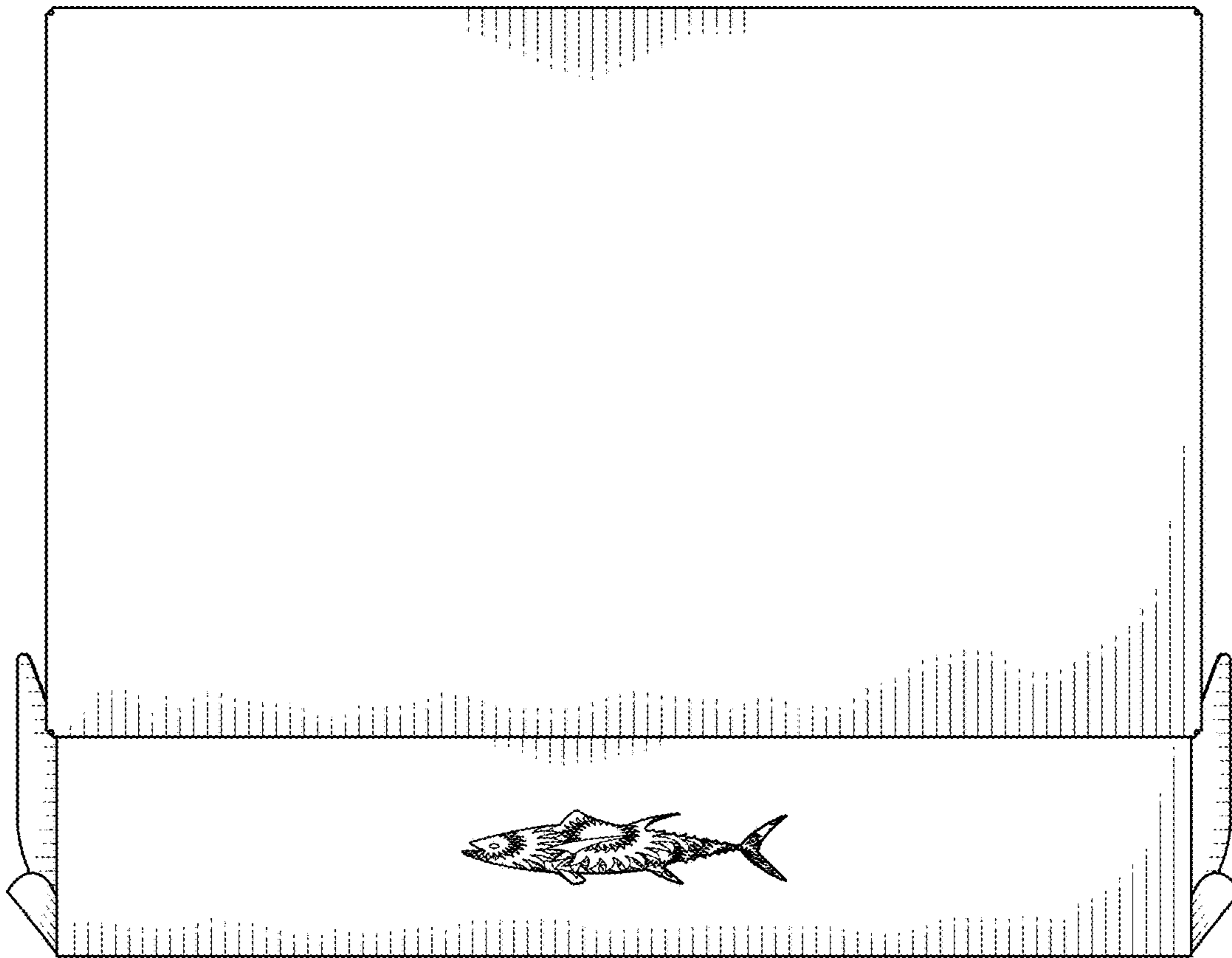
