FIG. 3 is a front view of a front door trim for an automobile. FIG. 4 is a top plan view of a front door trim for an automobile.

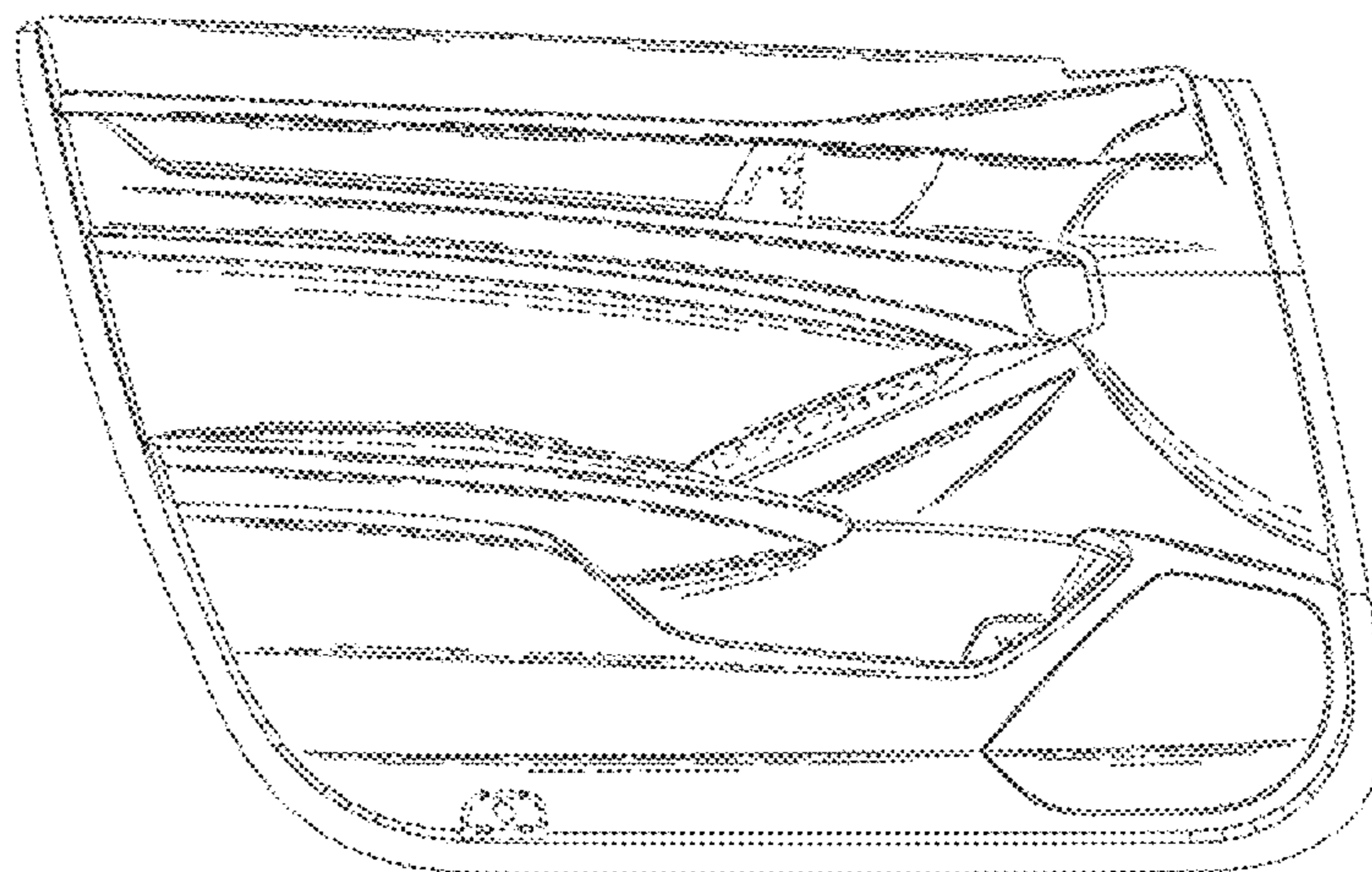
FIG. 5 is a left side view of a front door trim for an automobile.

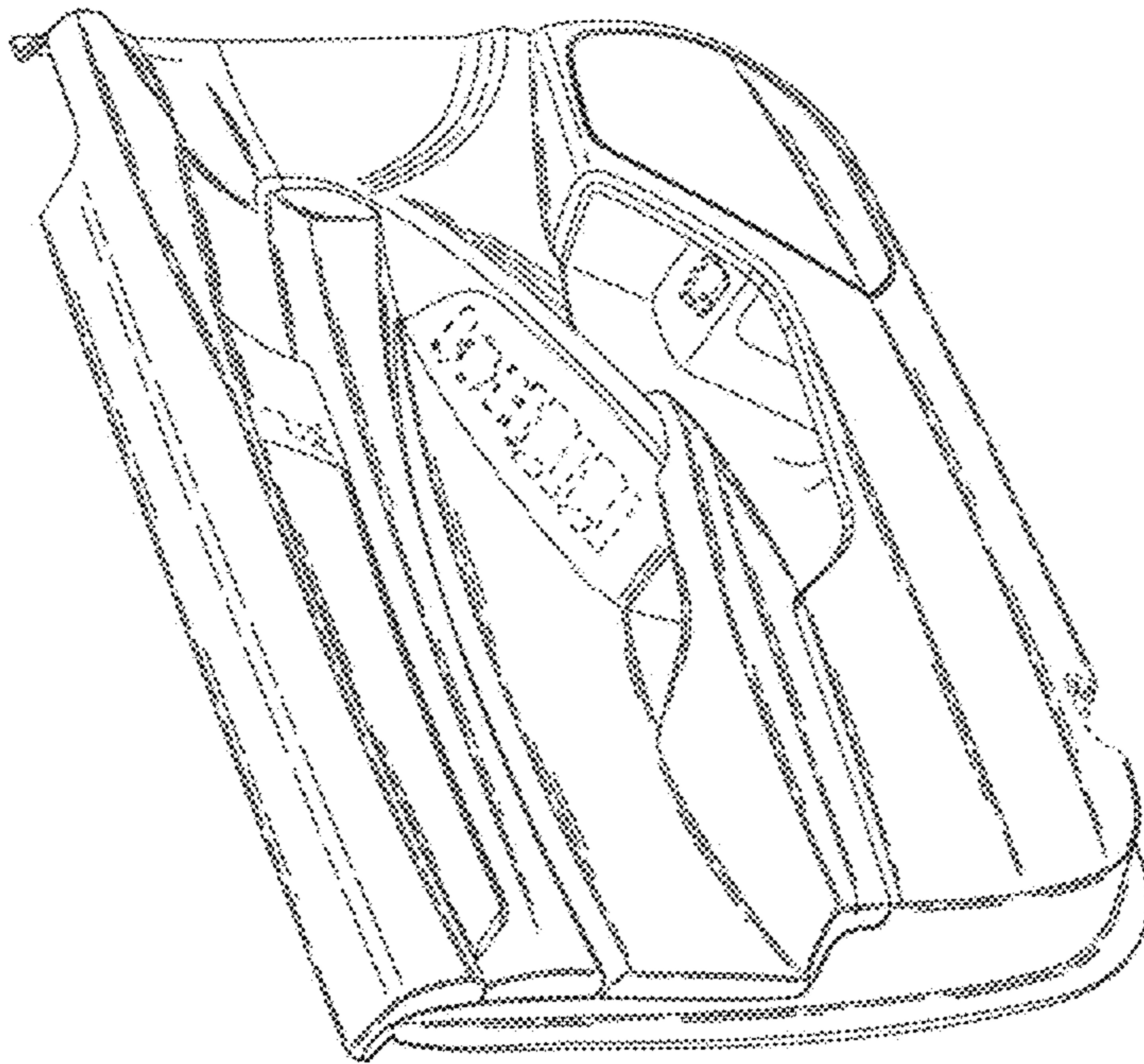

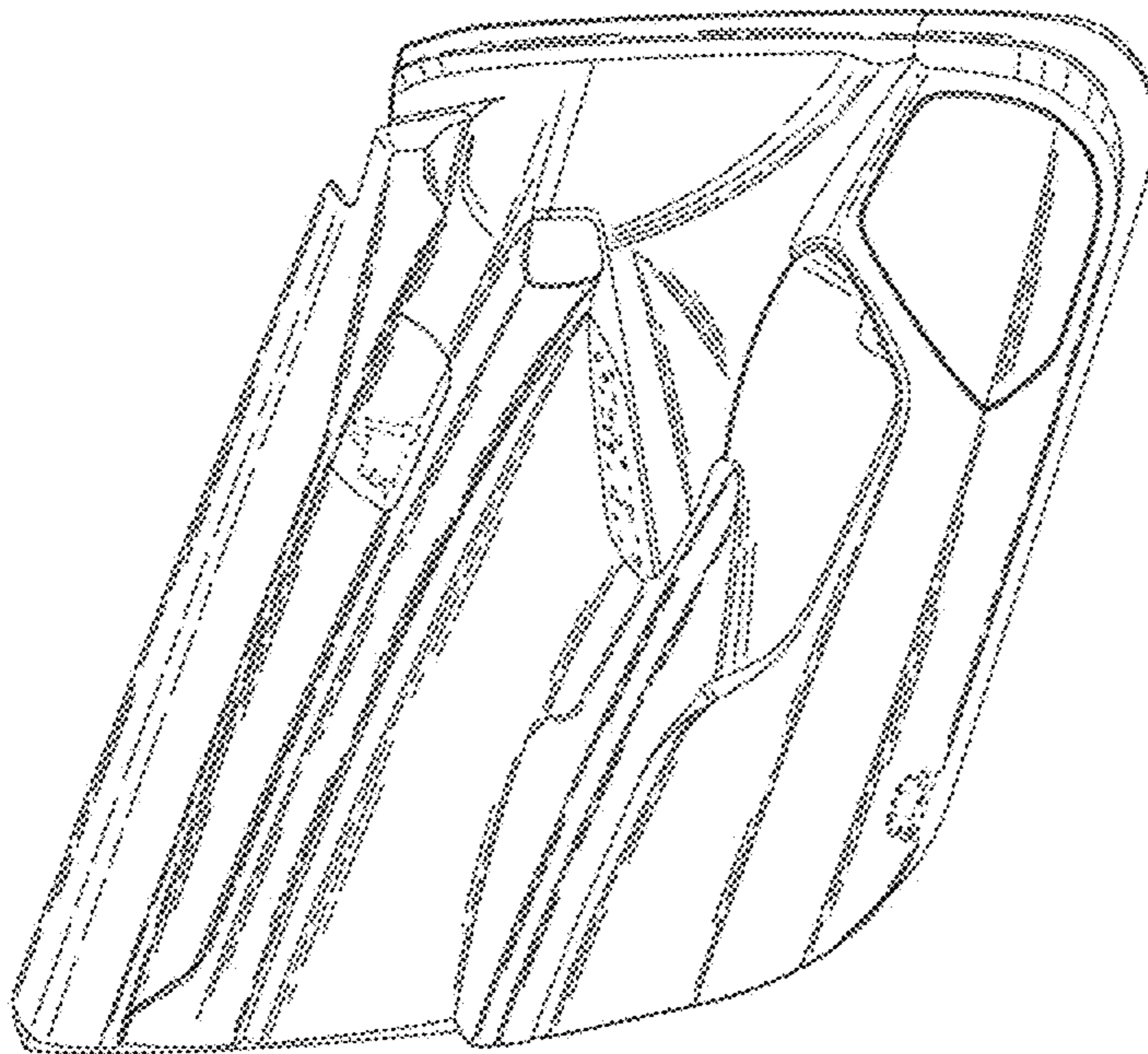

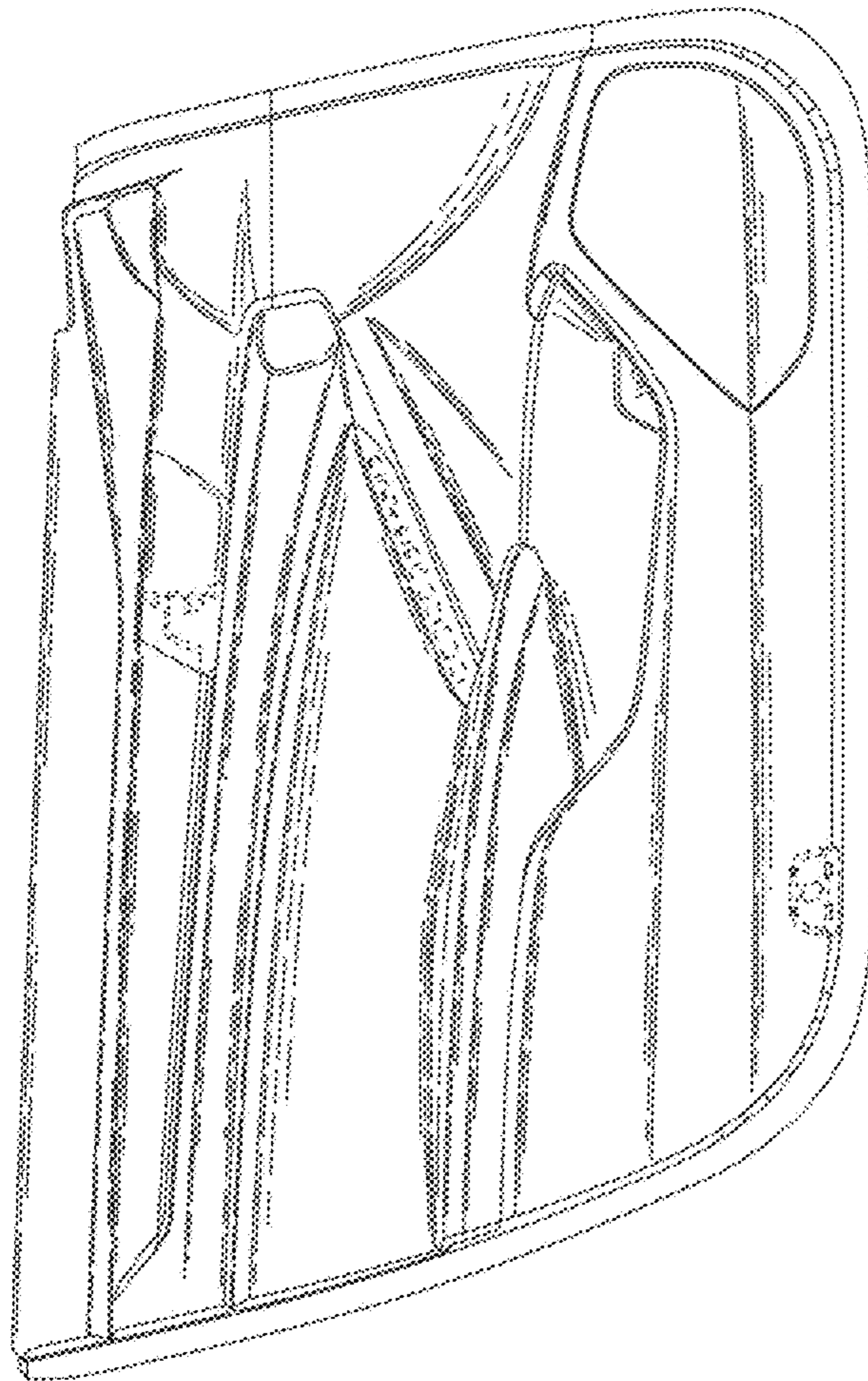

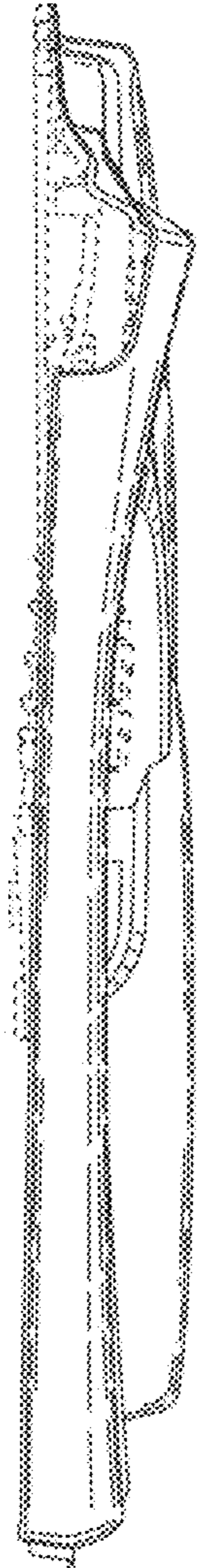

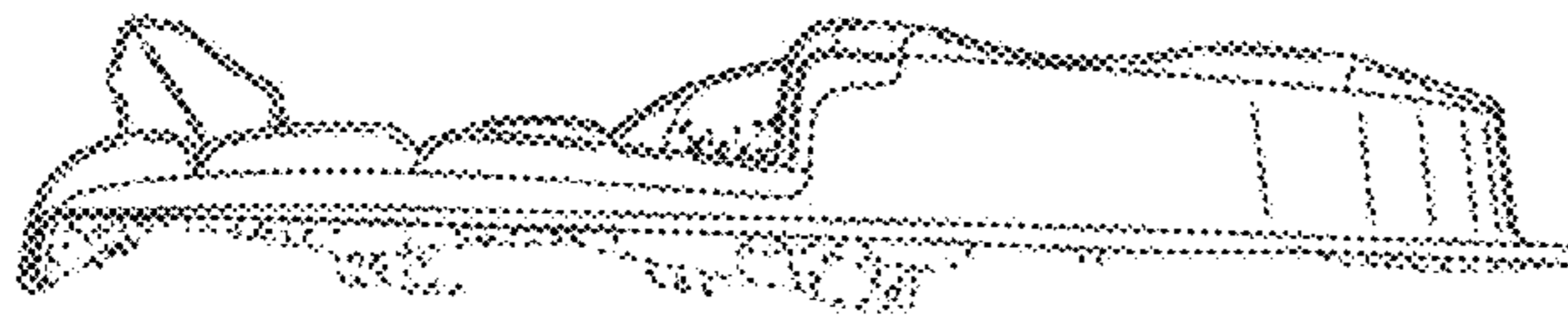

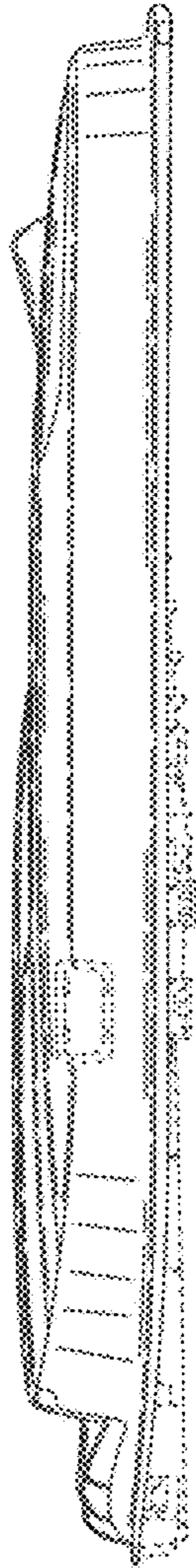
