(57) **CLAIM**

The ornamental design for front outward flange of a vehicle wheel, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a front outward flange of a vehicle wheel according to my new design;
FIG. 2 is an enlarged view of the highlighted area of FIG. 1 thereof;
FIG. 3 is a front plan view thereof;
FIG. 4 is an enlarged view of the highlighted area of FIG. 3 thereof; and,
FIG. 5 is a side elevational view thereof.
The broken lines showing the side of the wheel, spokes, bolts and center cap in the central hub area are included for the purpose of illustrating environment and form no part of the claimed design.

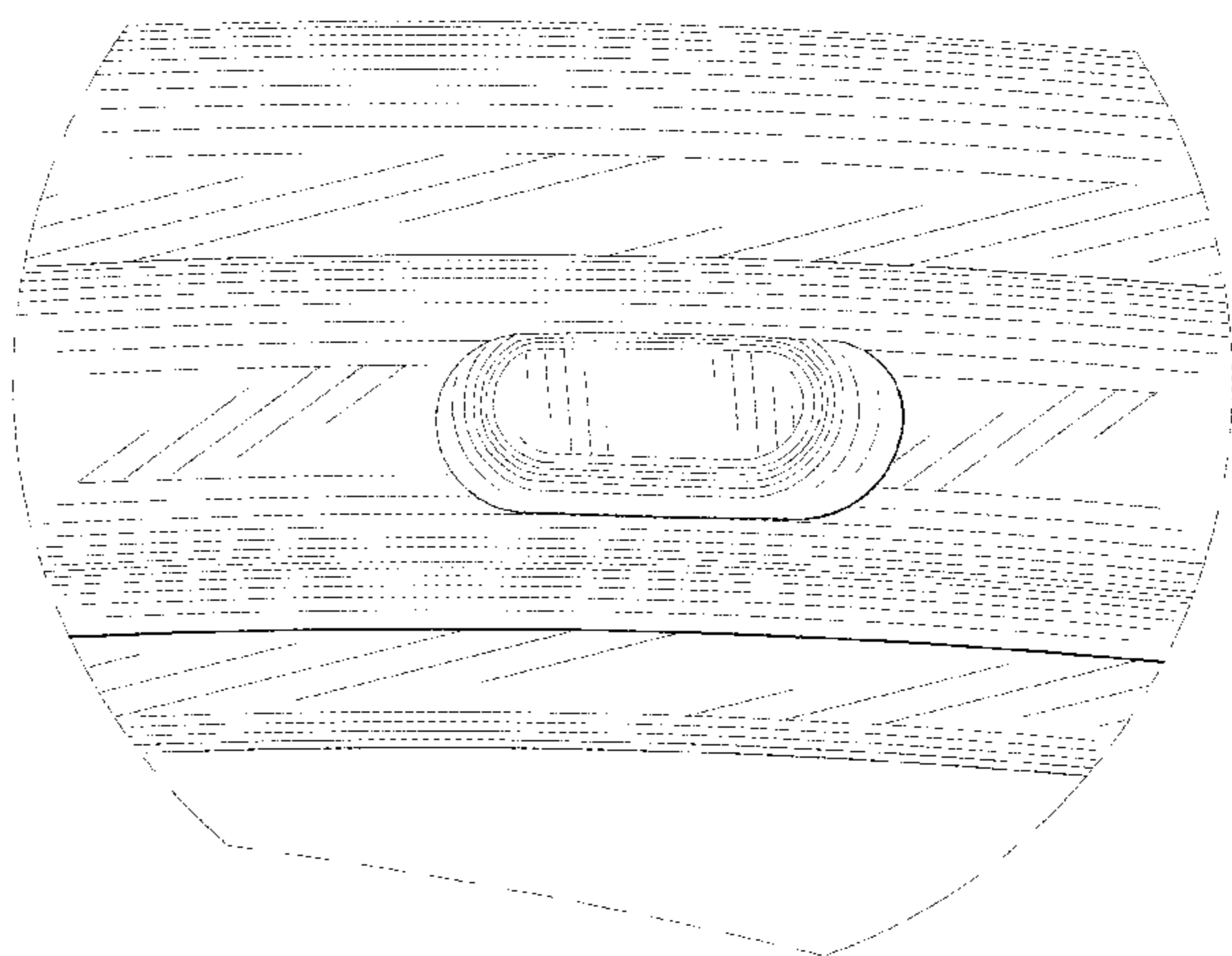
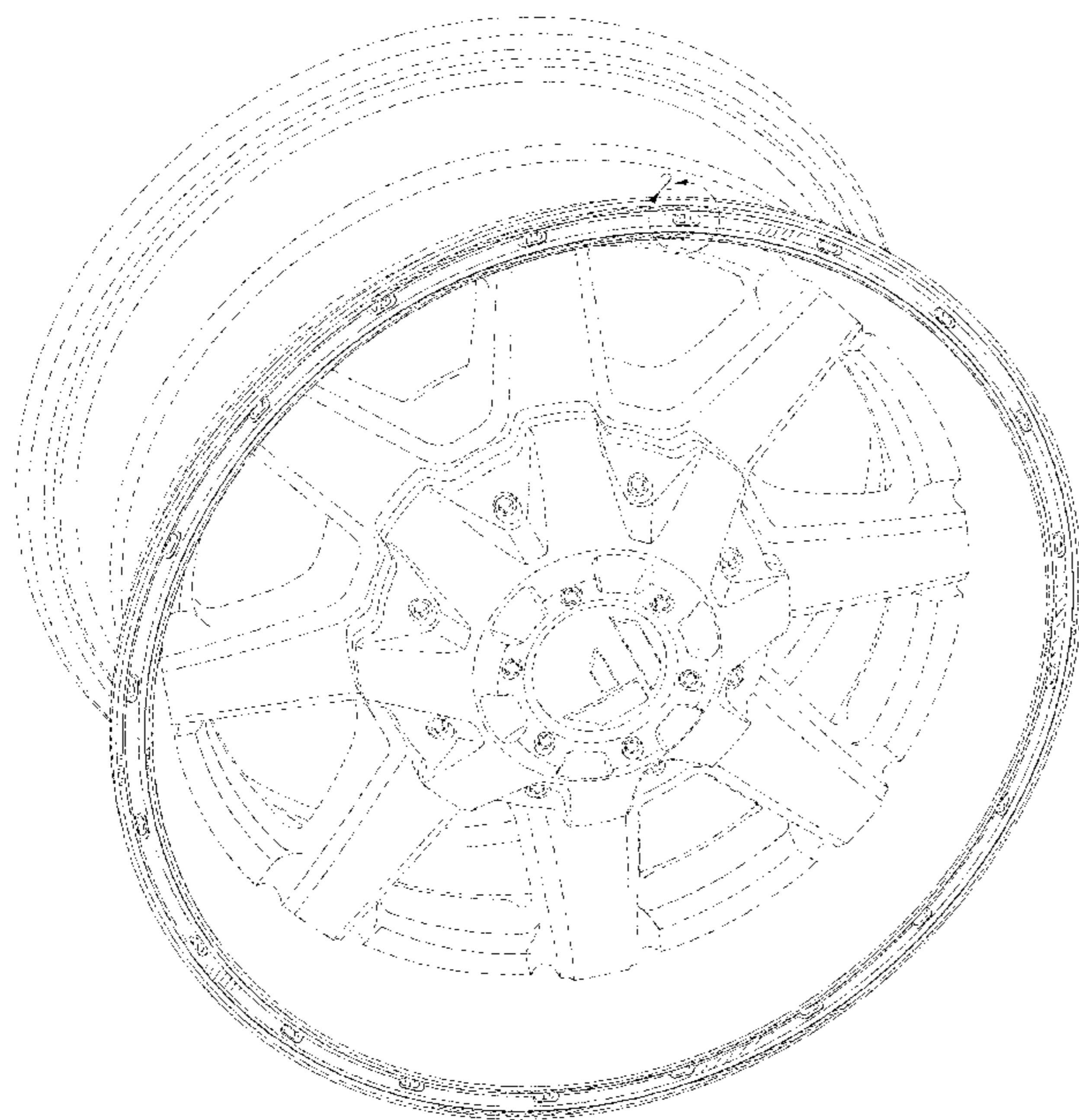

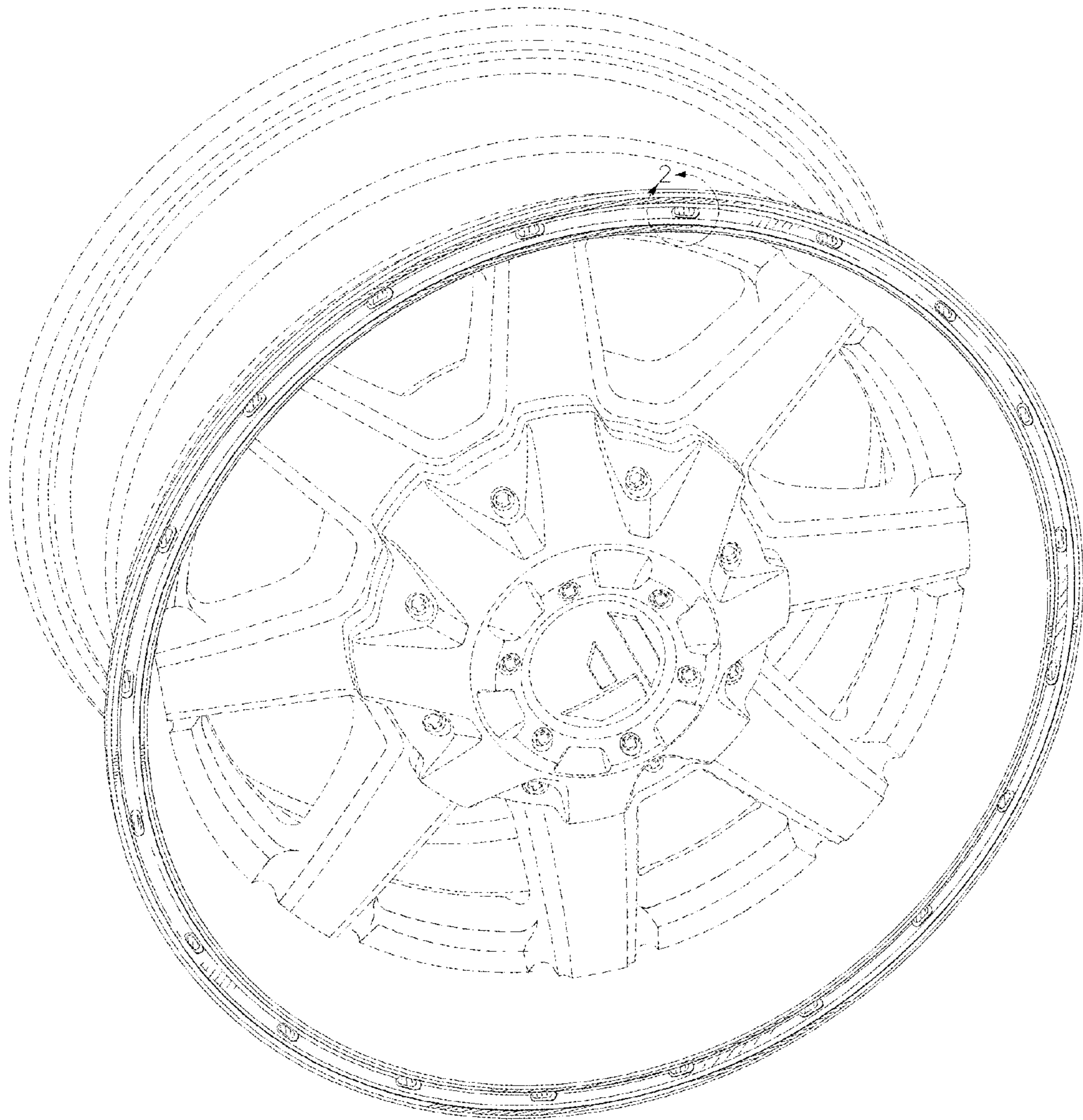

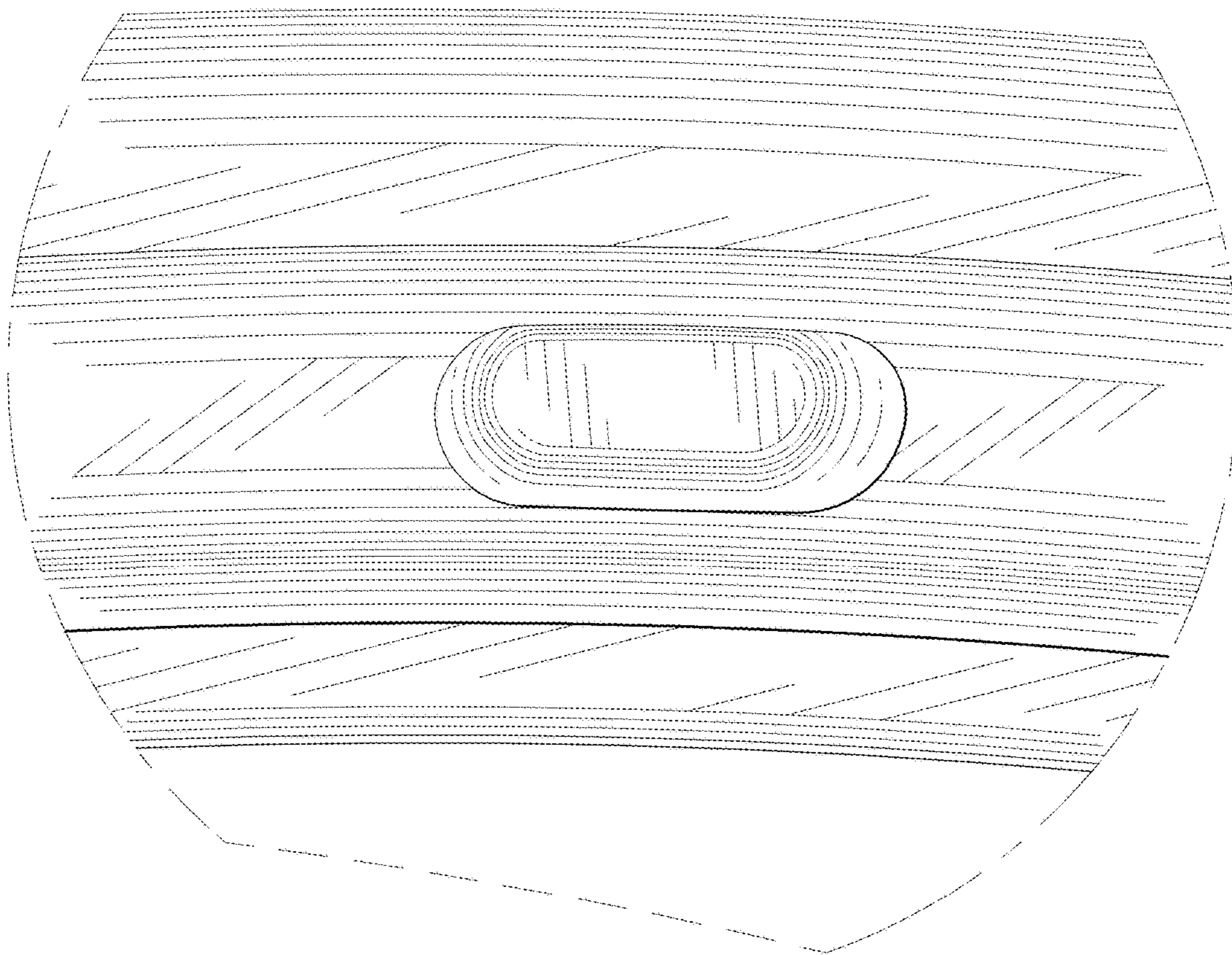

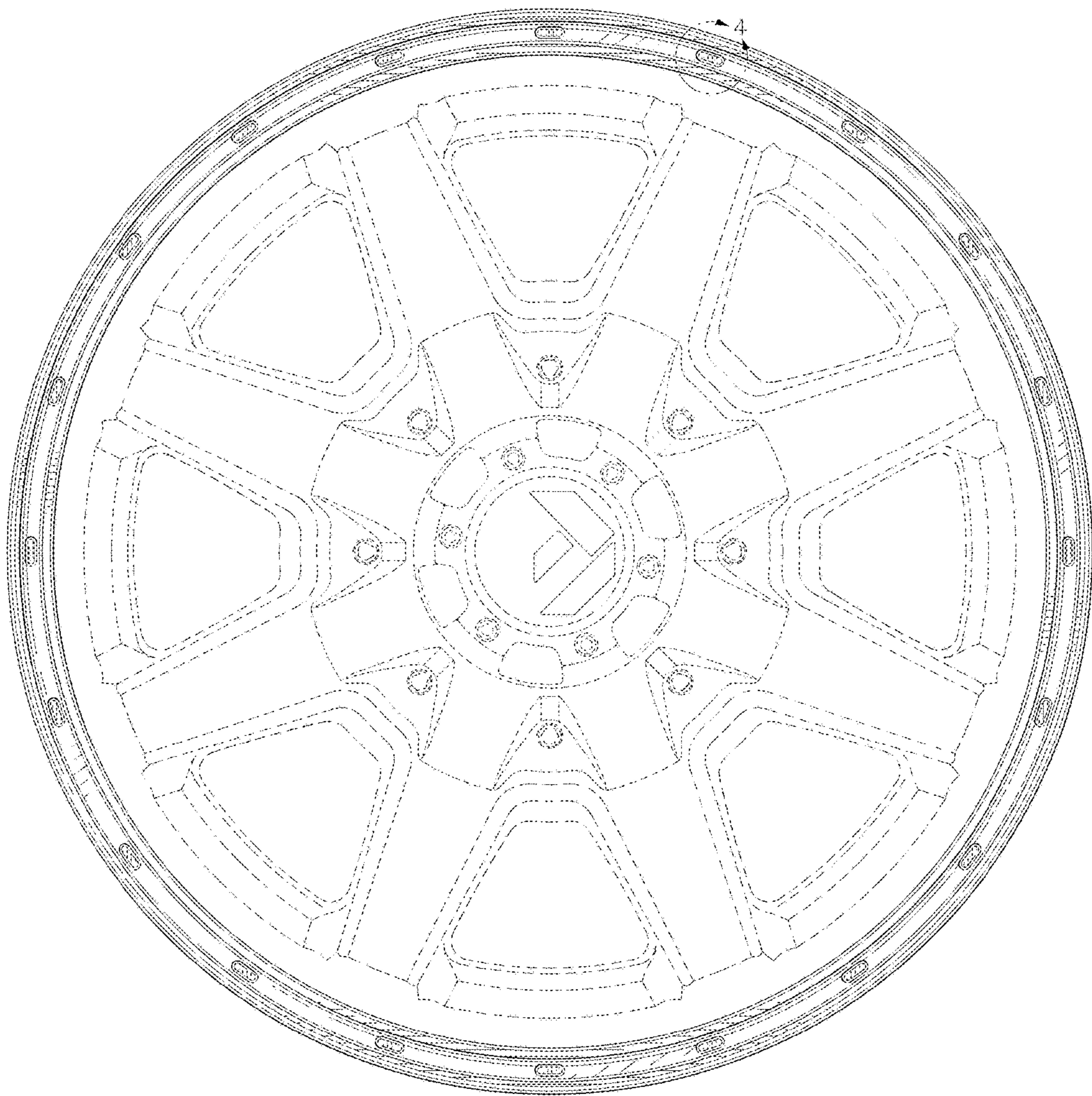

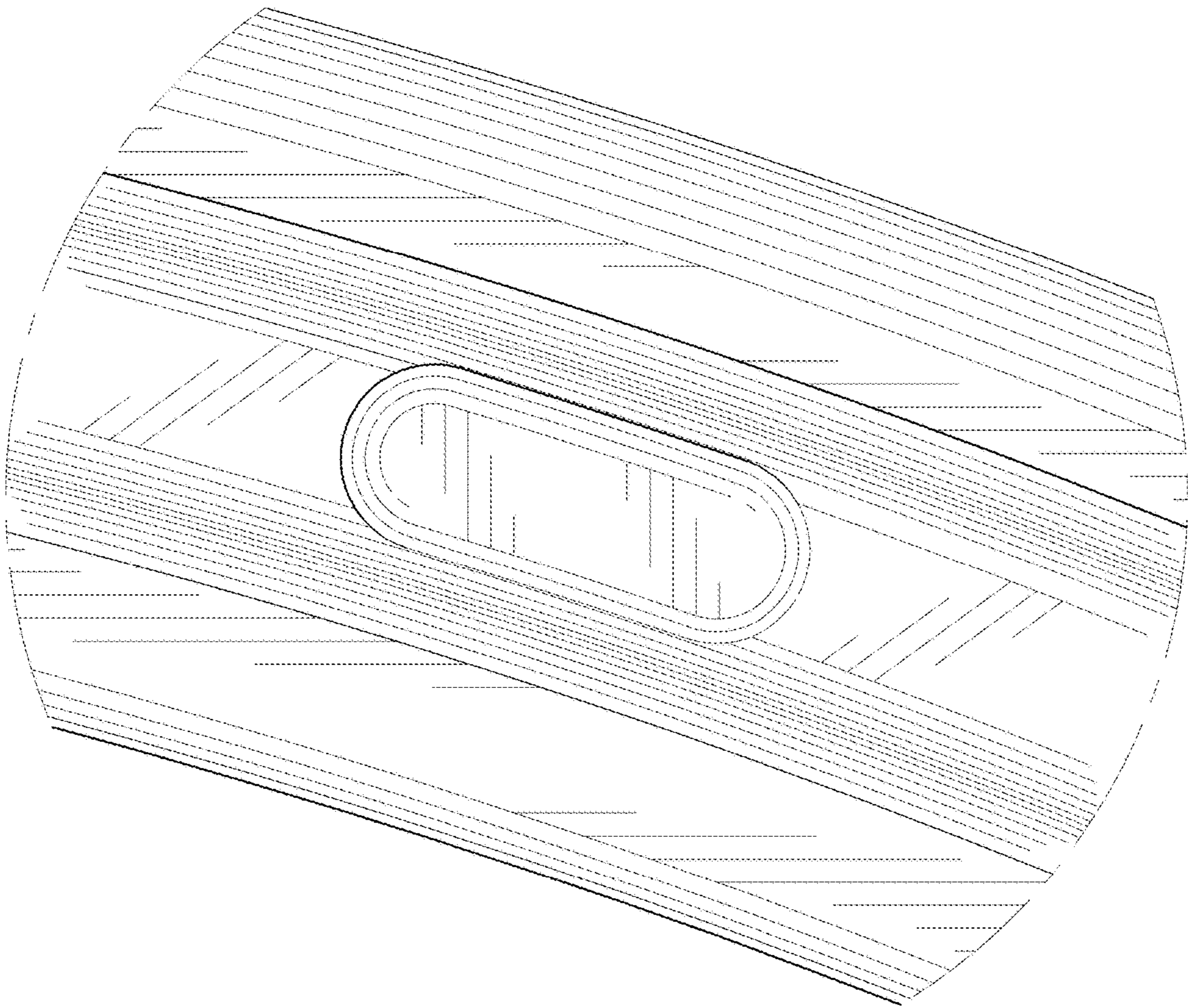
