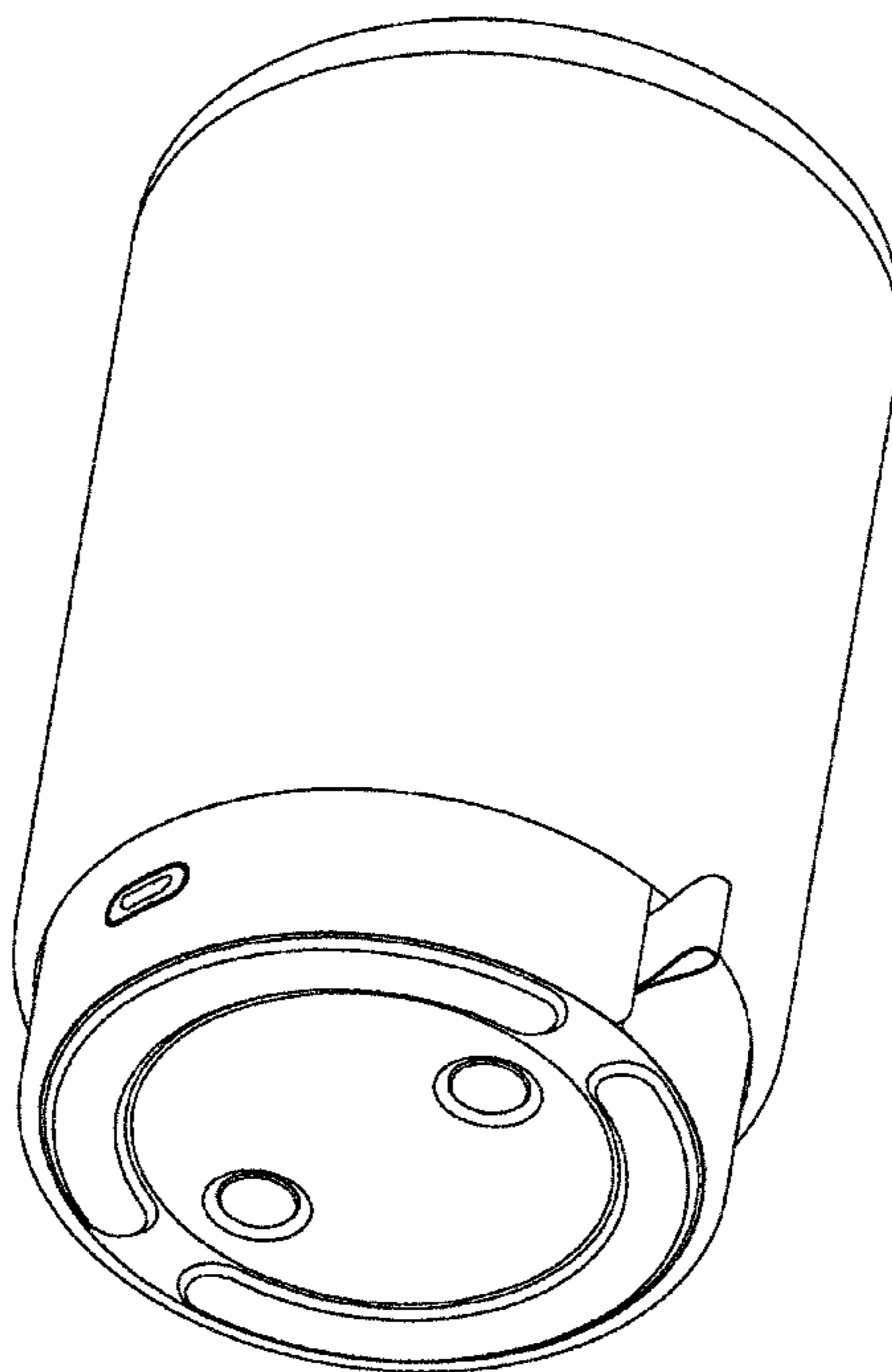
(57) **CLAIM**

The ornamental design for a combined baby monitor and night light, as shown and described.

DESCRIPTION

FIG. 1 is a front/left side/top perspective view of the combined baby monitor and night light of my design;
FIG. 2 is a rear/left side/bottom perspective view of the combined baby monitor and night light;
FIG. 3 is a front view of the combined baby monitor and night light;
FIG. 4 is a left side view of the combined baby monitor and night light;

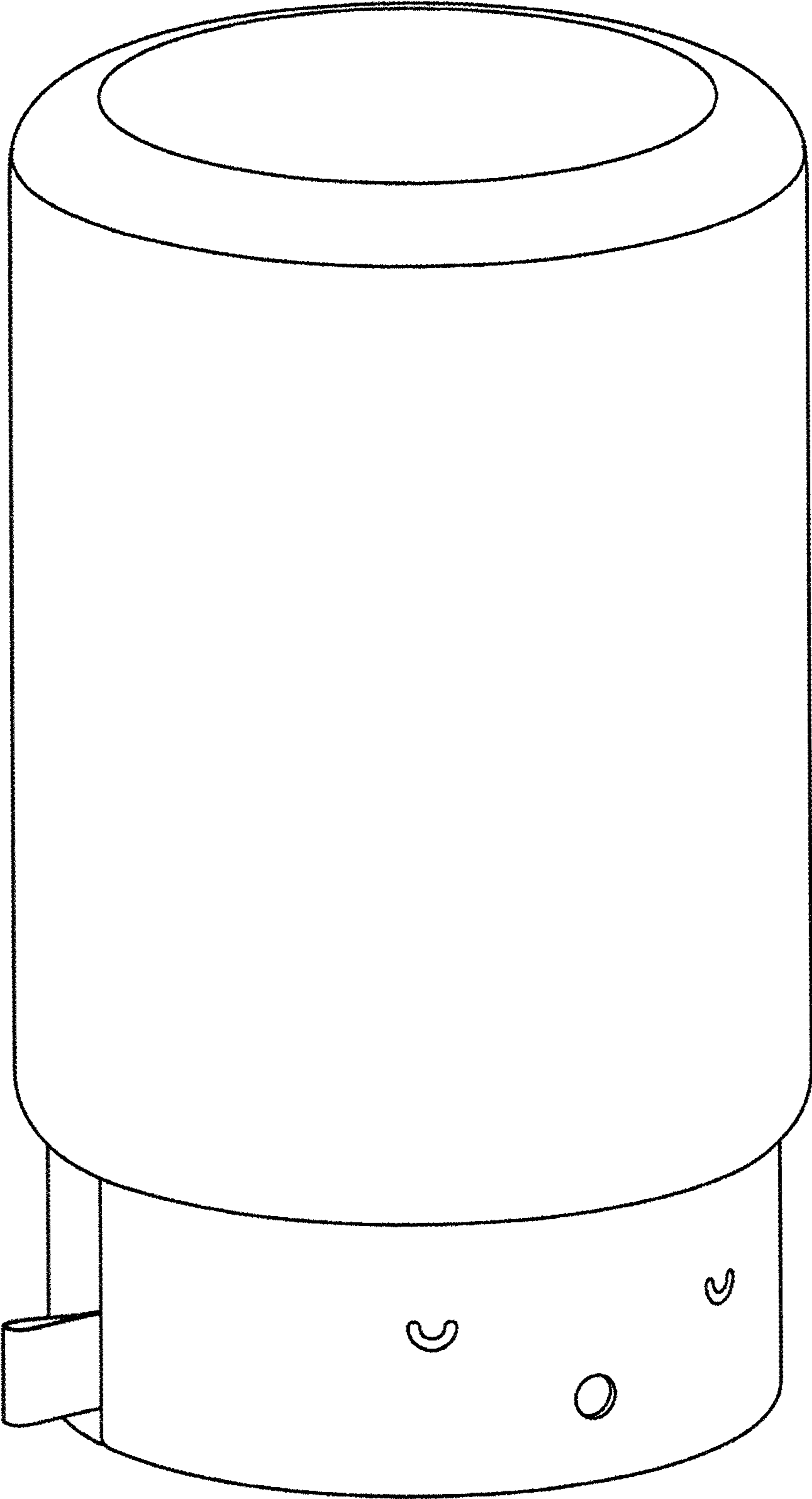

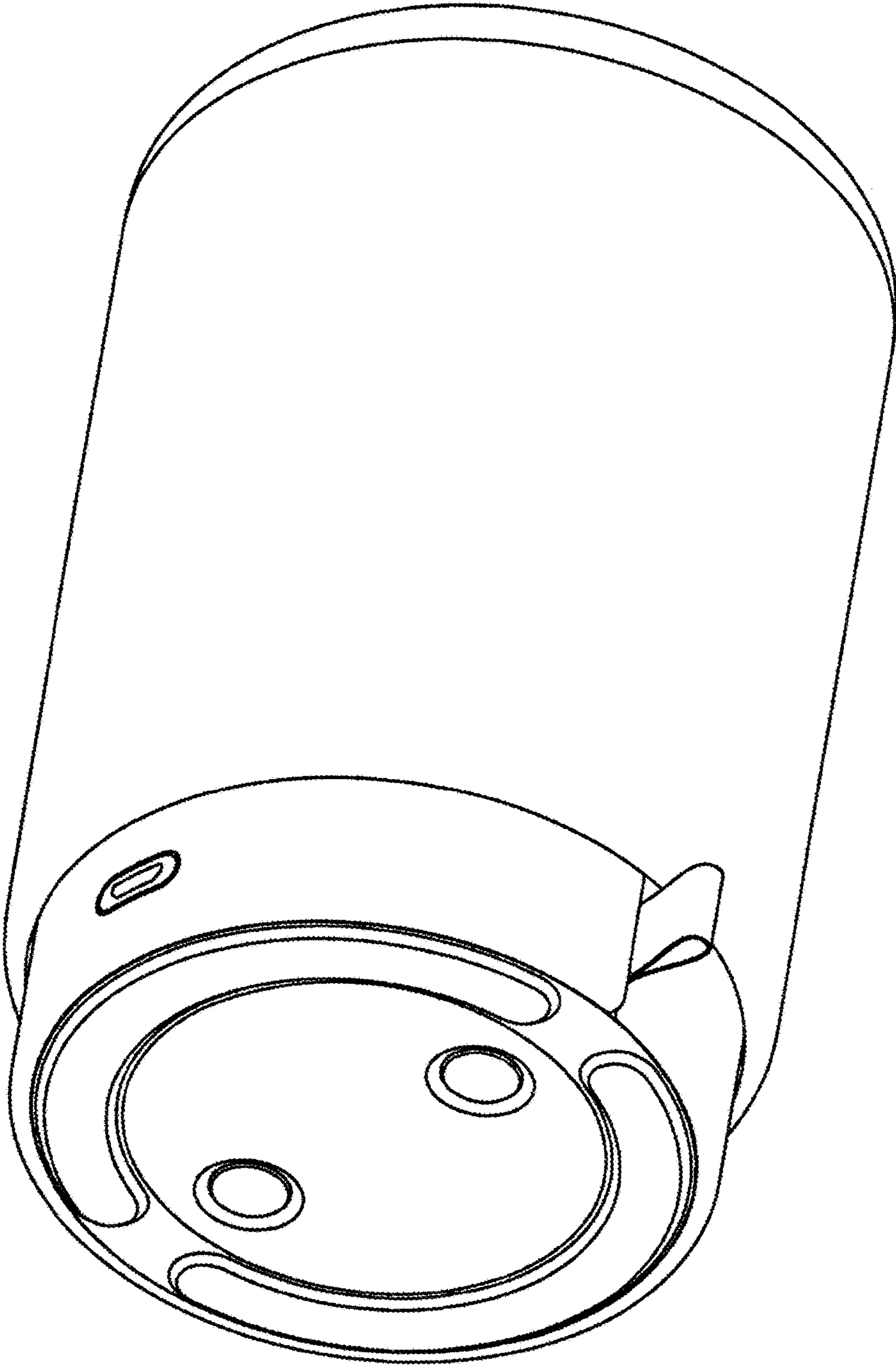

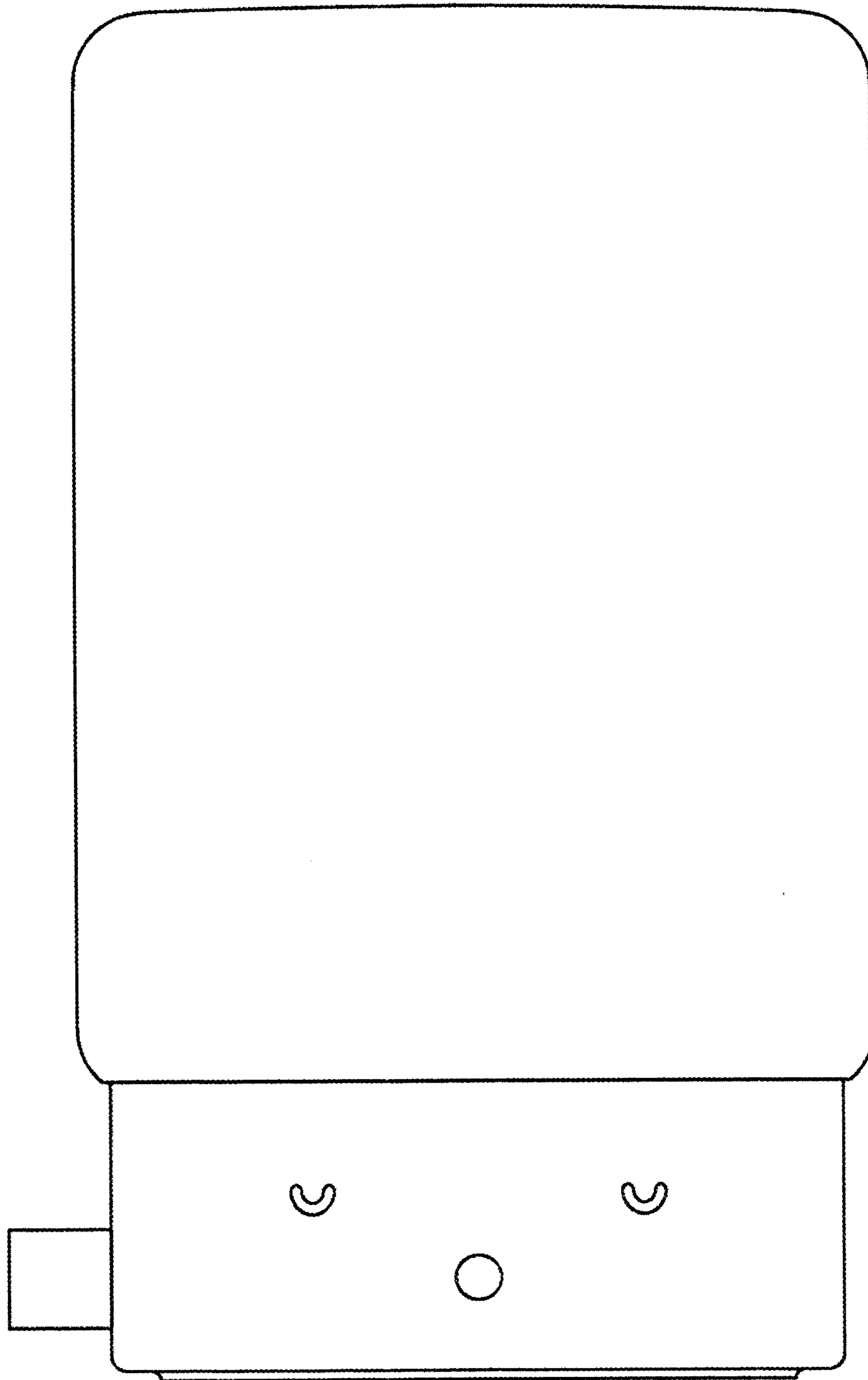

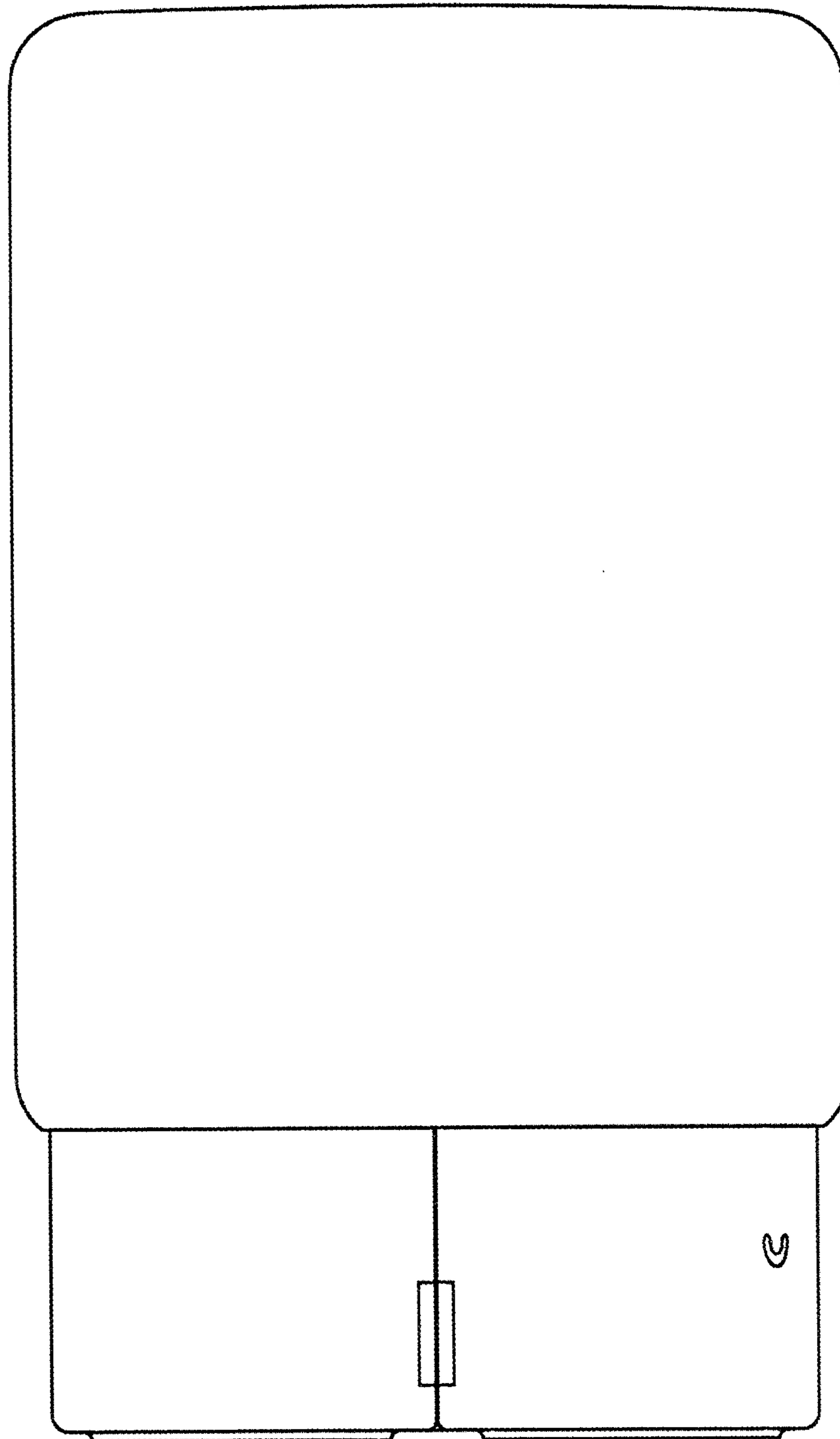

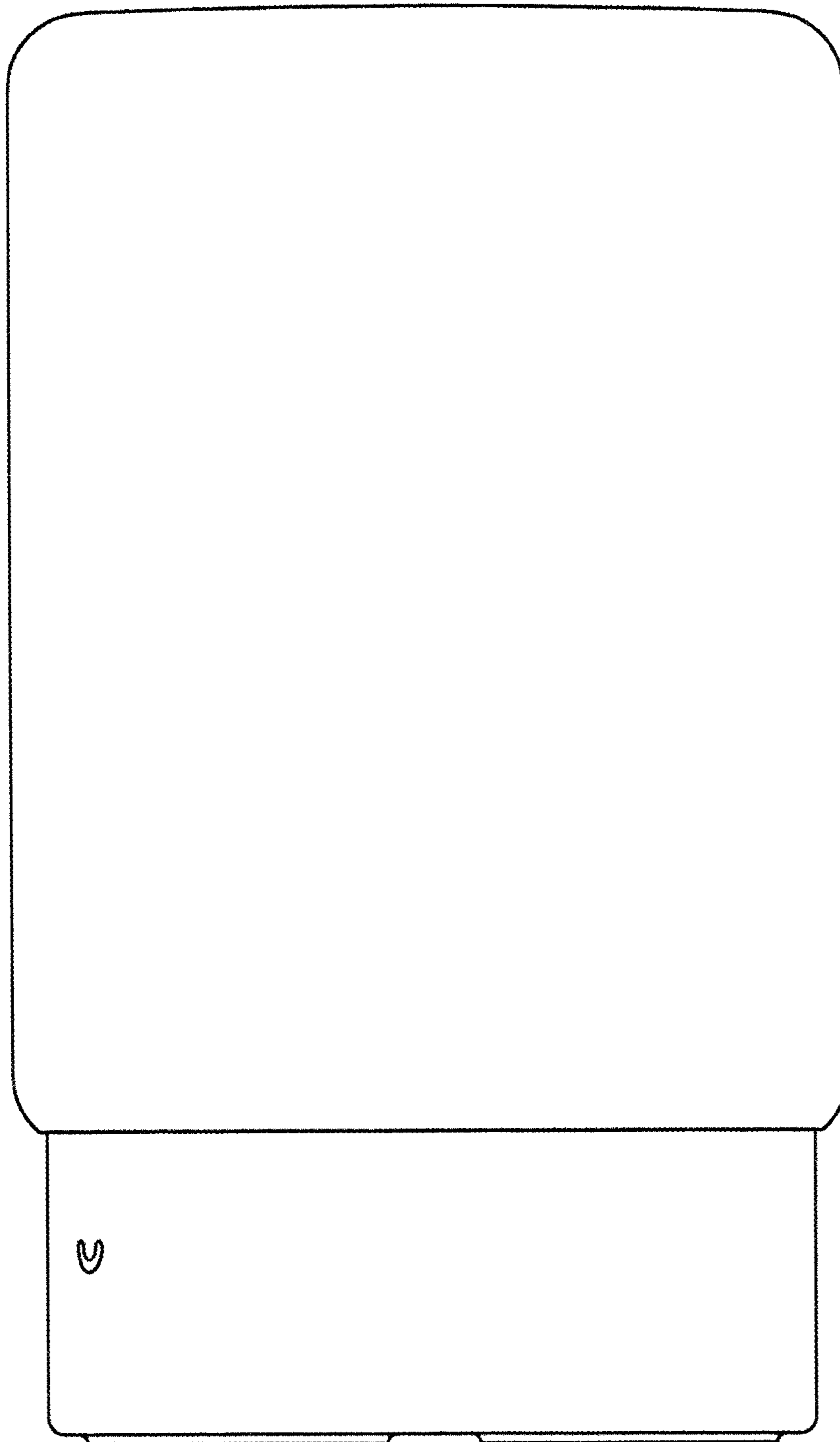

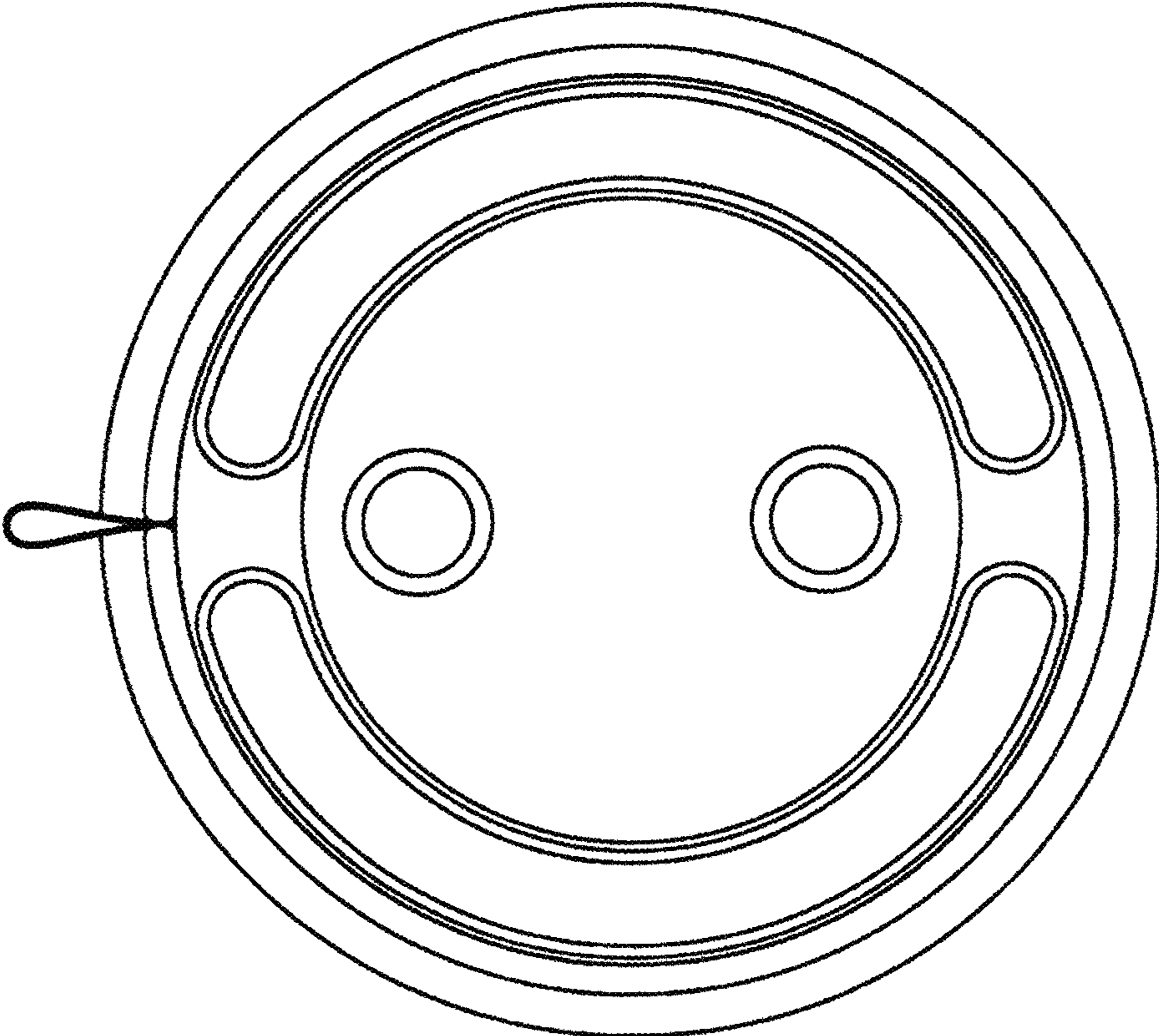
