(57) **CLAIM**

The ornamental design for an information display for a vehicle with a graphical user interface, as shown and described.

**DESCRIPTION**

FIG. 4 is a fourth transitional image of the information display for vehicle with graphical user interface according to the first embodiment;

FIG. 5 is a first transitional image of information display for vehicle with graphical user interface showing a second embodiment of our new design;

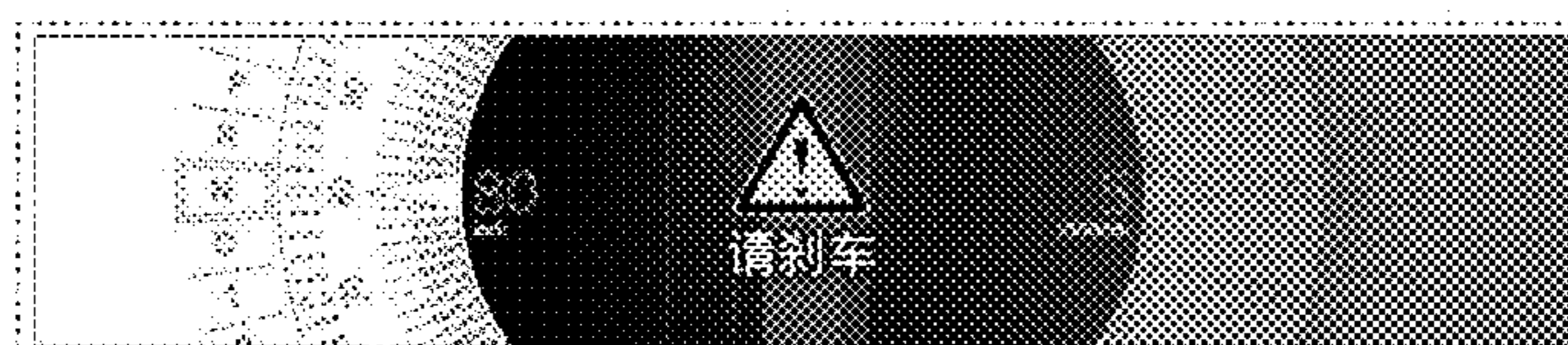
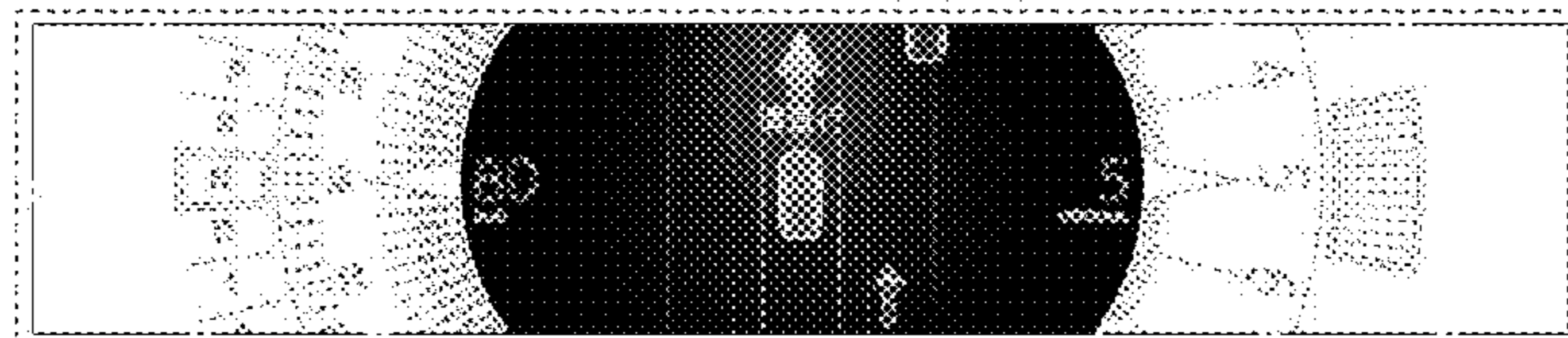
FIG. 6 is a second transitional image of the information display for vehicle with graphical user interface according to the second embodiment;

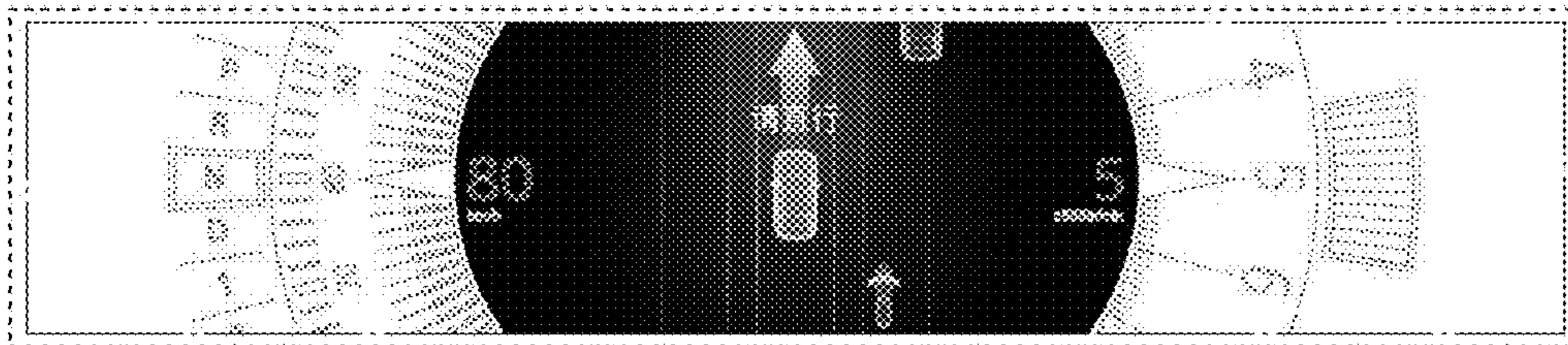

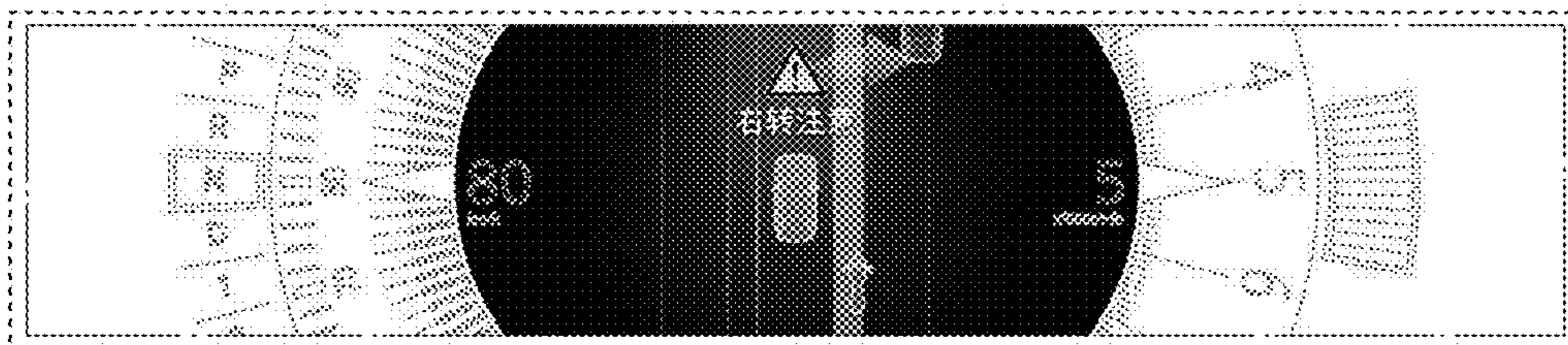

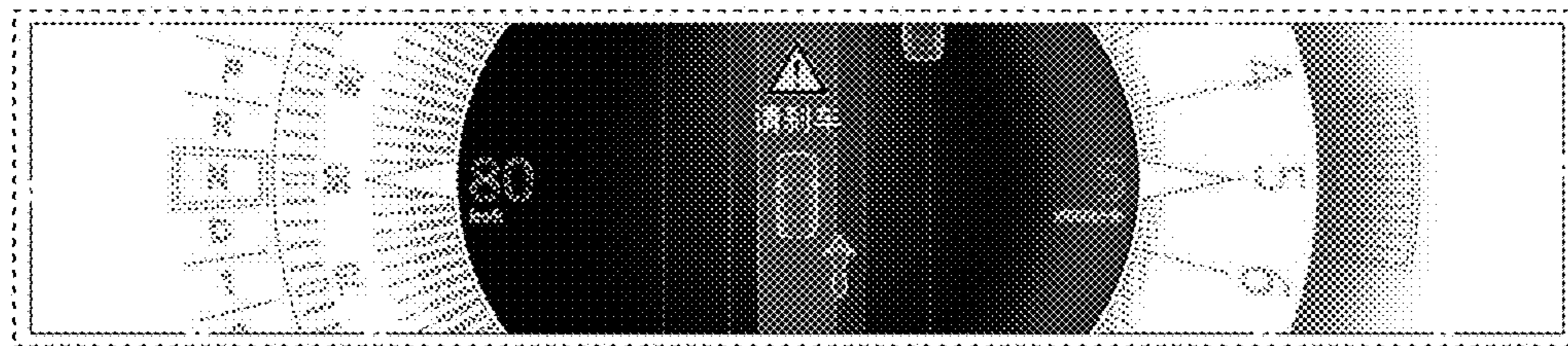

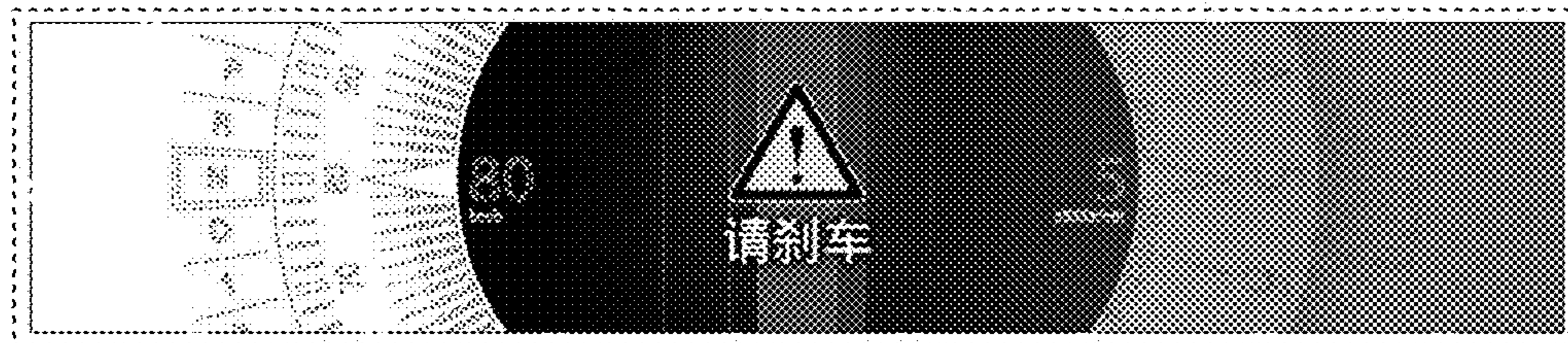

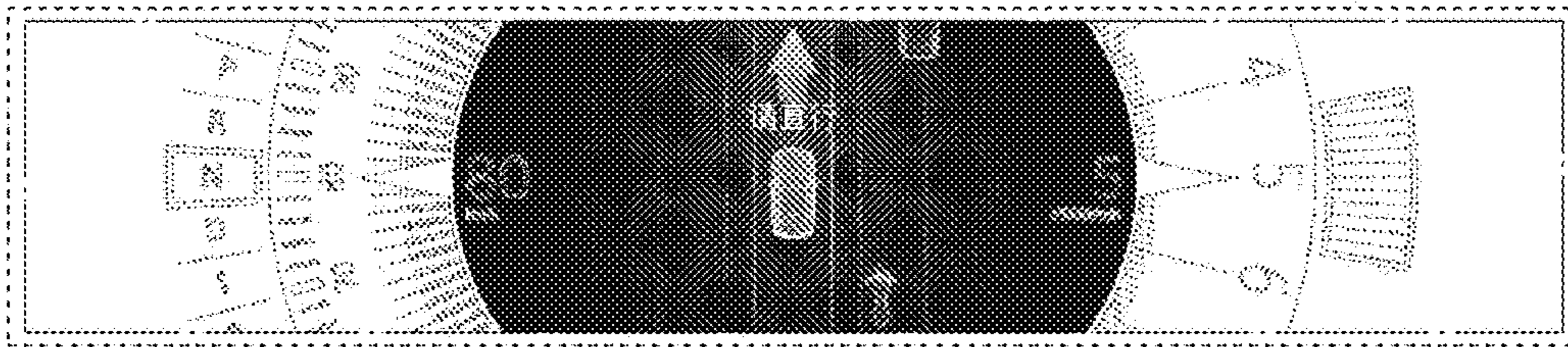

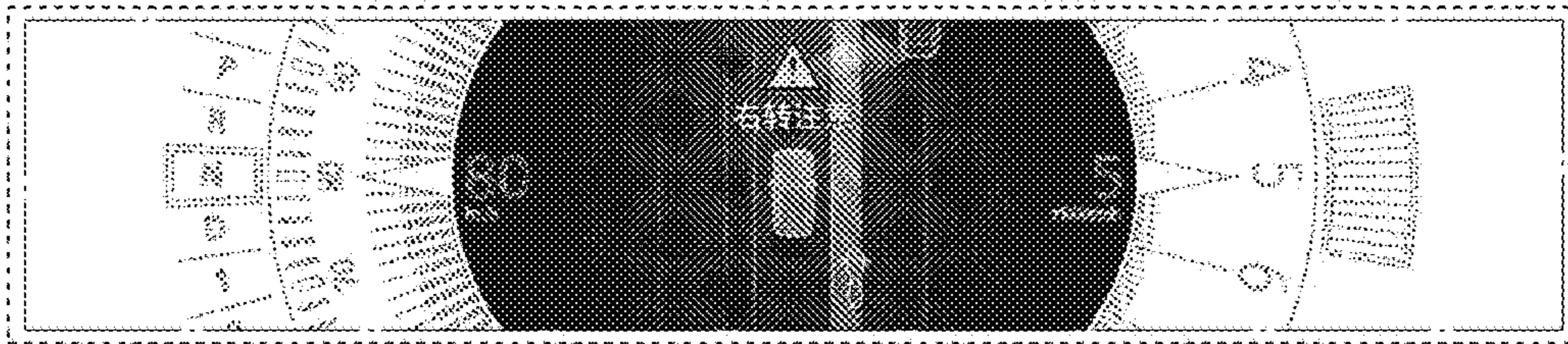

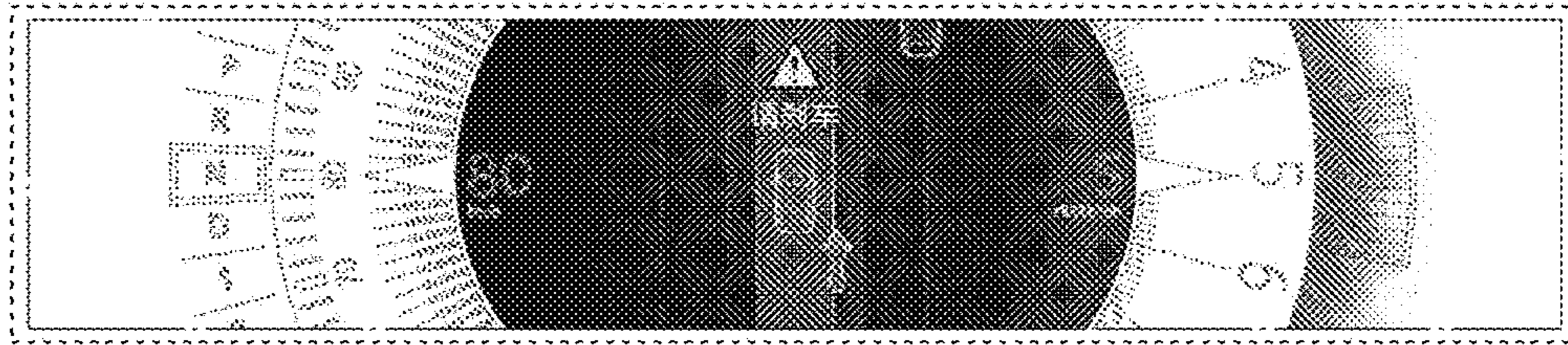
