FIG. 5 is a front view of a display screen or portion thereof with graphical user interface according to a fifth embodiment.

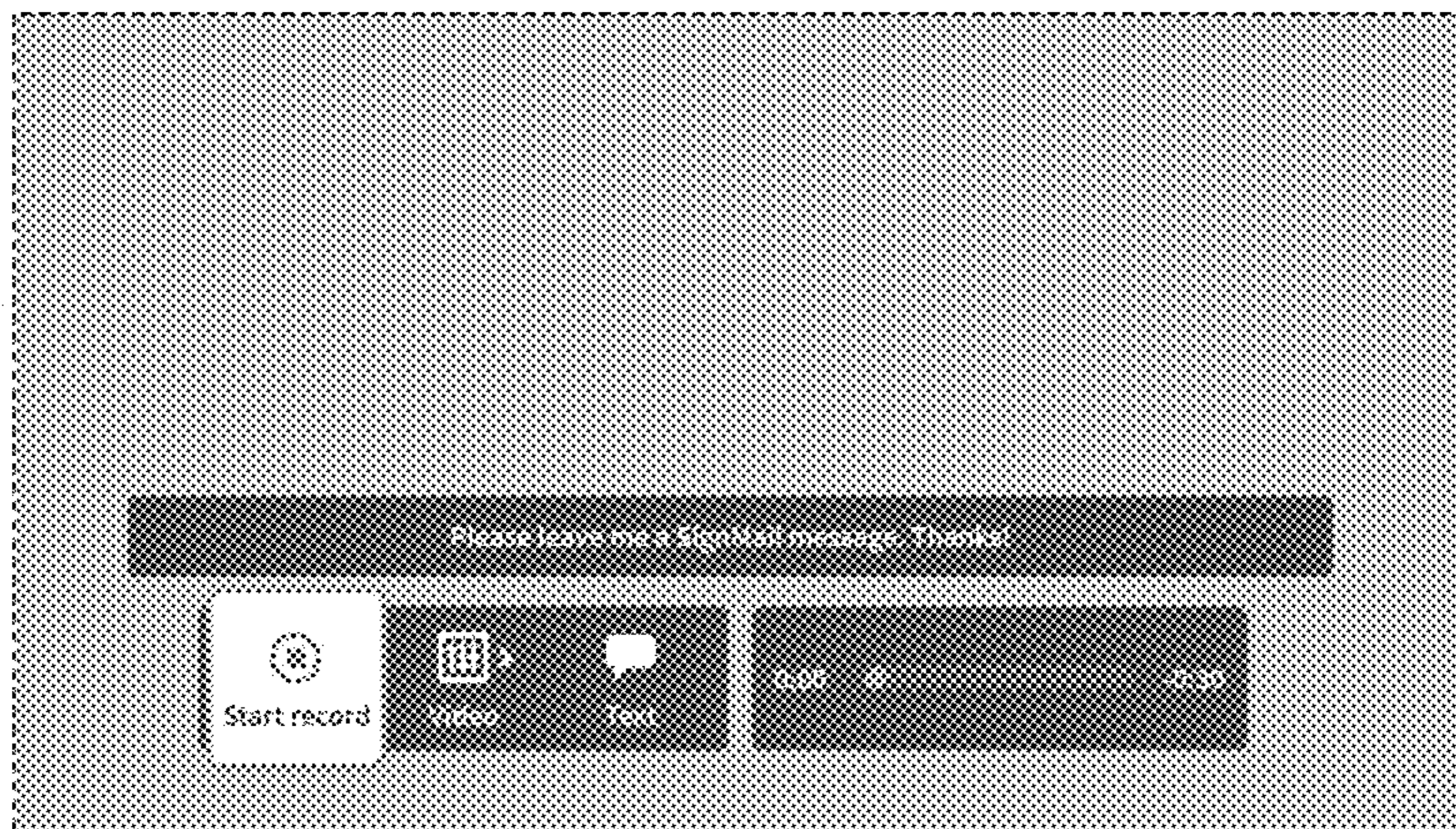
FIG. 6 is a front view of a display screen or portion thereof with graphical user interface according to a sixth embodiment.

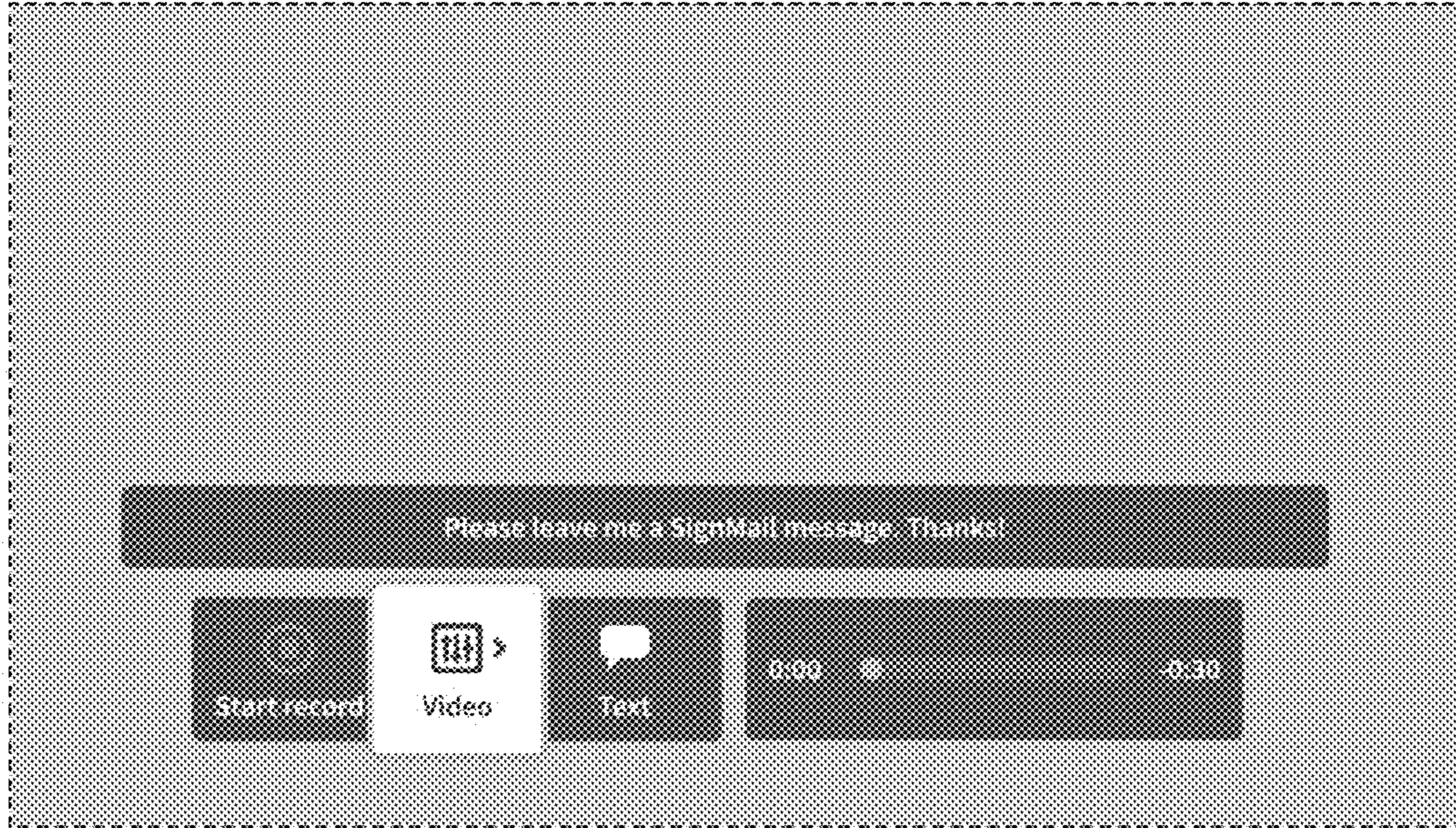

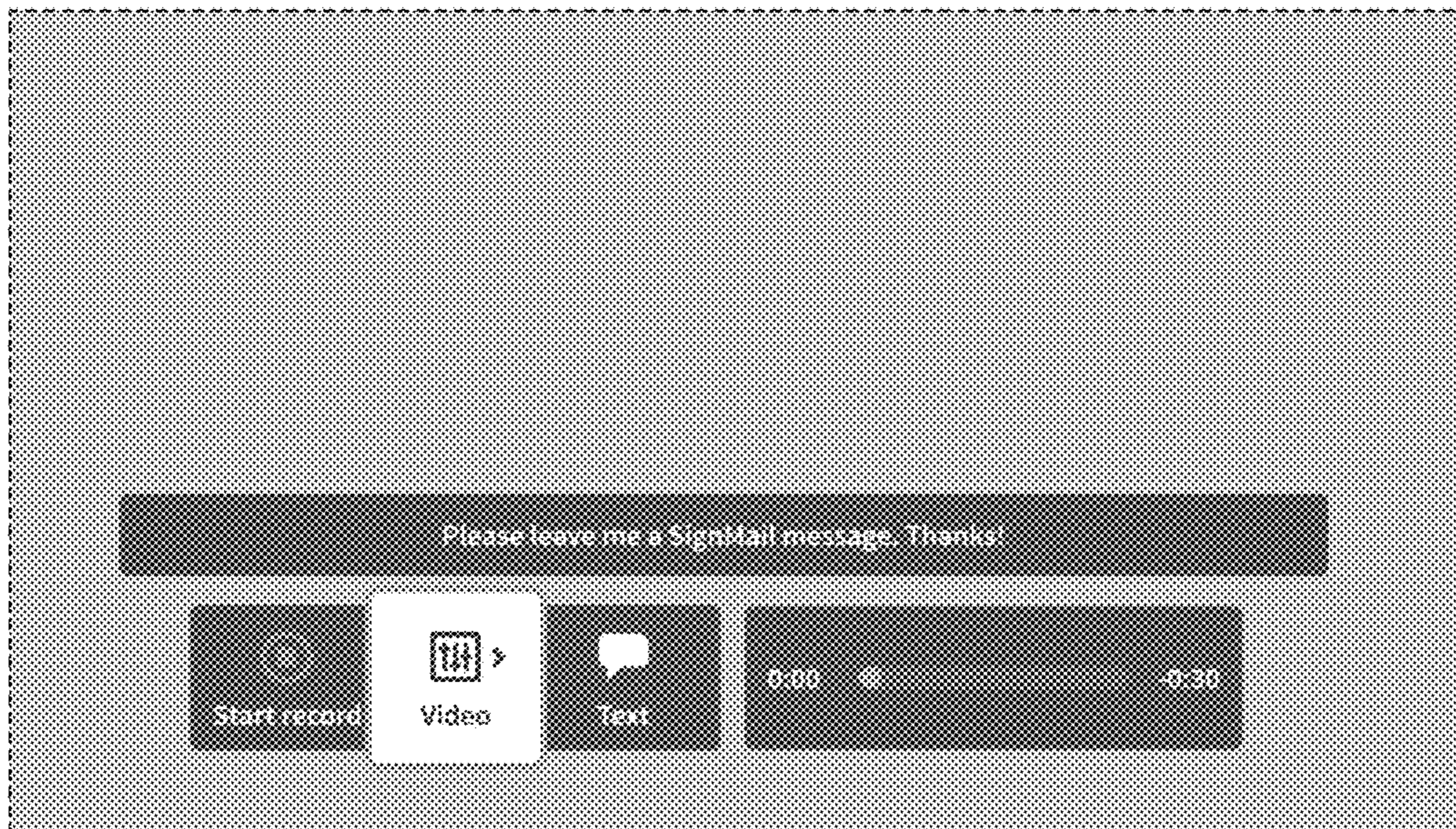

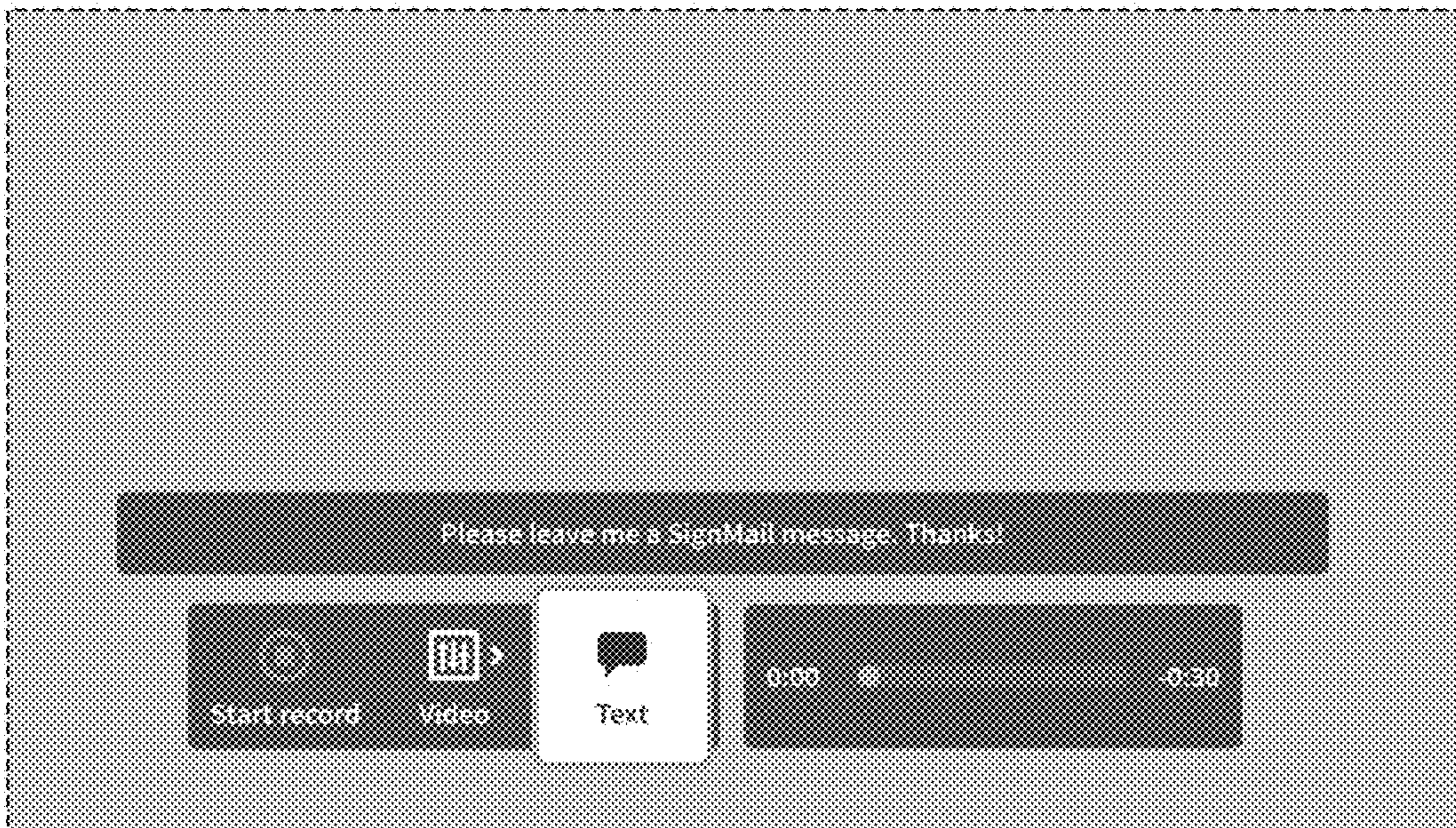

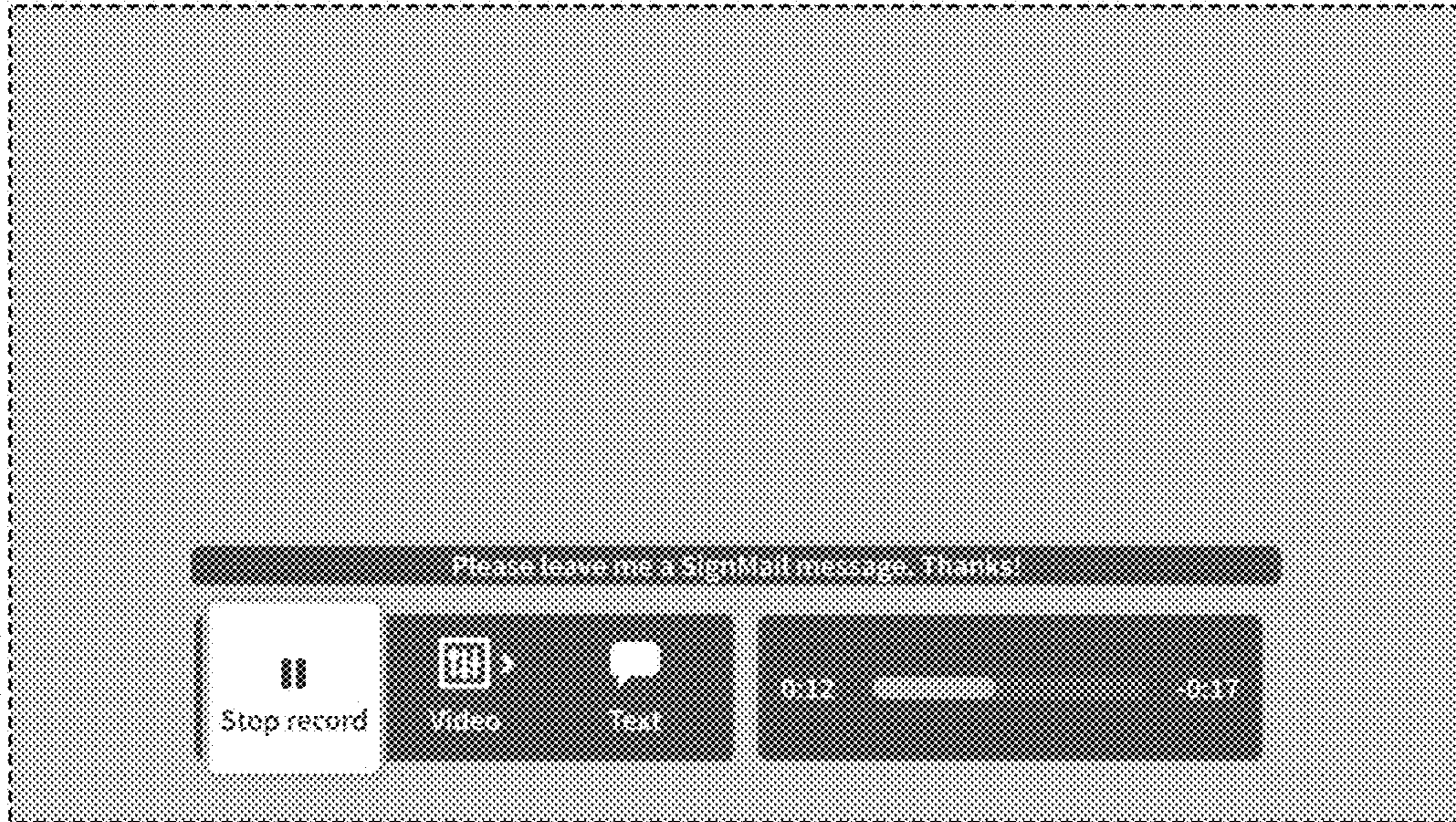

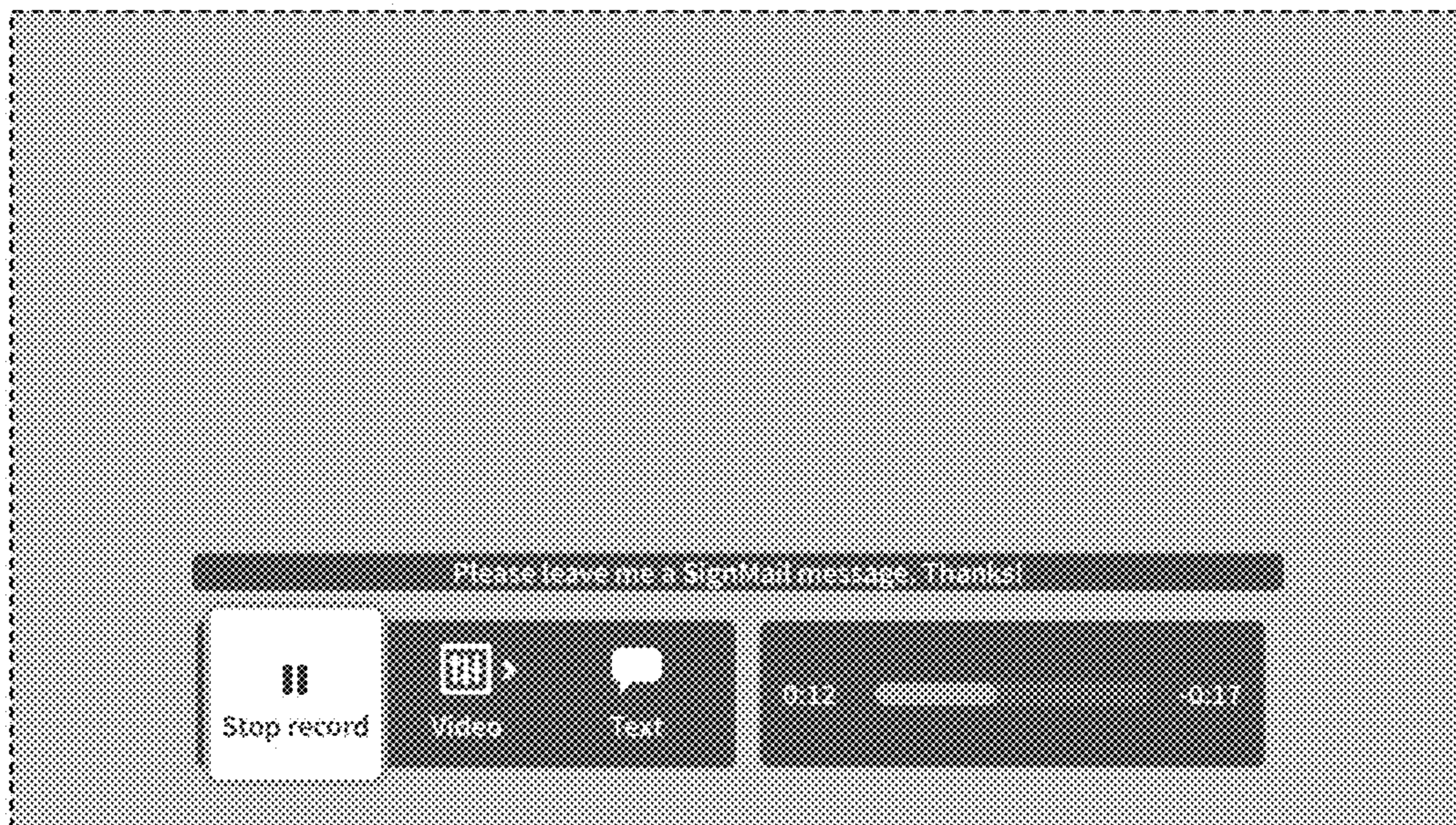
