CLAIM

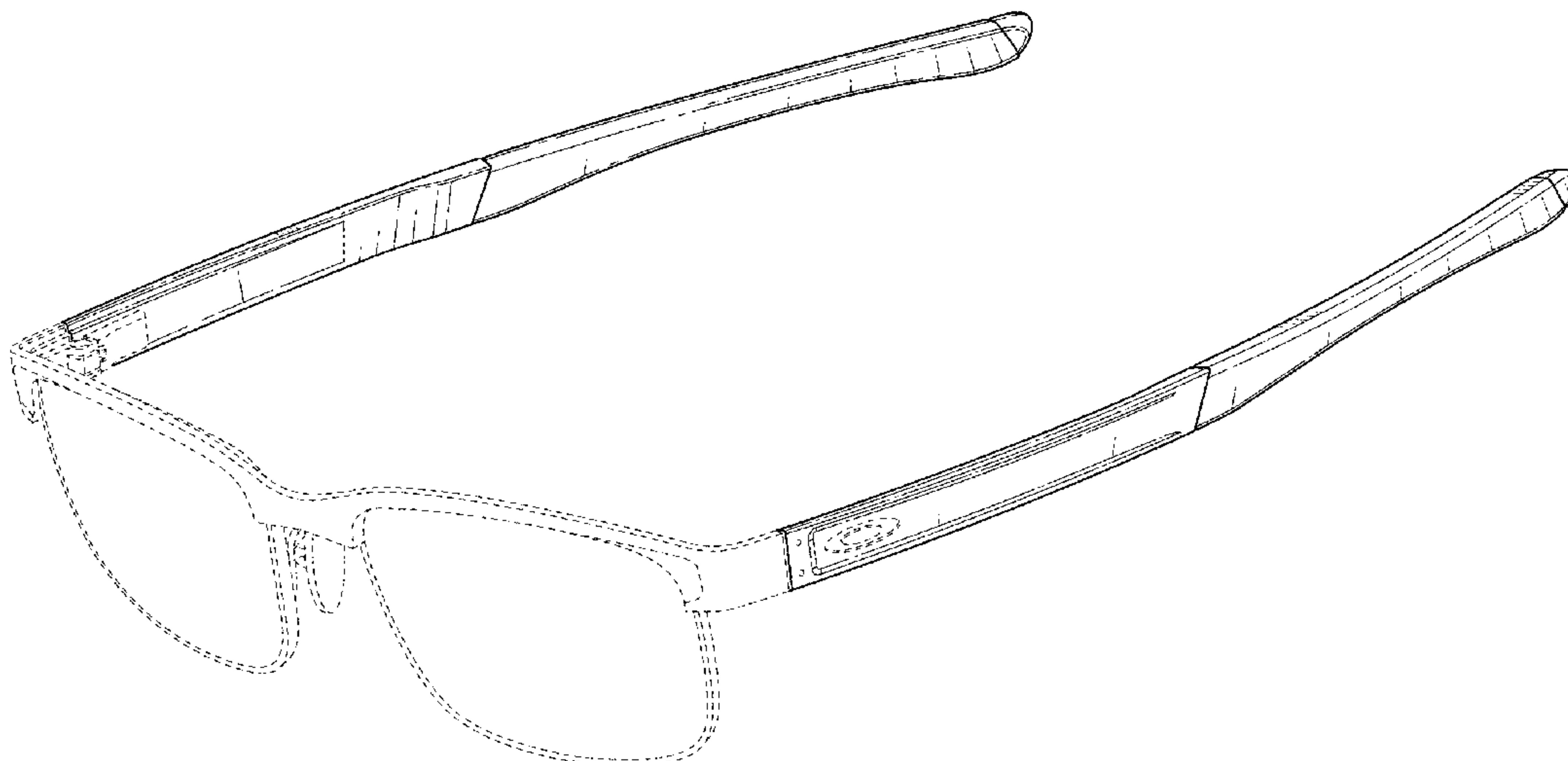
The ornamental design for a set of eyeglass components, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a set of eyeglass components showing our new design;
FIG. 2 is a front elevational view thereof;
FIG. 3 is a rear elevational view thereof;
FIG. 4 is a left side elevational view thereof, the right side elevational view being a mirror image thereof;
FIG. 5 is a top plan view thereof; and,
FIG. 6 is a bottom plan view thereof.

The broken lines in the Figures show portions of the set of eyeglass components which form no part of the claimed design.

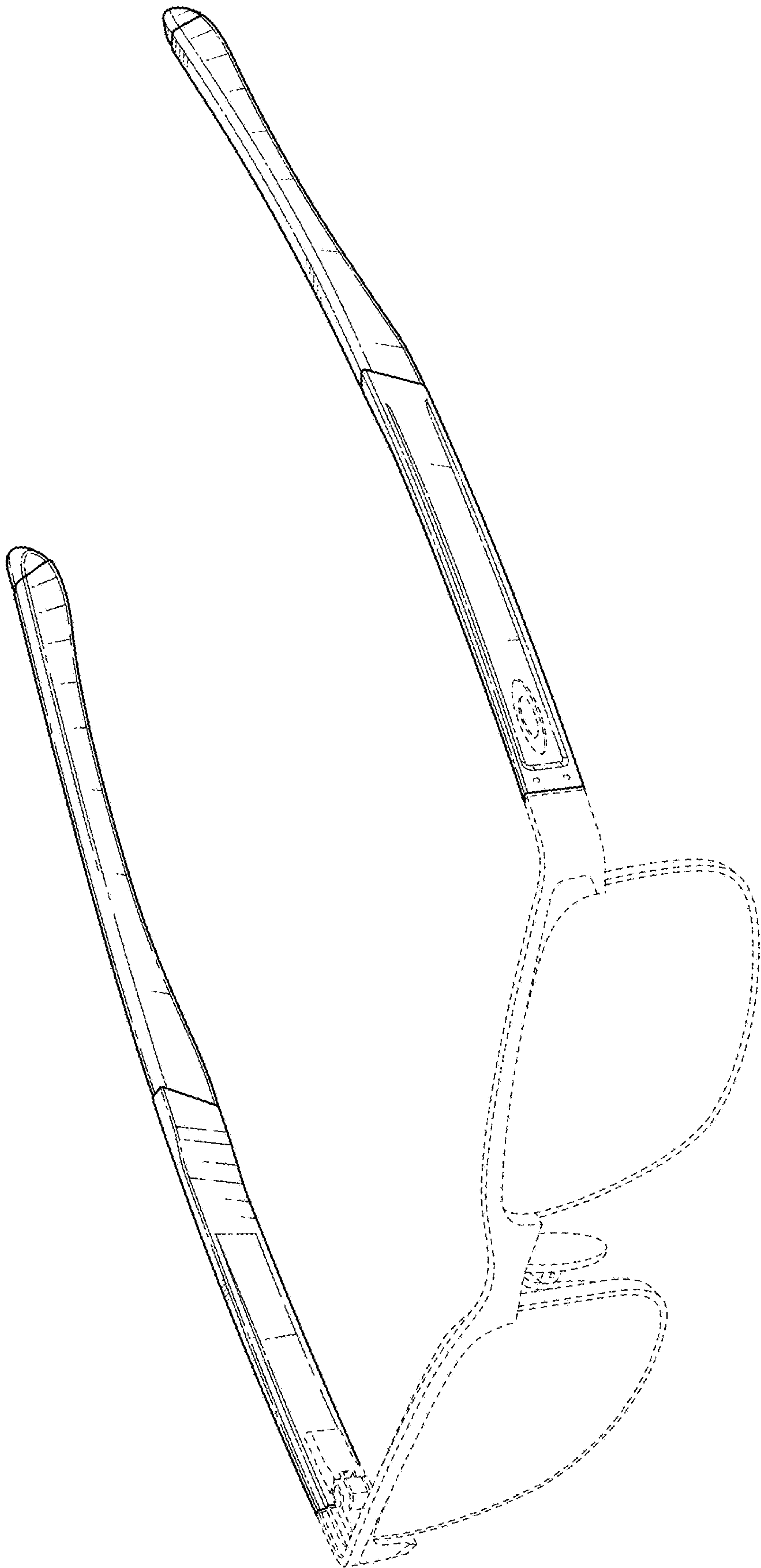

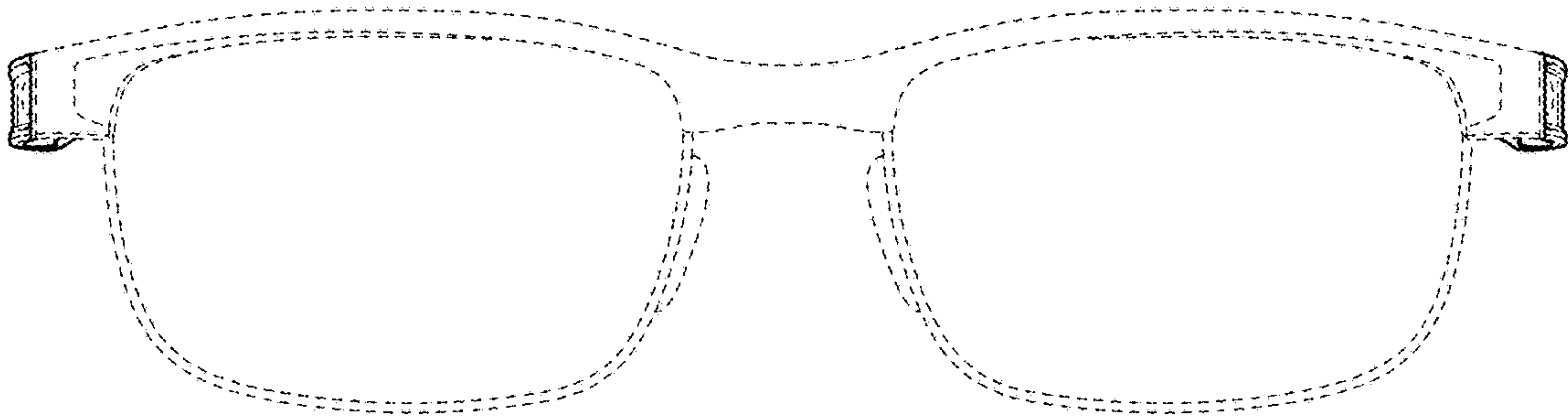

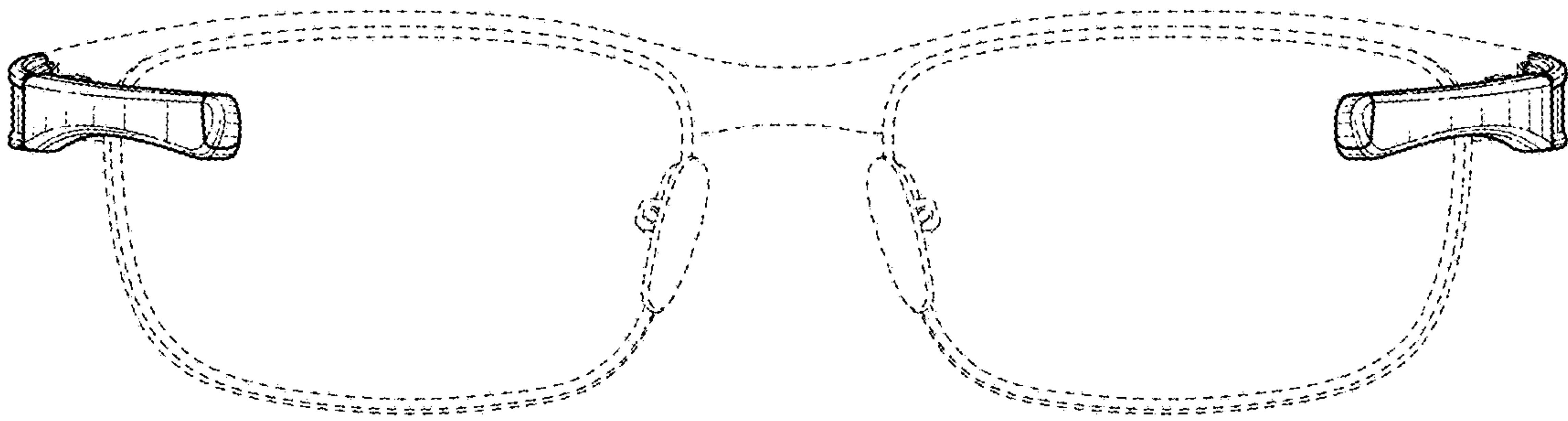

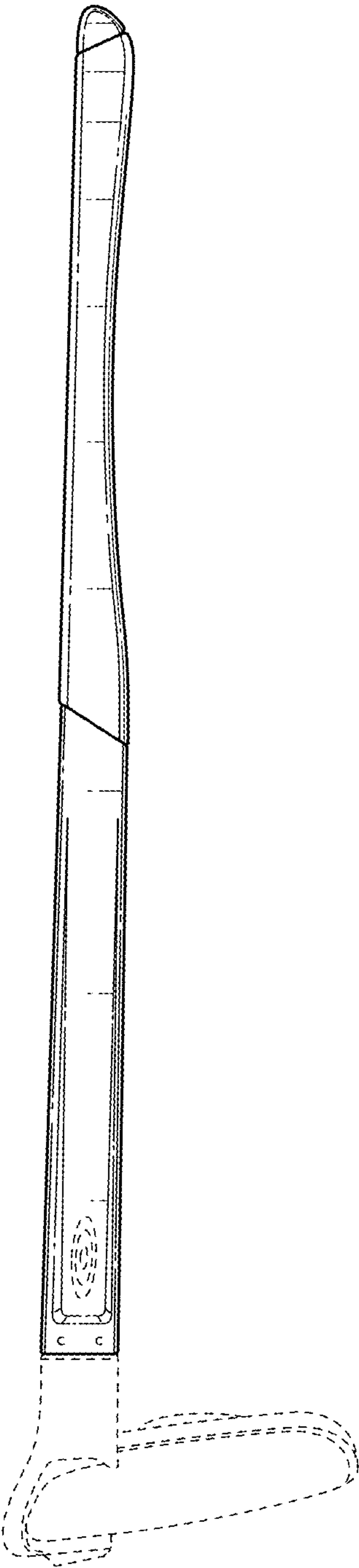

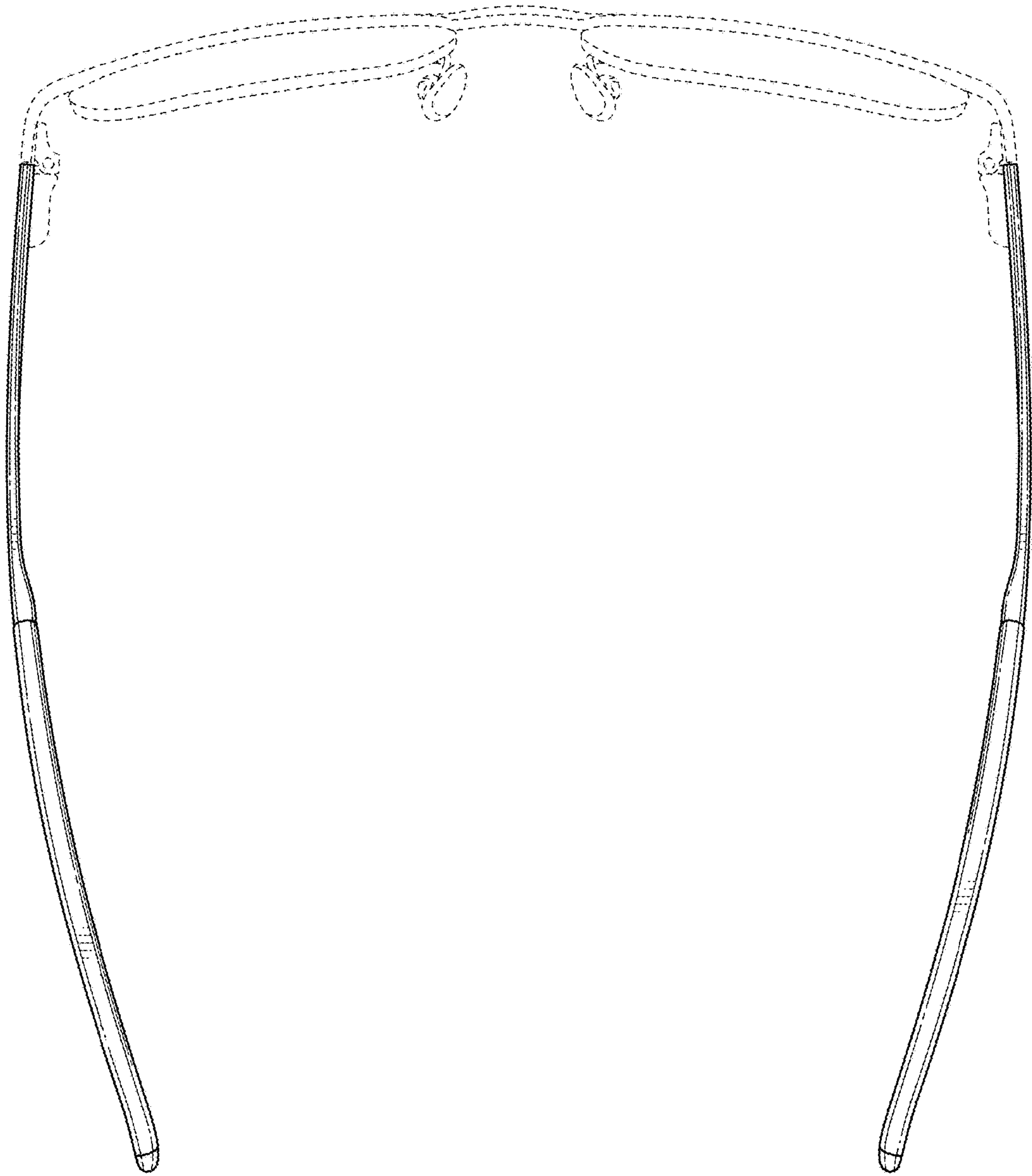
