(57) **CLAIM**

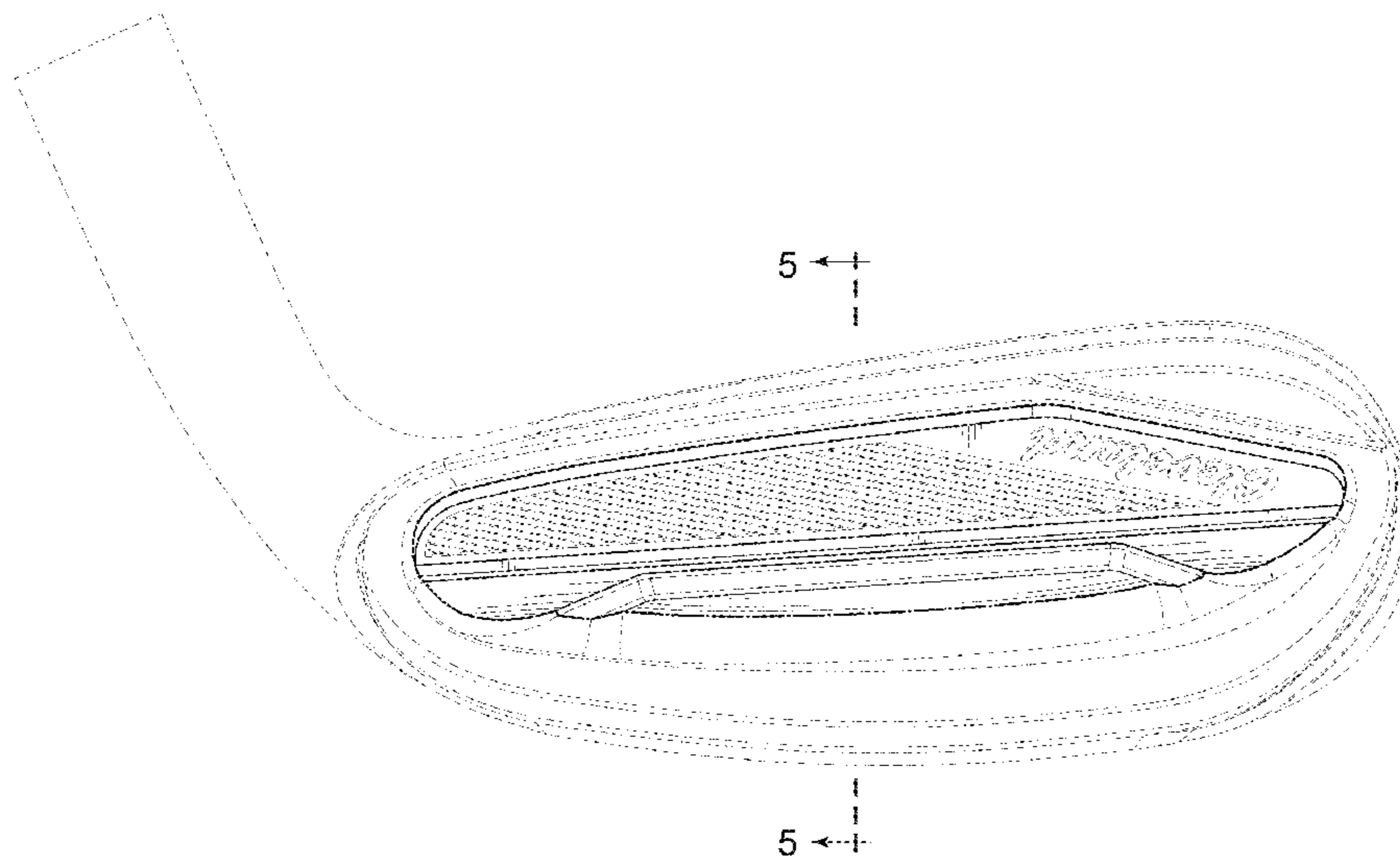
The ornamental design for a golf club head, as shown and described.

**DESCRIPTION**

FIG. 1 is a bottom, heel-side, rear perspective view of the golf club head;  
 FIG. 2 is a rear elevational view thereof;  
 FIG. 3 is a toe-side elevational view thereof;  
 FIG. 4 is a heel-side elevational view thereof; and,  
 FIG. 5 is a cross-sectional view thereof taken along line 5-5 in FIG. 2.  
 The dot-dash chain lines depict boundaries of the claimed subject matter, and thus form no part of the claimed design.  
 The broken lines depict unclaimed parts of the golf club head, and thus form no part of the claimed design.

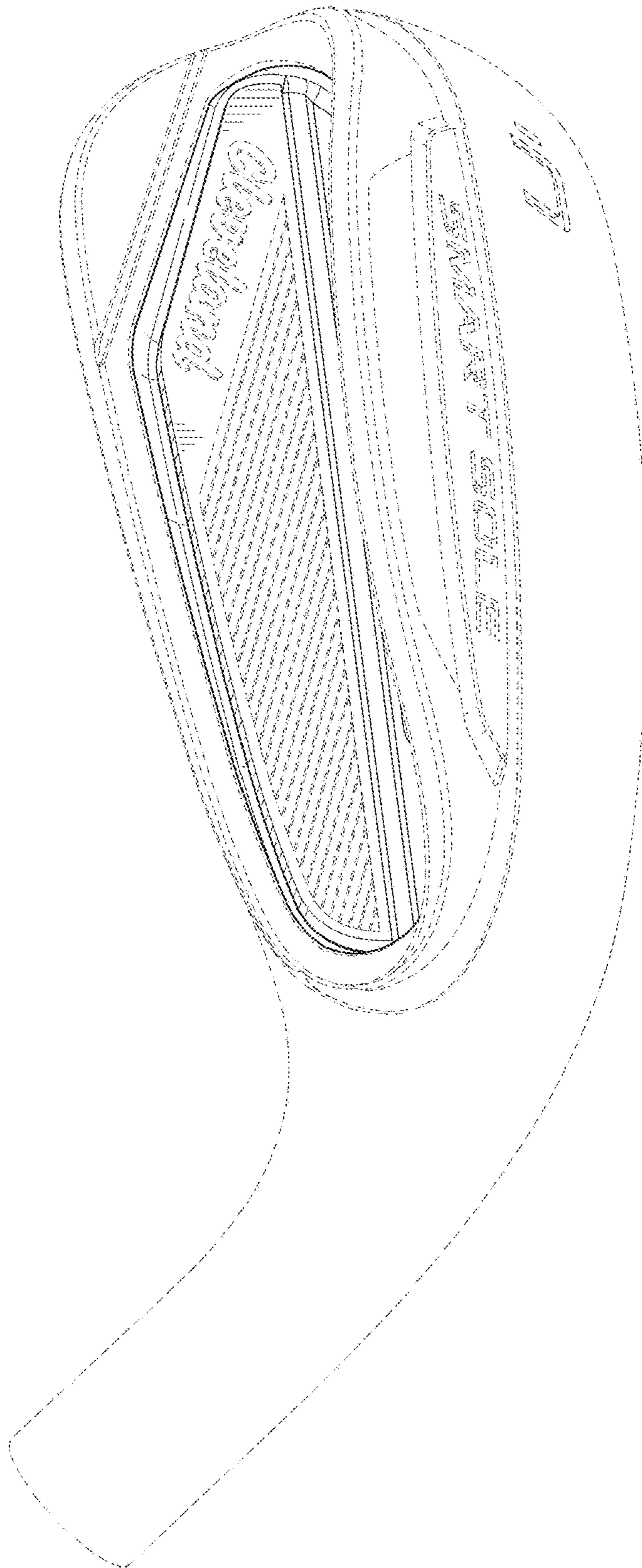

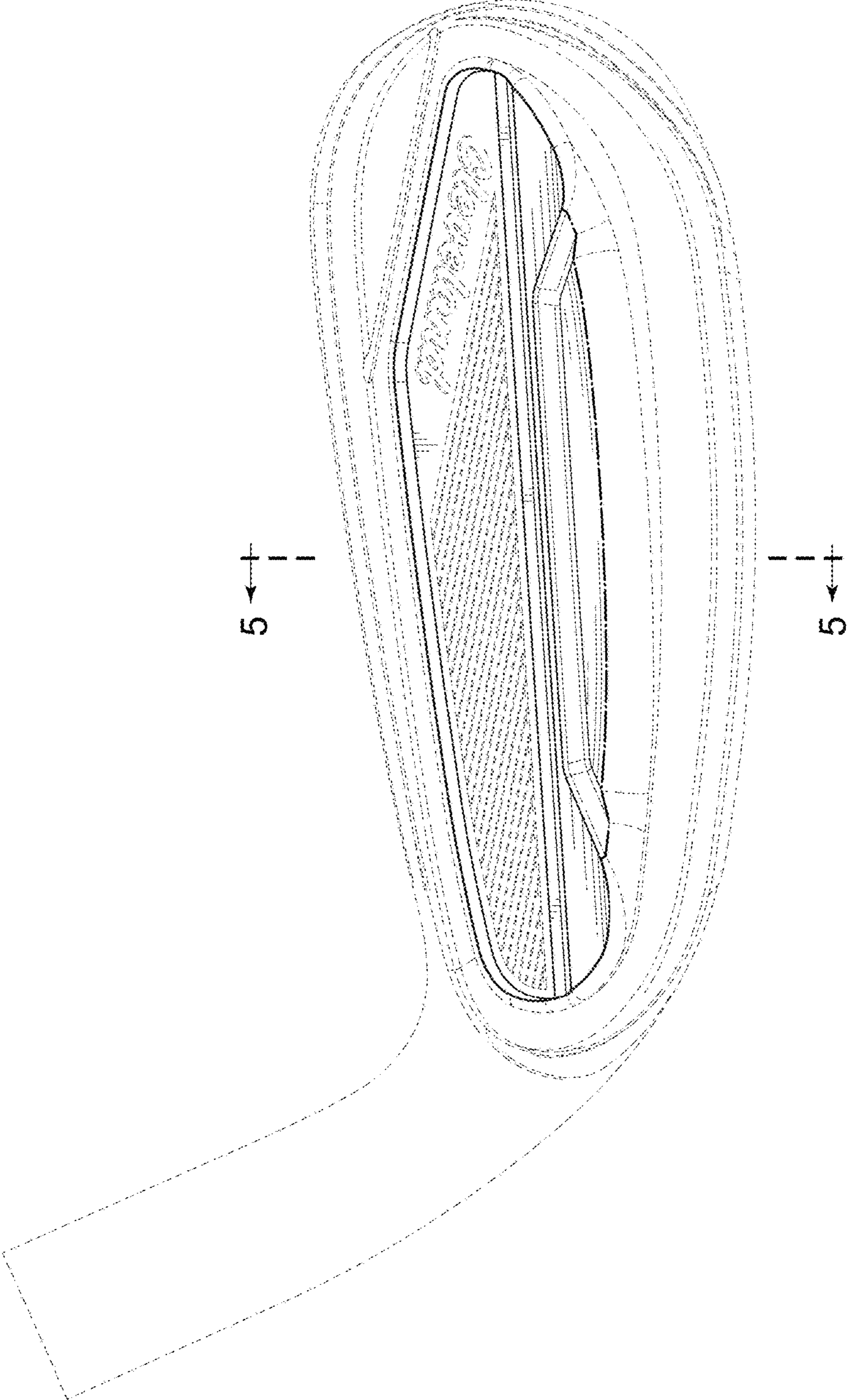

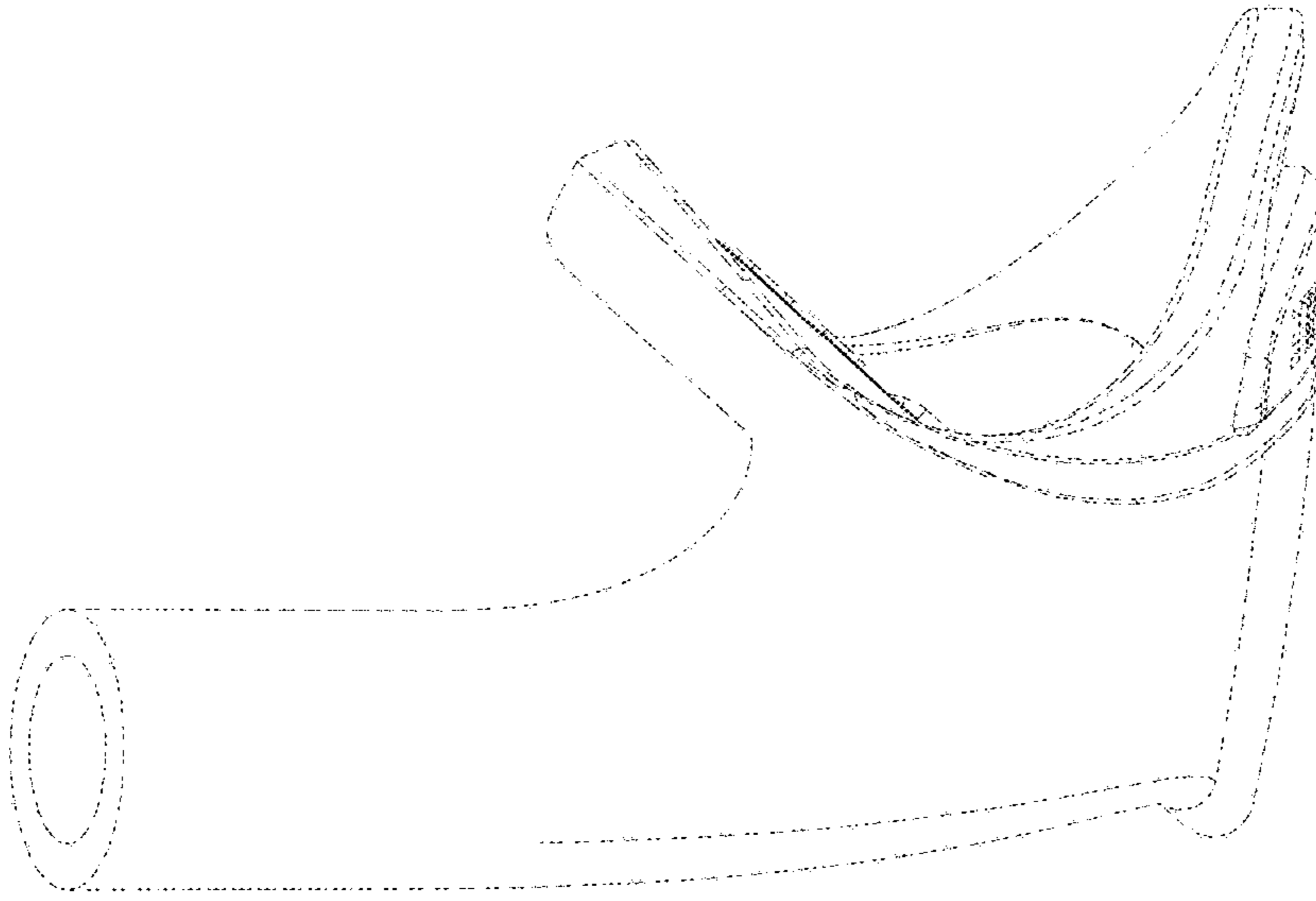

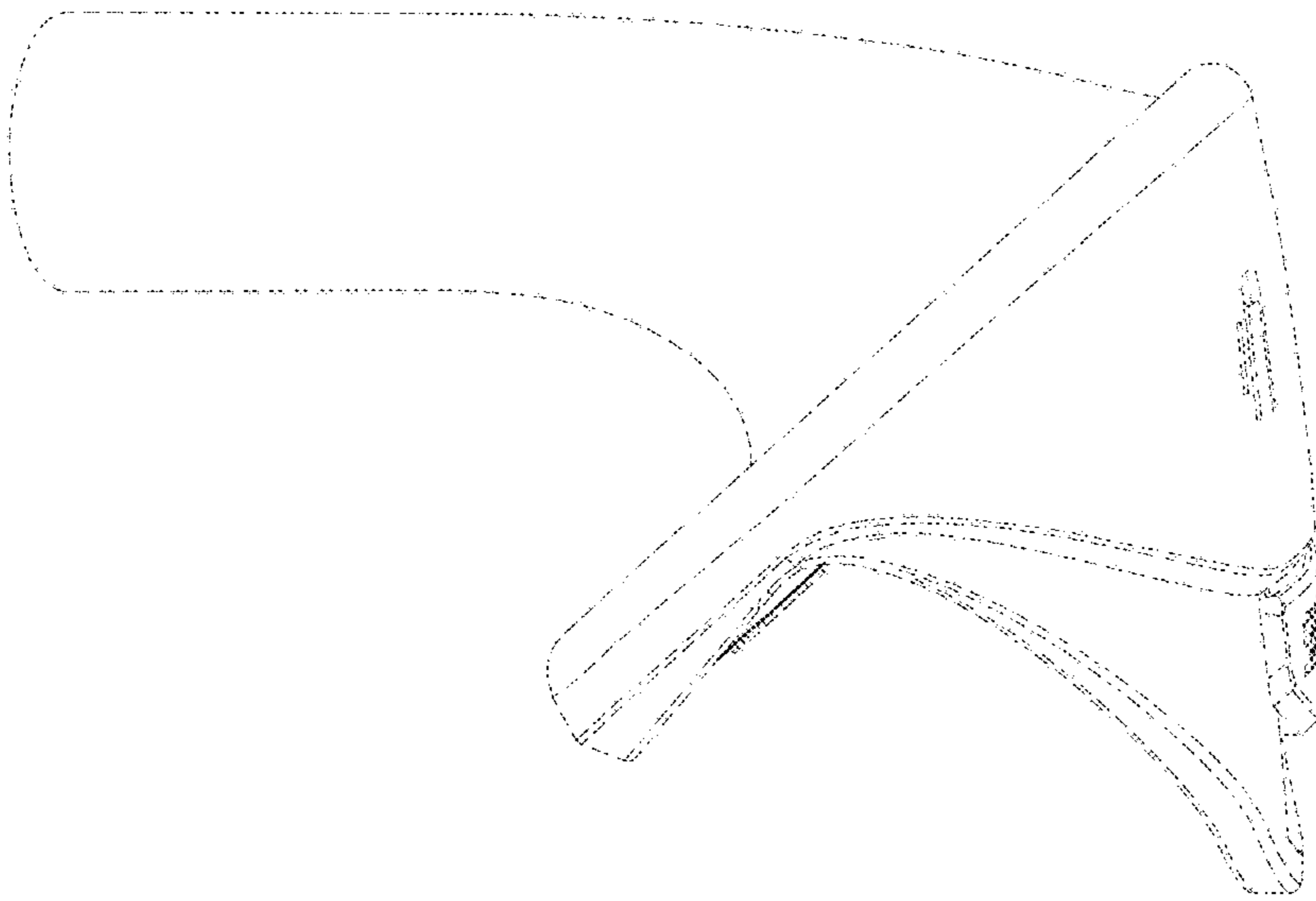

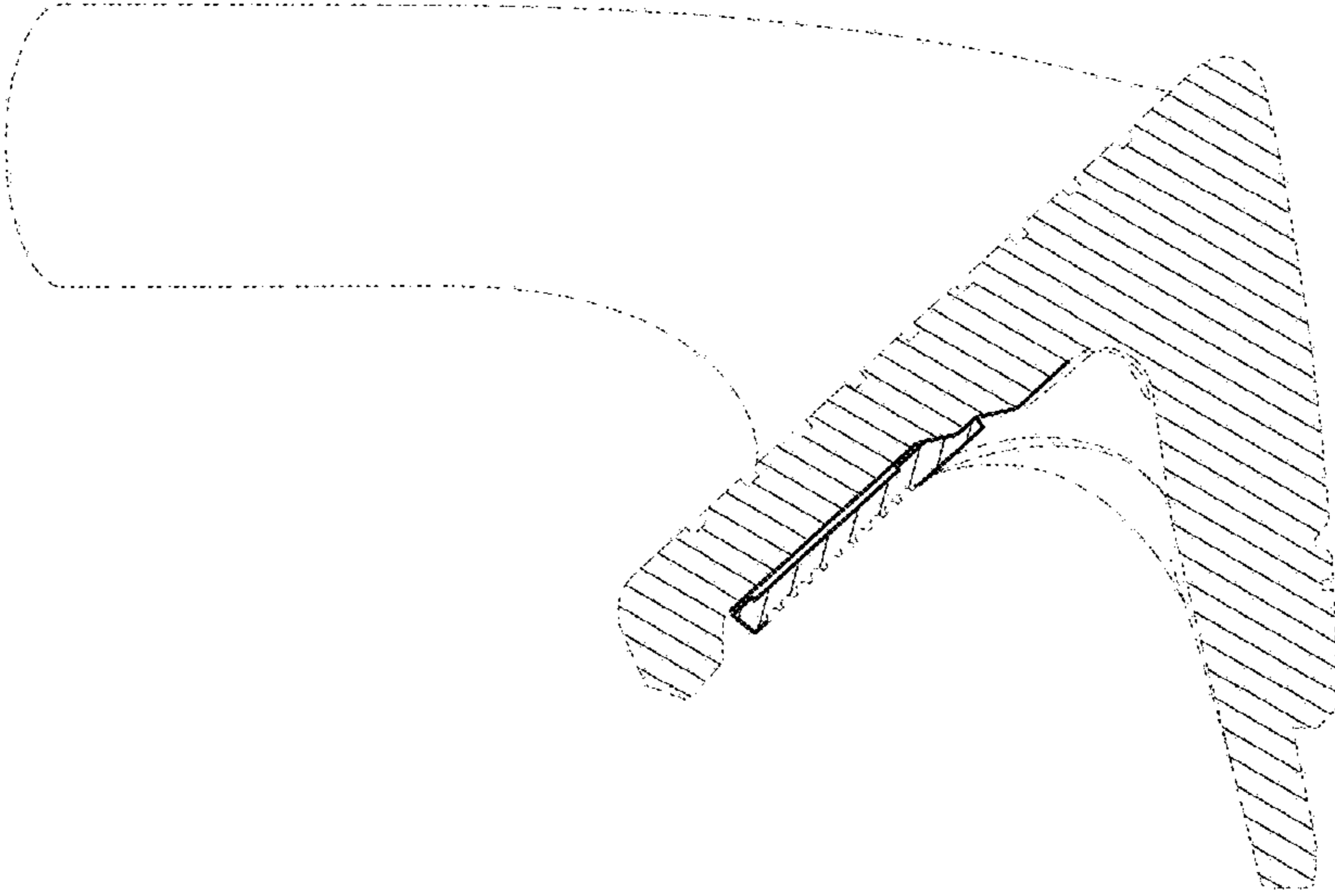
