(57) **CLAIM**

The ornamental design for a sports theme air freshener, as shown and described.

DESCRIPTION

FIG. 1 is a front, top, and right side perspective view of a sports theme air freshener in accordance with the present disclosure;

FIG. 2 is a front elevation view thereof;

FIG. 3 is a rear elevation view thereof;

FIG. 4 is a right side elevation view thereof;

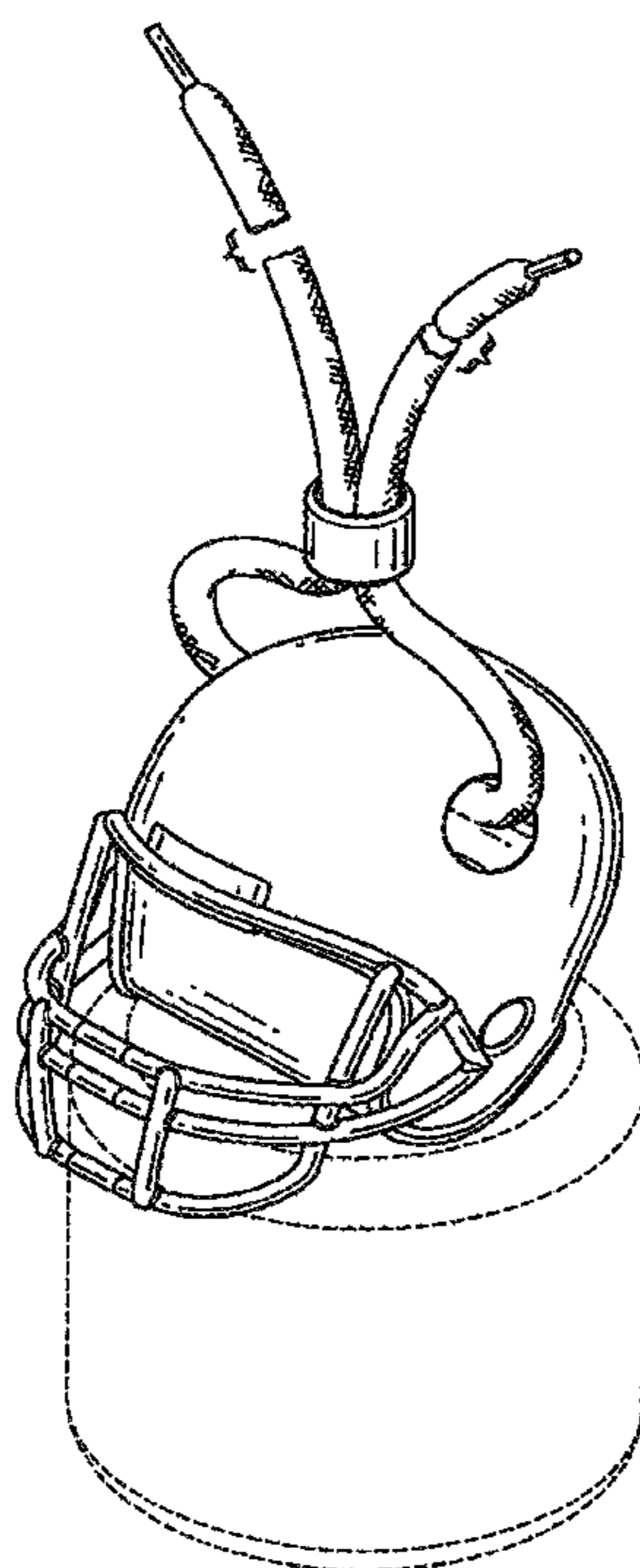
FIG. 5 is a left side elevation view thereof;

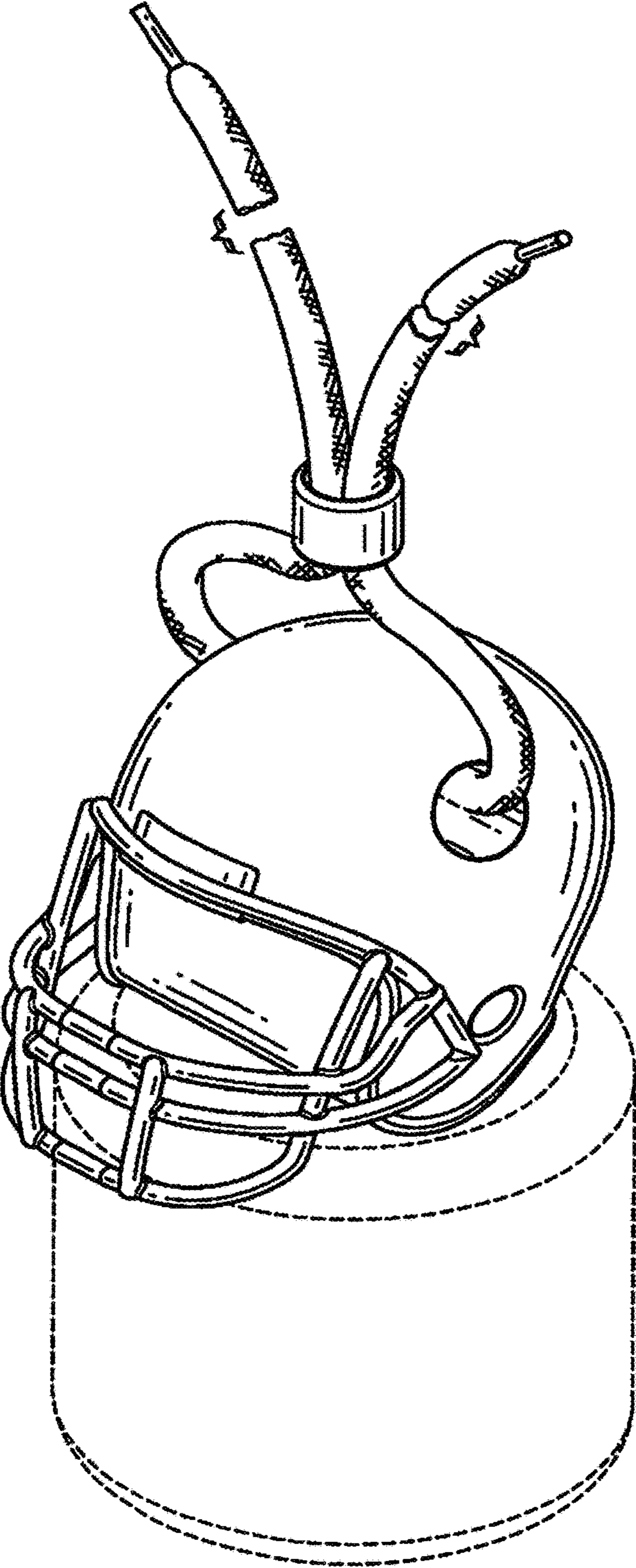

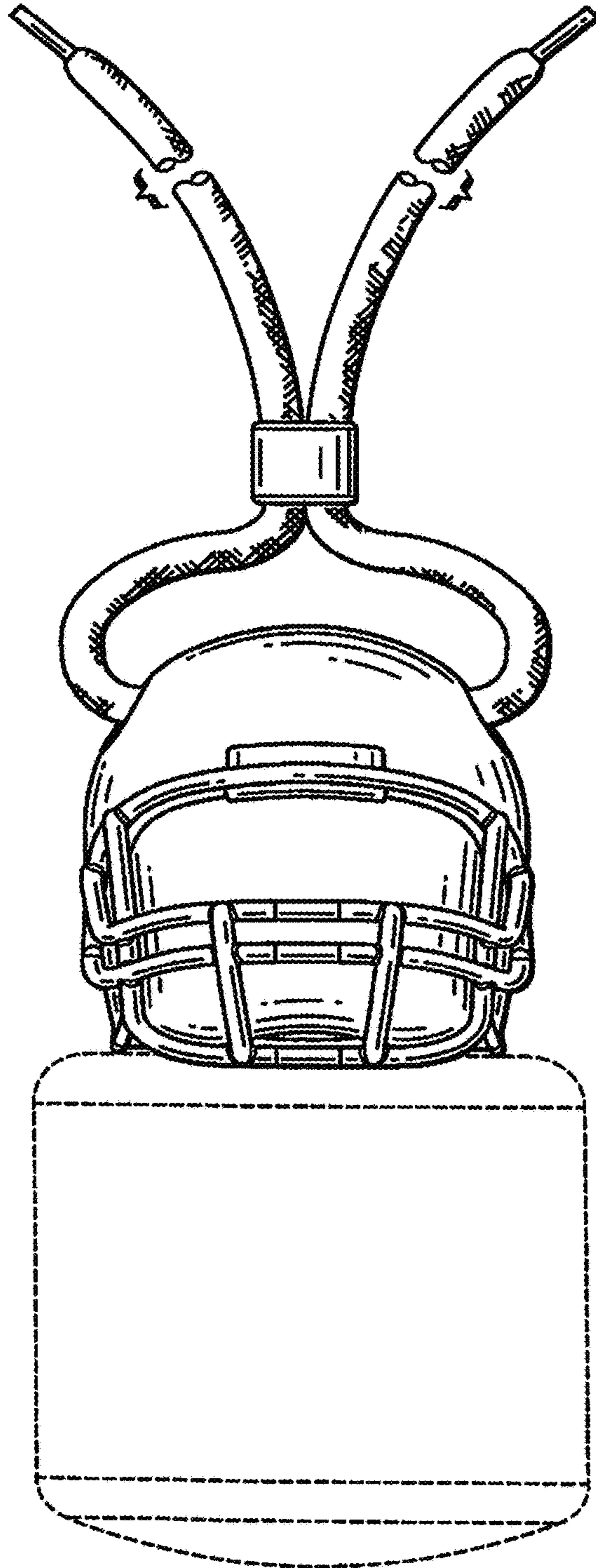

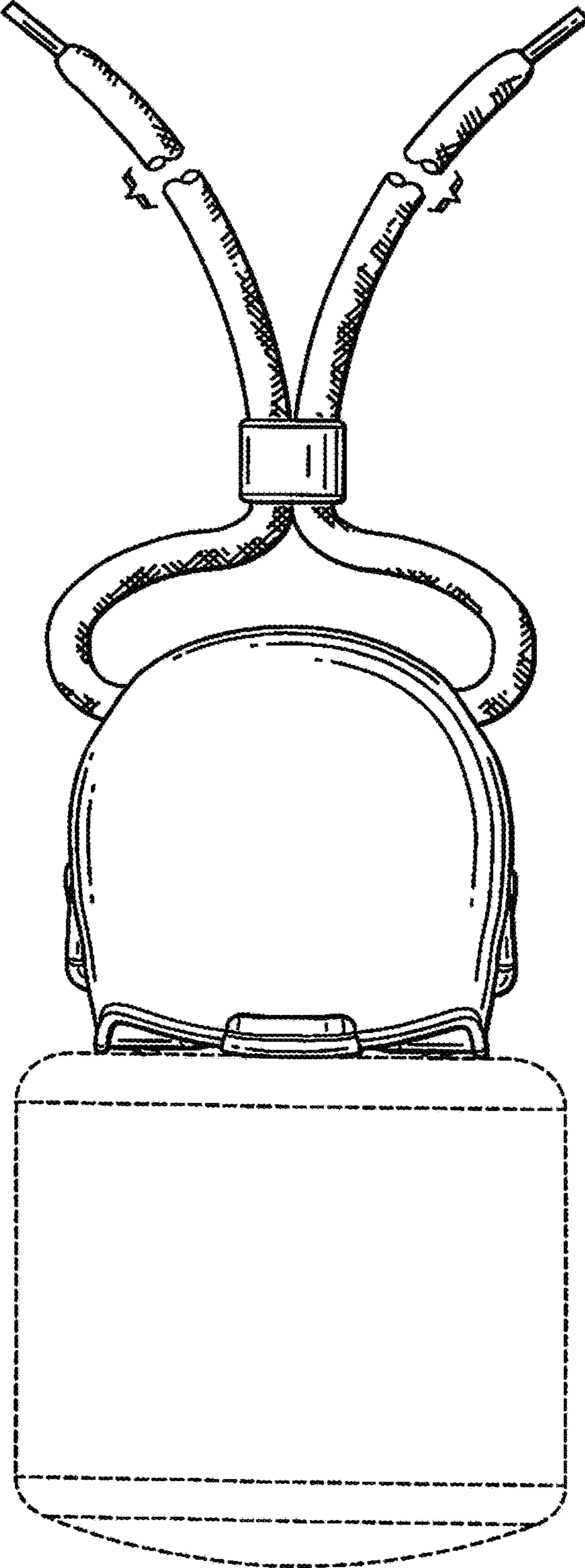

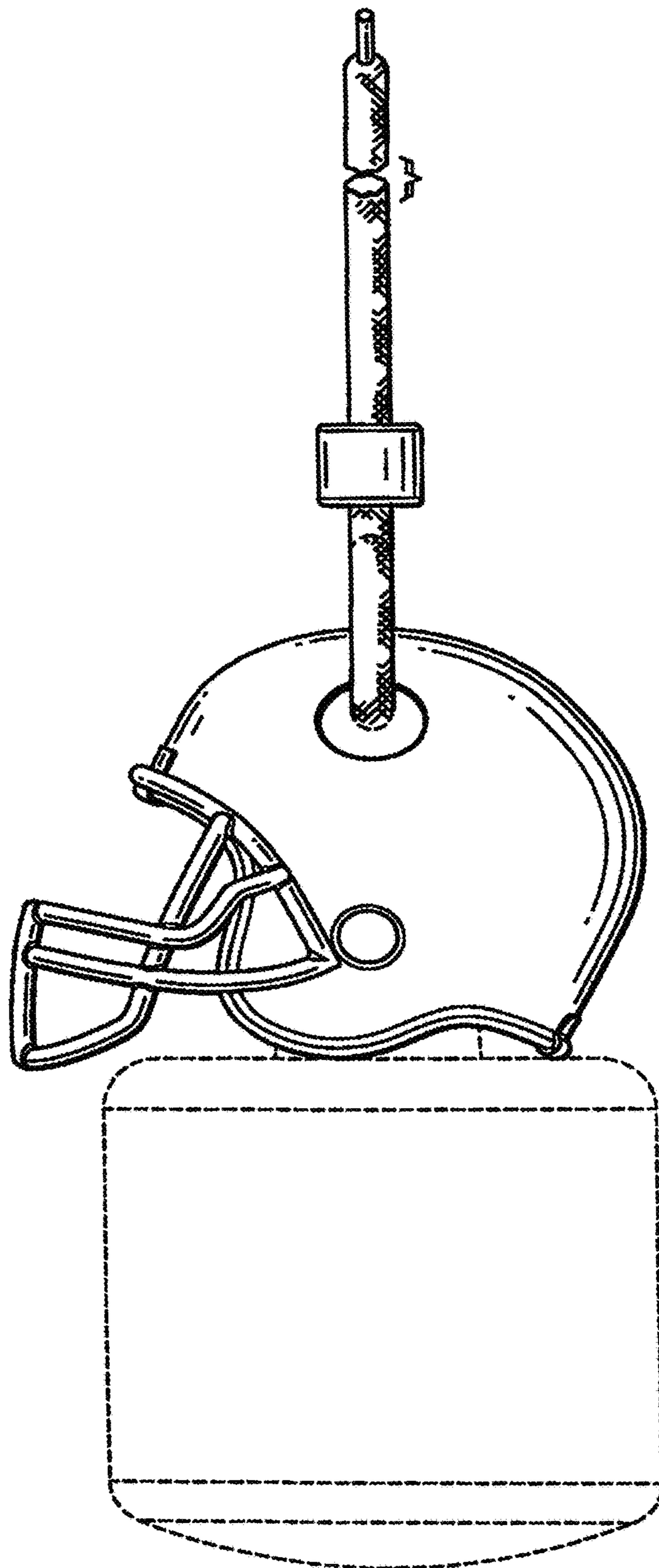

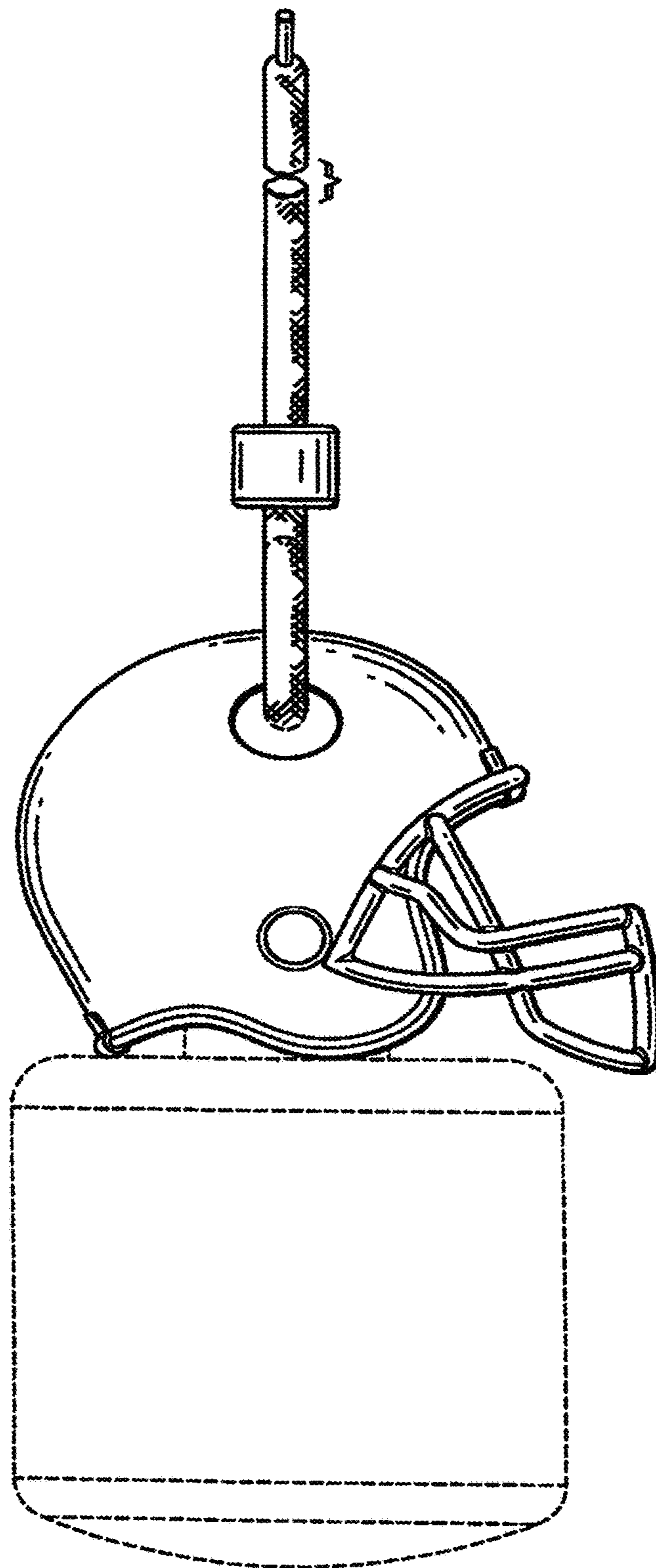

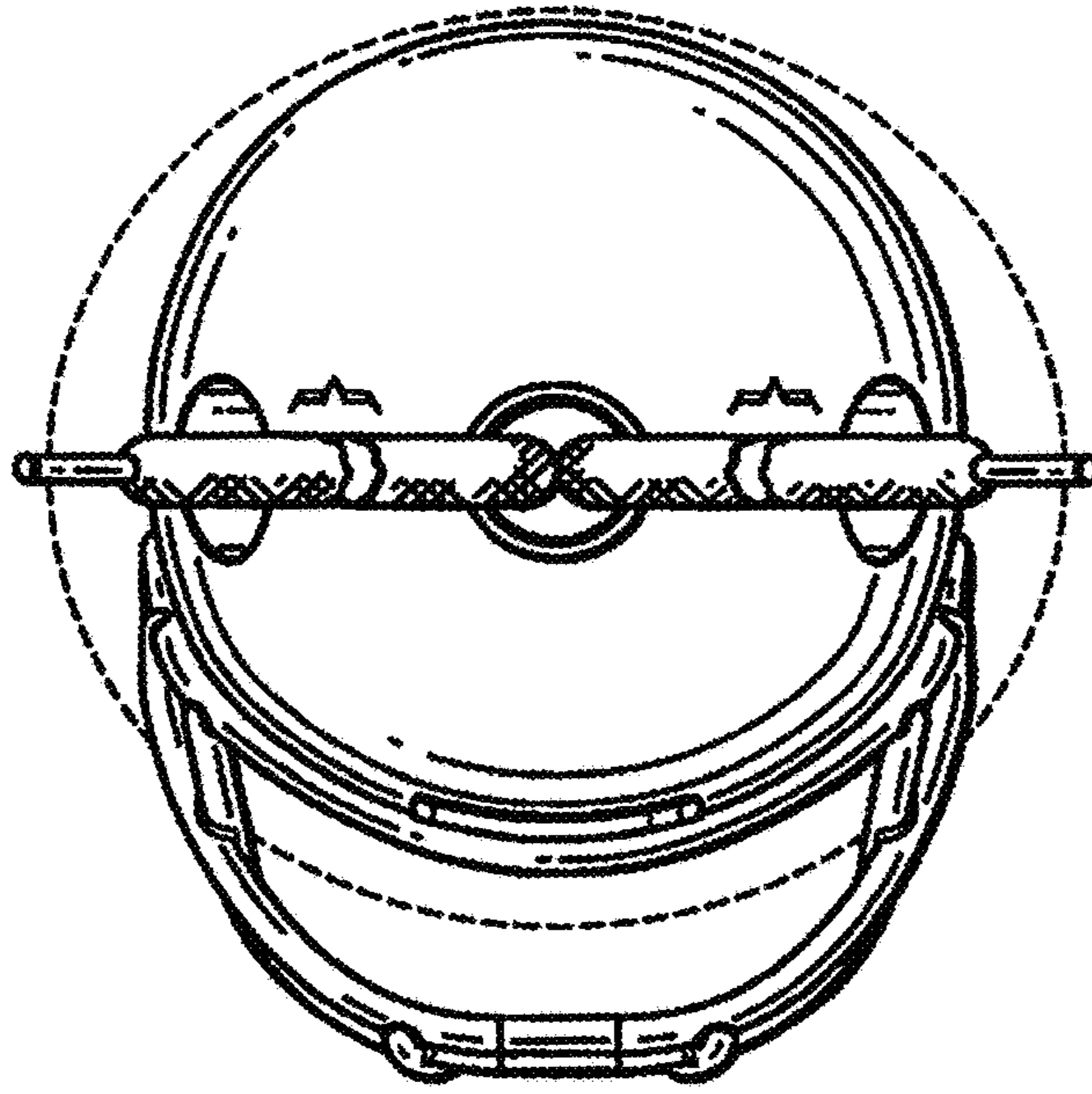

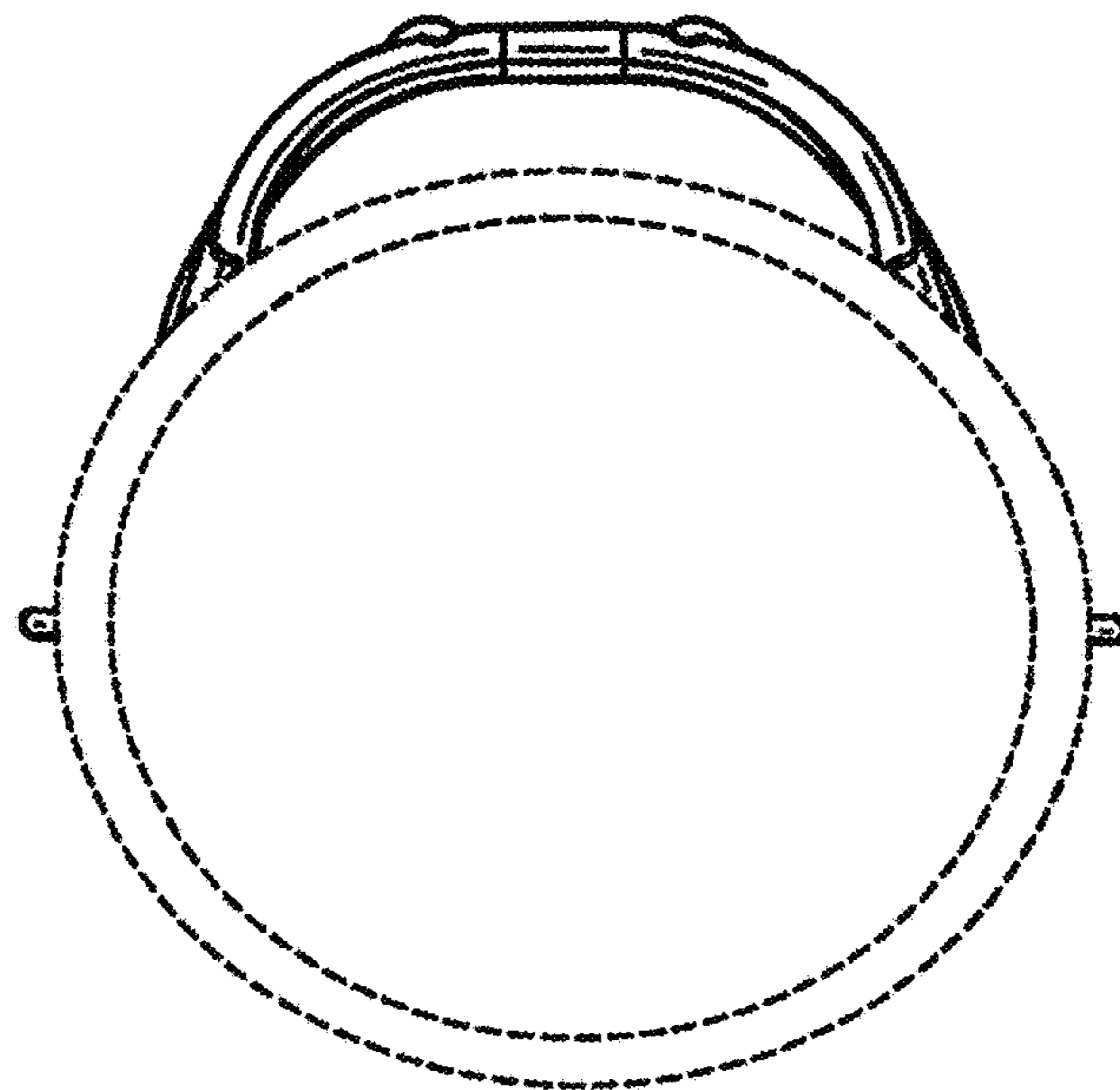
