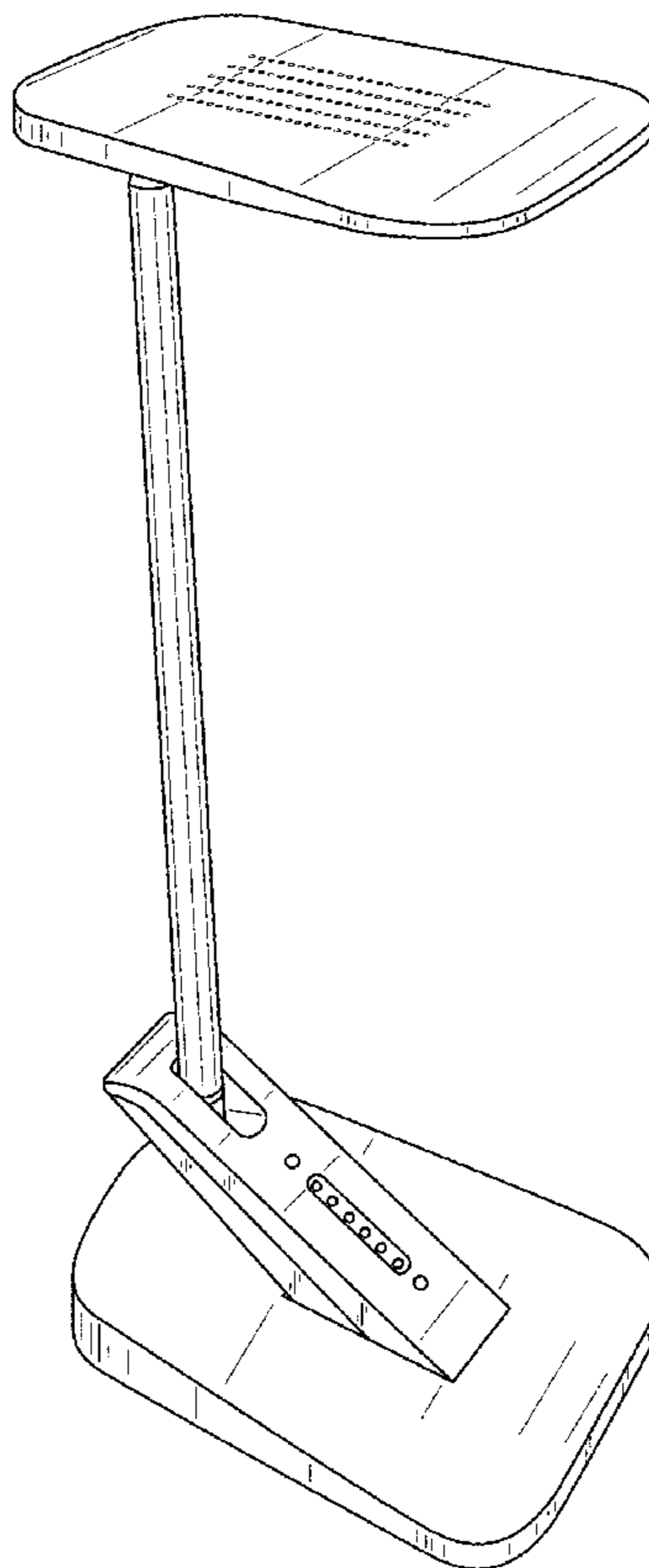
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a left perspective view of an LED lamp showing my design;
FIG. 2 is a front view of the LED lamp of FIG. 1;

FIG. 4 is a left side view of the LED lamp of FIG. 1;

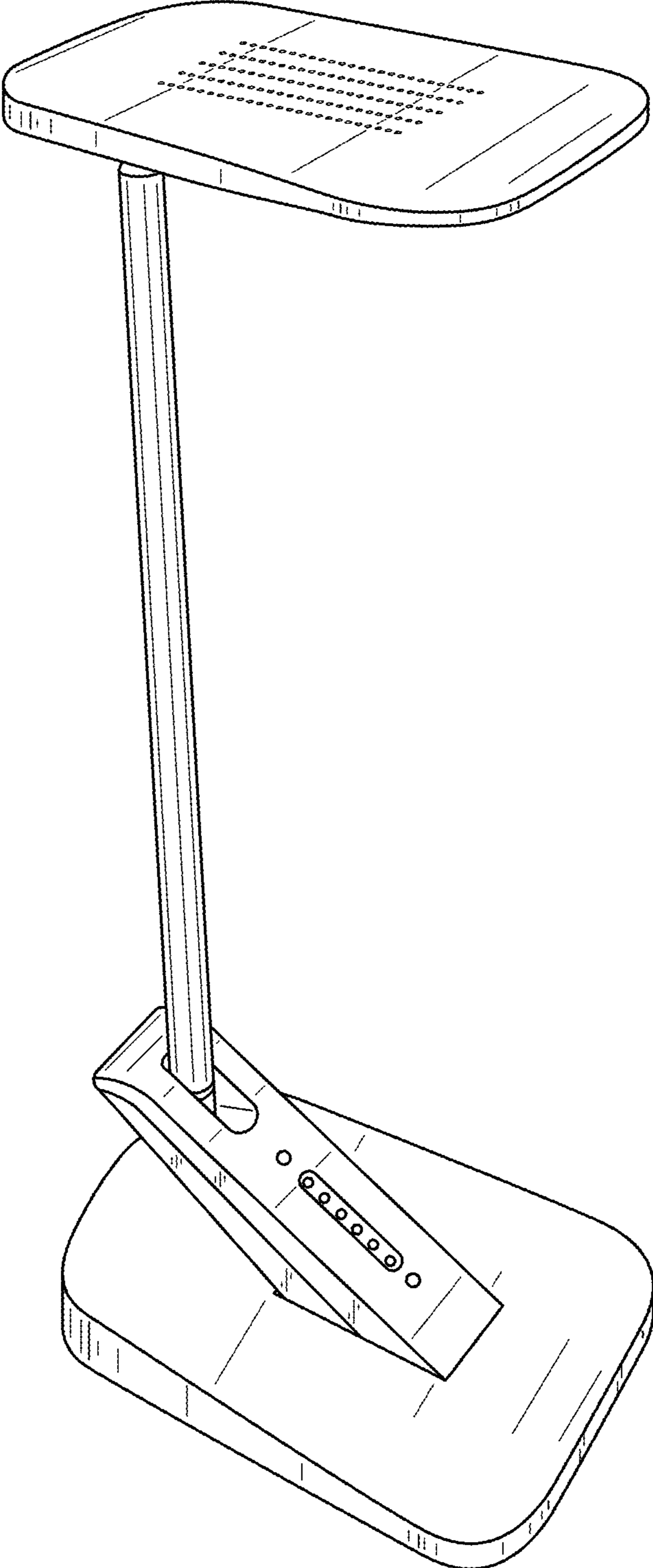

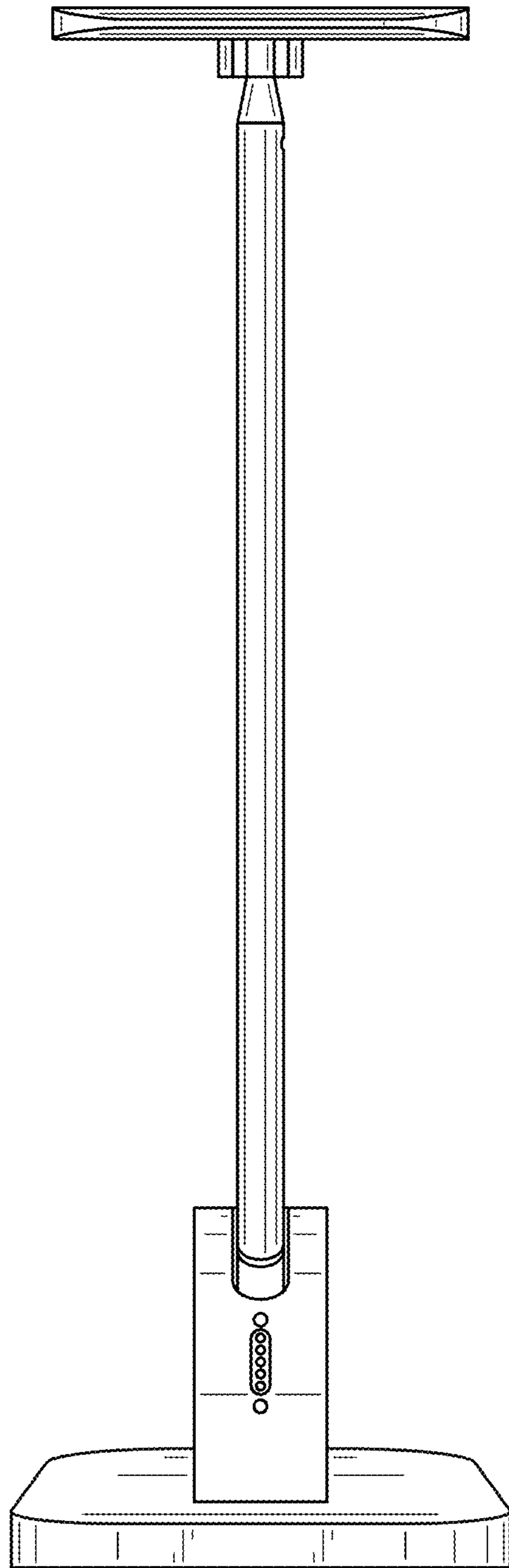

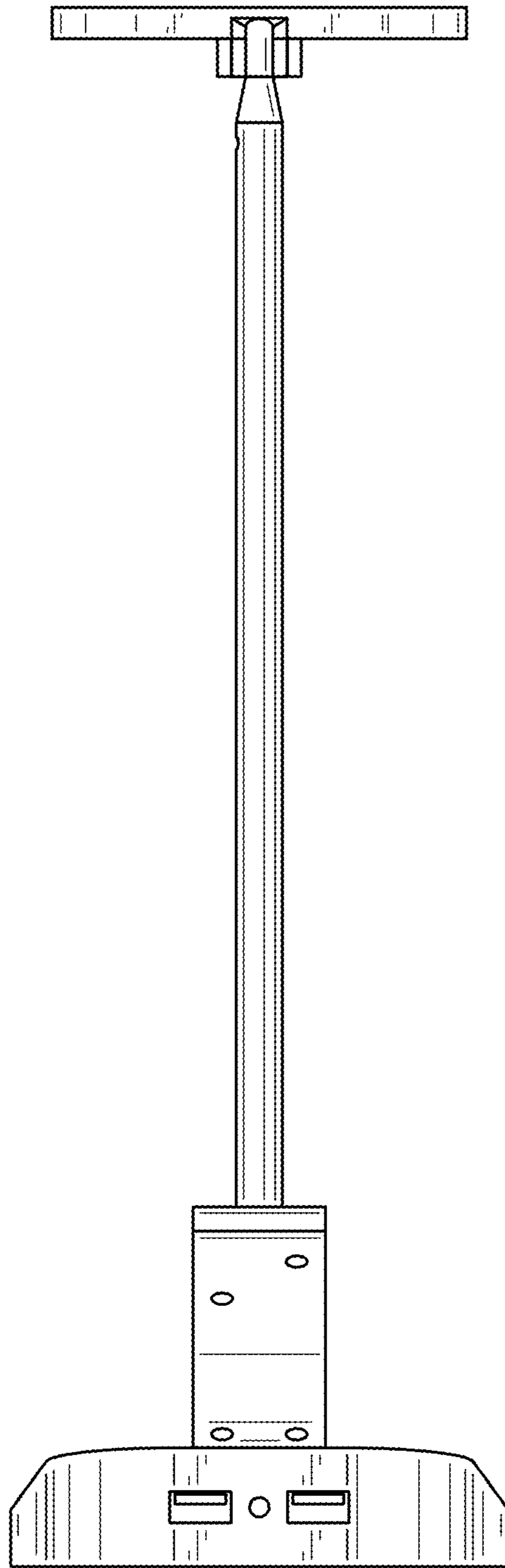

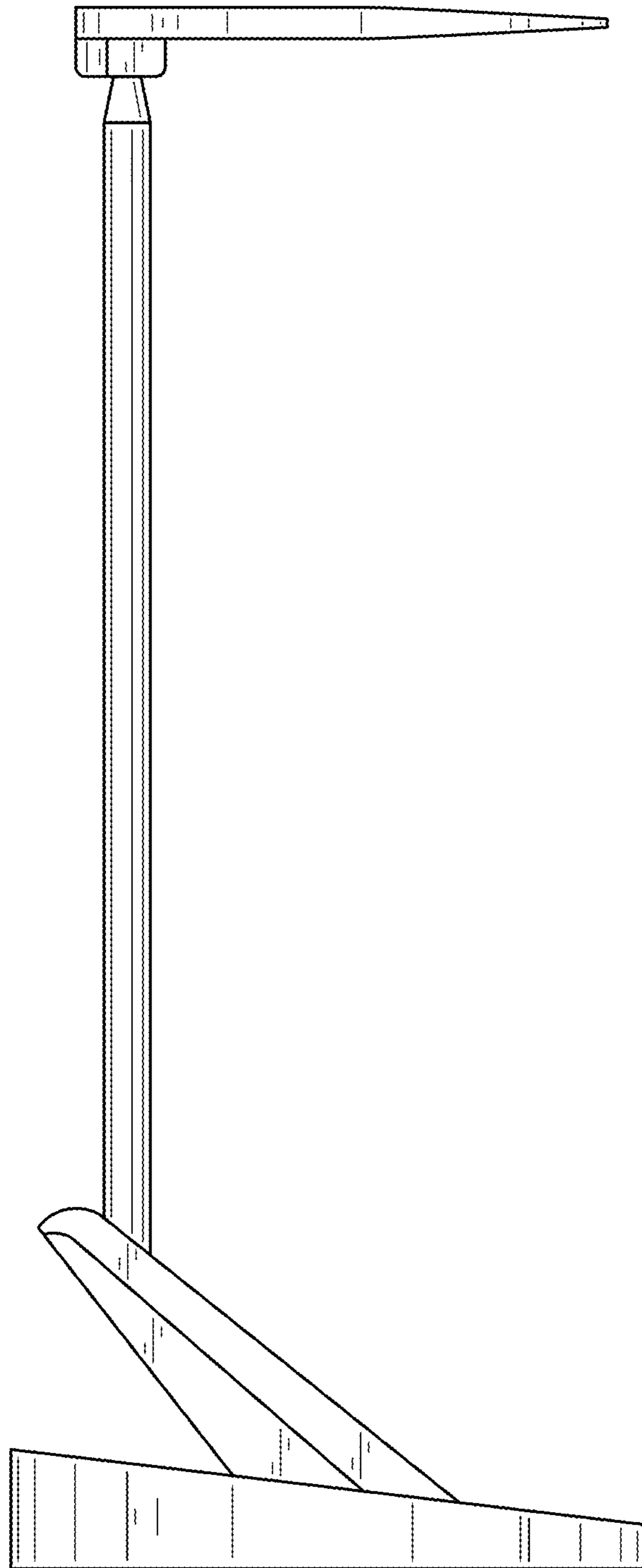

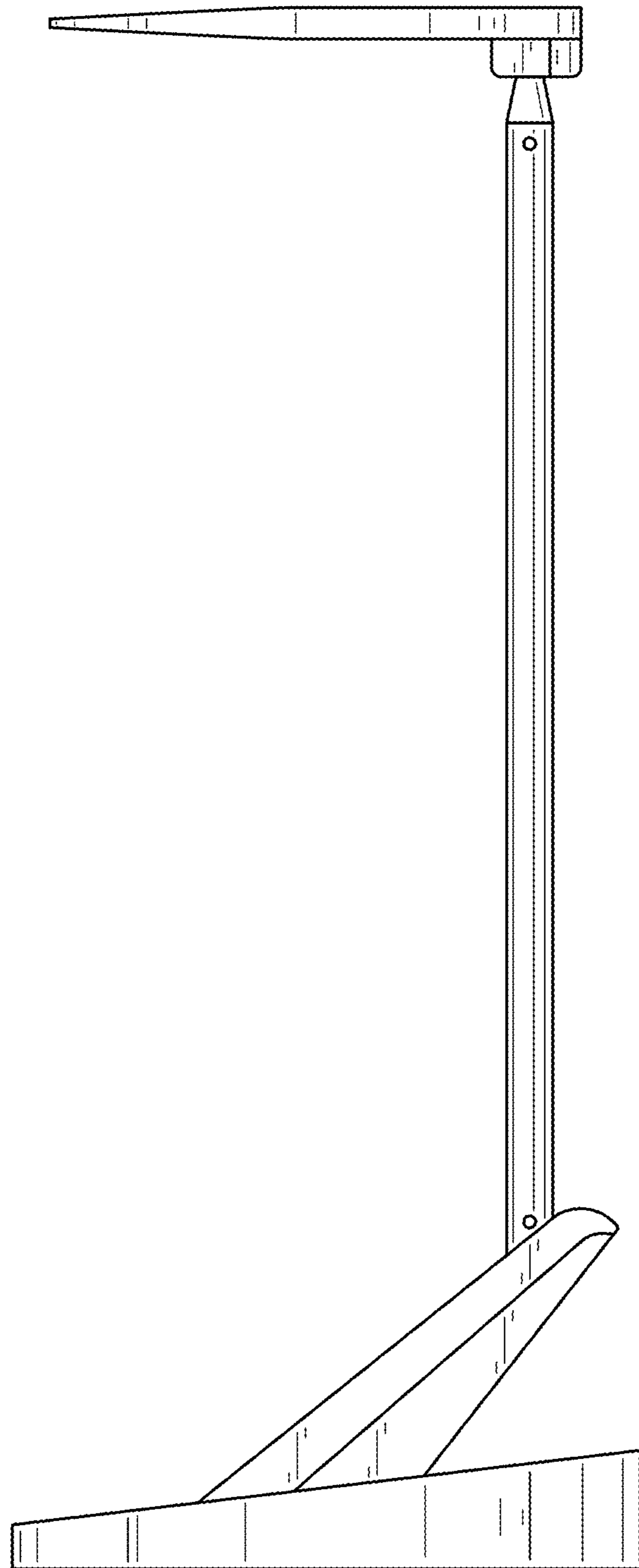

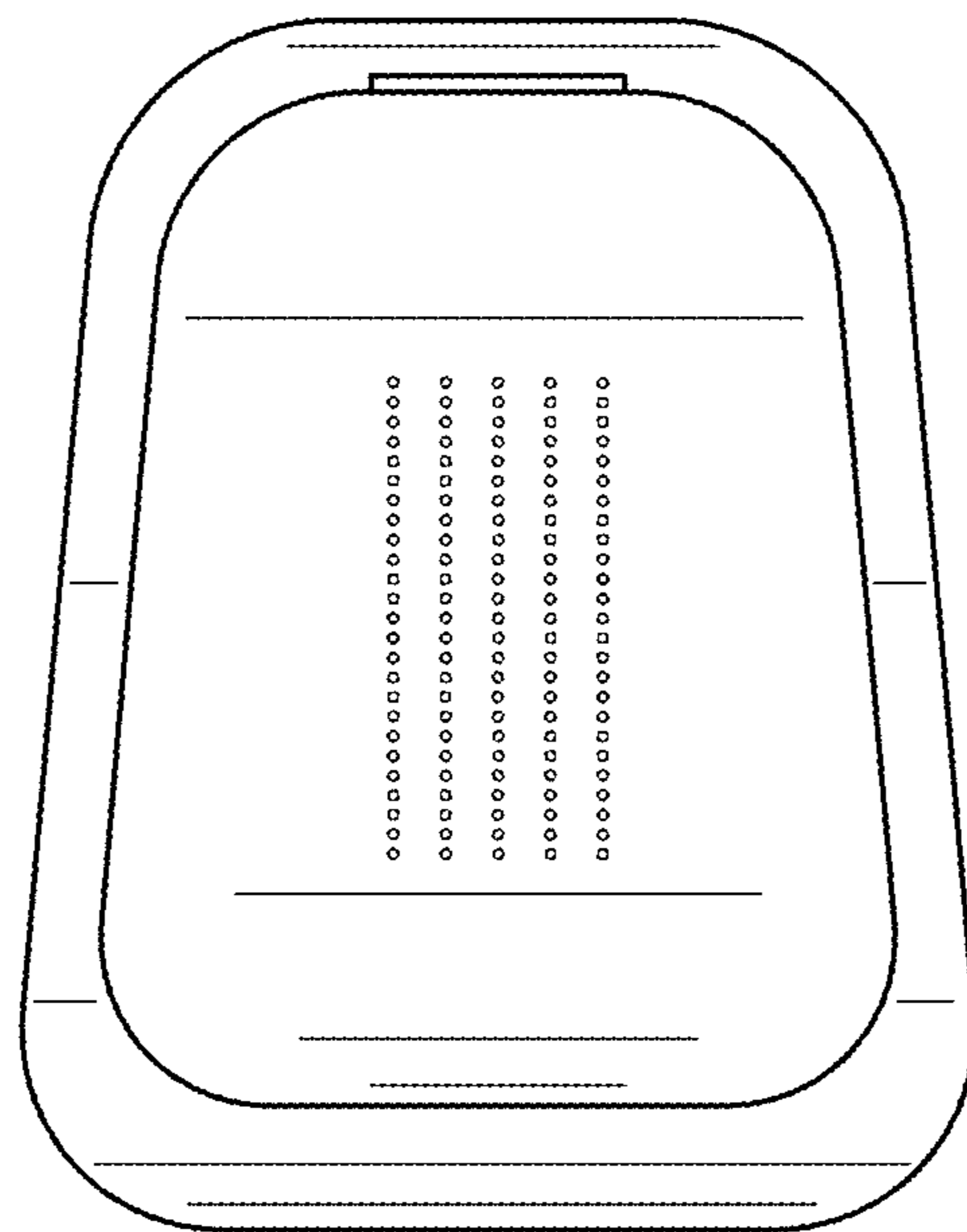

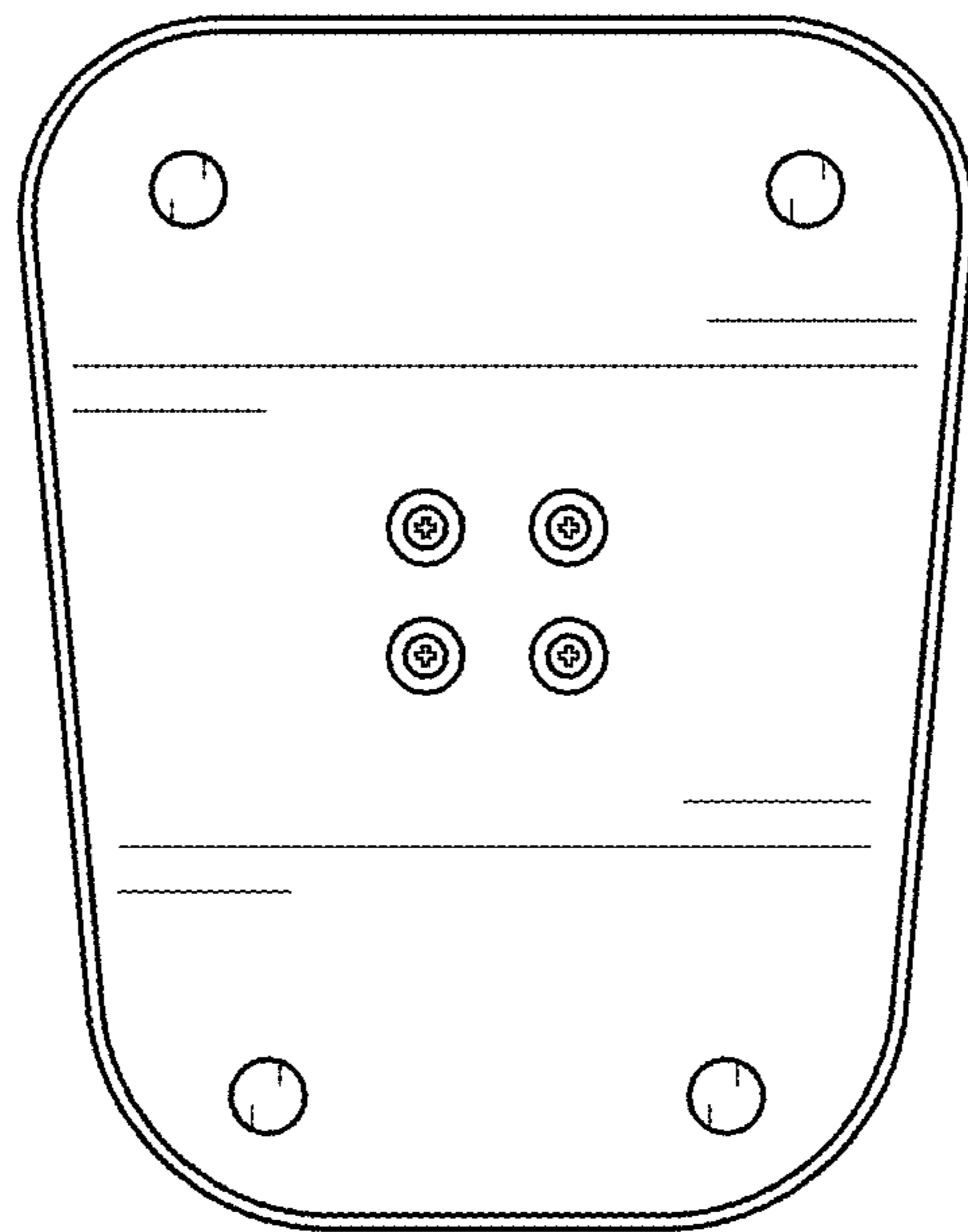

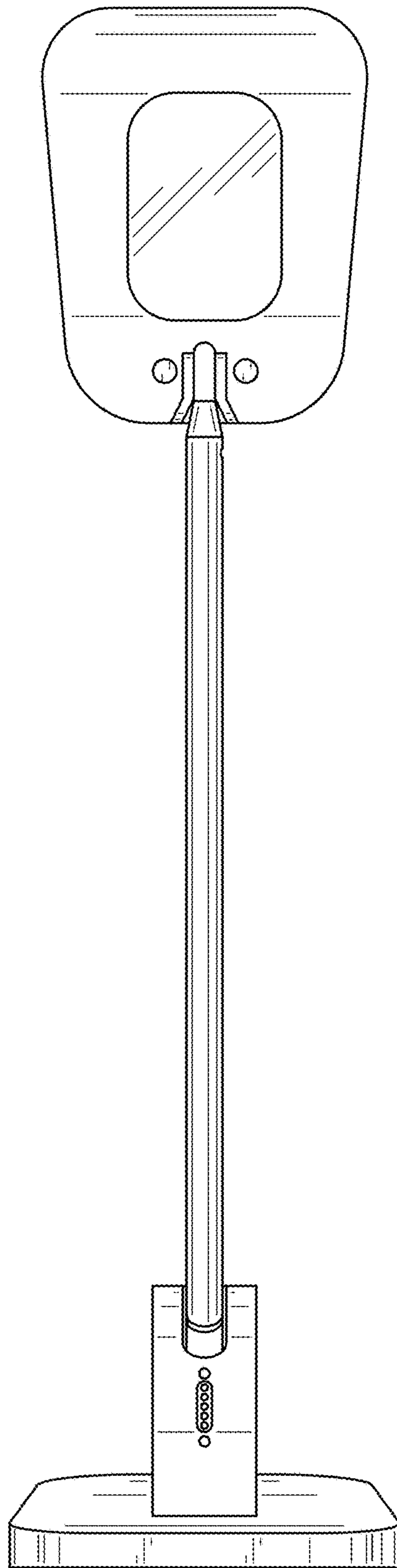

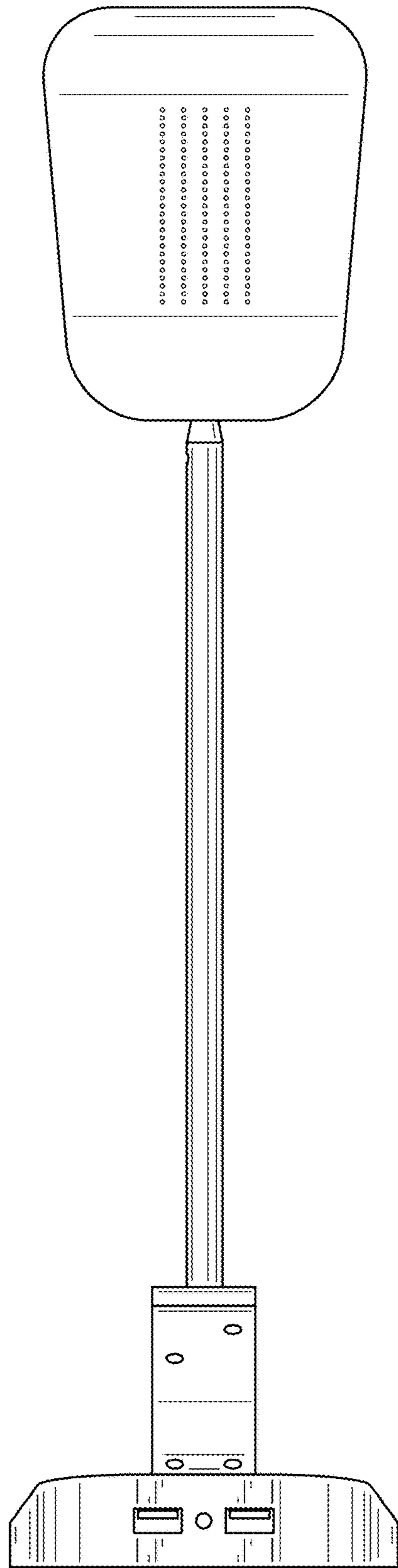
