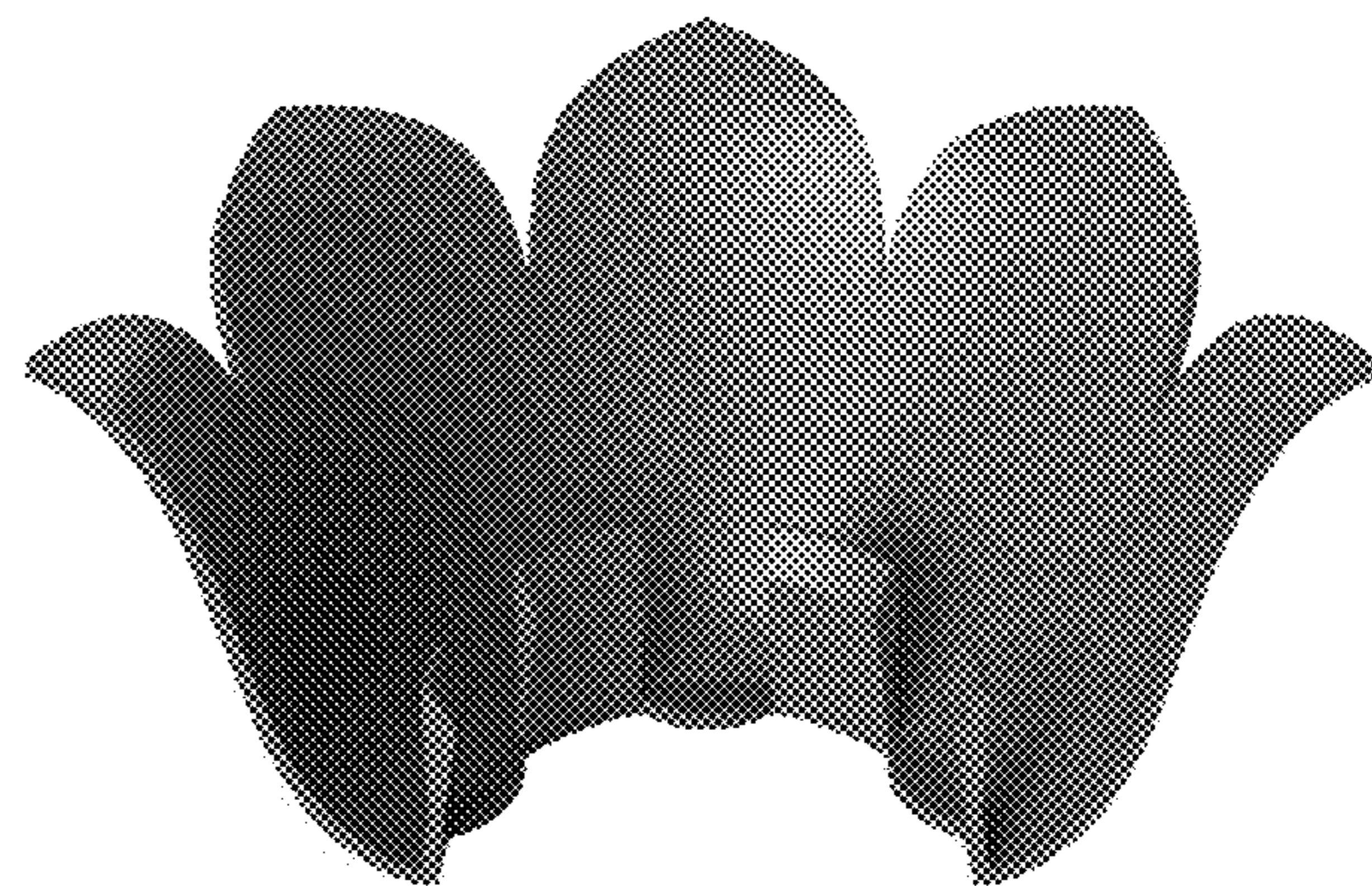
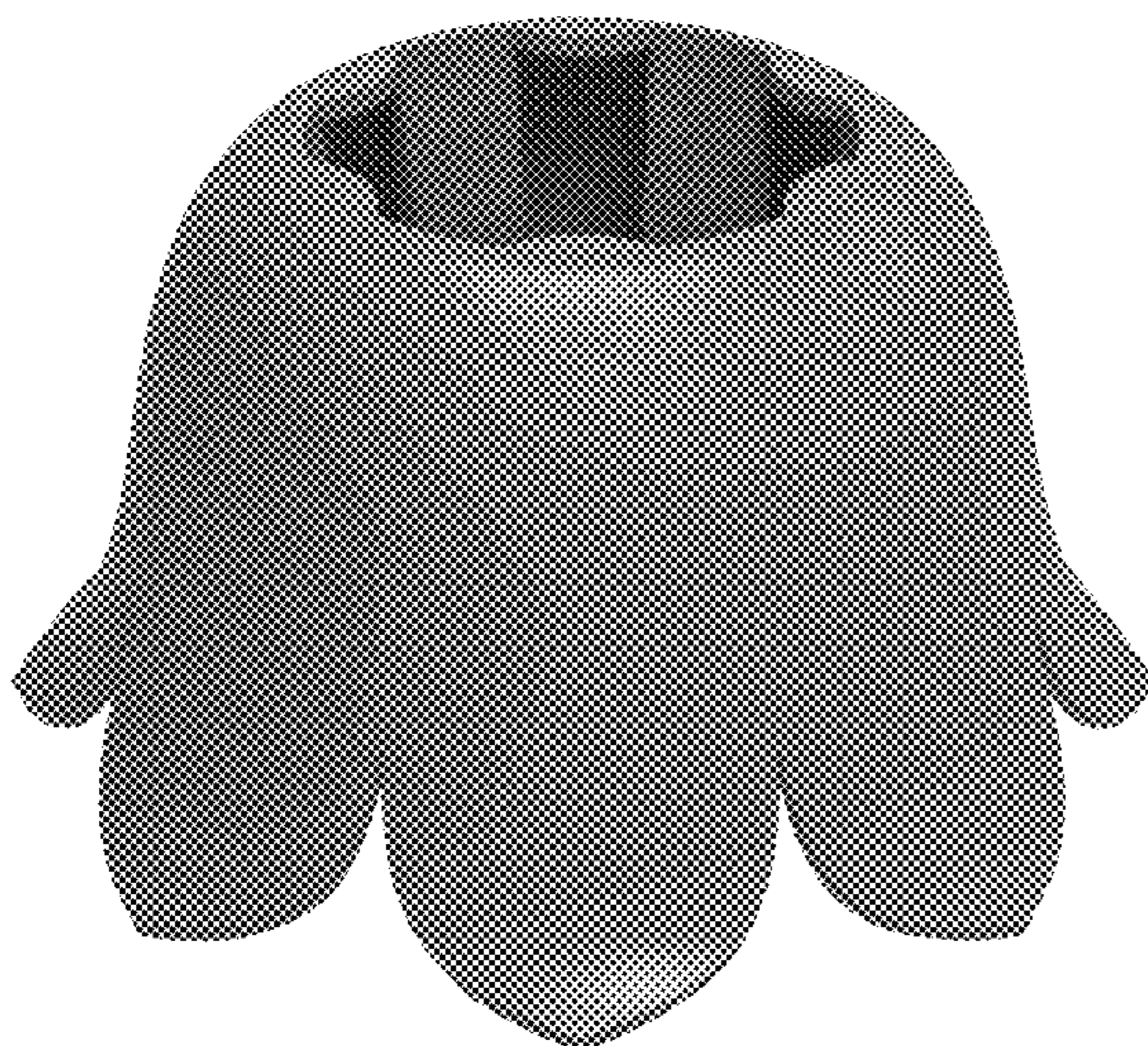
(57) **CLAIM**

DESCRIPTION

FIG. 1 is the 1st perspective view of cover for lamp holder, showing our new design;

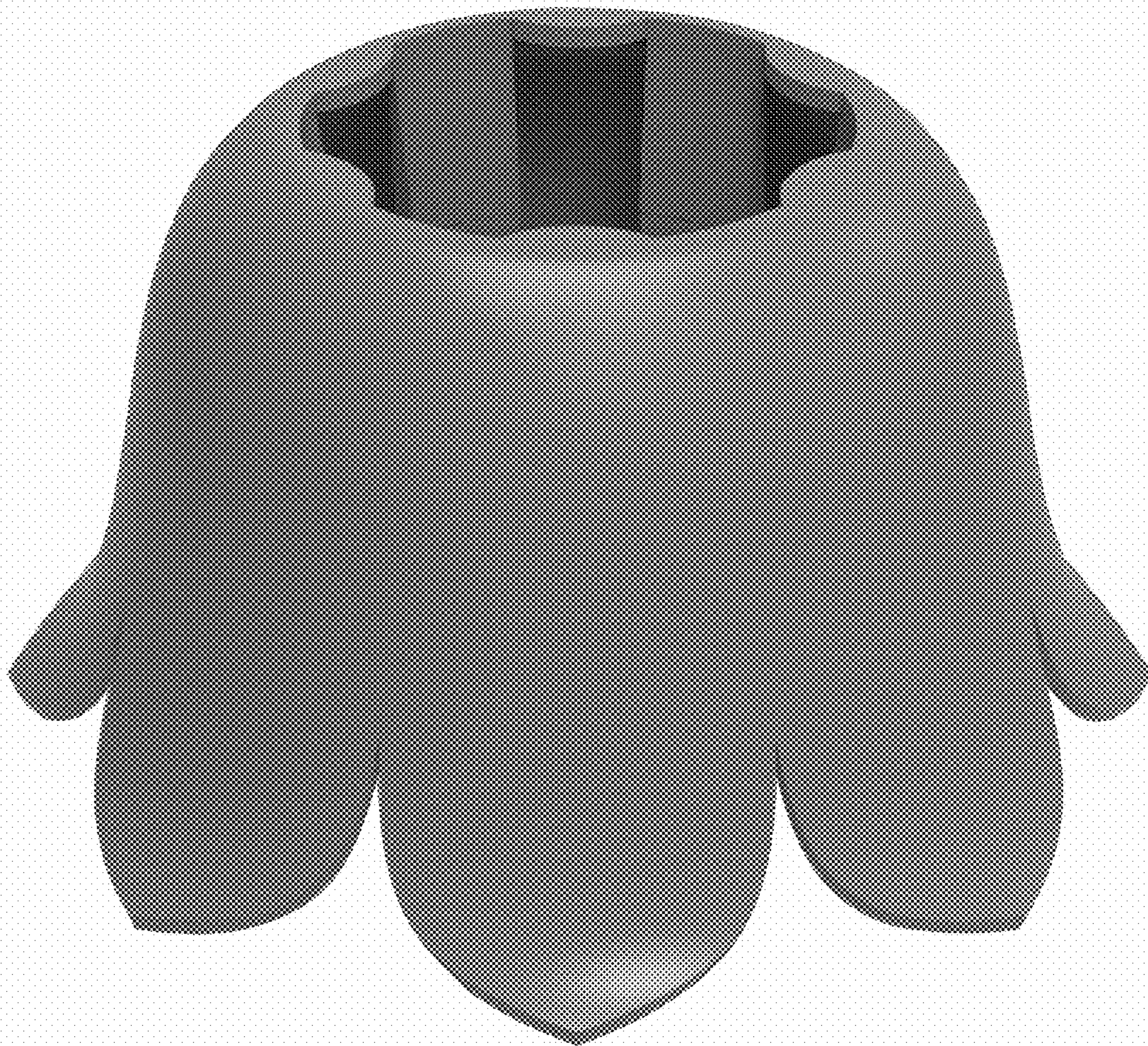

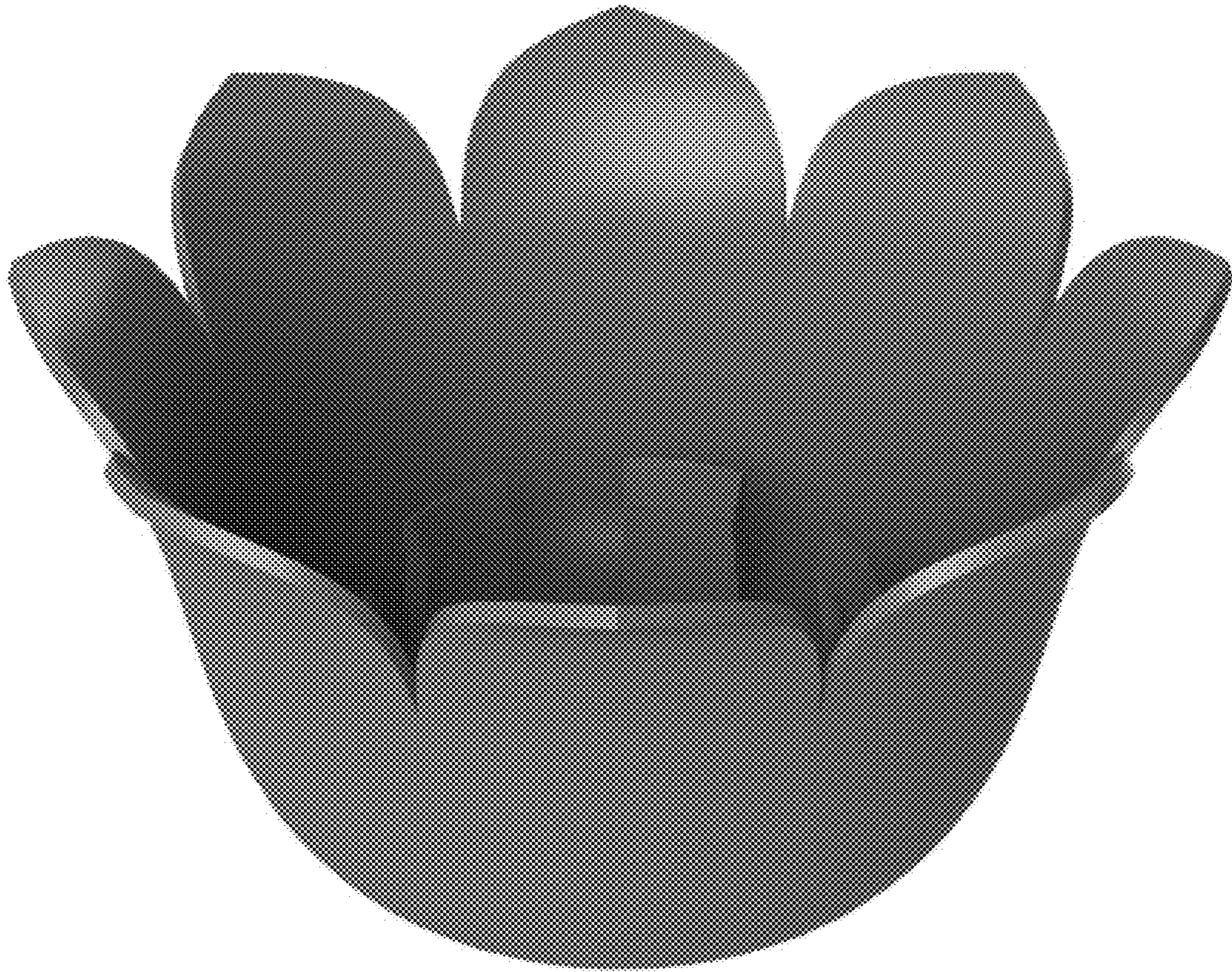

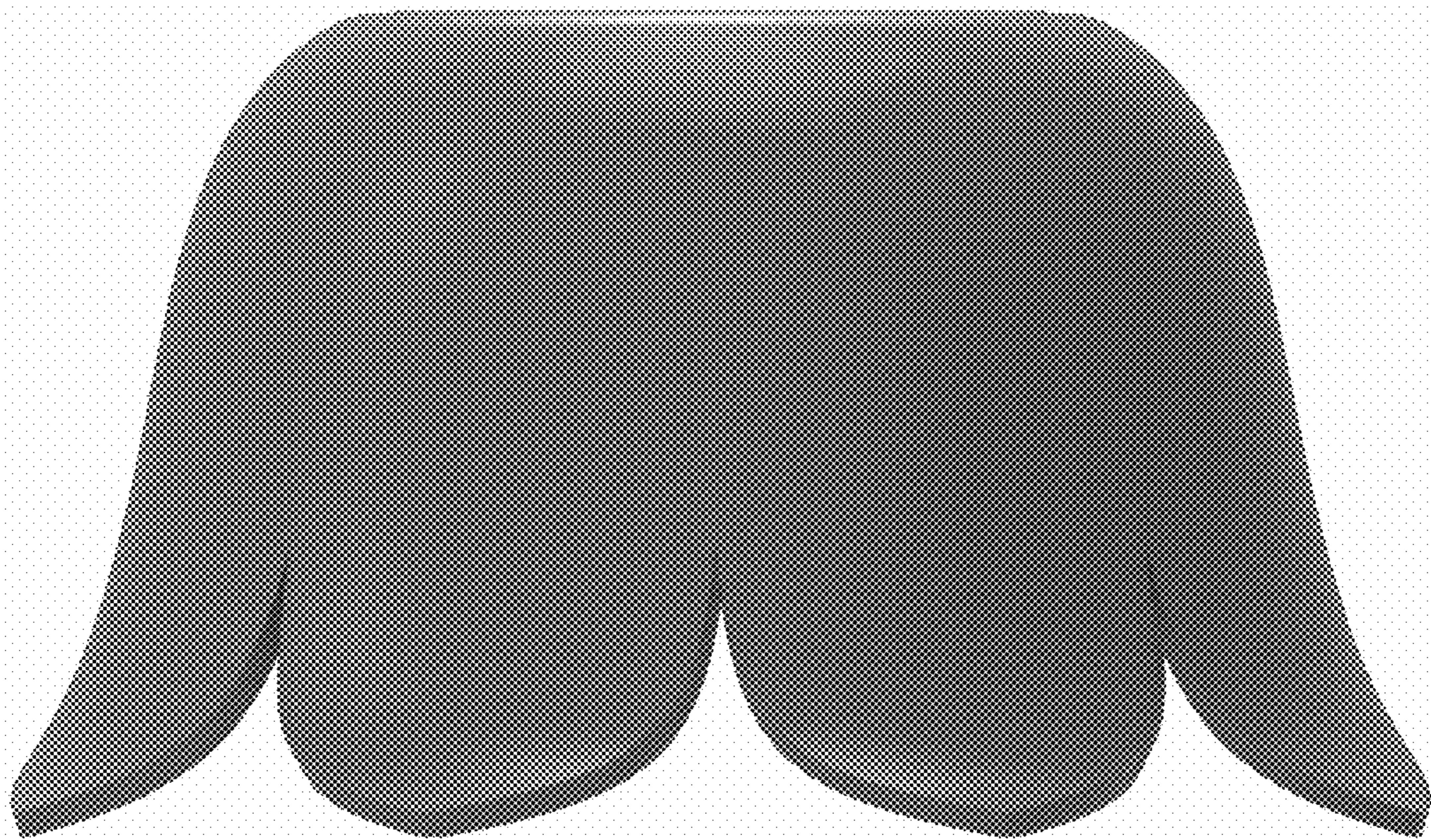

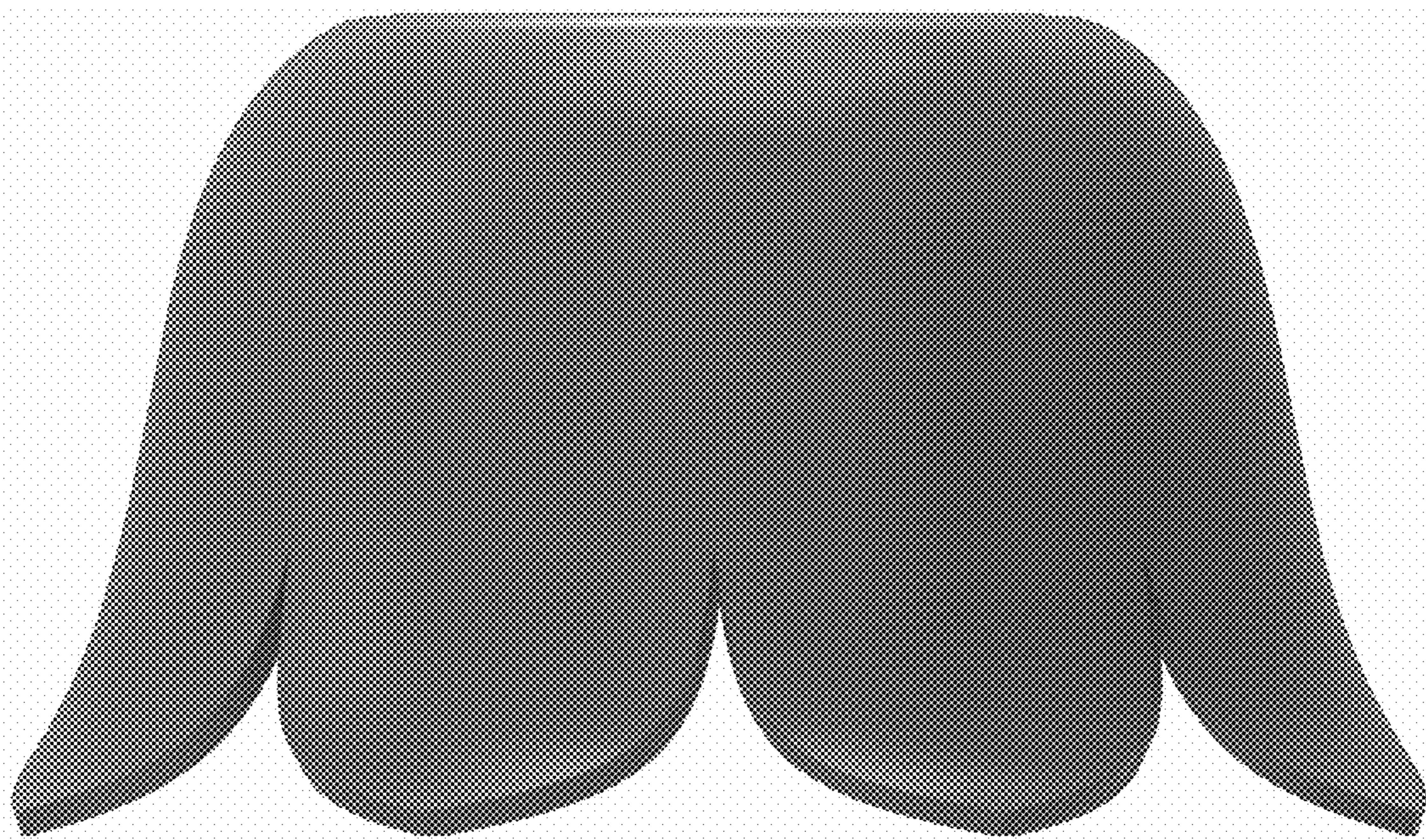

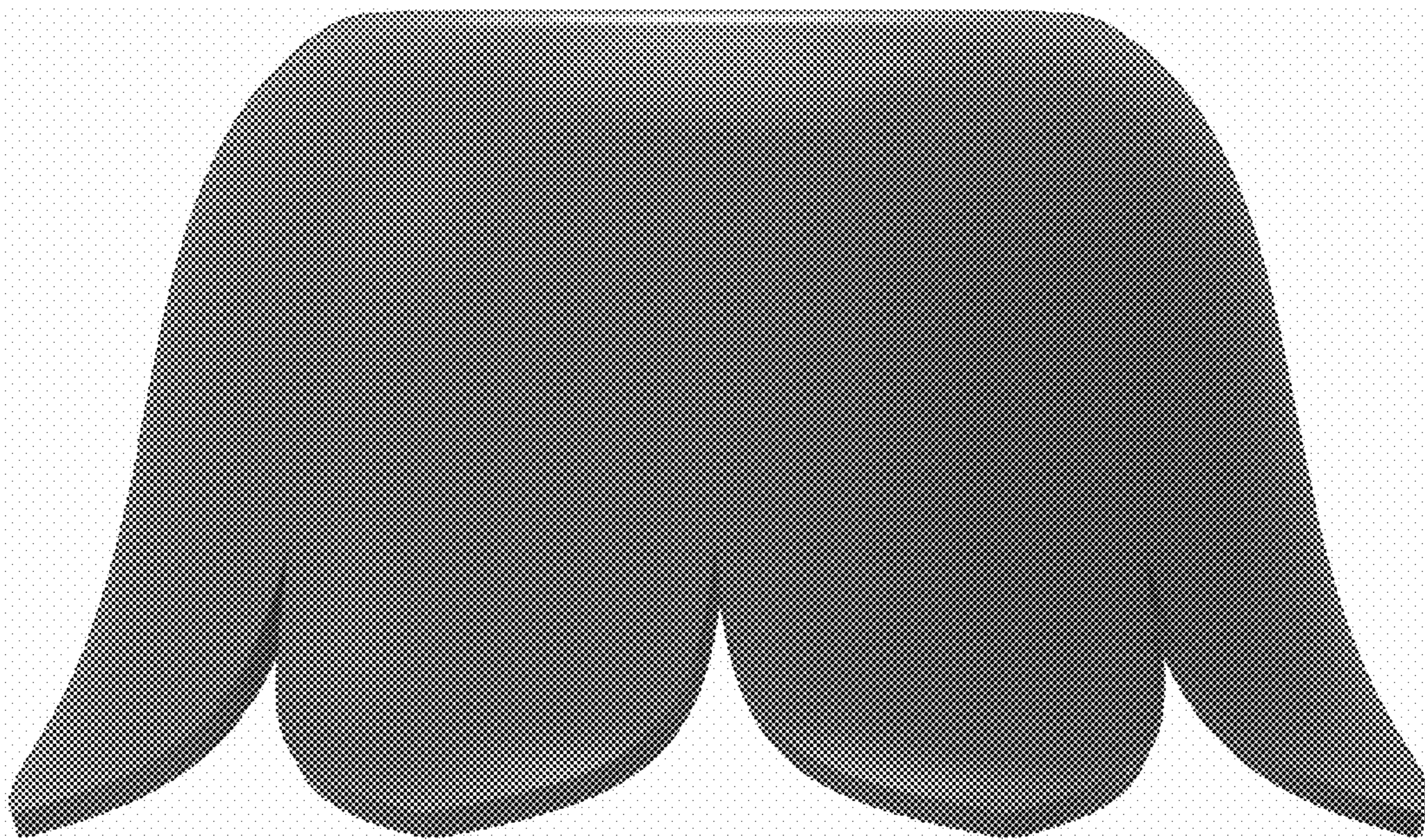

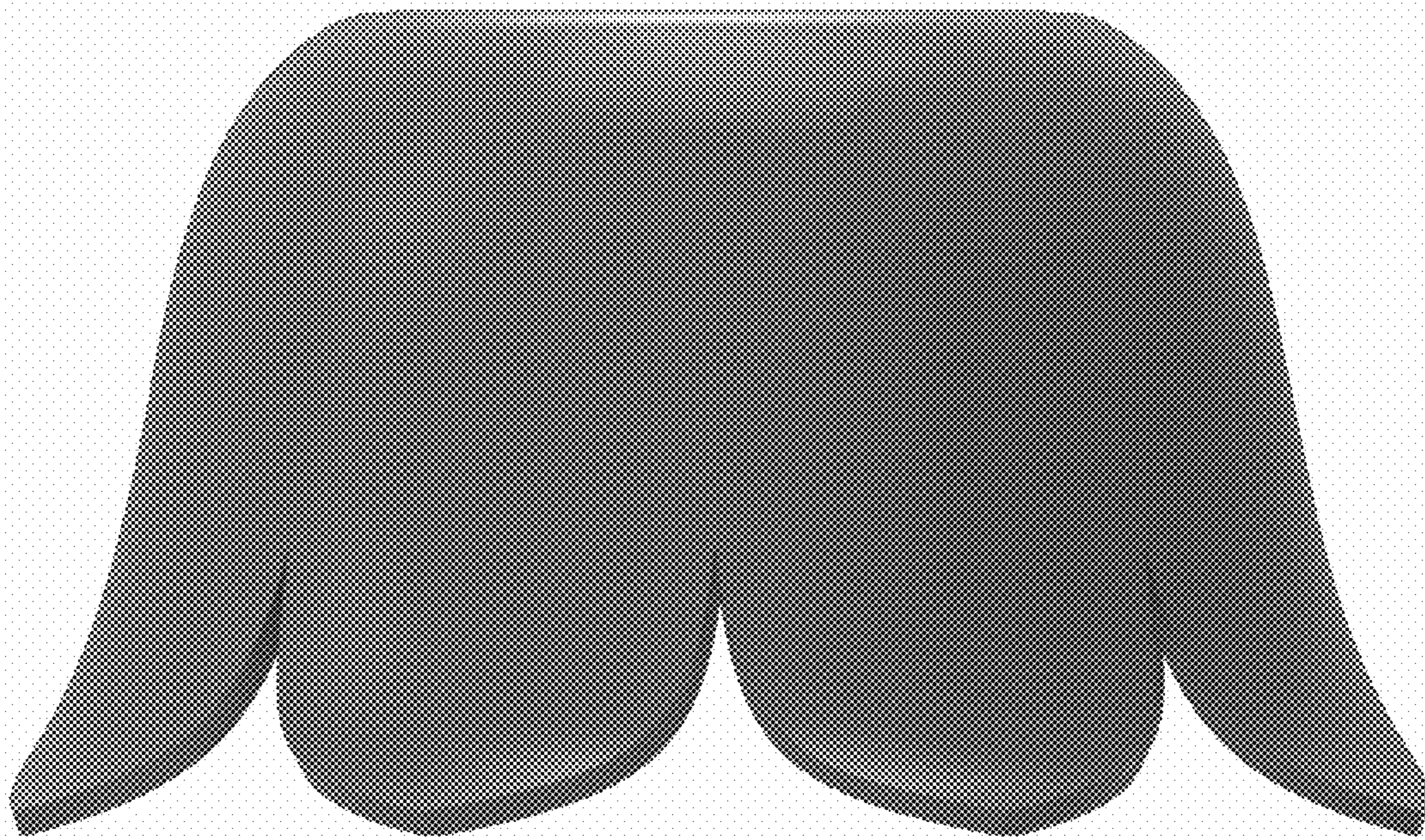

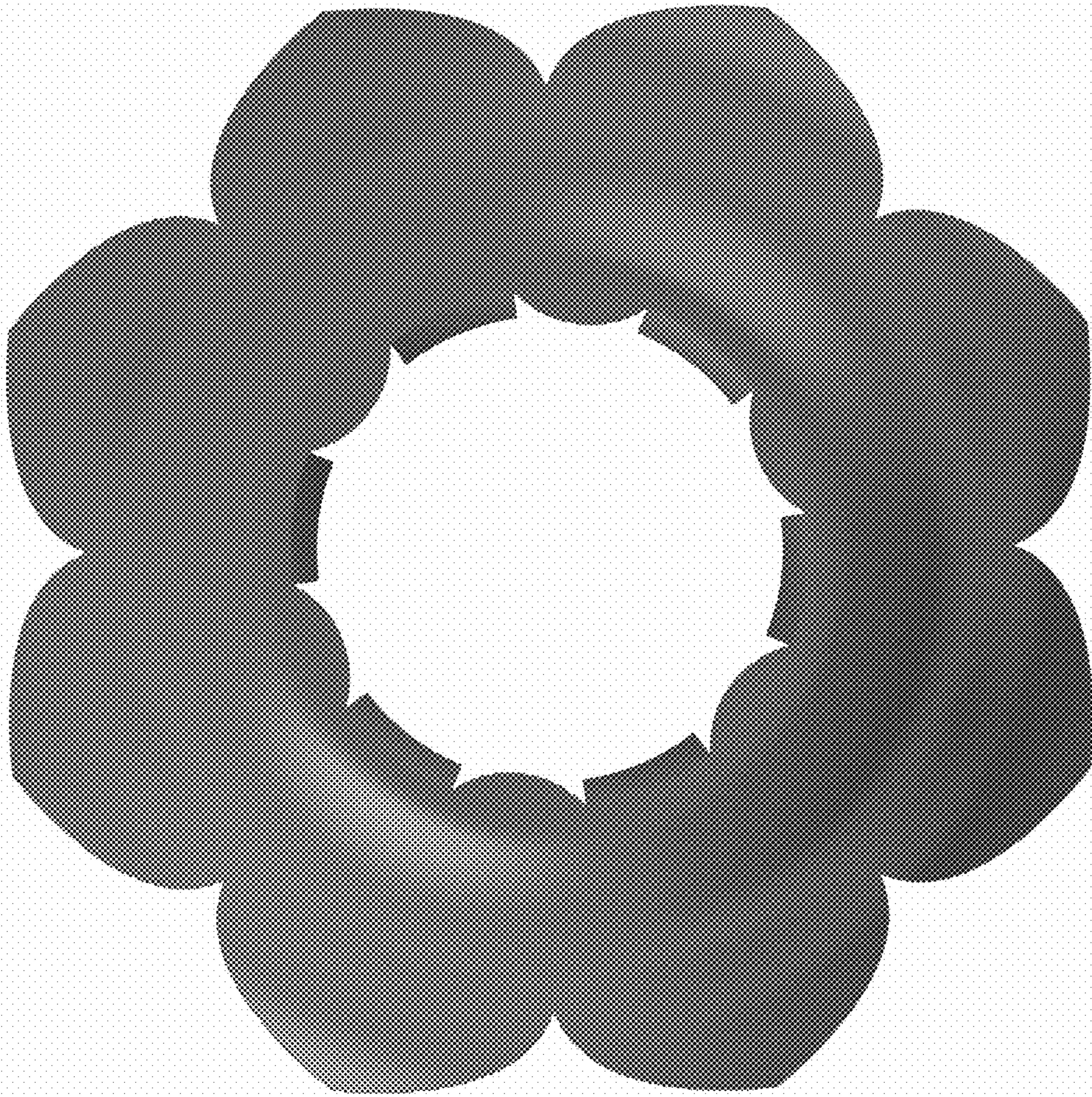

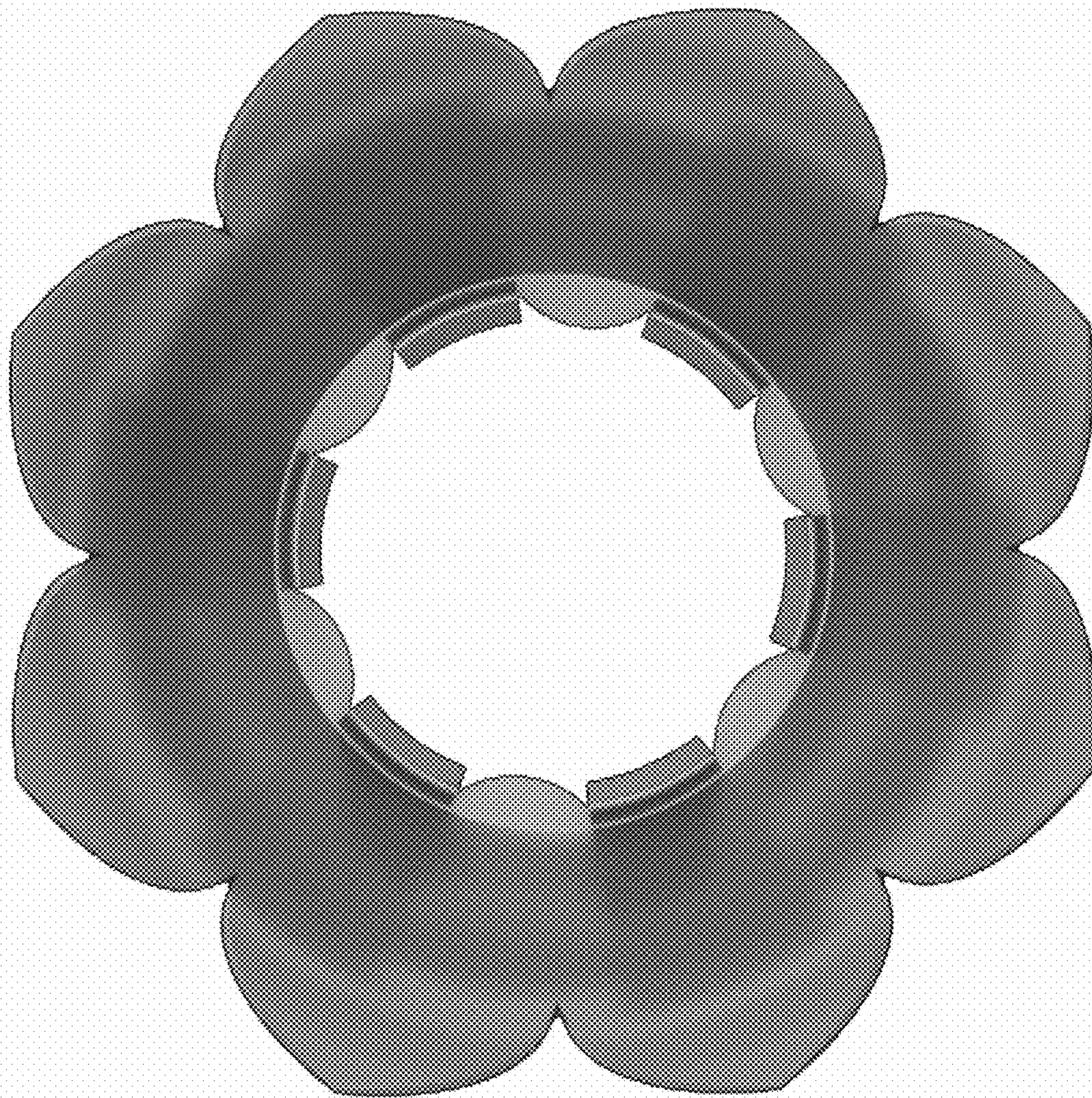

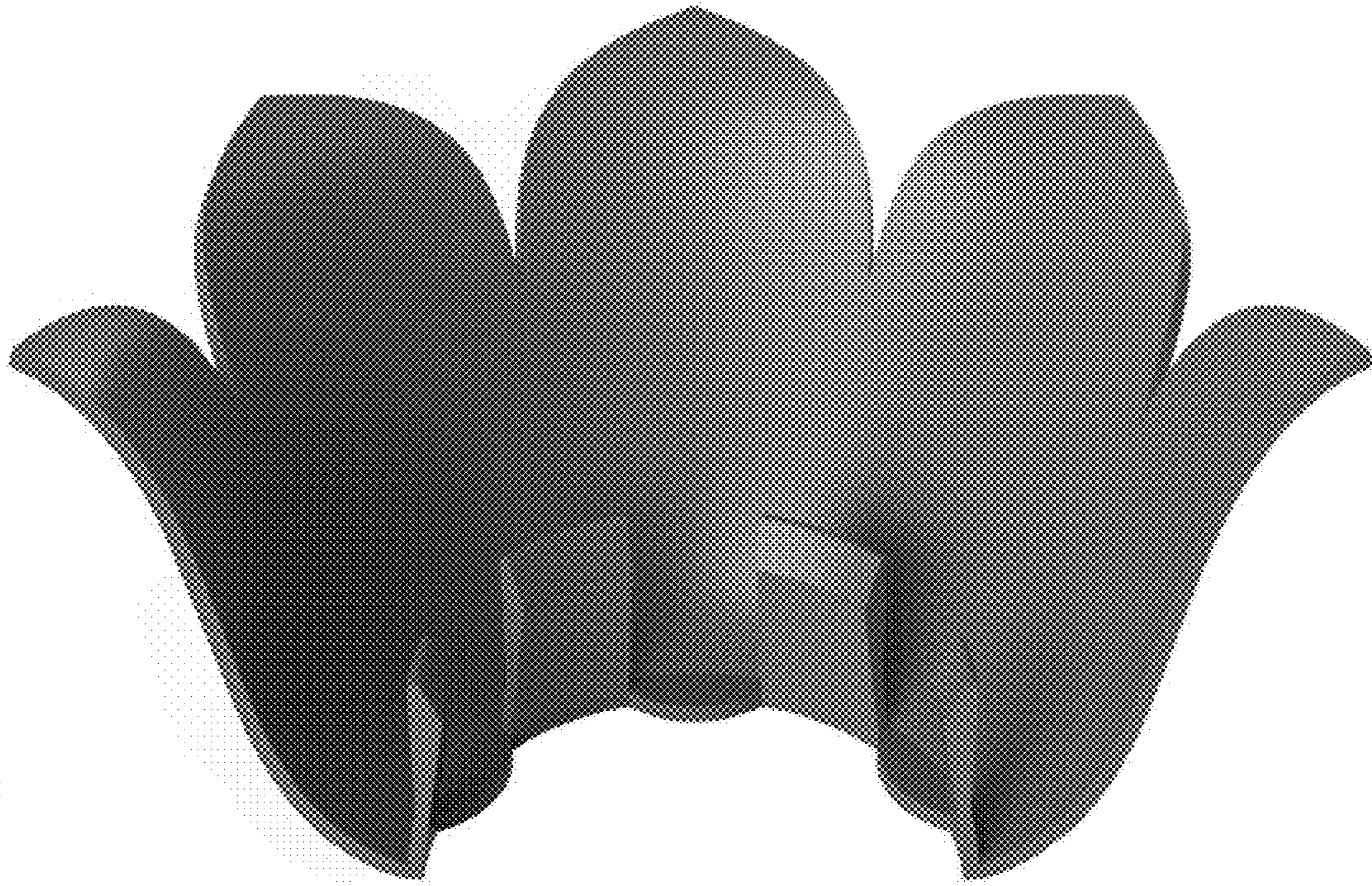
