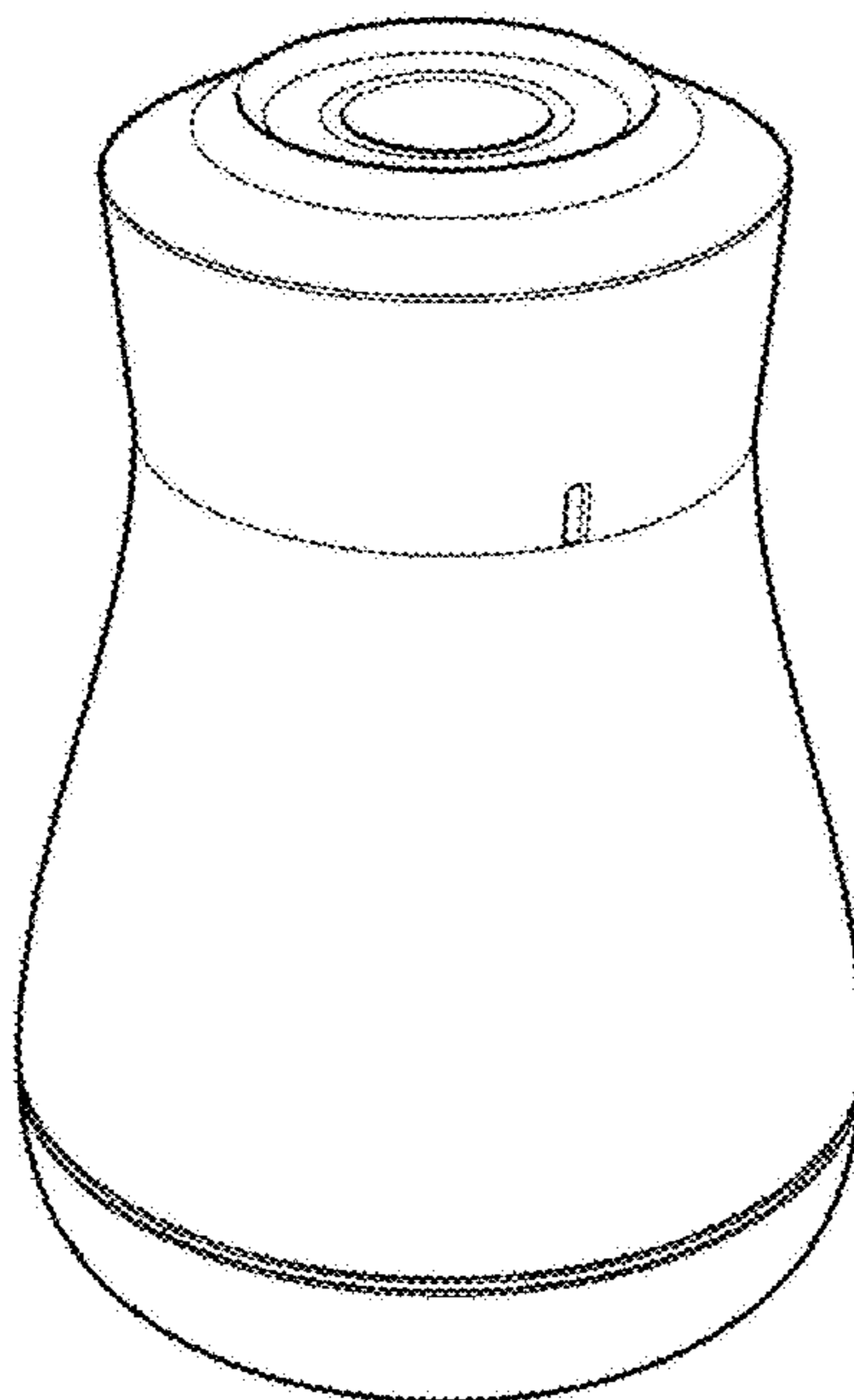

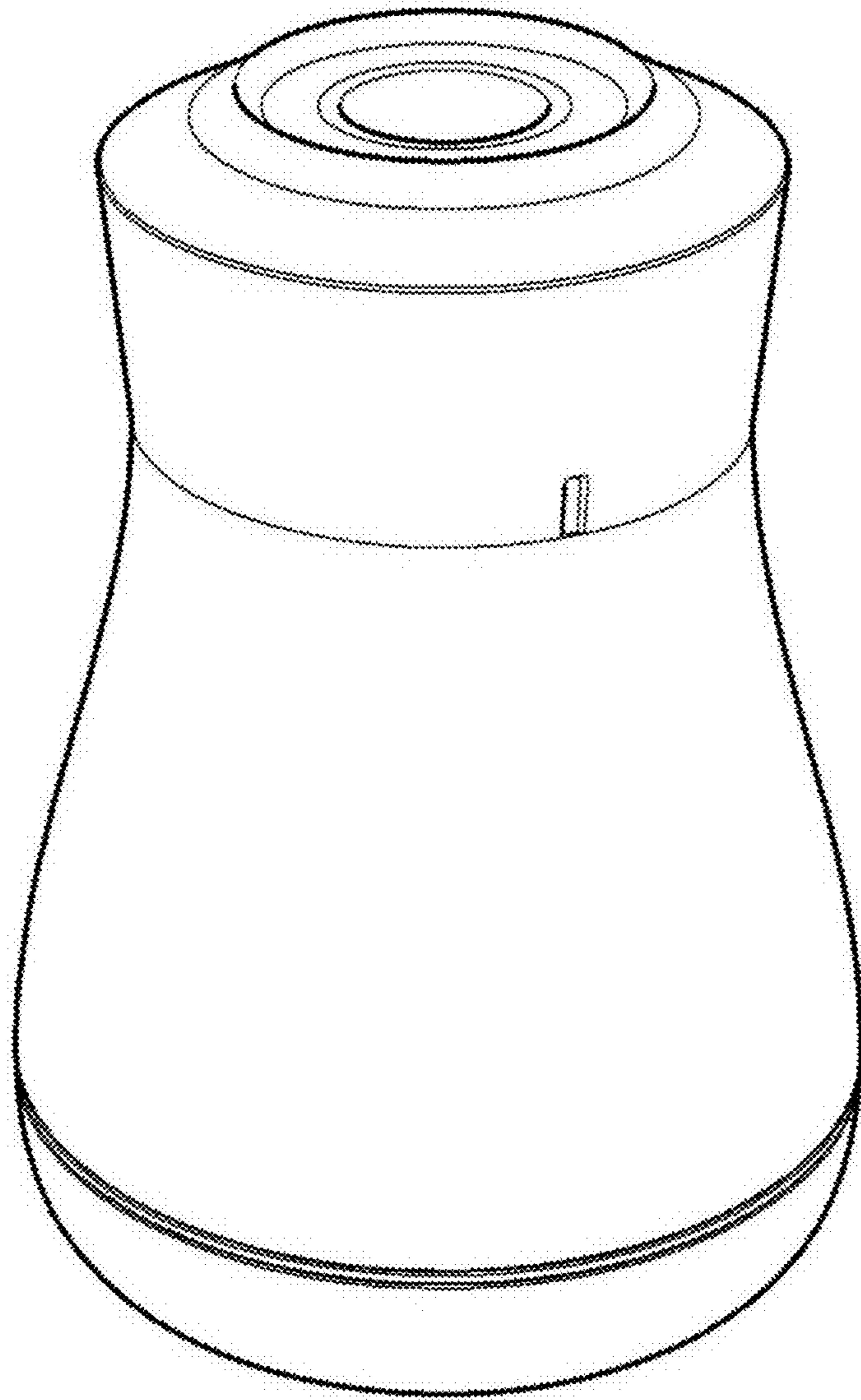

Fig. 1.7 is a bottom plan view.

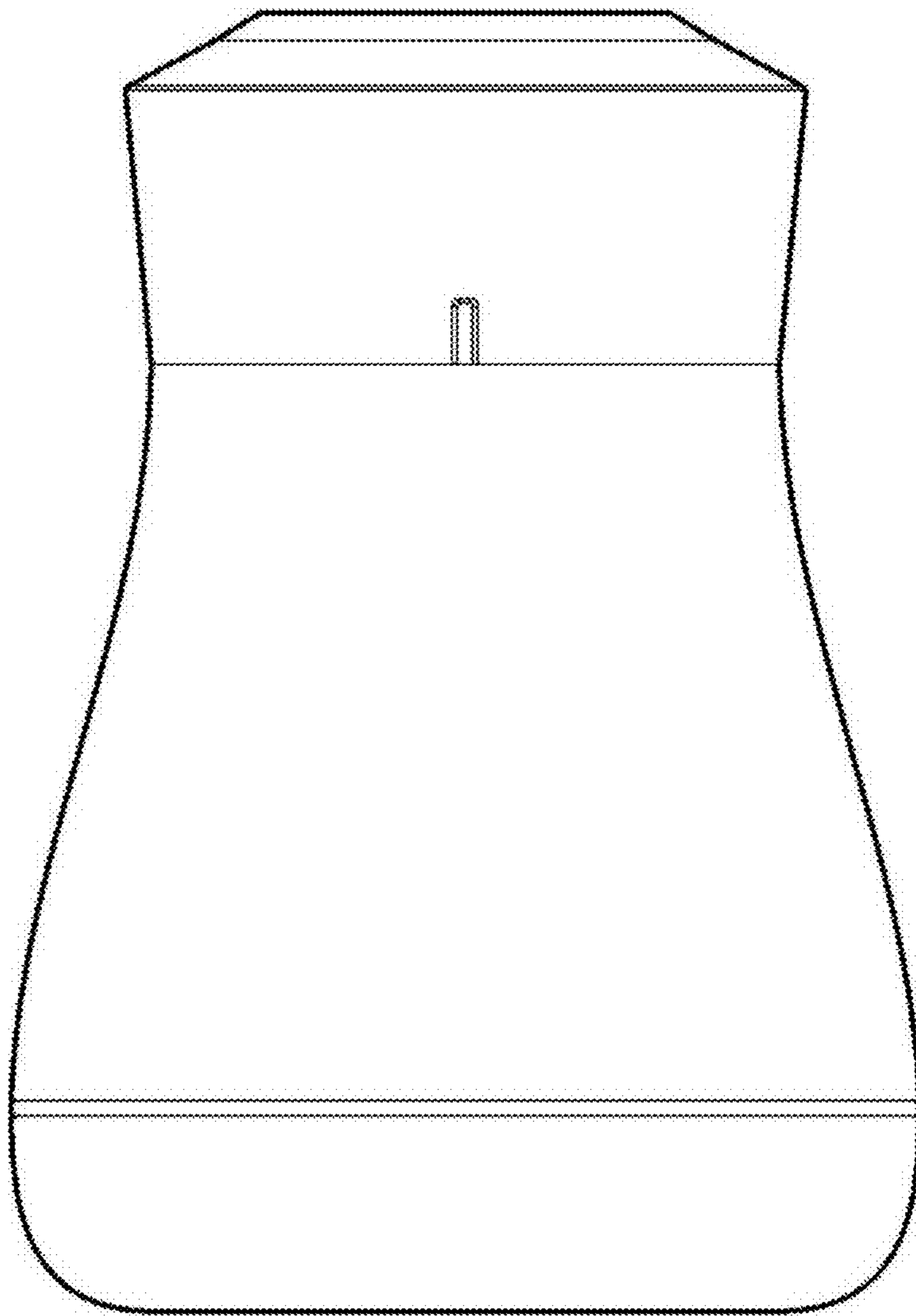

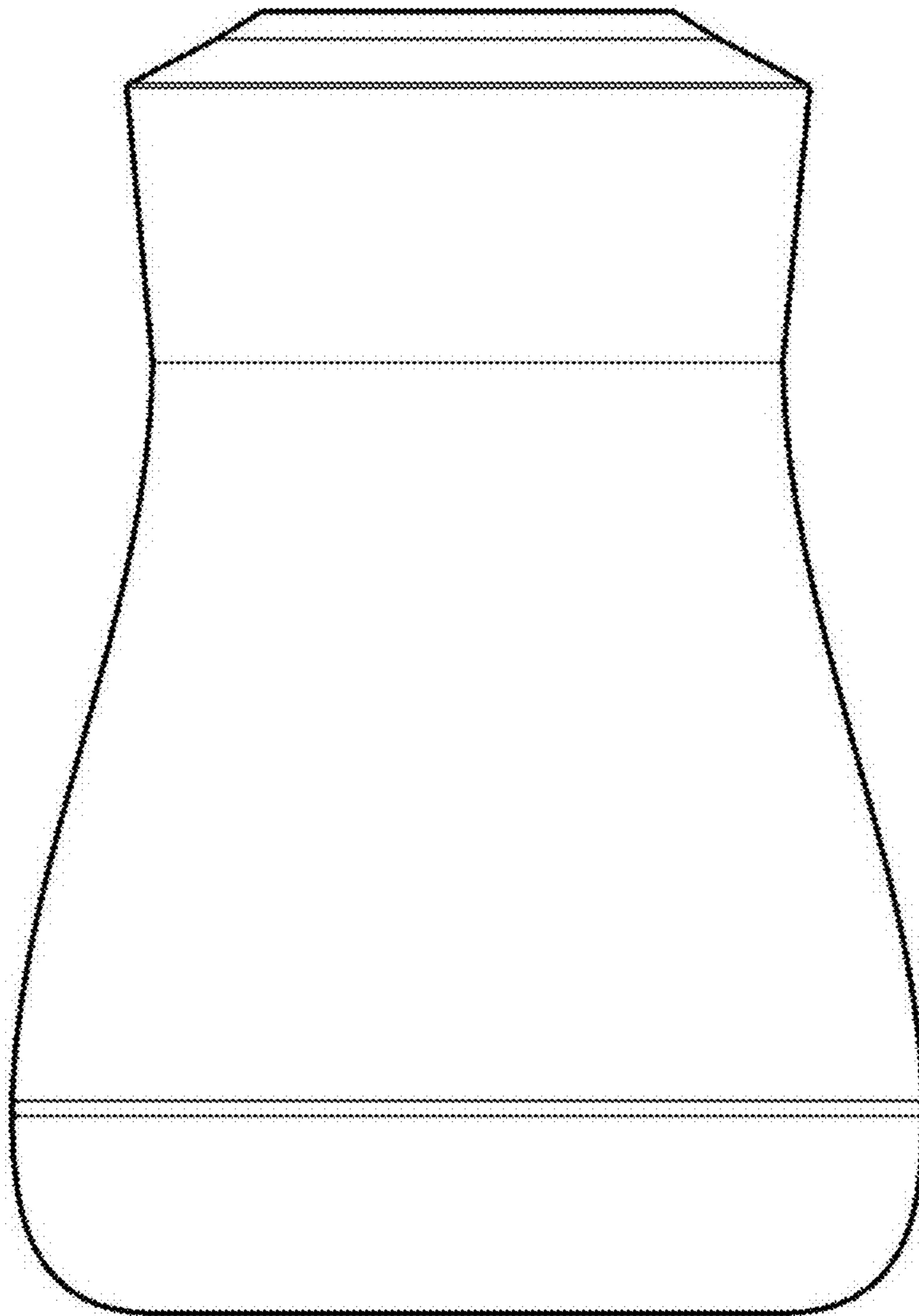

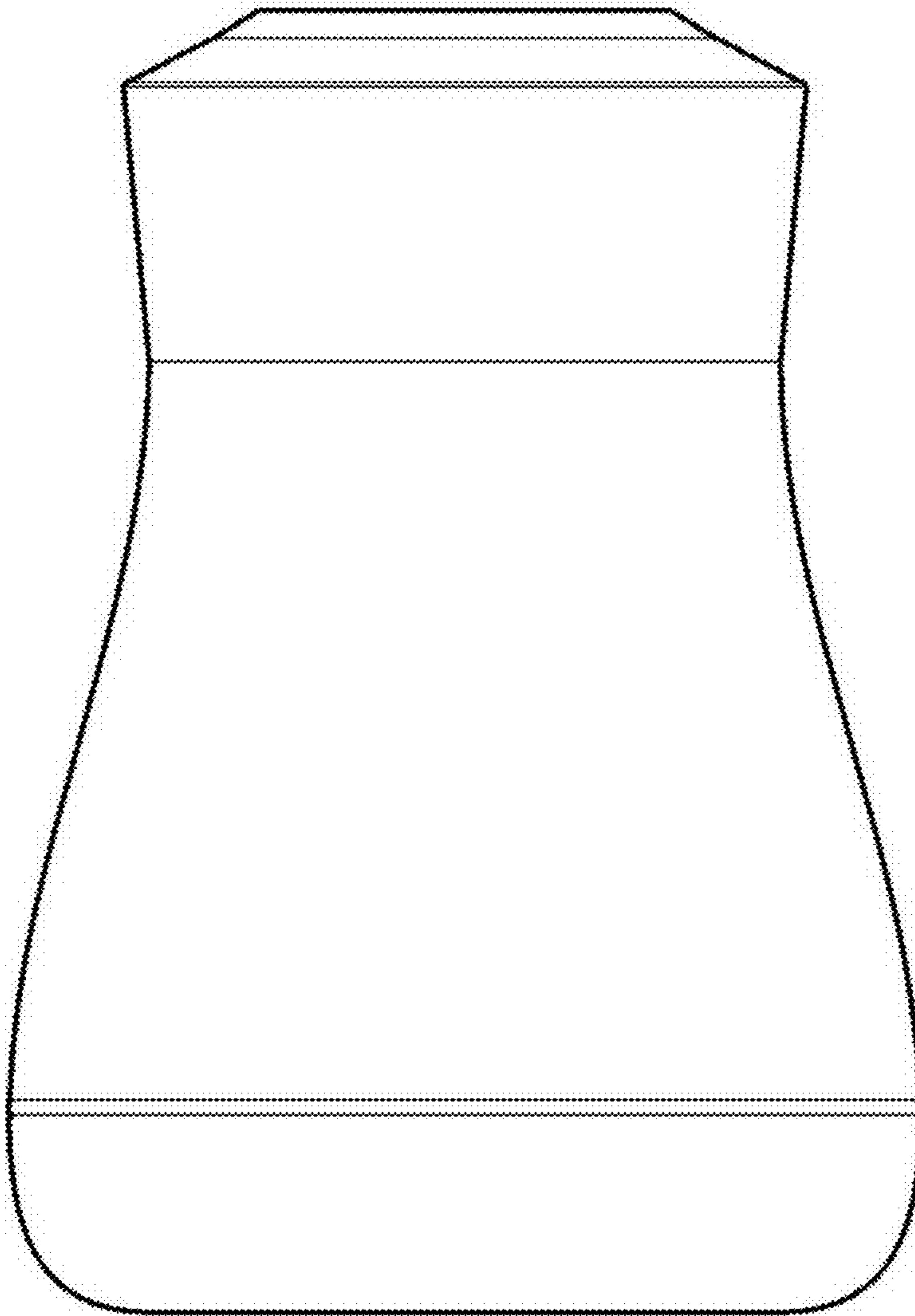

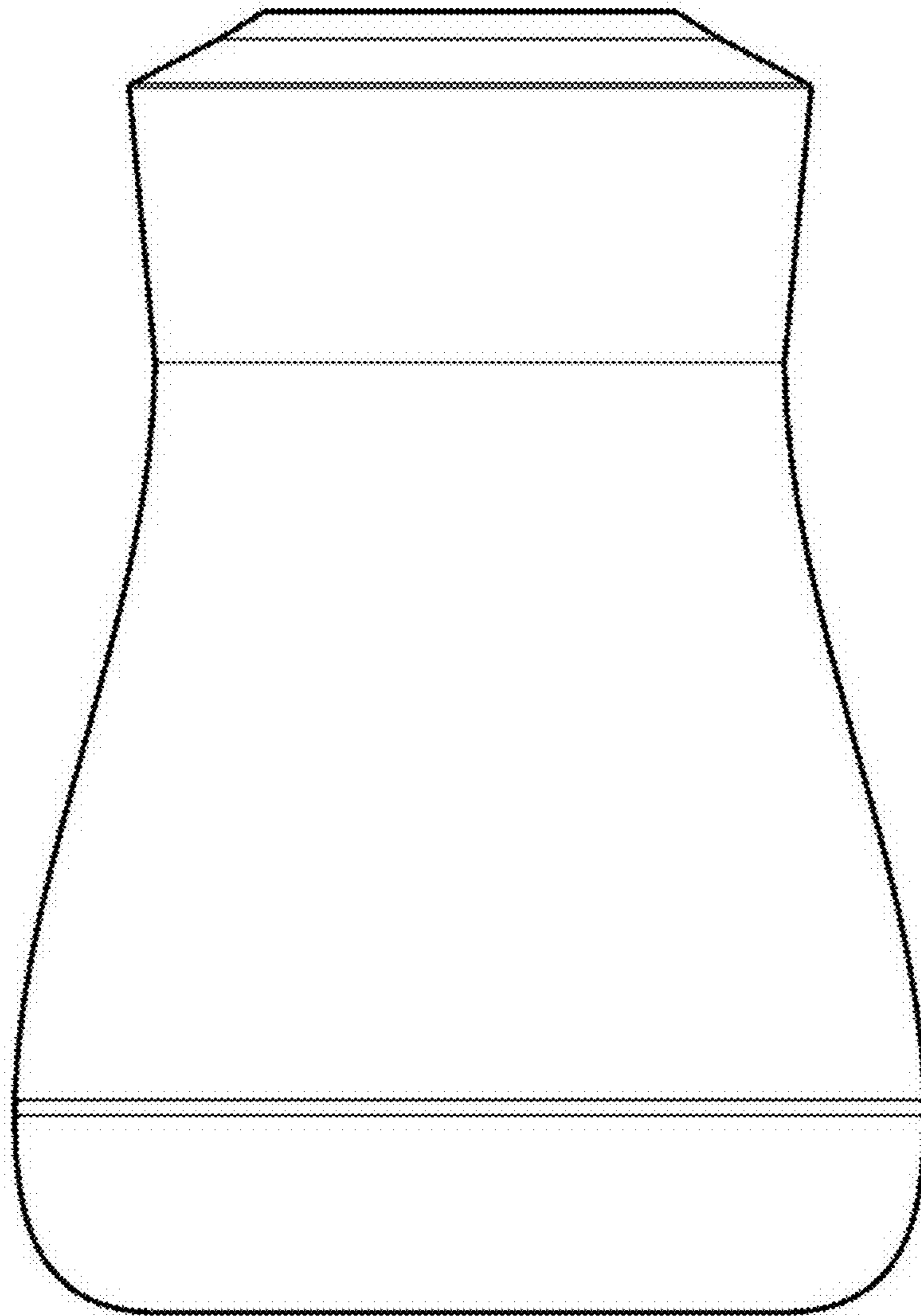

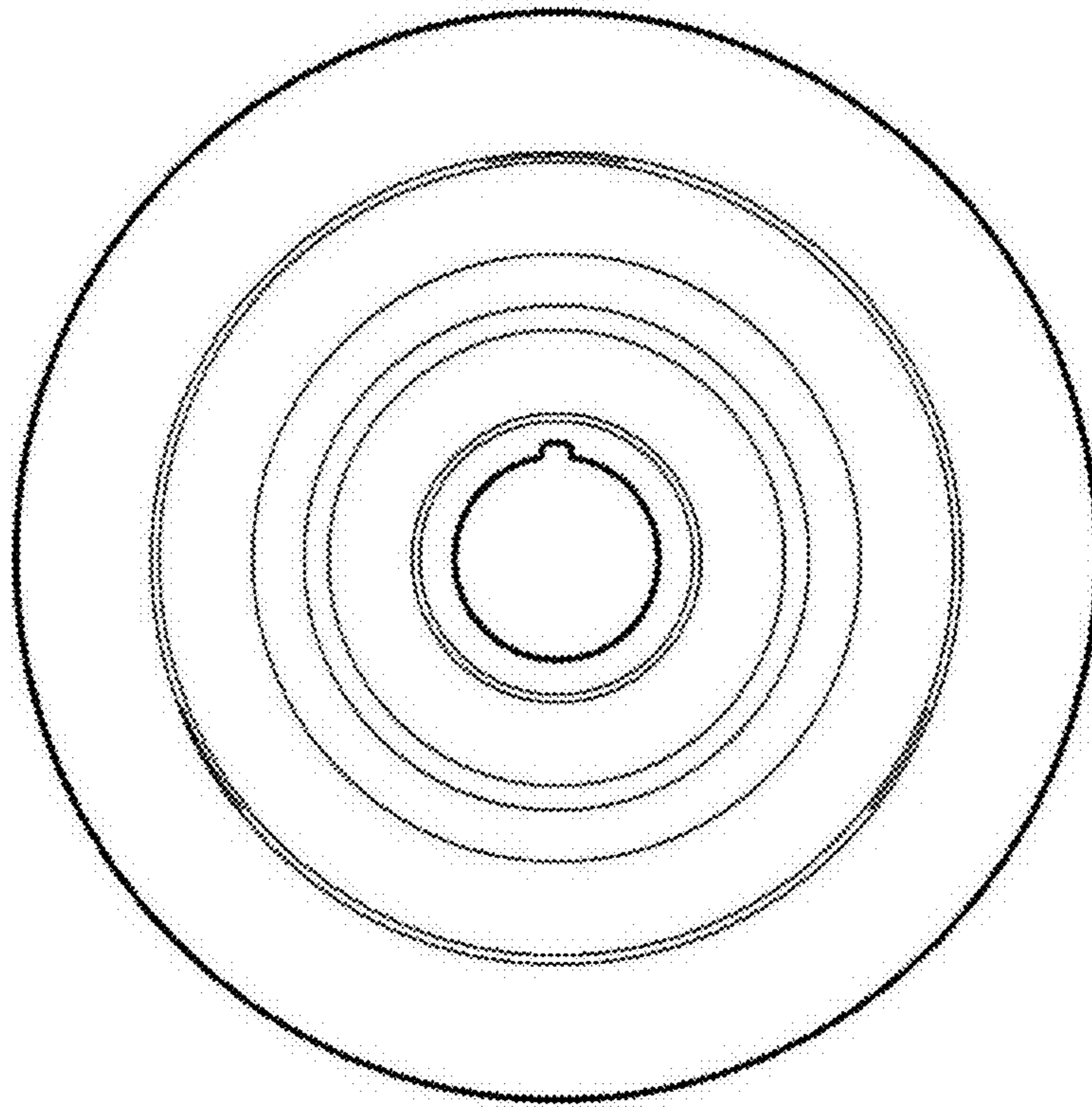
