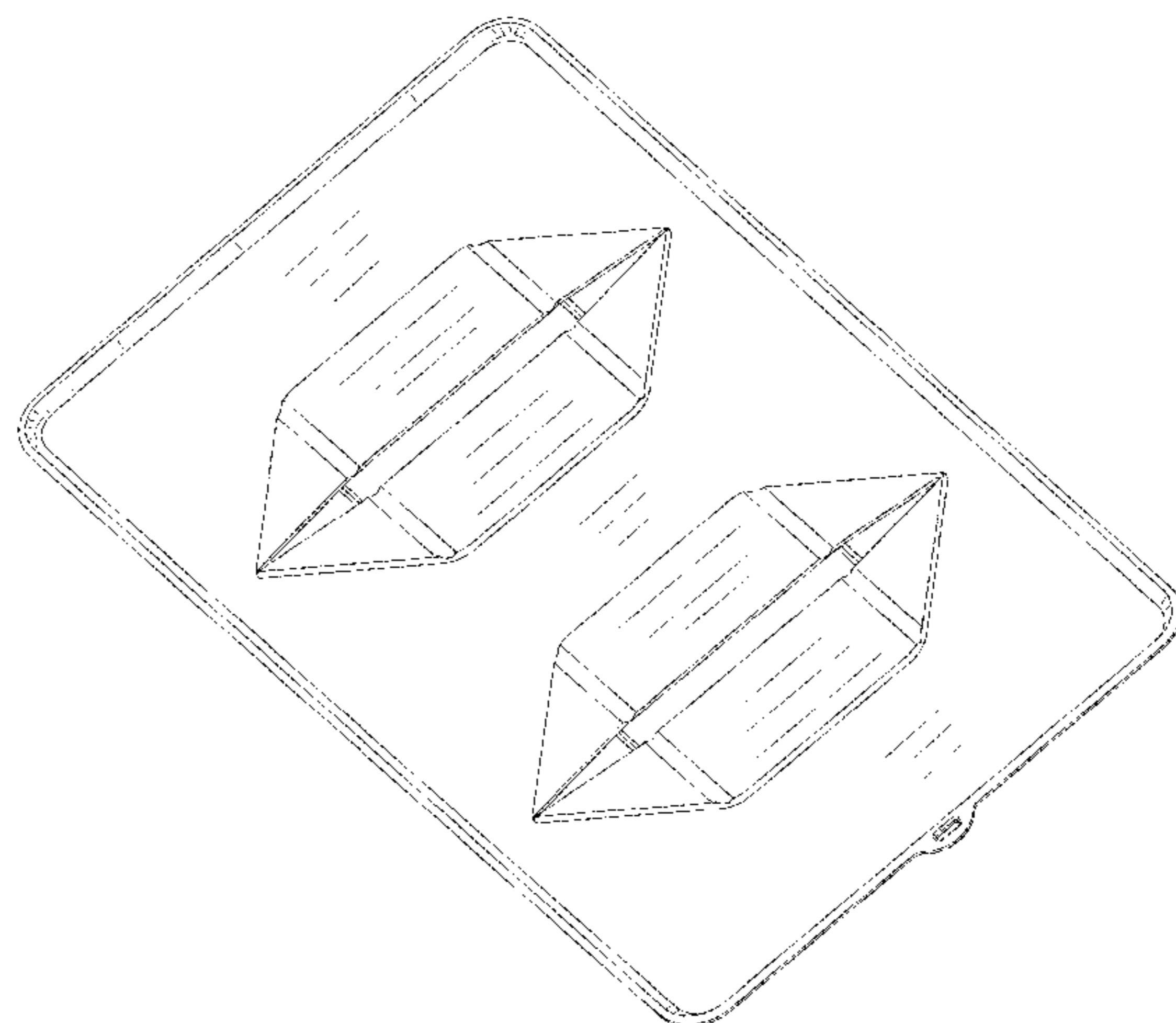
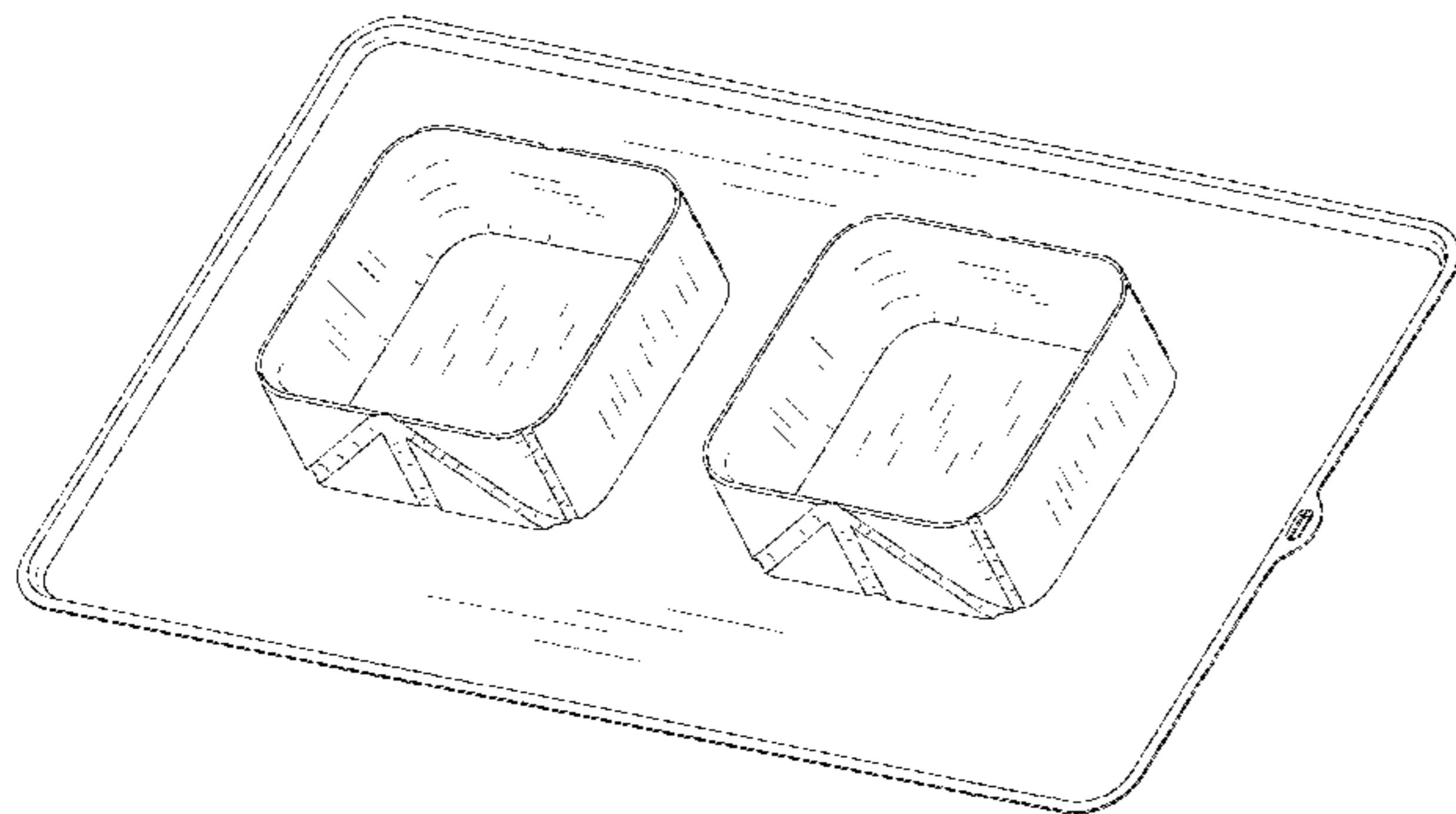
(57) **CLAIM**

**DESCRIPTION**

FIG. 1 is a front elevational view of a feeder showing our new design;  
FIG. 2 is a rear elevational view thereof;  
FIG. 3 is a bottom plan view thereof;  
FIG. 4 is a left side view thereof;  
FIG. 5 is a right side view thereof;  
FIG. 6 is a first perspective view thereof;  
FIG. 7 is a second perspective view thereof;  
FIG. 8 is a third perspective view of the feeder showing the feeder bowls in a collapsed state; and,  
FIG. 9 is a fourth perspective view showing the feeder in a rolled-up state.

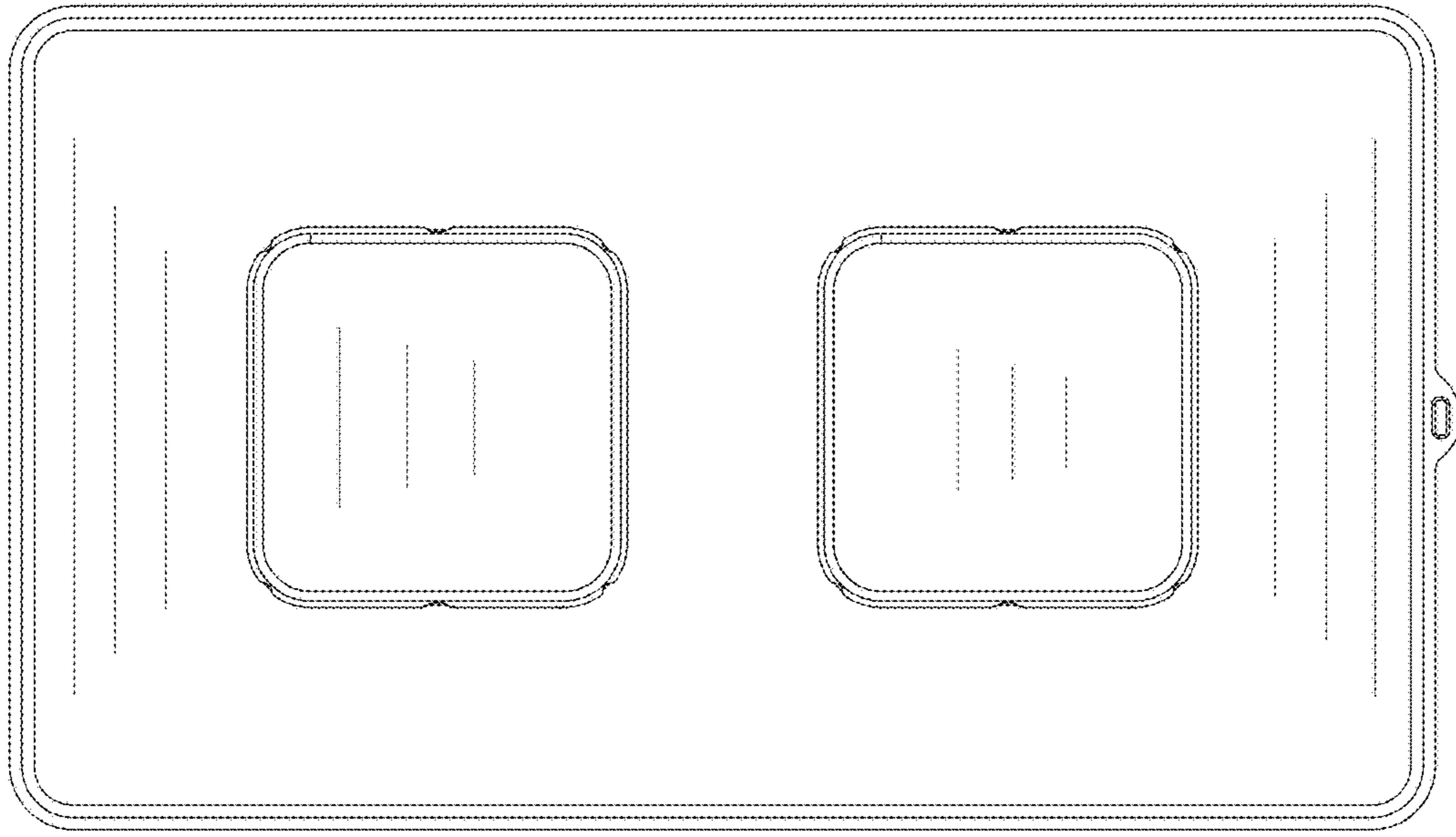

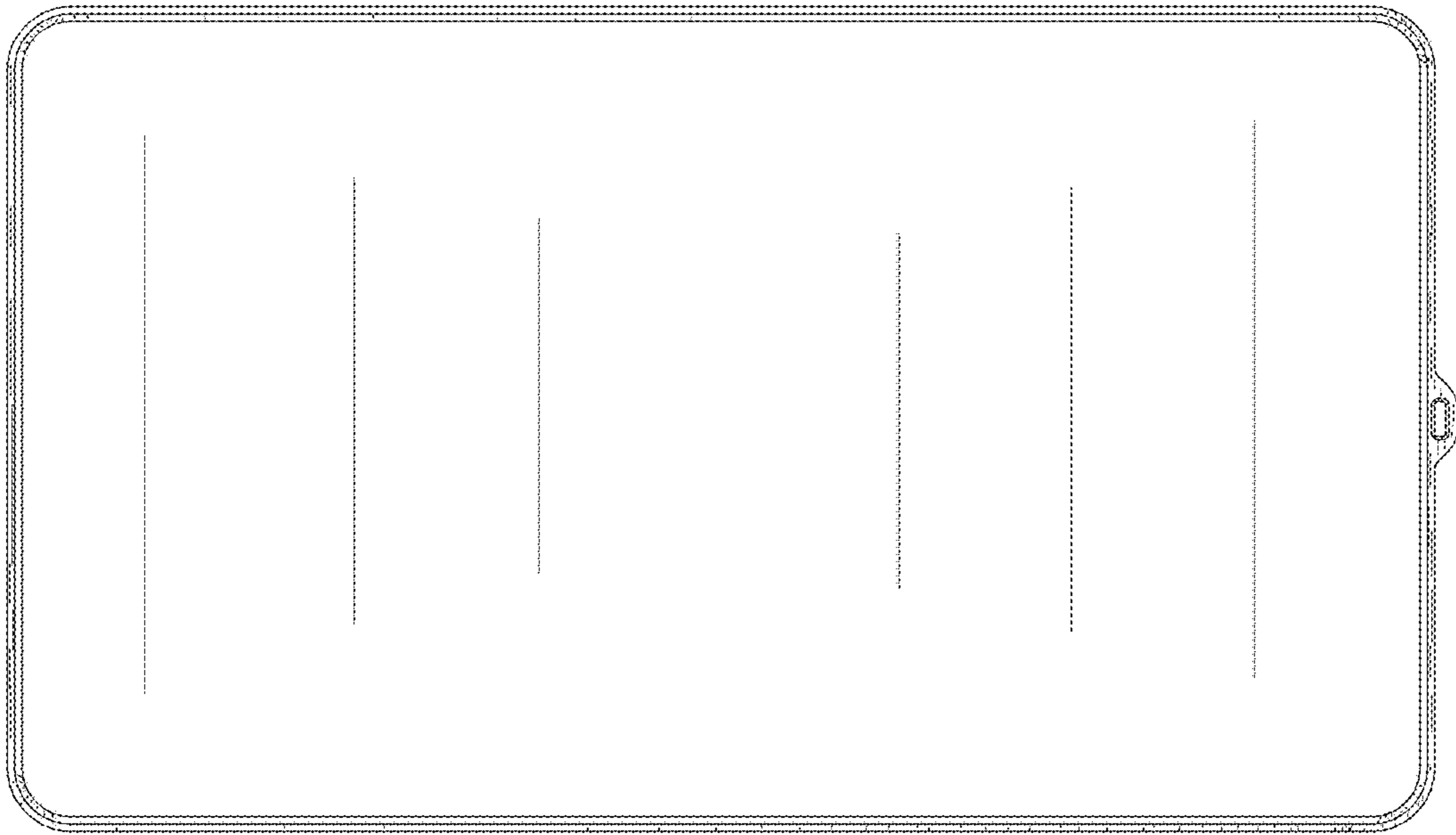

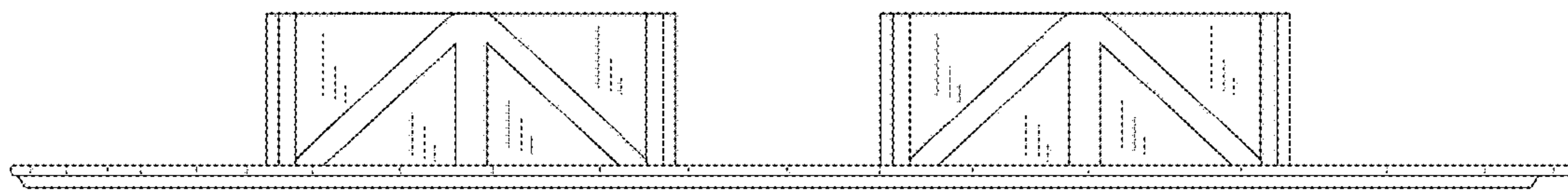

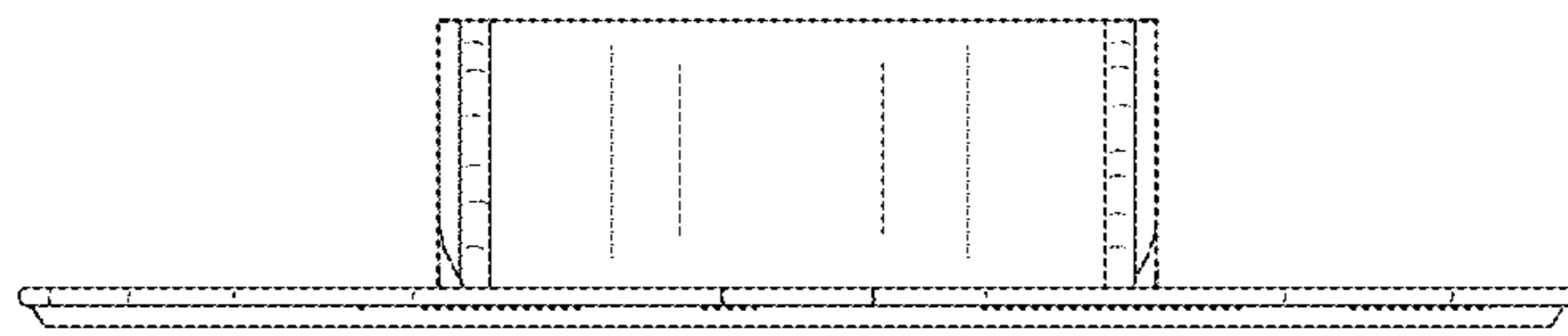

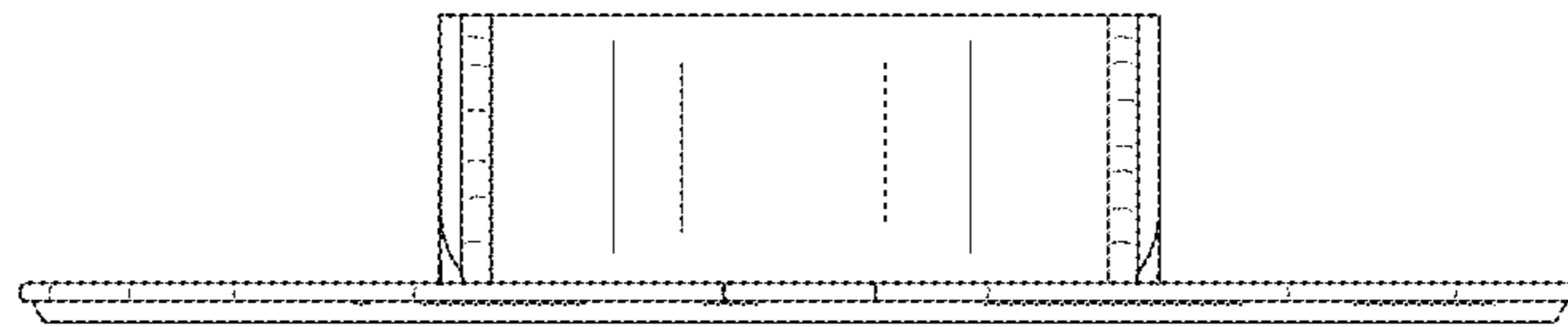

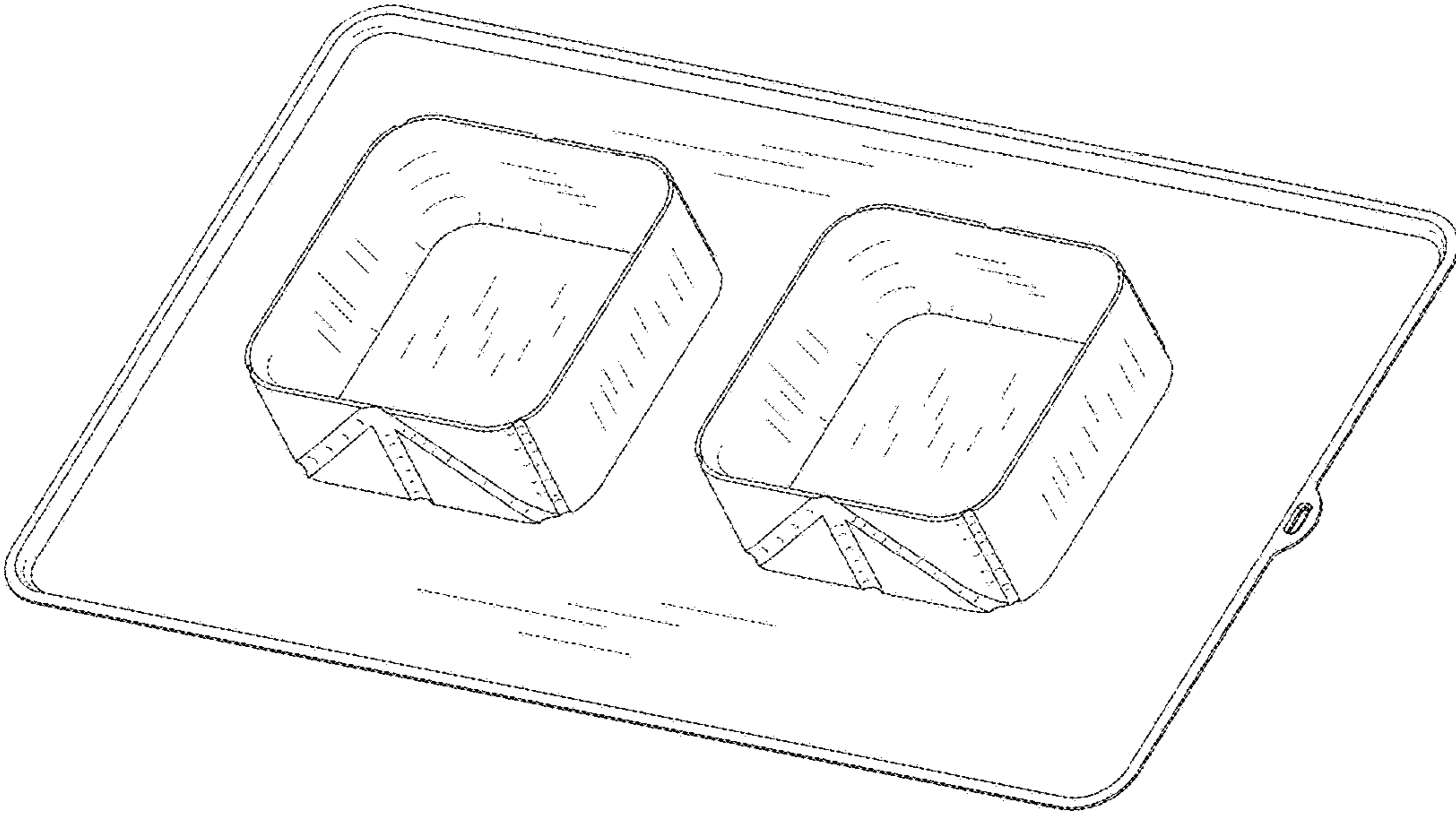

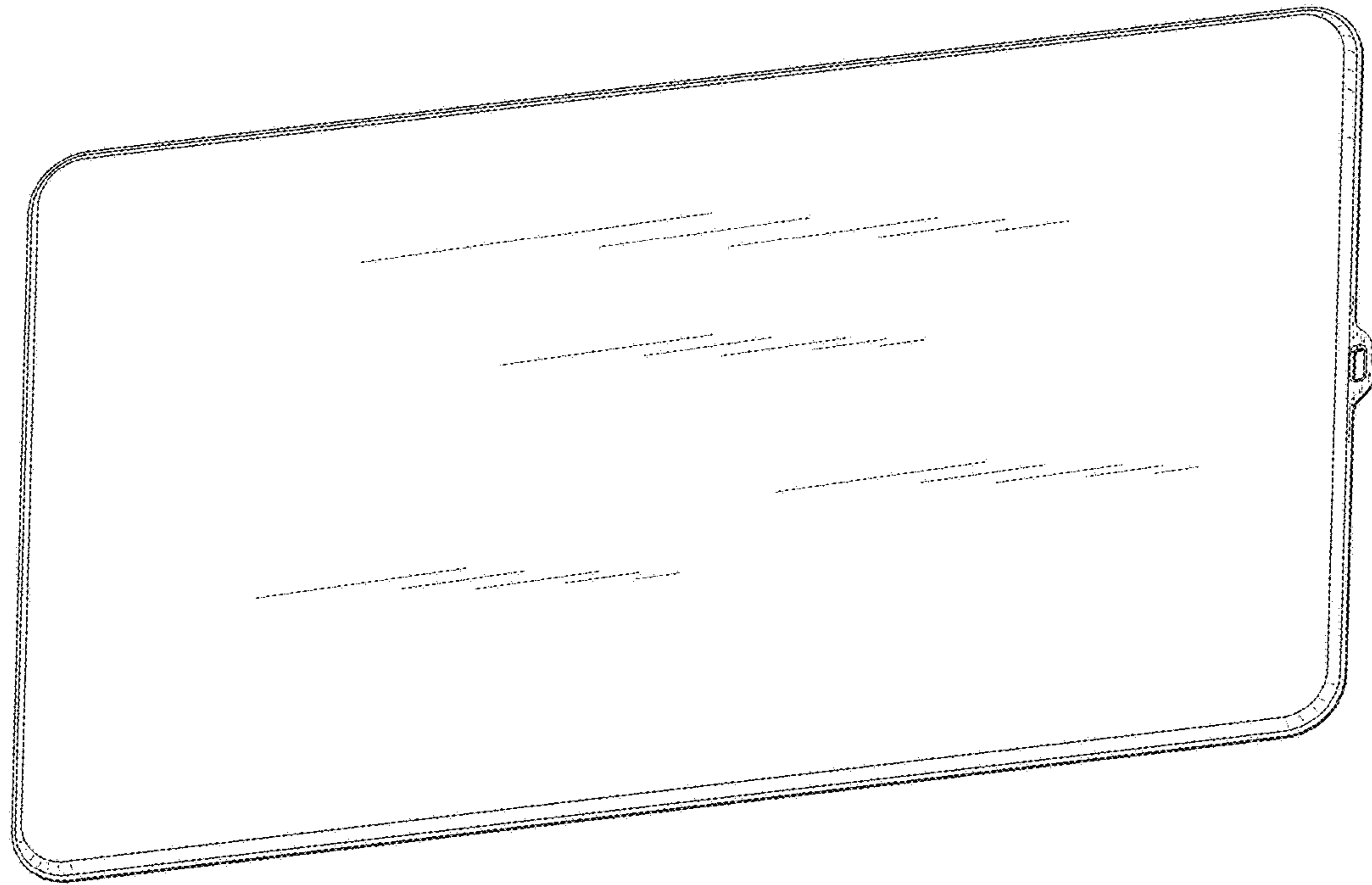

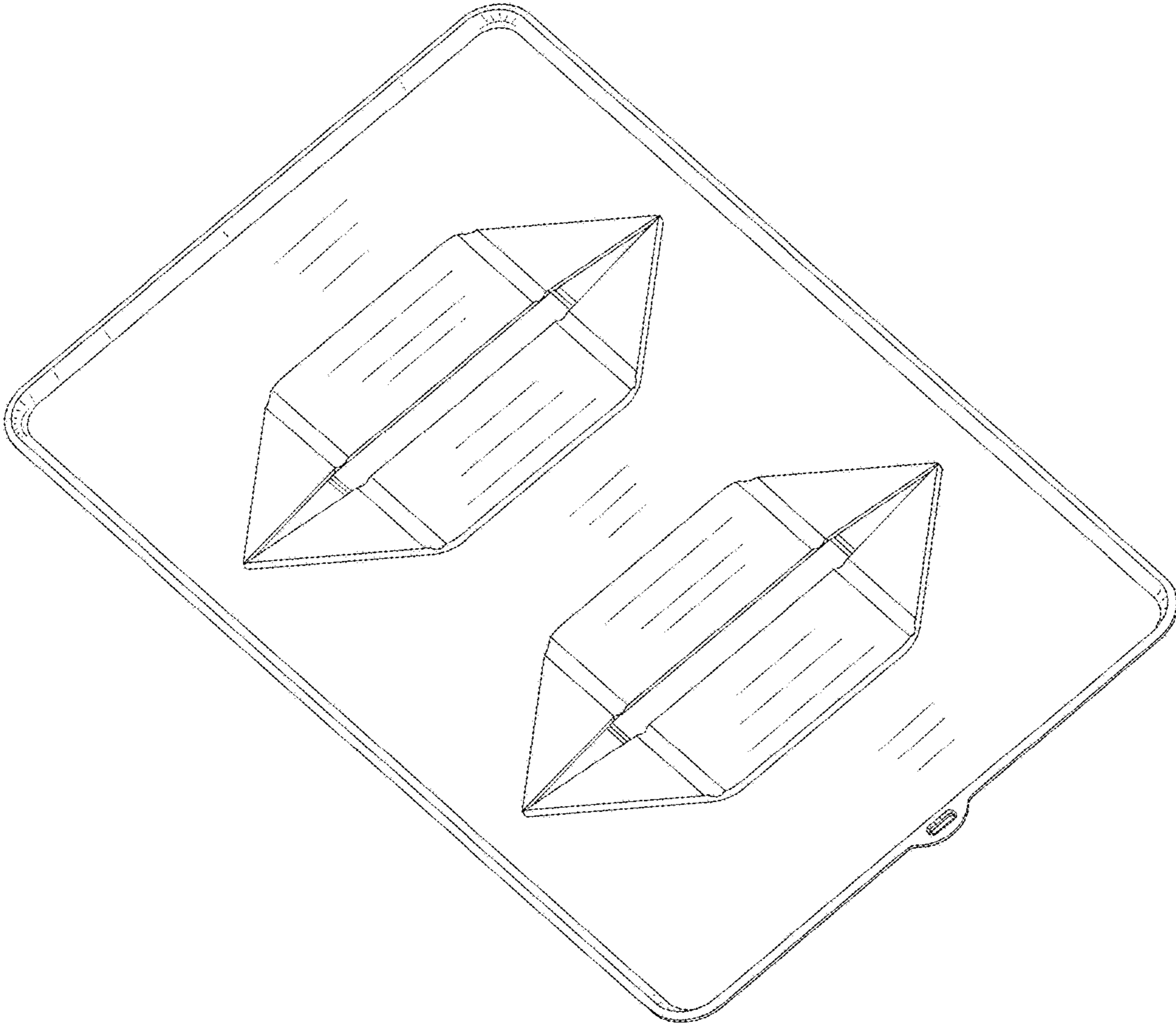

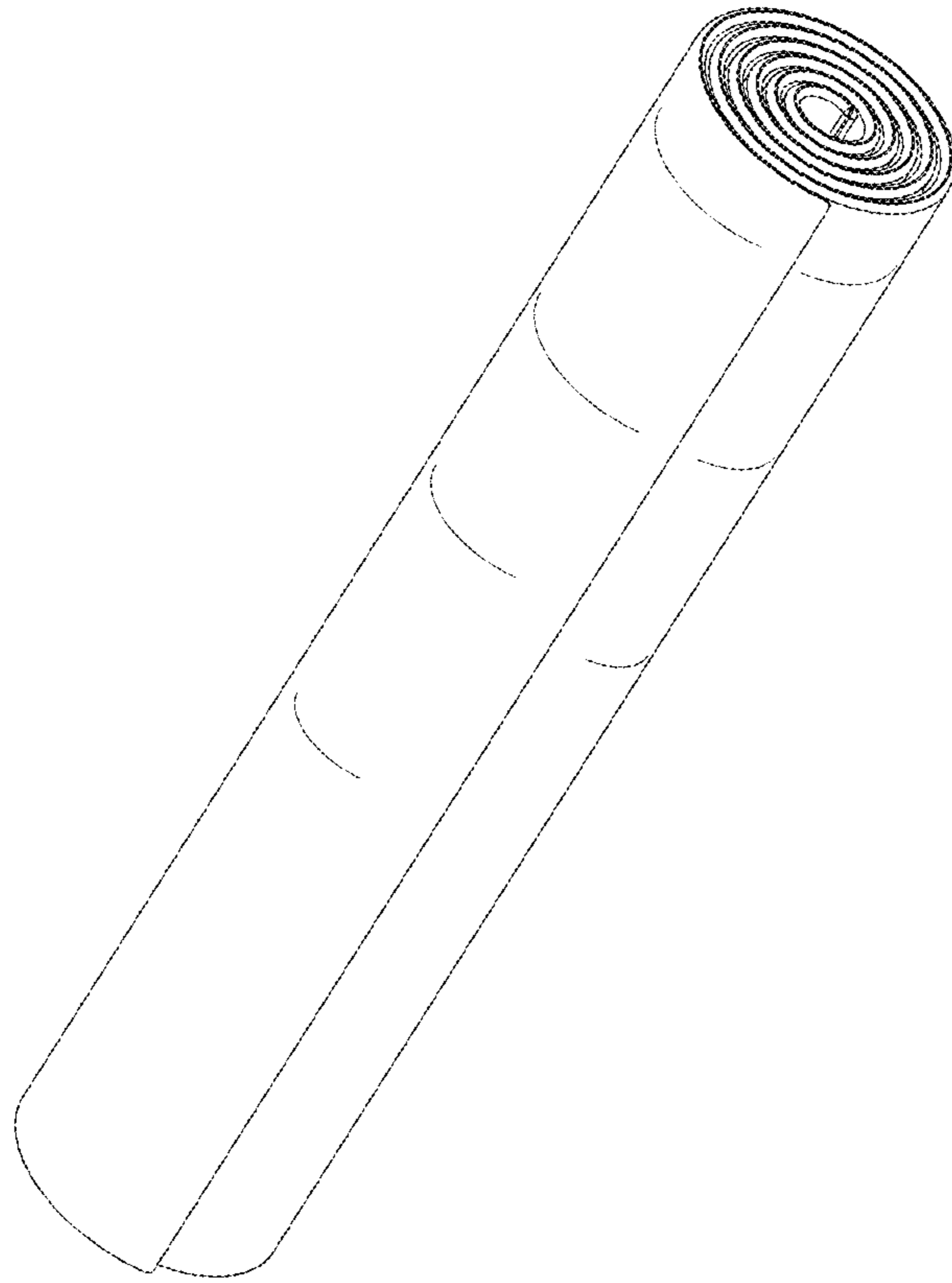
