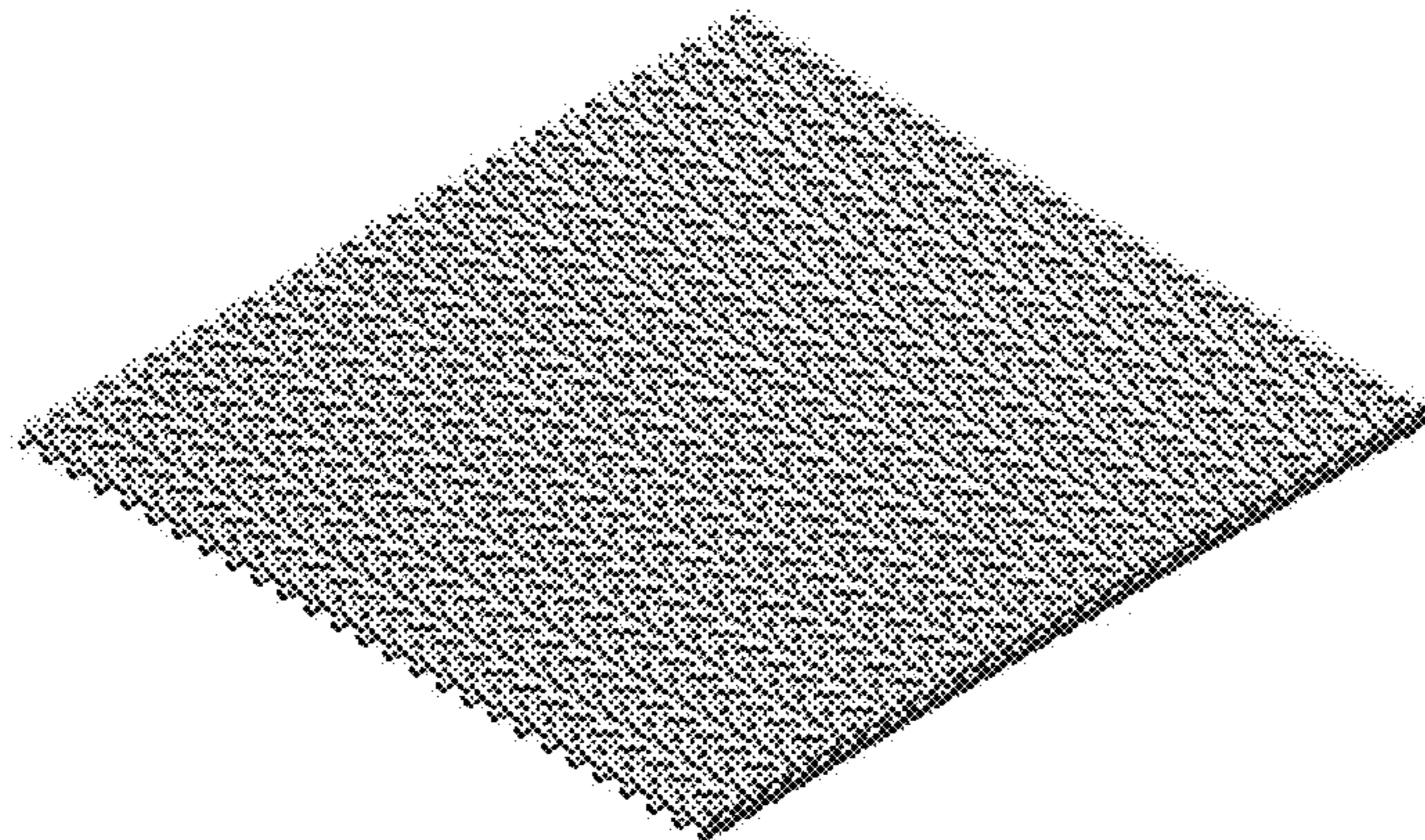
(57) **CLAIM**

DESCRIPTION

FIG. 1 is a perspective view of a first embodiment of a sheet material;
FIG. 2 is a front view of the sheet material as seen in FIG. 1;

FIG. 11 is a top perspective view of a third embodiment of a sheet material;
FIG. 12 is a bottom perspective view of the sheet material as seen in FIG. 11;
FIG. 13 is a front view of the sheet material as seen in FIG. 11;
FIG. 14 is a side view of the sheet material as seen in FIG. 11;
FIG. 15 is a top plan view of the sheet material as seen in FIG. 11; and,
FIG. 16 is a bottom plan view of the sheet material as seen in FIG. 11.

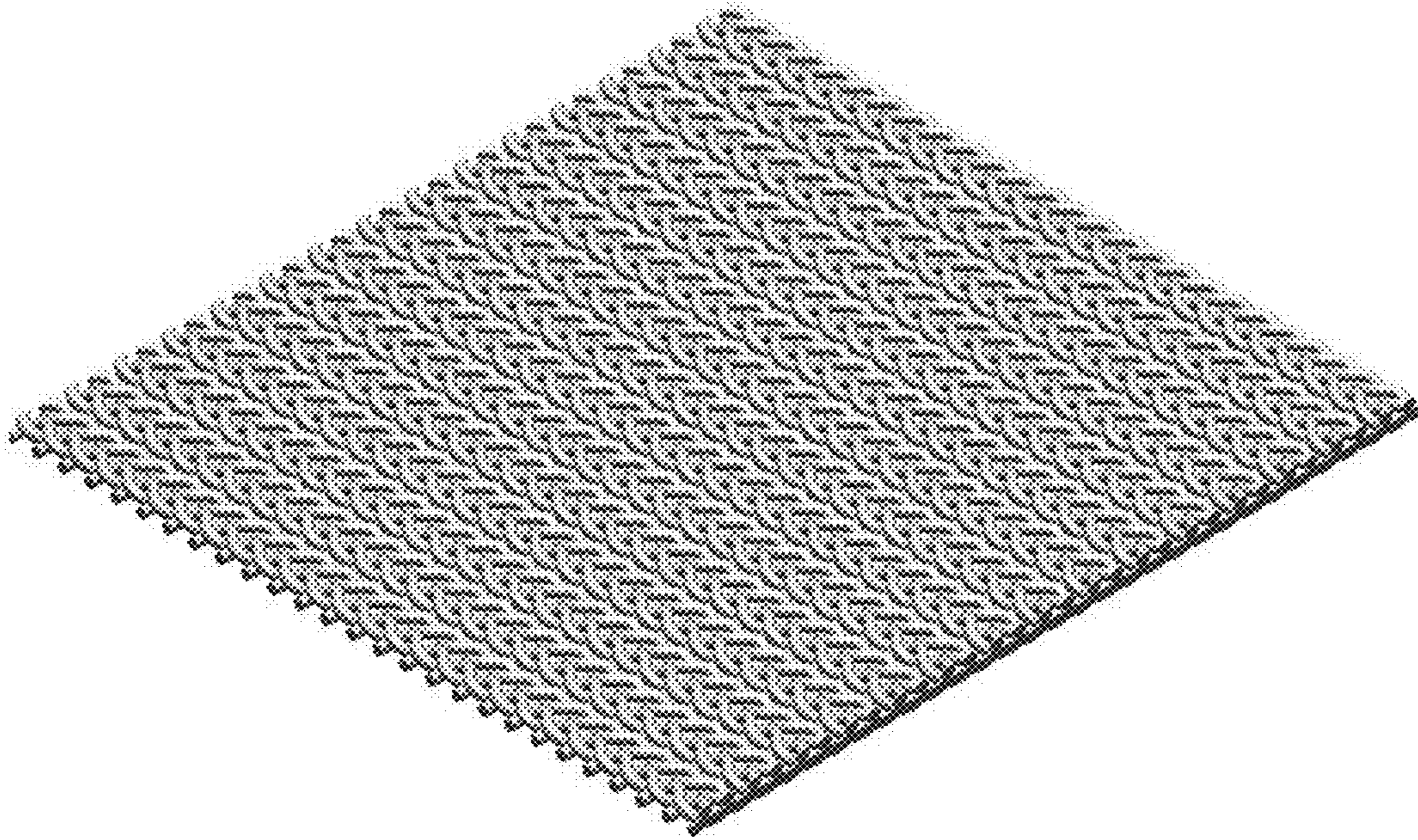

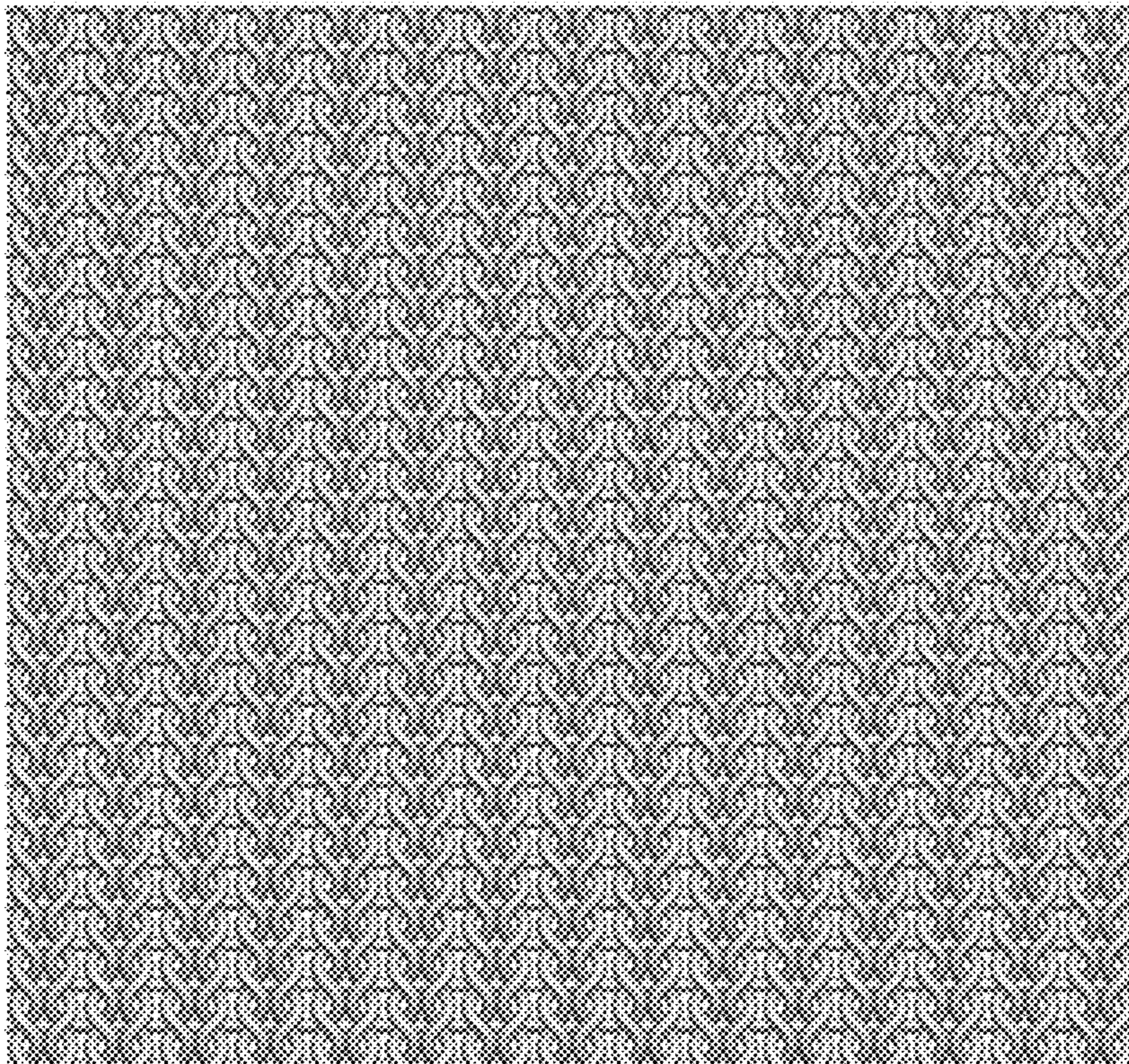

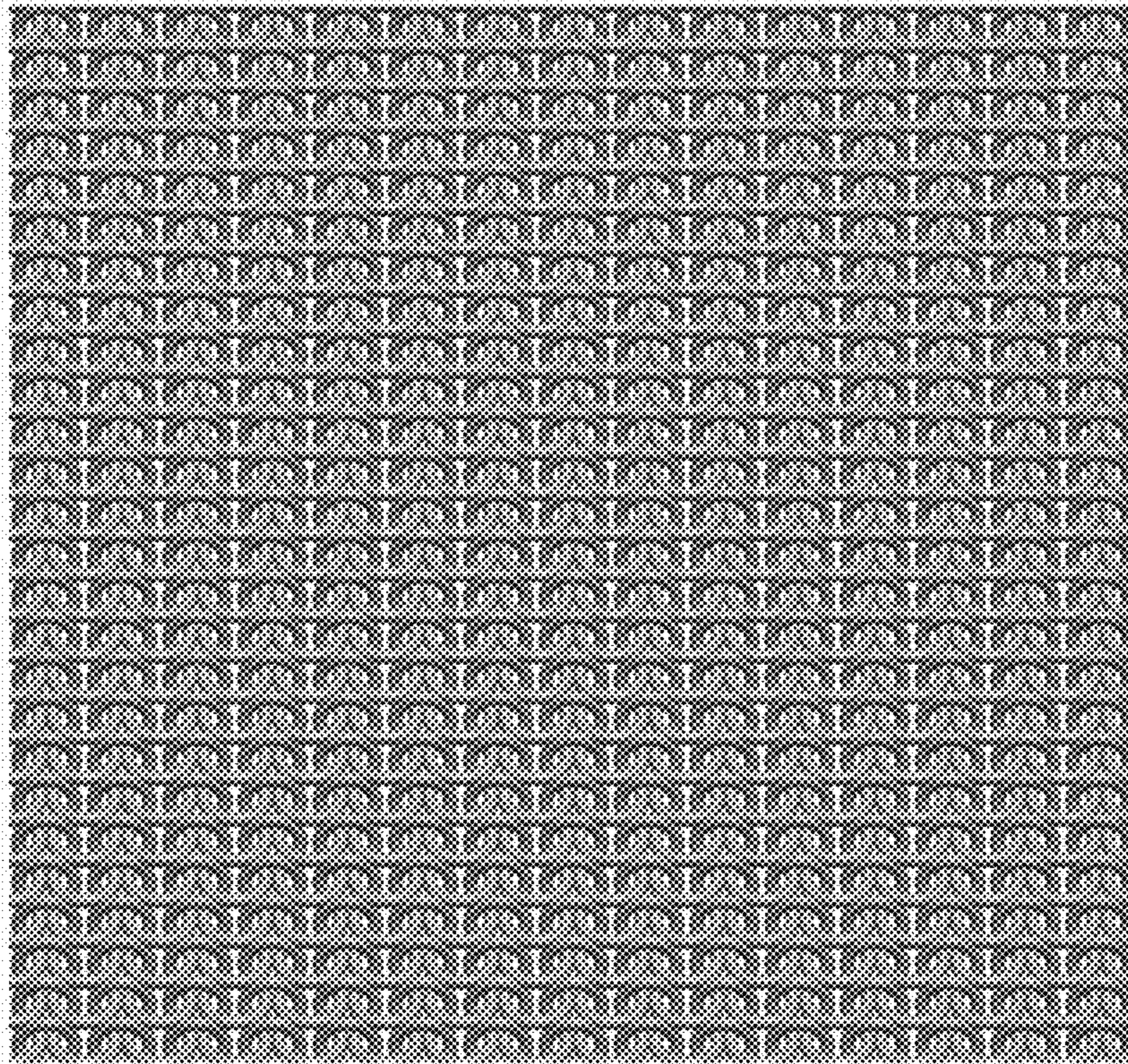

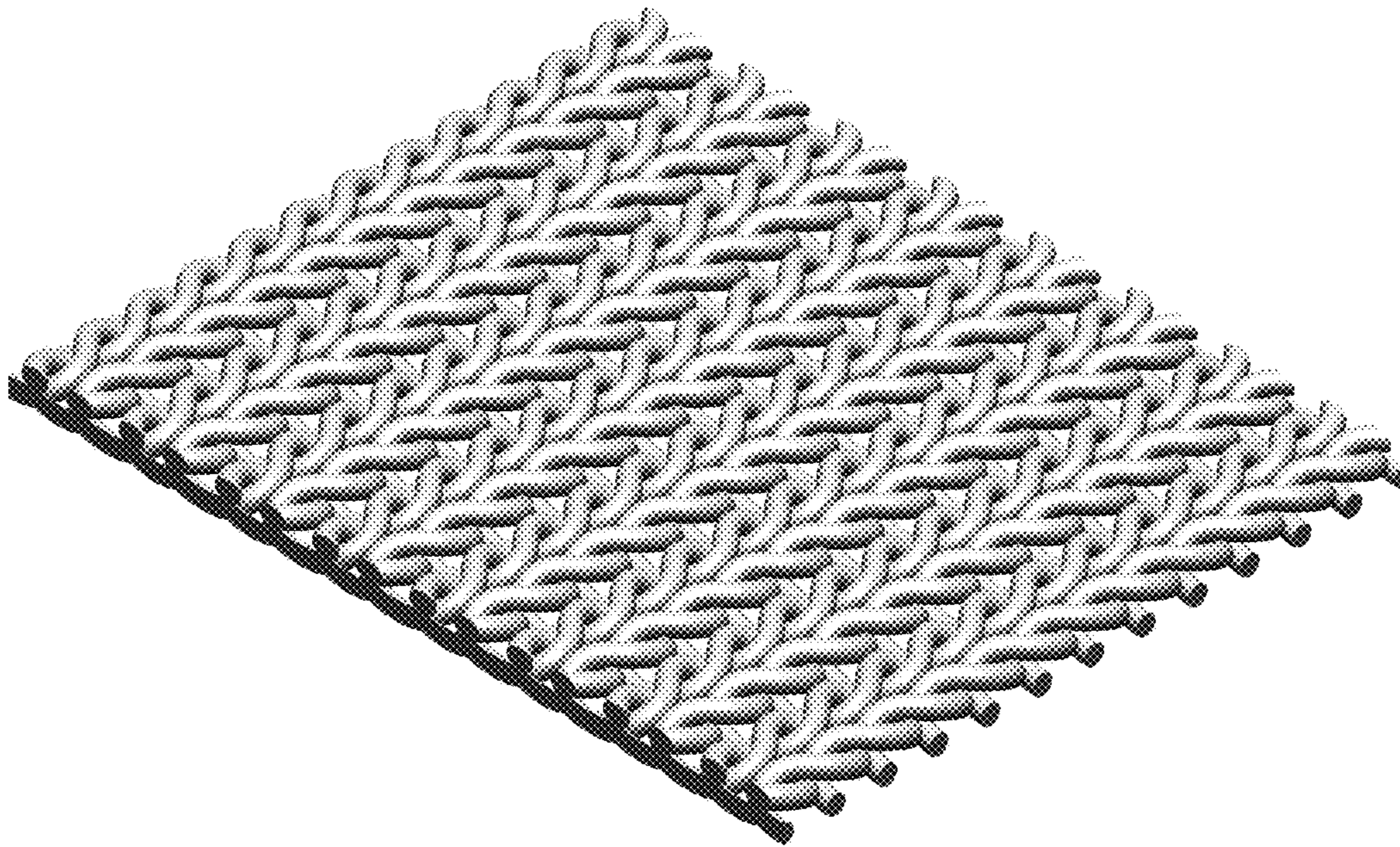

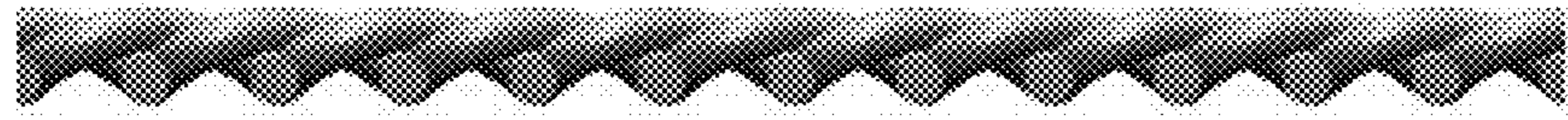

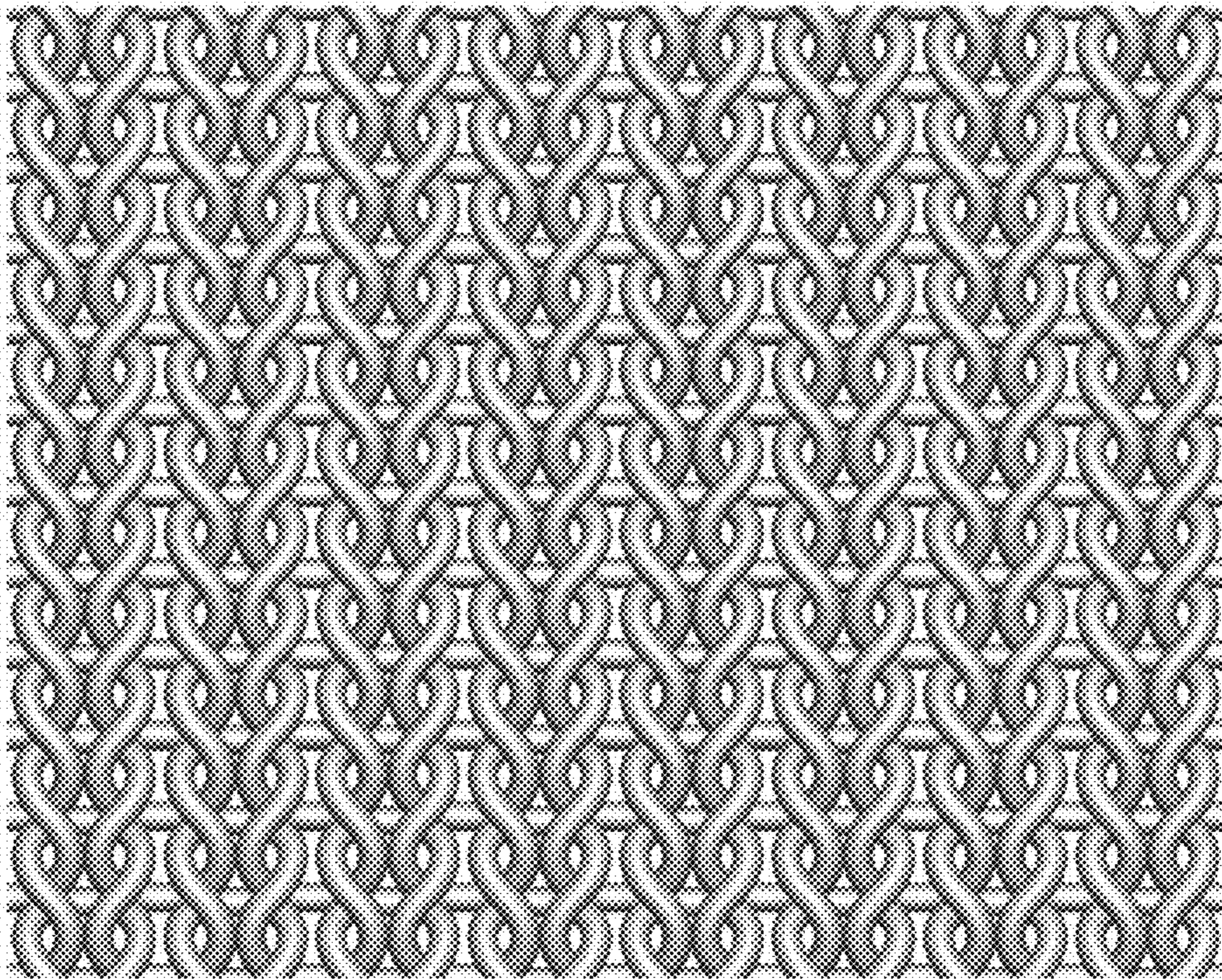

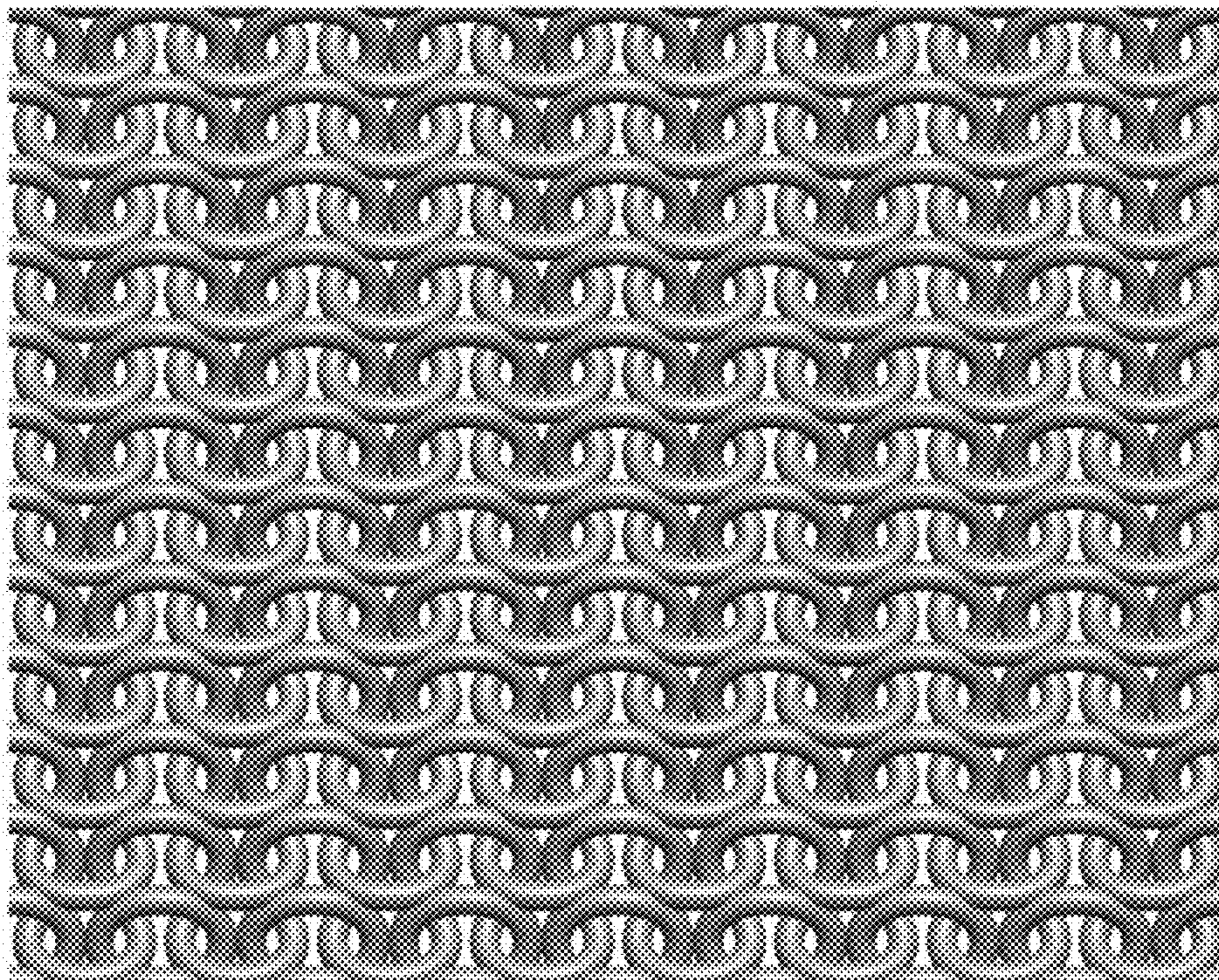

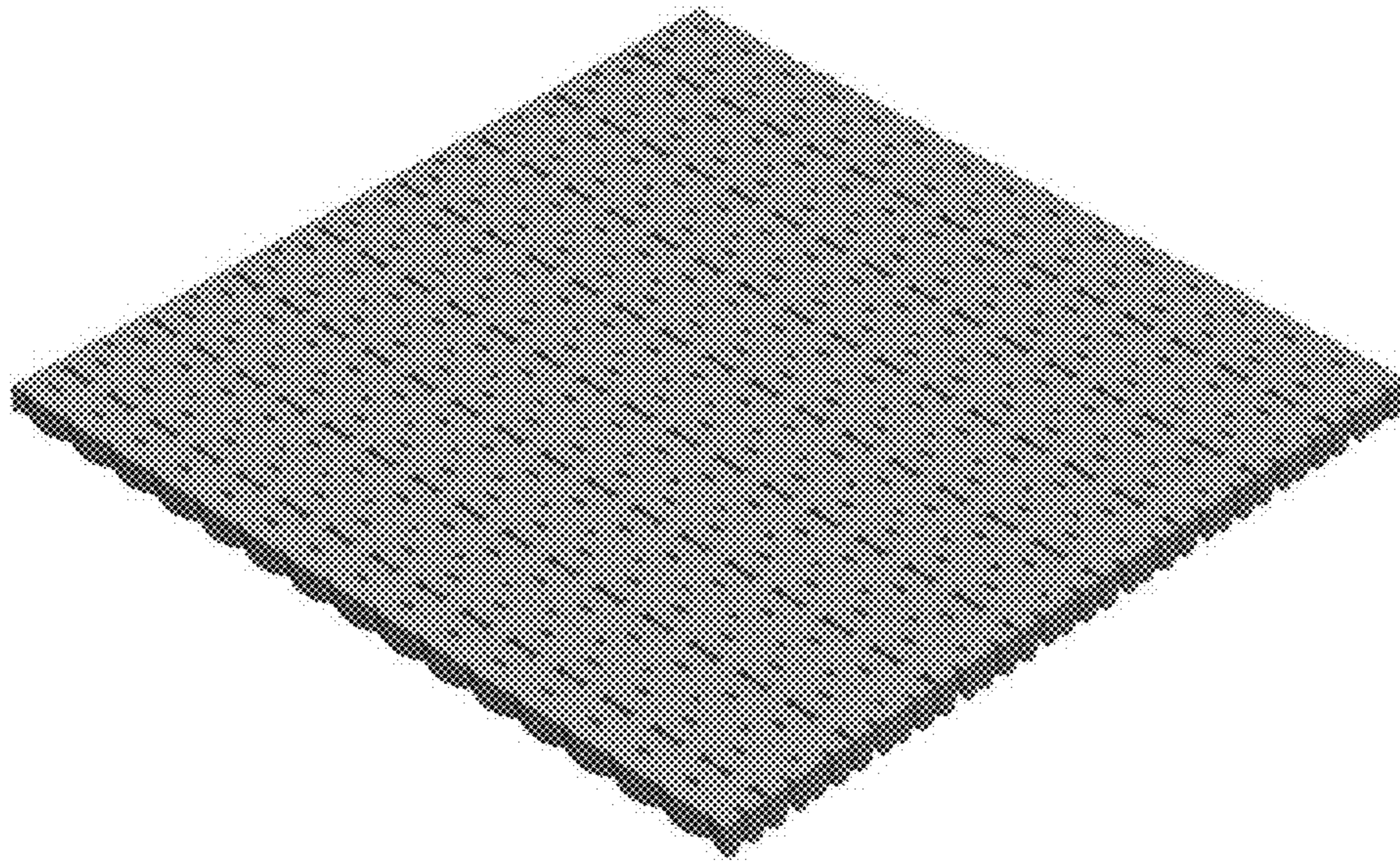

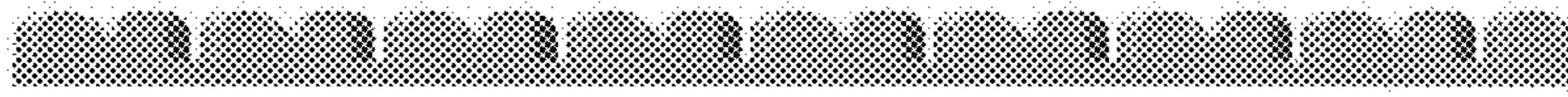

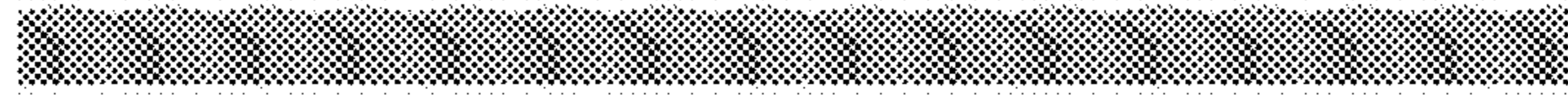

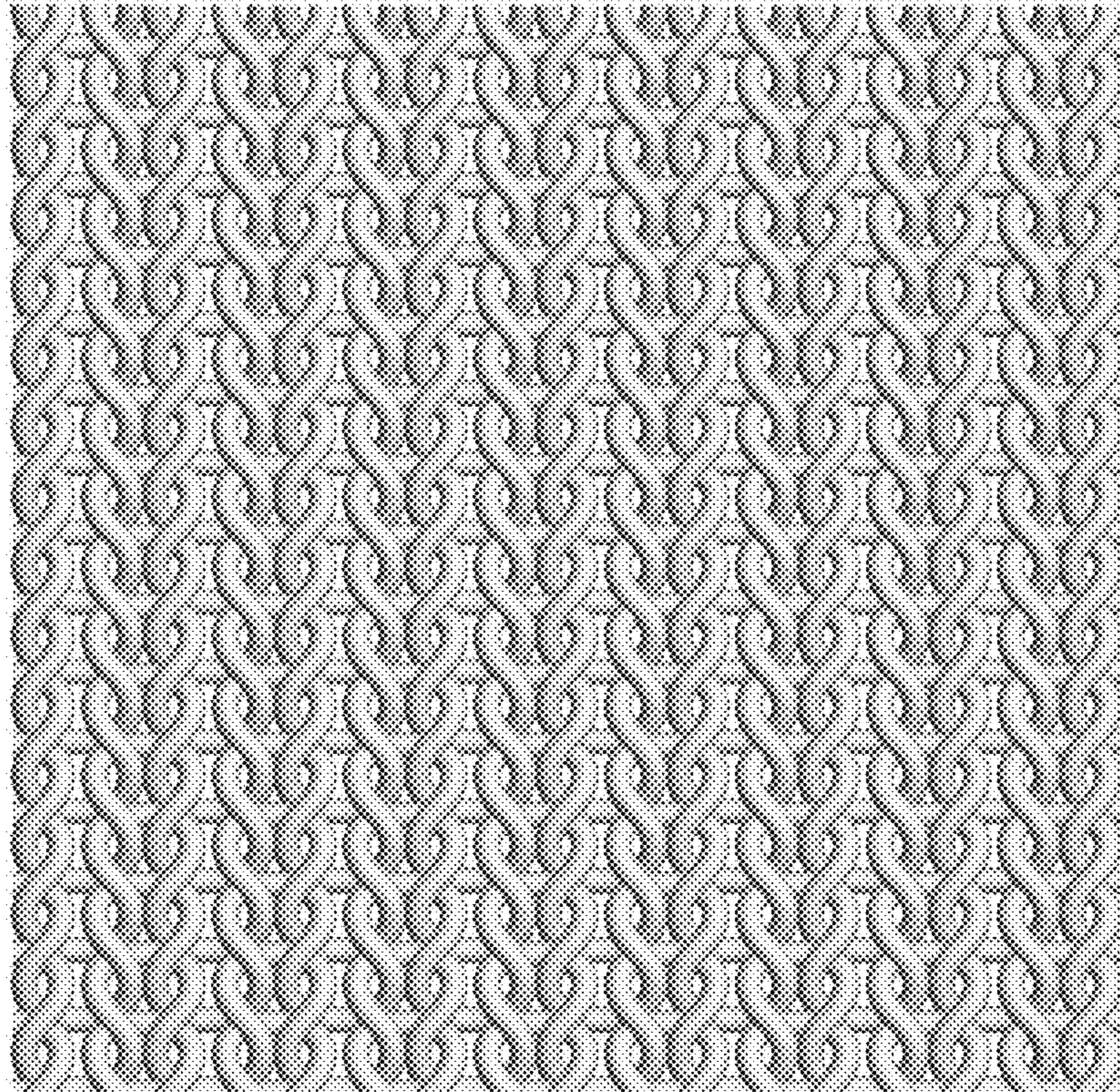

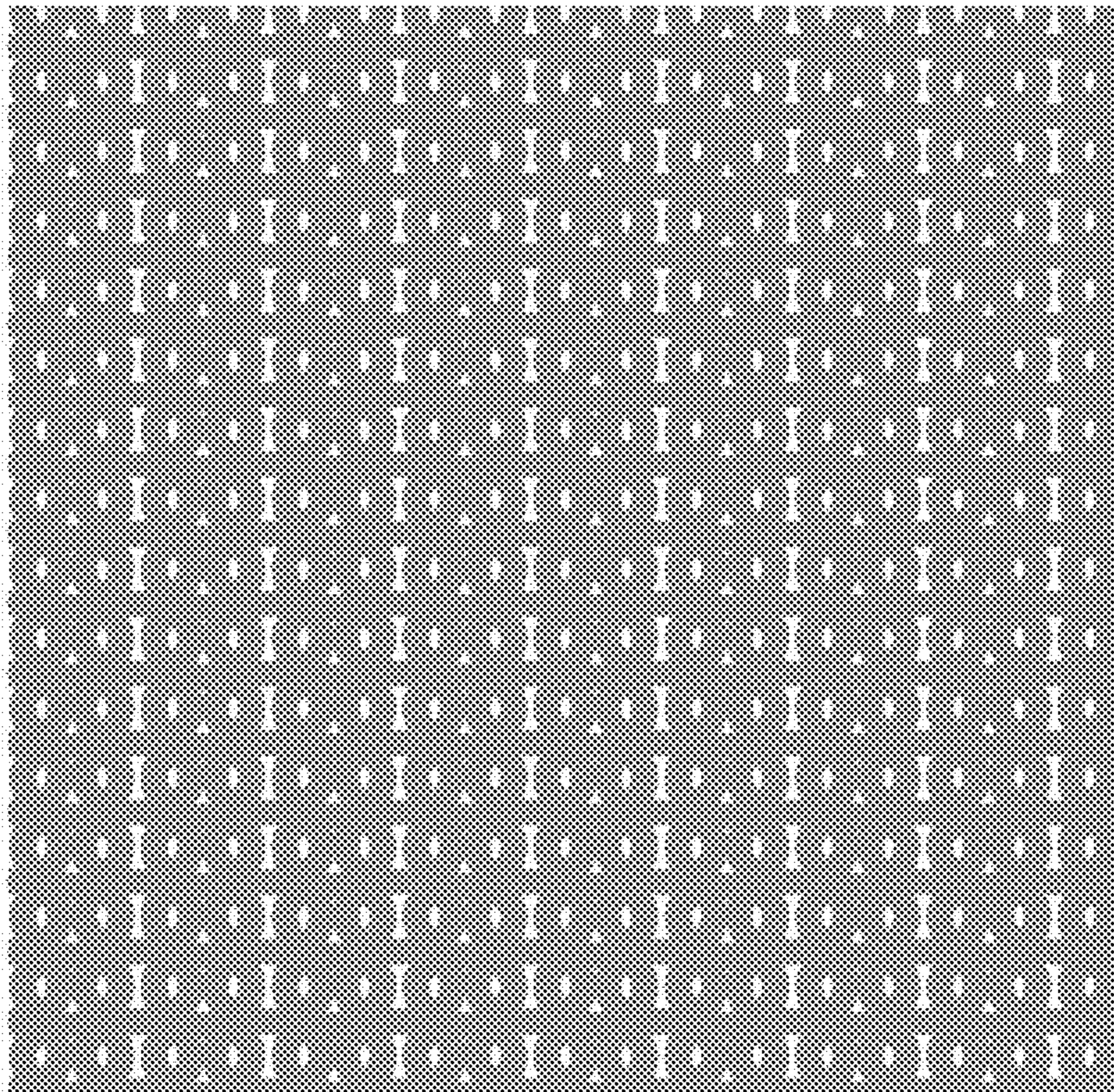
