**DESCRIPTION**

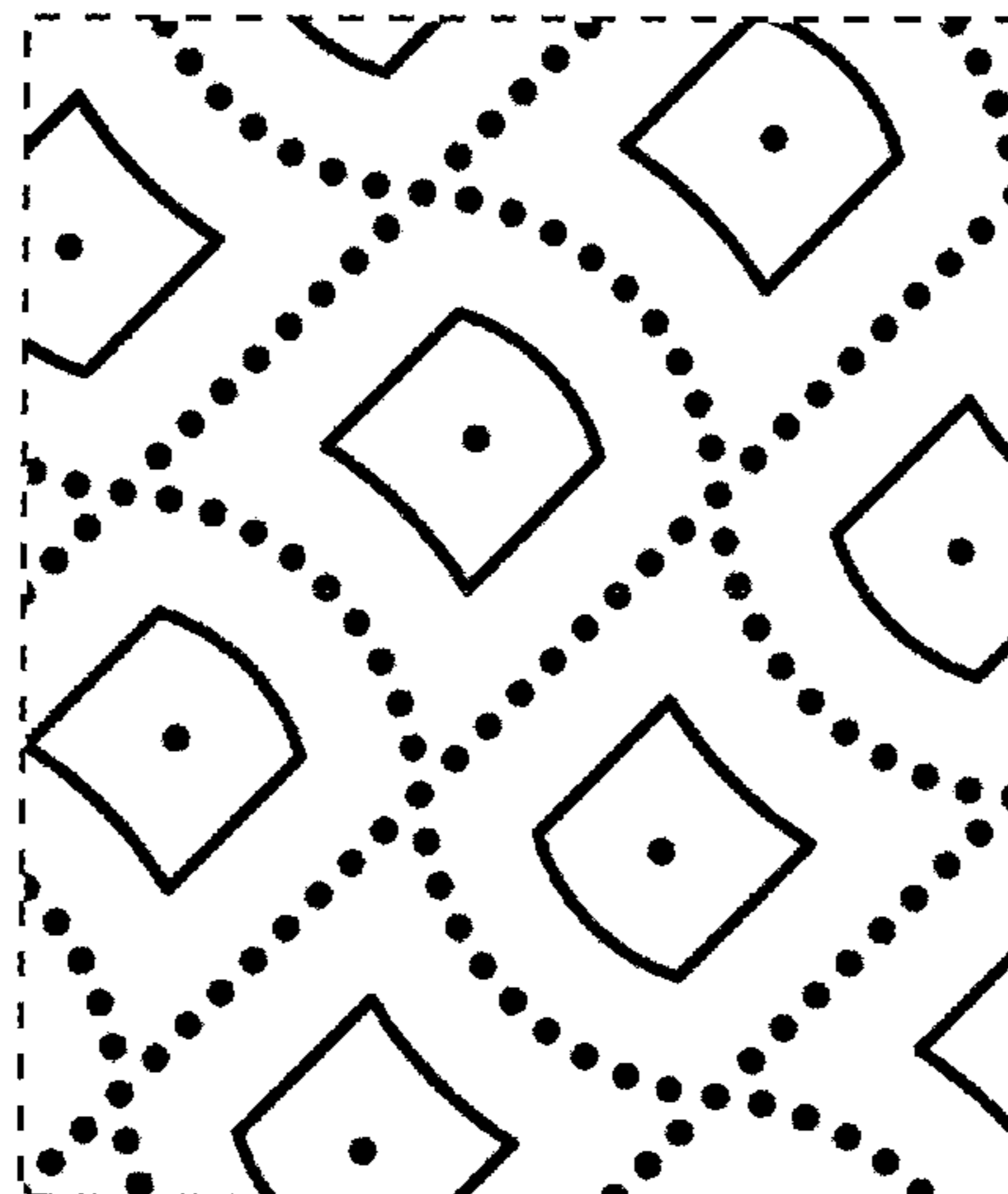
The FIGURE is a plan view of one side of a paper product with embossing pattern.
