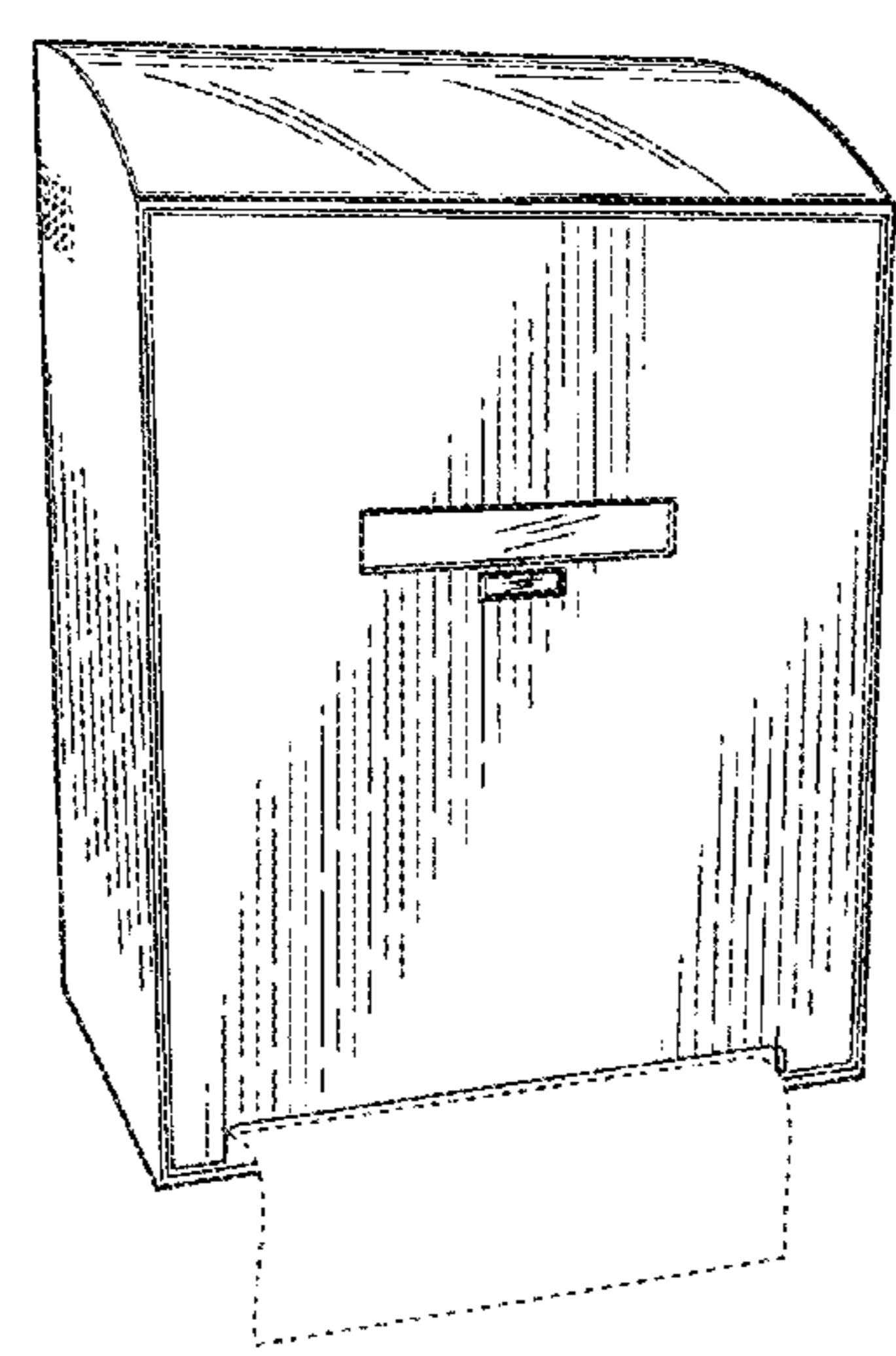

(57) **CLAIM**  
The ornamental design for an automatic double roll tissue feeder, as shown and described.

**DESCRIPTION**  
FIG. 1 is a perspective view of the automatic double roll tissue feeder showing my new design;  
FIG. 2 is a perspective view thereof, with the front and top housing removed;  
FIG. 3 is a front elevation view thereof;  
FIG. 4 is a rear elevation view thereof;  
FIG. 5 is a right elevation view thereof;  
FIG. 6 is a left elevation view thereof;  
FIG. 7 is a top plan view thereof; and,  
FIG. 8 is a bottom plan view thereof.  
Broken lines are included for the purpose of illustrating portions of the automatic double roll tissue feeder and form no part of the claimed design.

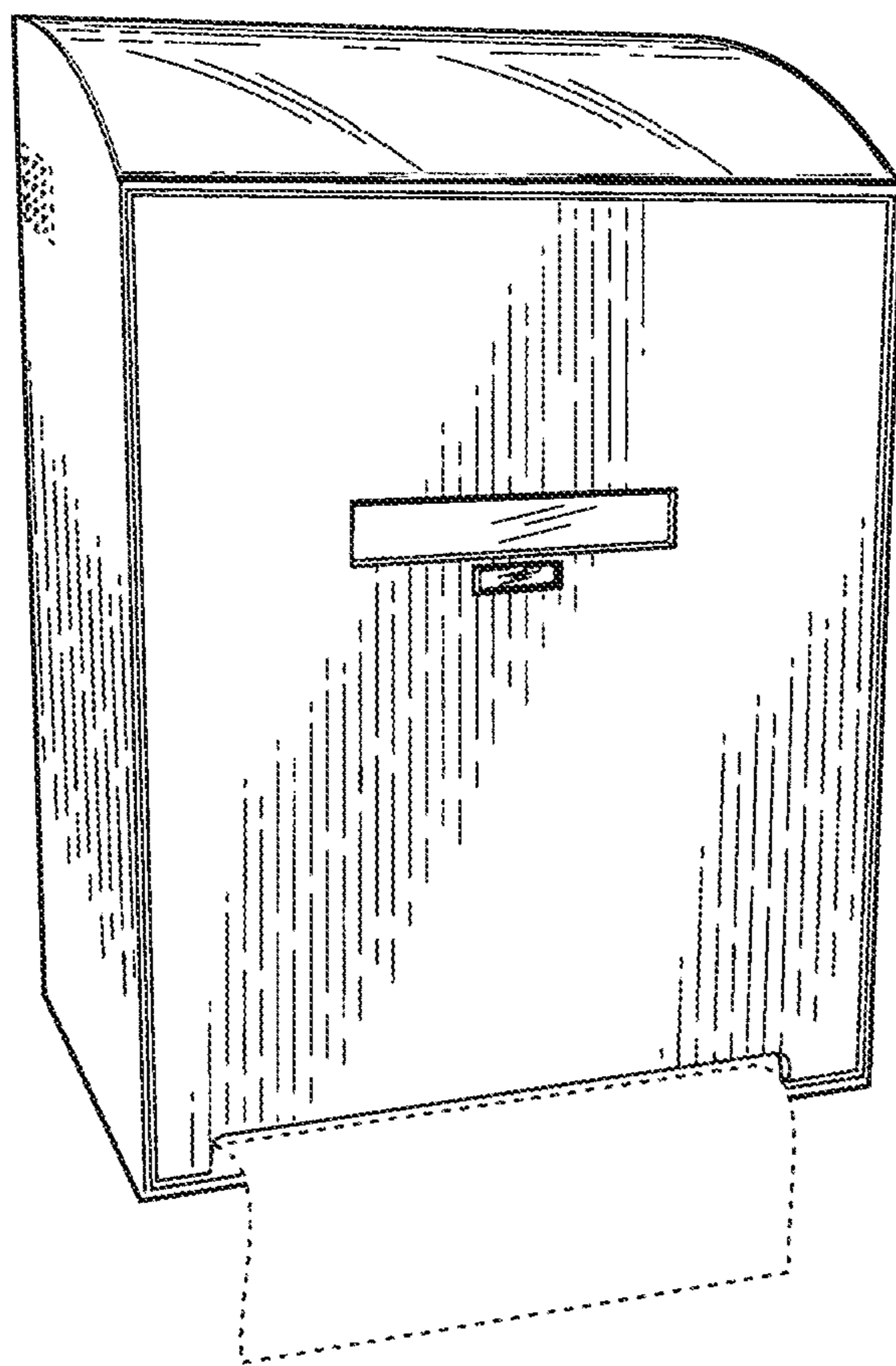

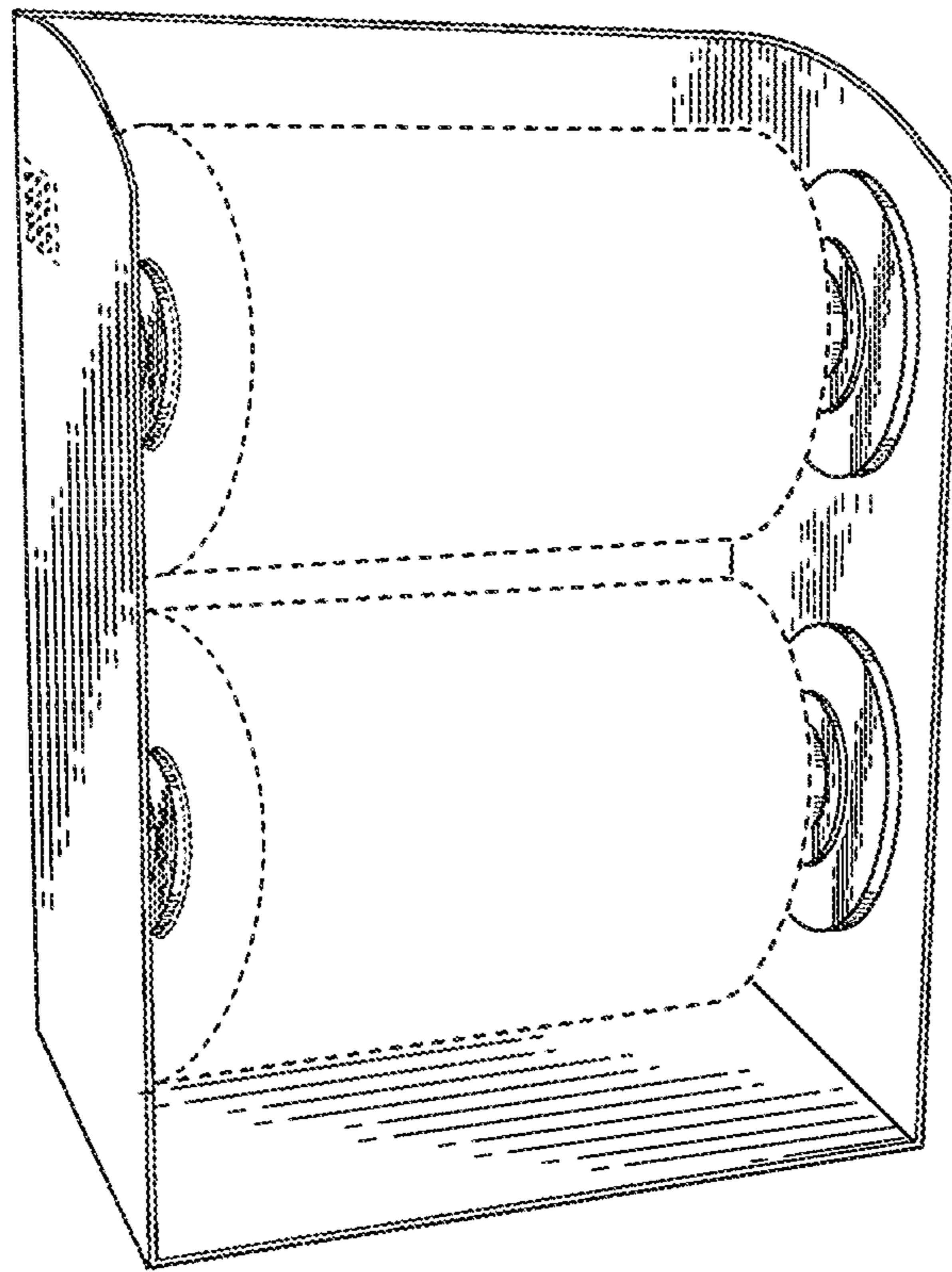

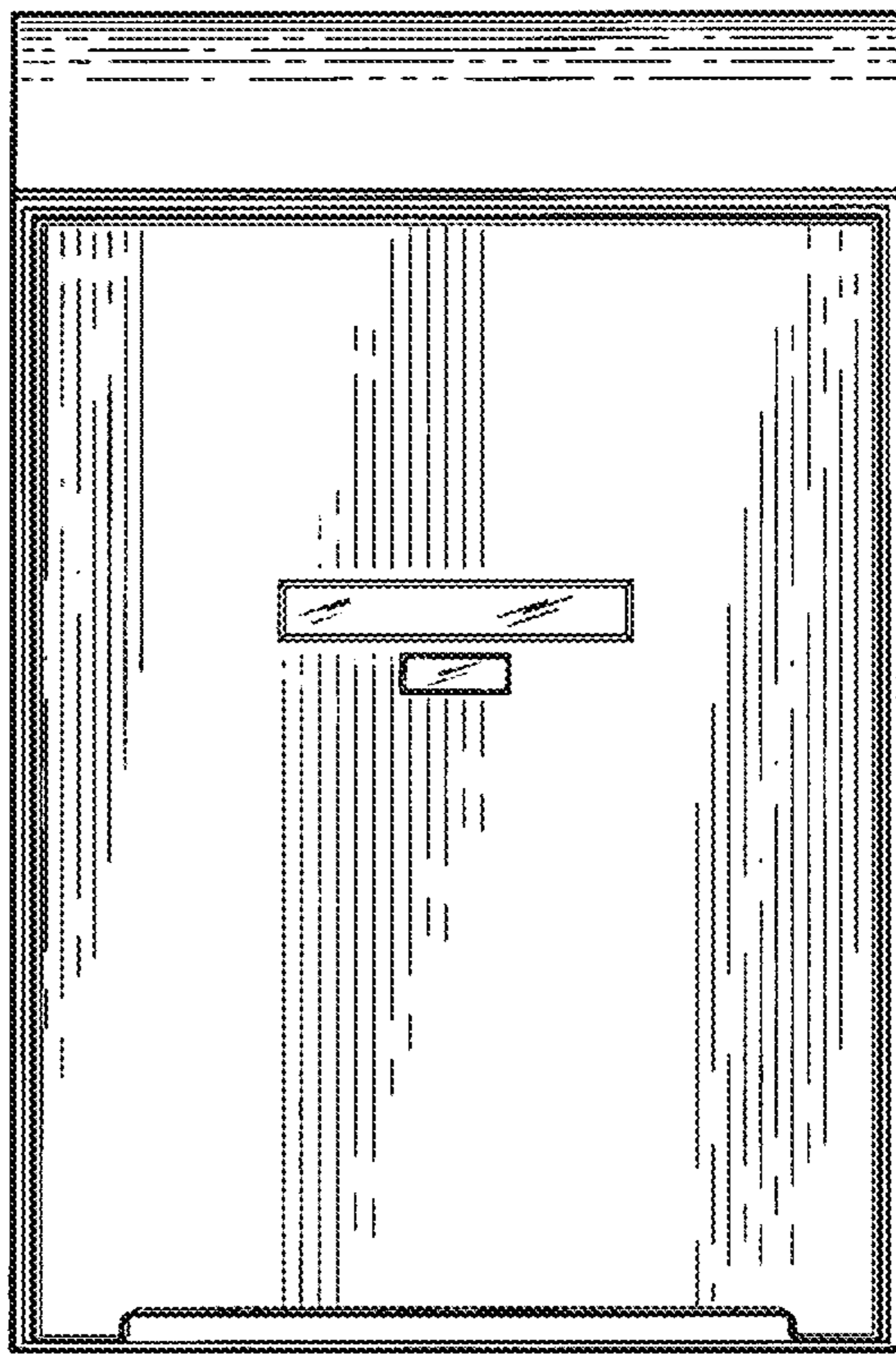

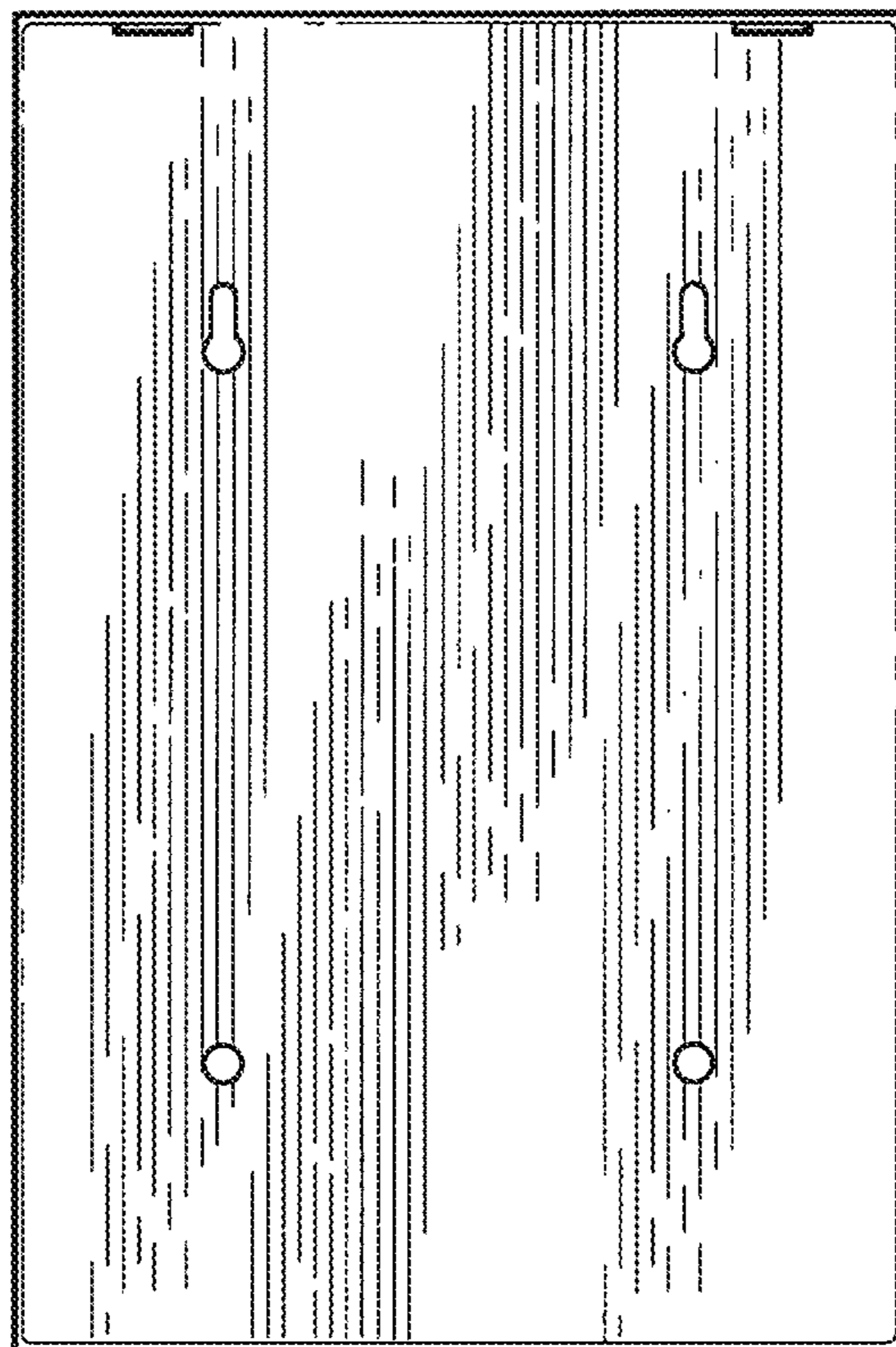

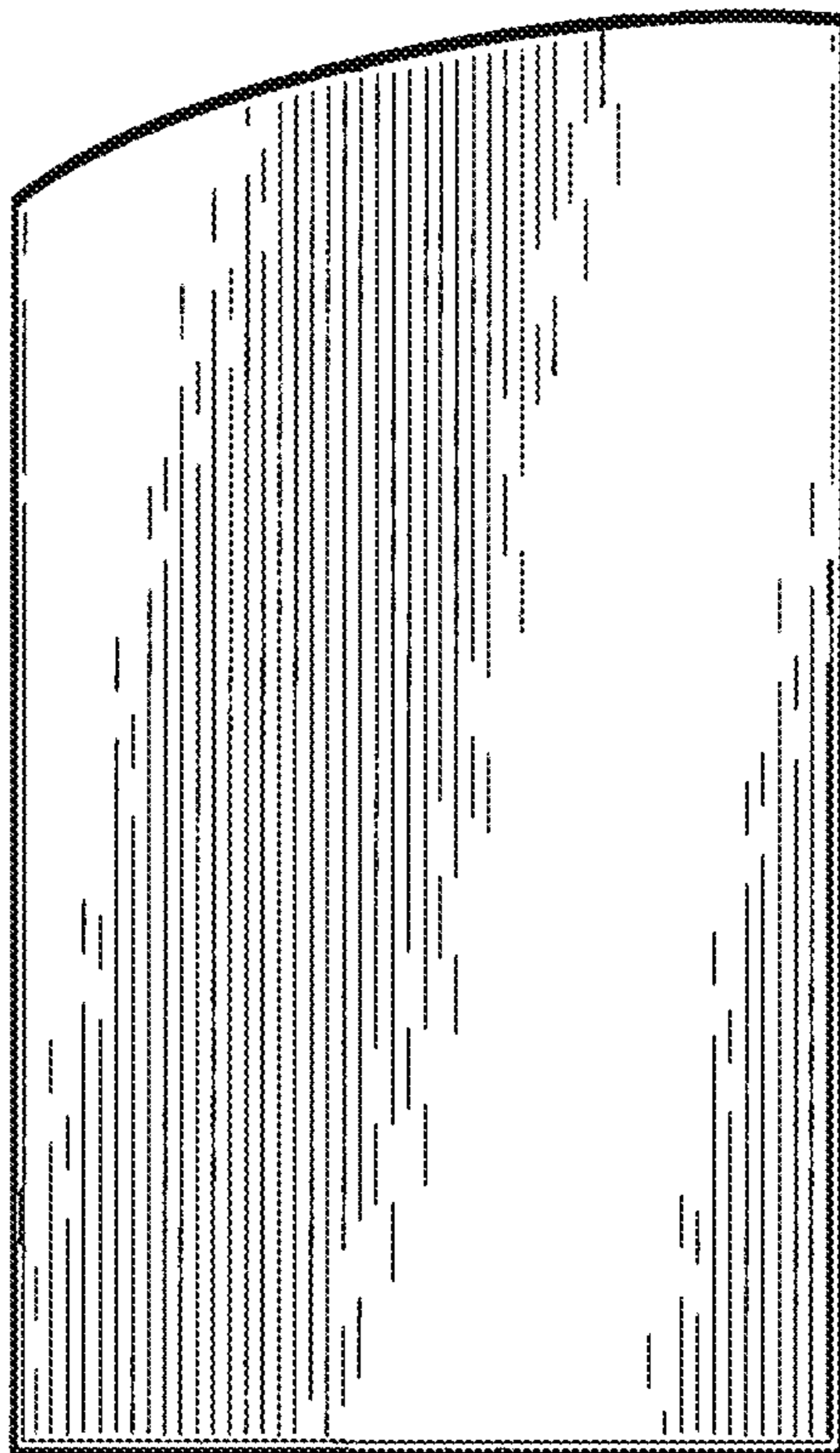

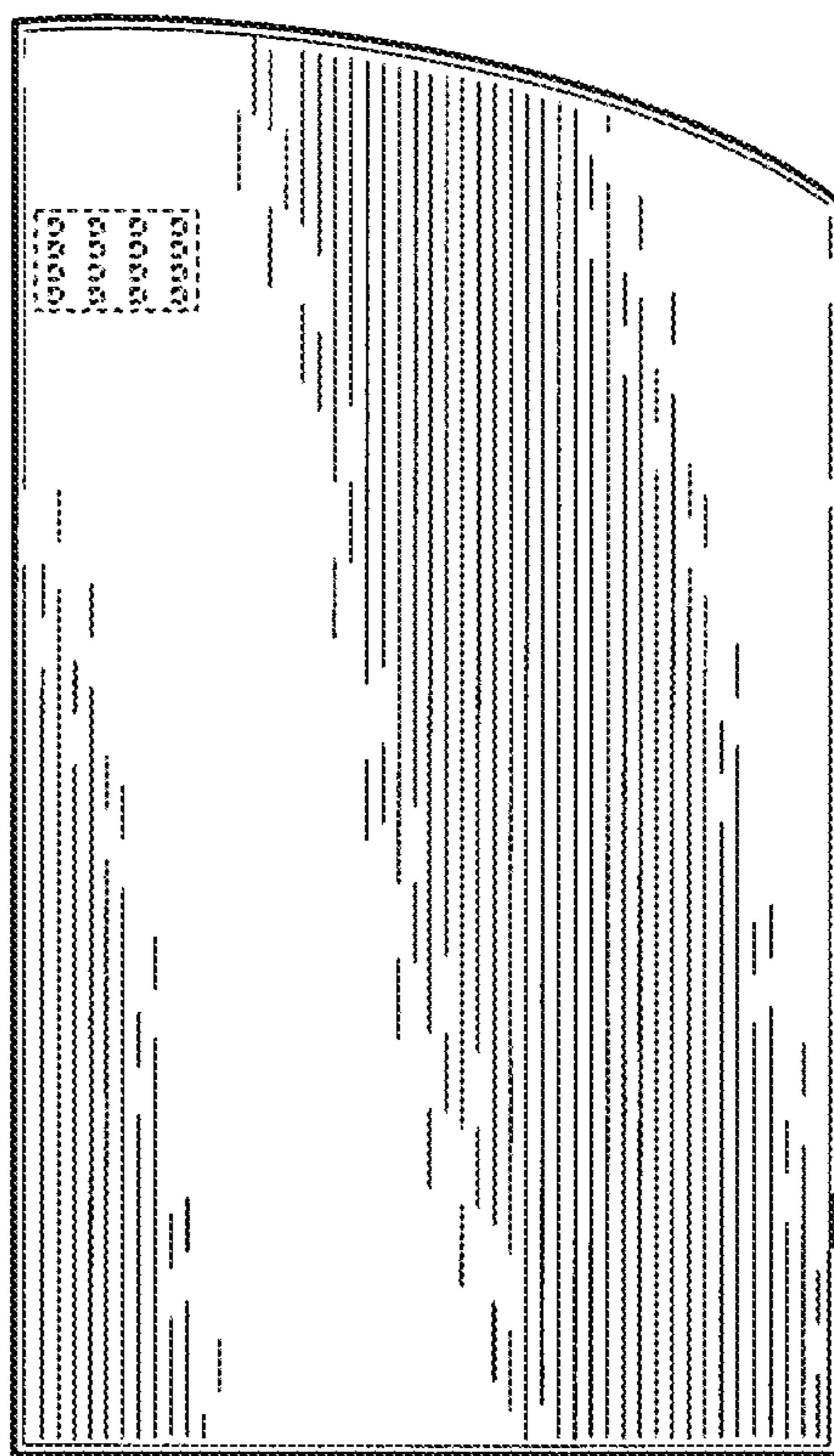

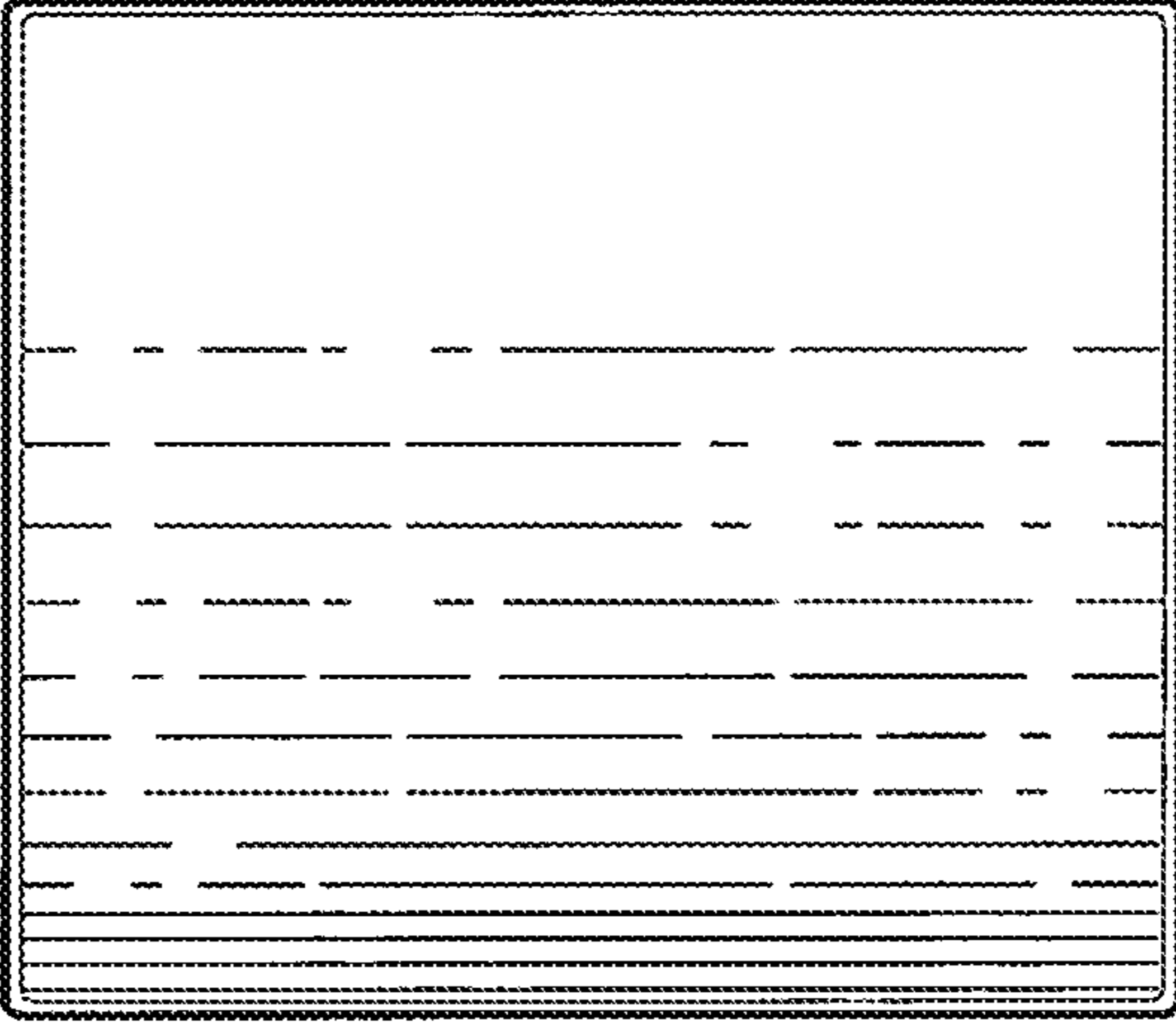

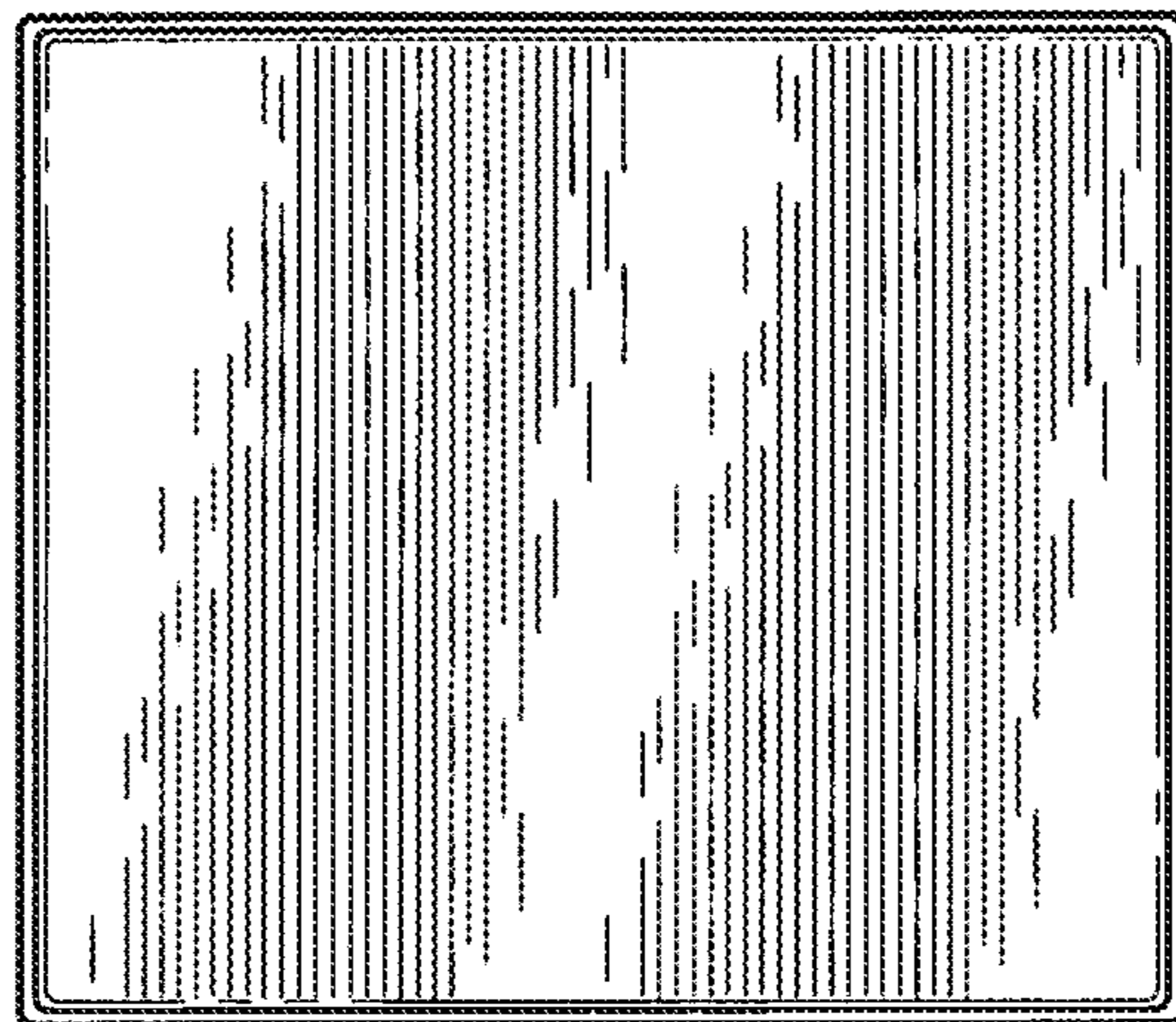
