The ornamental design for a desk, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of the top, front and right side of a desk showing our new design;
FIG. 2 is a front view thereof;
FIG. 3 is a rear view thereof;
FIG. 4 is a top view thereof;
FIG. 5 is a bottom view thereof;
FIG. 6 is a left side view thereof;
FIG. 7 is a right side view thereof; and,
FIG. 8 is a perspective view of the top, rear and left side thereof in a lifting state.

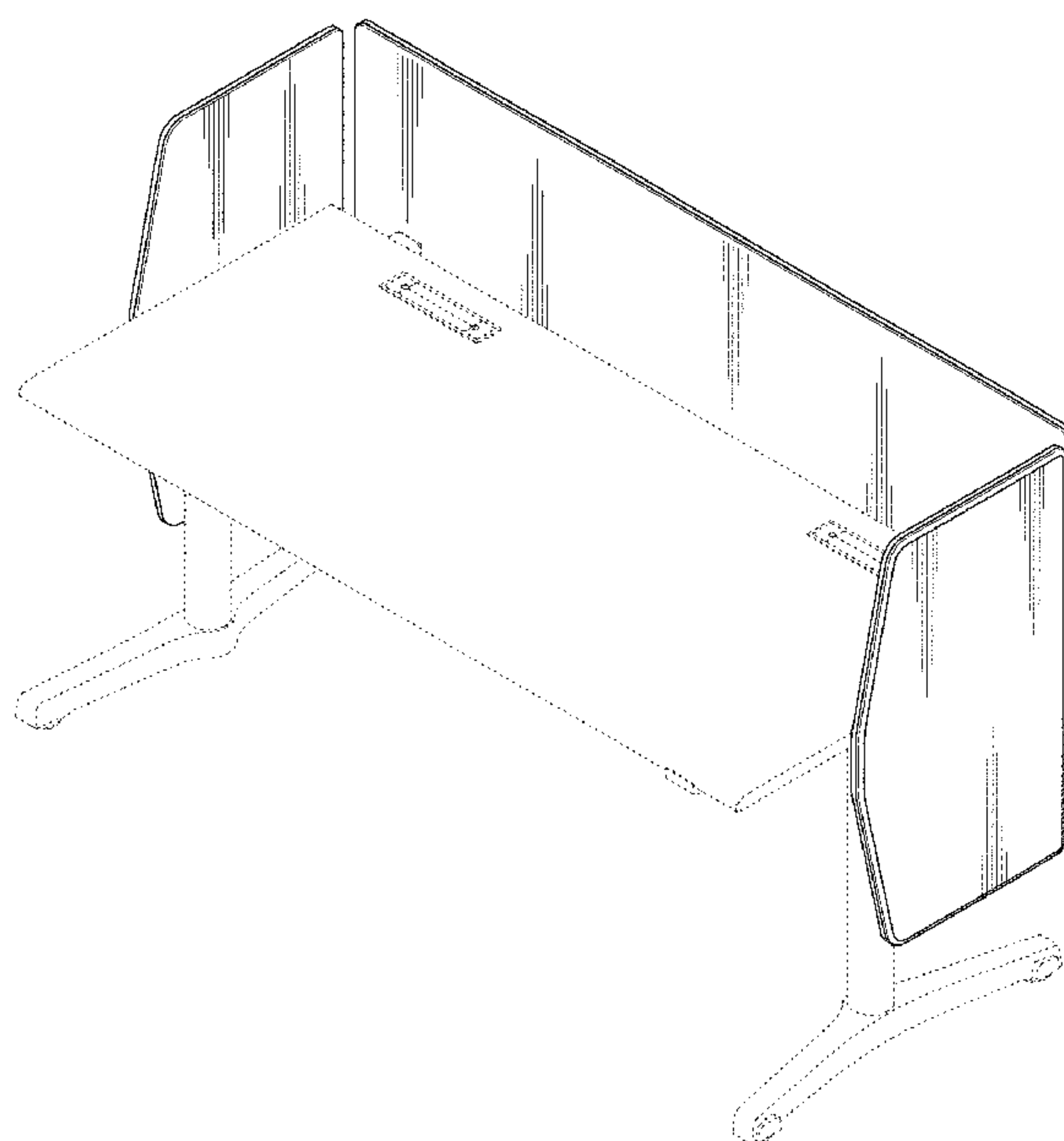

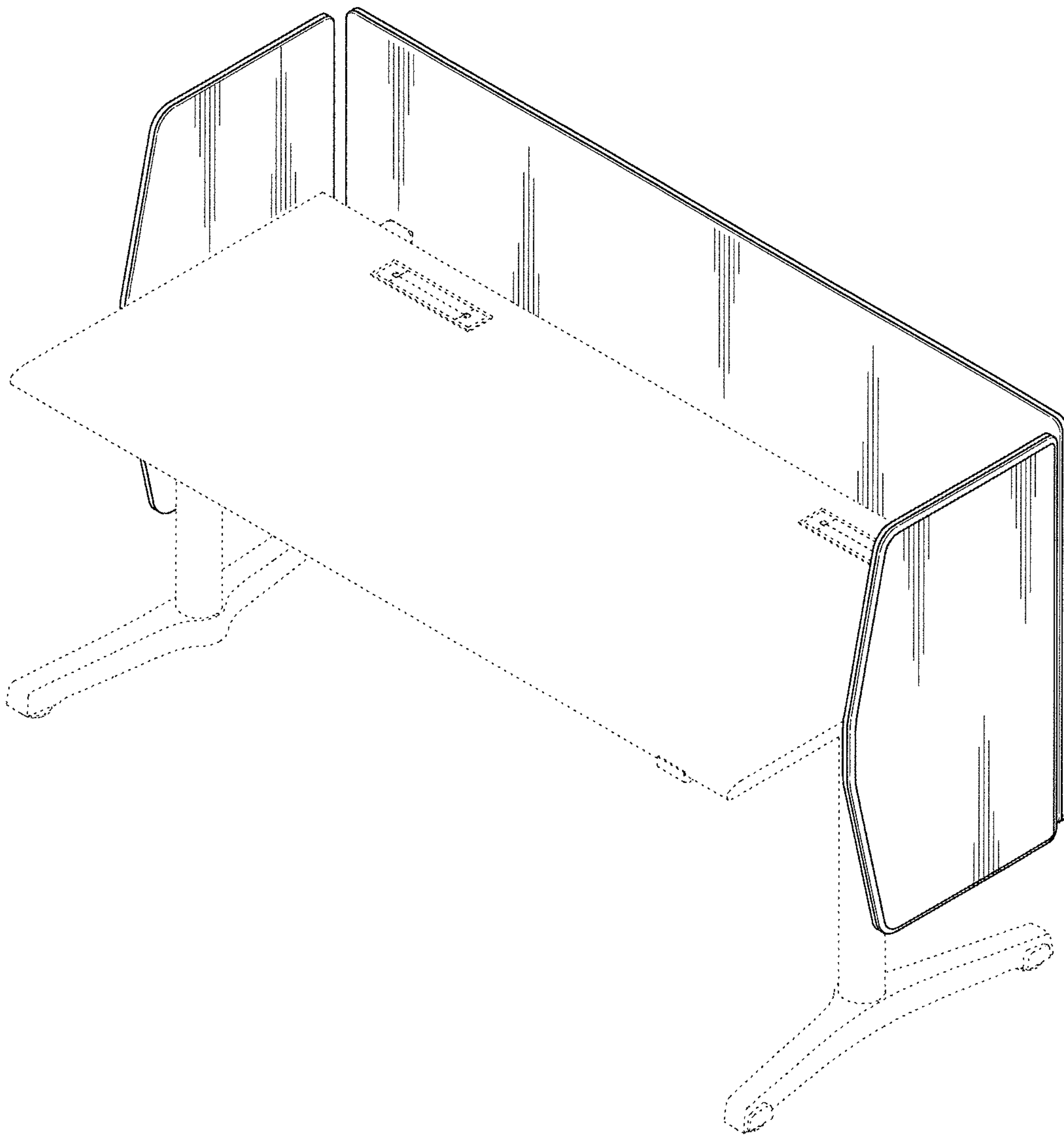

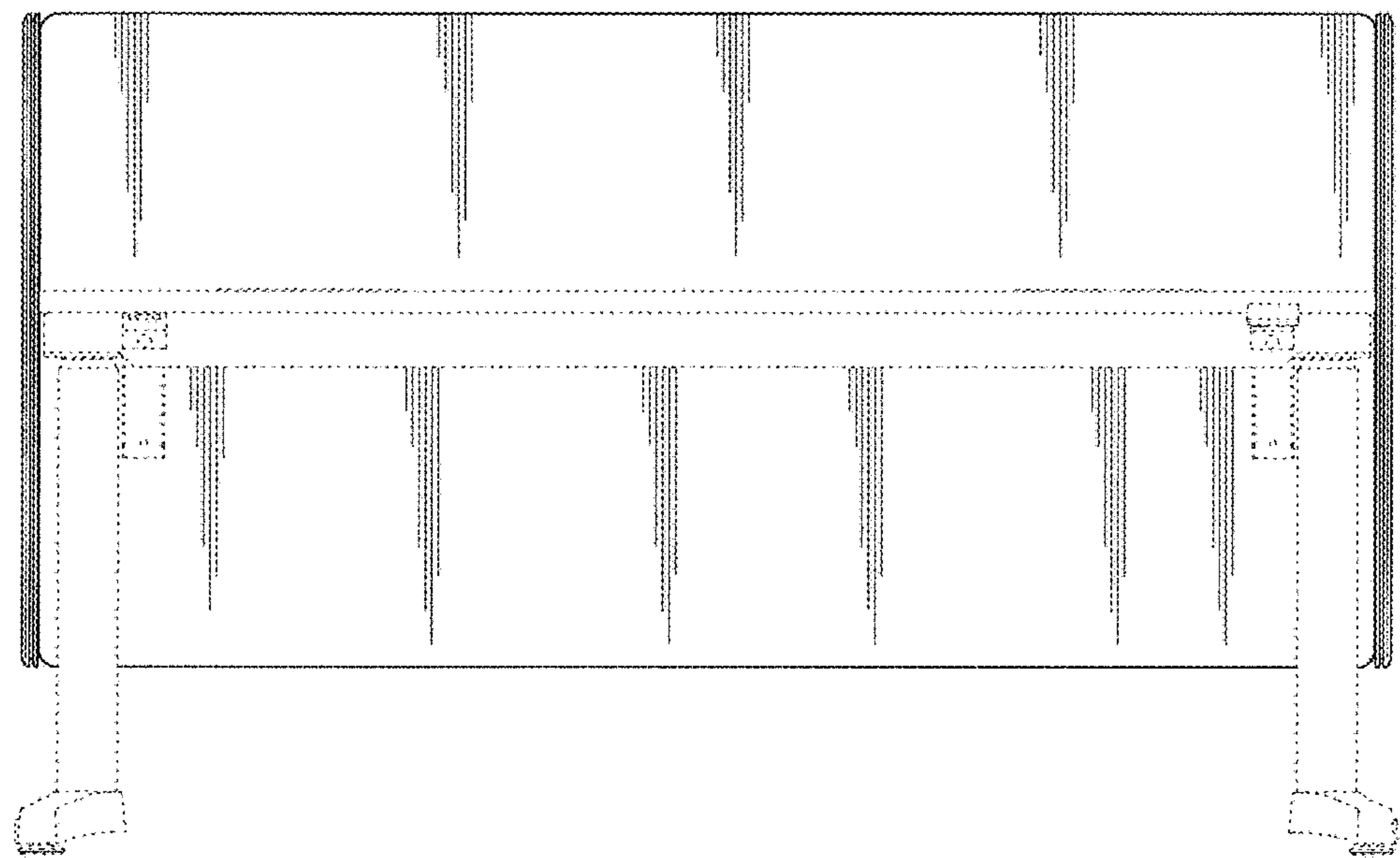

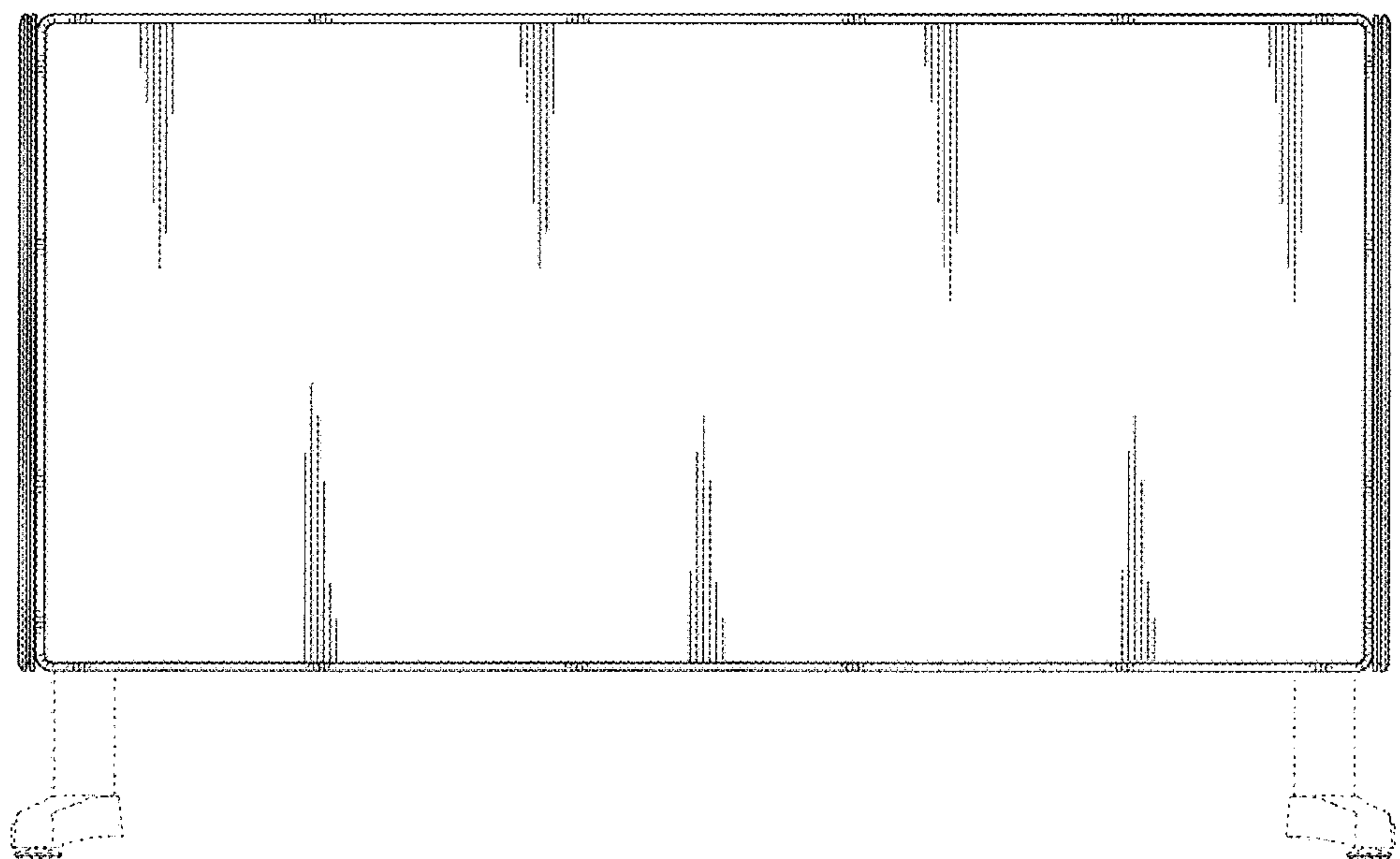

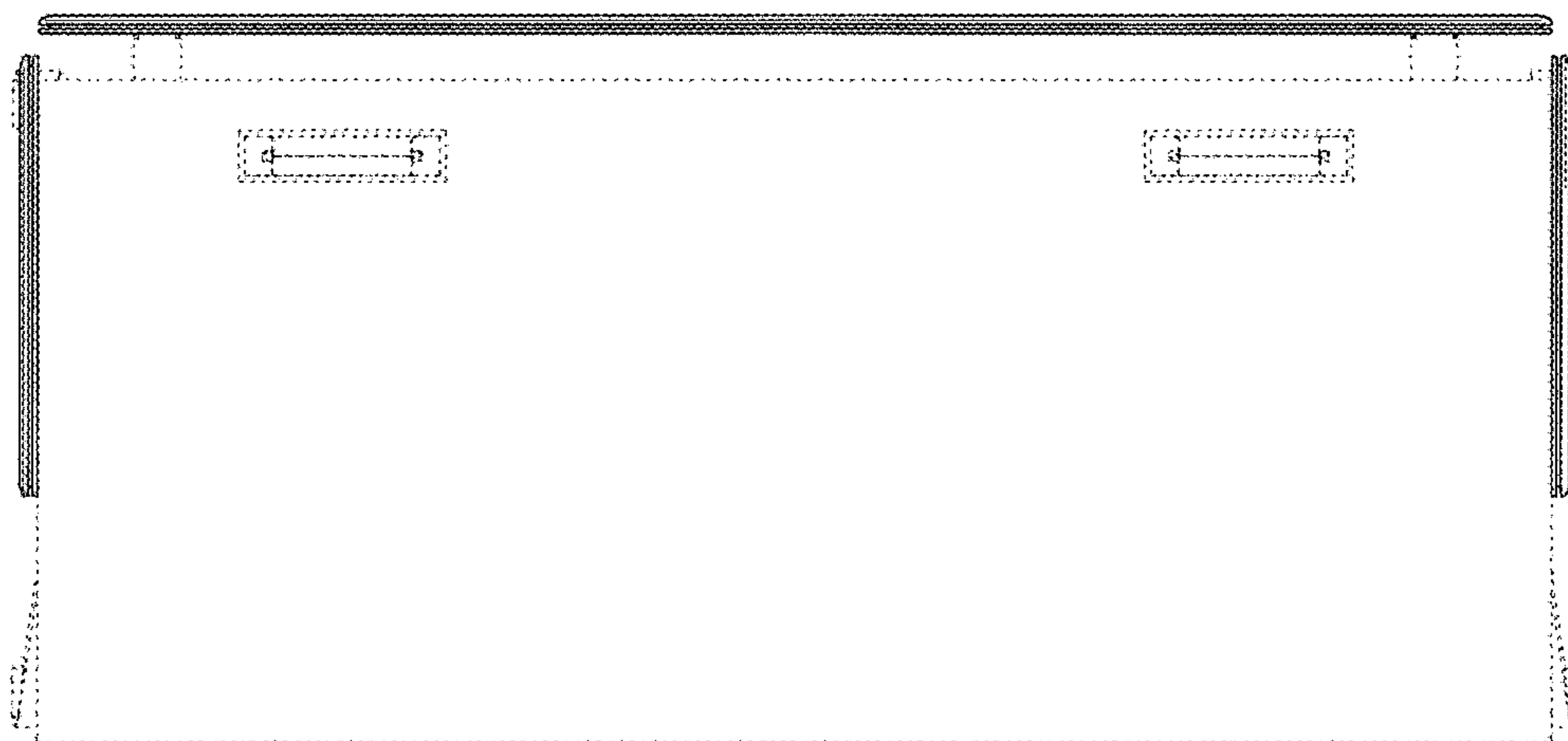

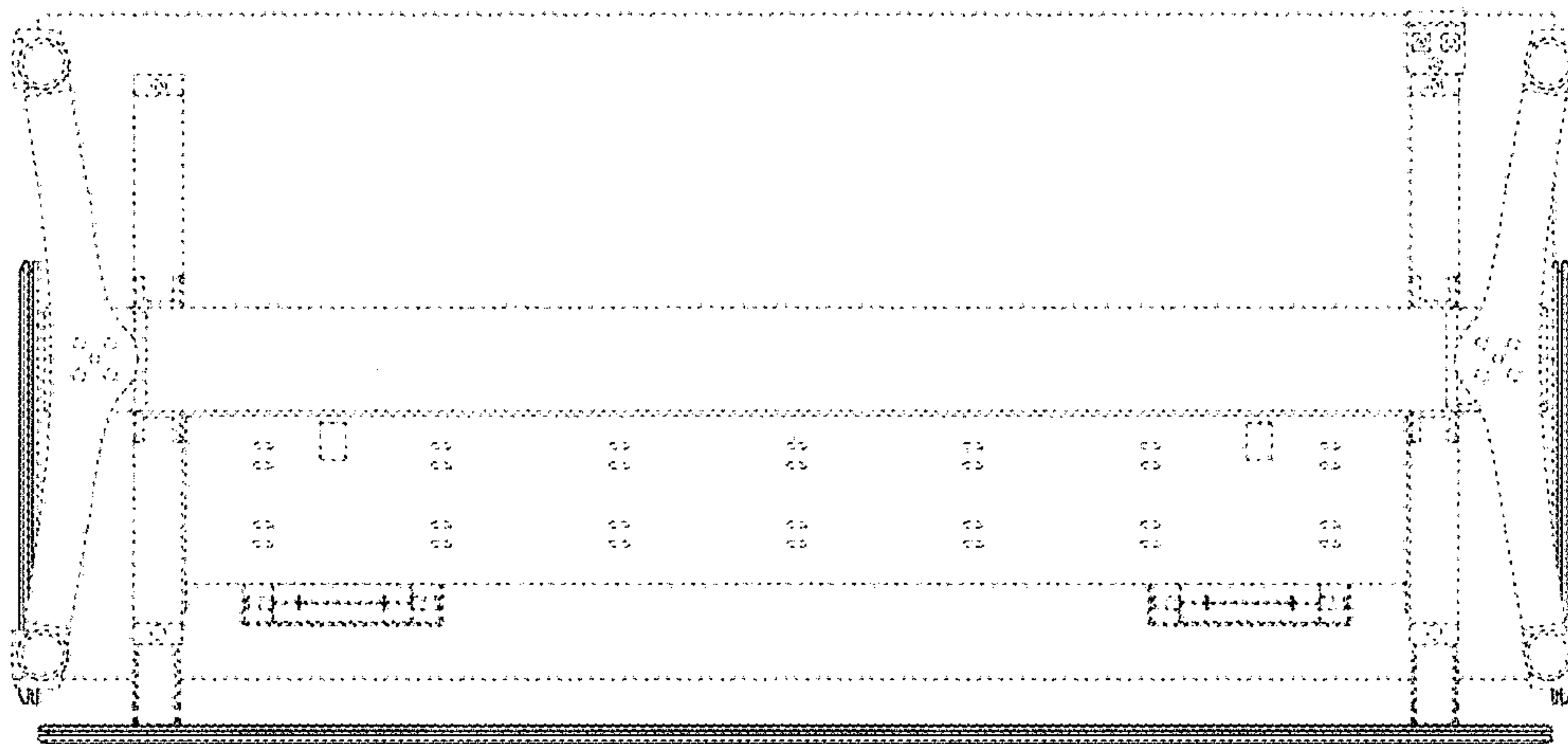

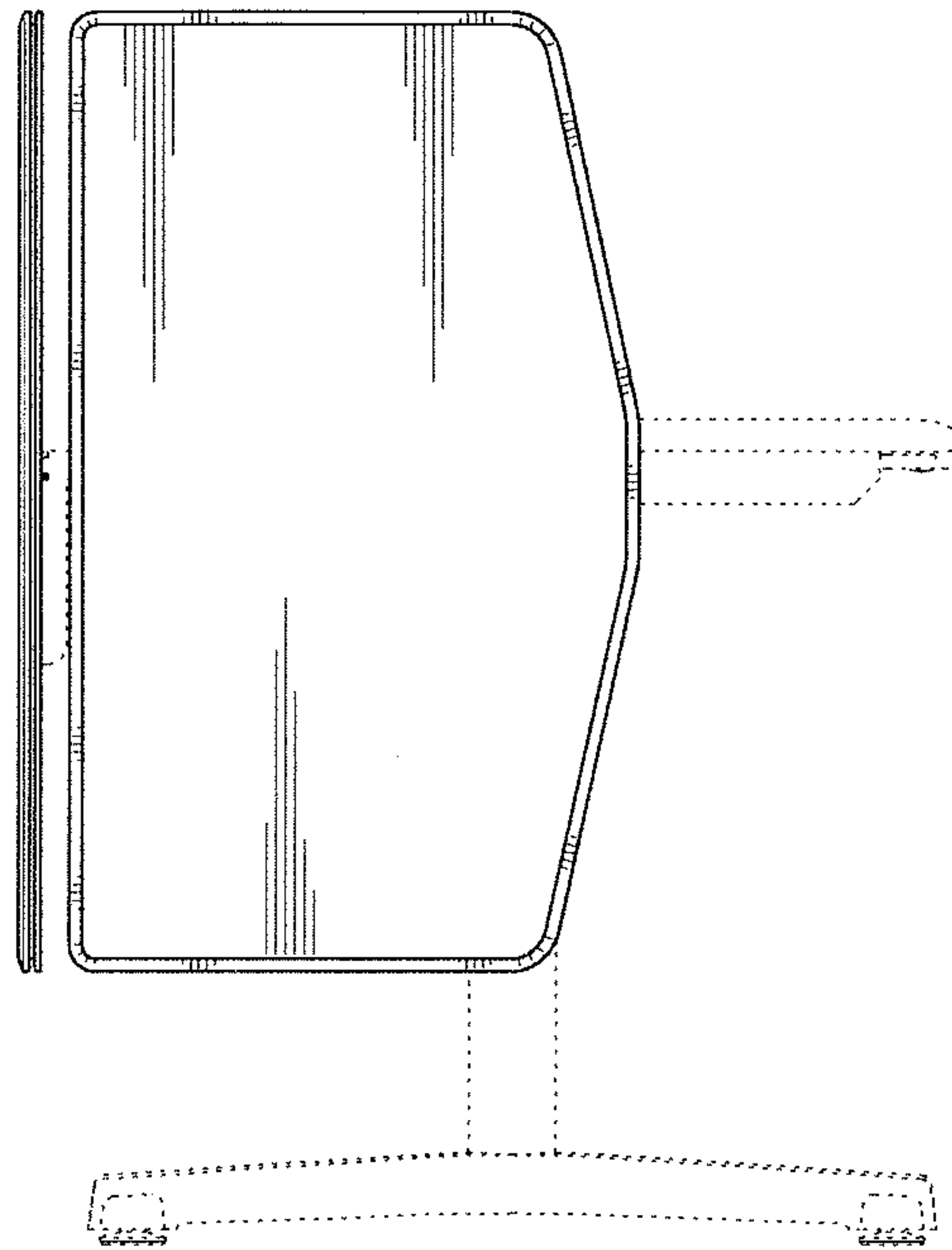

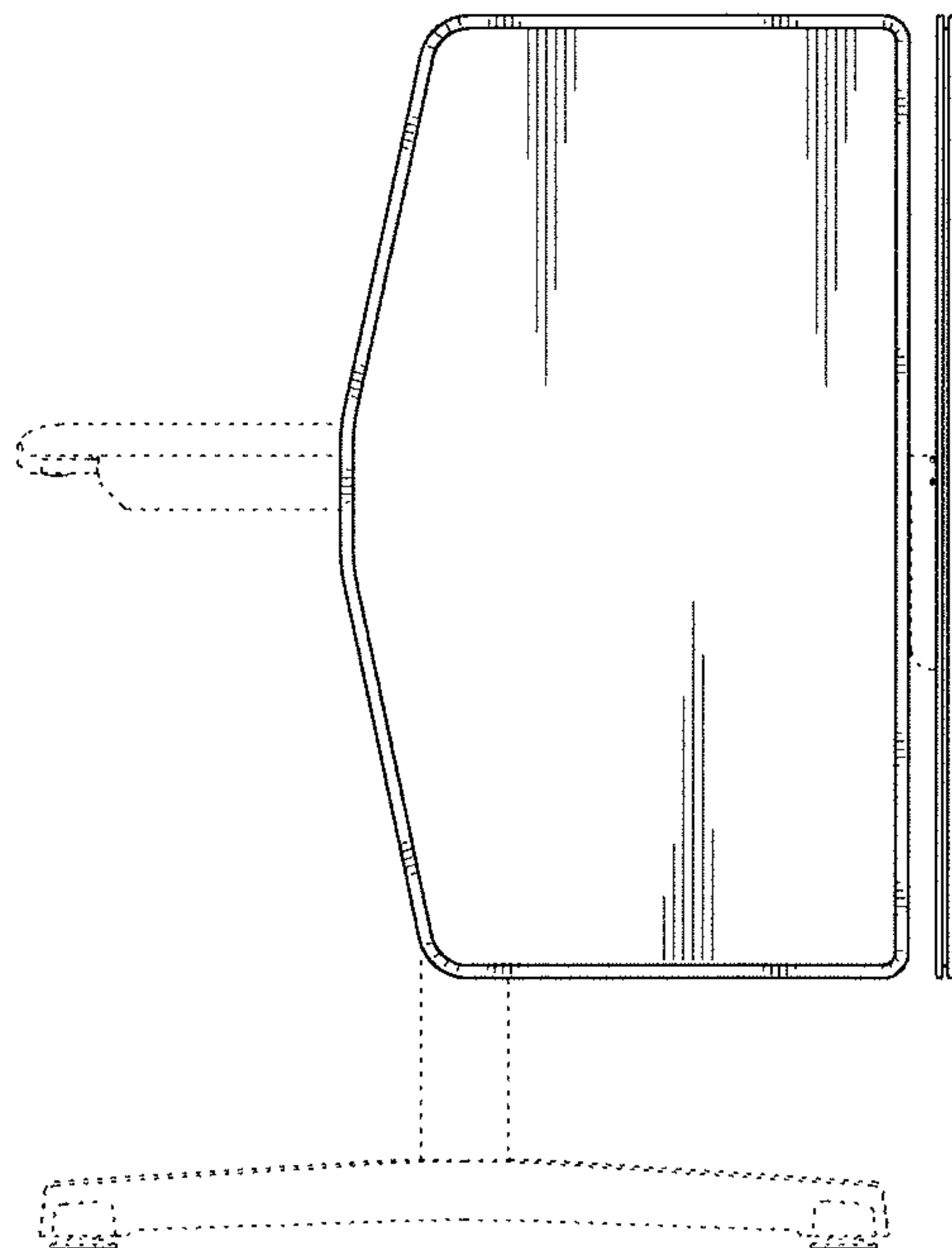
