FIG. 8 is an enlarged view of the encircled portion '8' in FIG. 5.

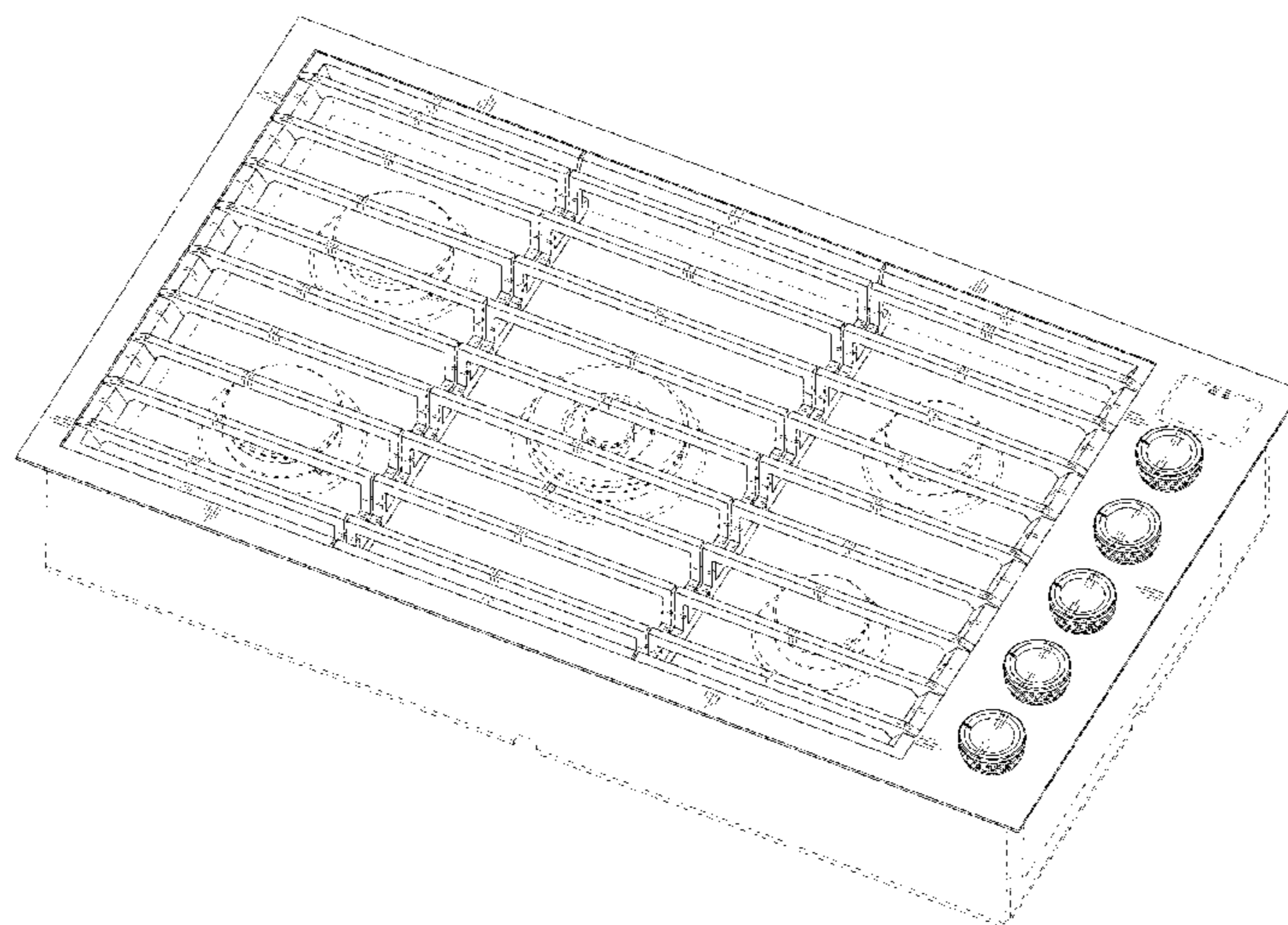

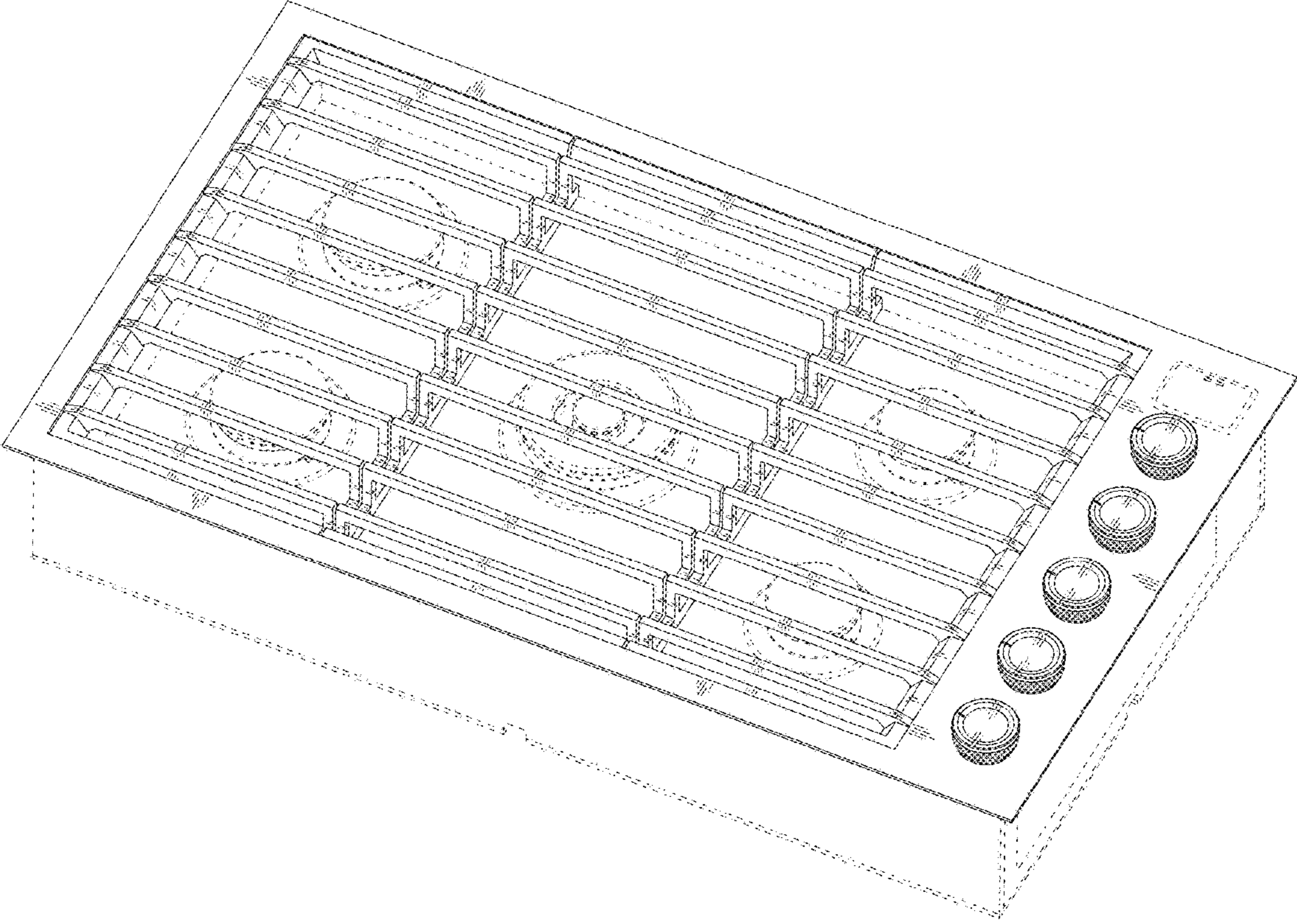

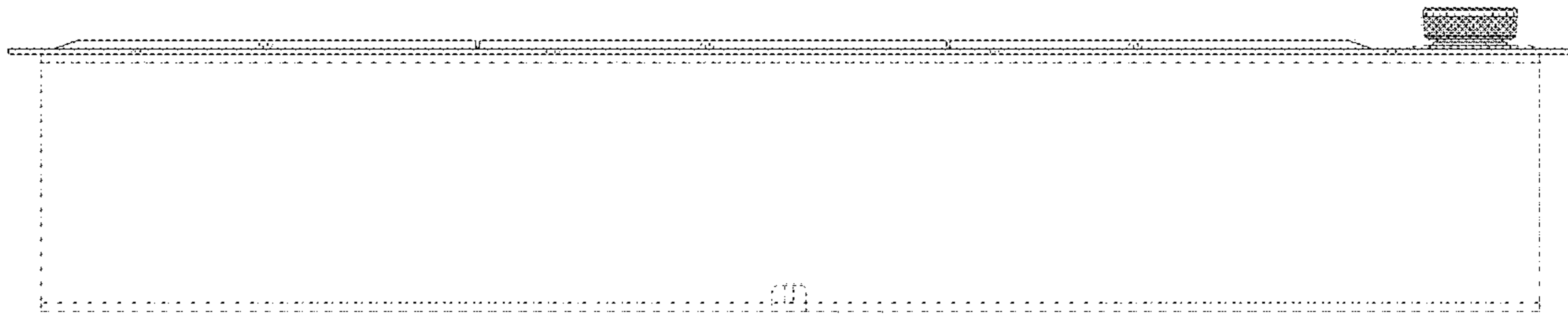

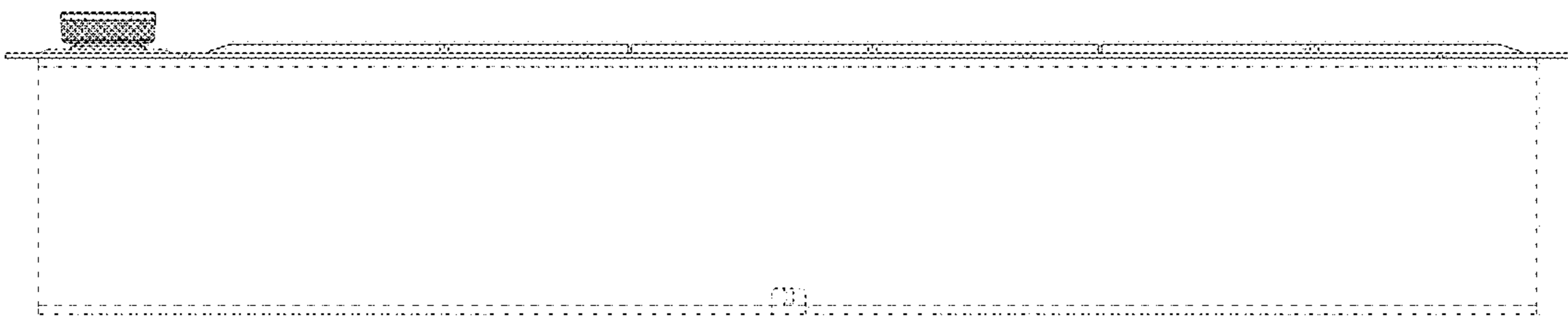

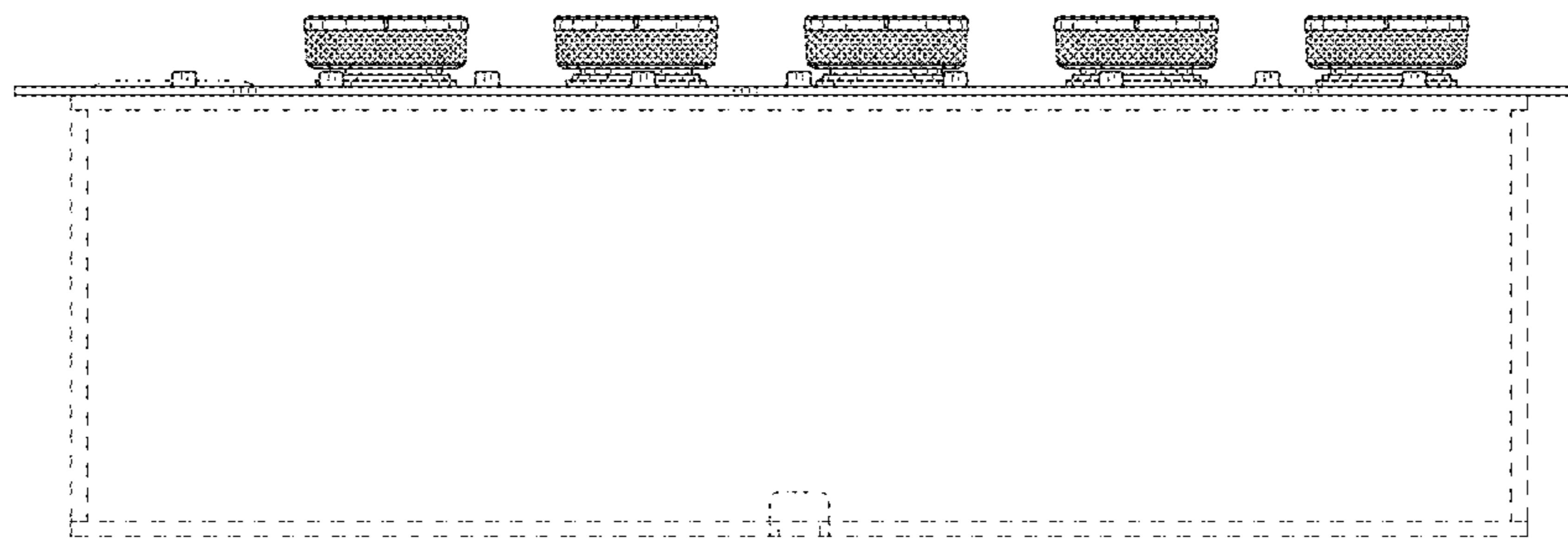

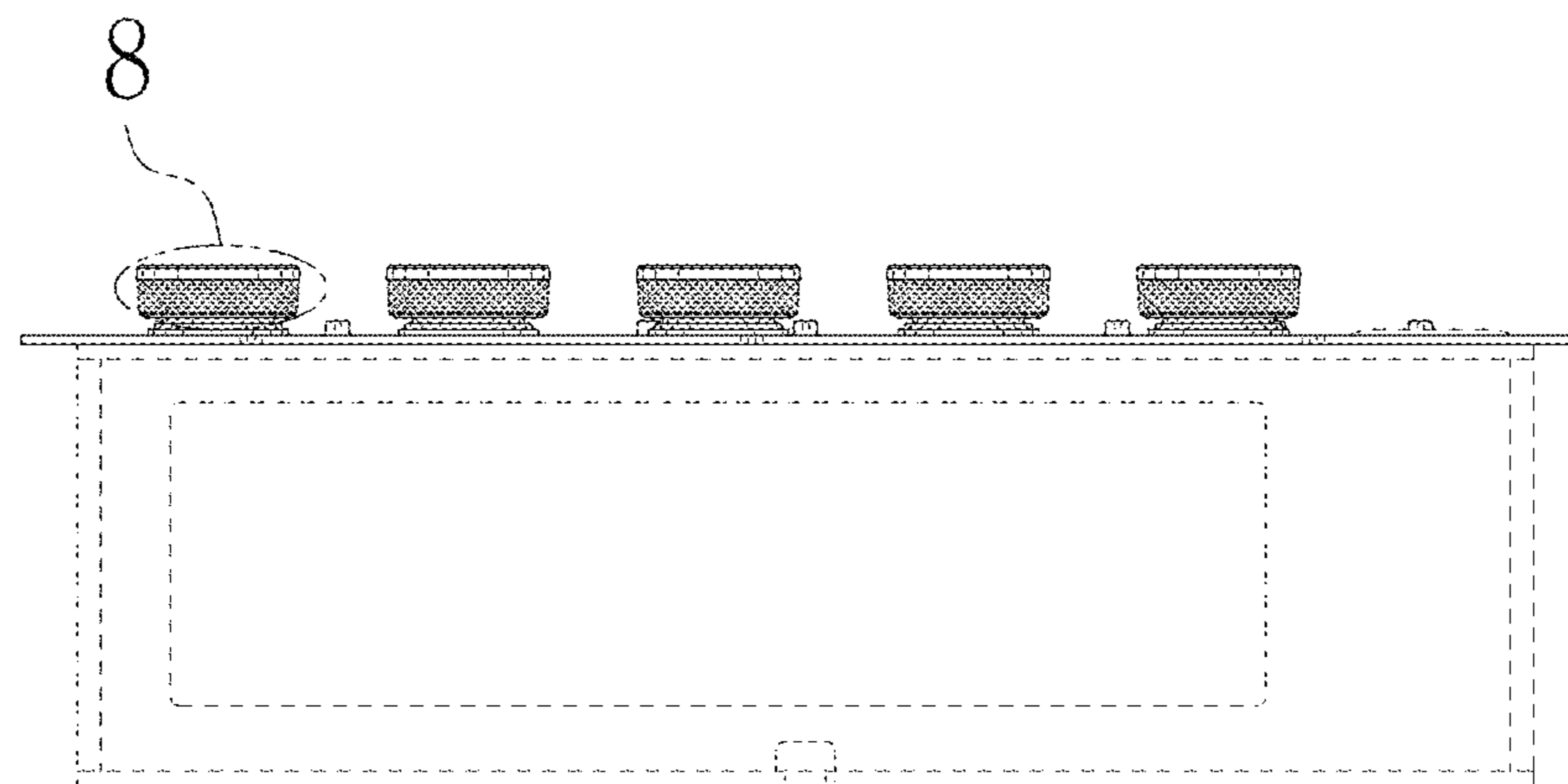

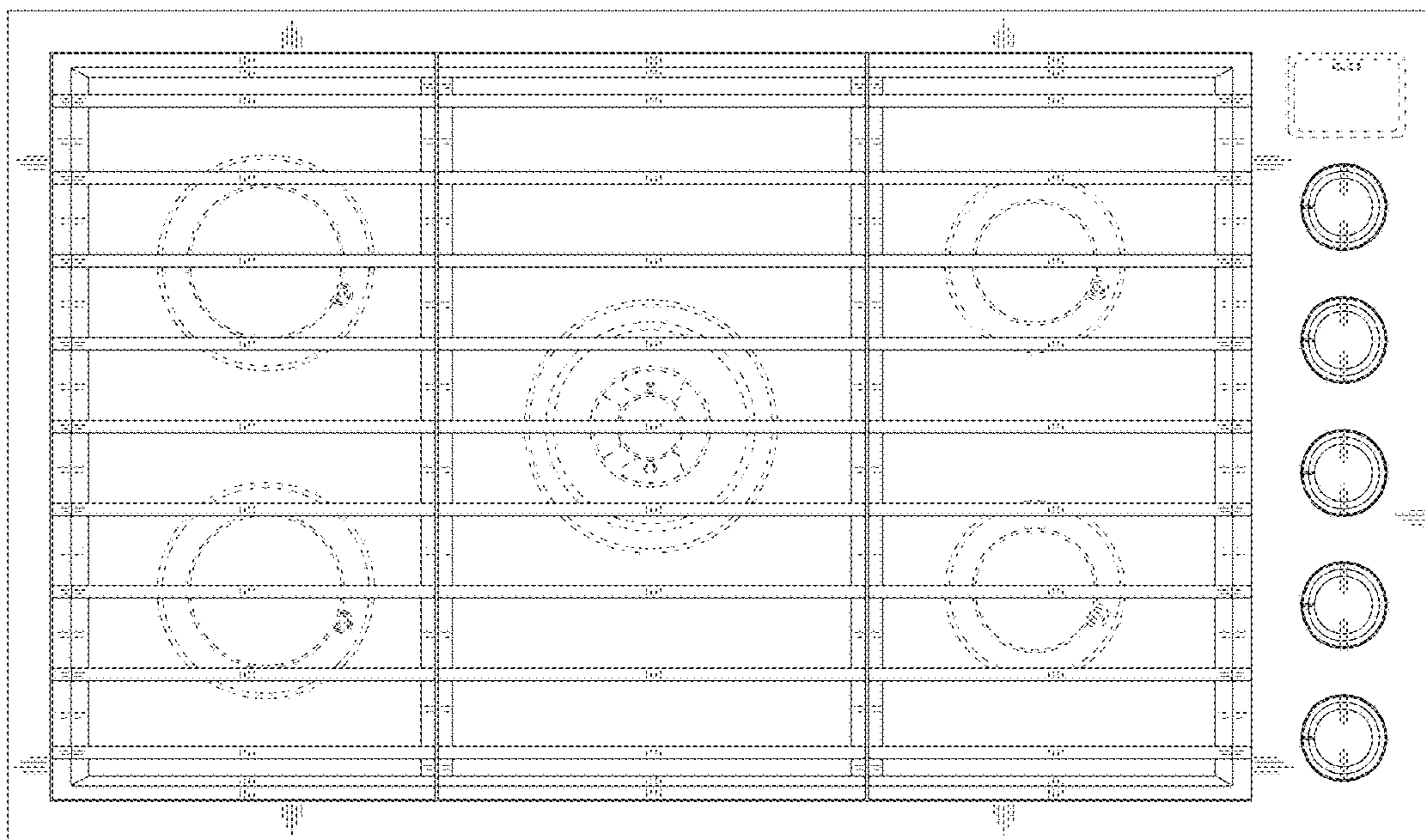

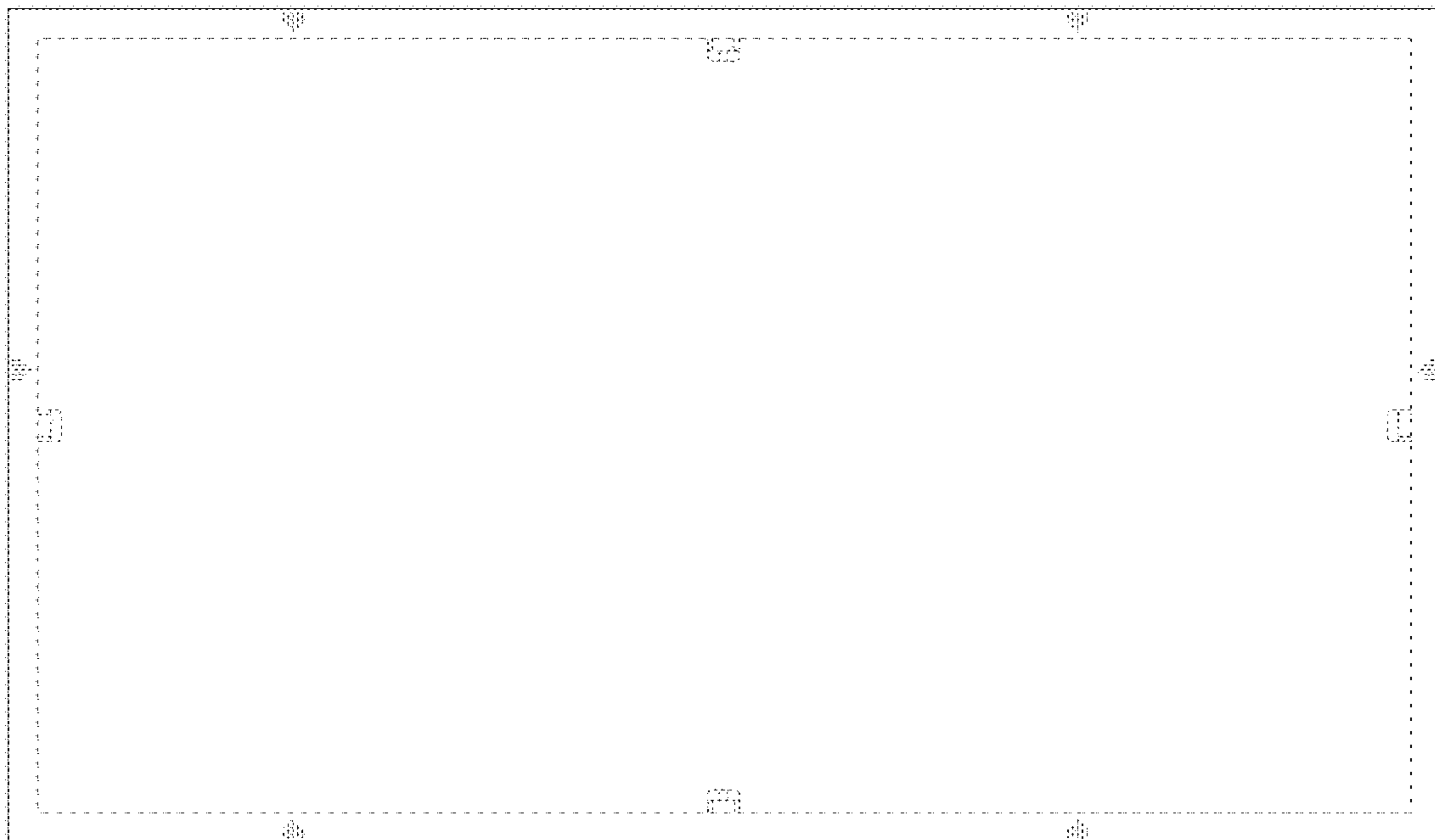
