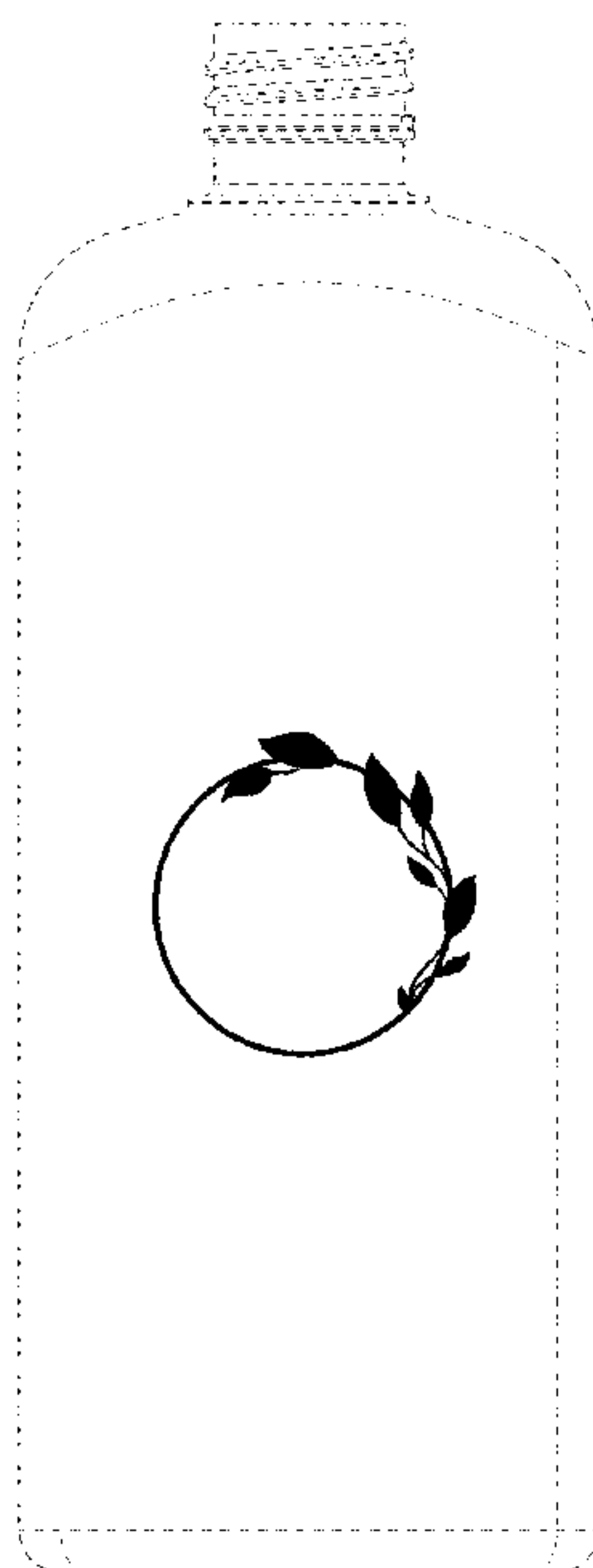

The ornamental design for a container with surface indicia,  
as shown and described.

**DESCRIPTION**  
FIG. 1 is a perspective view of a container with surface  
indicia, embodying our new design;  
FIG. 2 is a front side view of the container with surface  
indicia of FIG. 1;  
FIG. 3 is a first side view of the container with surface

indicia of FIG. 1;

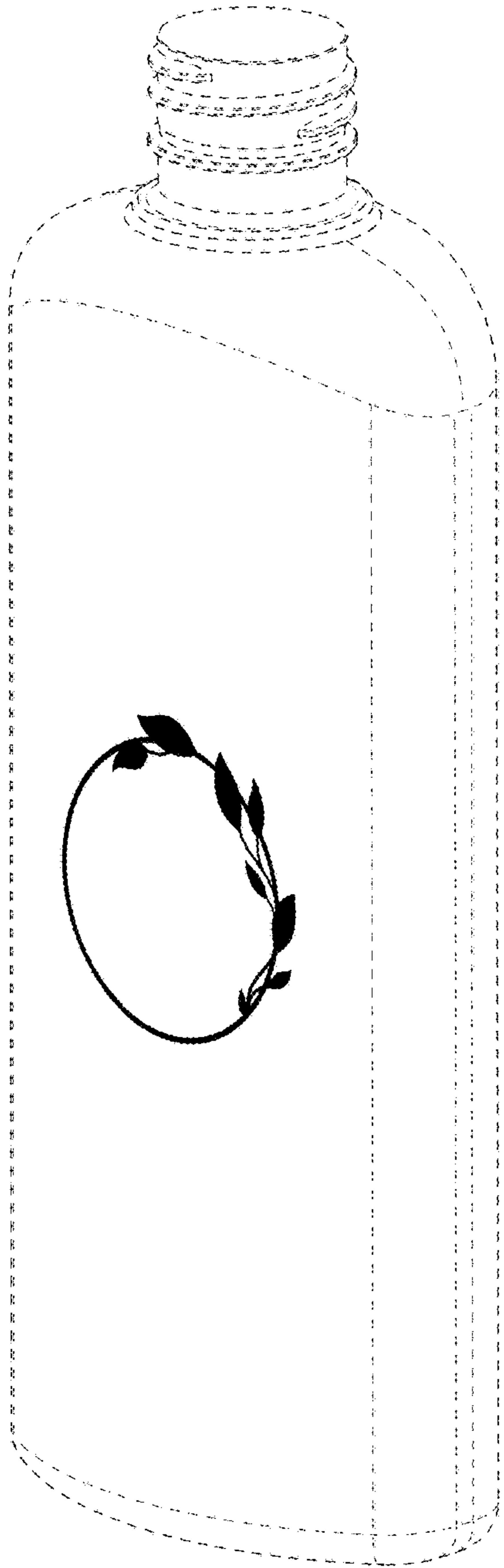

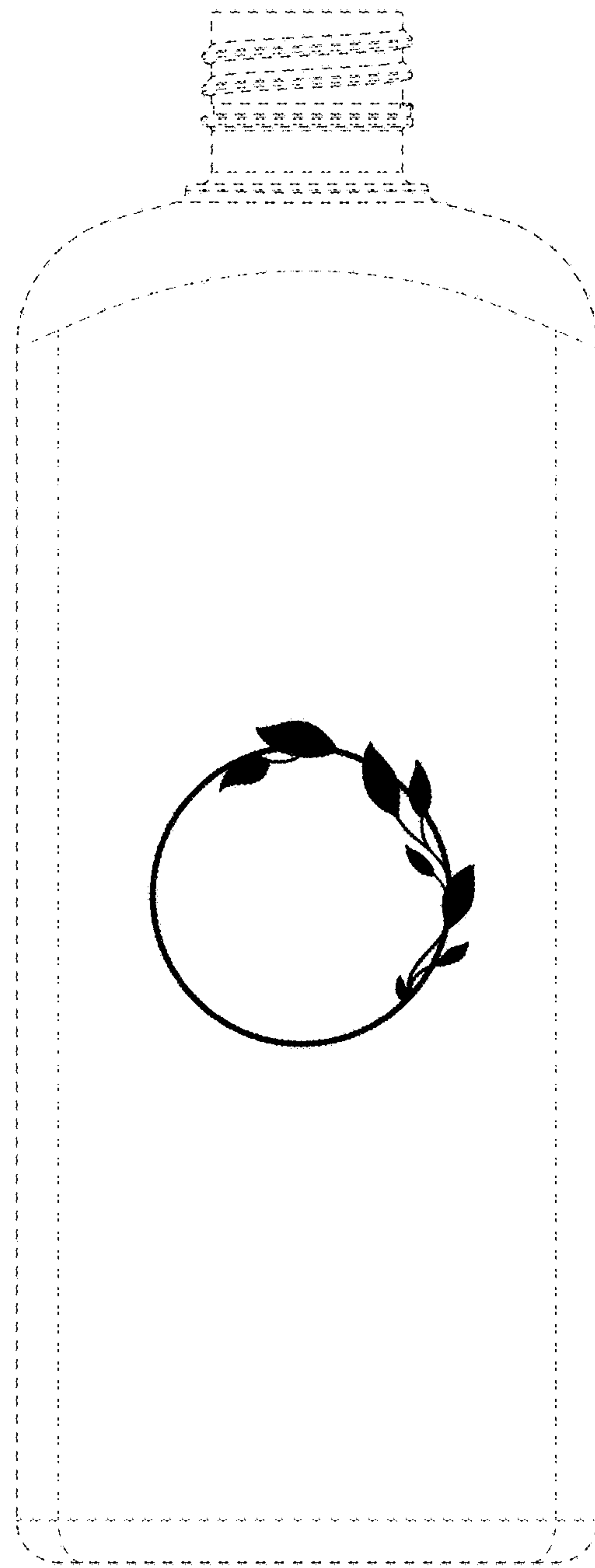

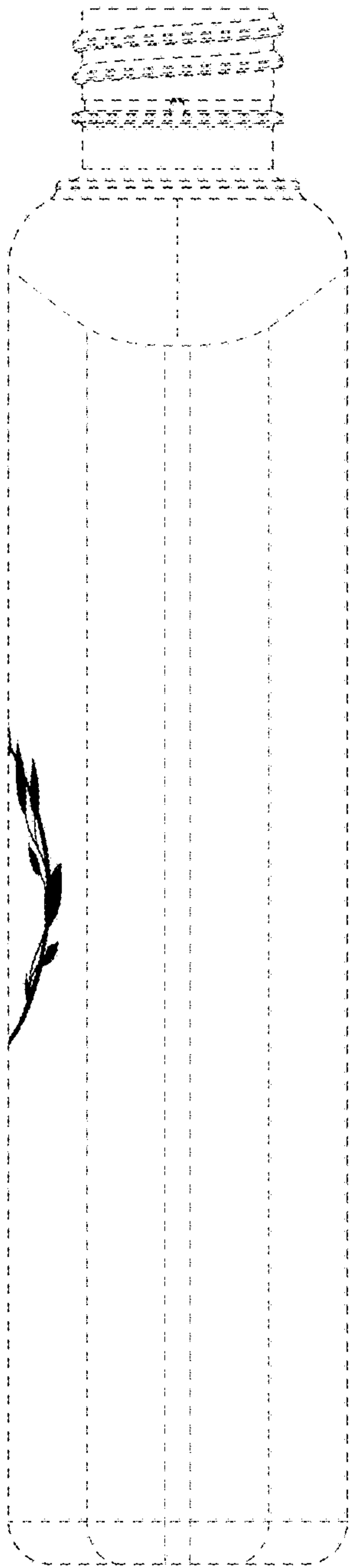

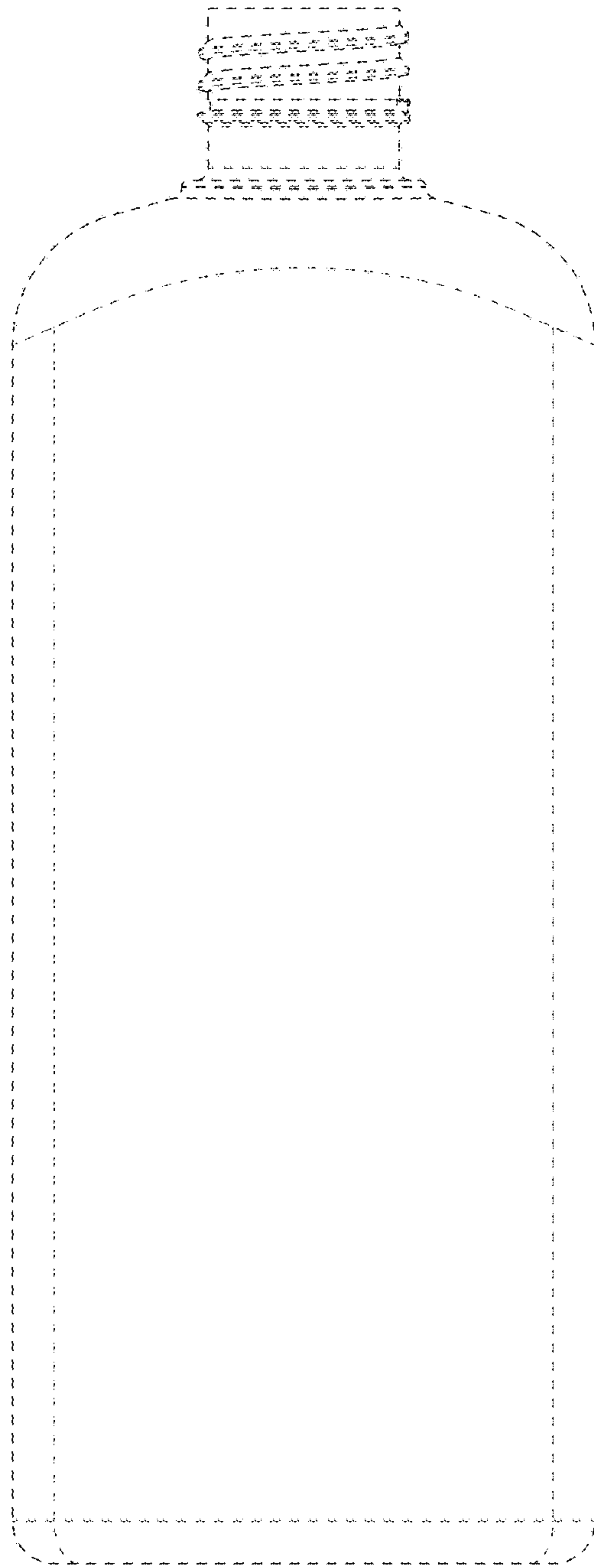

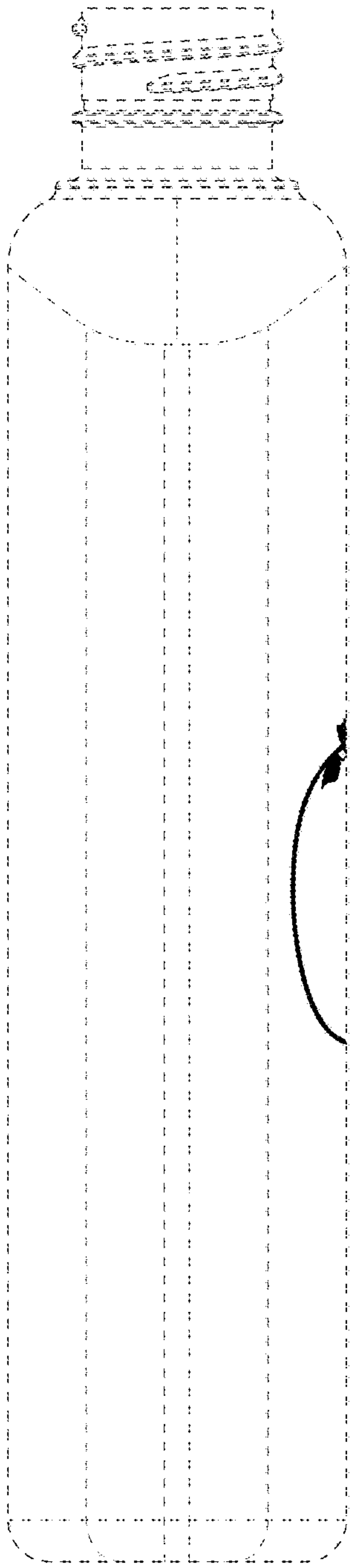

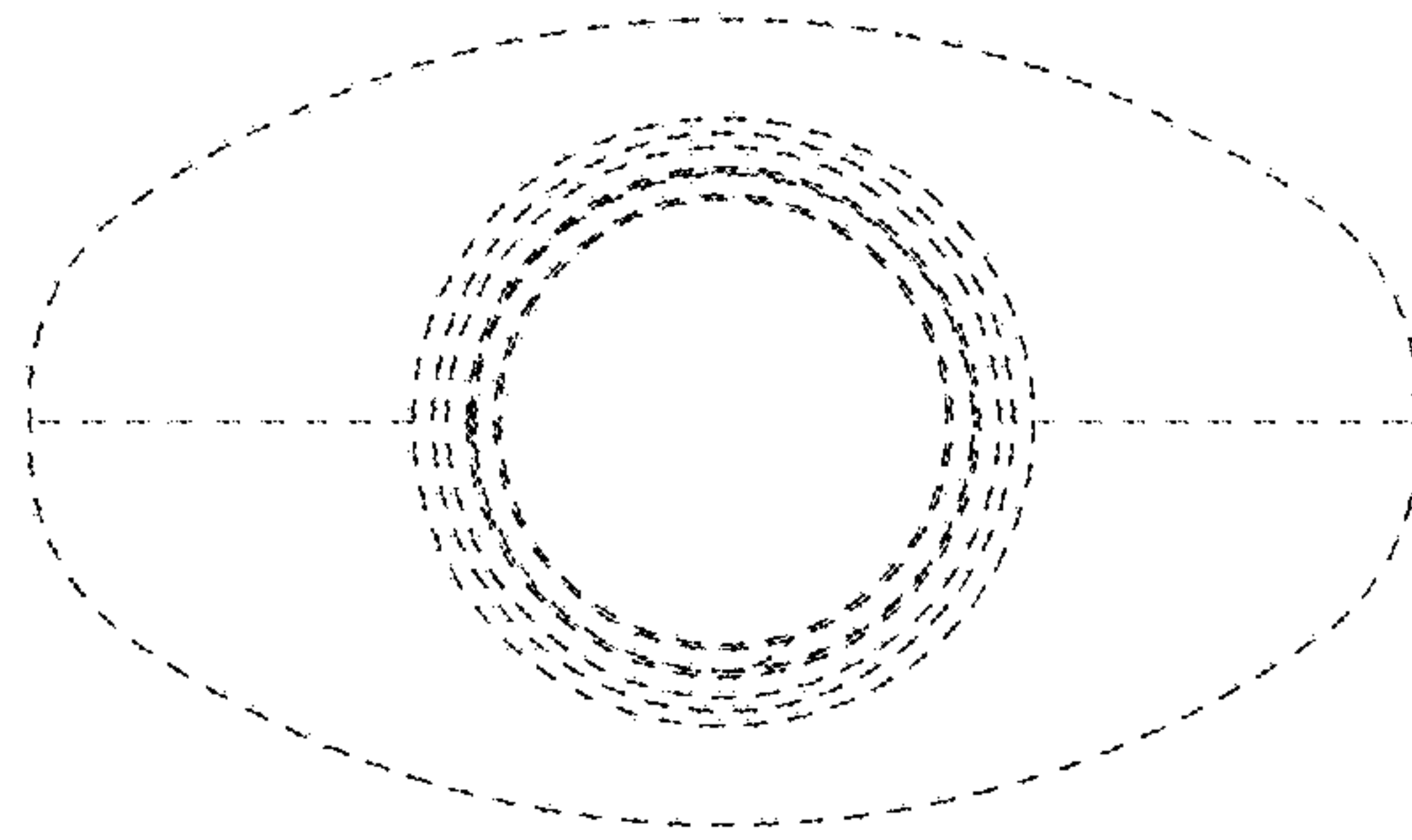

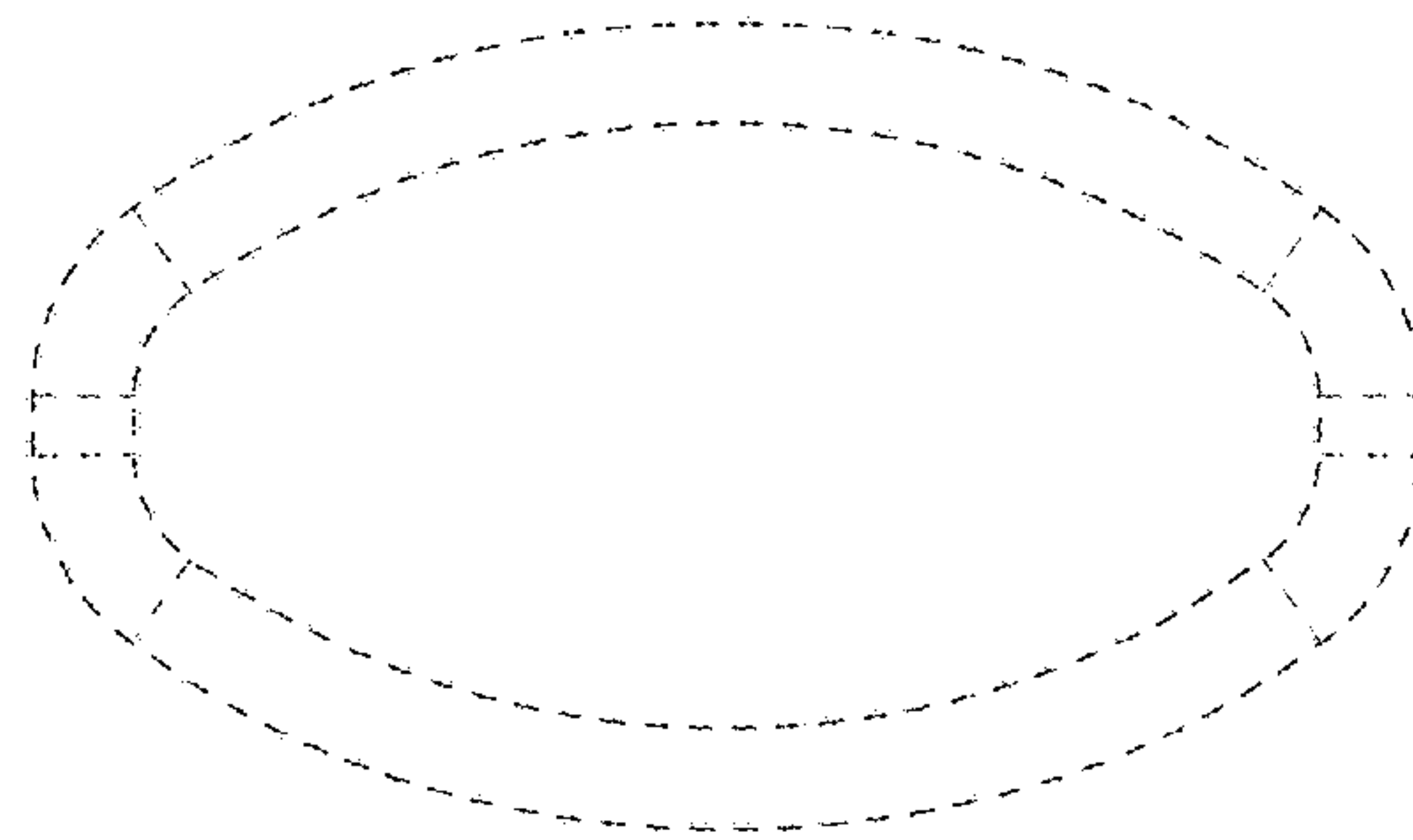
