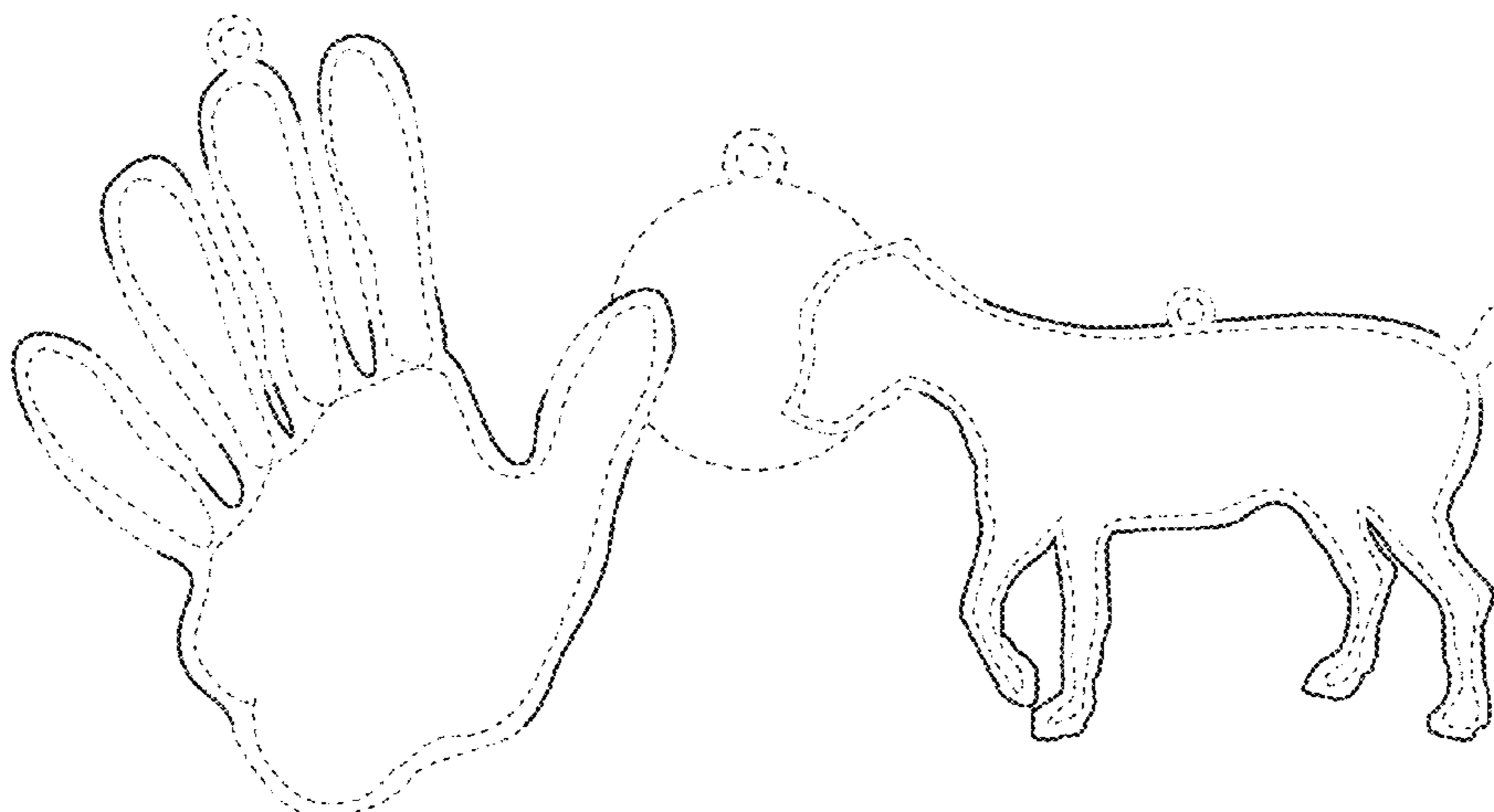
(57) **CLAIM**

The ornamental design for a jewelry article including hand and dog, as shown and described.

**DESCRIPTION**

FIG. 1 is a front elevational view of a jewelry article including hand and dog showing the new design; FIG. 2 is a left side elevational view thereof; FIG. 3 is a top plan view thereof; FIG. 4 is a right side elevational view thereof; FIG. 5 is a bottom plan view thereof; and, FIG. 6 is a rear elevational view thereof. The broken lines in the figures represent portions of the jewelry article including hand and dog that form no part of the claimed design.

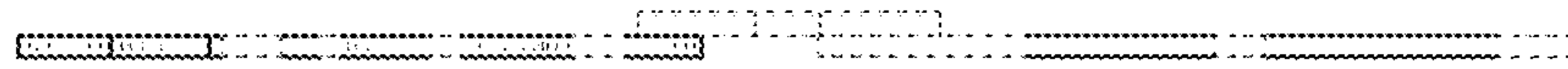

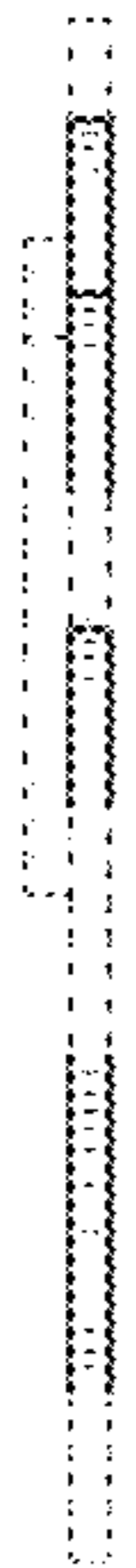

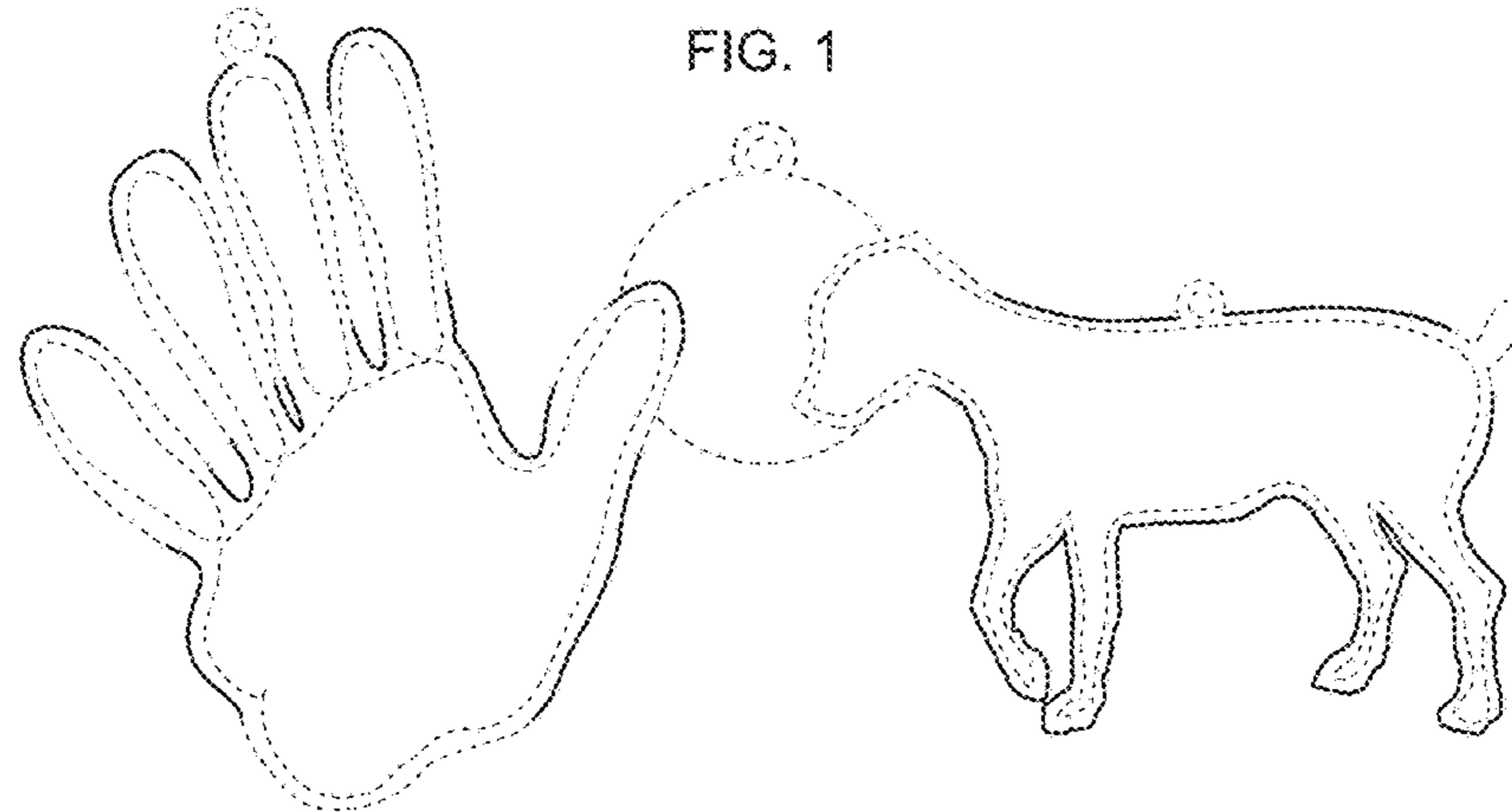

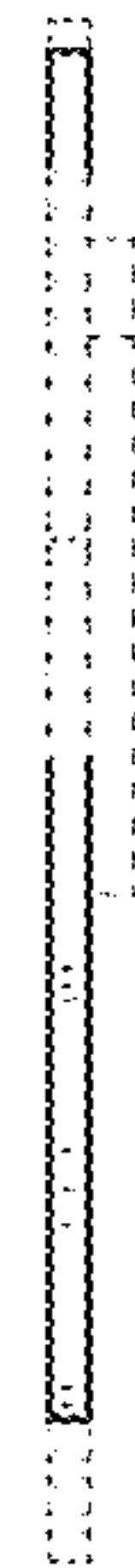
