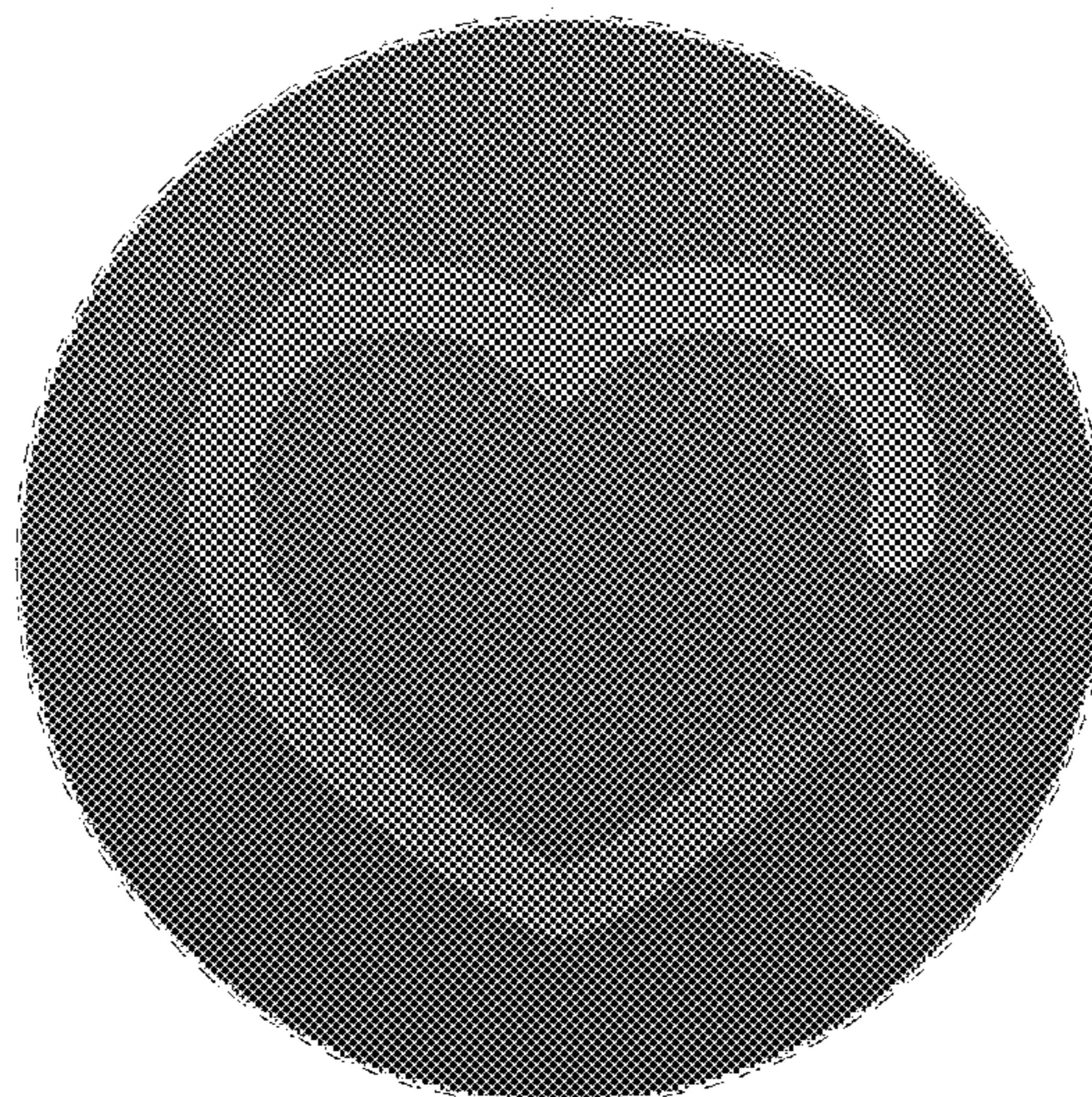

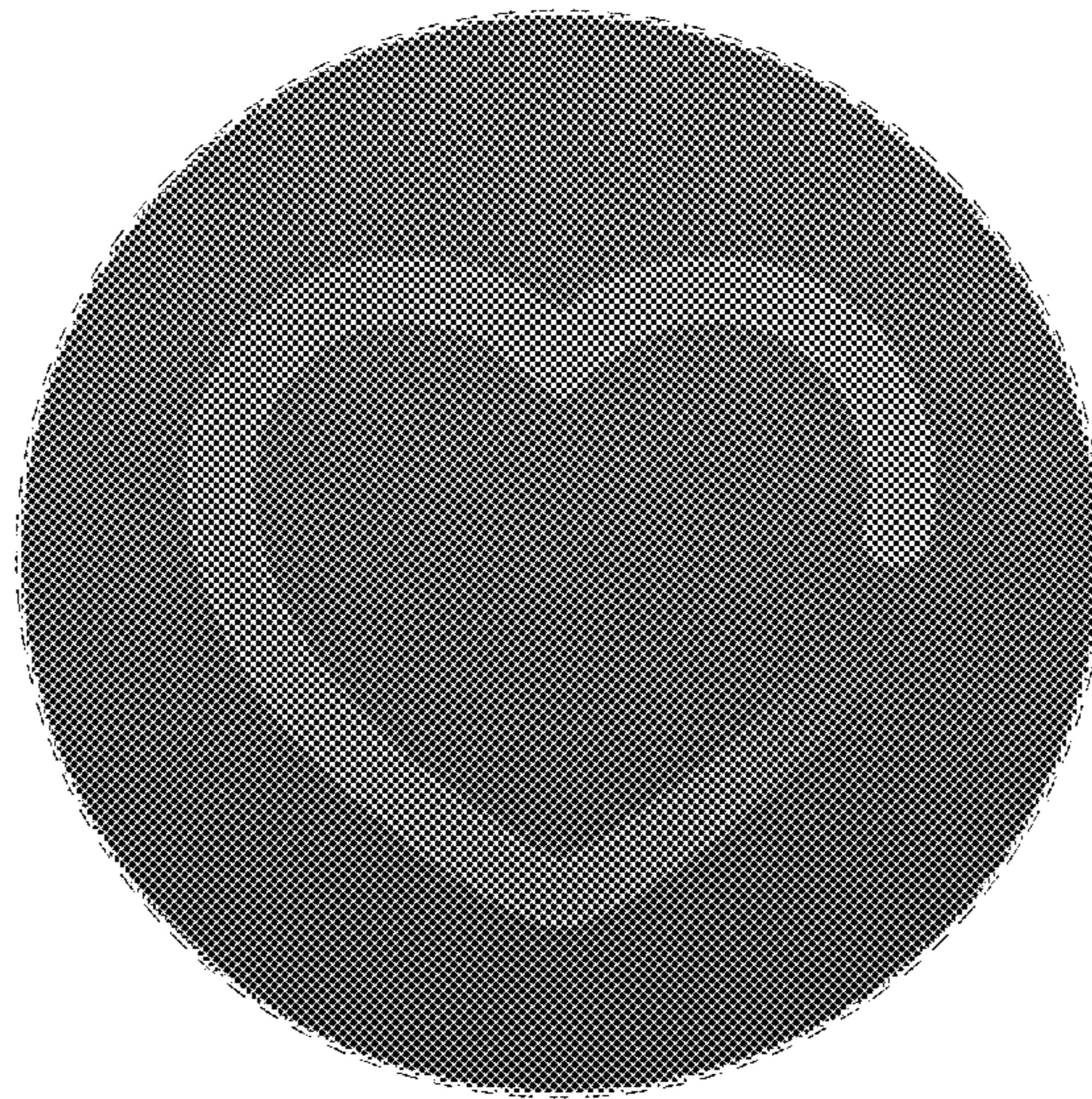
FIG. 1 shows a display screen or portion thereof with icon showing our new design; and,

FIG. 2 shows a second embodiment thereof, which our icon may be displayed;

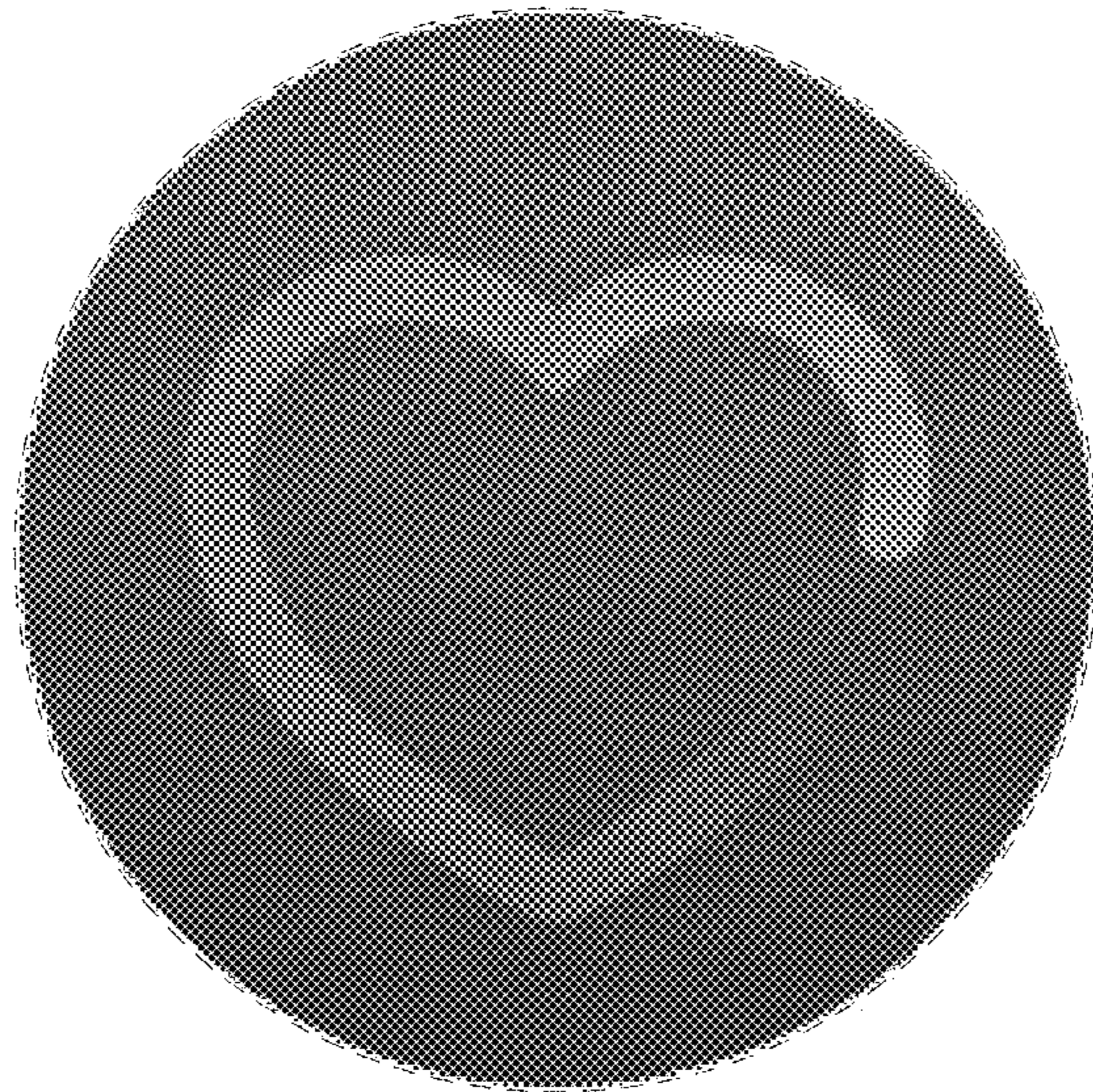
The dashed broken line represents a display screen or portion thereof and forms no part of the claimed design.
