**DESCRIPTION**

FIG. 1 is a perspective view of a soap mold showing our new design;

FIG. 5 is a right side elevational view thereof;

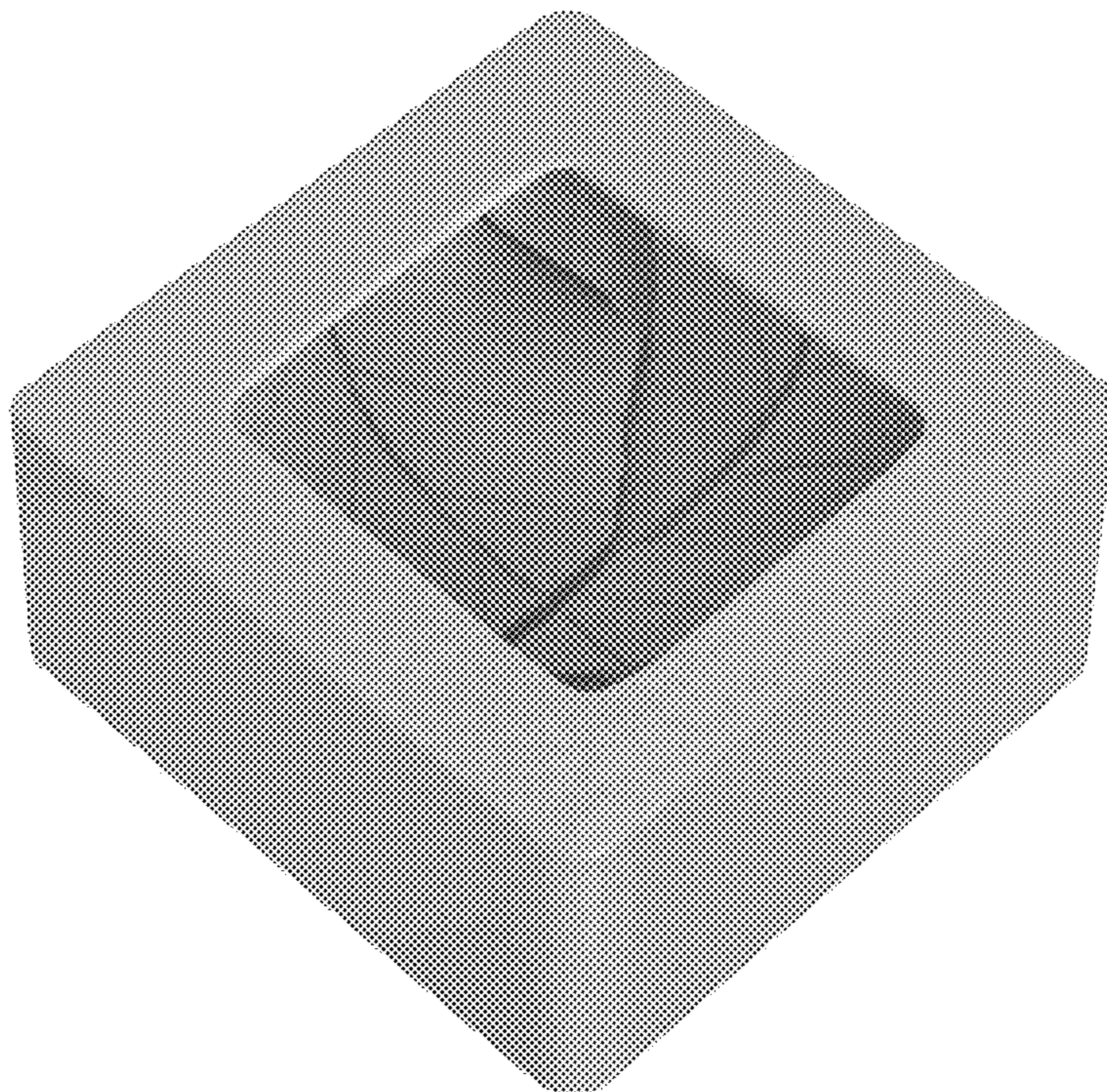
FIG. 6 is a top plan view thereof;

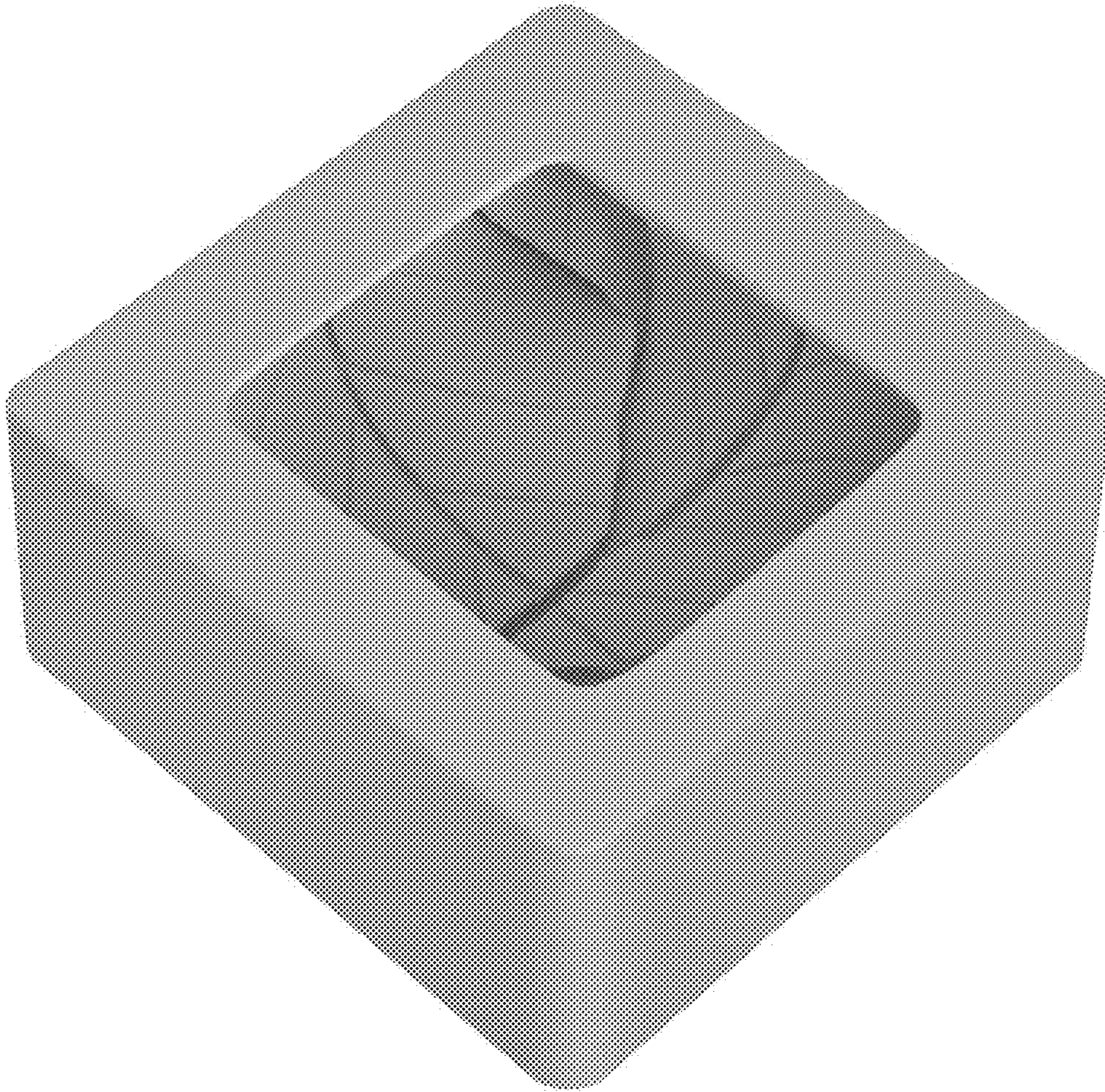

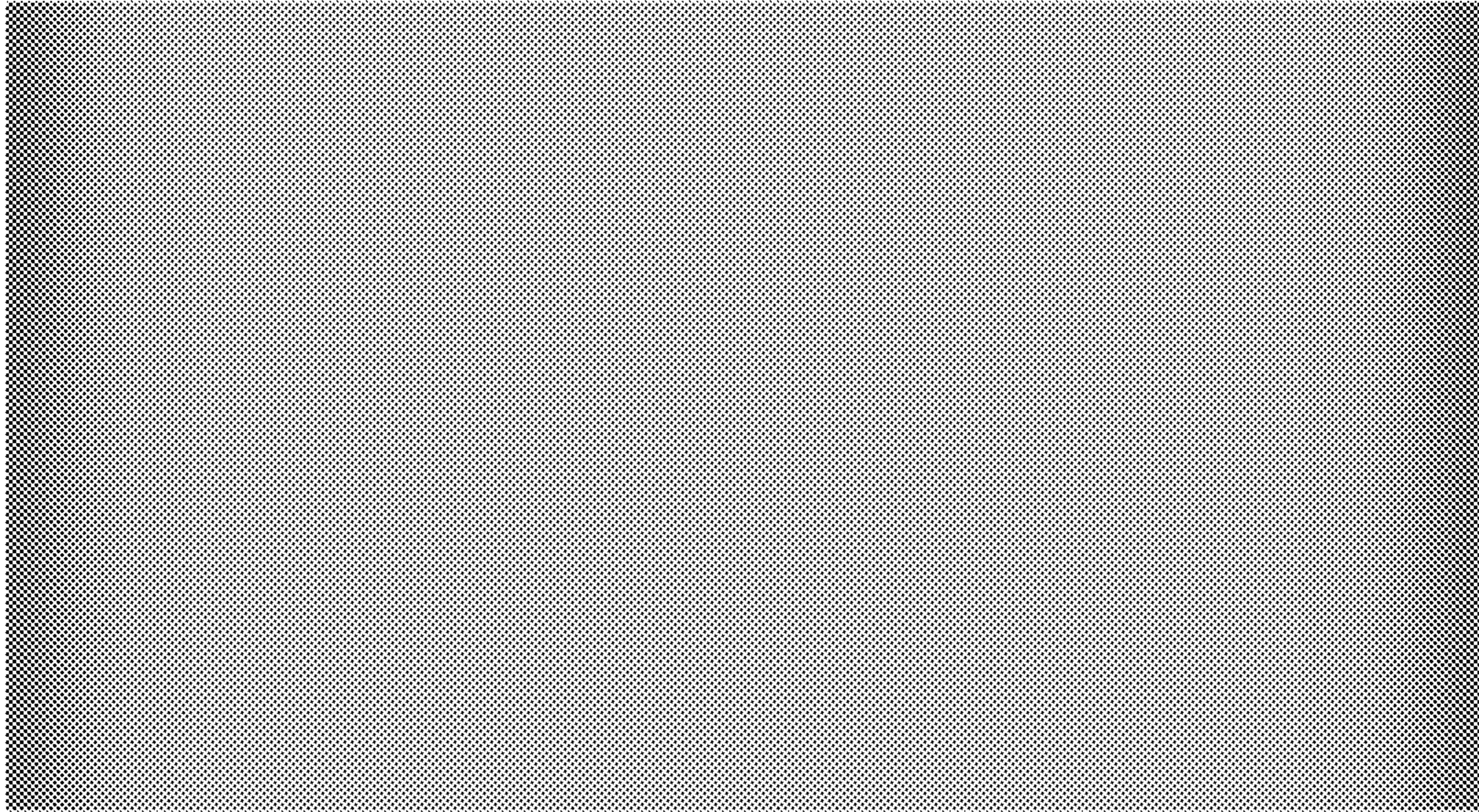

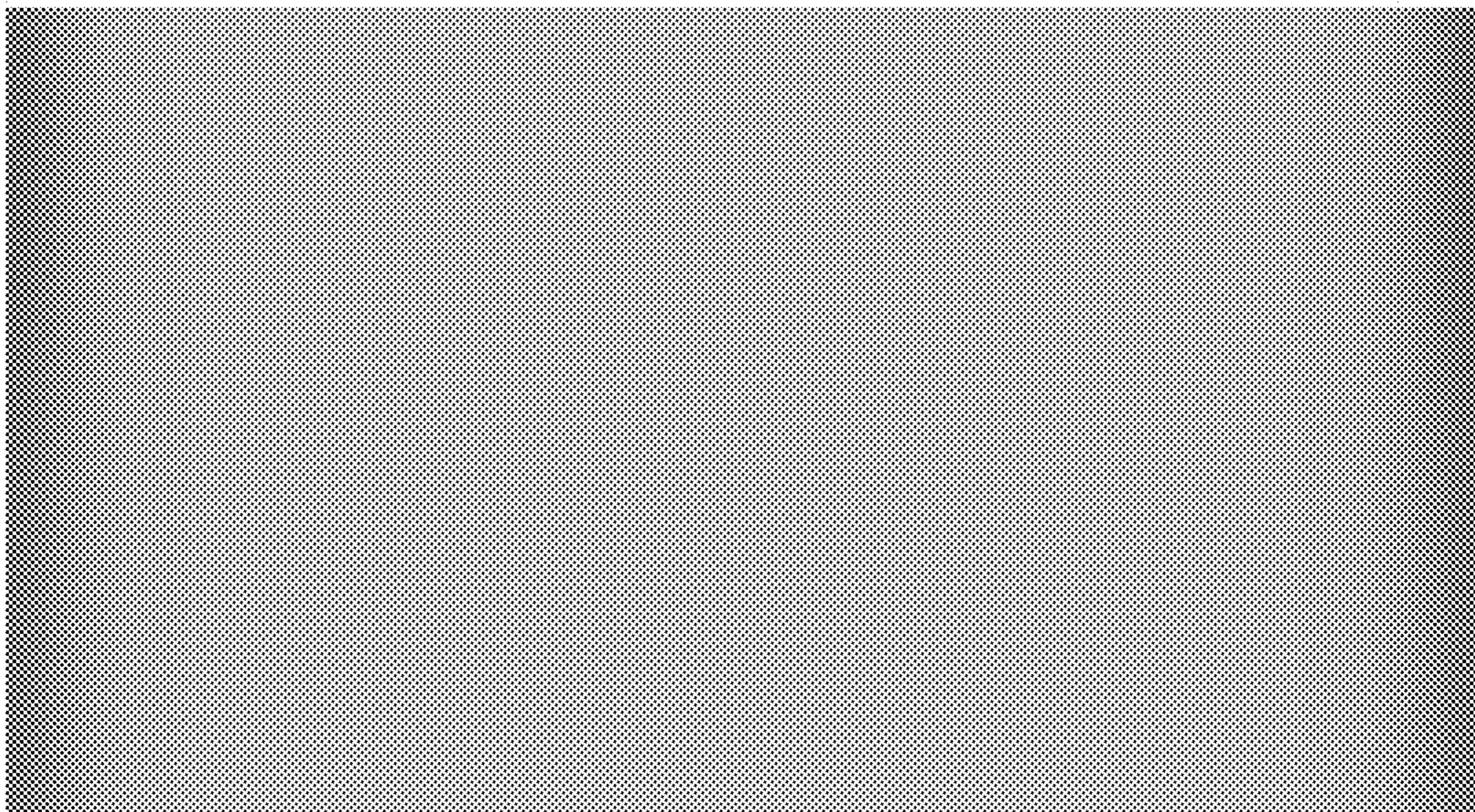

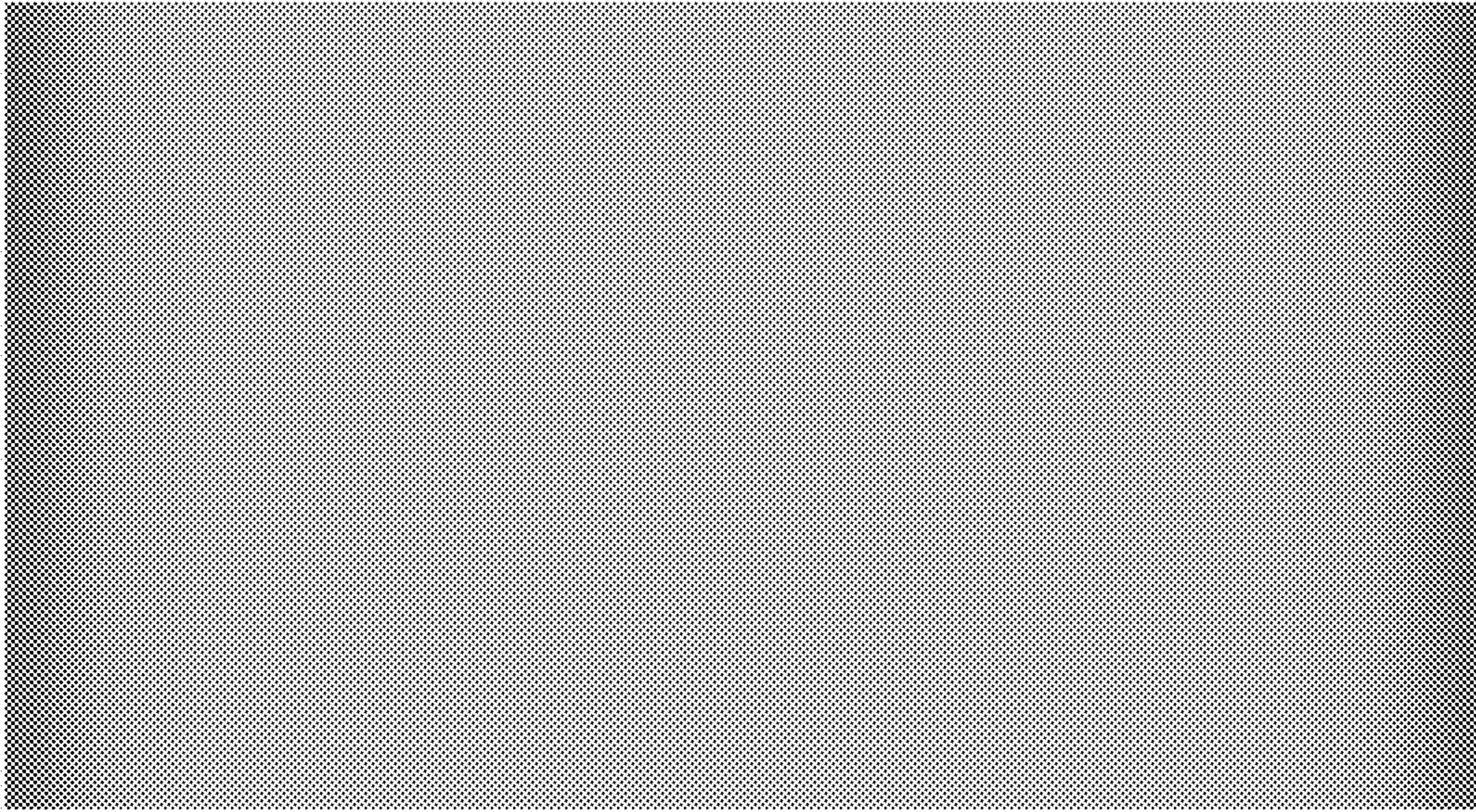

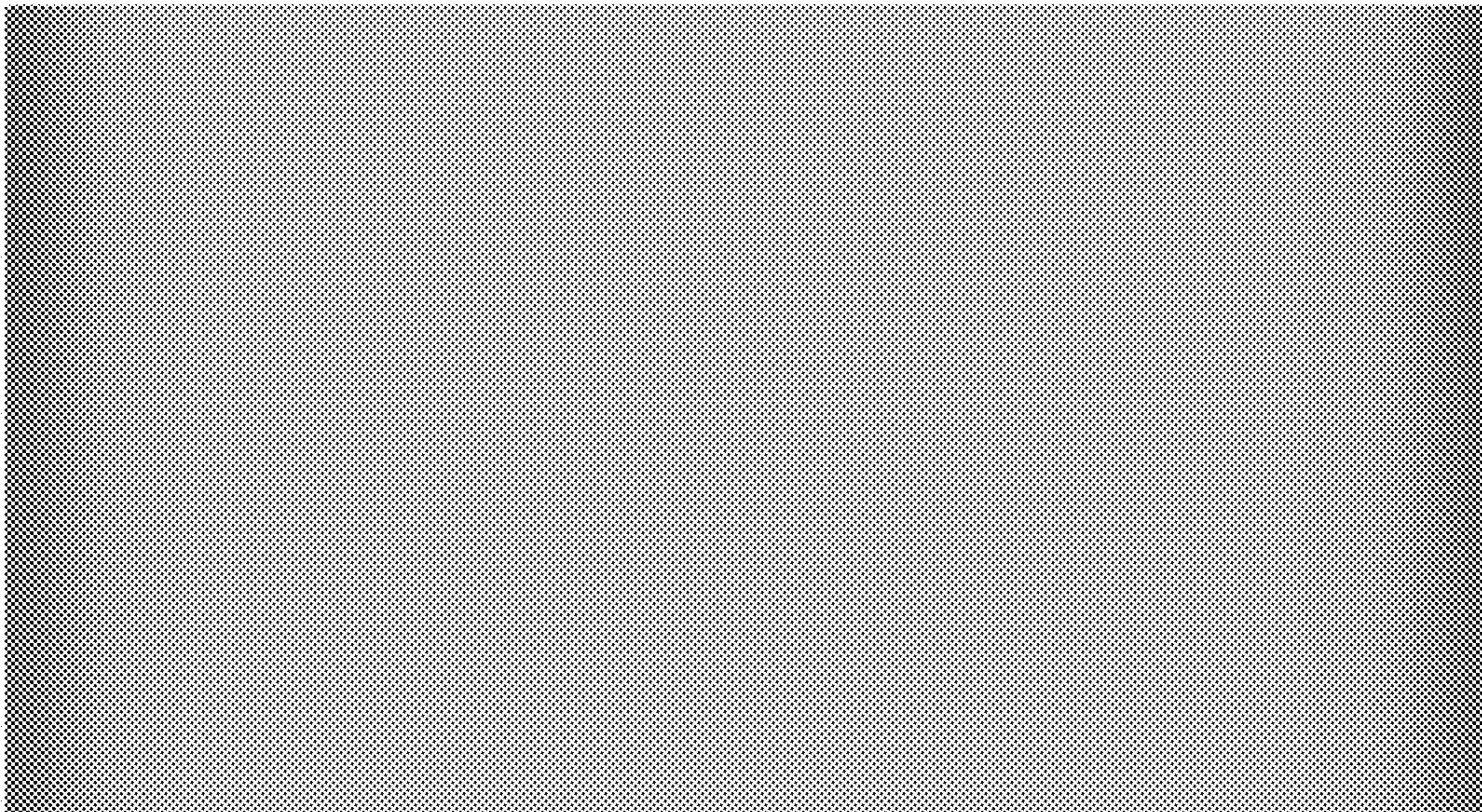
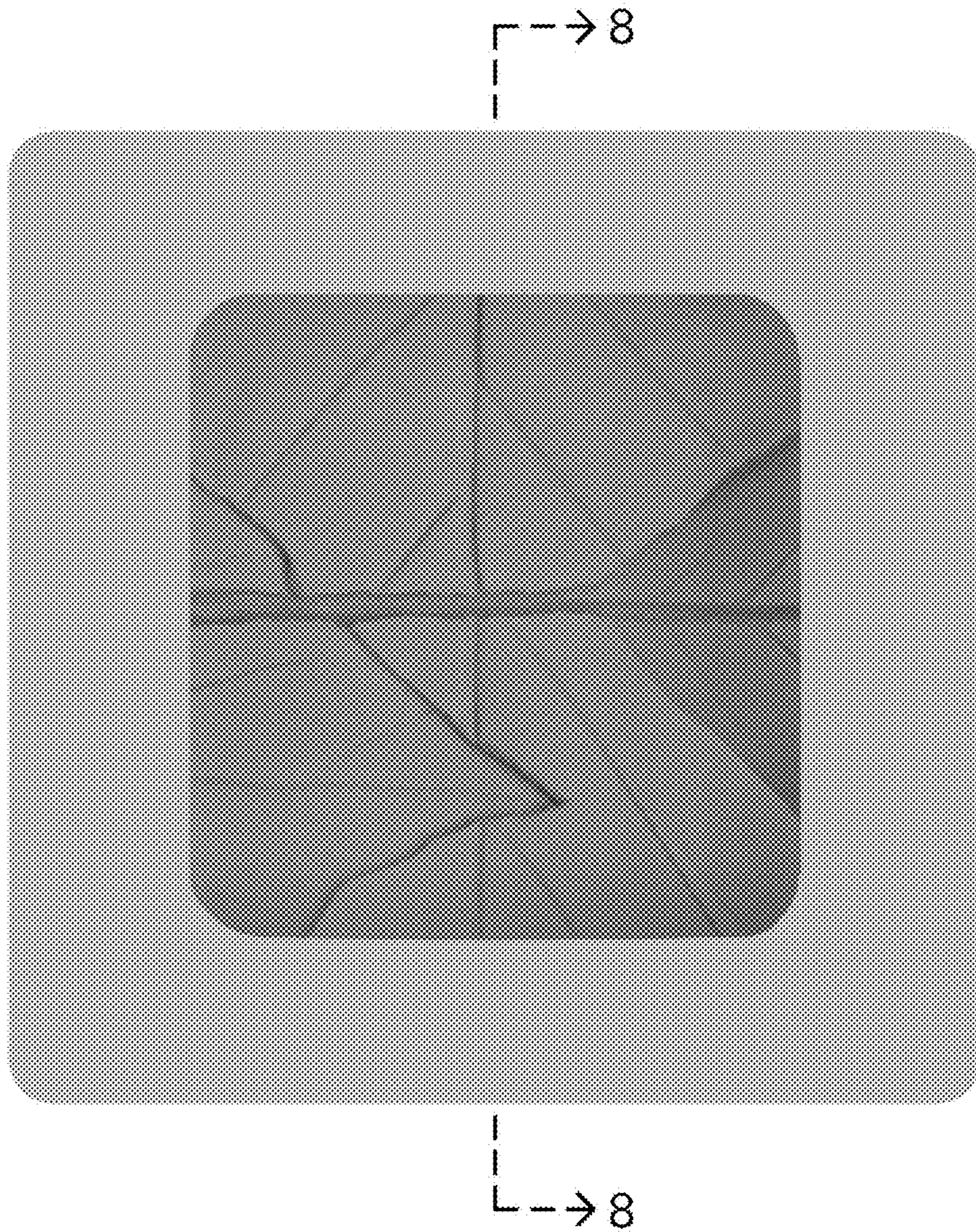

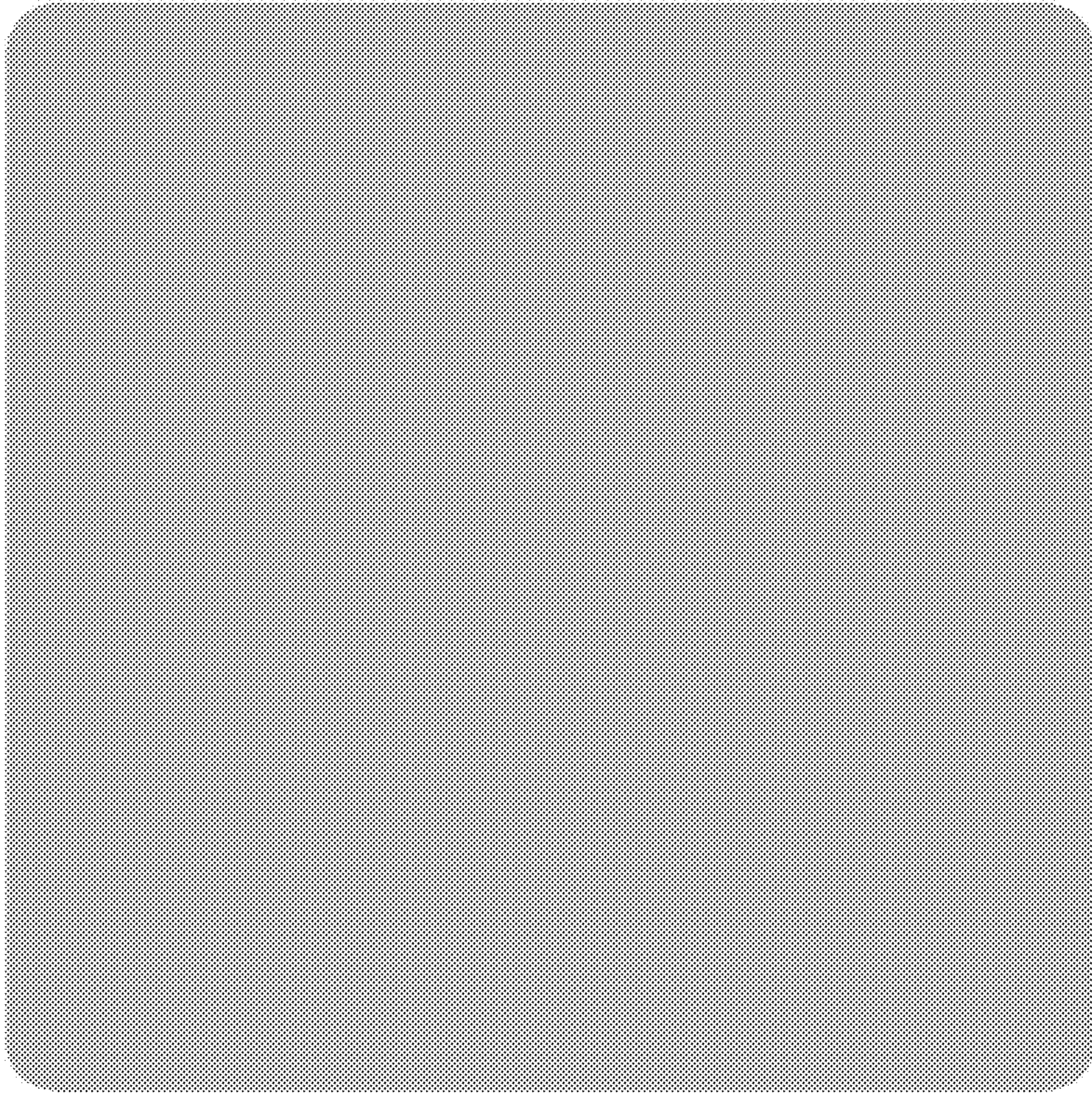

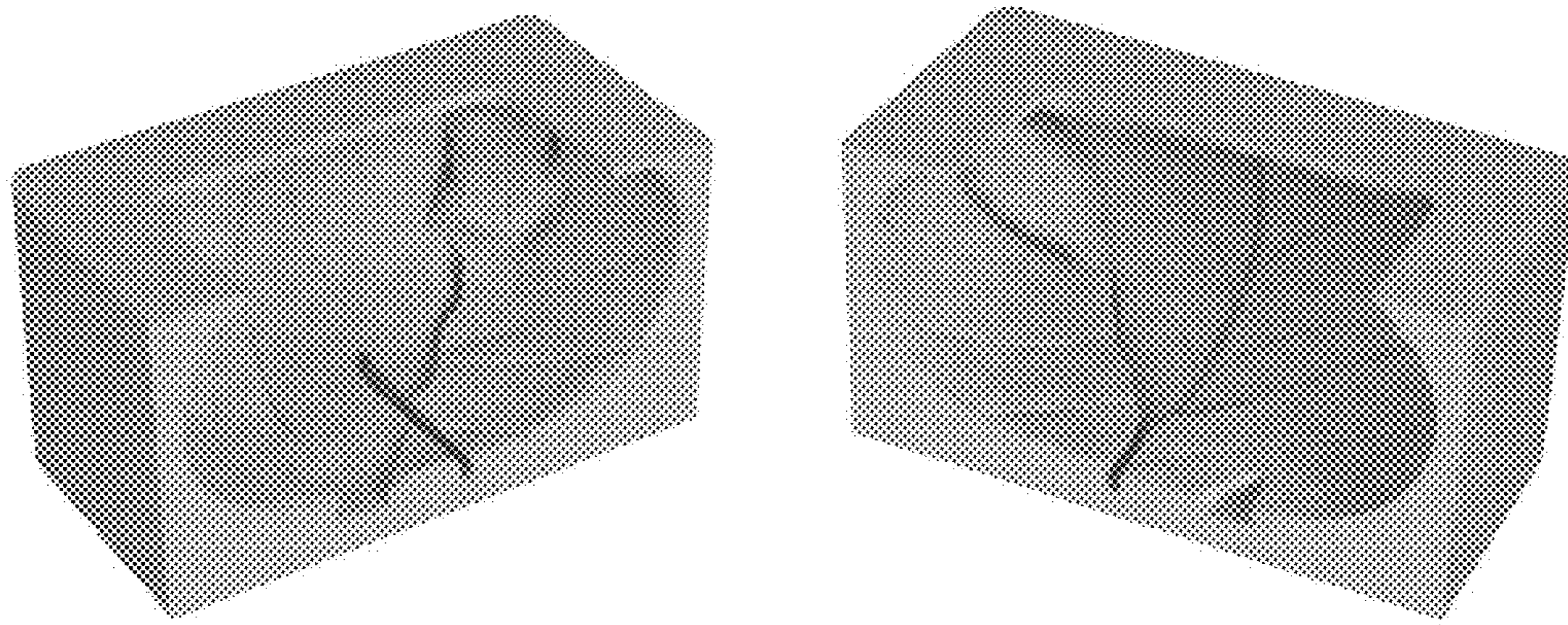
