FIG. 3 is a first side elevational view thereof;

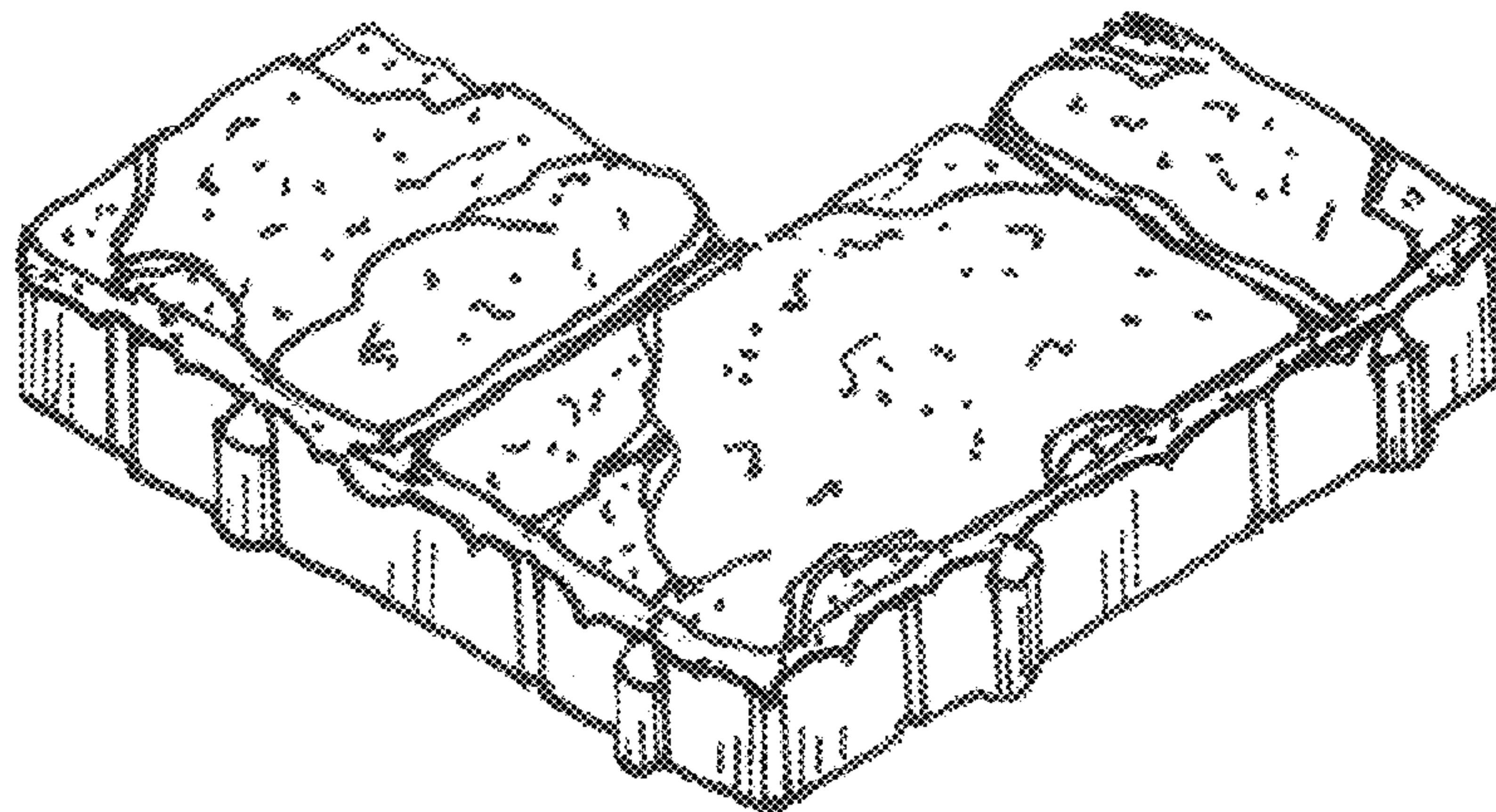
FIG. 4 is a second side elevational view thereof;

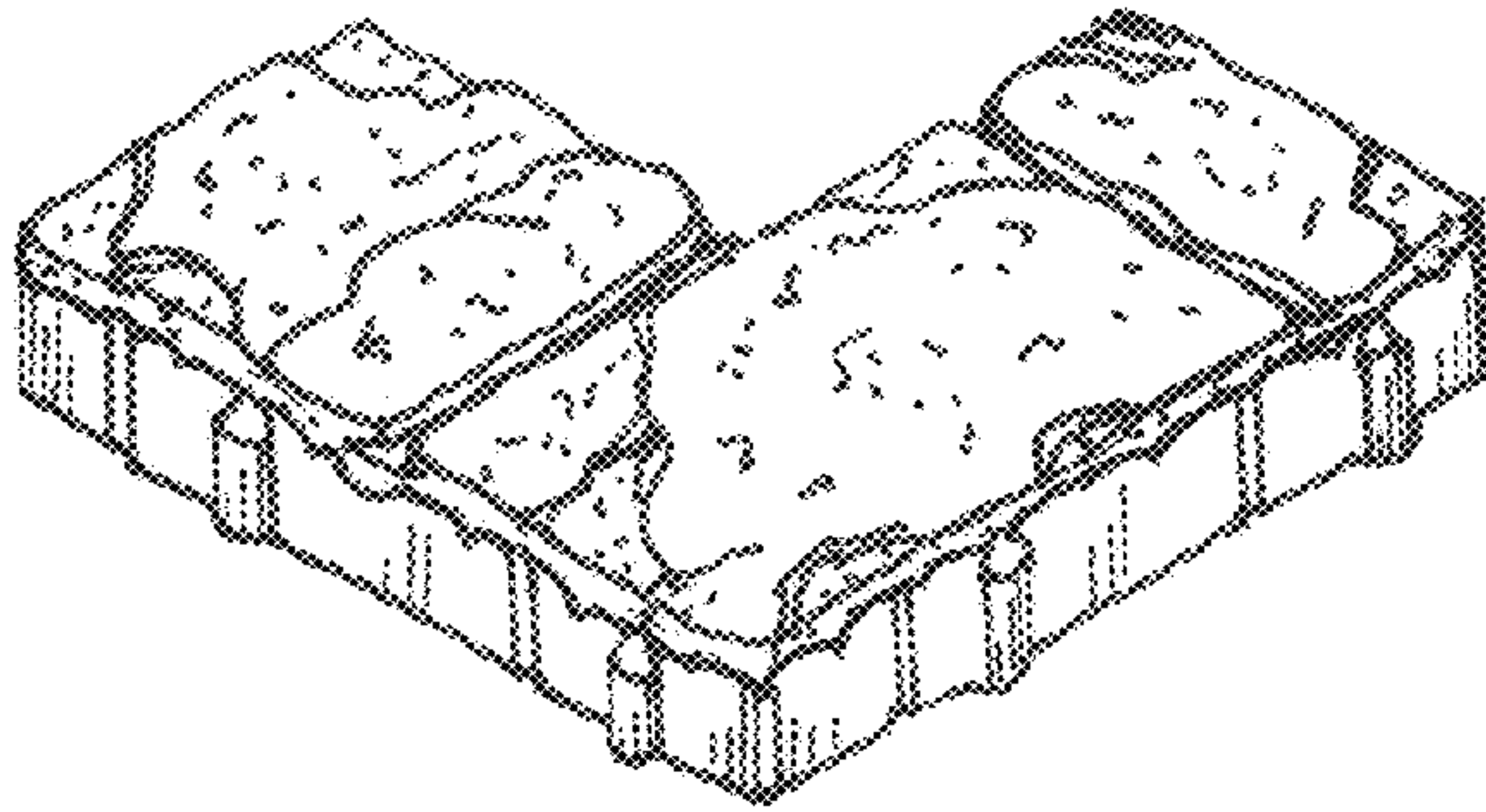

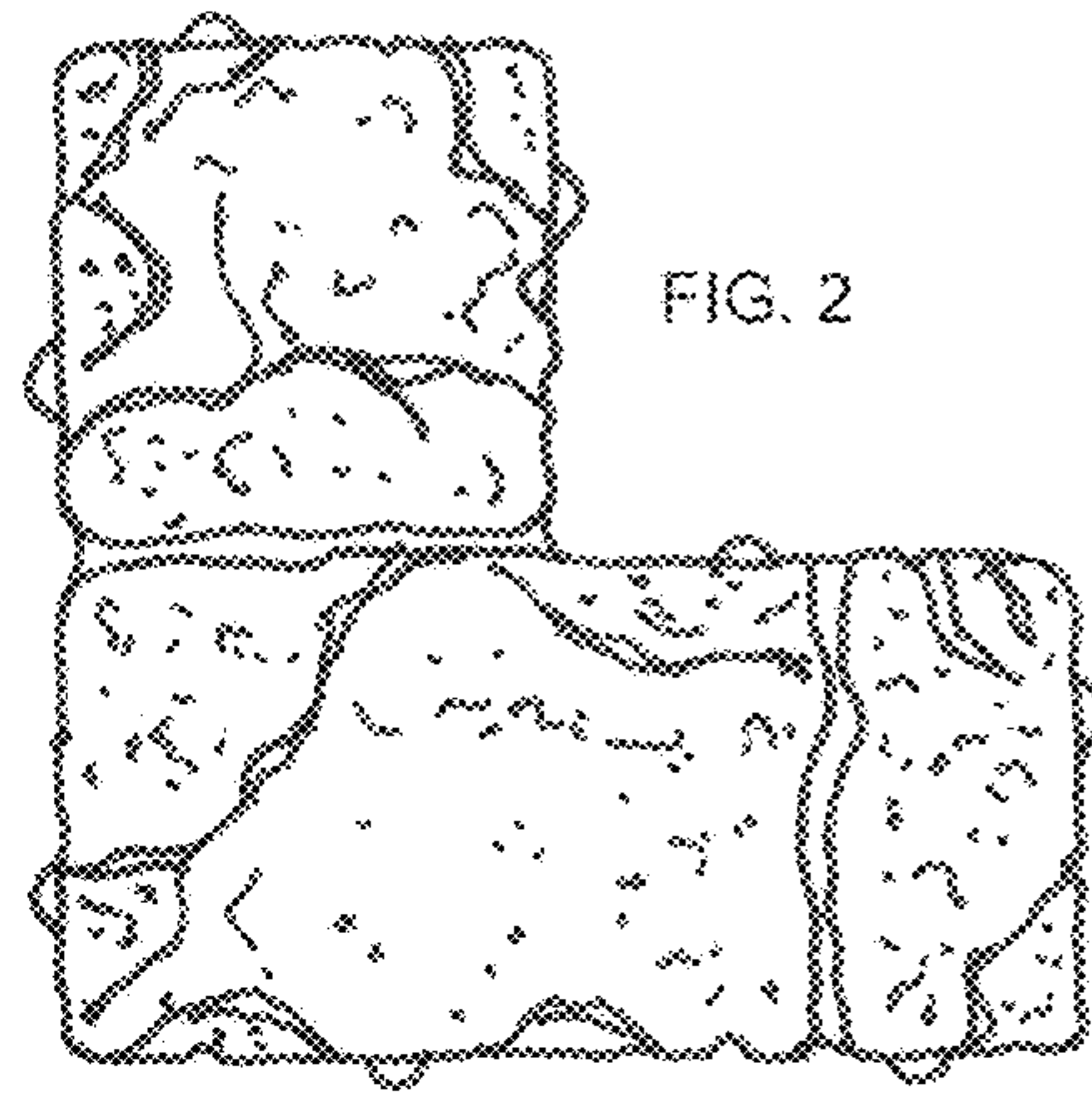

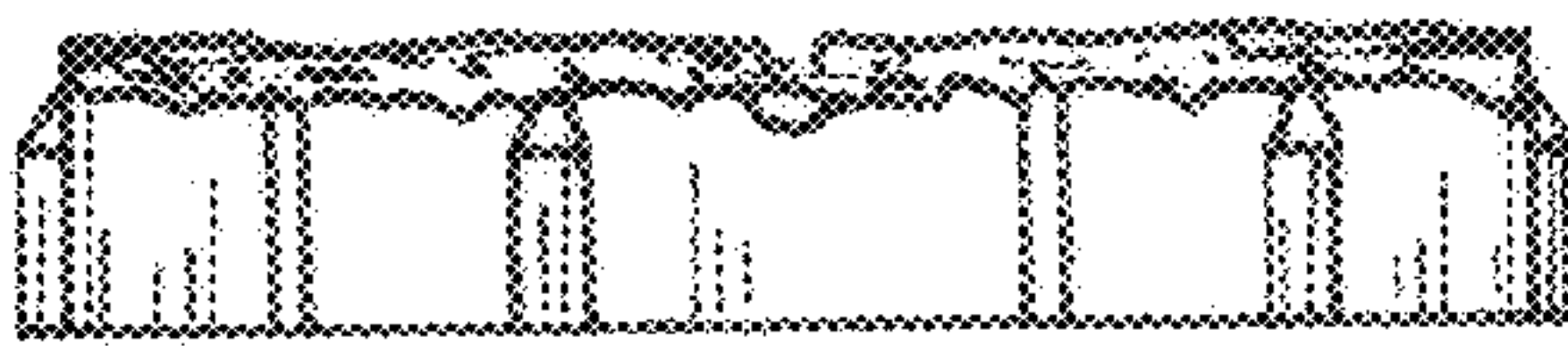

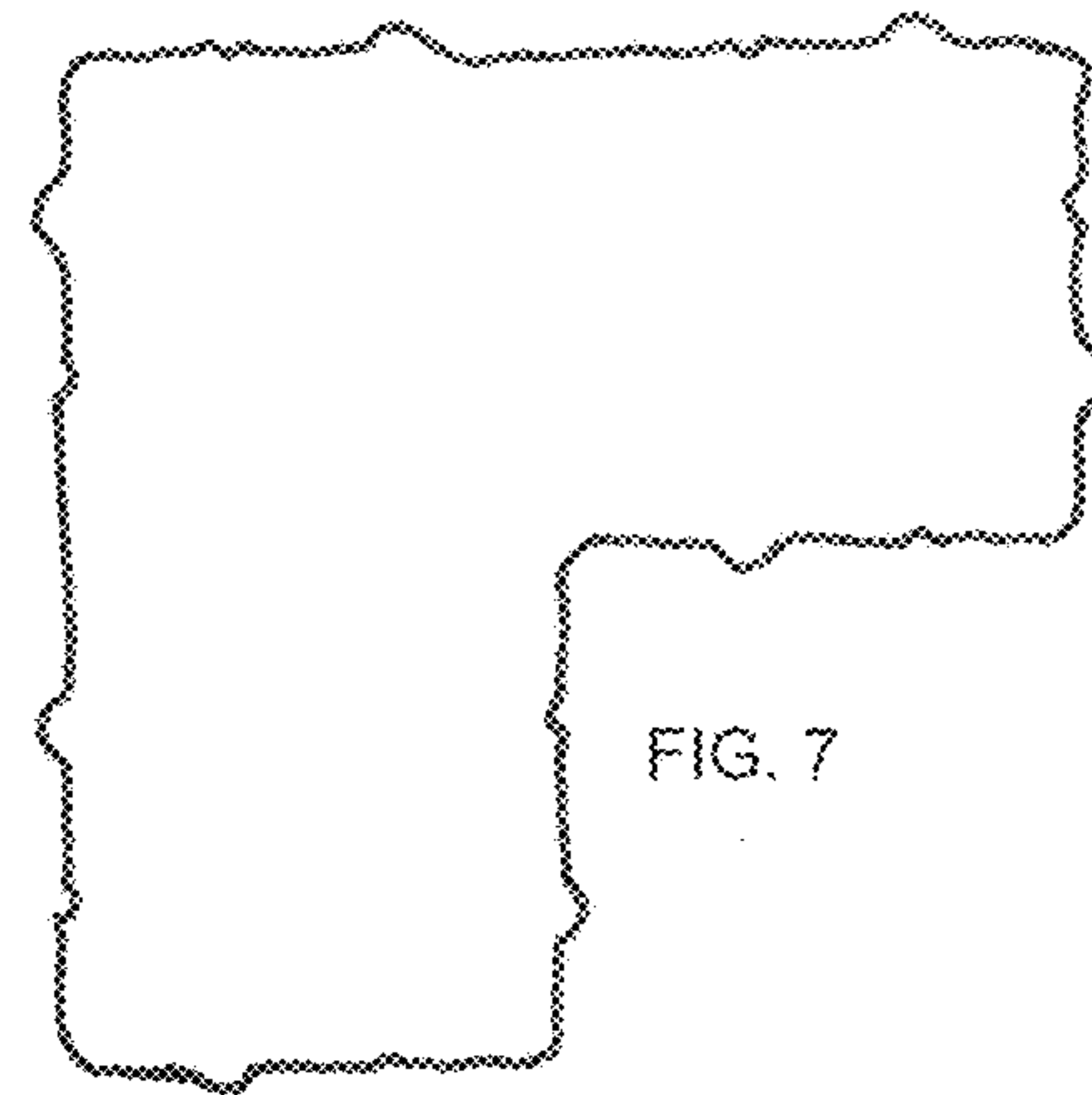
