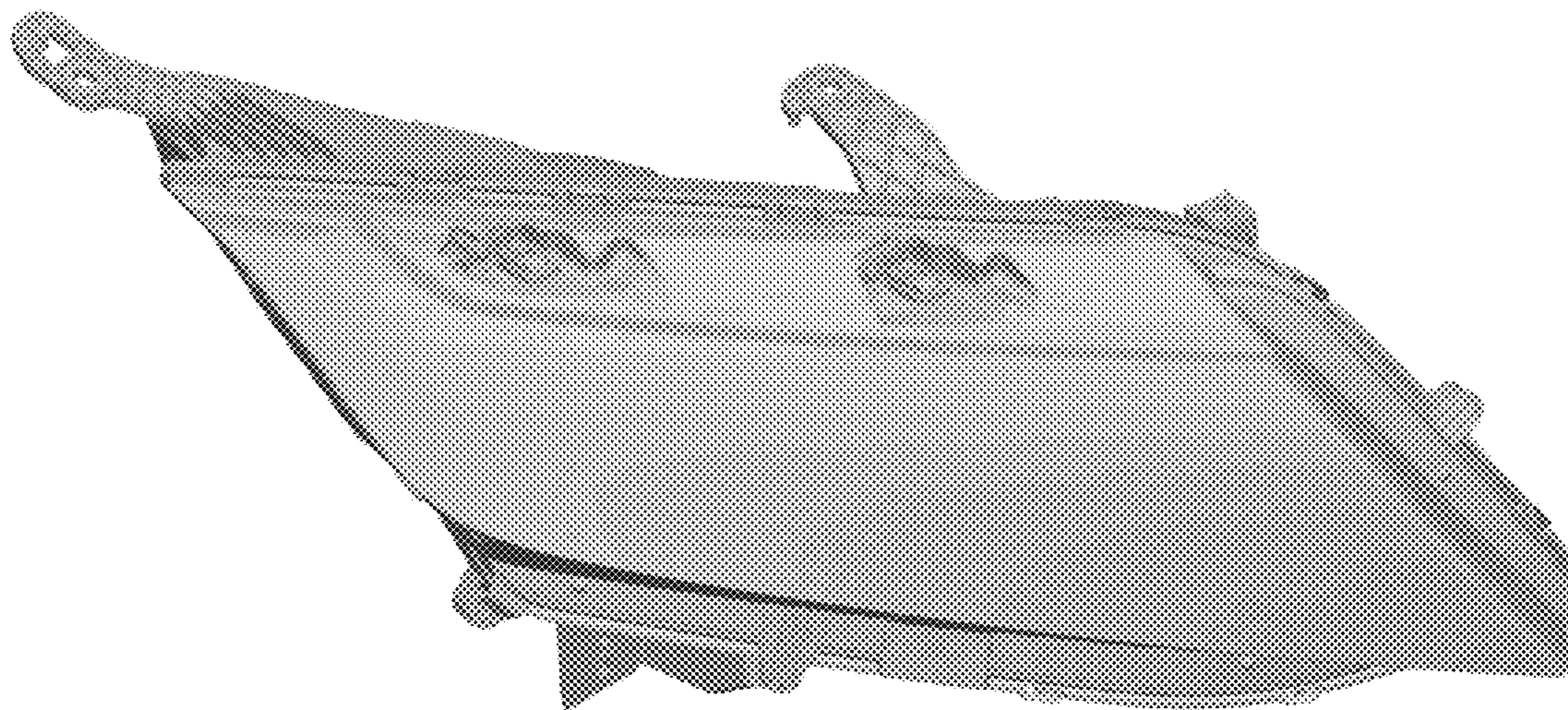
(57) **CLAIM**

The ornamental design for a LED headlight, as shown and described.

**DESCRIPTION**

FIG. 1 is a top left perspective view of a first embodiment of a LED headlight showing my new design;

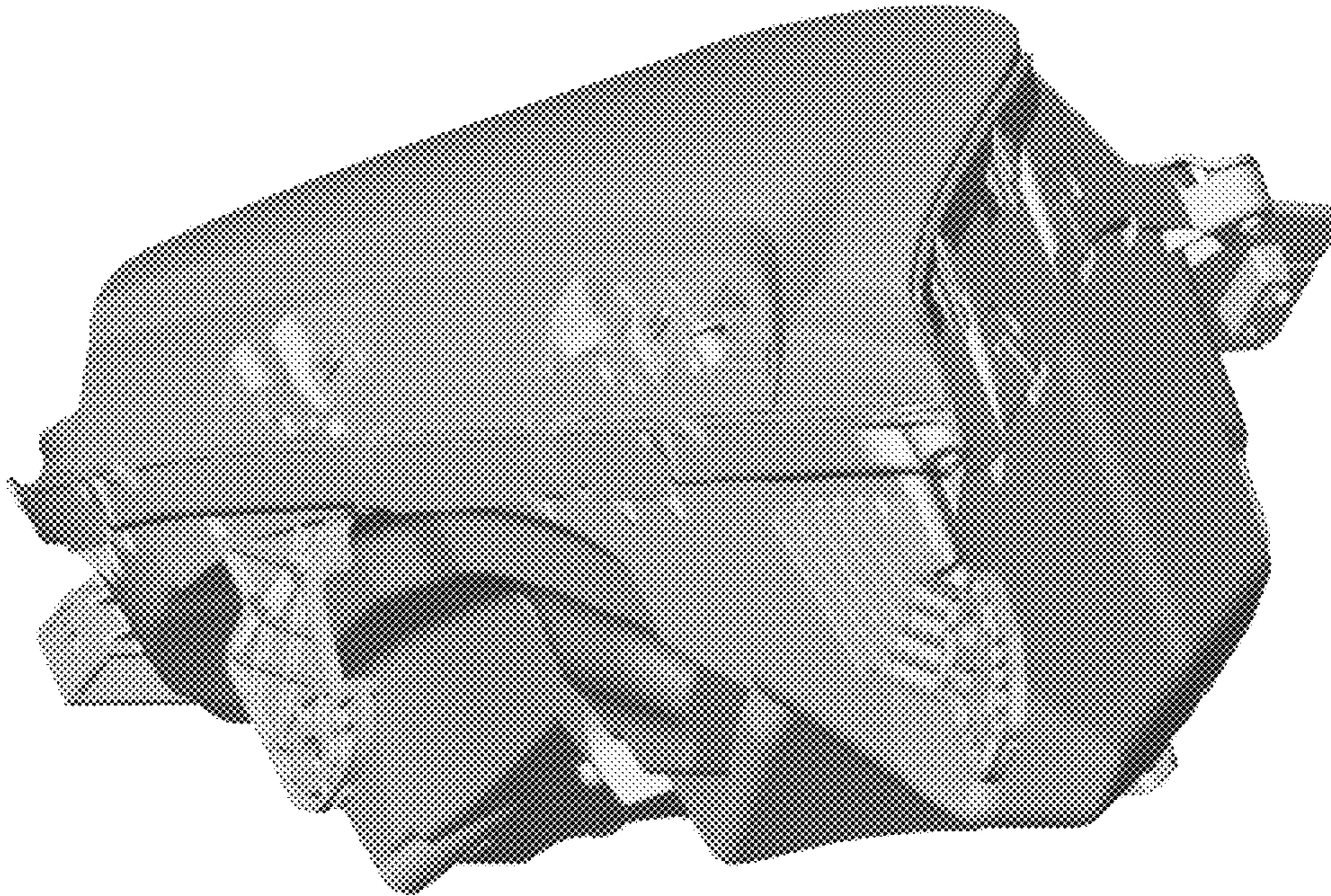

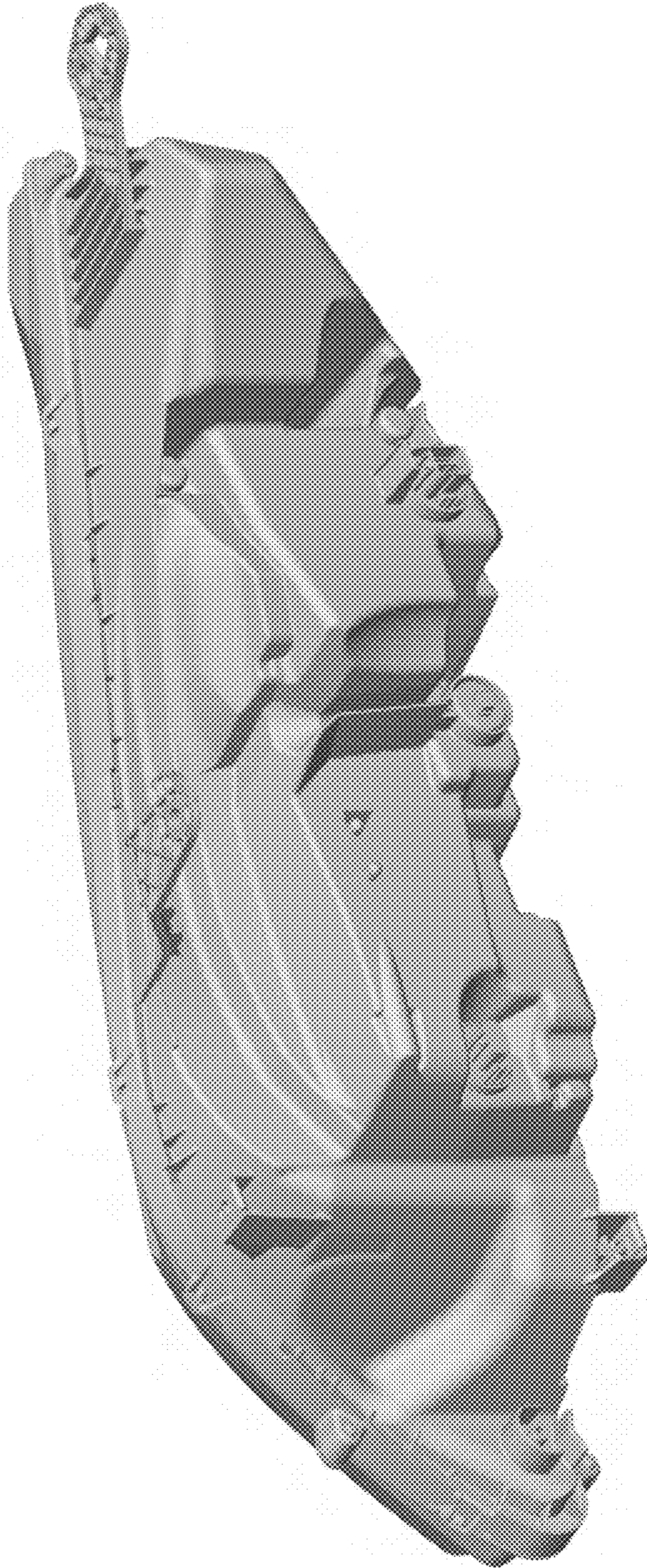

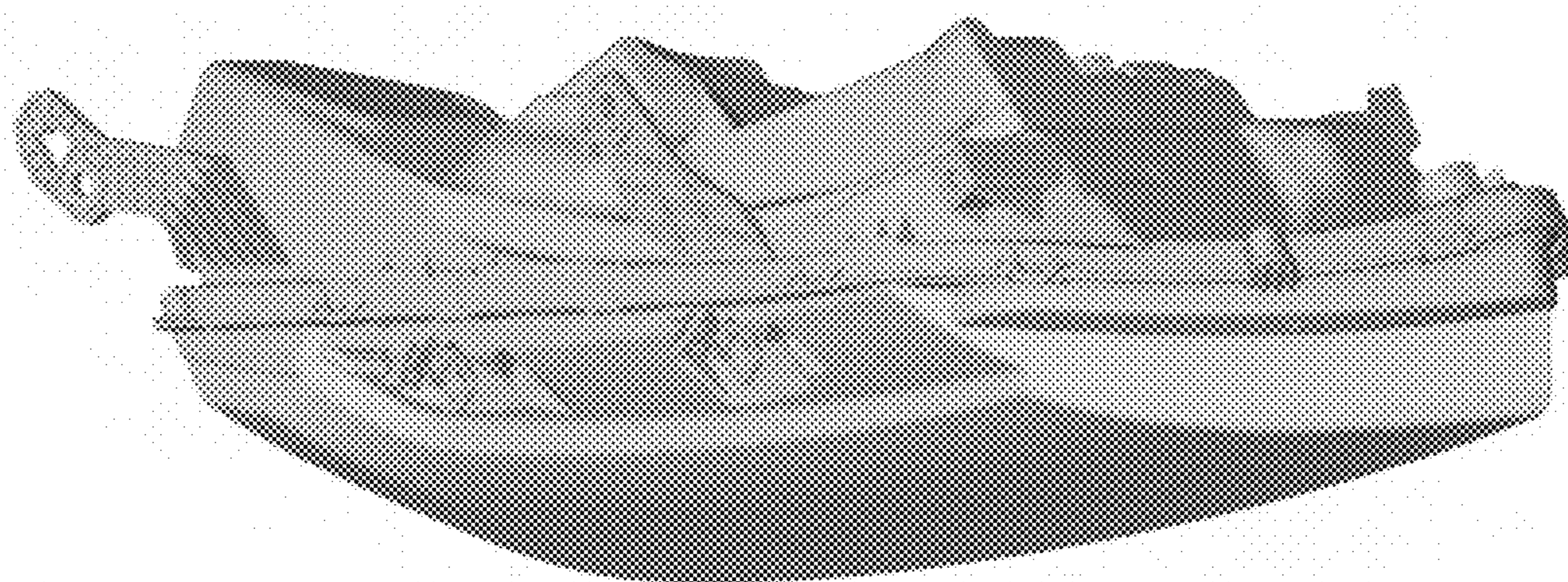

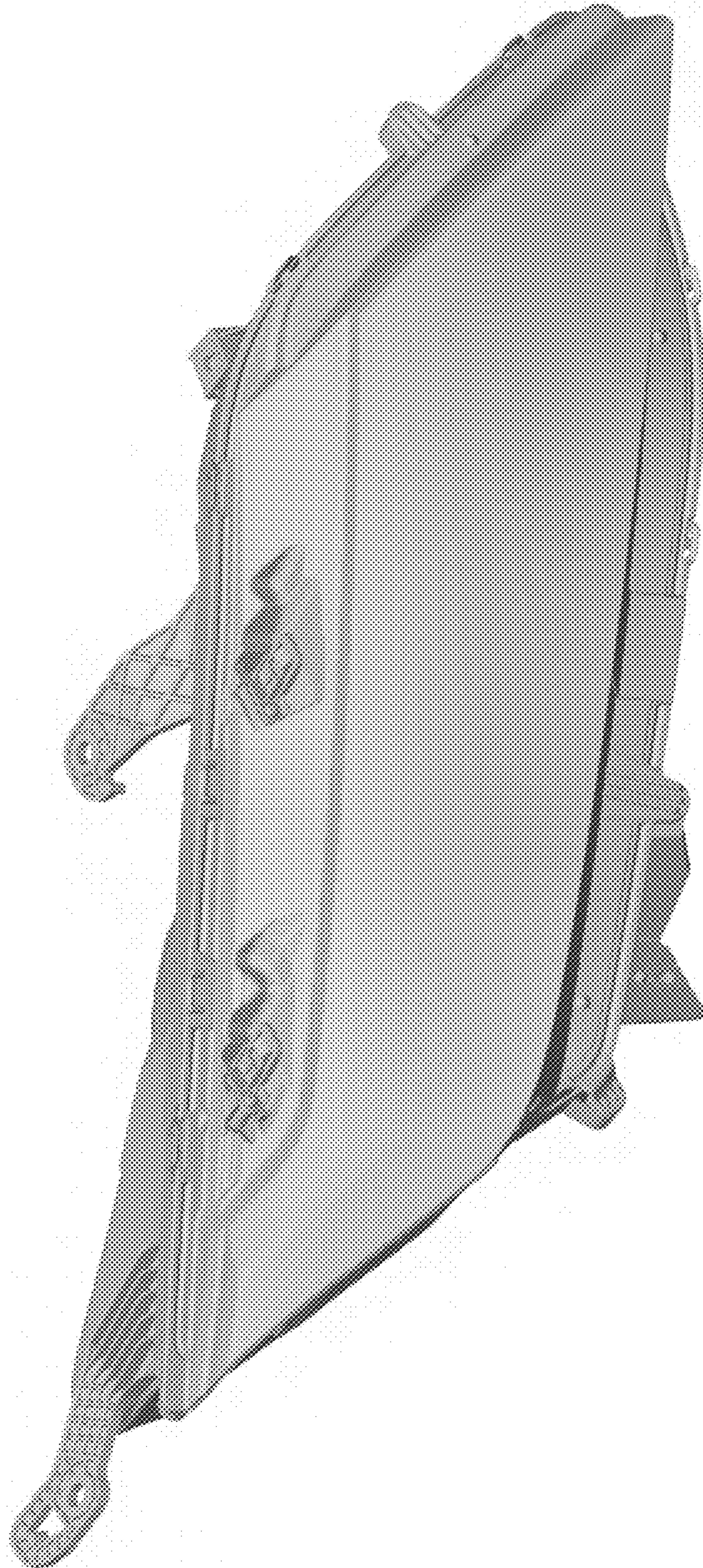

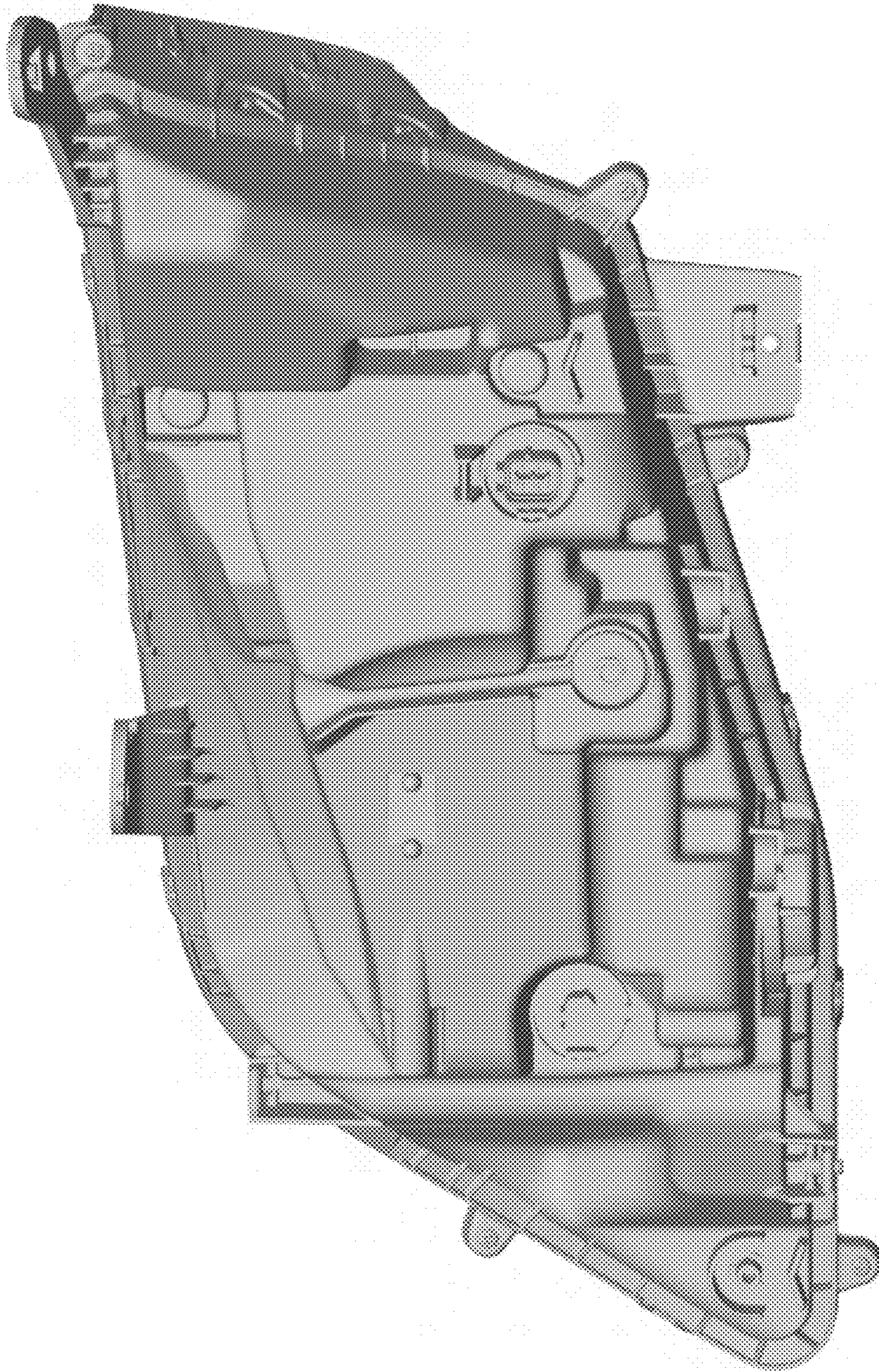

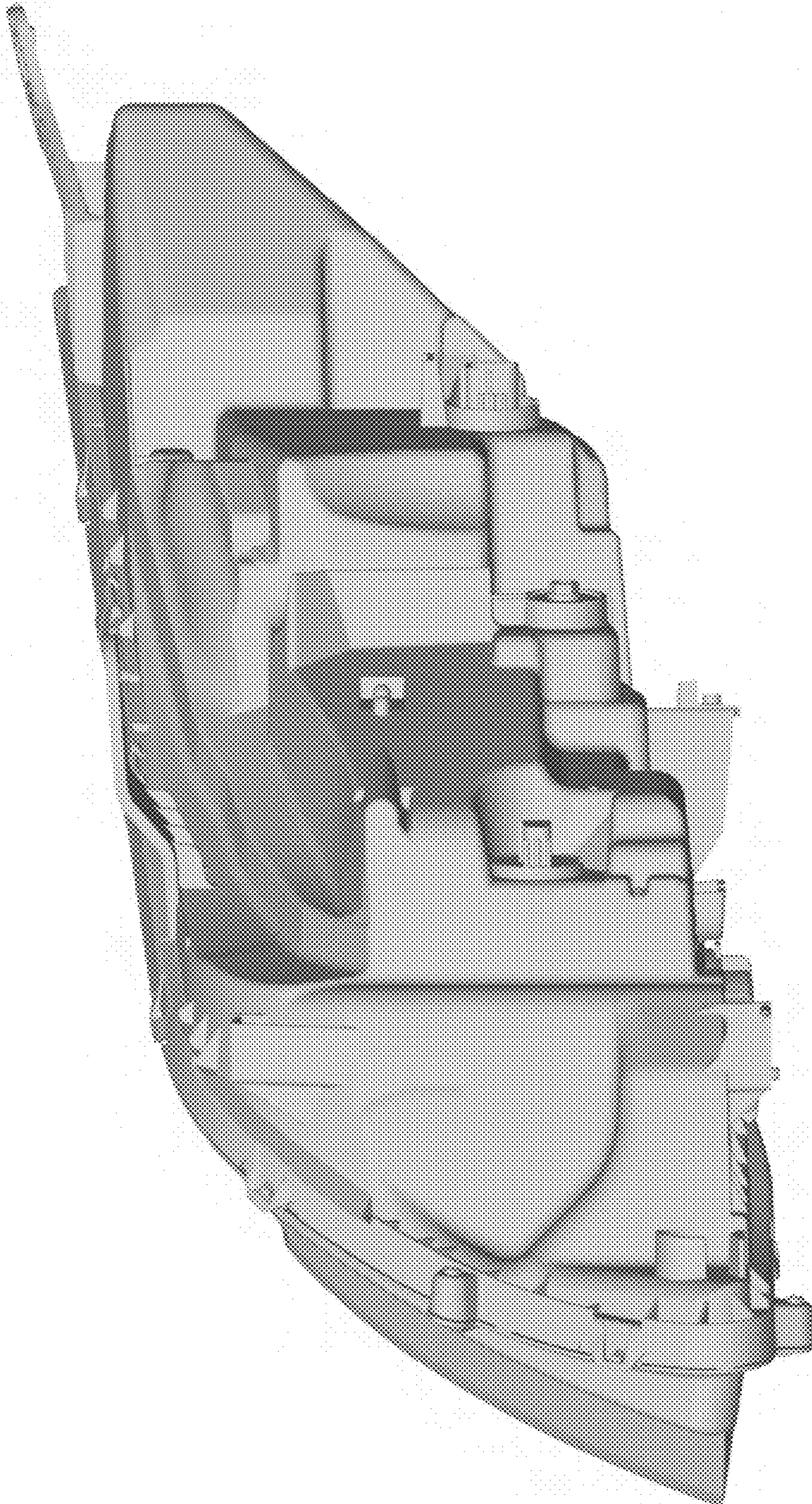

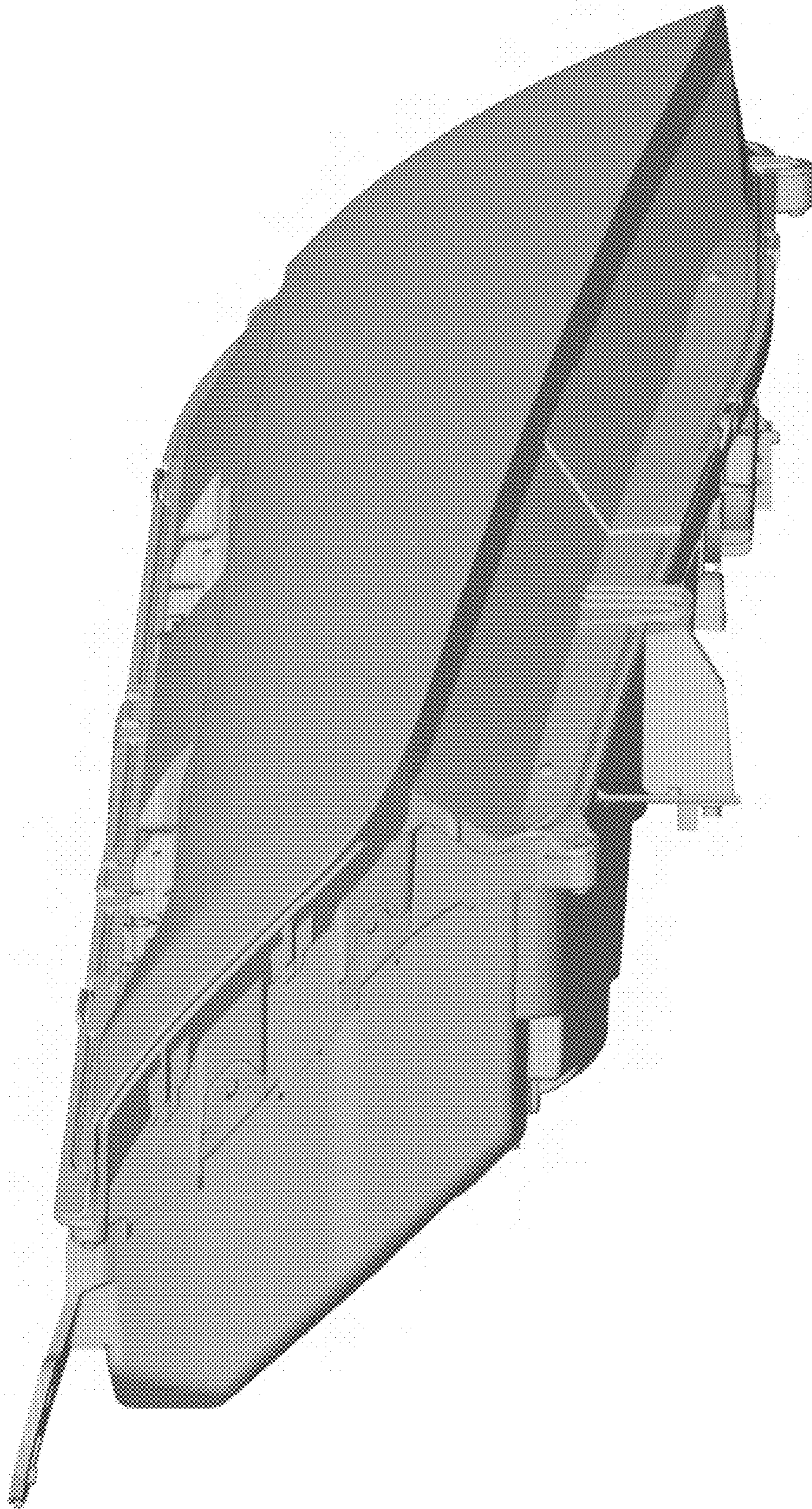

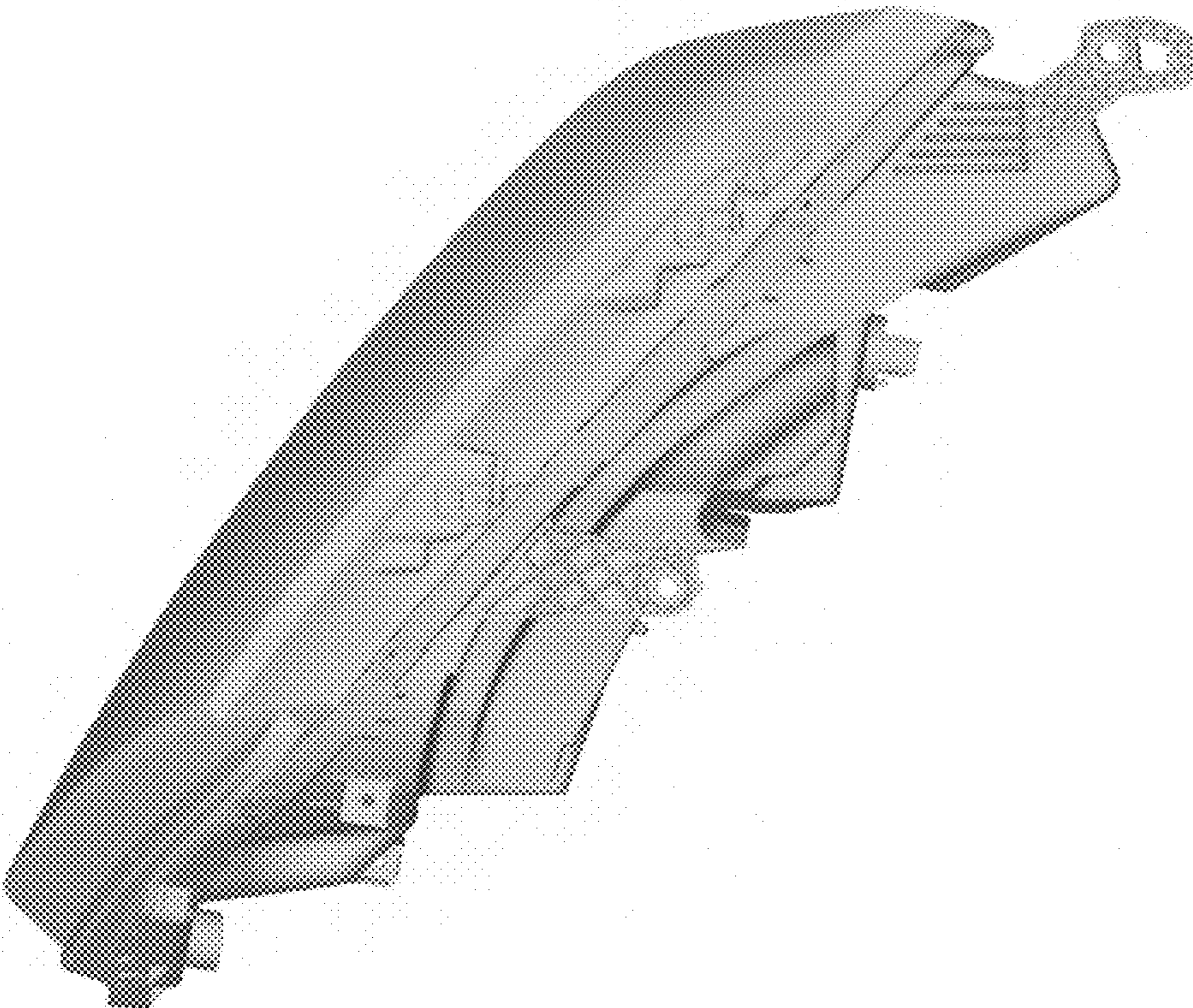
