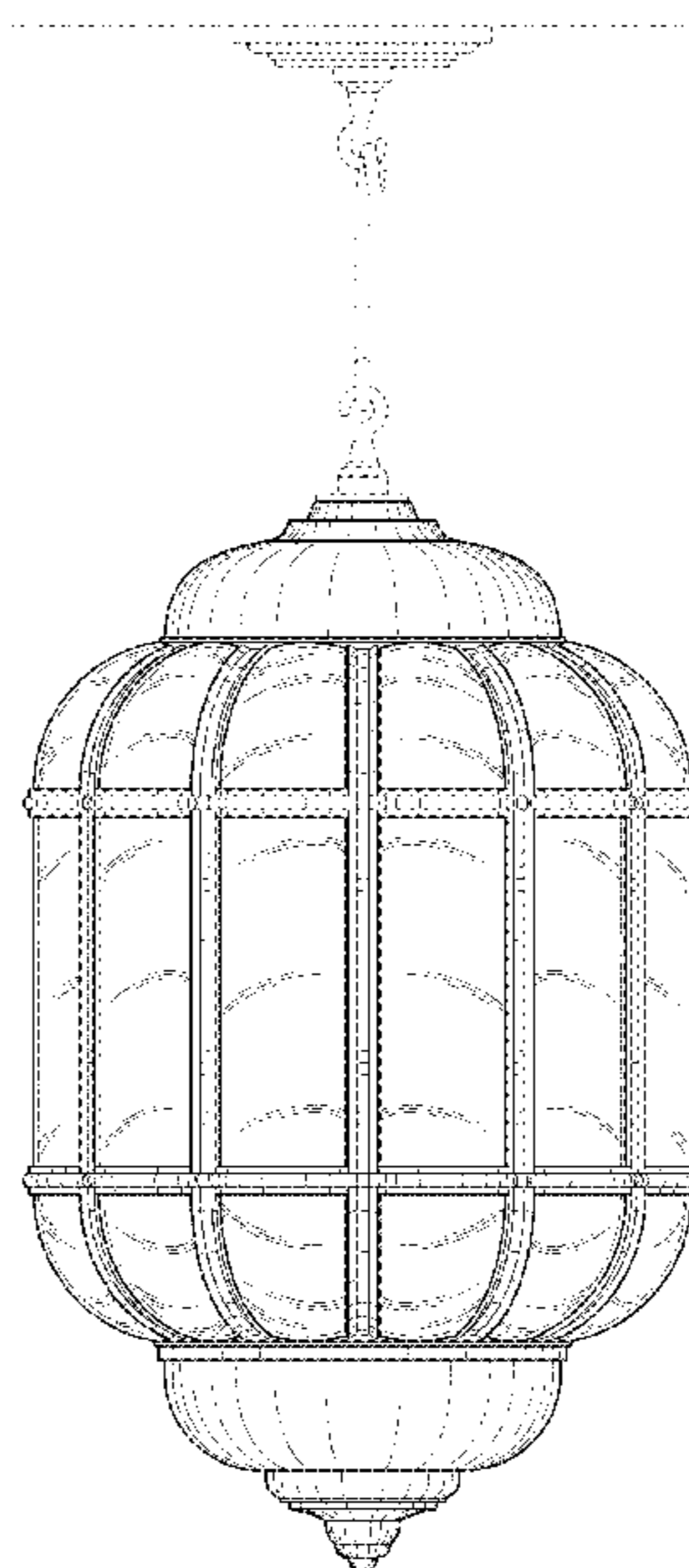
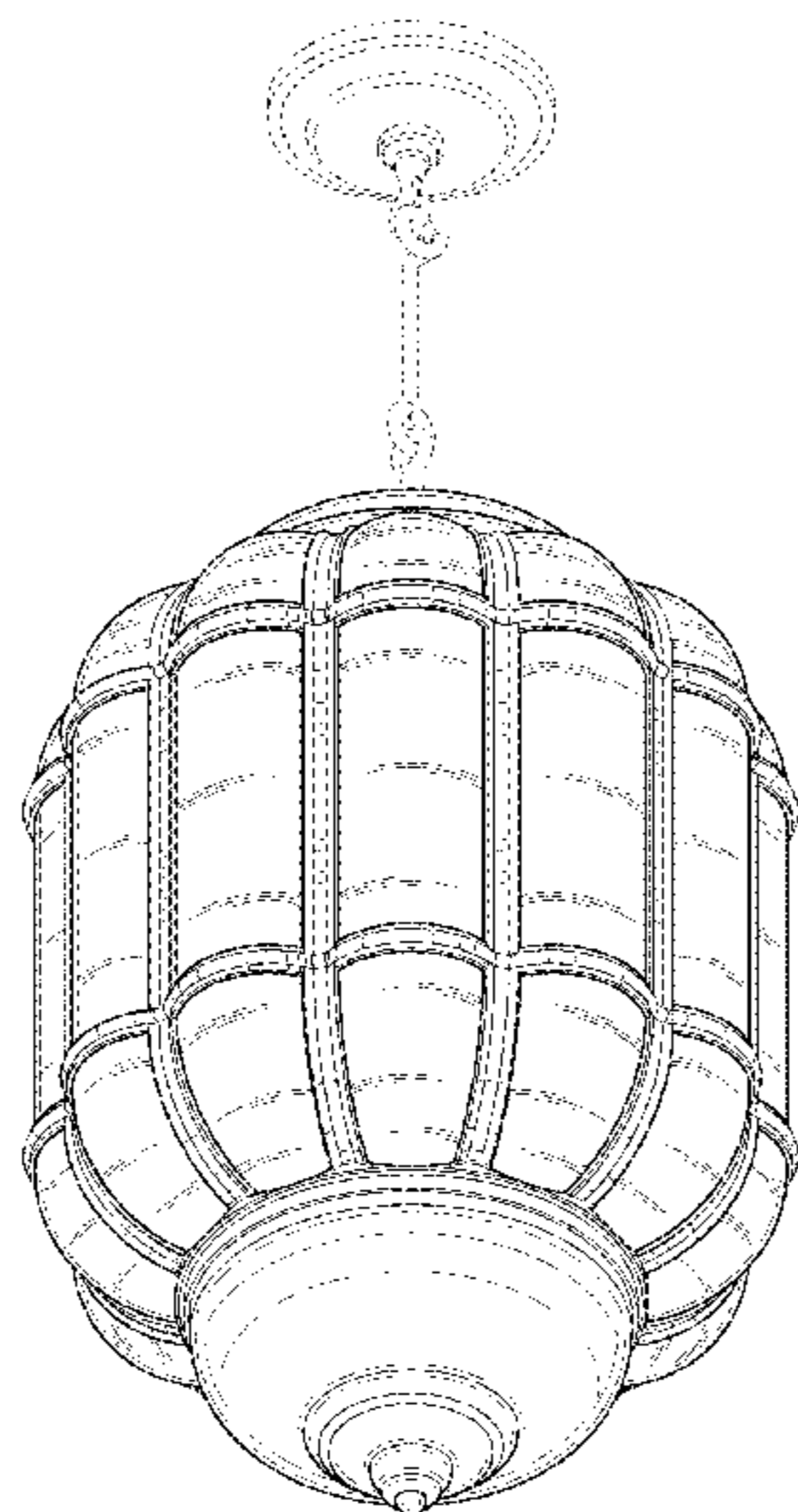
The ornamental design for a lighting fixture, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a new lighting fixture; FIG. 2 is a bottom perspective view thereof; FIG. 3 is a right elevation view thereof; FIG. 4 is a left elevational view thereof; FIG. 5 is a front elevation view thereof; FIG. 6 is a back elevation view thereof; FIG. 7 is a top plan view thereof; and, FIG. 8 is a bottom plan view thereof.

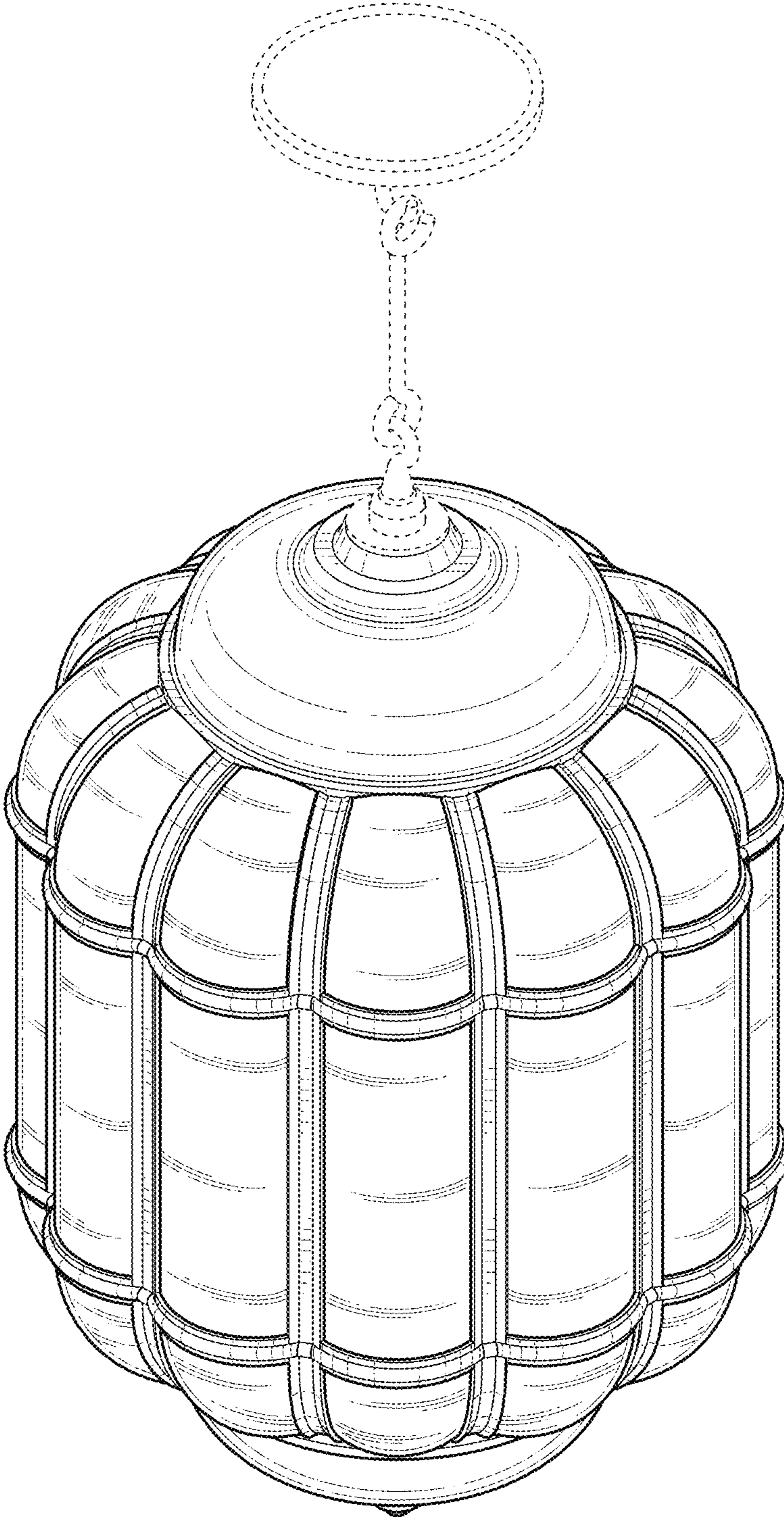

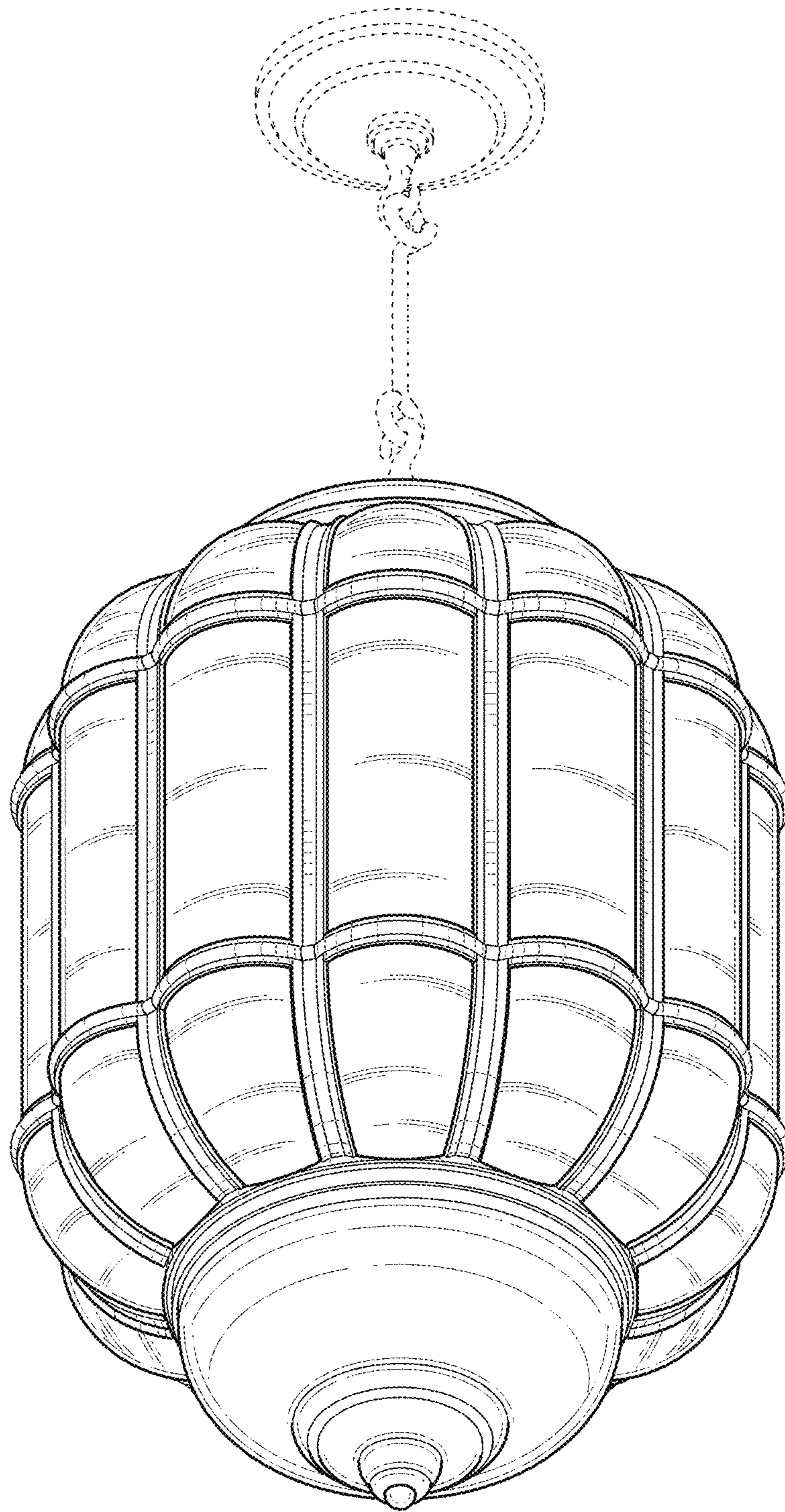

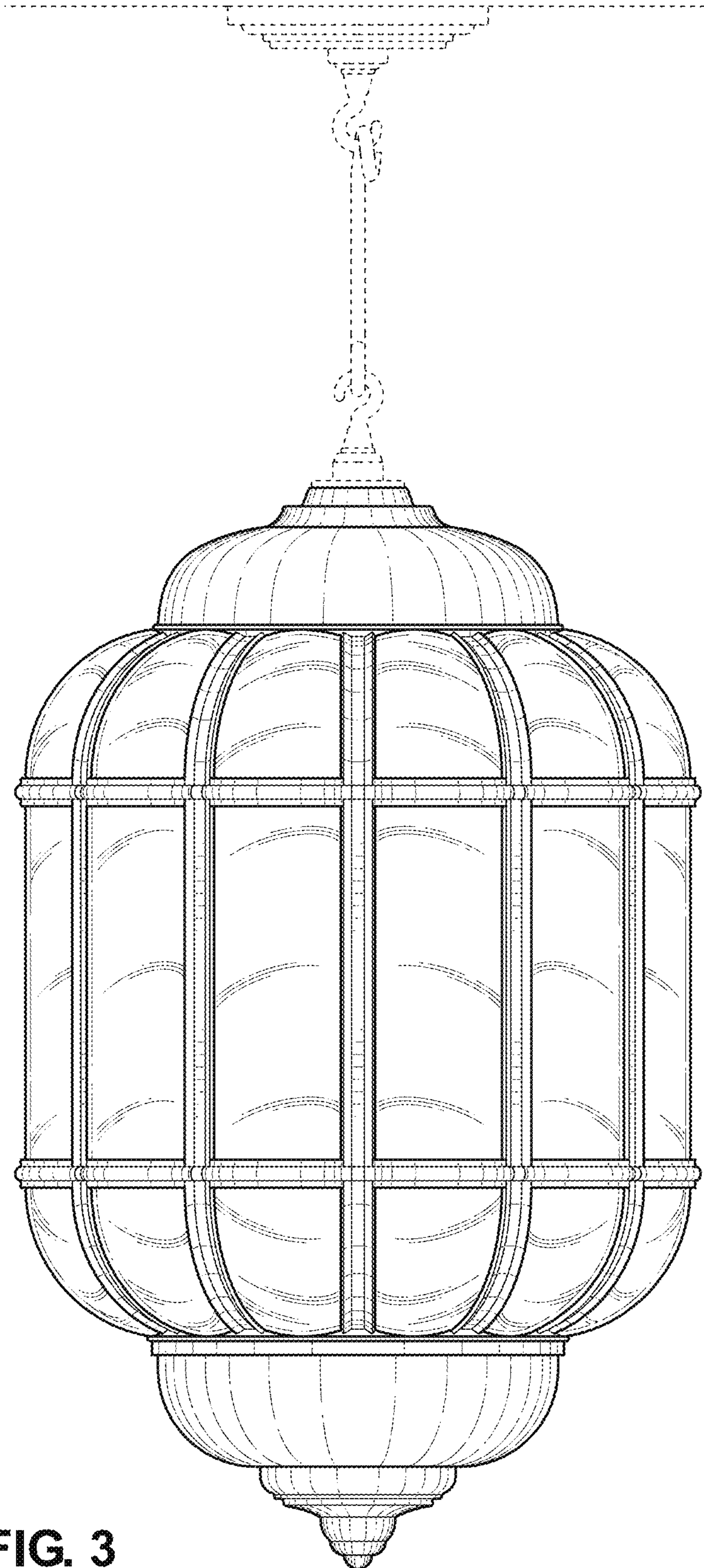

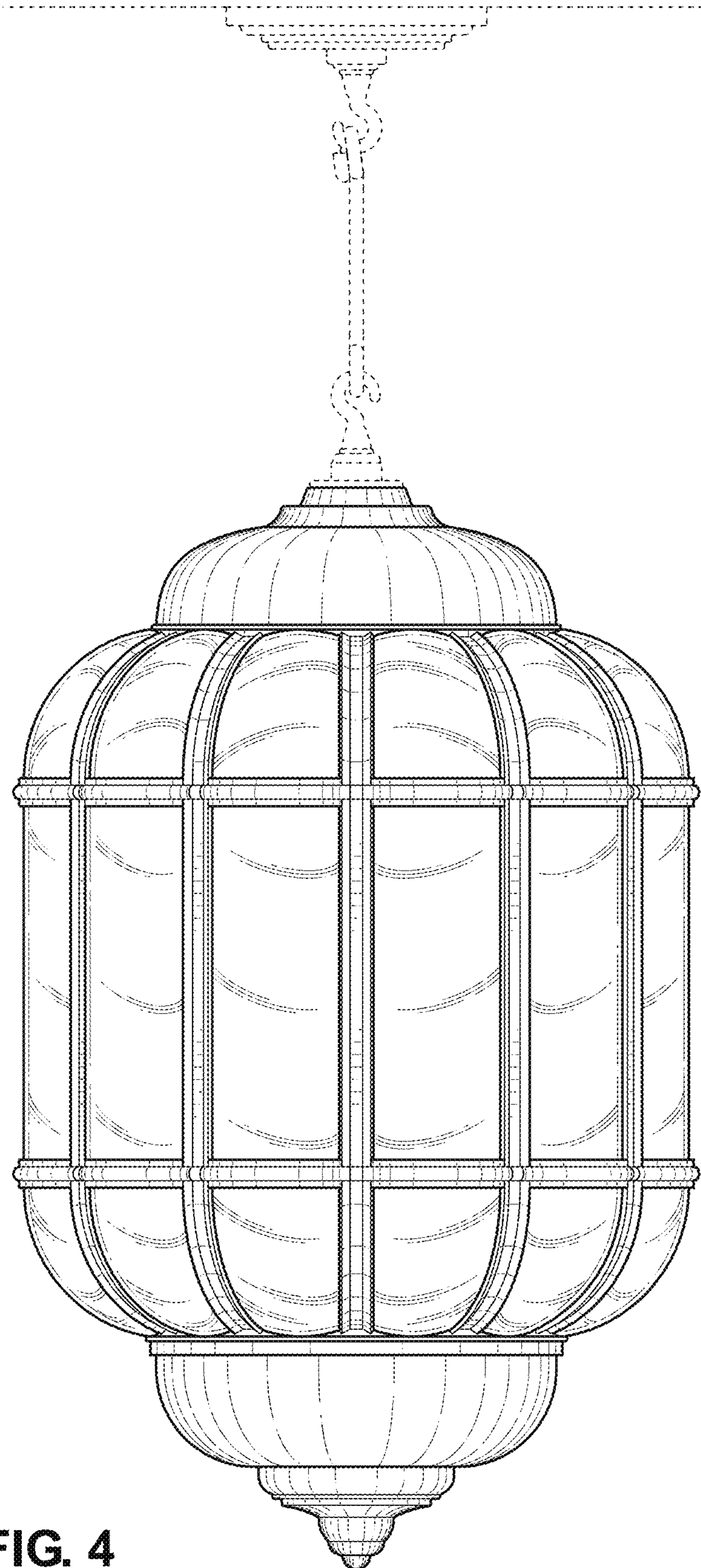

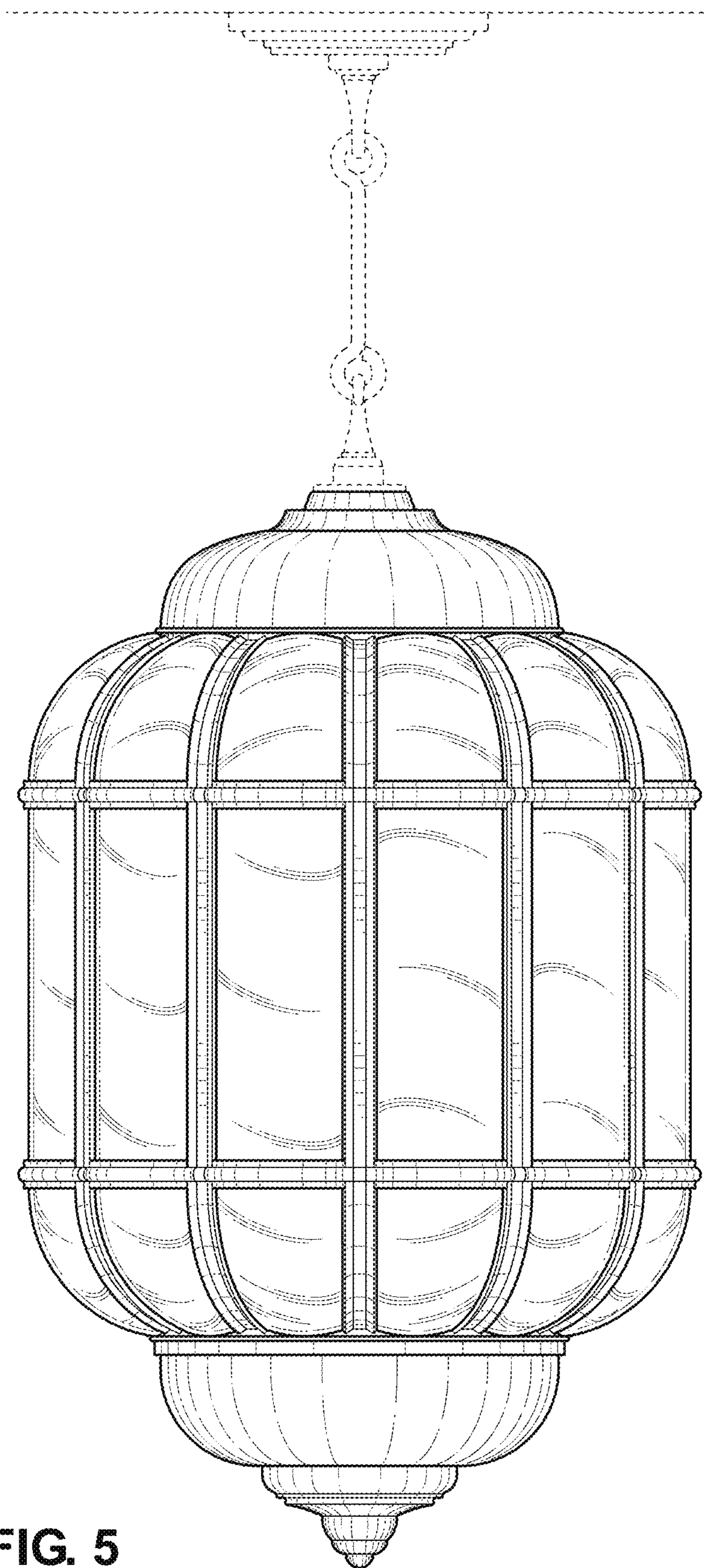

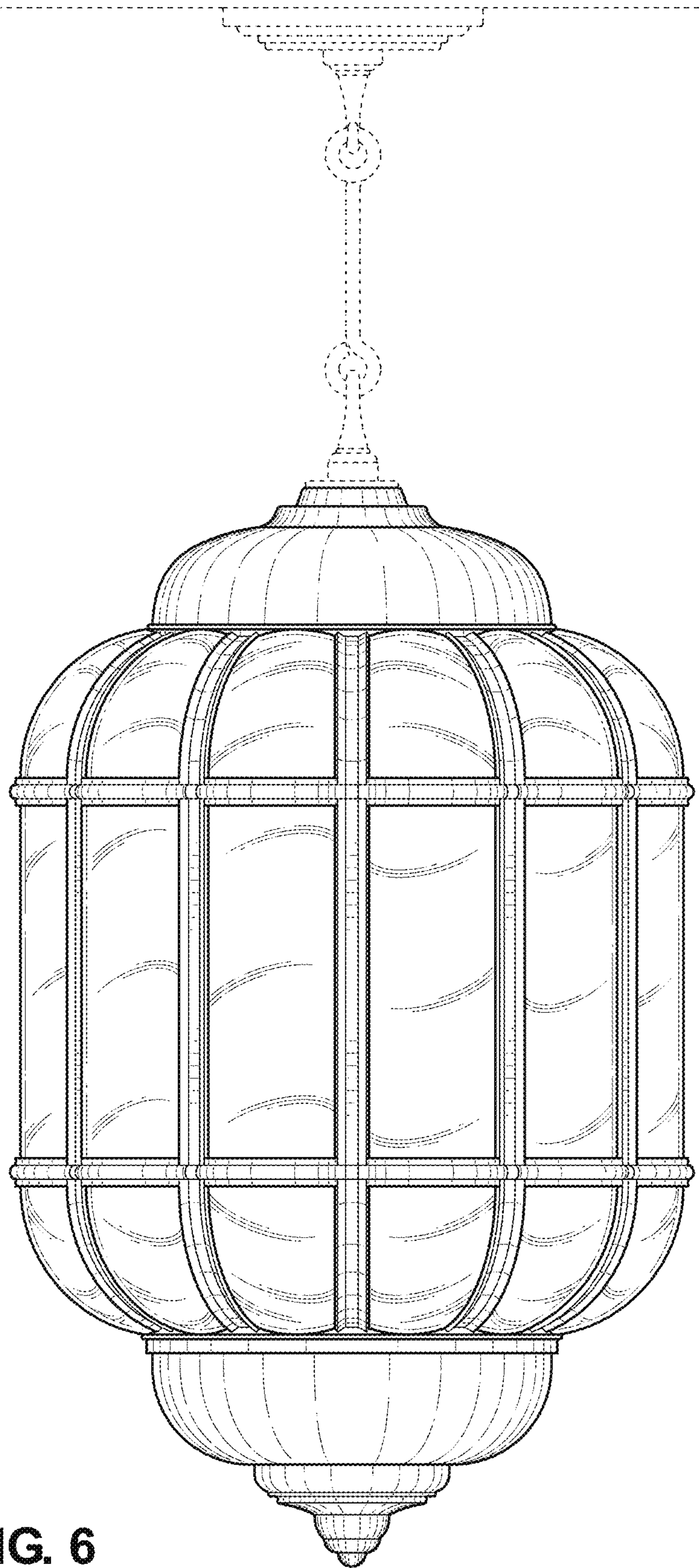

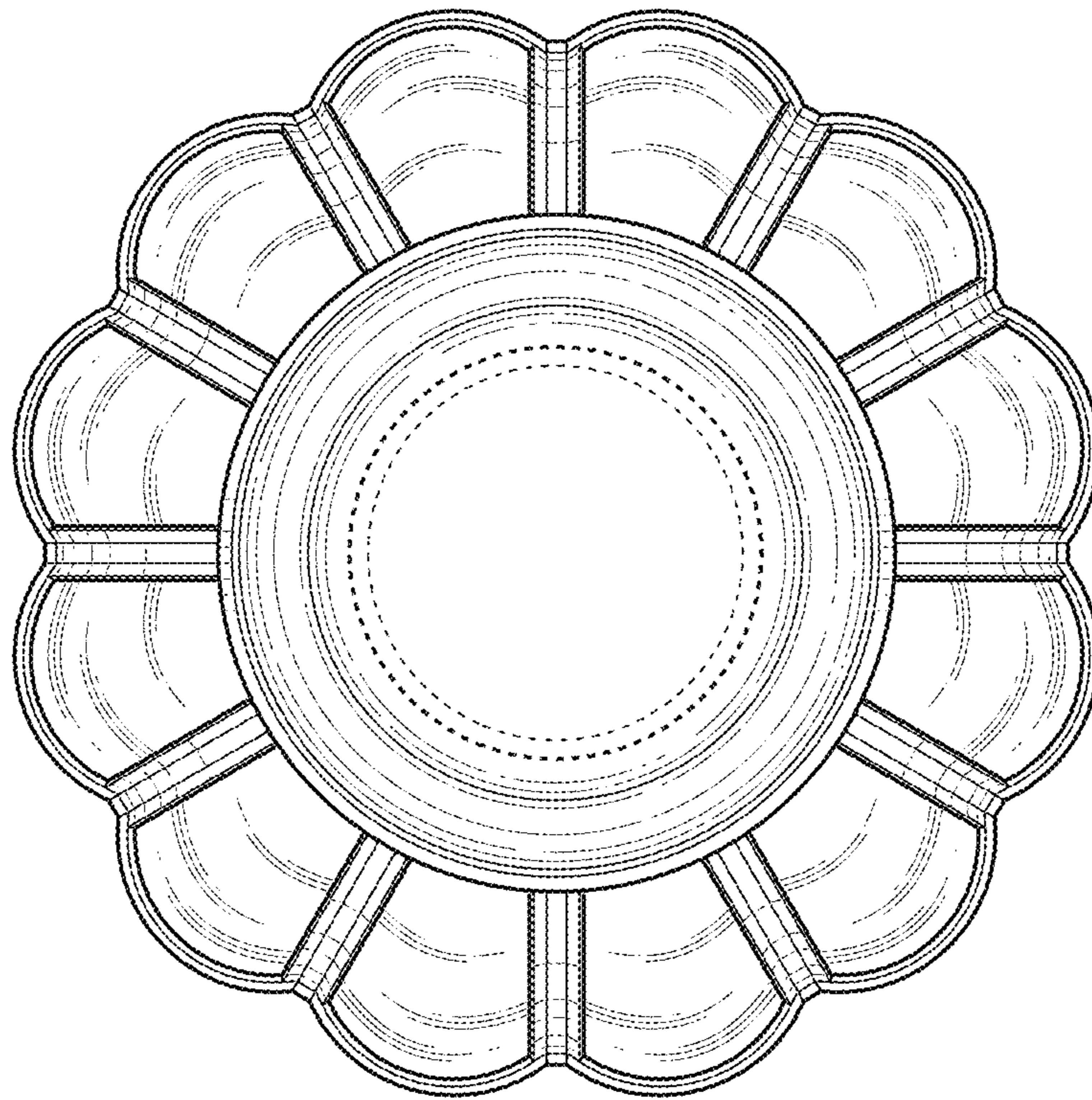

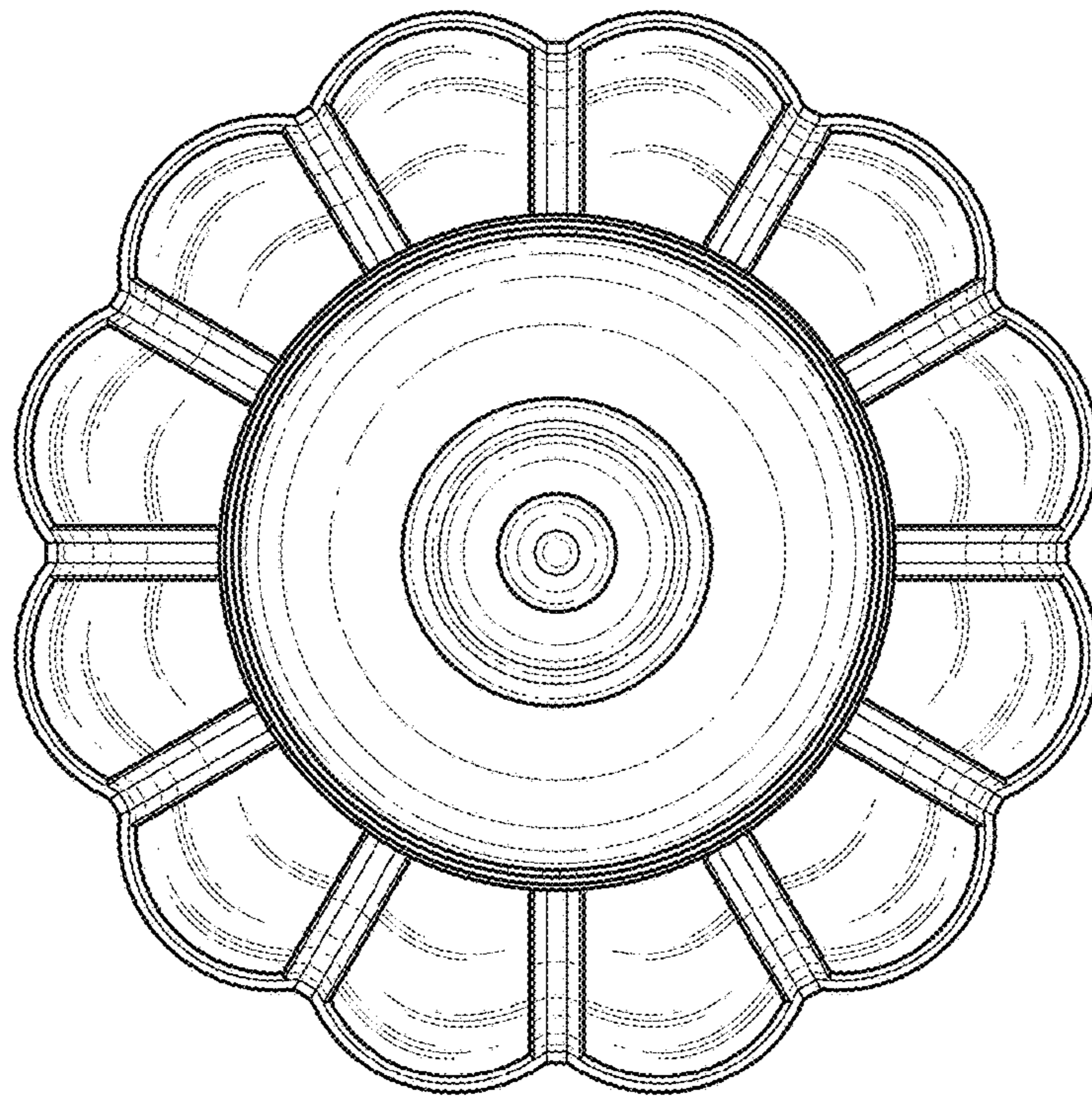
