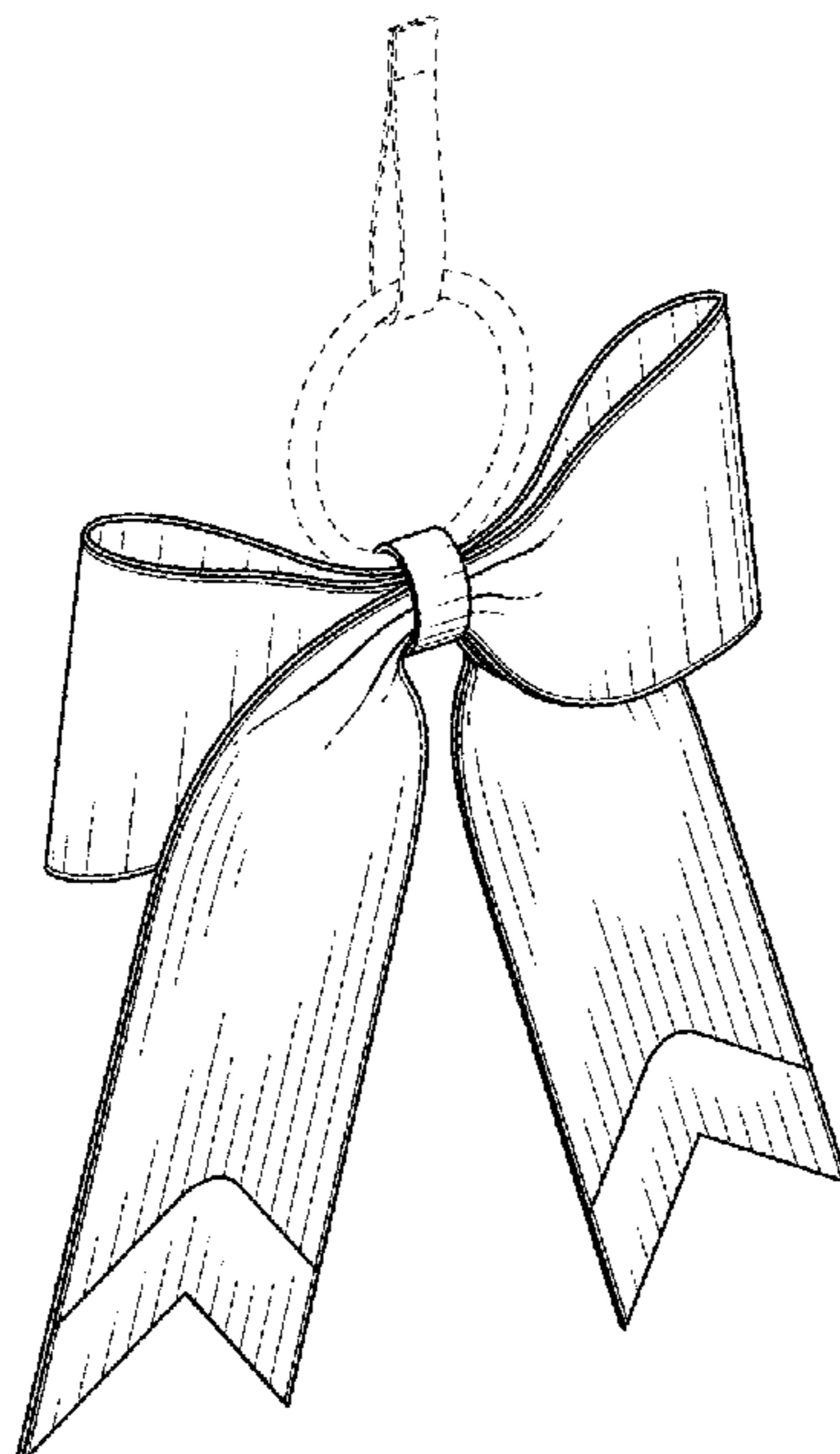
(57) **CLAIM**

I claim the ornamental design for a hair bow, as shown and described.

DESCRIPTION

FIG. 1 is a perspective view of a hair bow, showing my new design;
FIG. 2 is a front elevational view of FIG. 1;
FIG. 3 is a rear elevational view of FIG. 1;
FIG. 4 is a left-side elevational view of FIG. 1;
FIG. 5 is a right-side elevational view of FIG. 1;
FIG. 6 is a top plan view of FIG. 1; and,
FIG. 7 is a bottom plan view of FIG. 1.
The broken lines showing an attachment band in the figures depict environmental matter and form no part of the claimed design.

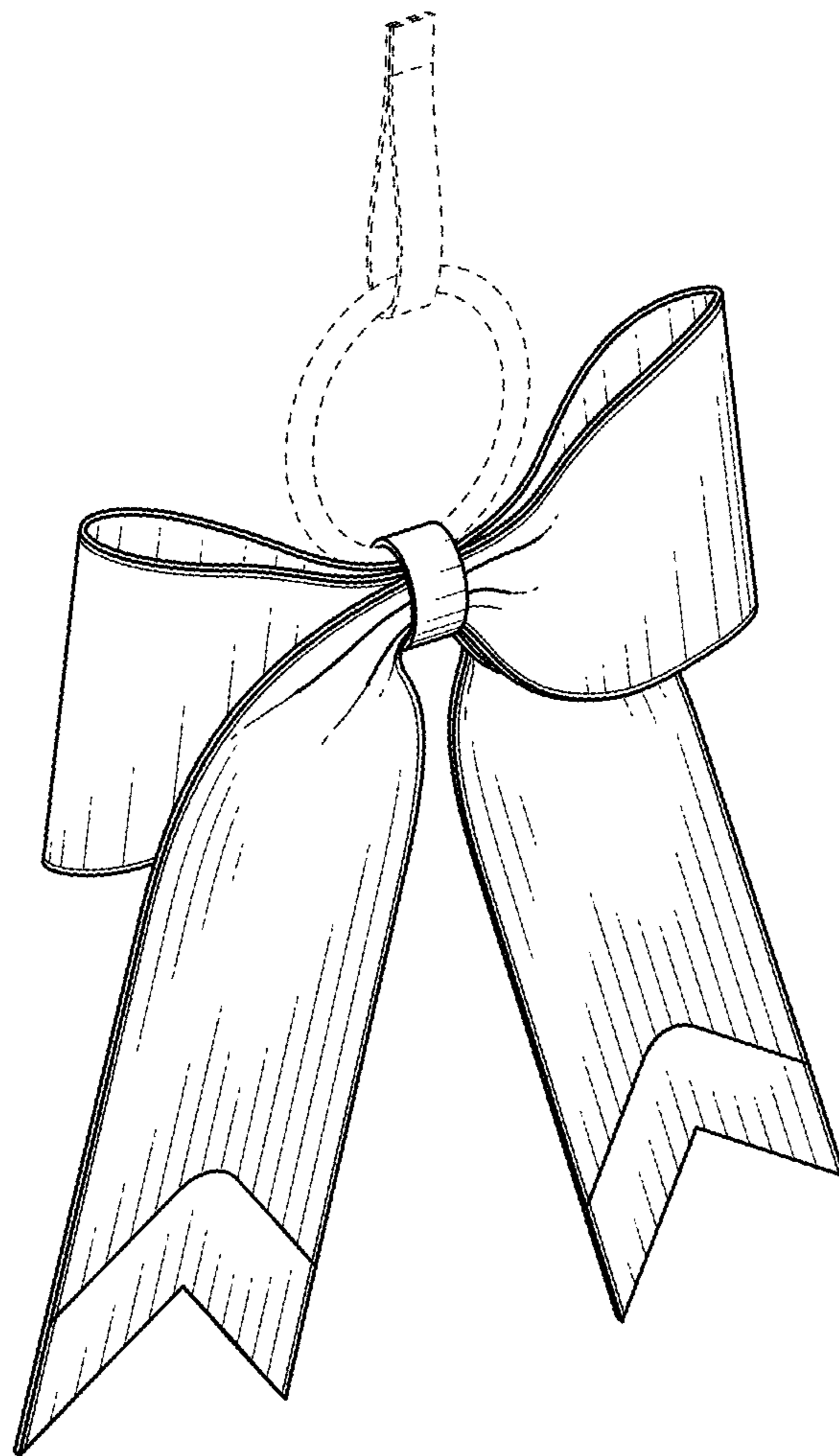

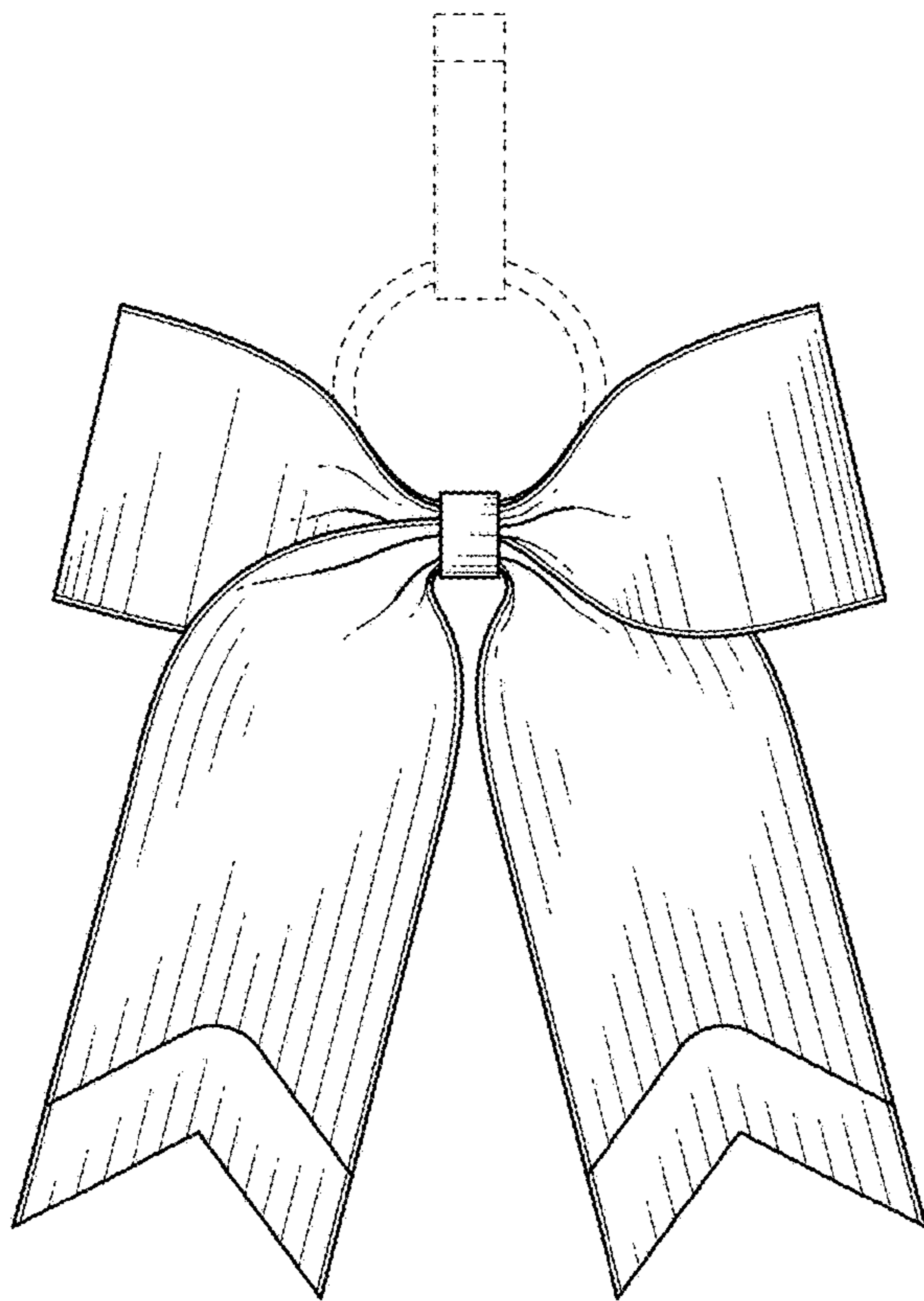

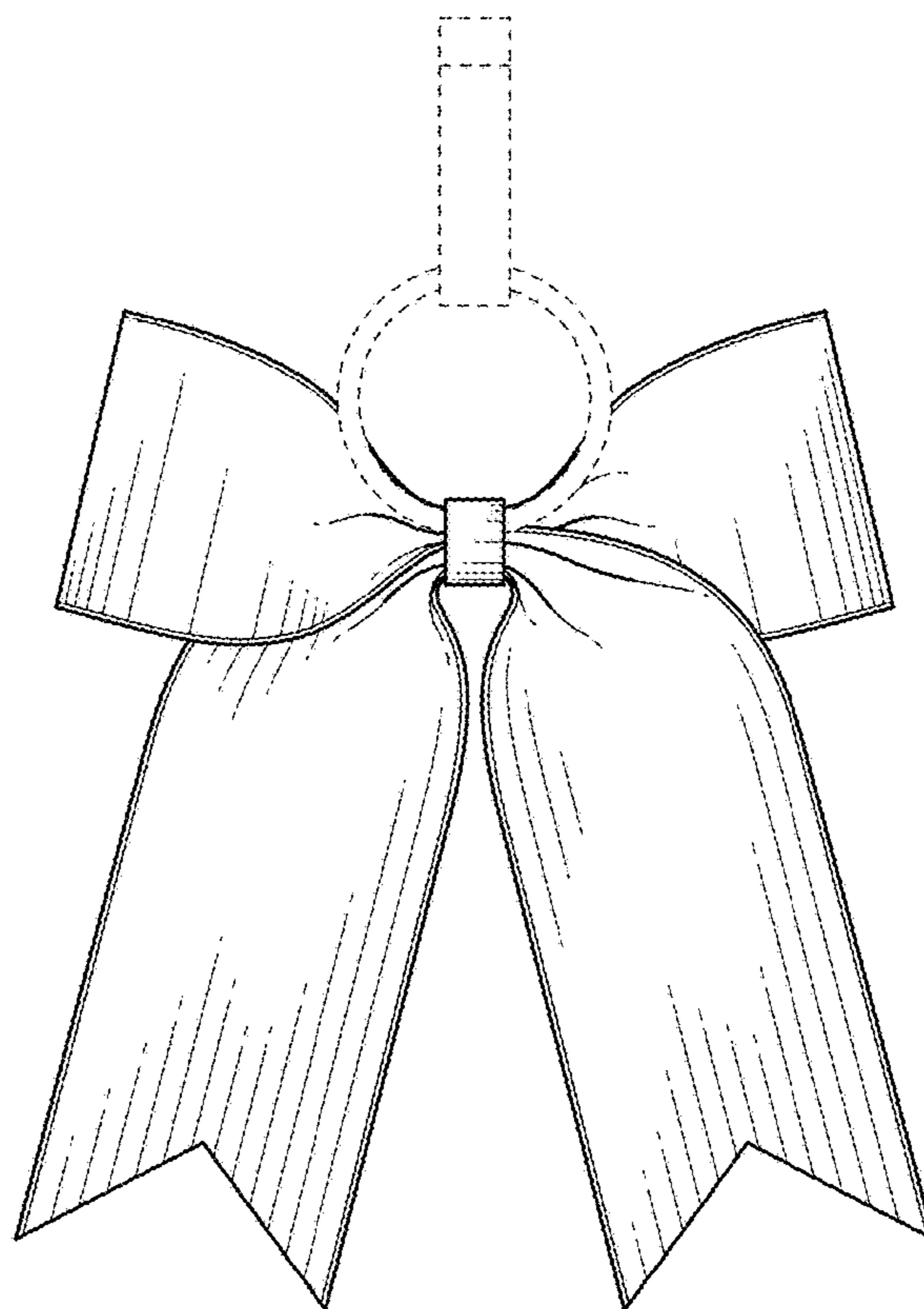

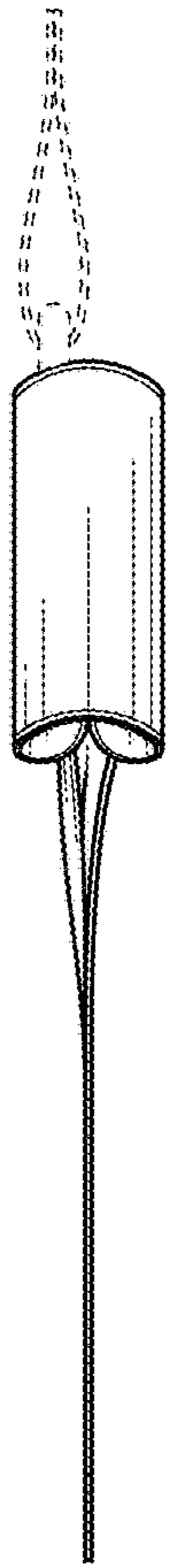

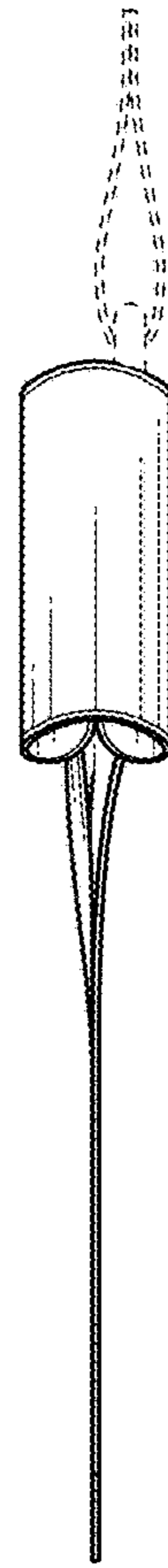

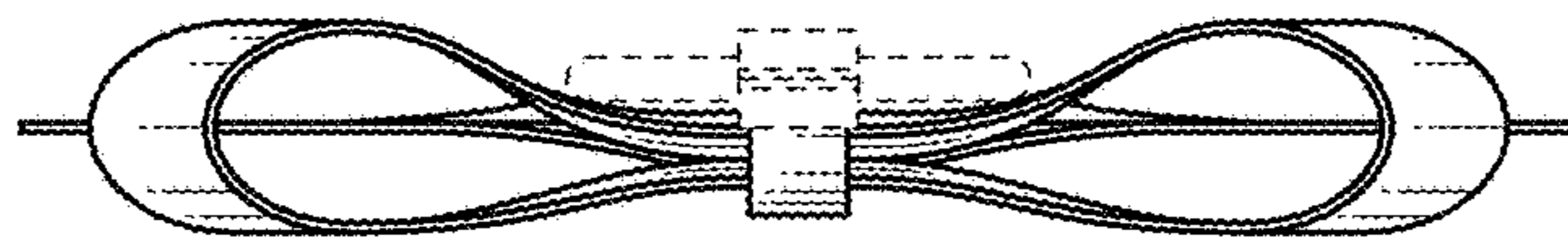

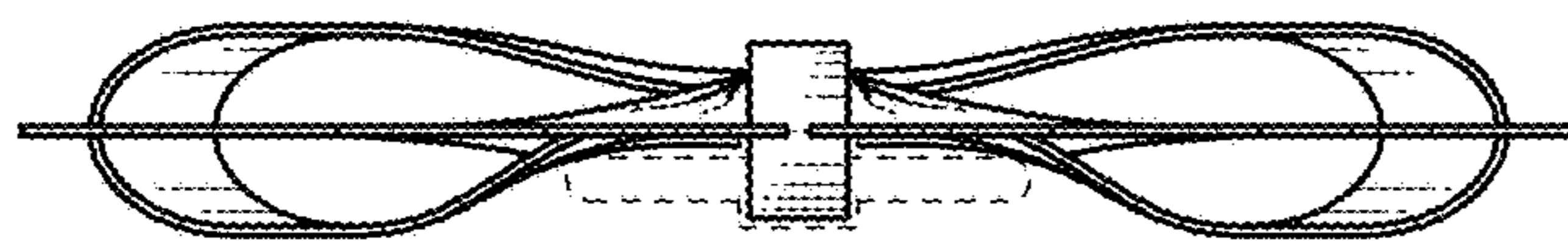
