FIG. 8 is a side view of the pet leash in accordance with our new design of FIGS. 1 to 7.

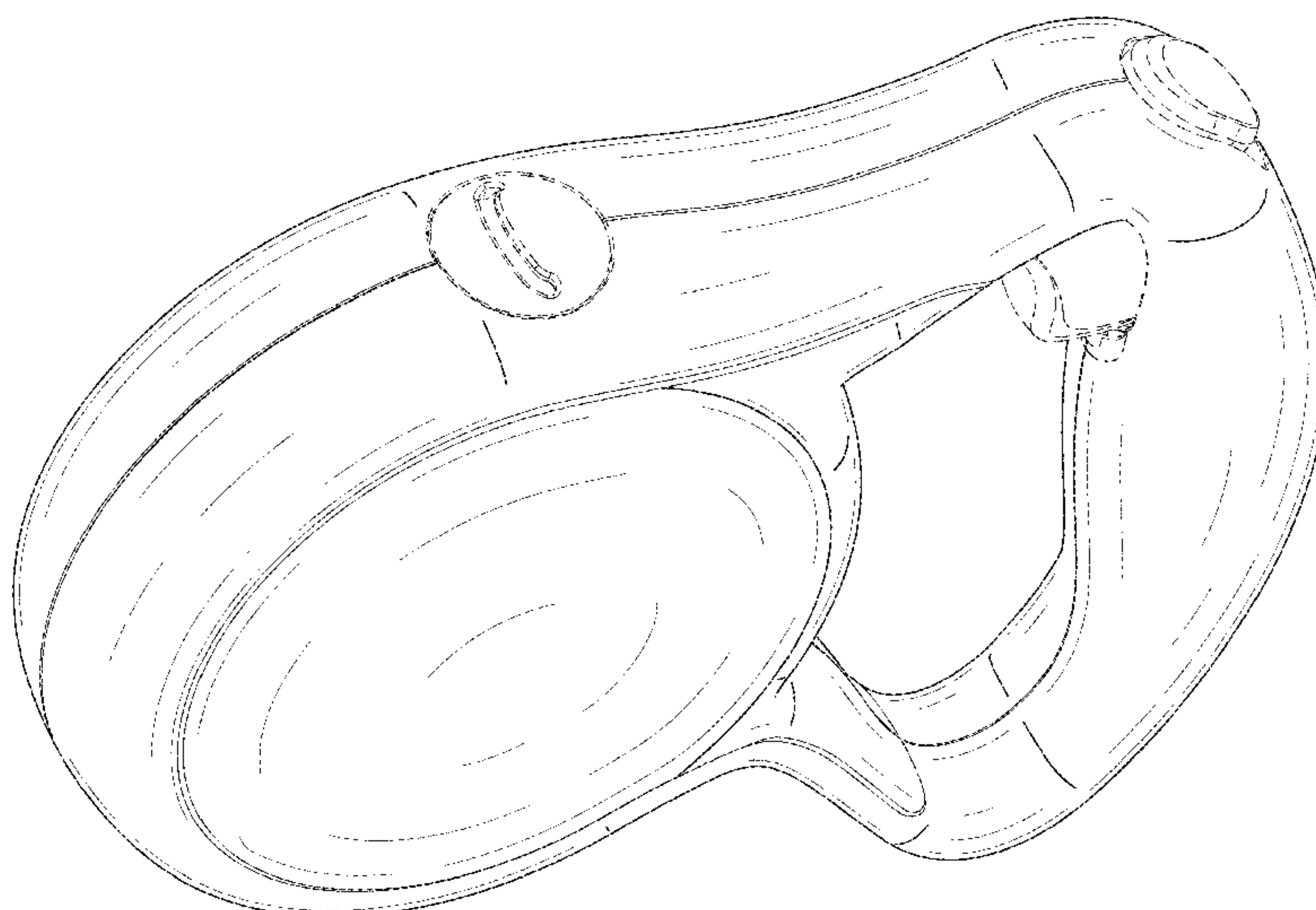

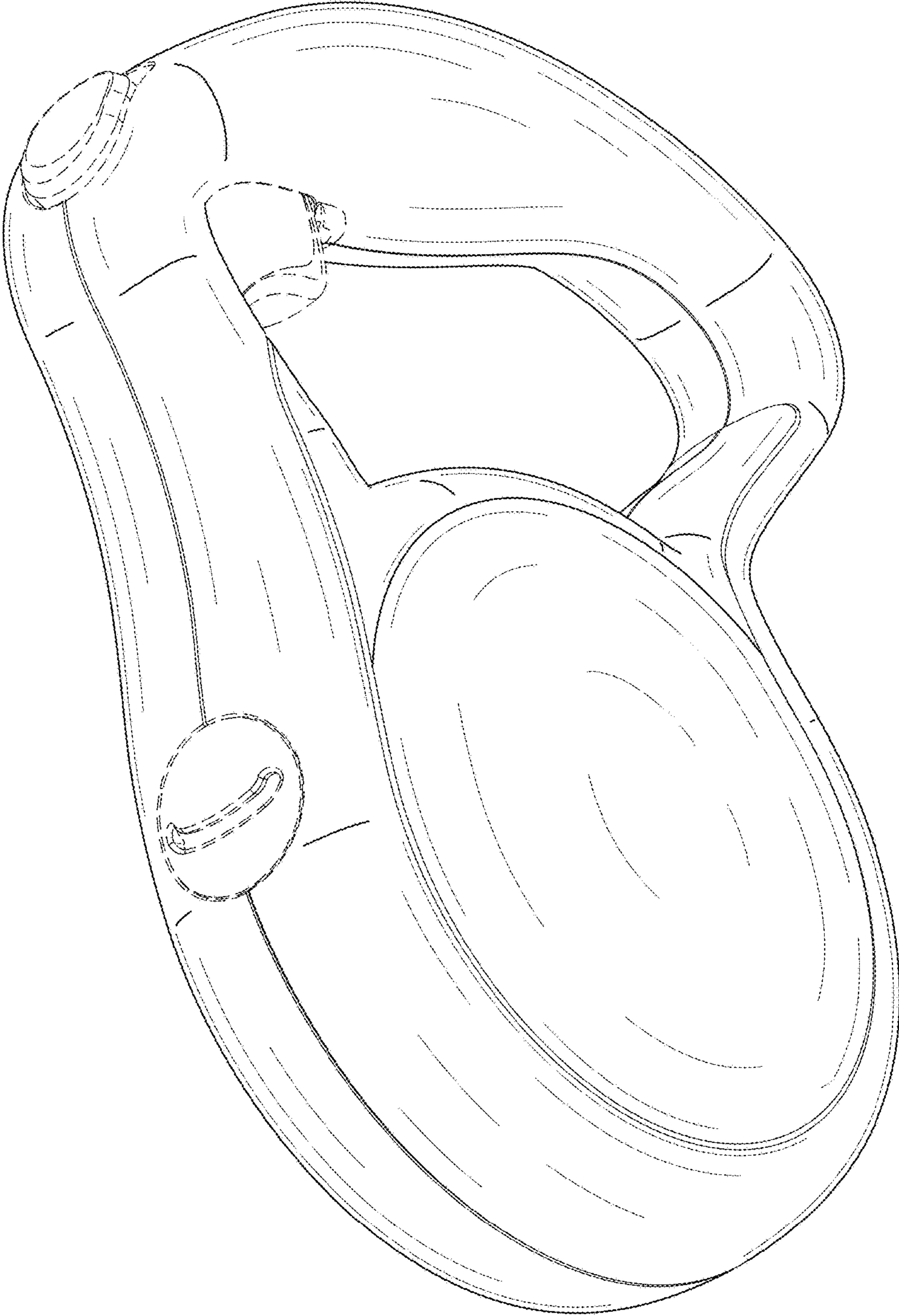

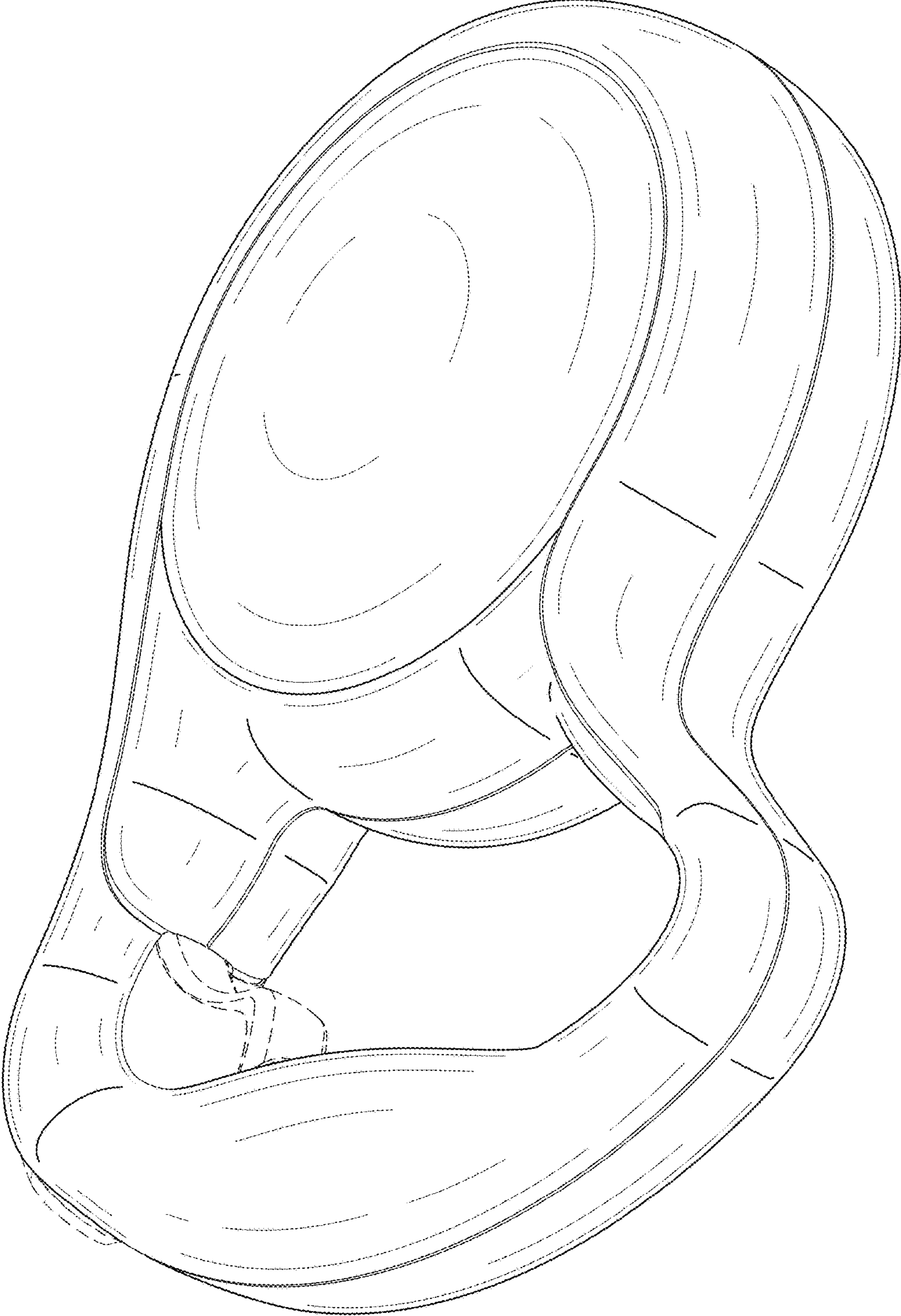

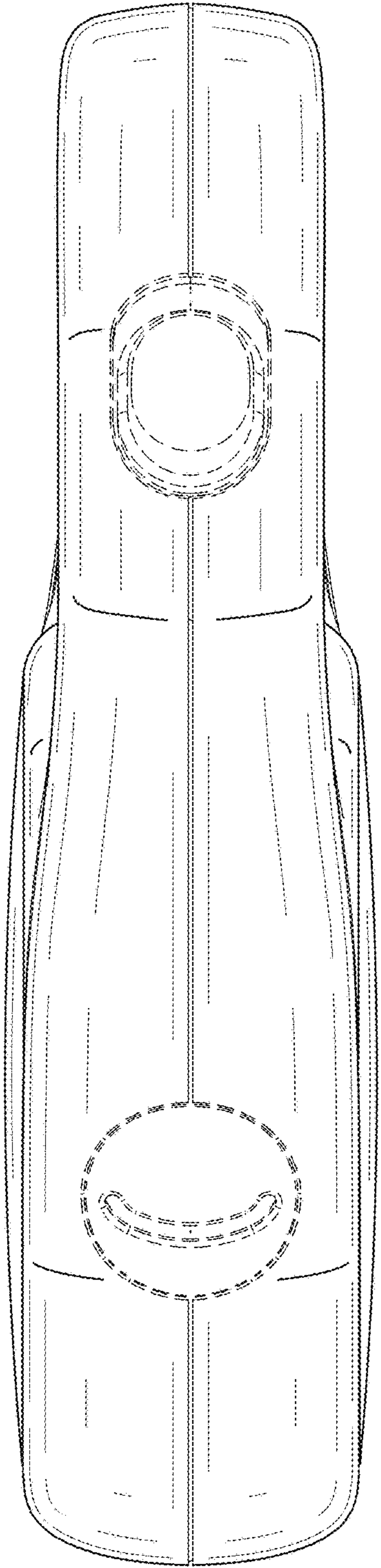

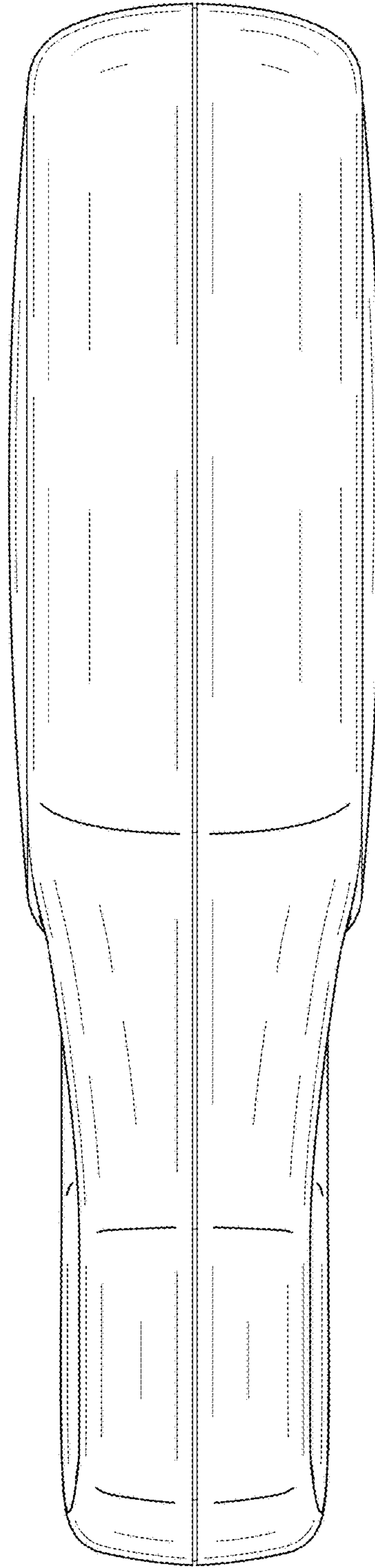

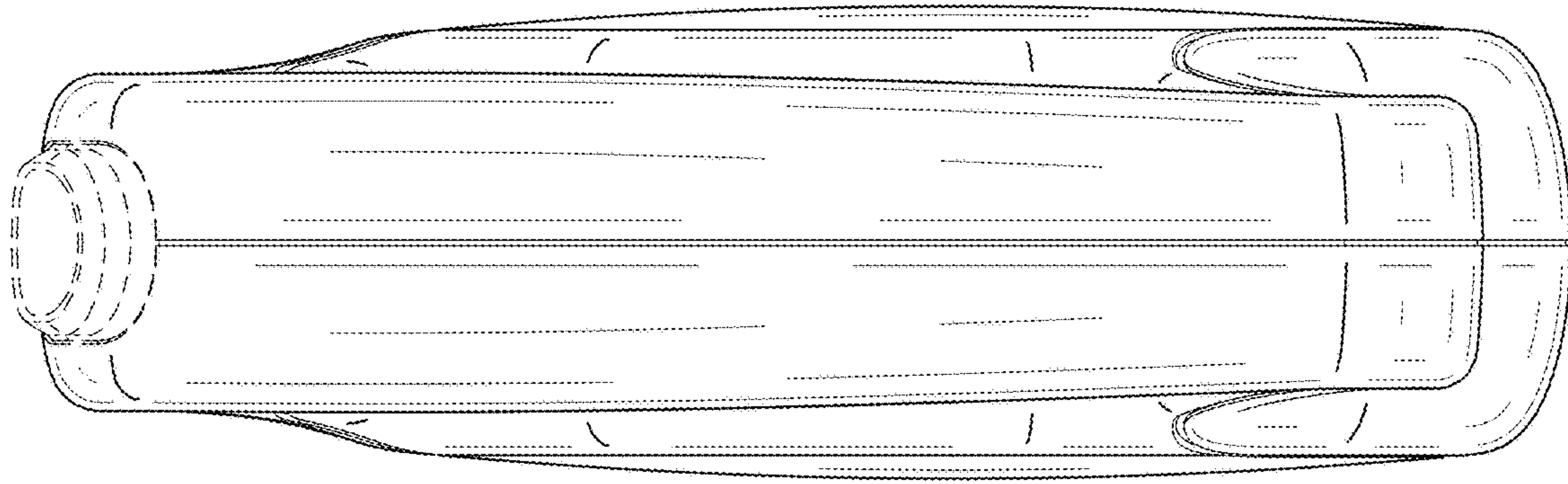

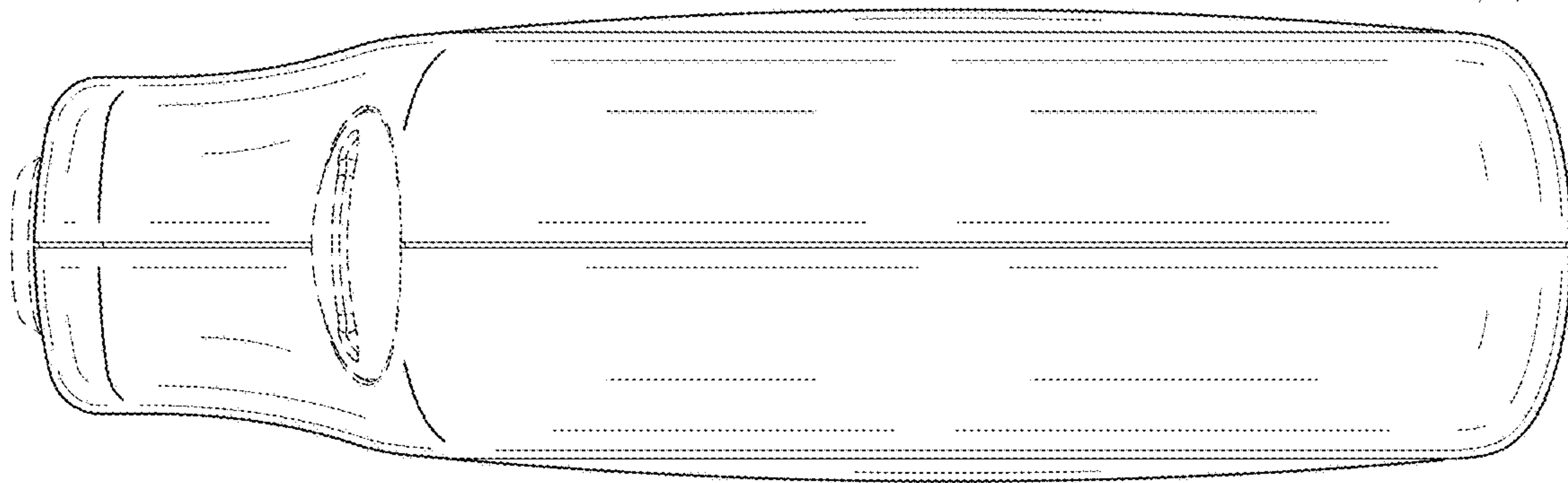

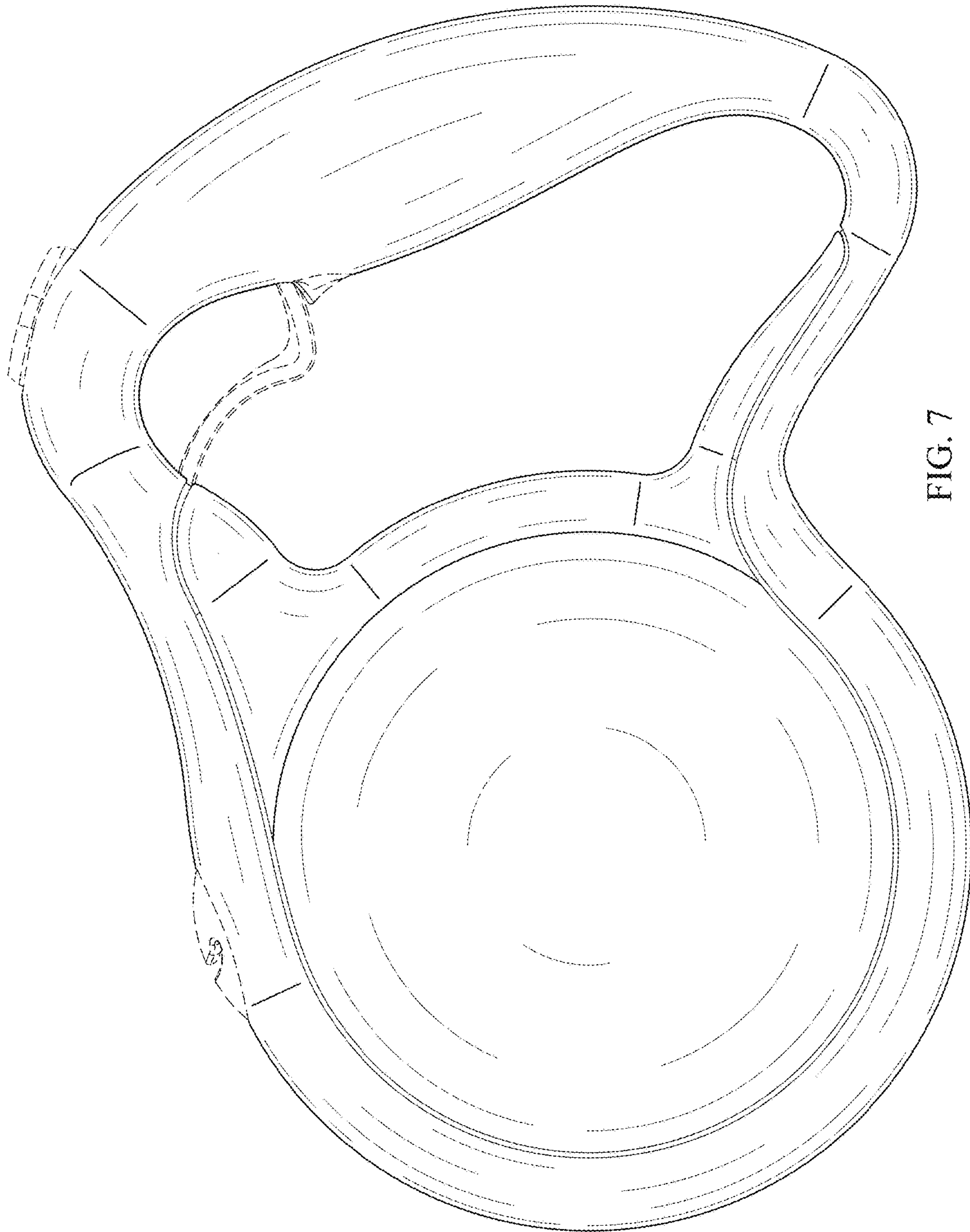

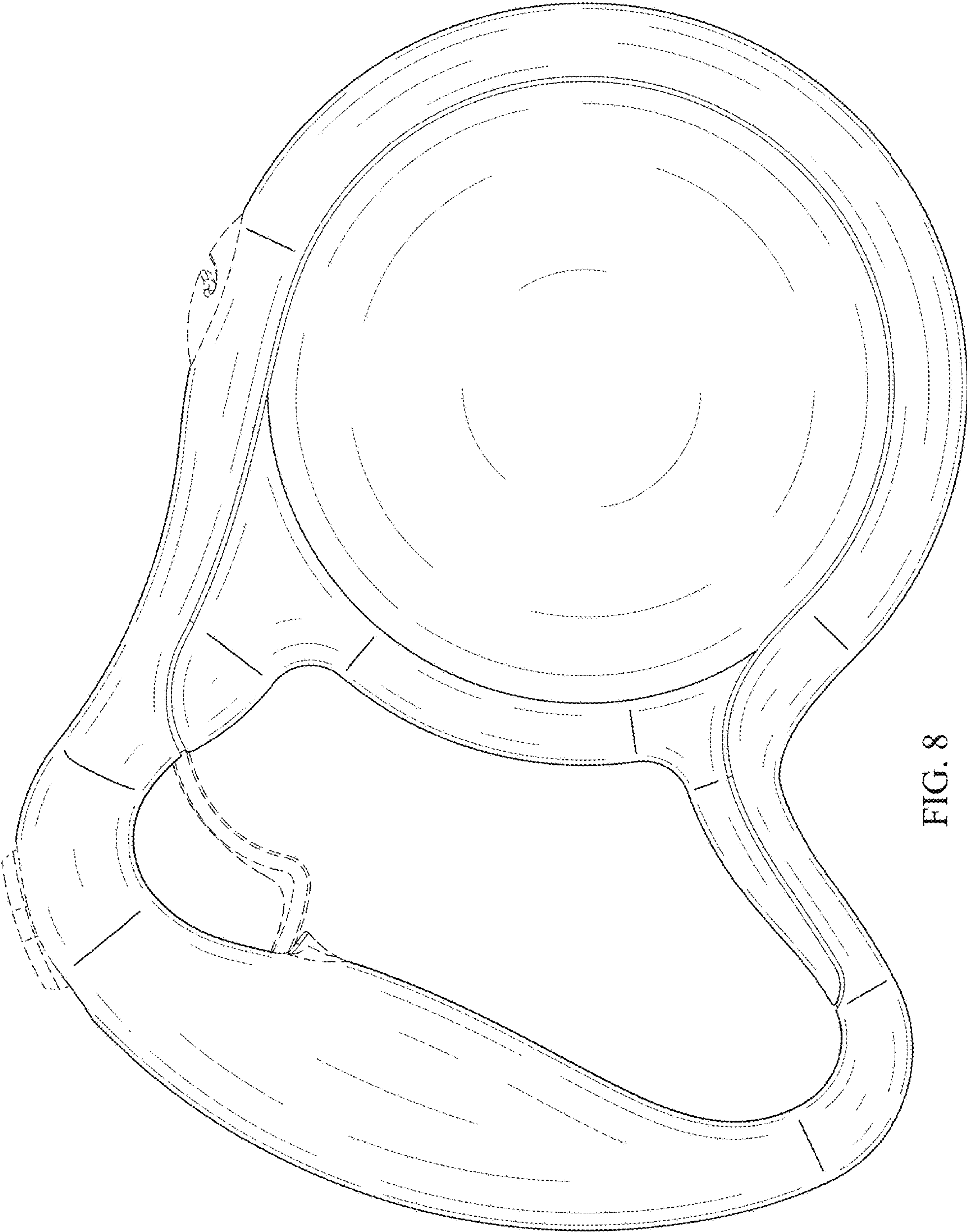
