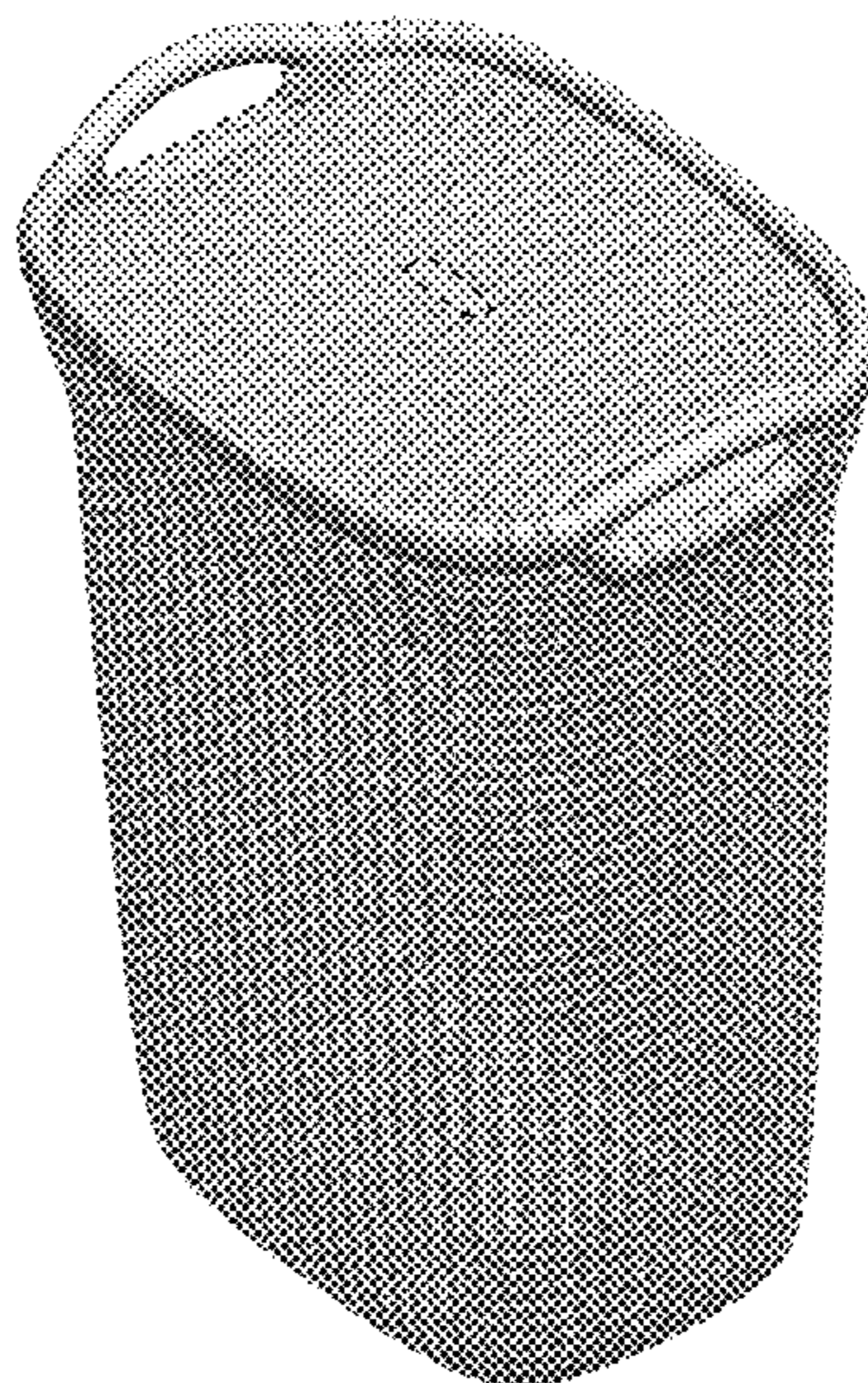
(57) **CLAIM**

The ornamental design for hamper with lid, as shown and described.

DESCRIPTION

FIG. 1 is a top perspective view of a hamper with lid at a closed position, showing a new design;
FIG. 2 is a top perspective view of the hamper with lid shown in FIG. 1, at an opened position;
FIG. 3 is a front view of the hamper with lid shown in FIG. 1, at a closed position;
FIG. 4 is a rear view of the hamper with lid shown in FIG. 1, at a closed position;
FIG. 5 is a right side view of the hamper with lid shown in FIG. 1, at a closed position; left side view being a mirror image;
FIG. 6 is a top view of the hamper with lid shown in FIG. 1, at a closed position; and,
FIG. 7 is a bottom view of the hamper with lid shown in FIG. 1, at a closed position.
The broken lines illustrate portions of the hamper with lid that form no part of the claimed design.

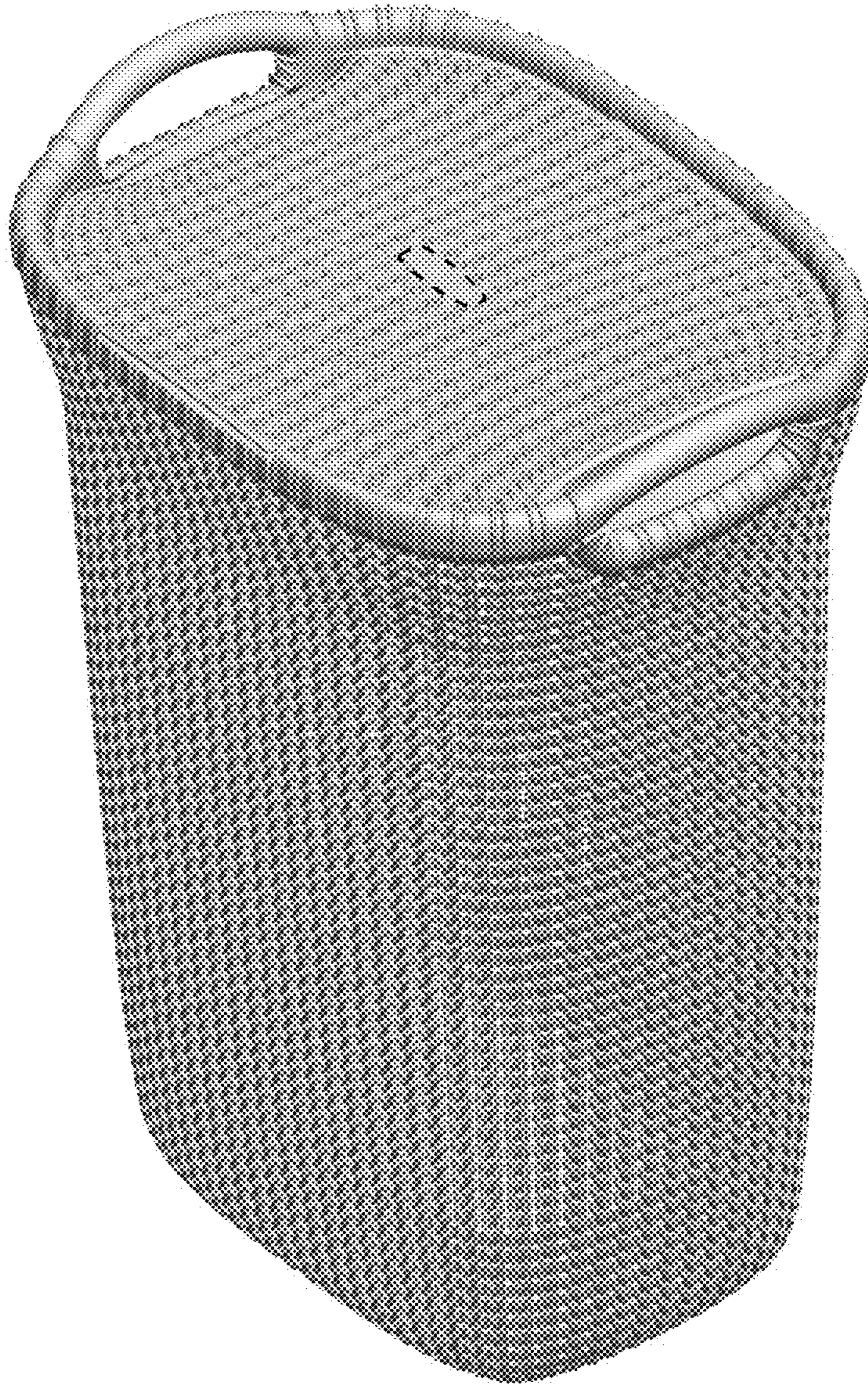

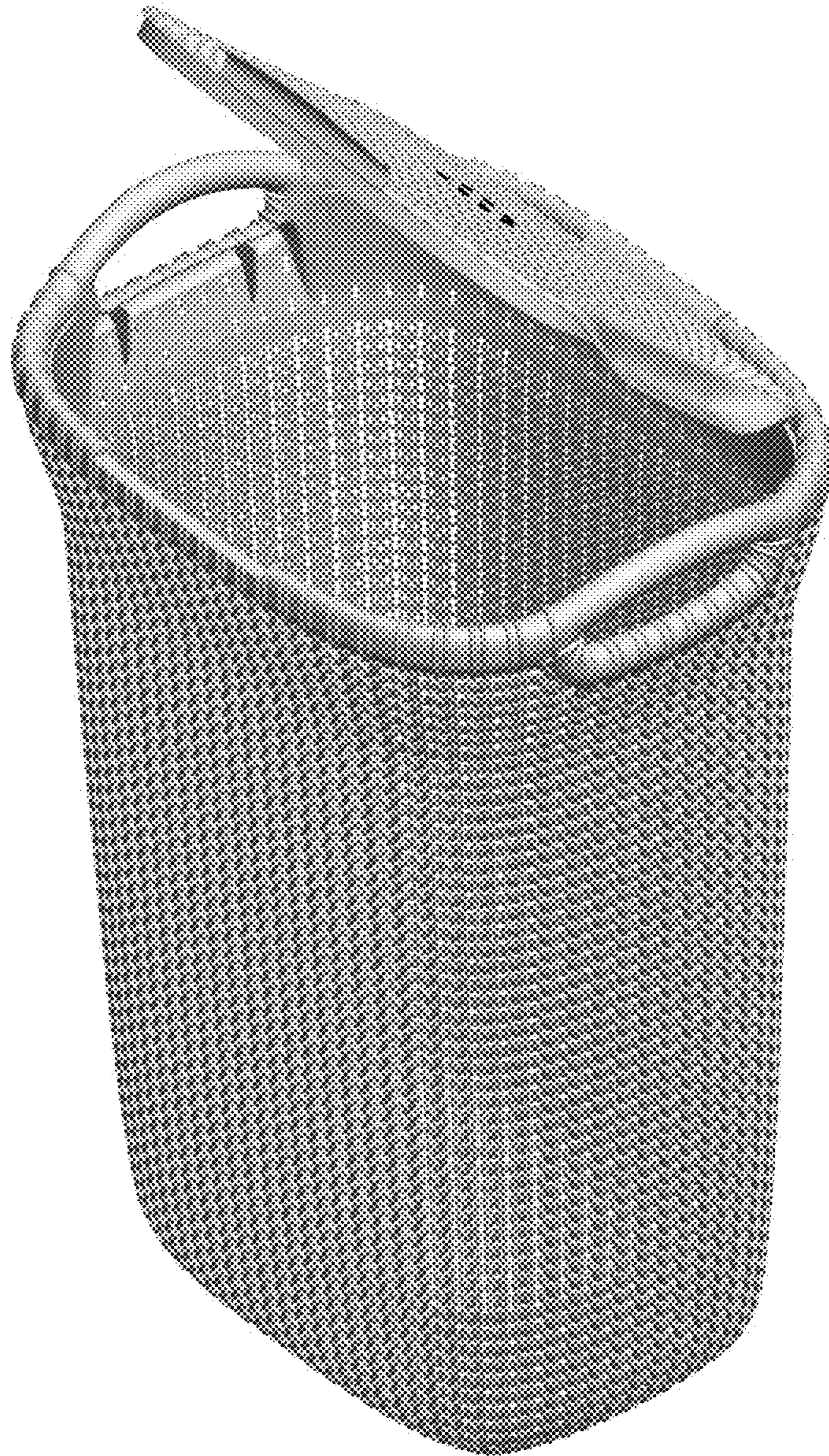

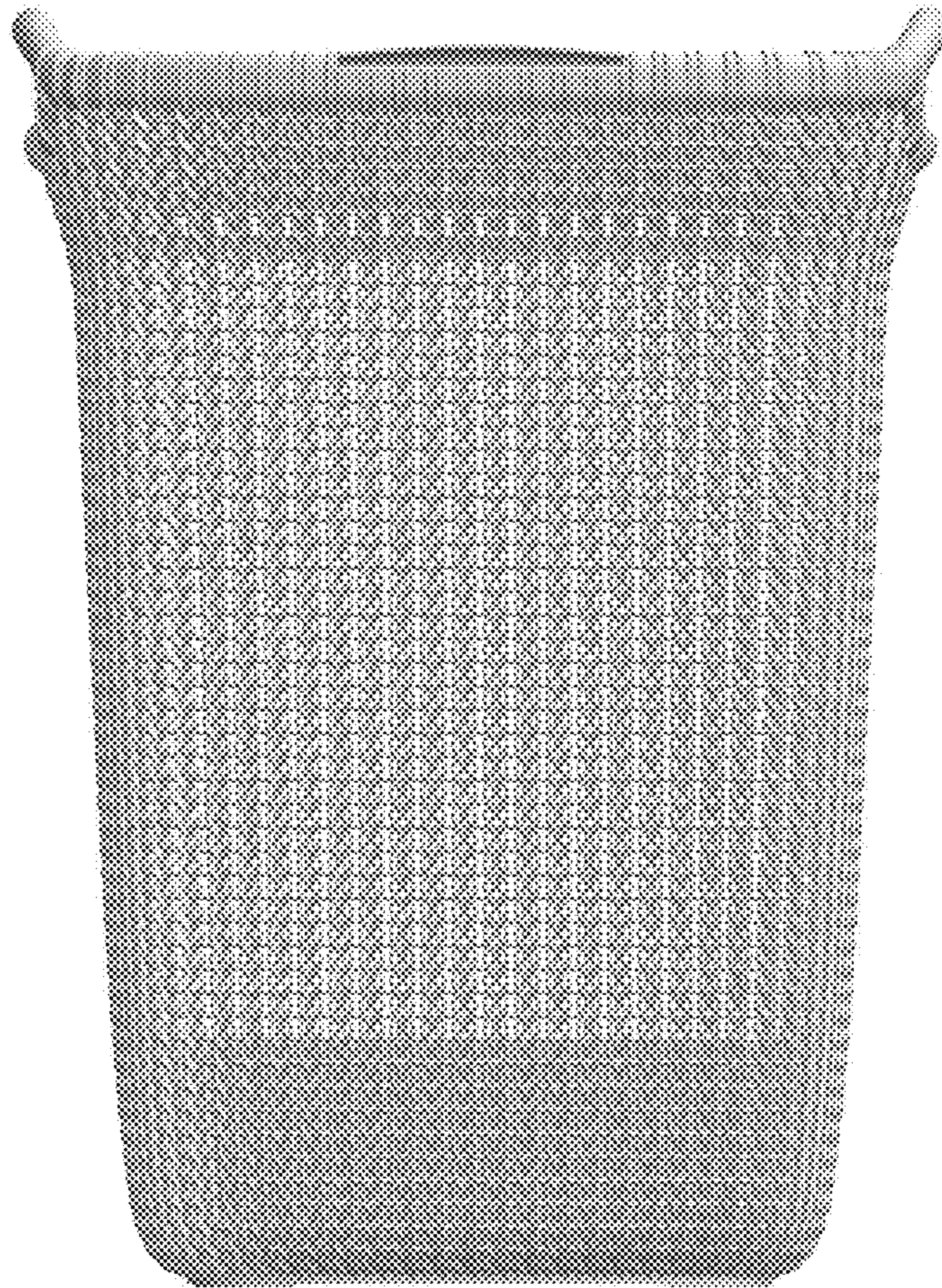

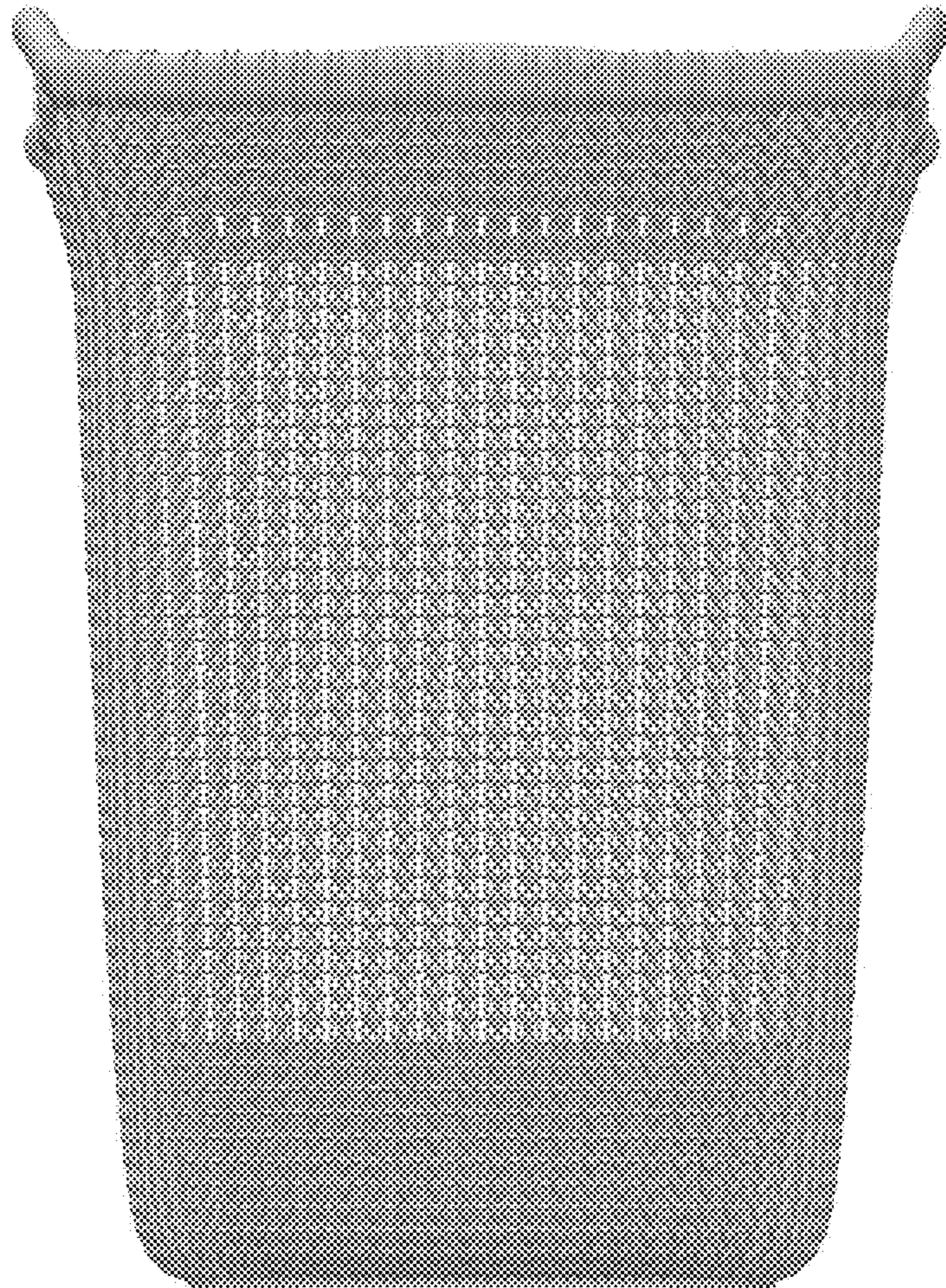

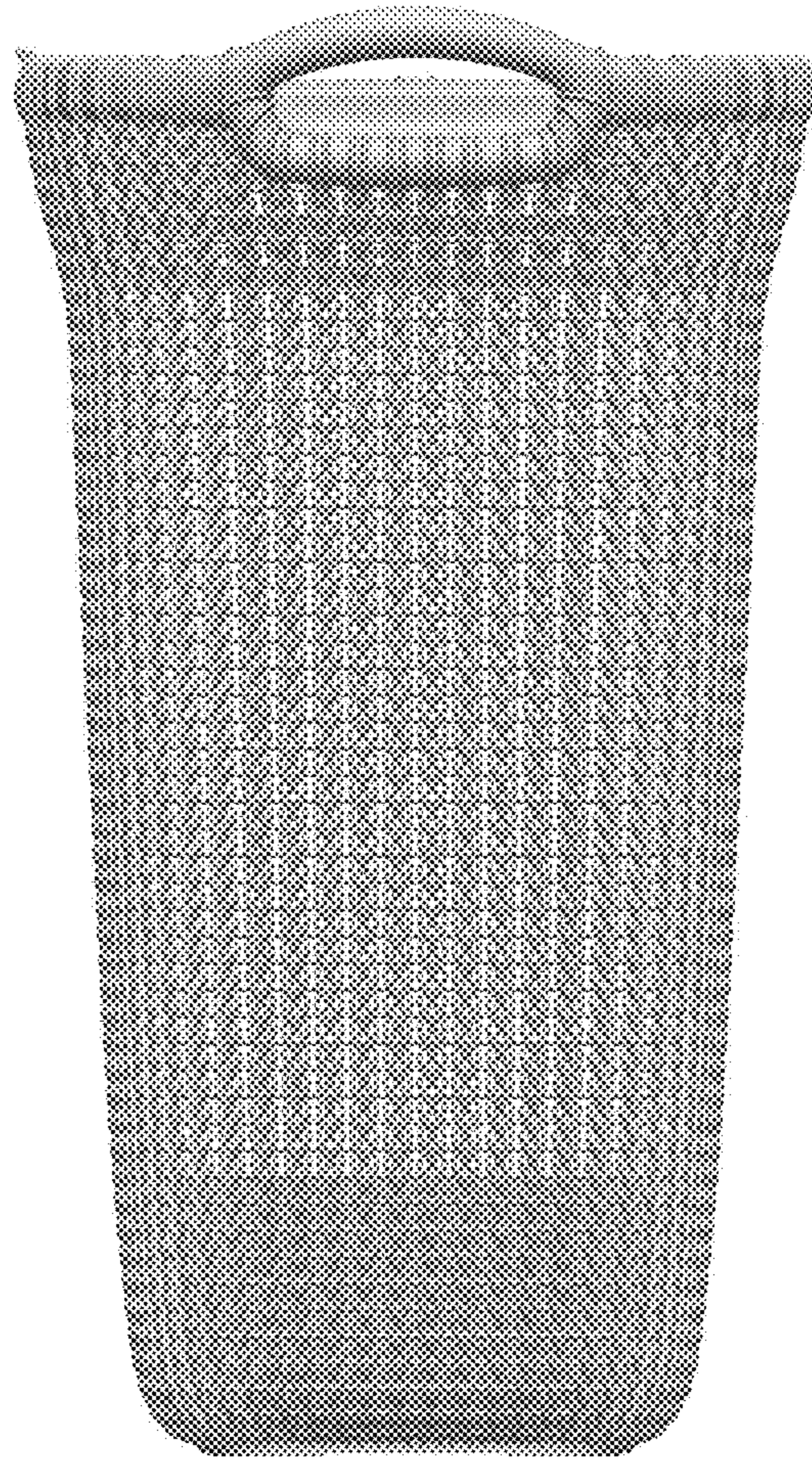

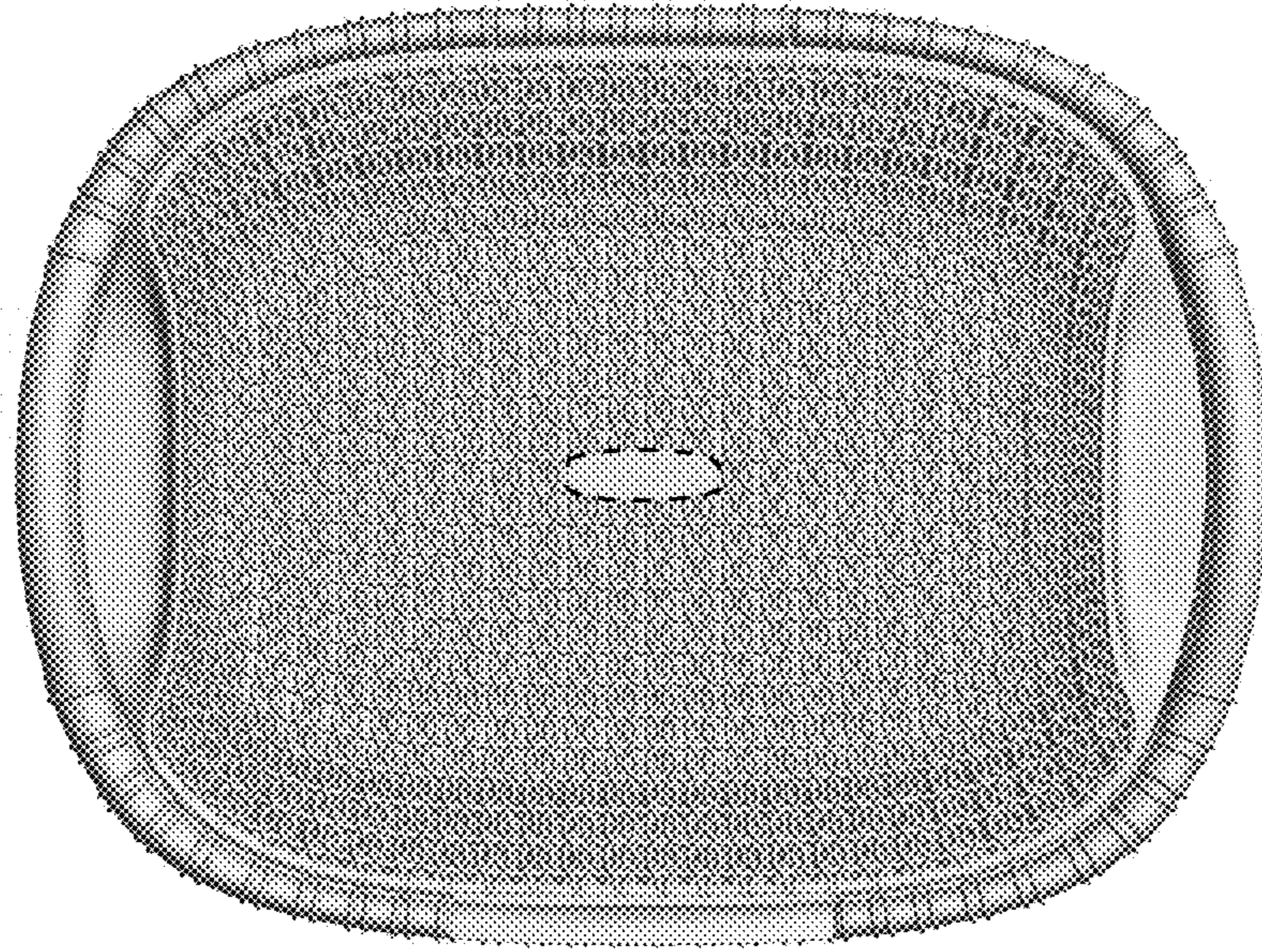

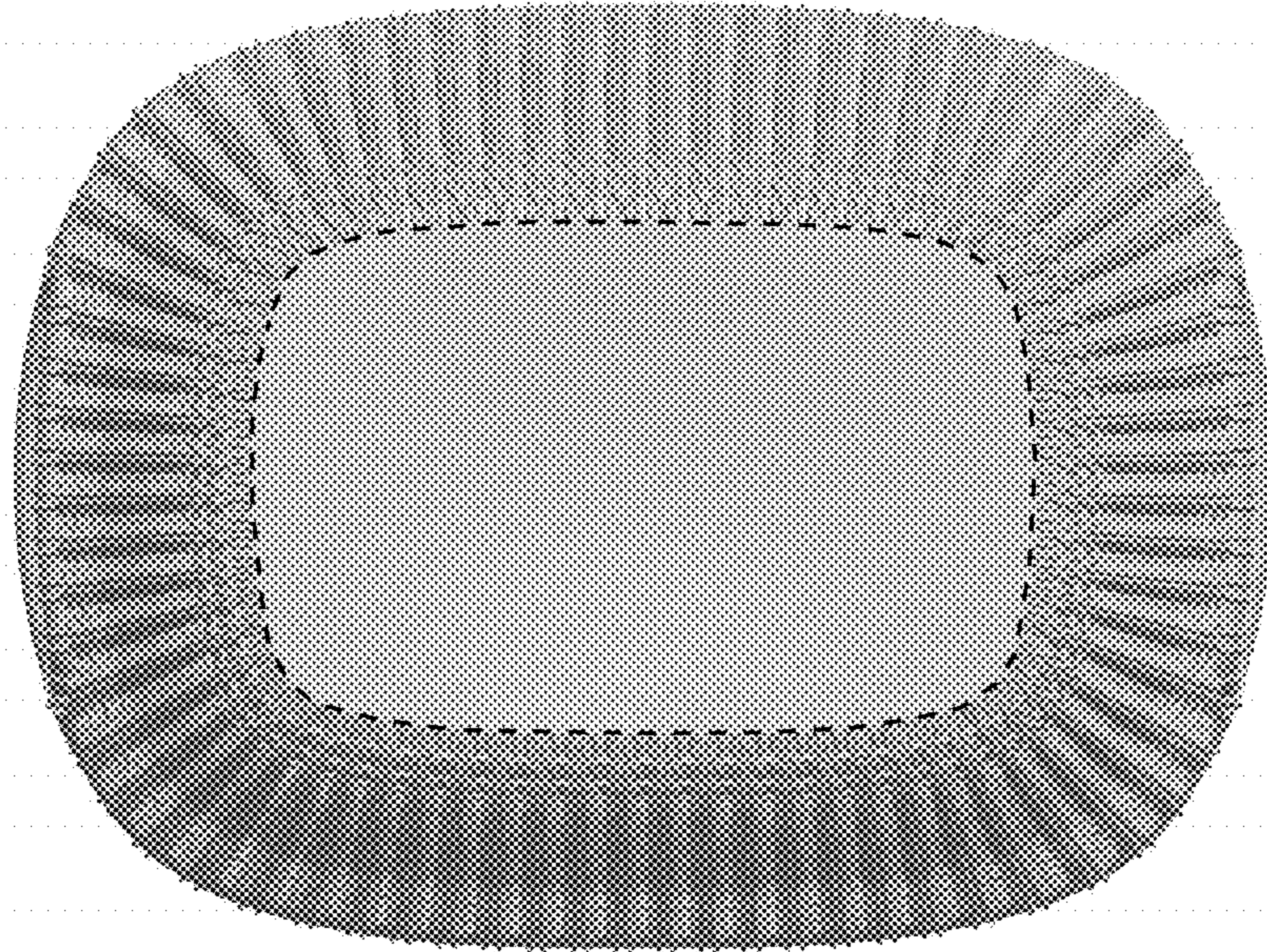
