DESCRIPTION

FIG. 1 is a perspective view of our new design for a gel cushion insole;

FIG. 7 is a bottom plan view thereof.

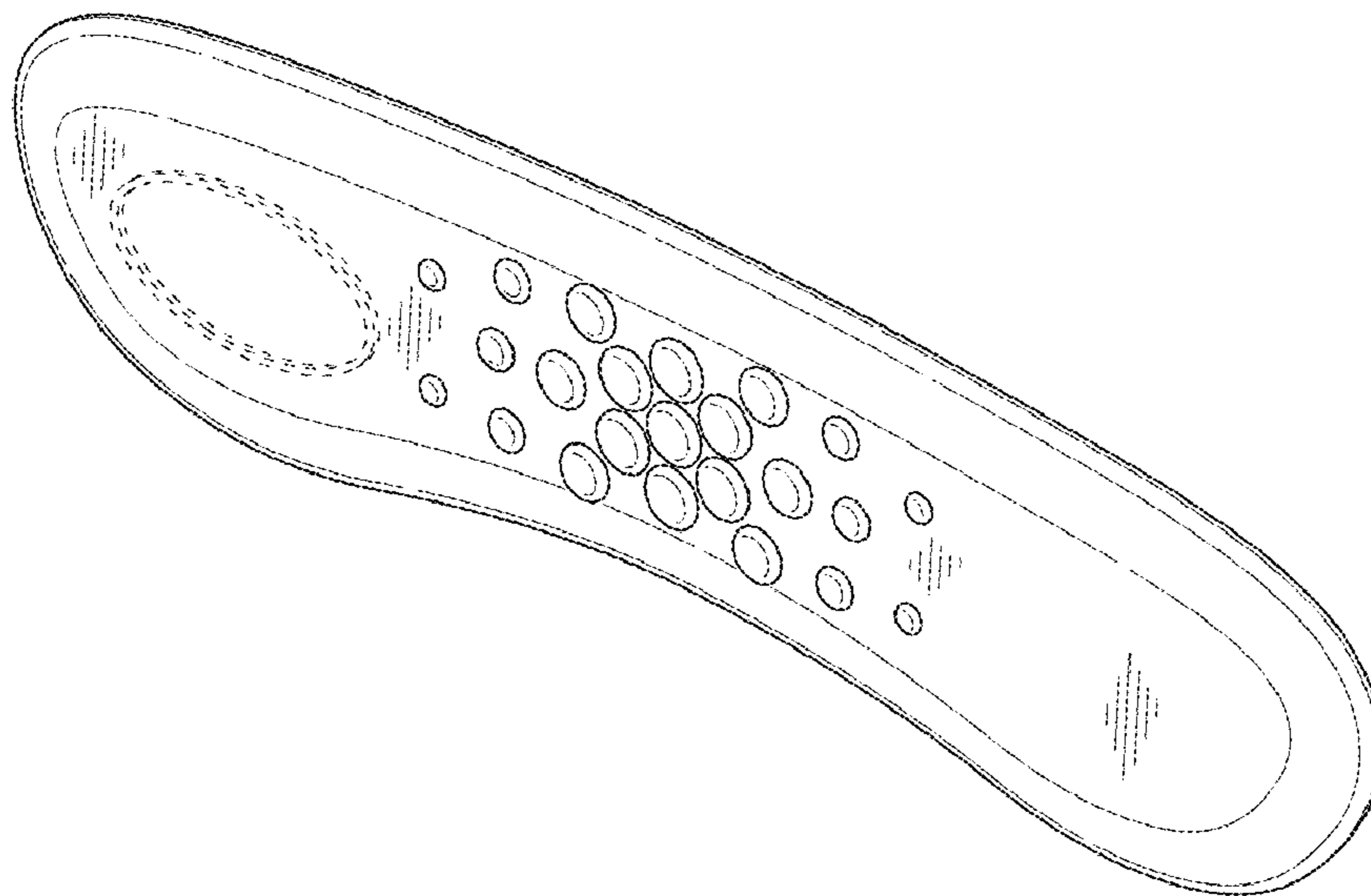
The broken lines are included for the purpose of illustrating a portion of the gel cushion insole that forms no part of the claimed design.

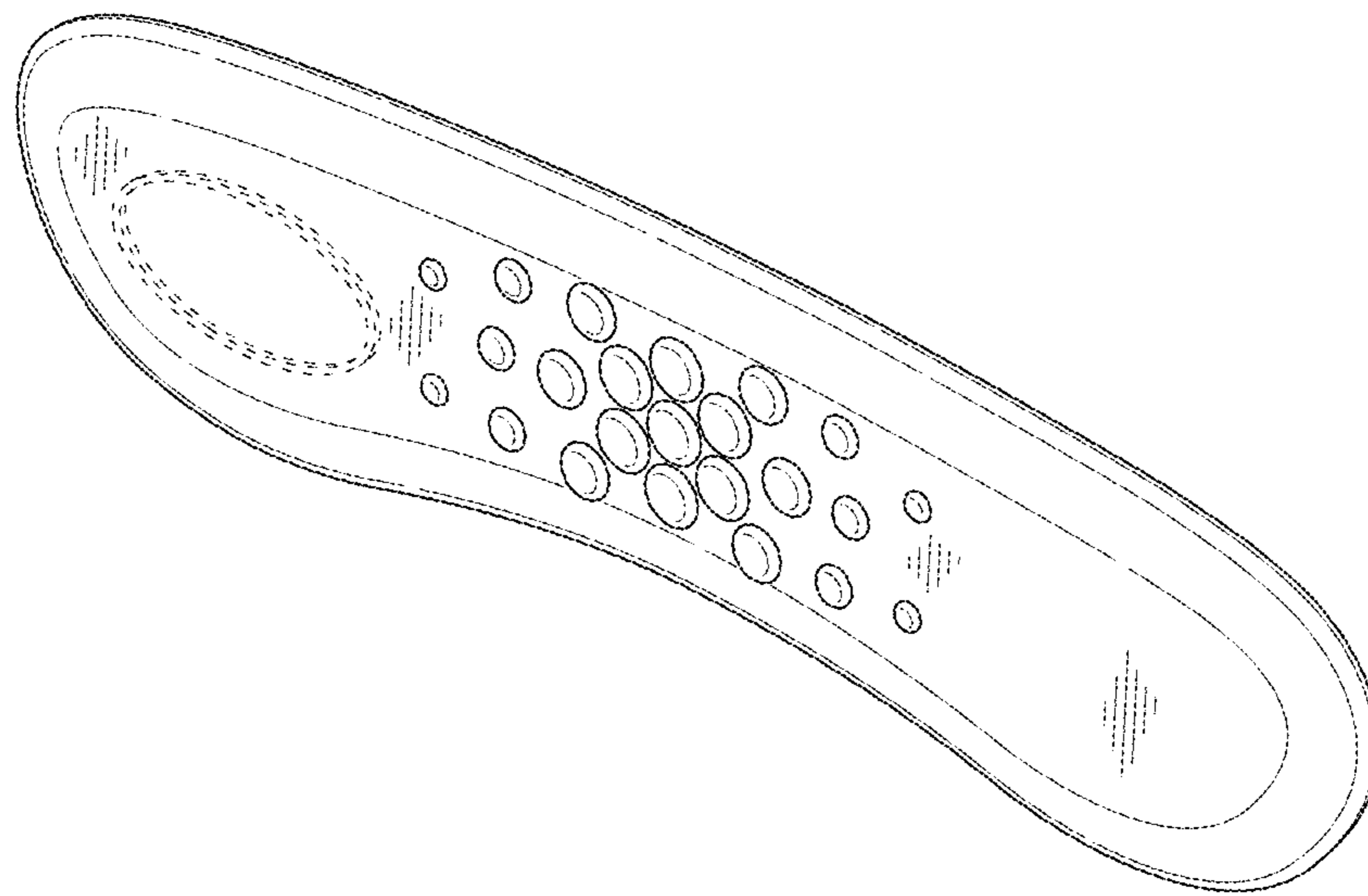

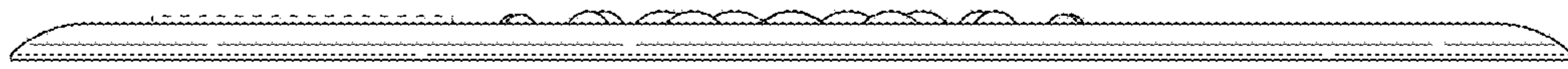

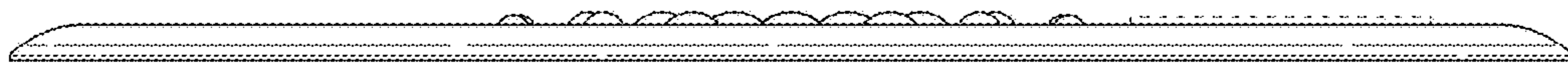

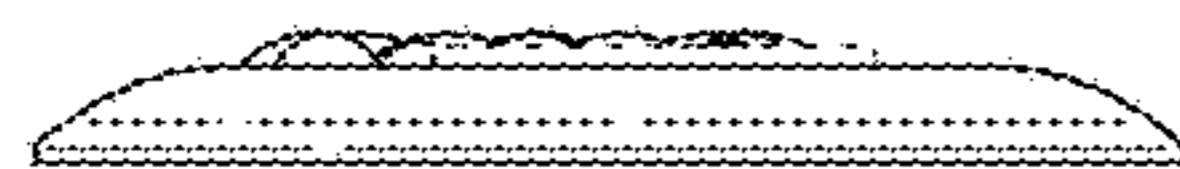

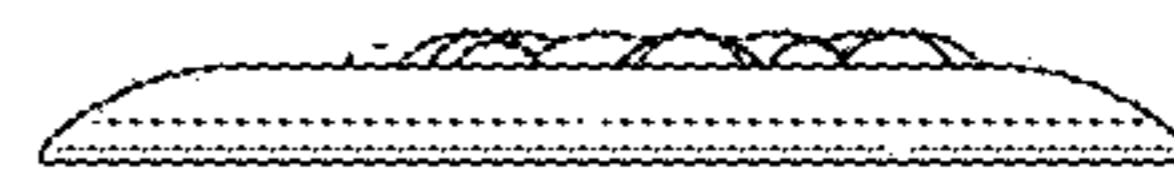

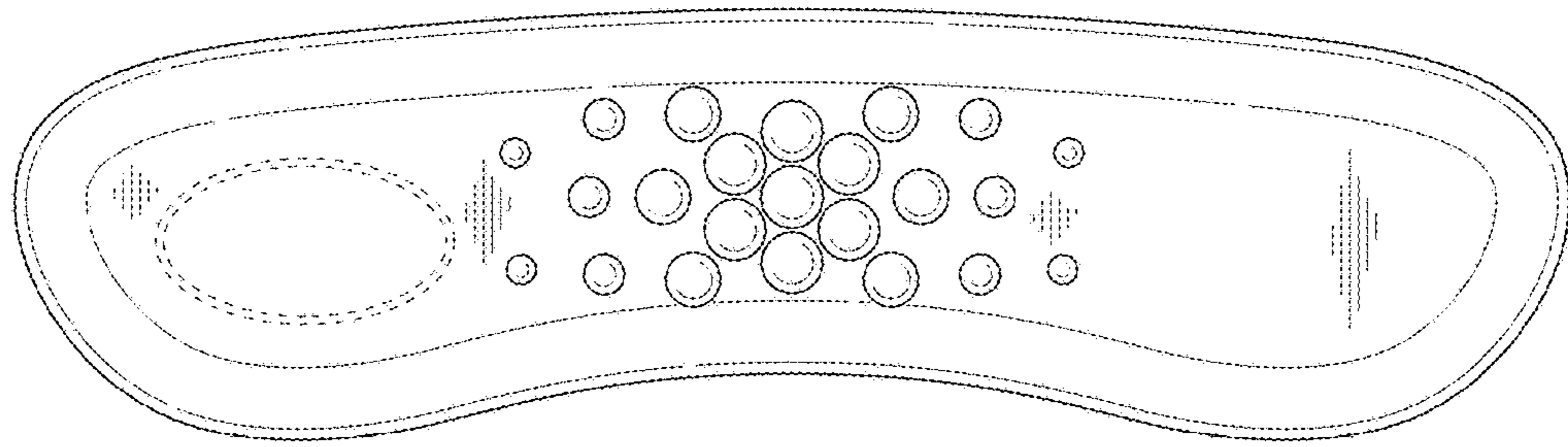

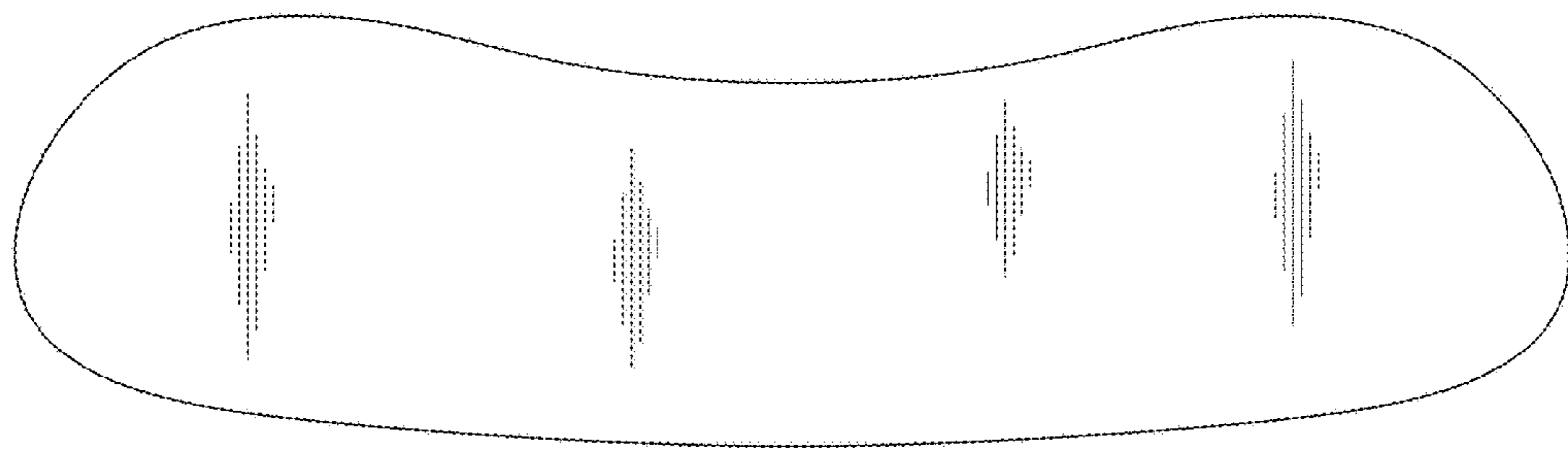
