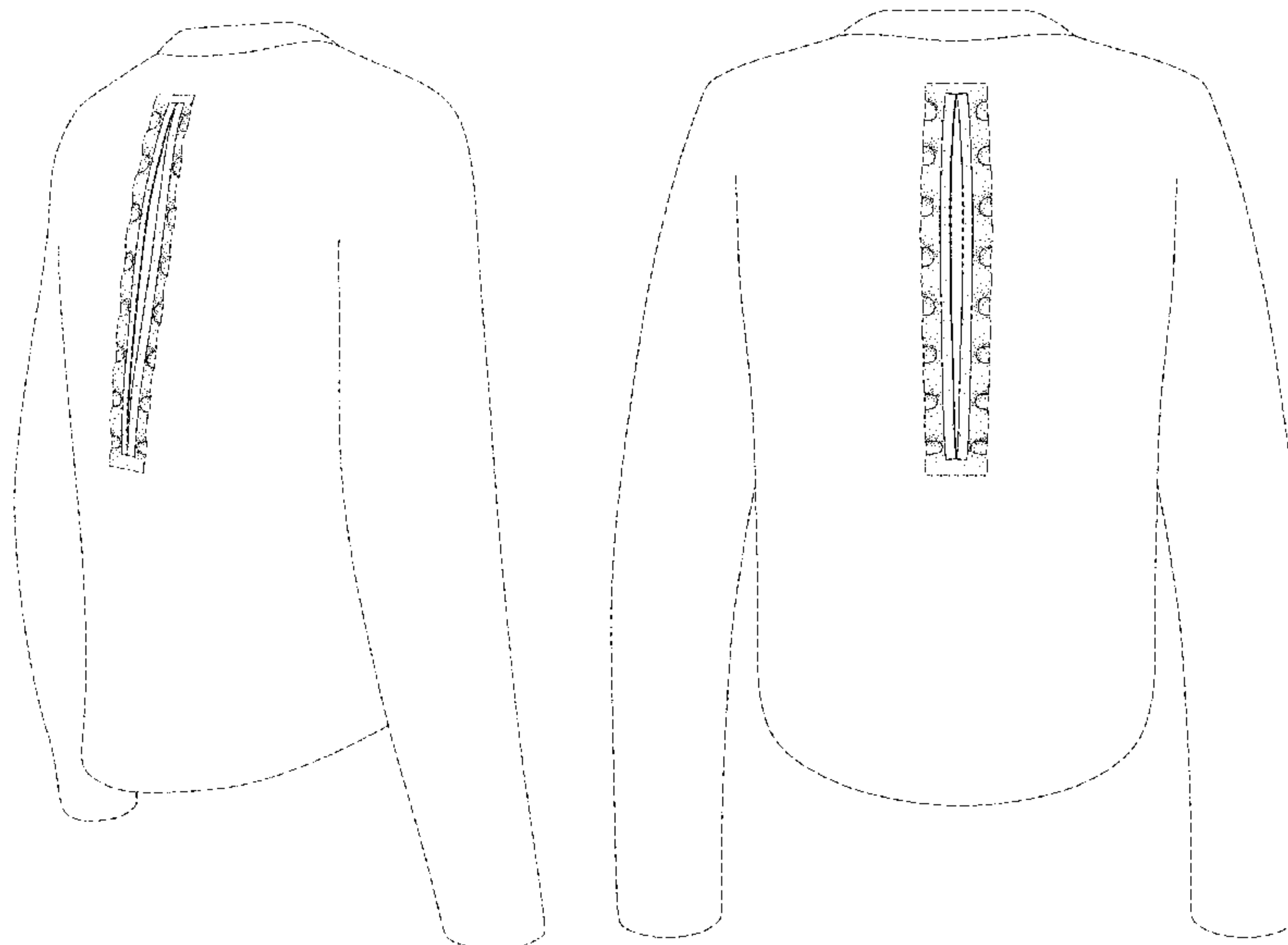

DESCRIPTION

FIG. 1 is a rear perspective view of a garment showing our design;
FIG. 2 is a rear view thereof;
FIG. 3 is a first side view thereof;
FIG. 4 is a second side view thereof; and,
FIG. 5 is a front view thereof.

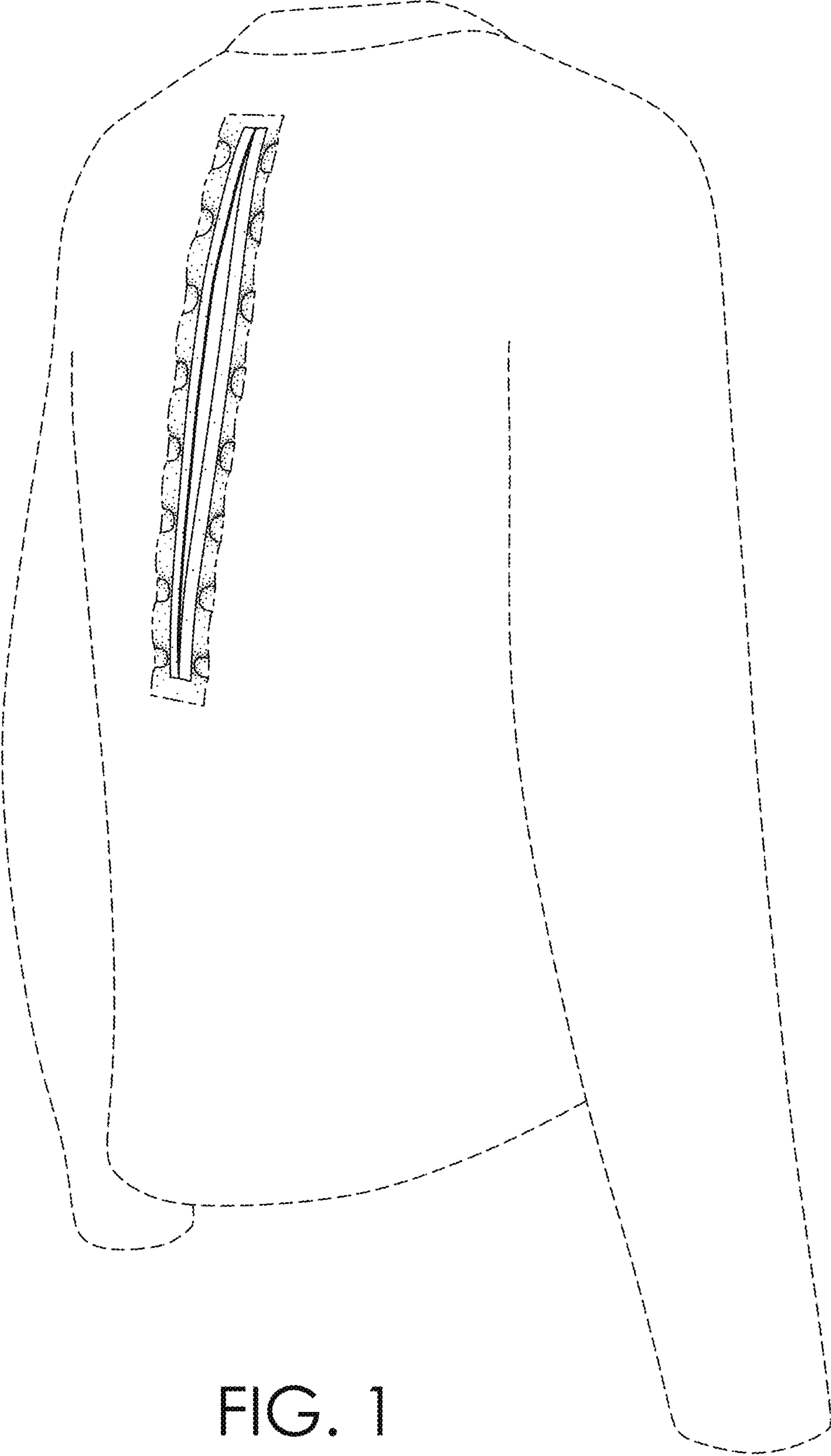

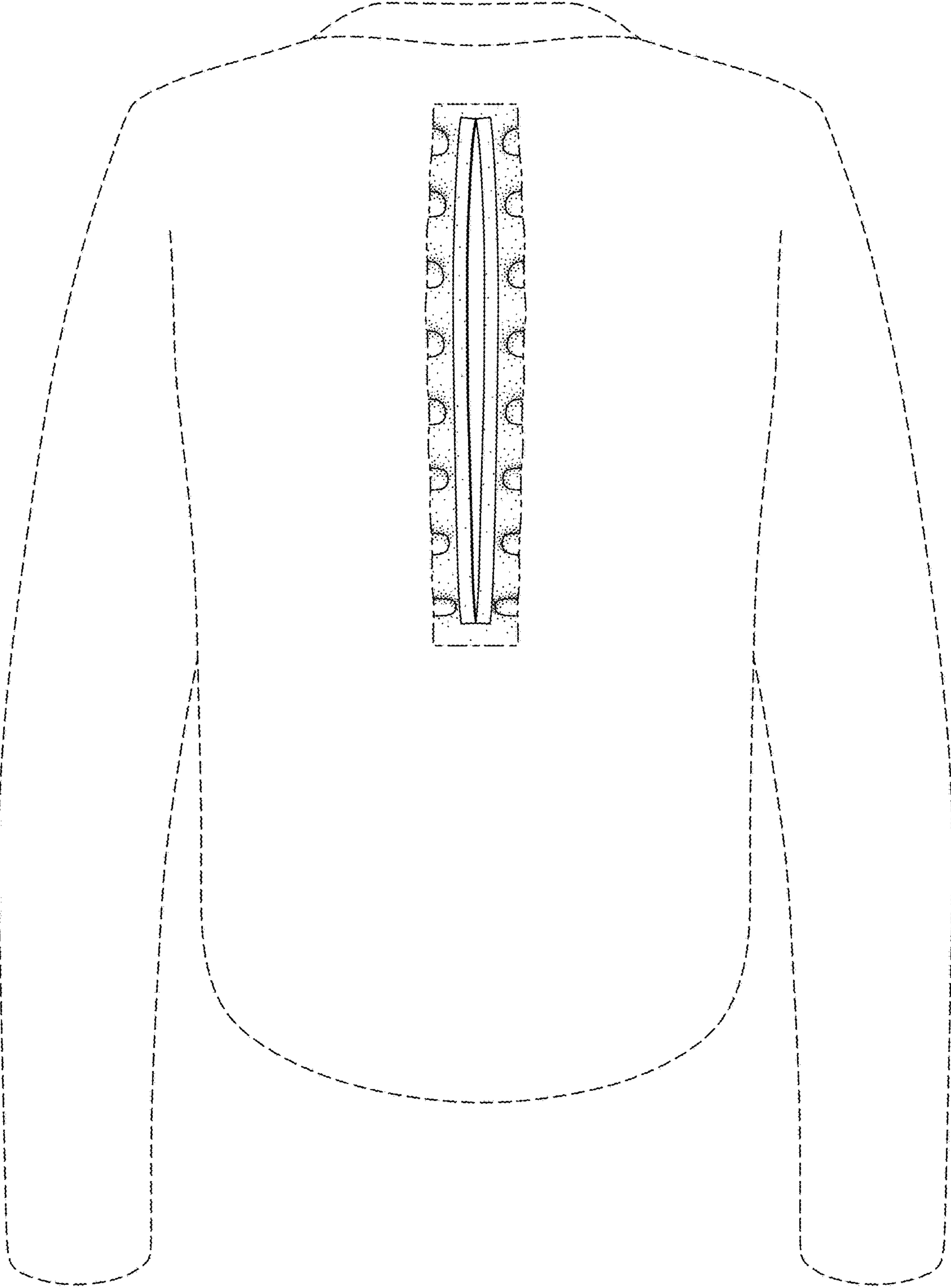

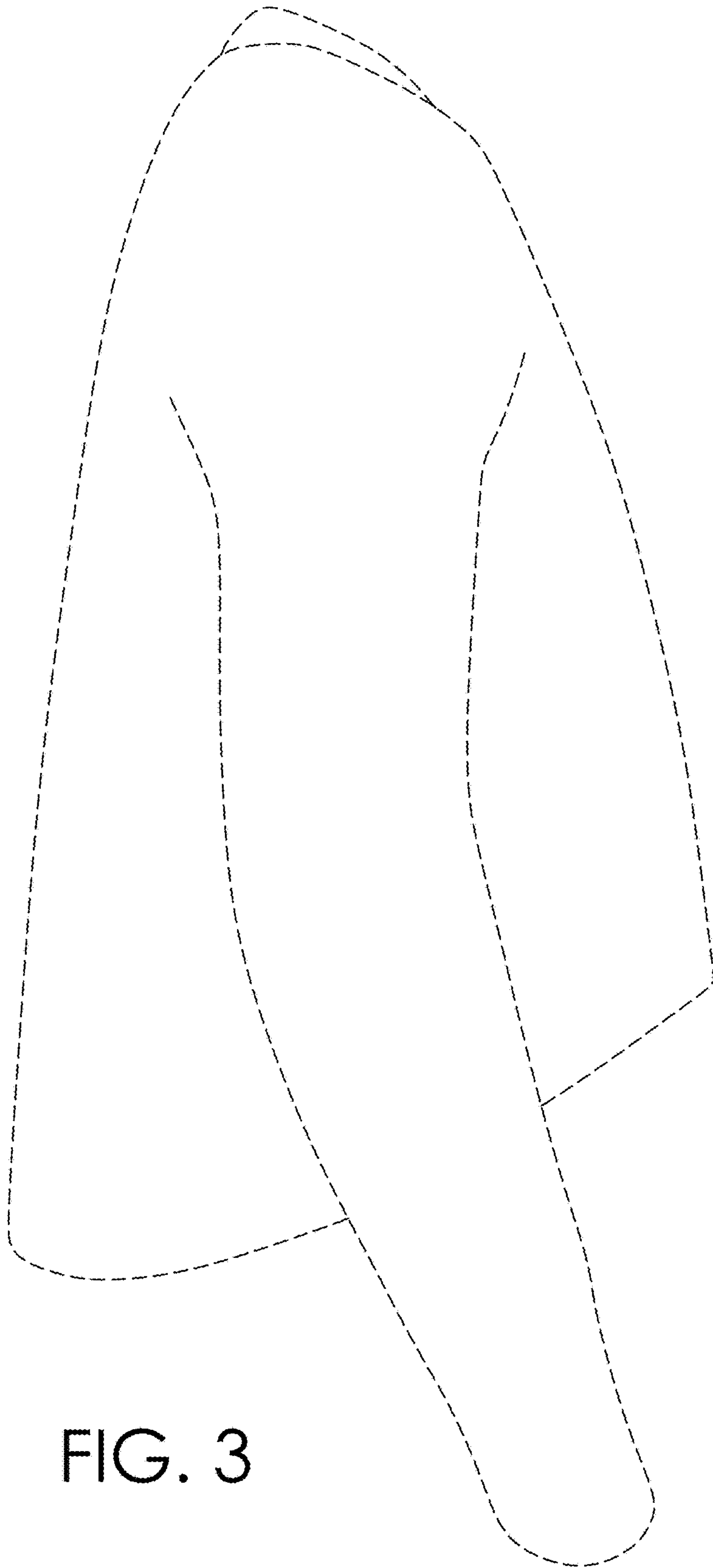

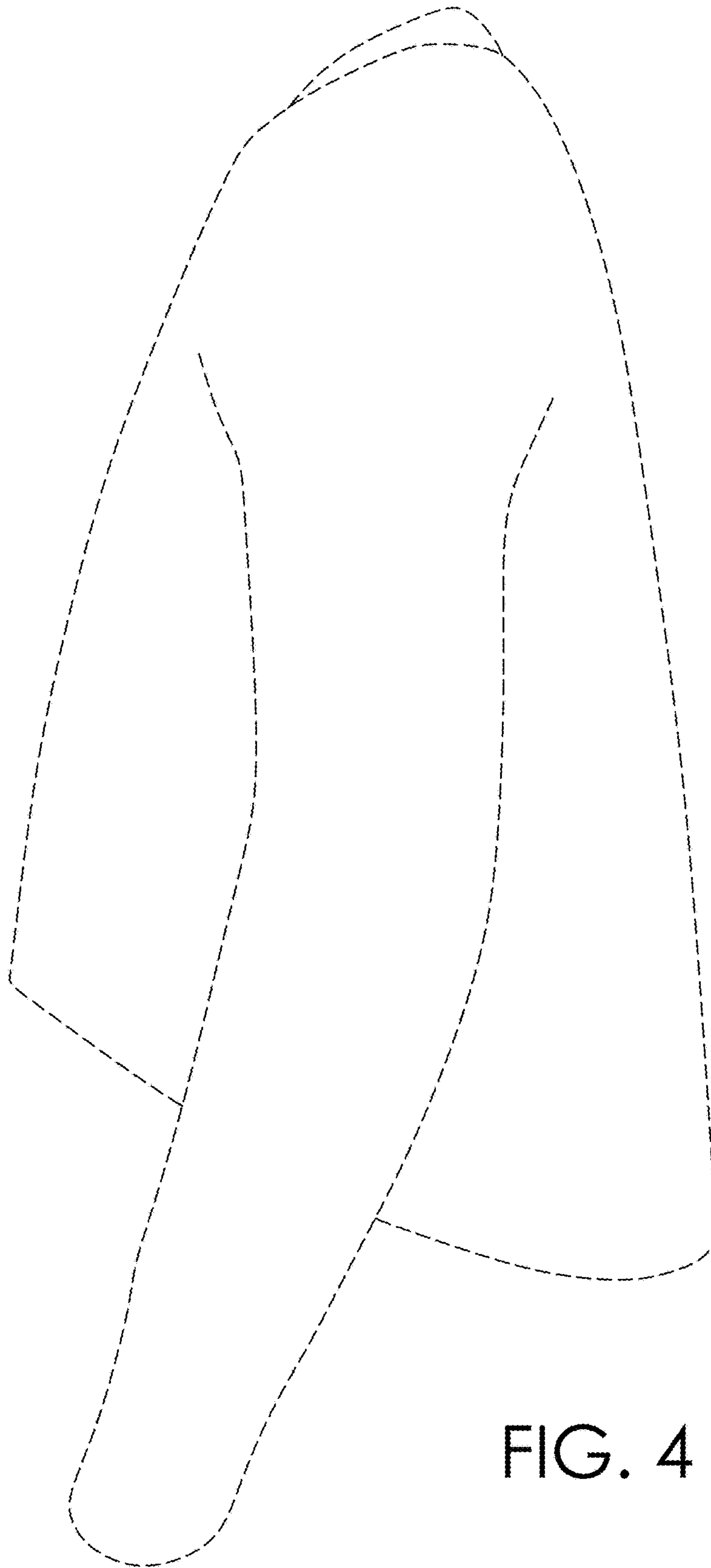

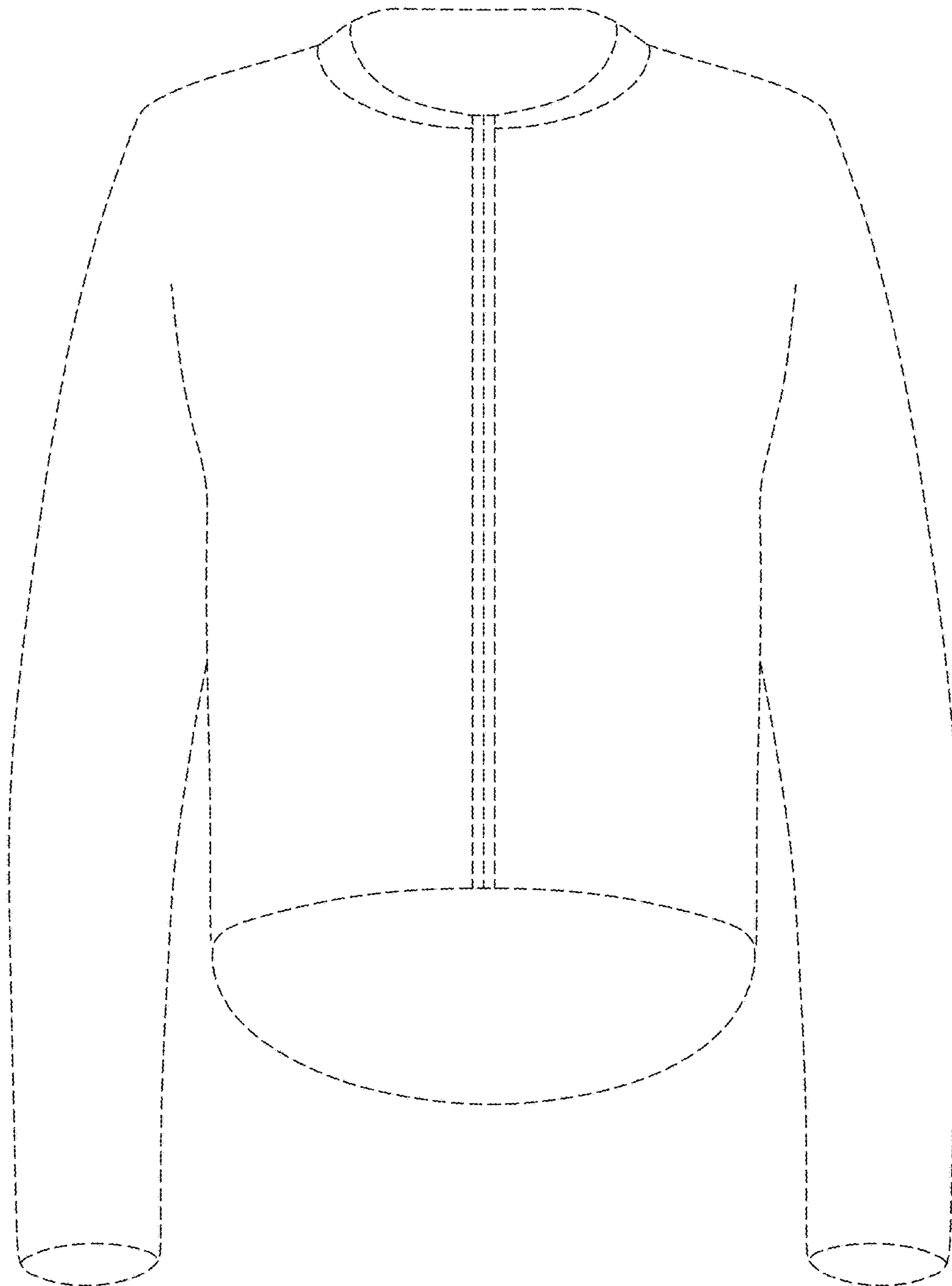
