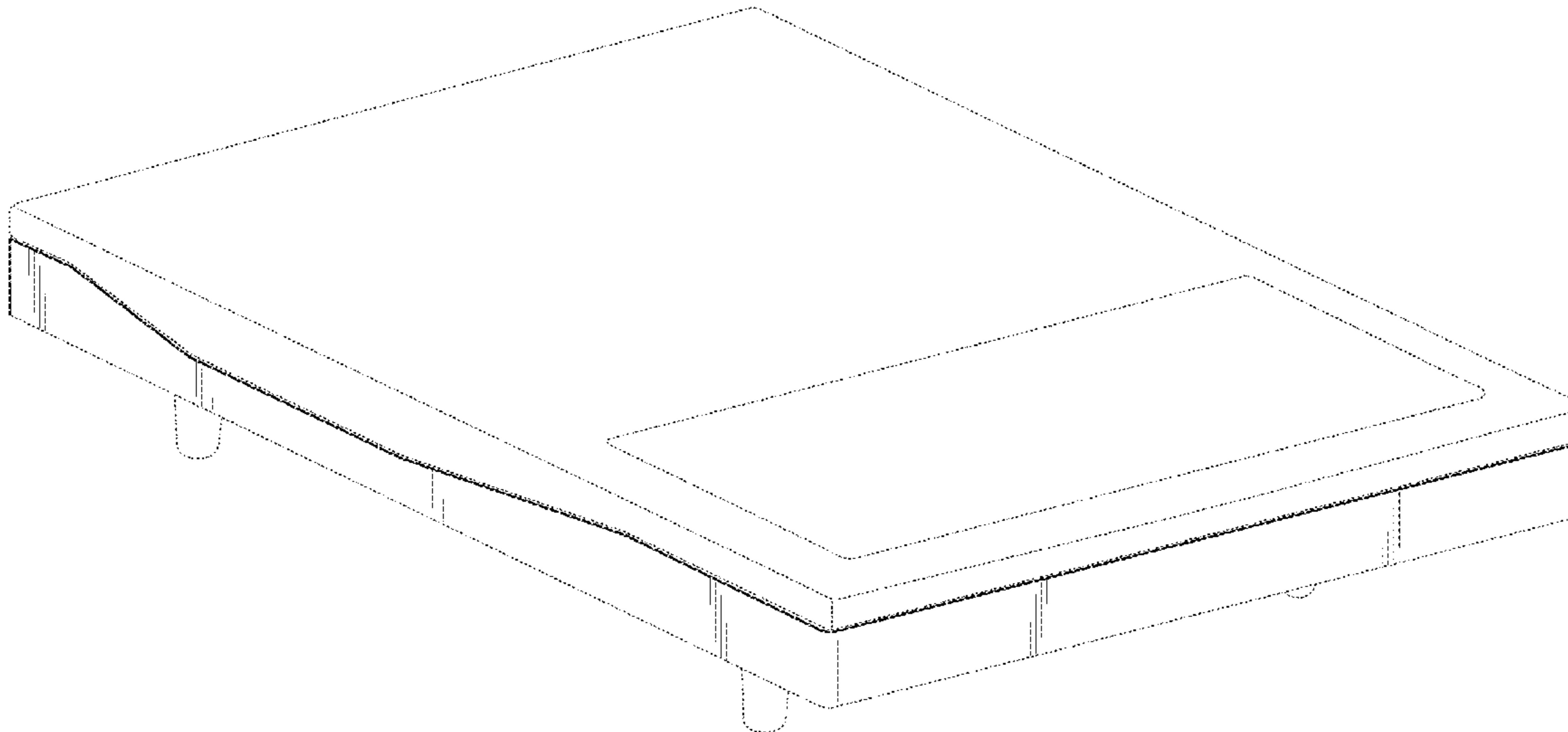
The ornamental design for an adjustable bed foundation, as shown and described.

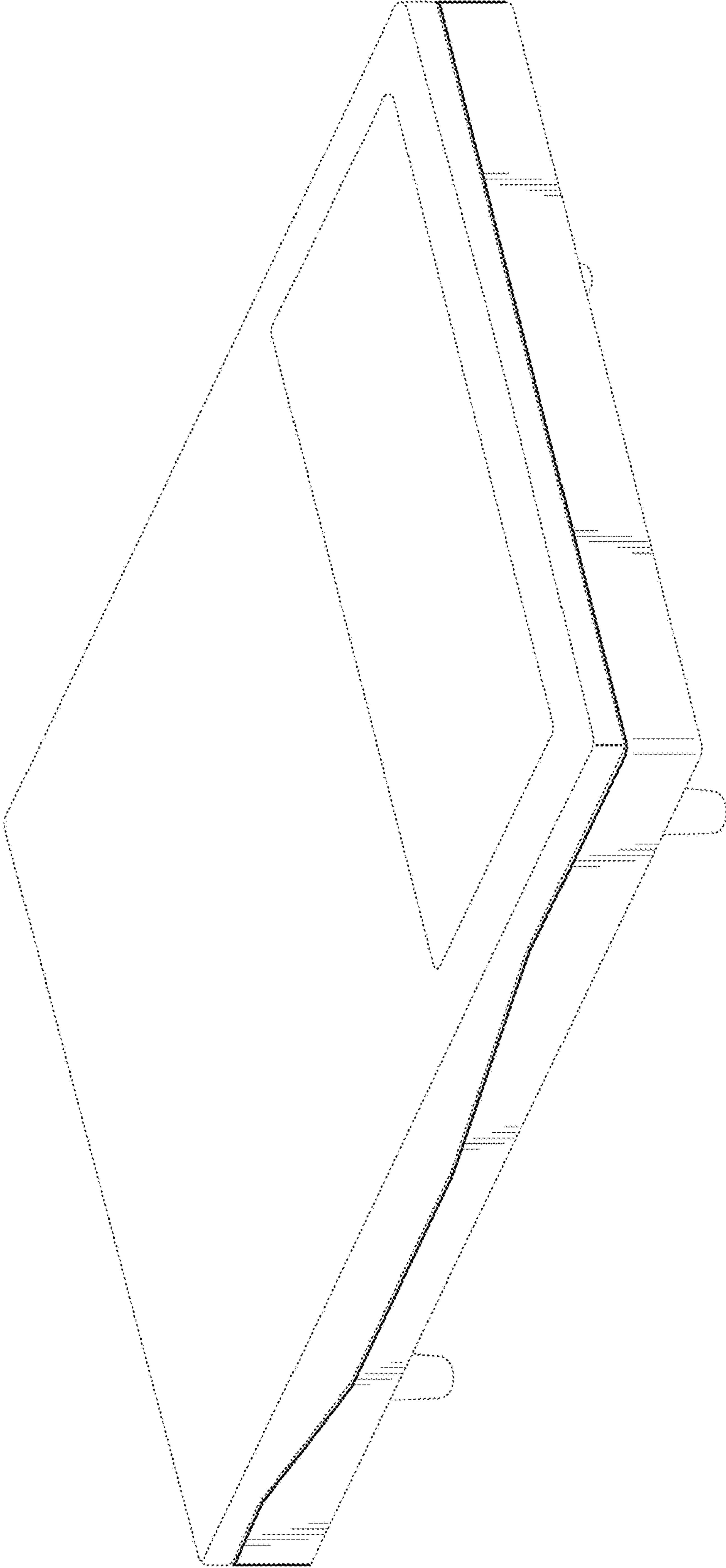

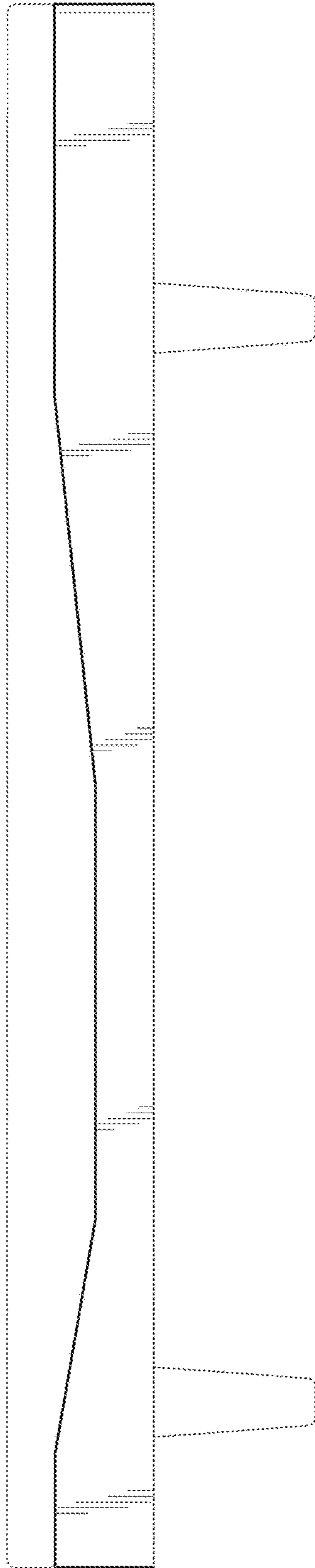
