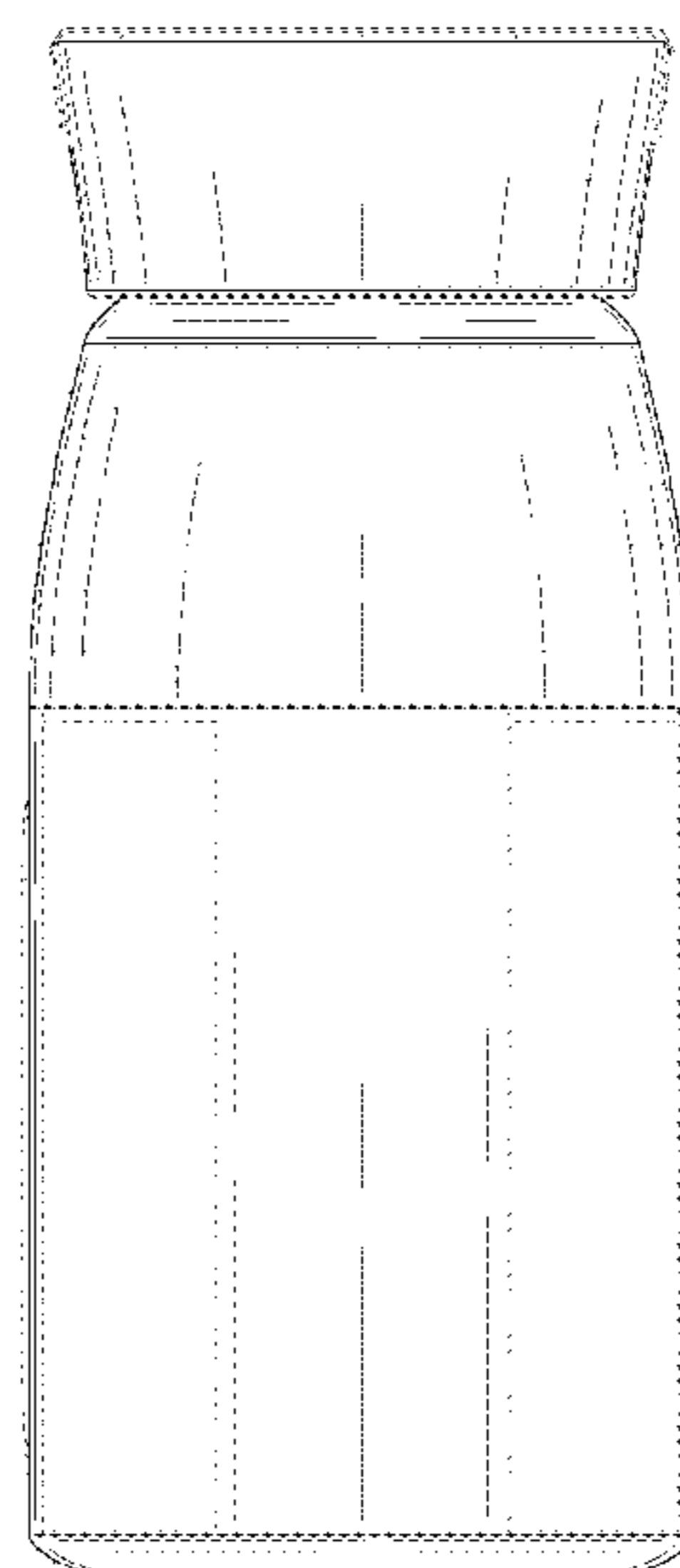
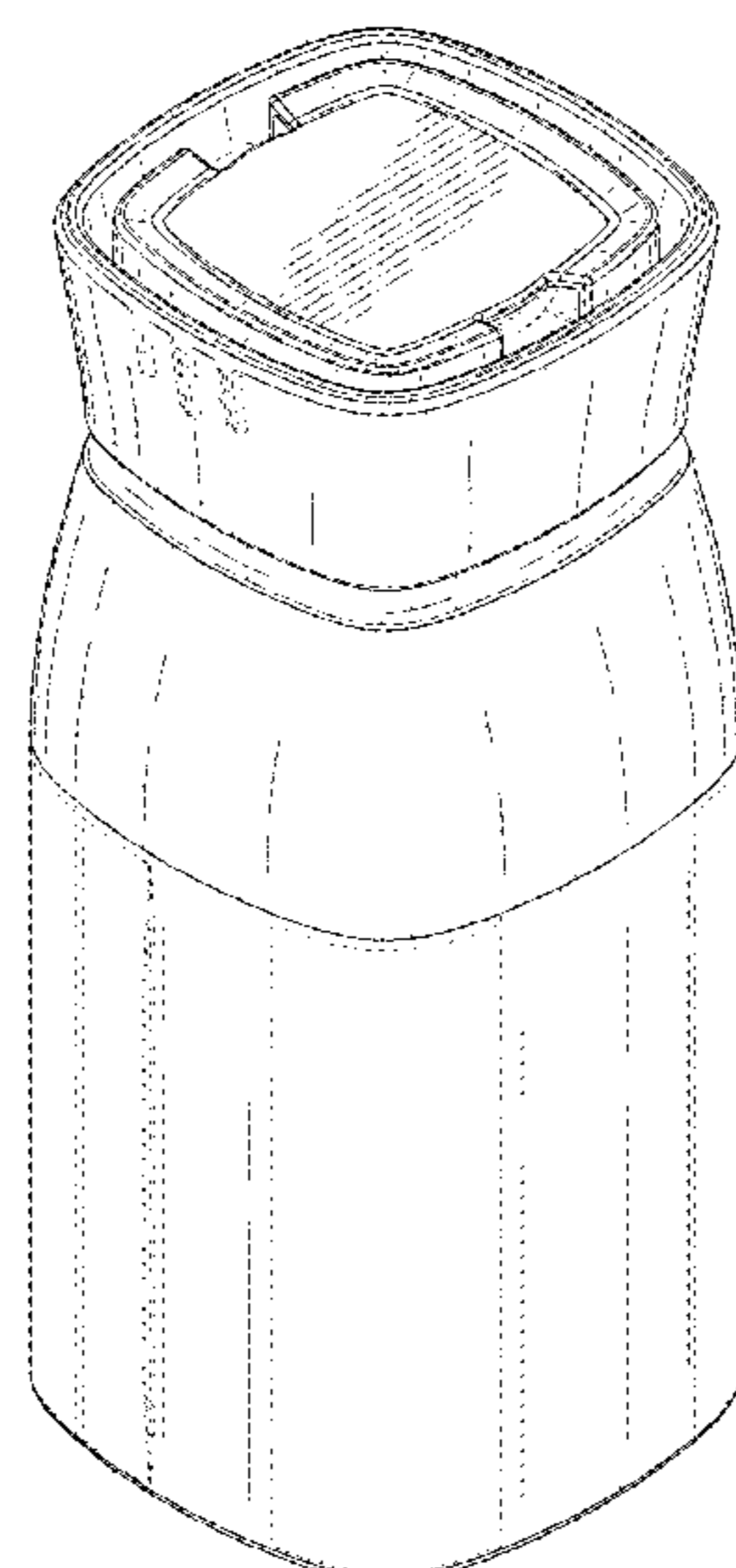
The ornamental design for a bottle with cap, as shown and described.

DESCRIPTION

FIG. 1 is a top, front and left perspective view of a bottle with cap showing the new design; FIG. 2 is a bottom, rear, and right perspective view thereof; FIG. 3 is a top plan view thereof; FIG. 4 is a bottom plan view thereof; FIG. 5 is a left side elevation view thereof; FIG. 6 is a right side elevation view thereof; FIG. 7 is a front elevation view thereof; and, FIG. 8 is a rear elevation view thereof.

The broken lines in the drawings showing the bottle with cap illustrate the portions of the bottle with cap that form no part of the claimed design.

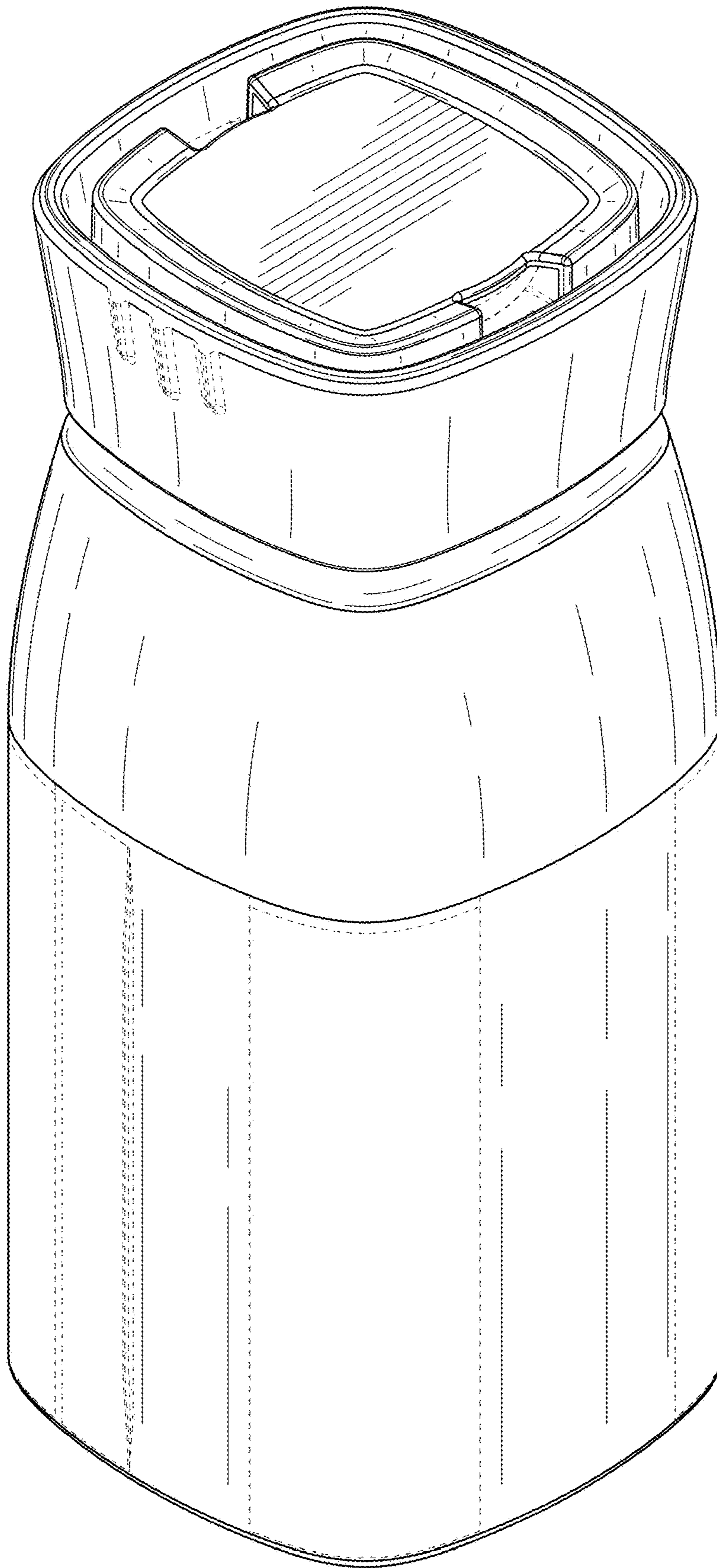

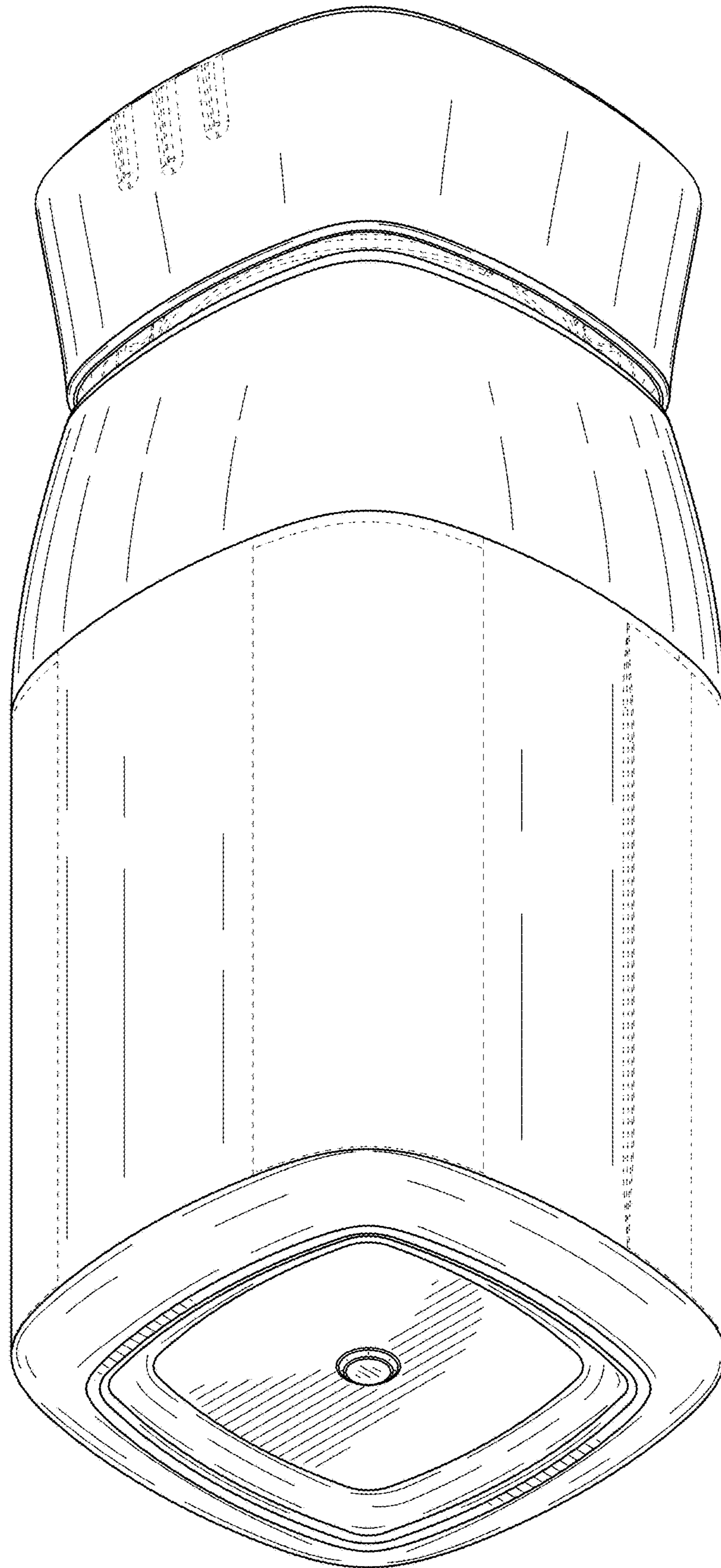

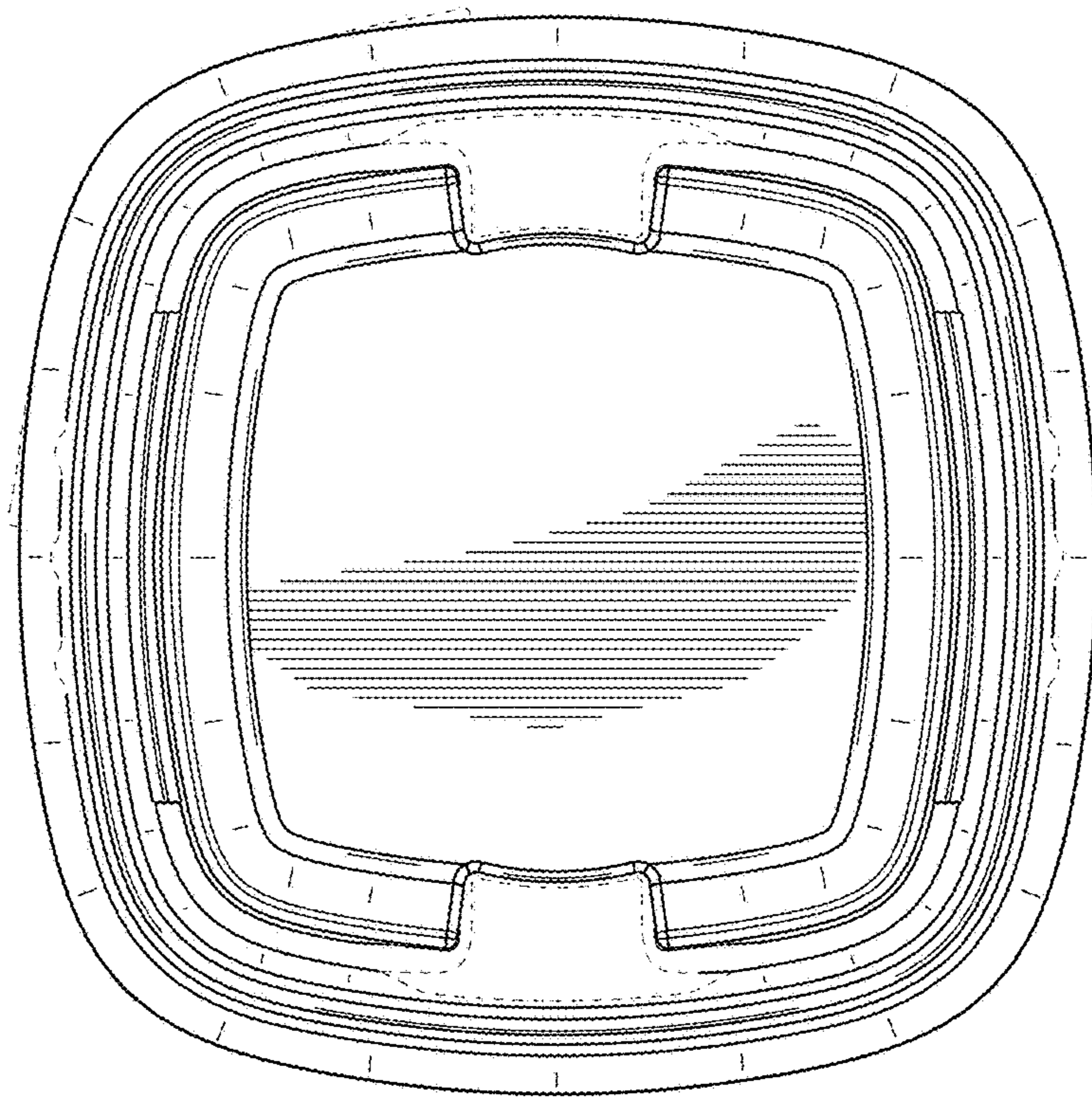

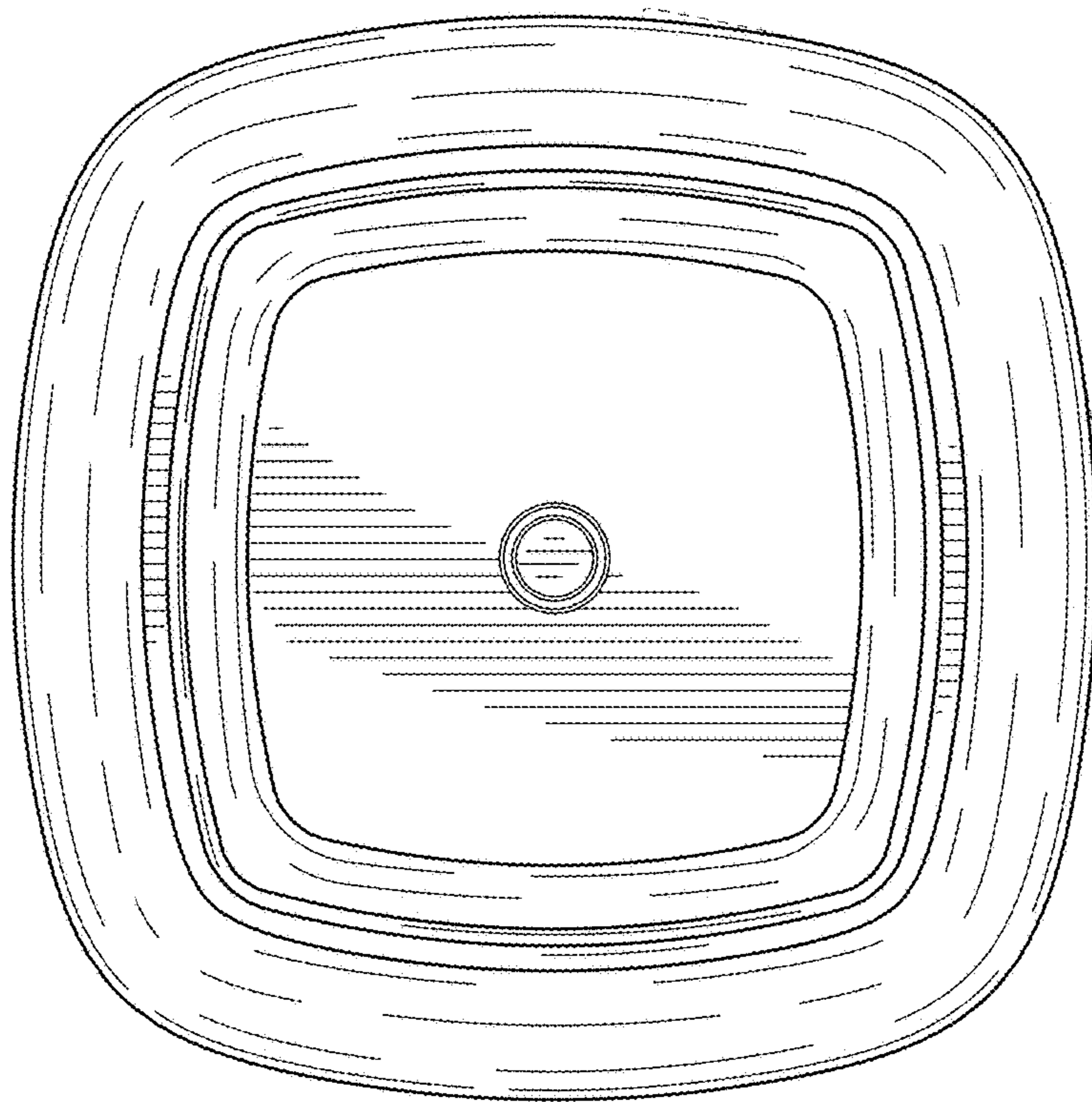

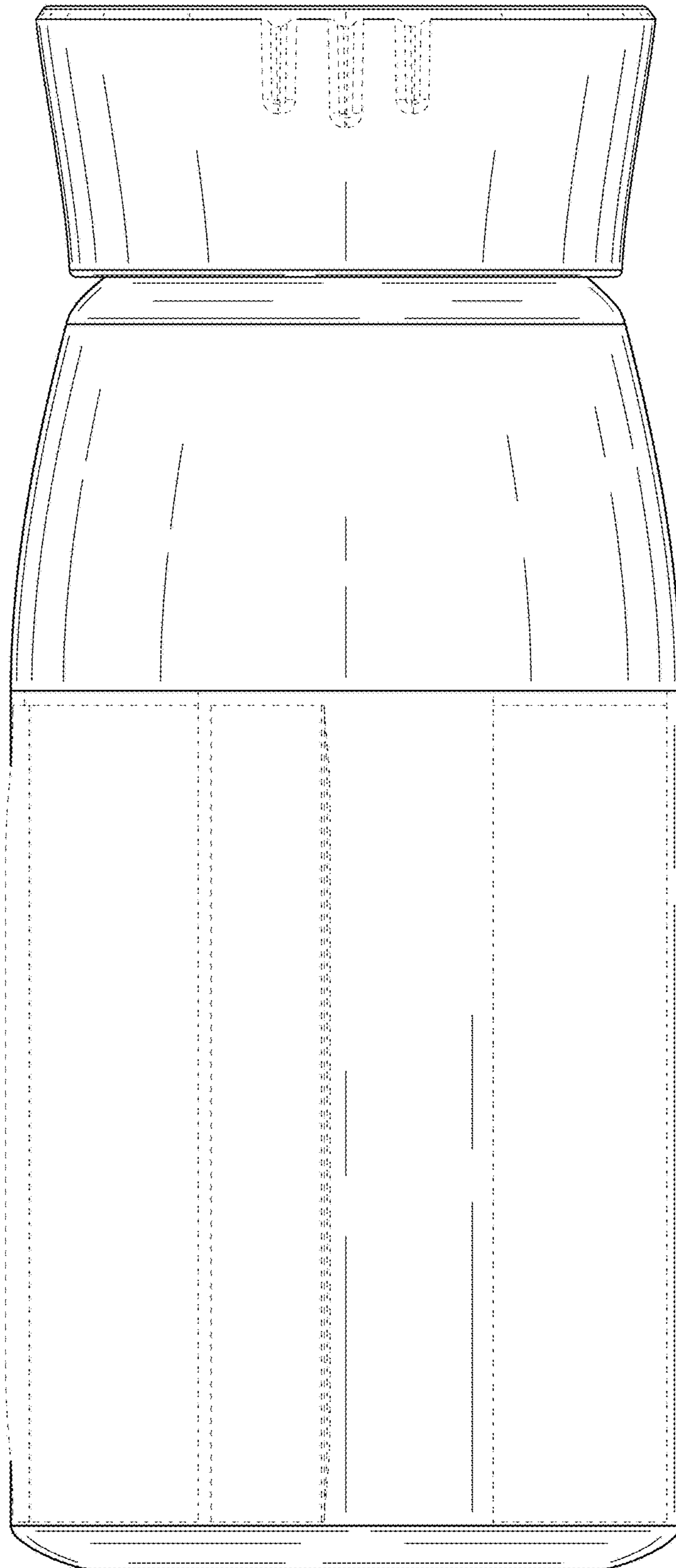

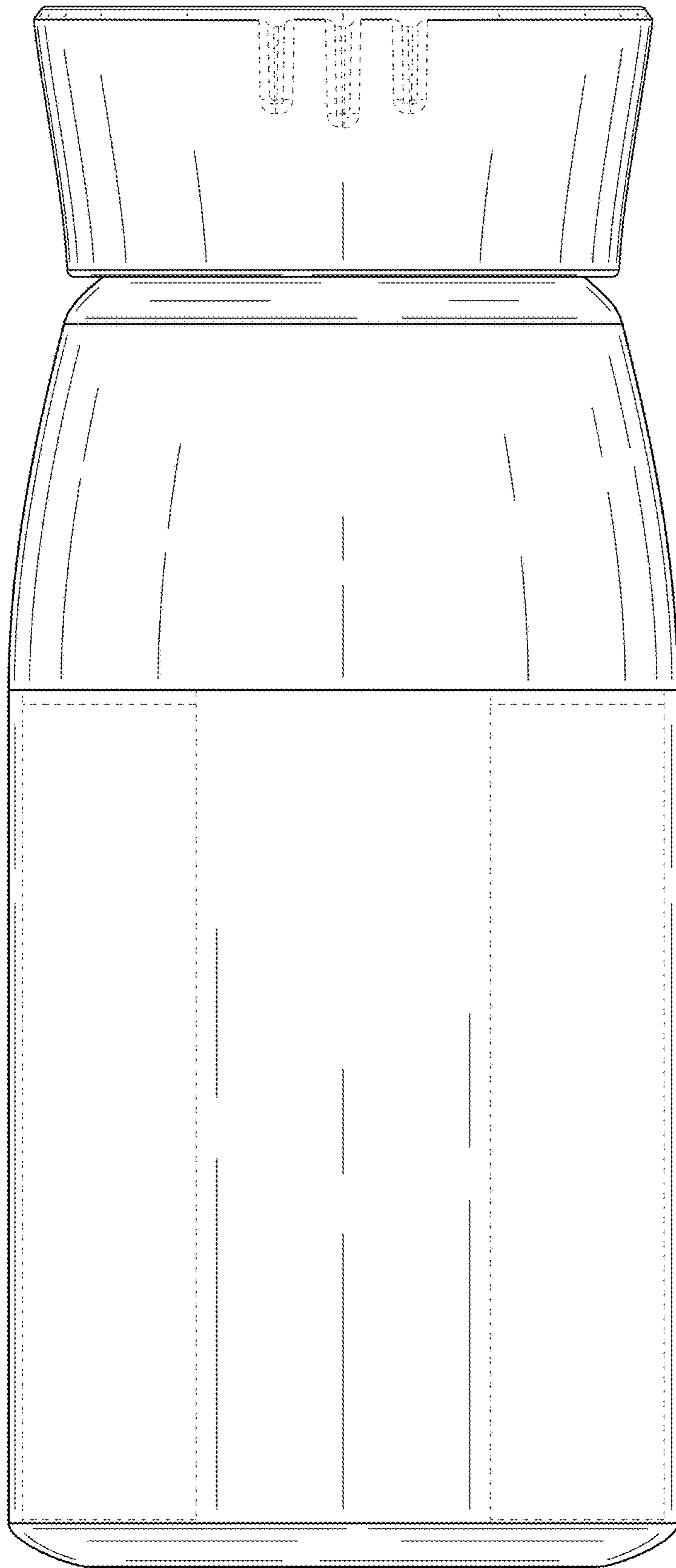

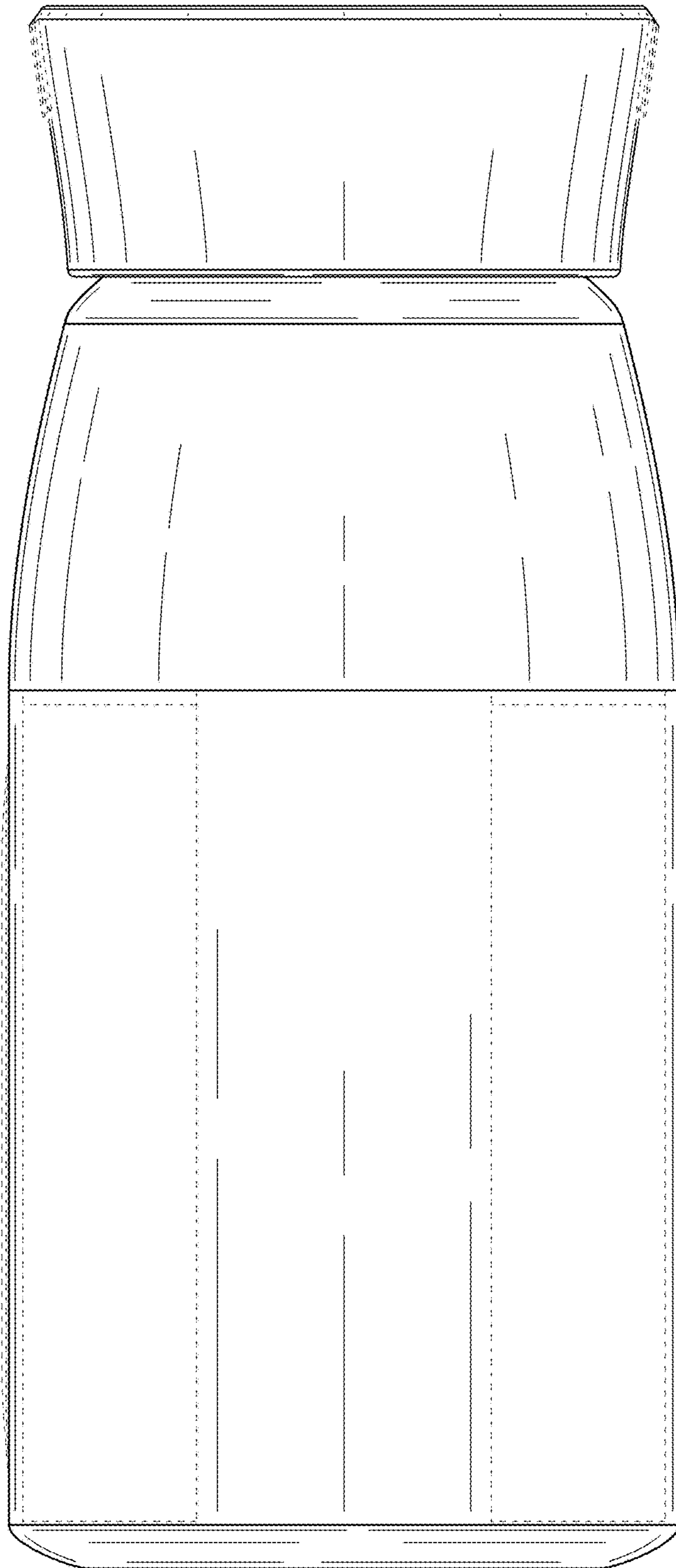

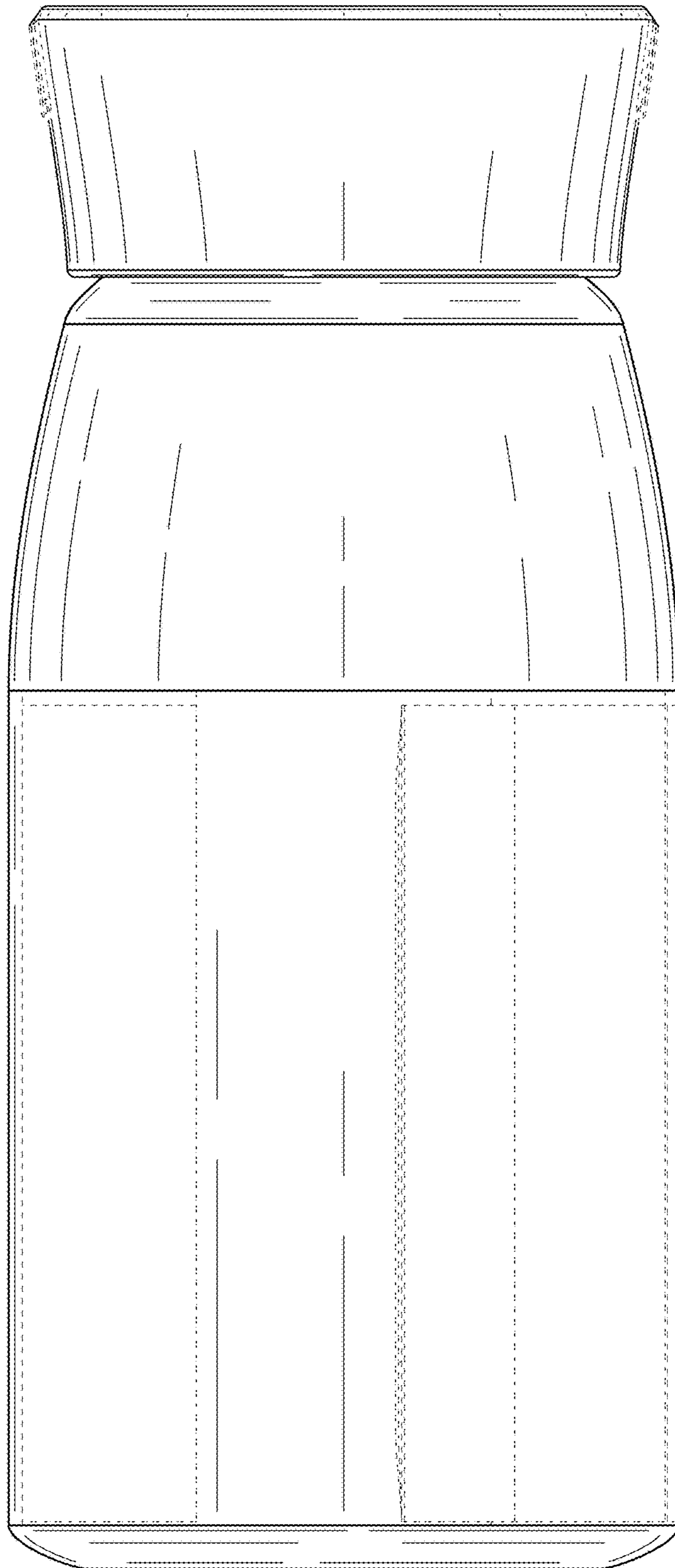
