The ornamental design for a rear of watch, as shown and described.

DESCRIPTION

FIG. 1 is a top front perspective view of a rear of watch showing my new design;
FIG. 2 is a rear bottom perspective view thereof;
FIG. 3 is a top view thereof;
FIG. 4 is a bottom view thereof;
FIG. 5 is a left side view thereof;
FIG. 6 is a right side view thereof;
FIG. 7 is a front view thereof; and,
FIG. 8 is a rear view thereof.

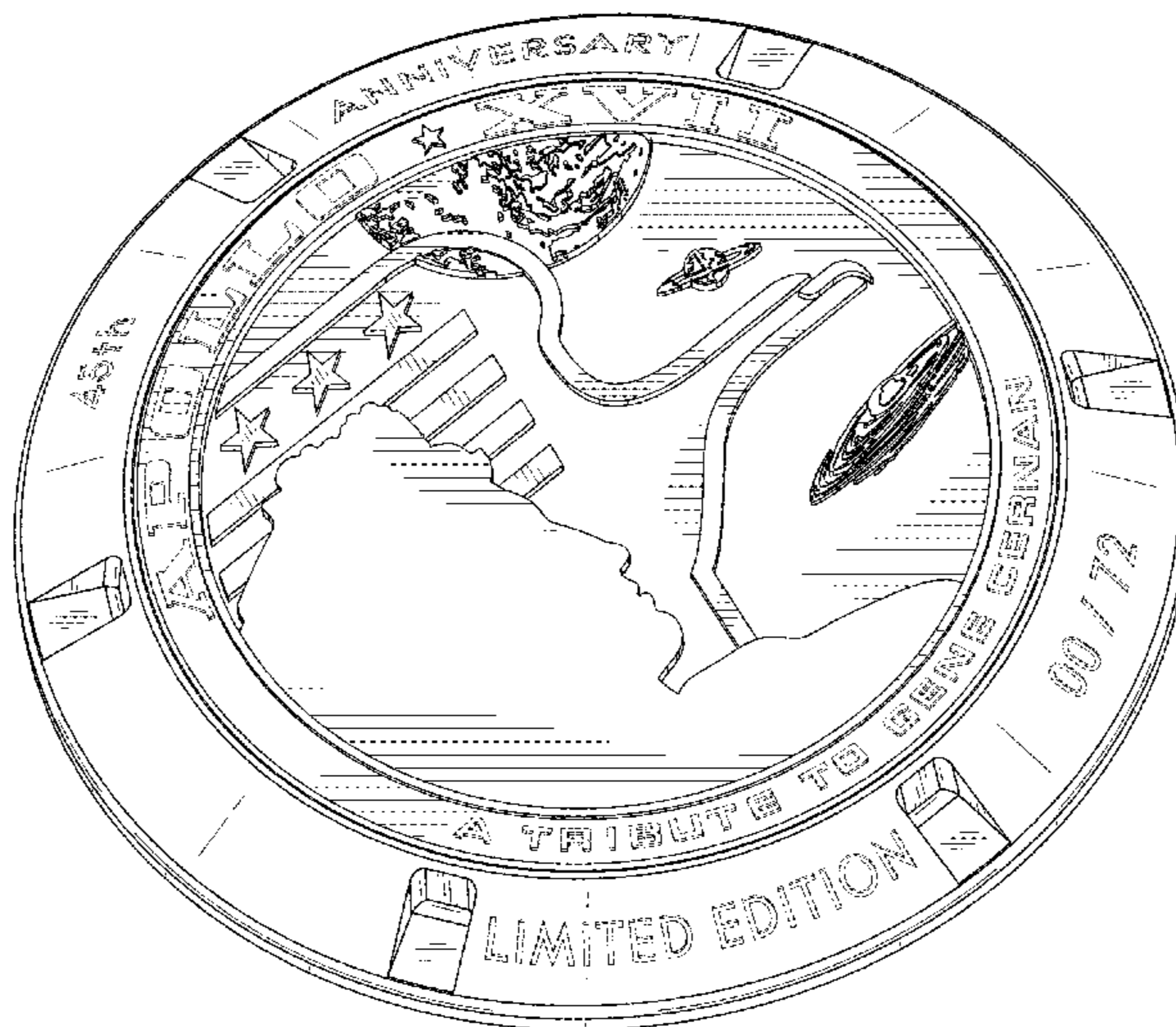

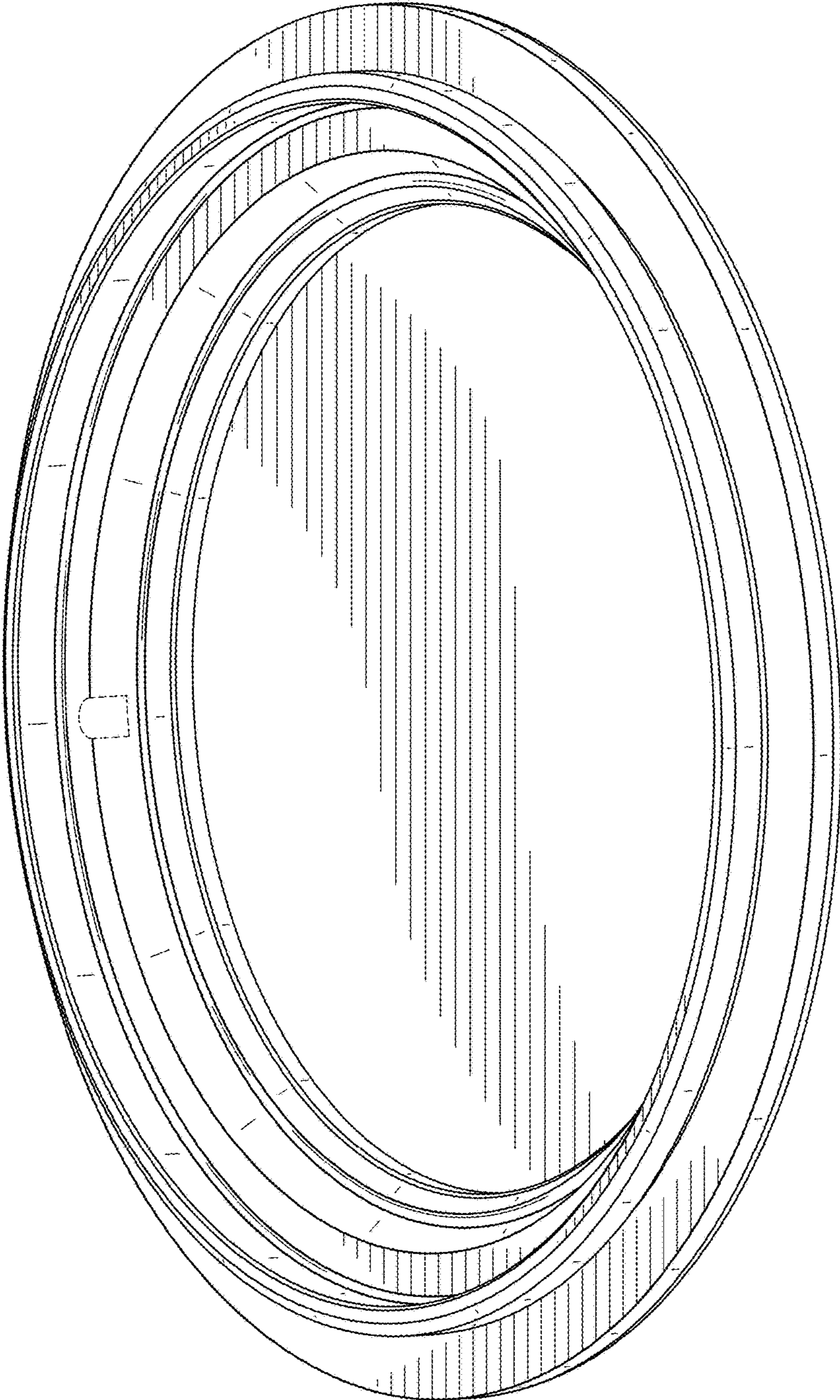

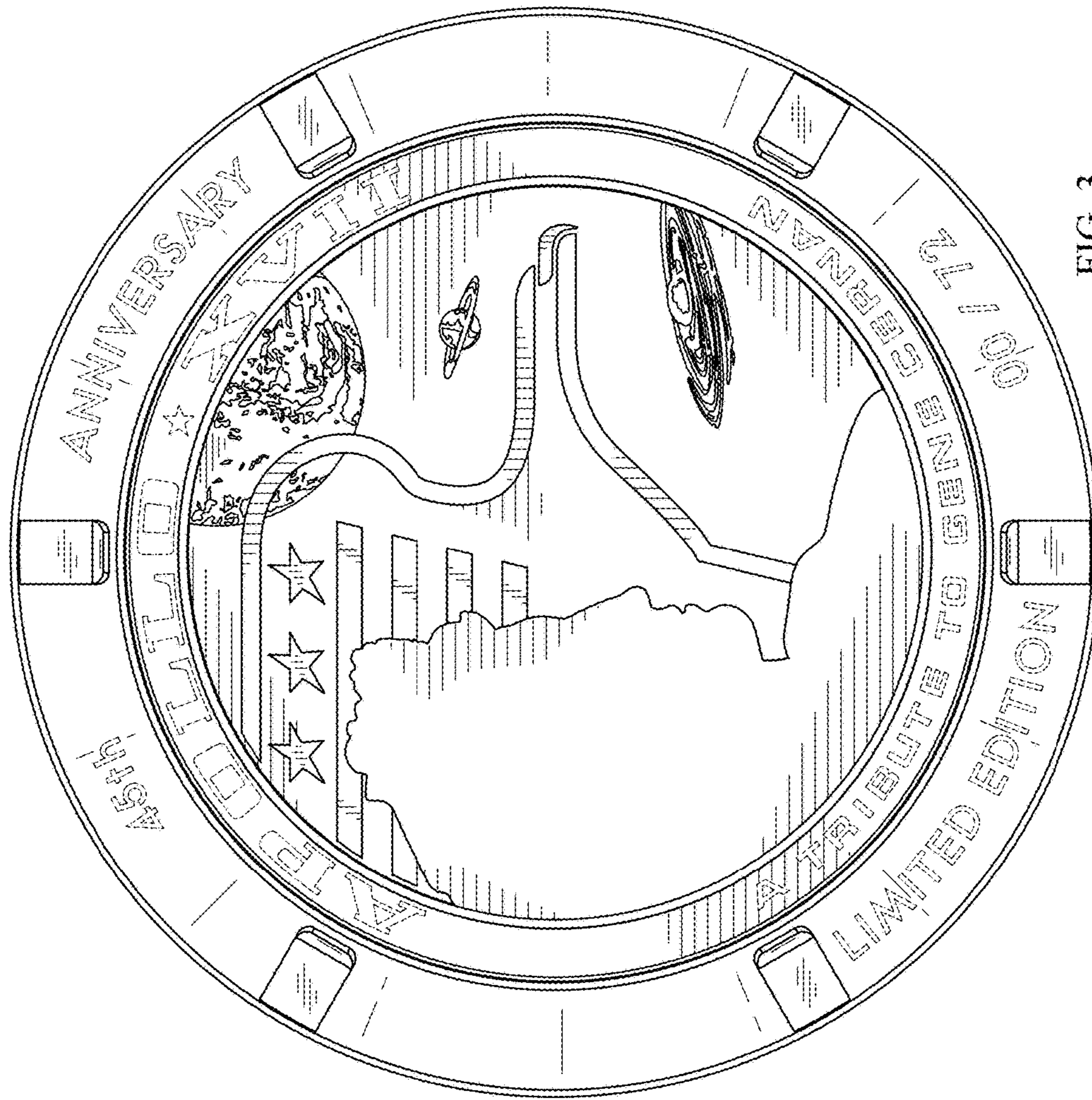

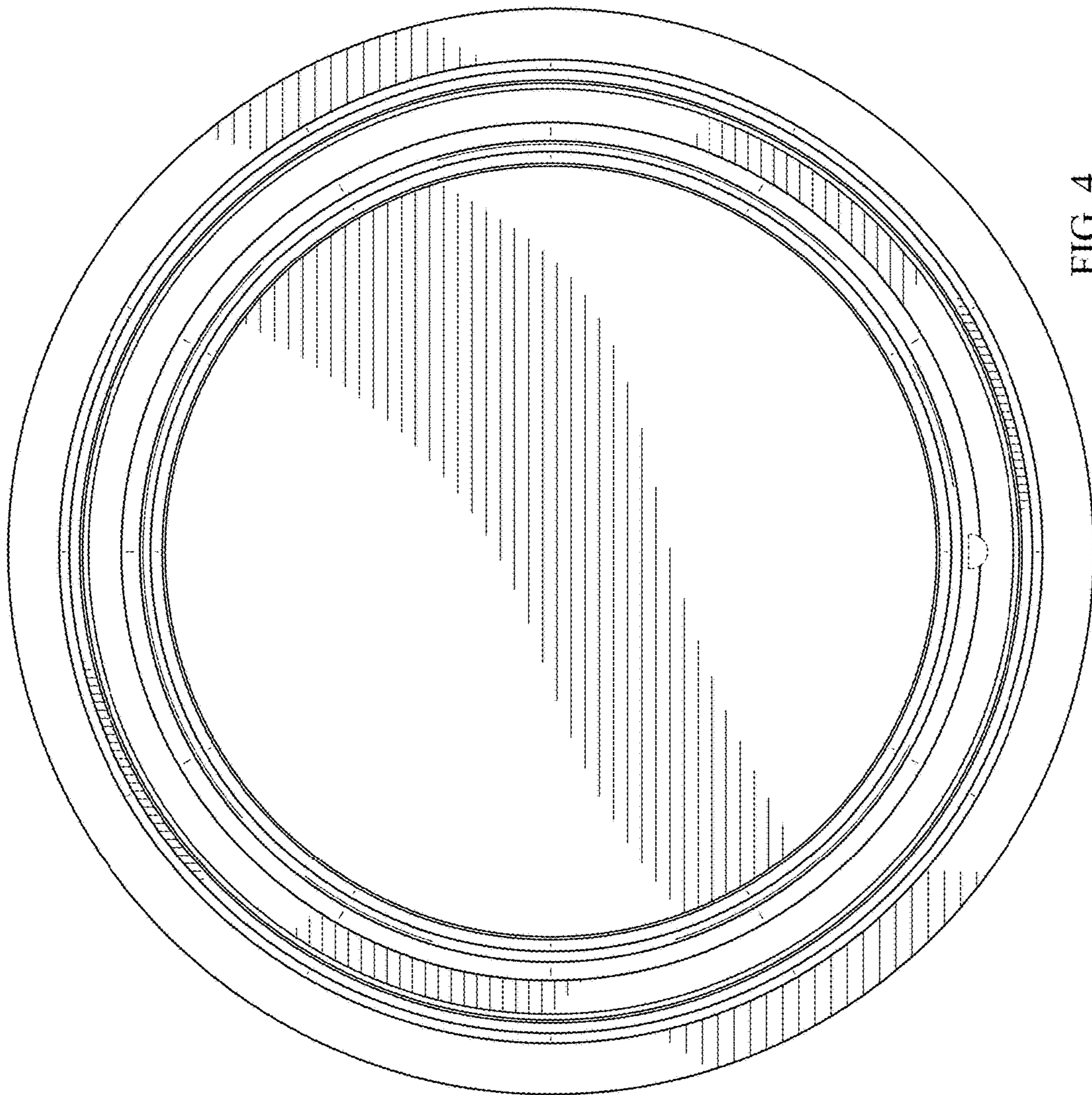

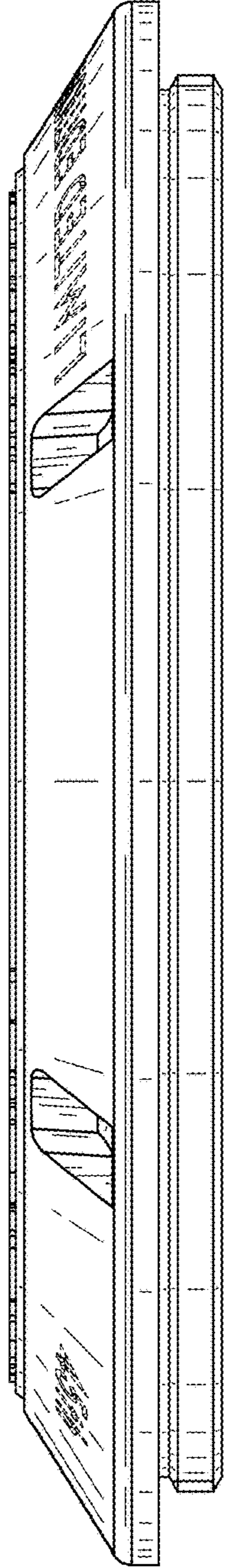

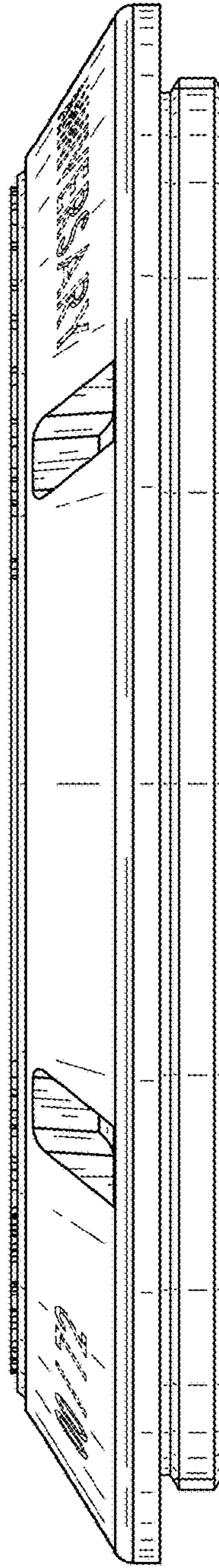

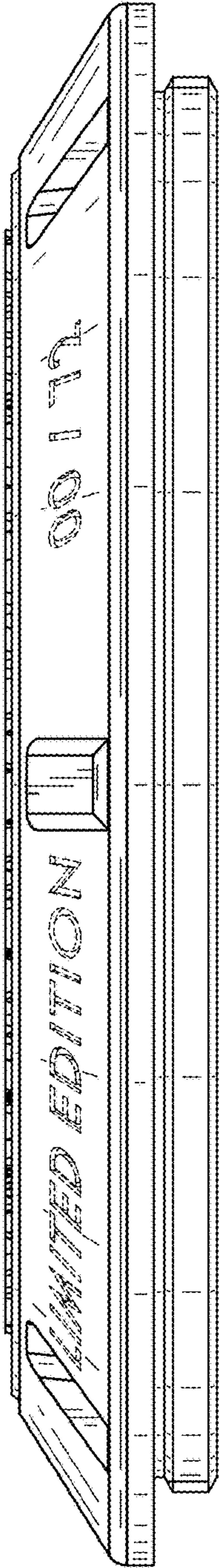

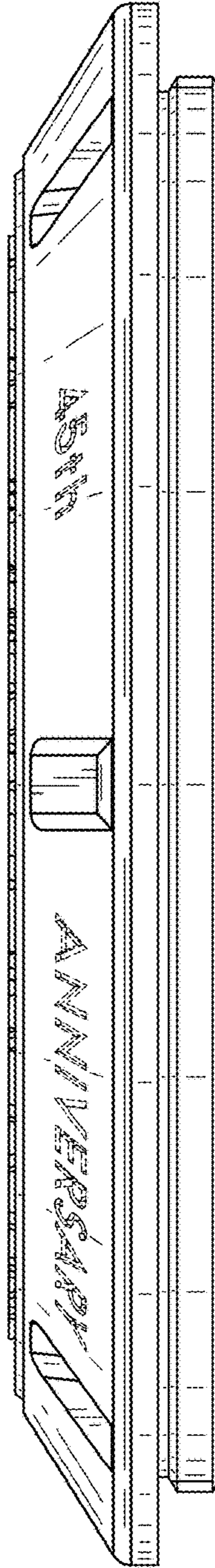
