1.1 is a front elevation view of a tire showing my new design;  
1.2 is a rear elevation view thereof;  
1.3 is a right side elevation view thereof, of which the left side elevation view is a mirror image;  
1.4 is a top plan view thereof, of which the bottom plan view is a mirror image;  
1.5 is a front perspective view thereof;  
1.6 is an enlarged front elevation view of portion 6-6 in reproduction 1.1;  
1.7 is an enlarged partial perspective view of portion 7-7 in reproduction 1.5;  
1.8 is a cross-sectional view thereof taken in the direction of line 8-8 in reproduction 1.1;  
1.9 is a cross-sectional view taken in the direction of line 9-9 in reproduction 1.6;  
1.10 is a cross-sectional view taken in the direction of line 10-10 in reproduction 1.6;  
1.11 is an enlarged front elevation view of portion 6-6 in reproduction 1.1; and  
1.12 is an enlarged cross-sectional view of the radial member taken in the direction 12-12 in reproduction 1.11.  
The broken lines in the reproductions illustrate portions of the tire that form no part of the claimed design.

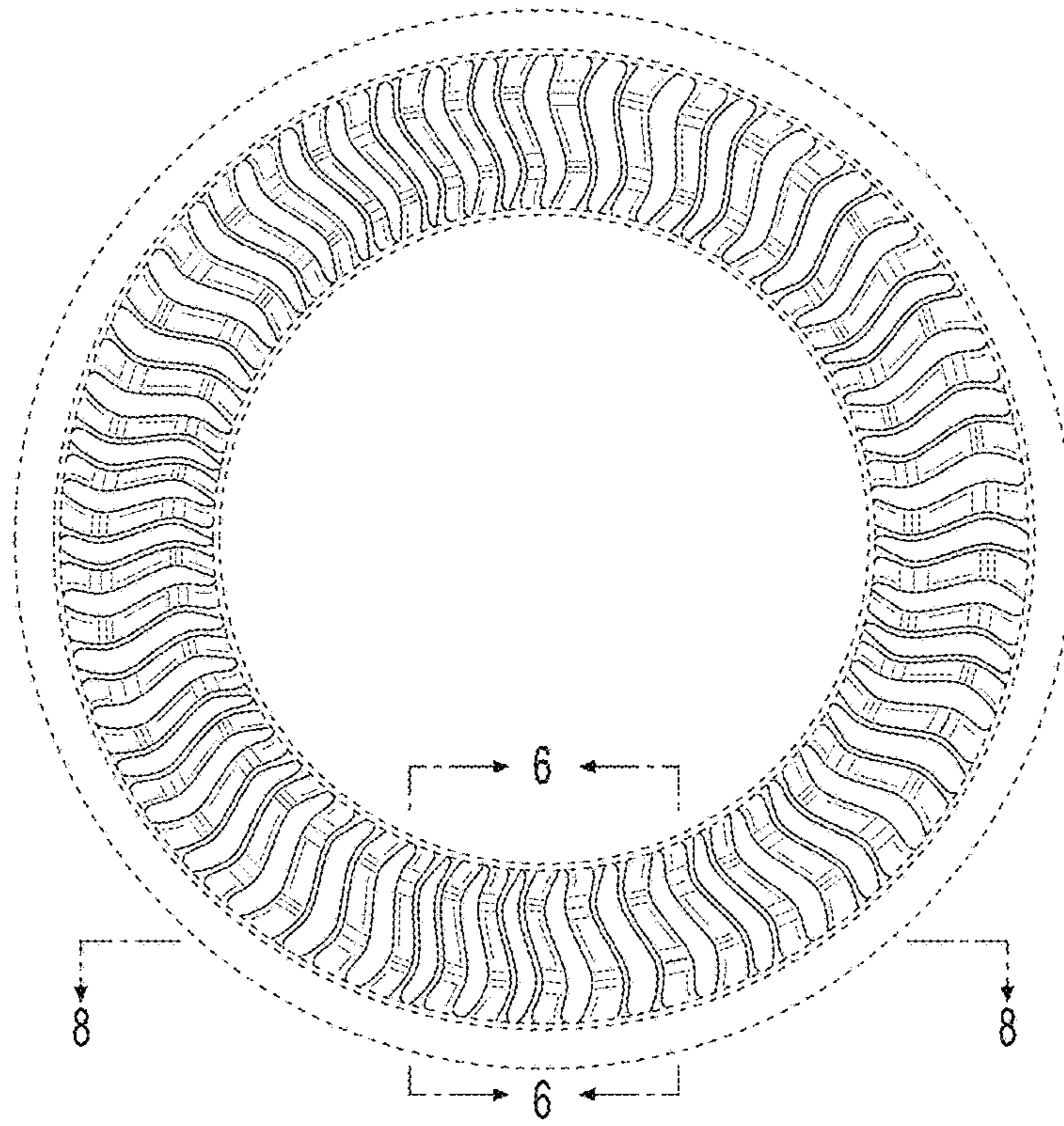

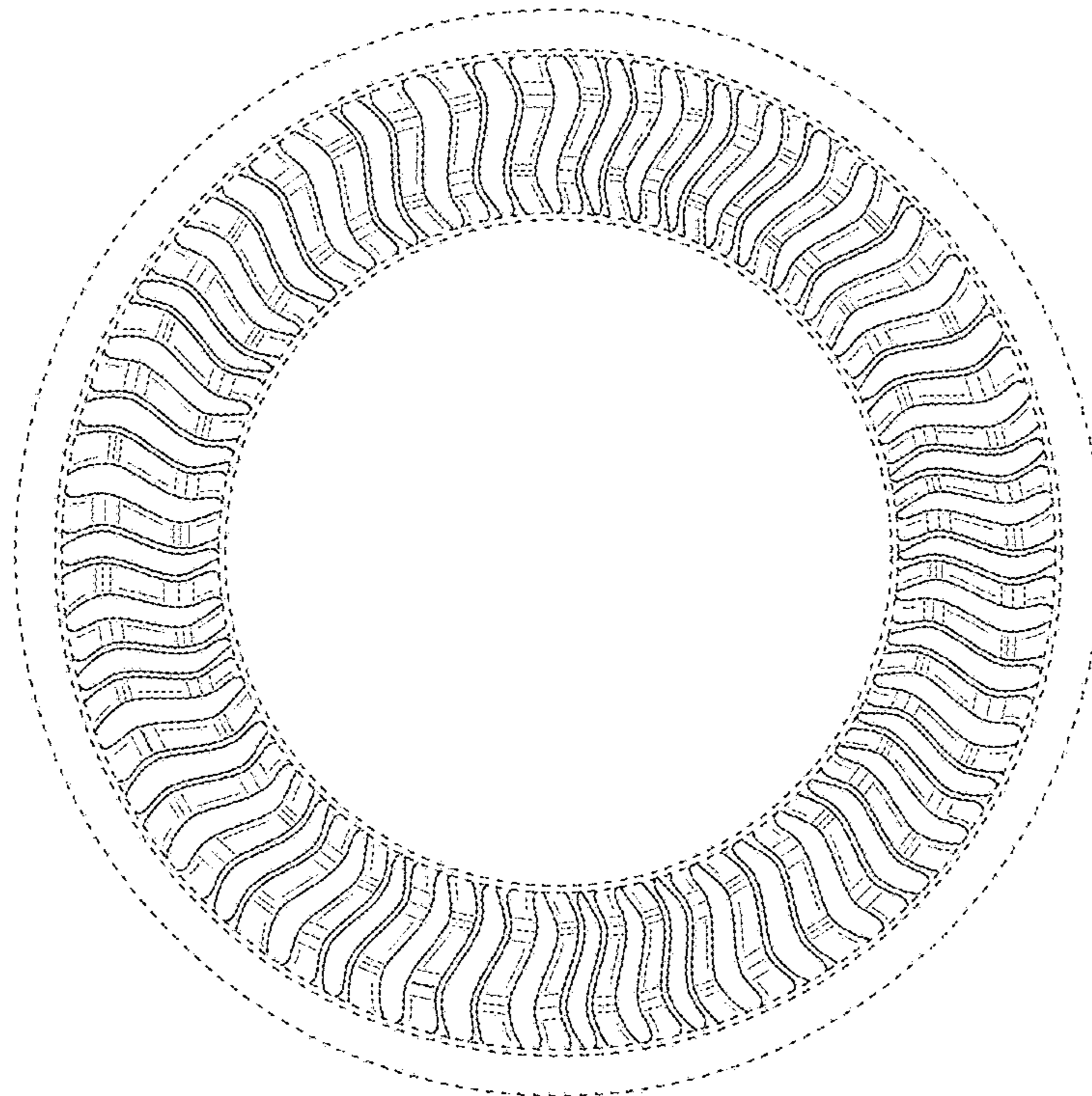

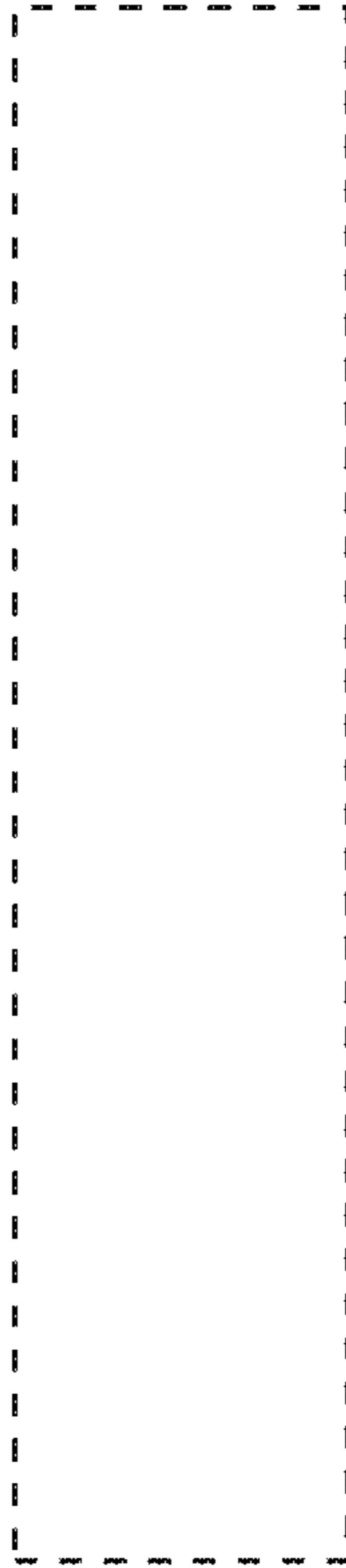

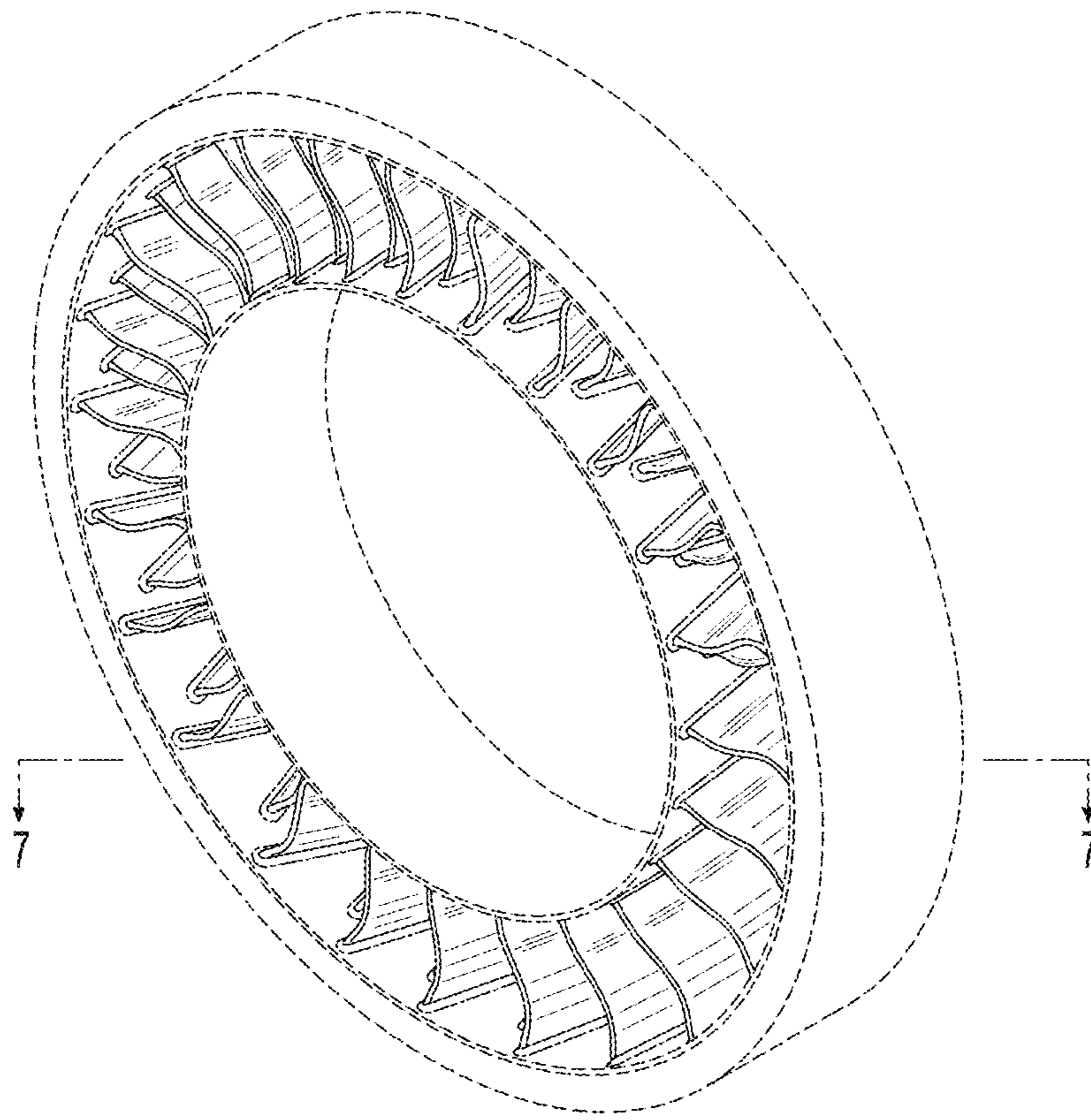

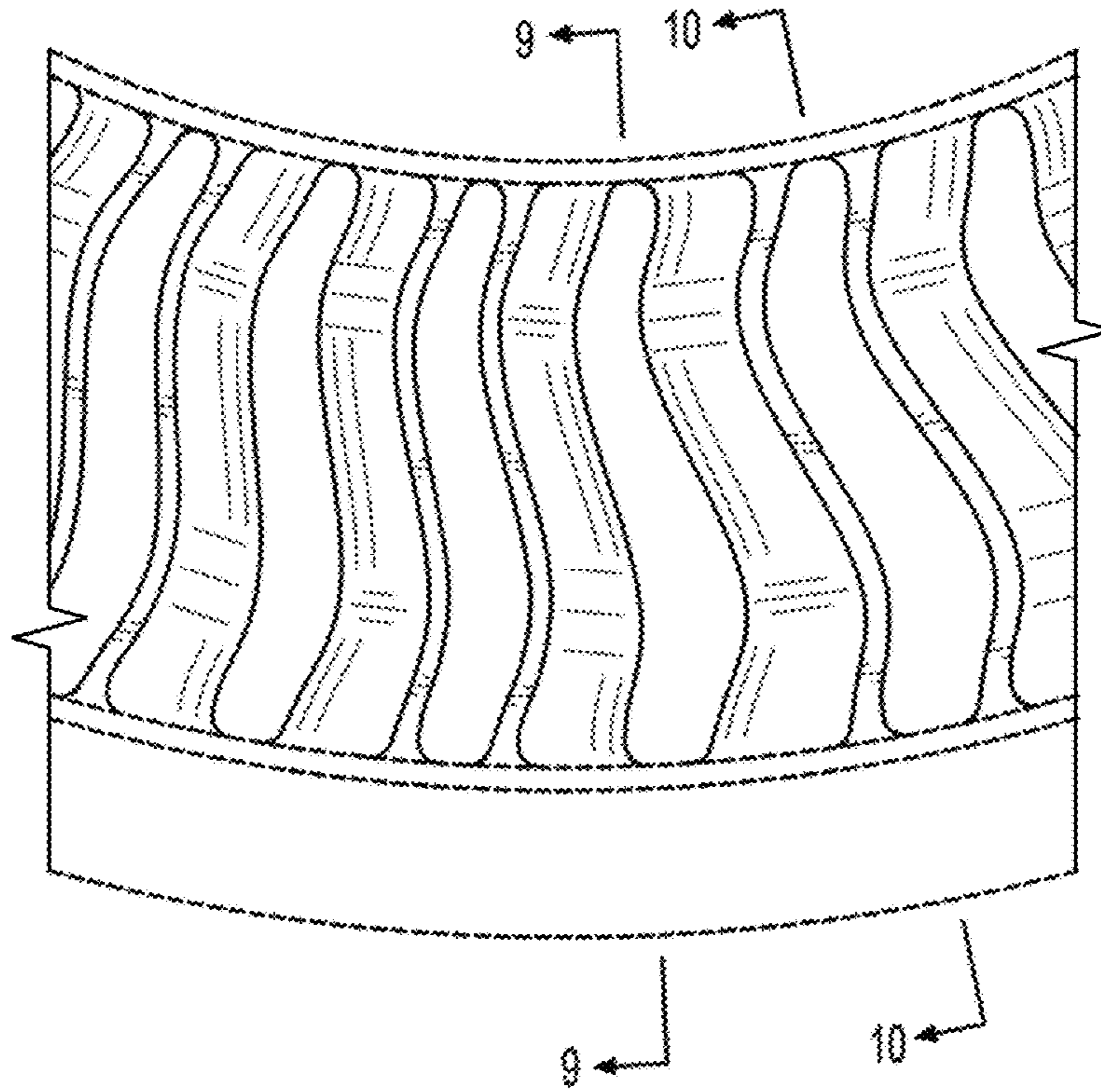

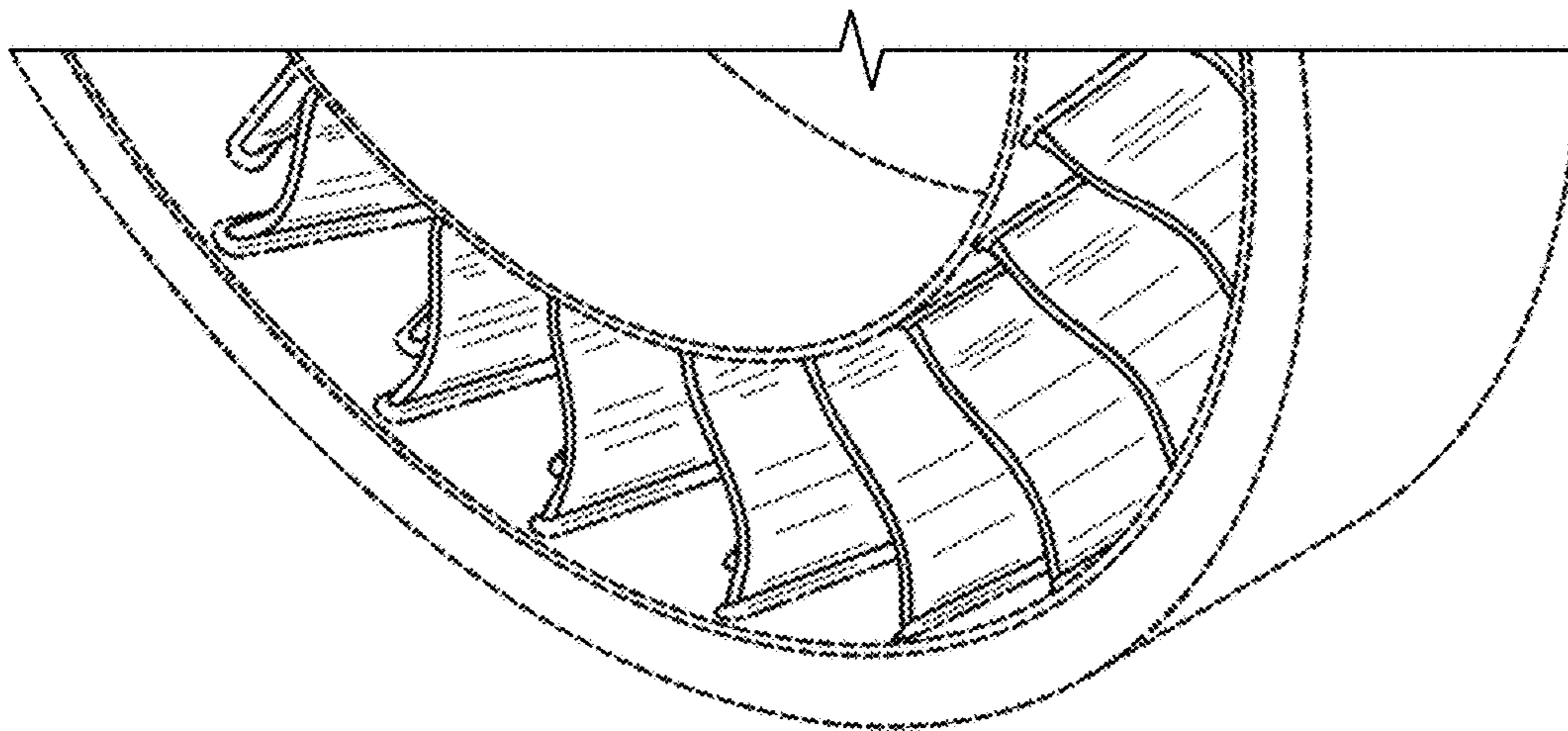




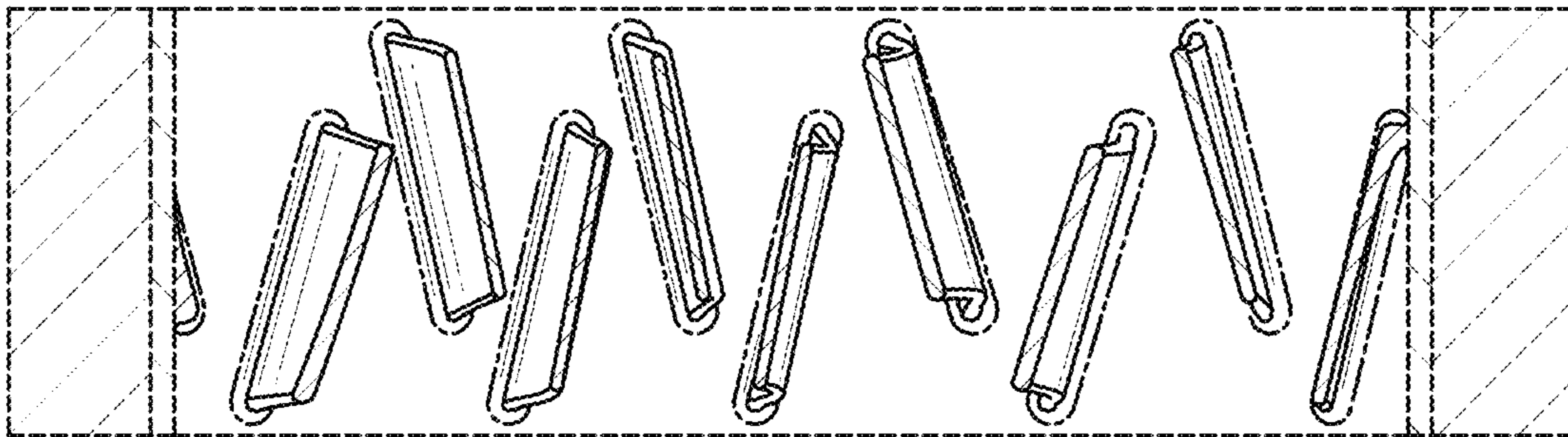

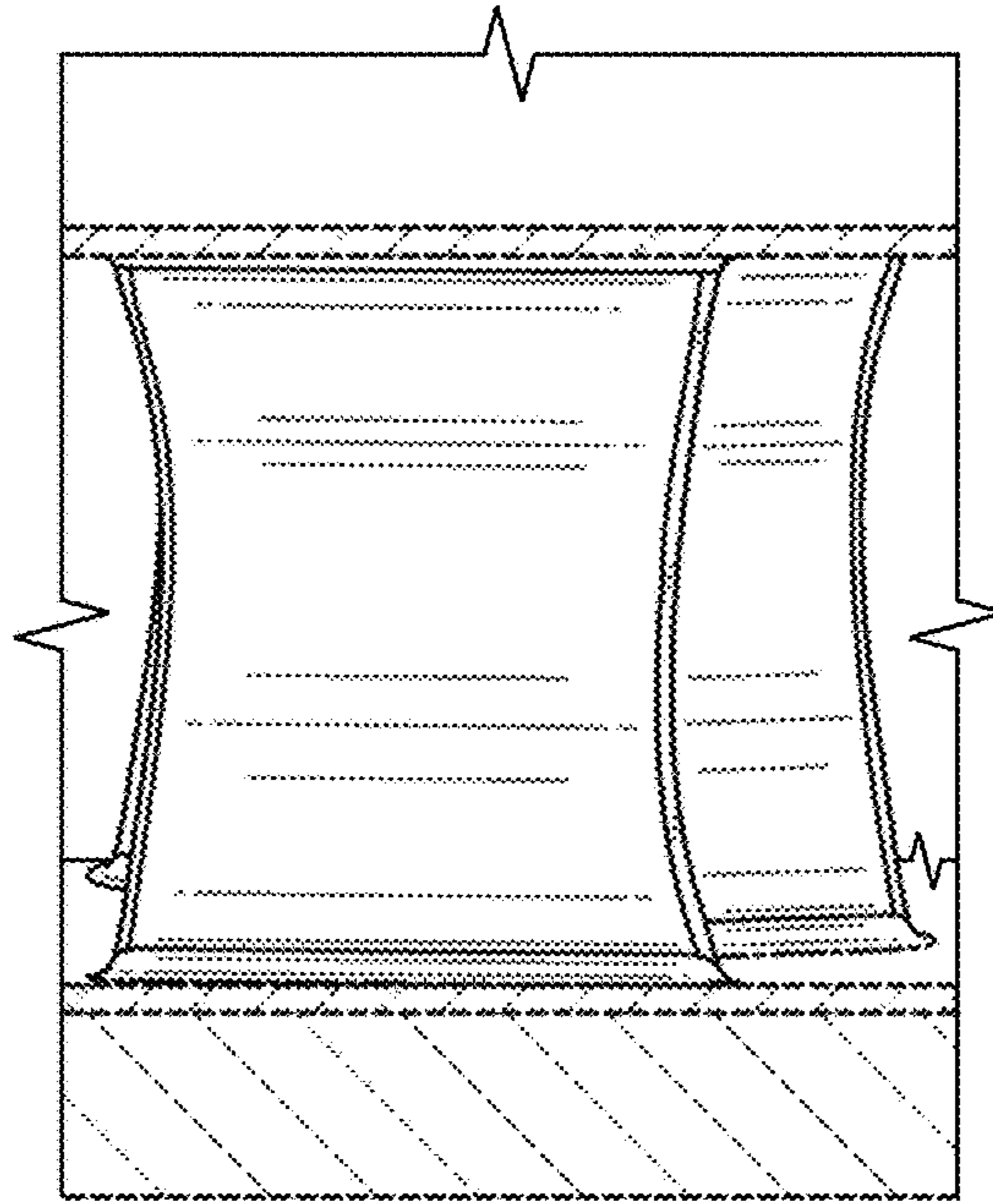

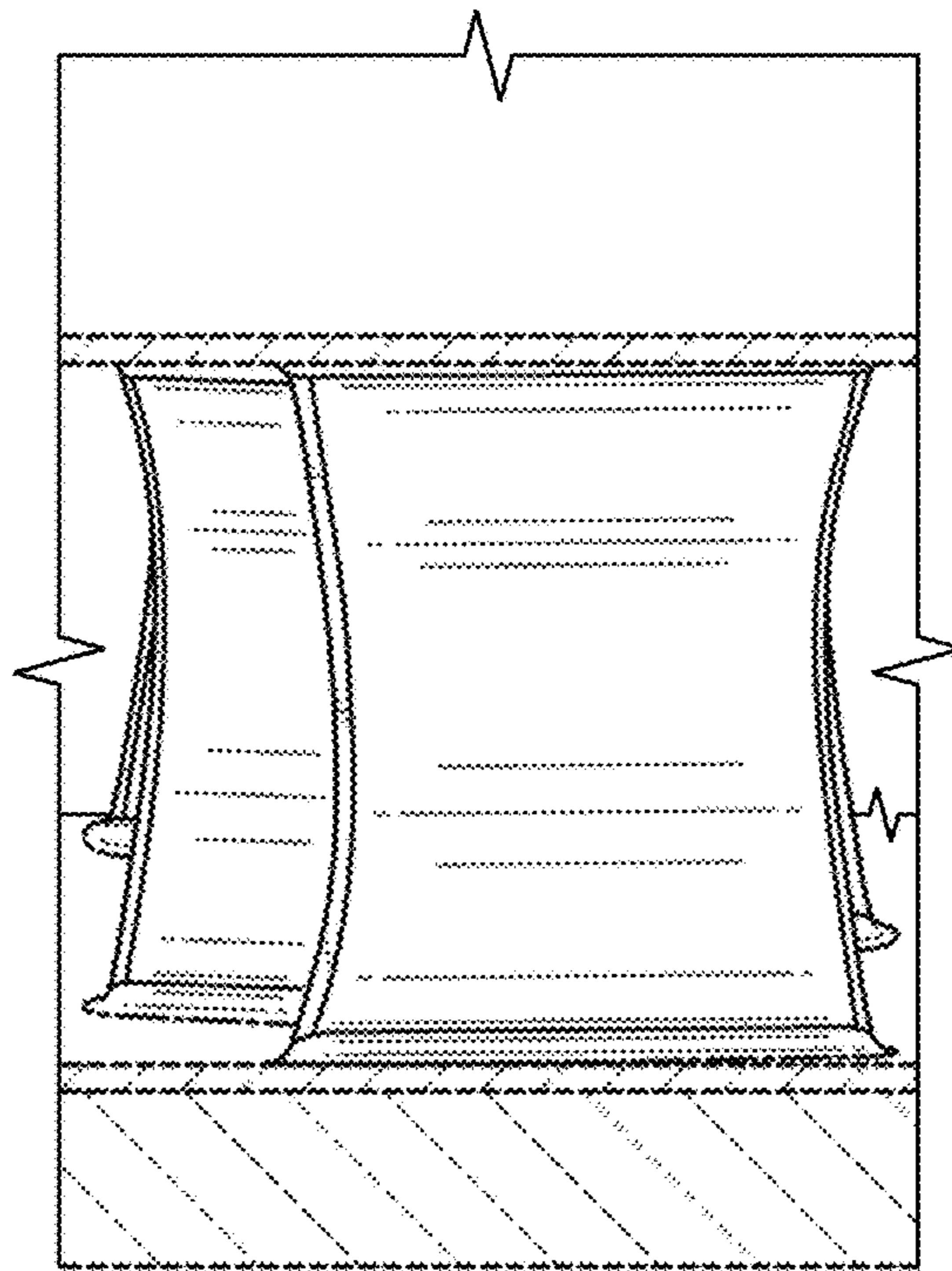

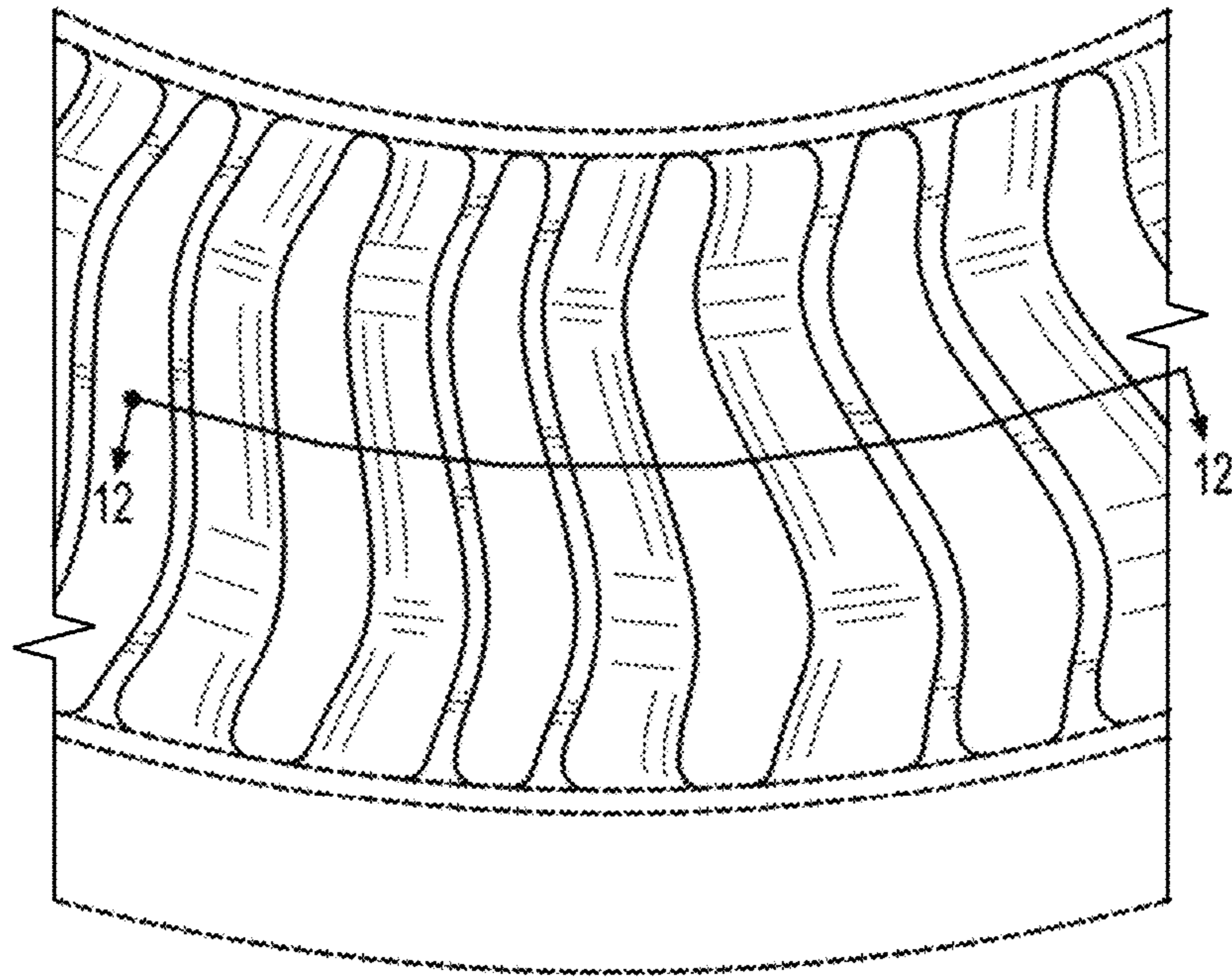

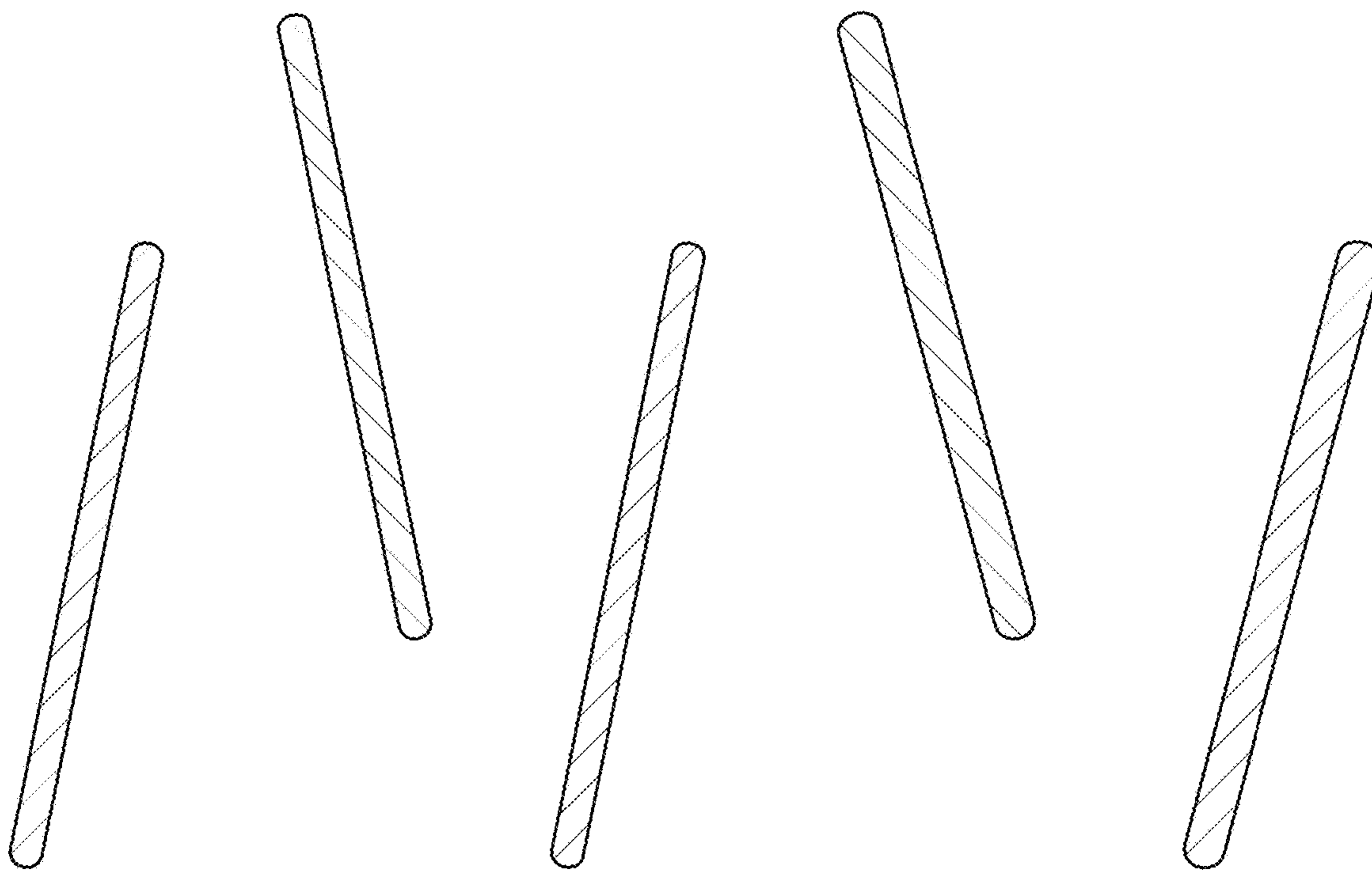
