FIG. 1 is a front view of a display screen or portion thereof showing a first image of a graphical user interface.

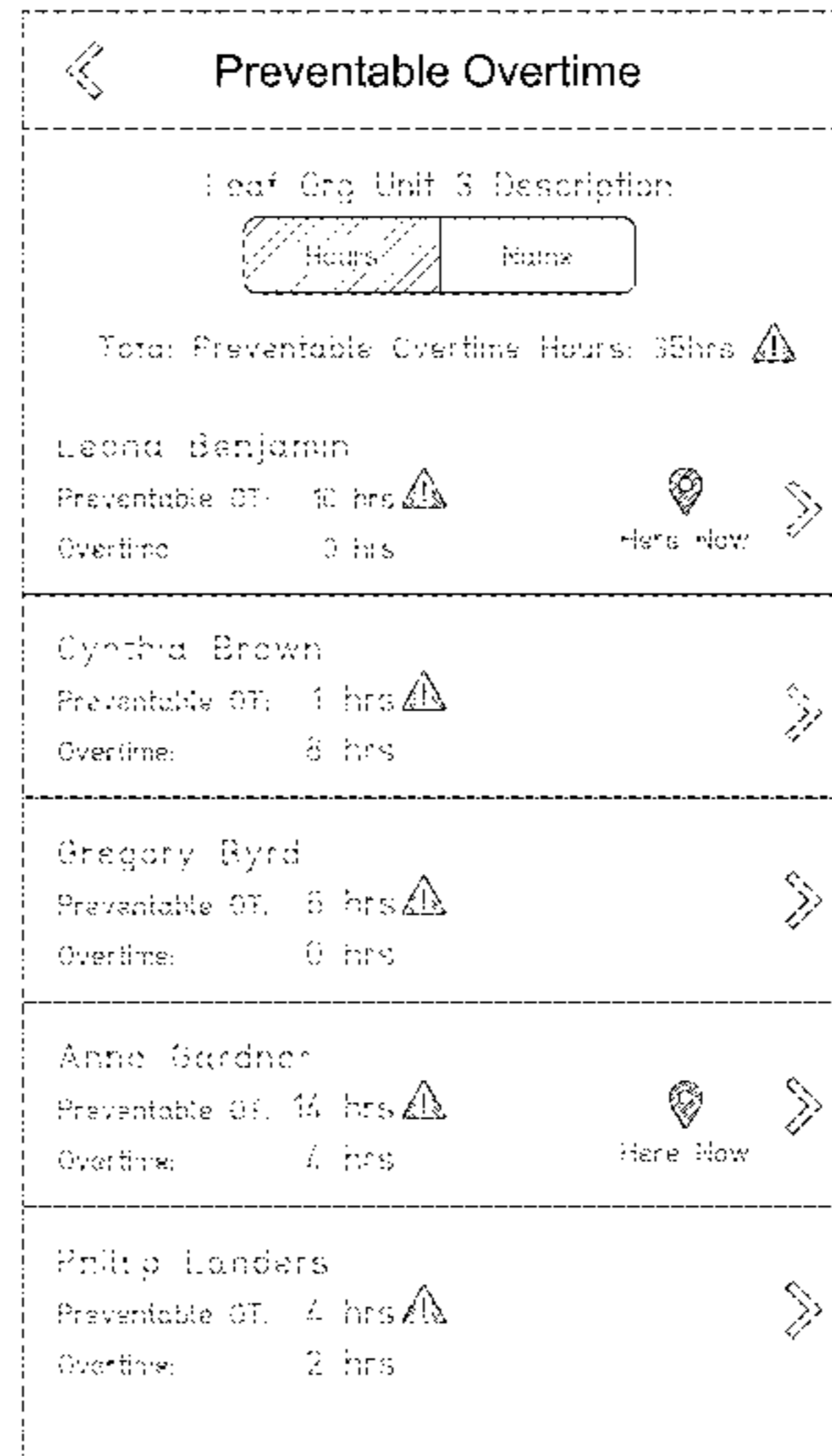
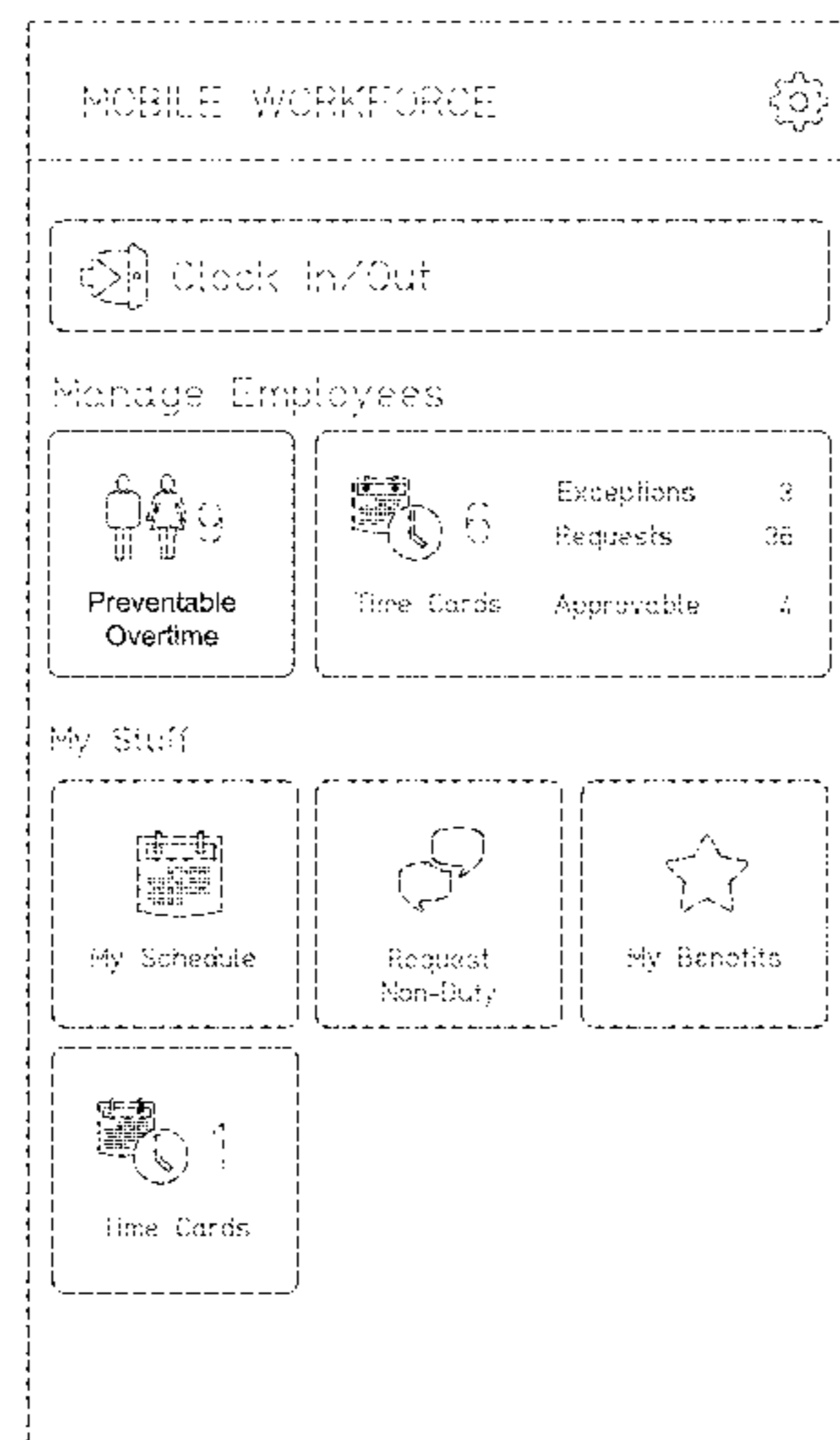
FIG. 2 is a front view of a display screen or portion thereof showing a second image of the graphical user interface.

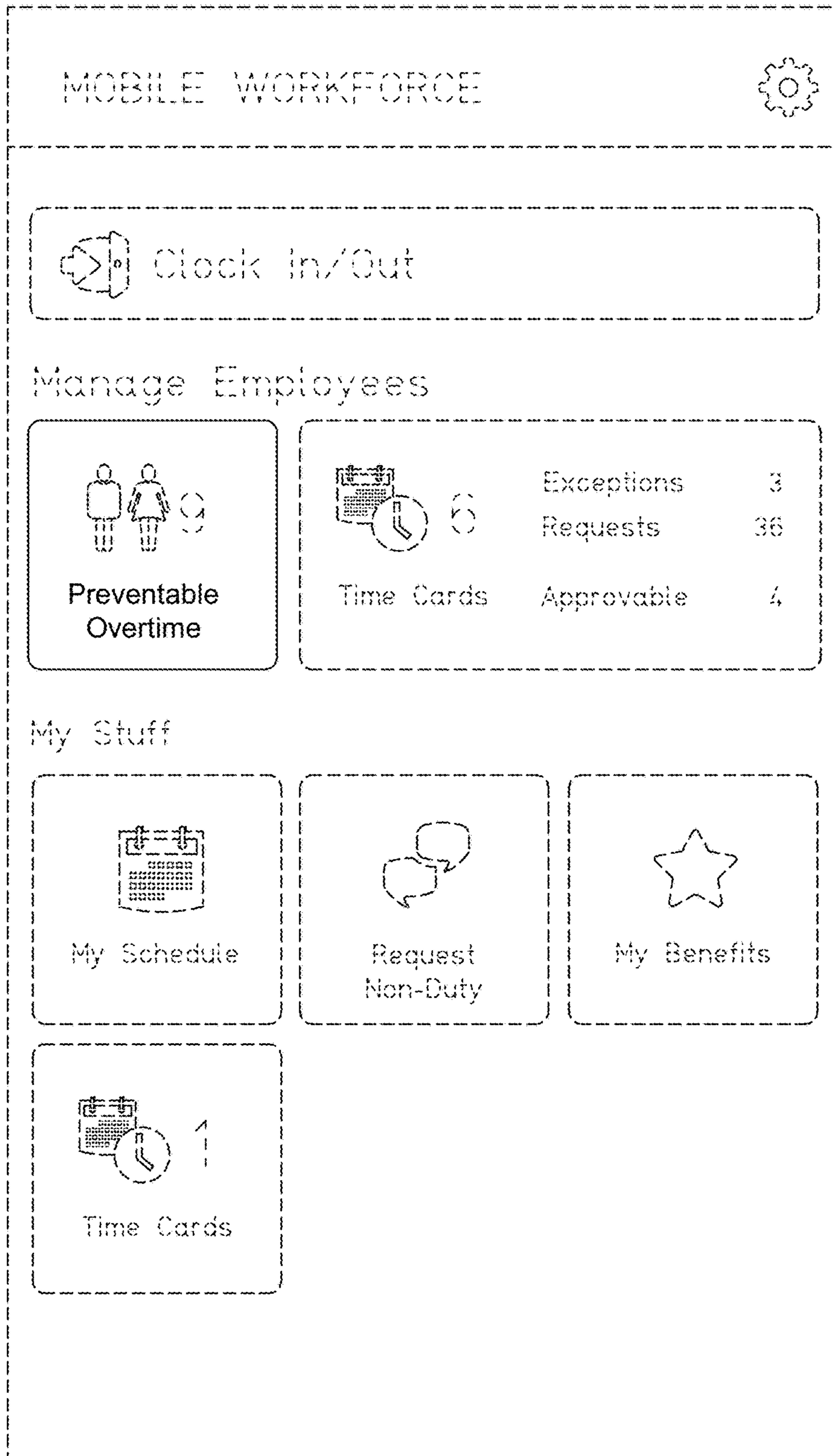


FIG. 1 © General Electric Company, 2016.

The appearance of the graphical user interface of the display screen or portion thereof sequentially transitions between the images shown in FIGS. 1-4. The process or period in which the graphical user interface transitions forms no part of the claimed design.

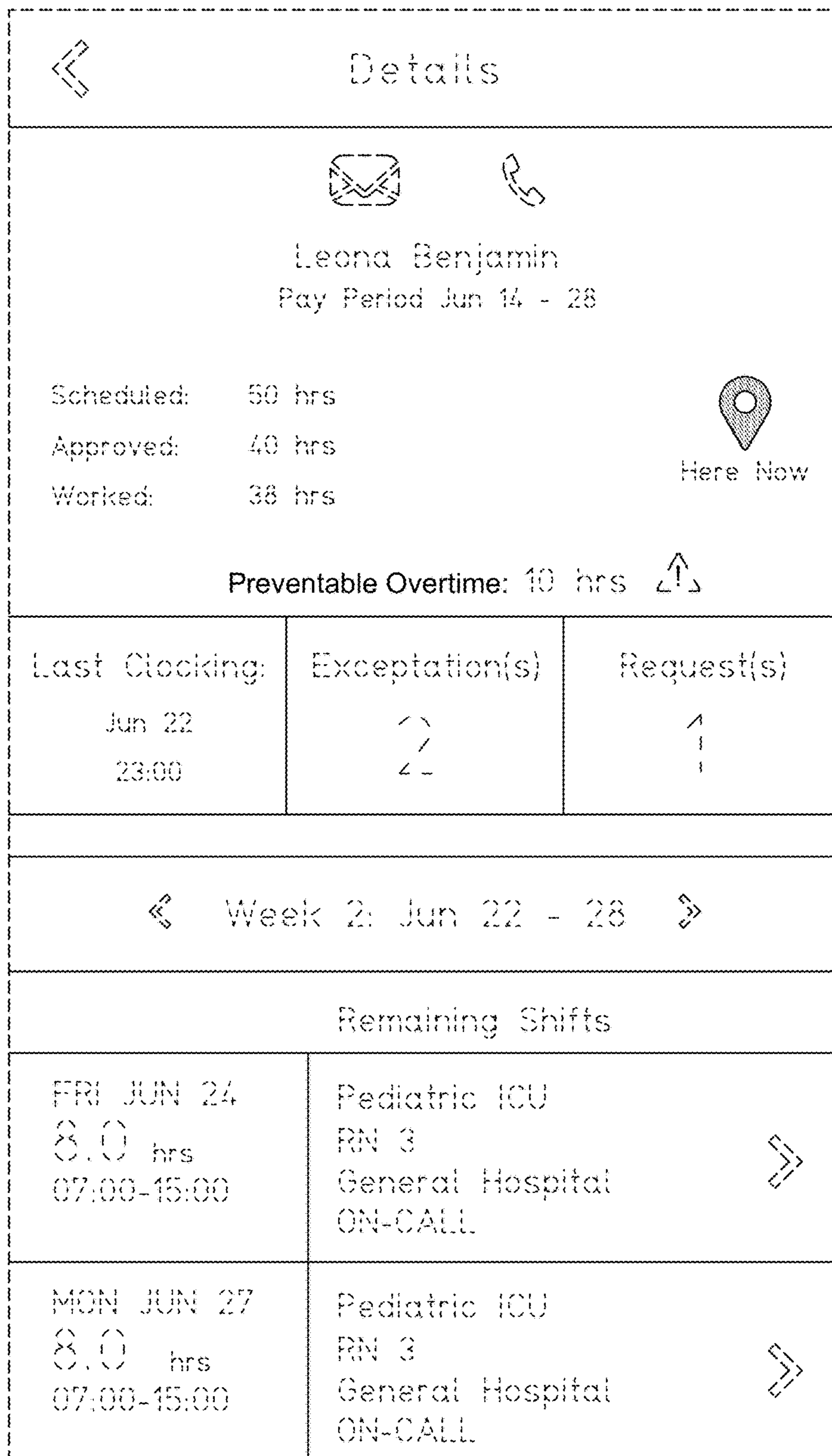


FIG. 4 © General Electric Company, 2016.
