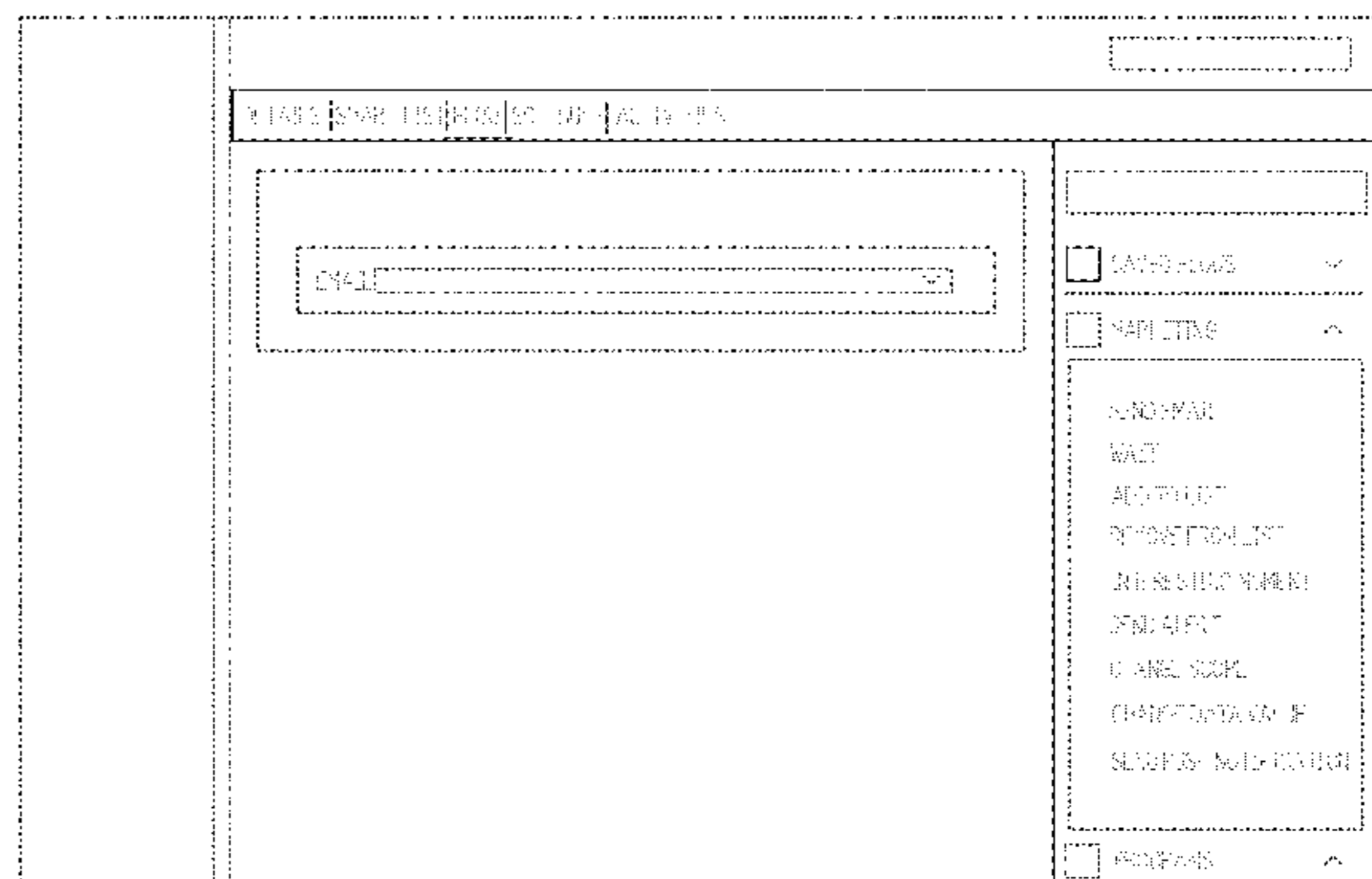
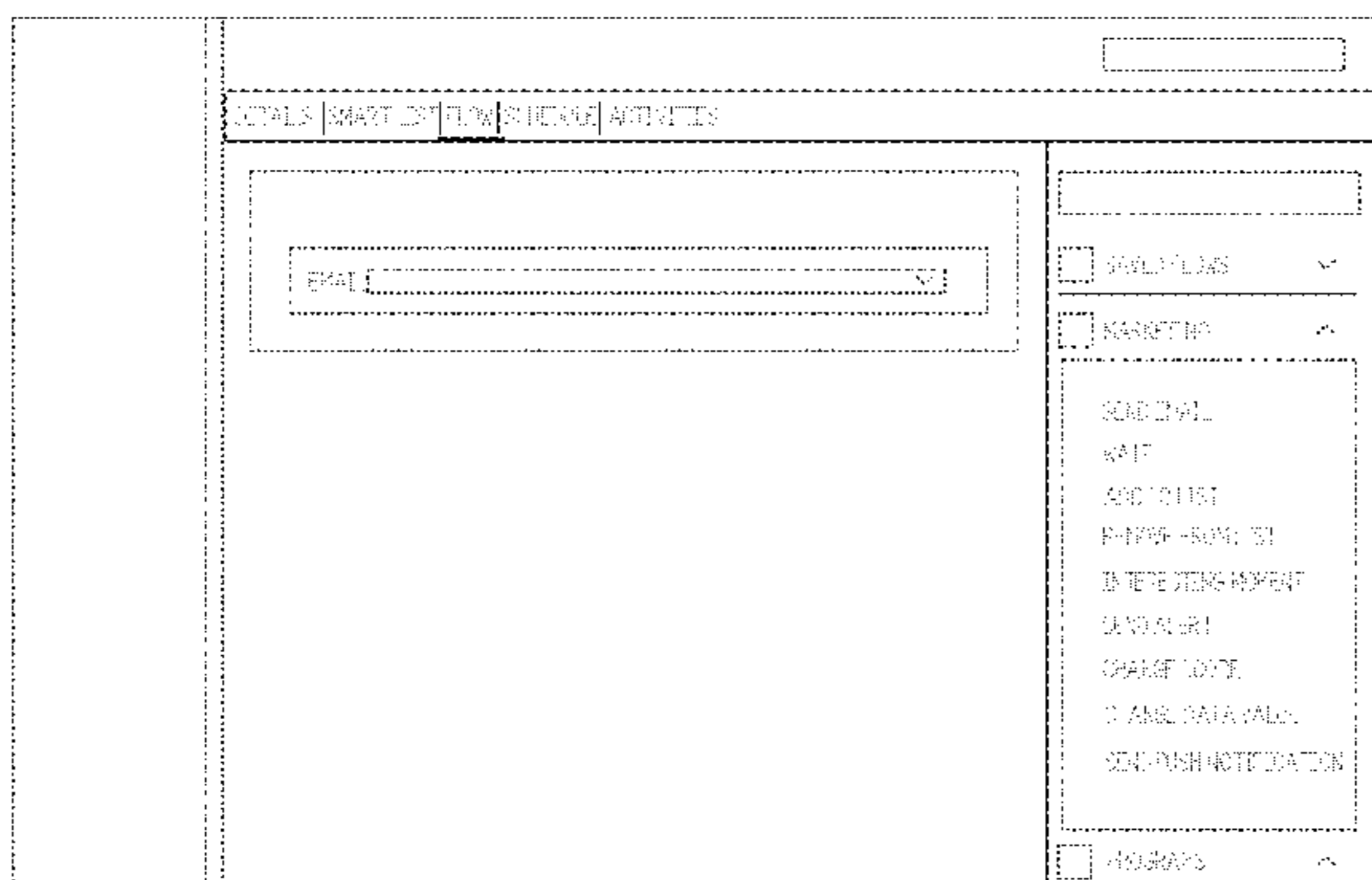
(57) **CLAIM**

The ornamental design for a display screen with a graphical user interface, as shown and described.

DESCRIPTION

FIG. 1 illustrates a display screen with a graphical user interface, according to a first embodiment; and, FIG. 2 illustrates a display screen with a graphical user interface, according to a second embodiment. 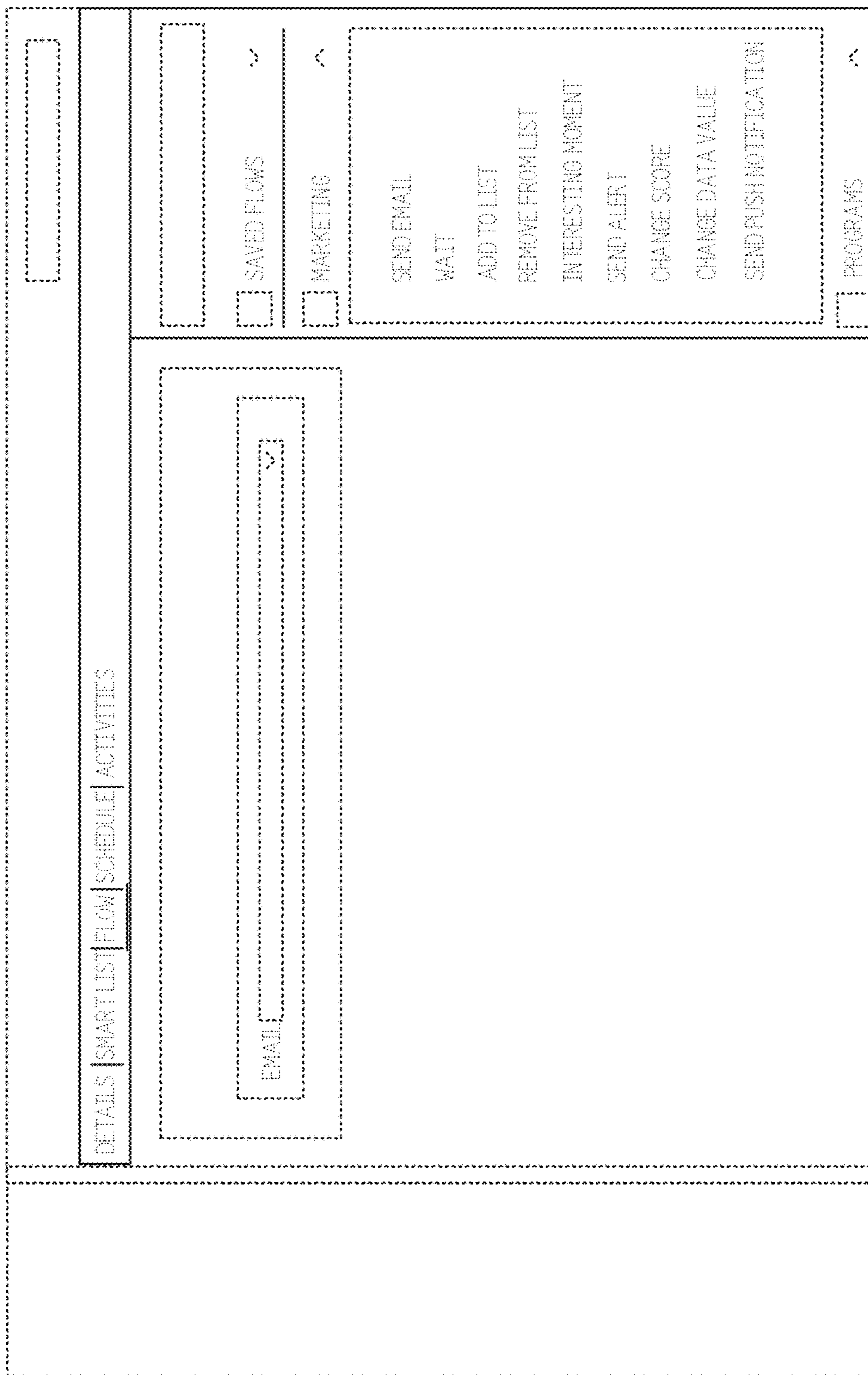
