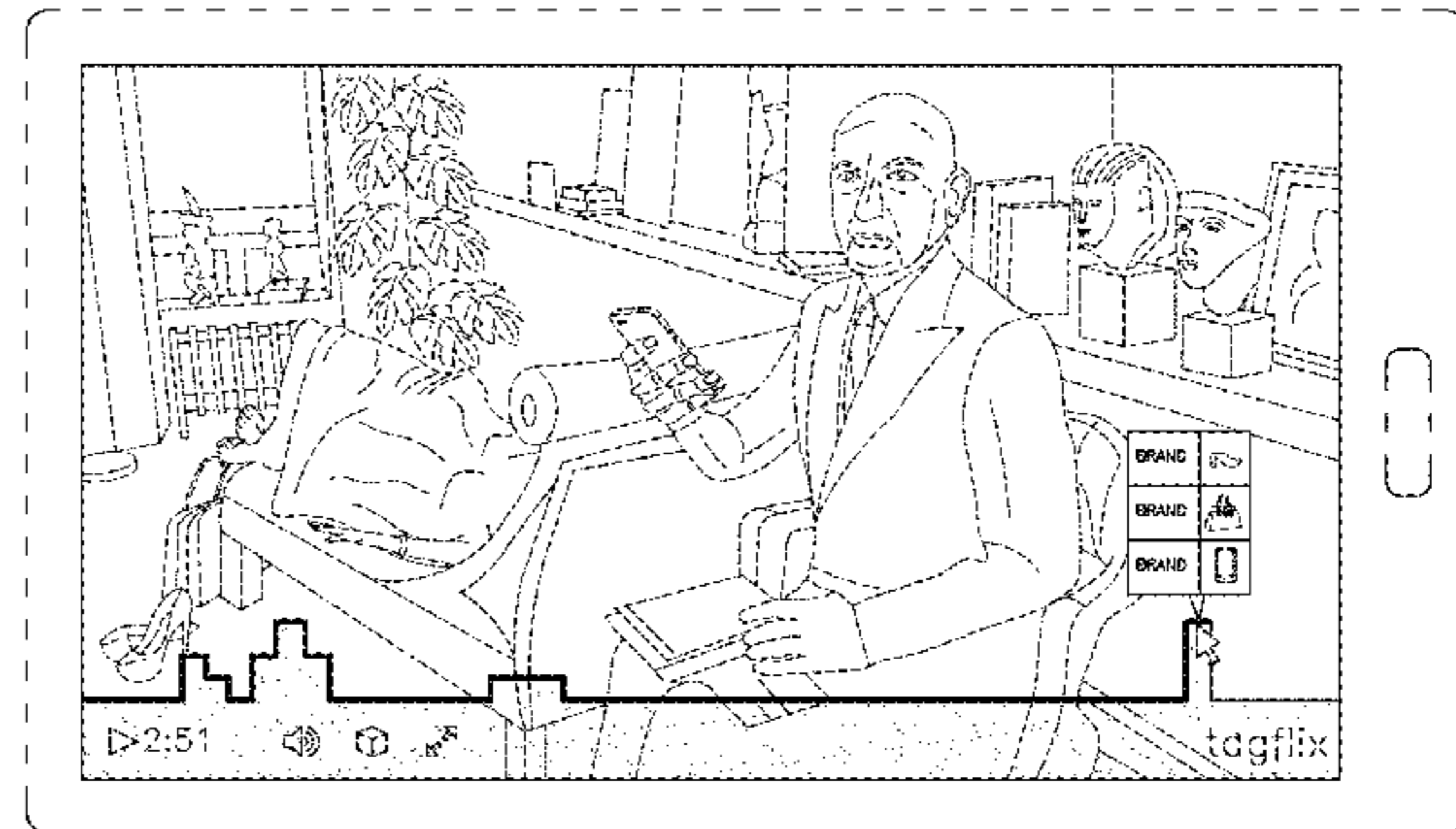
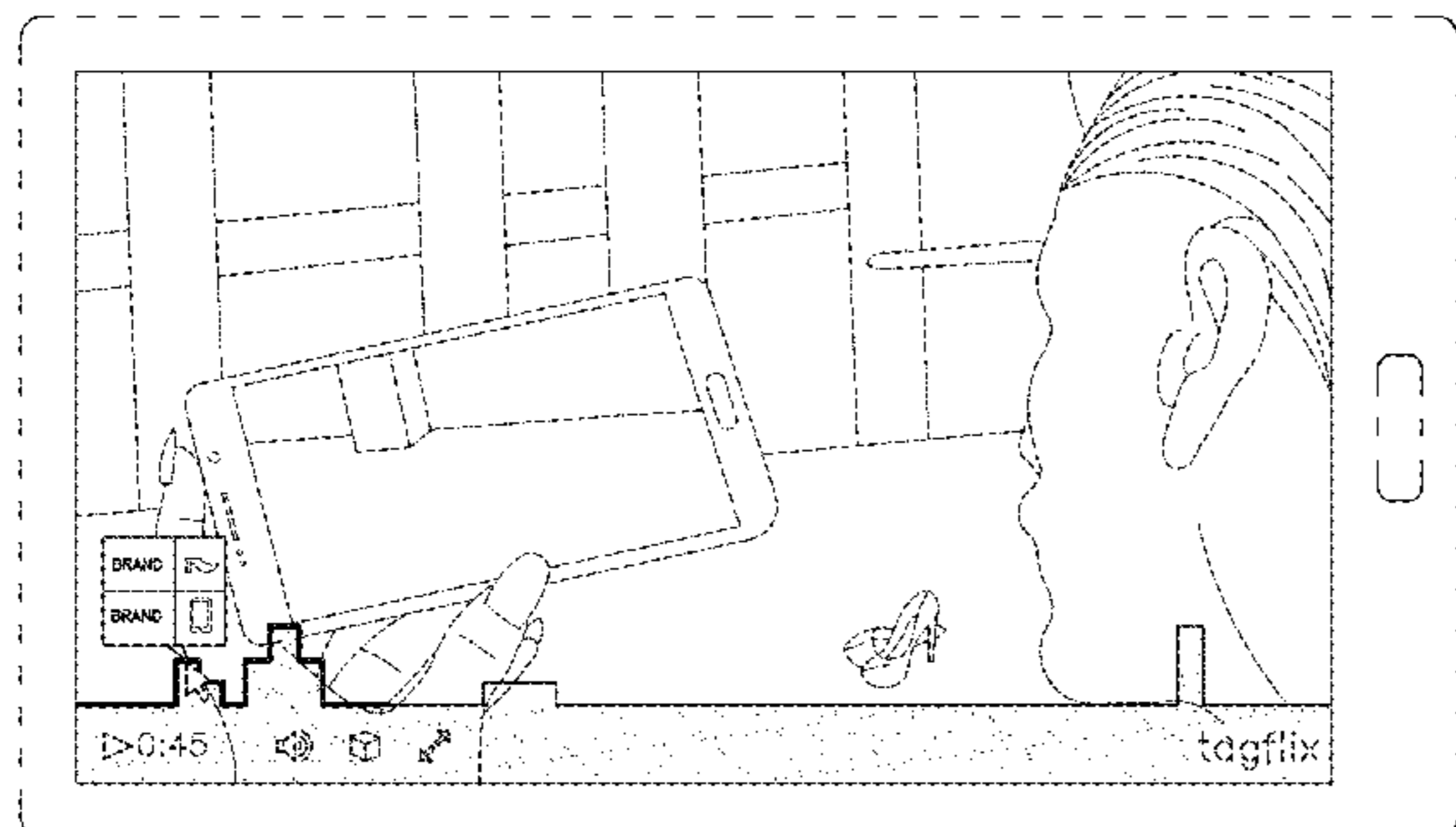
The ornamental design for a display screen with animated graphical user interface for video player, as shown and described.

**DESCRIPTION**

FIG. 1 is a front view of the first image in a sequence for a display screen with animated graphical user interface for video player;

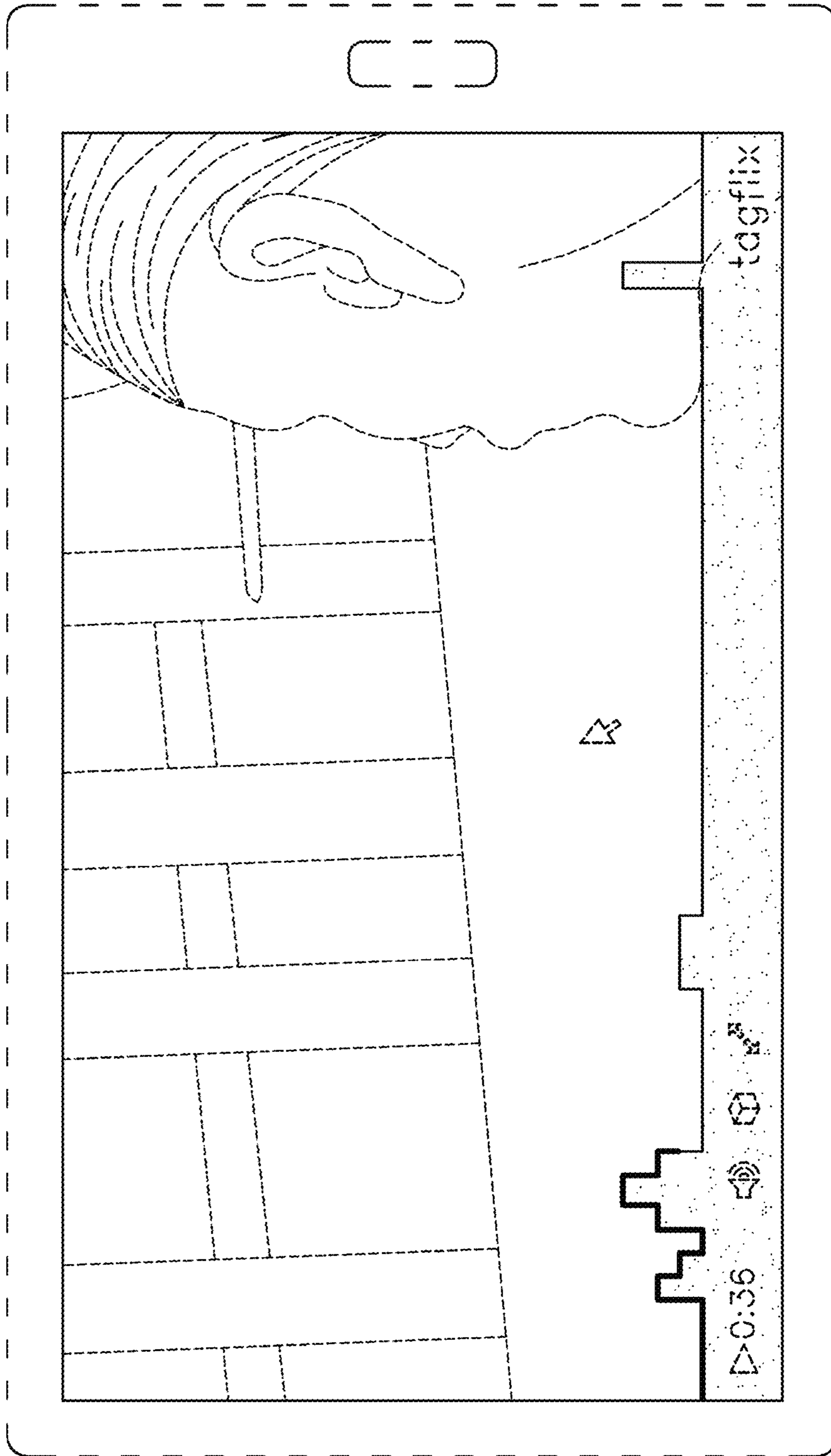

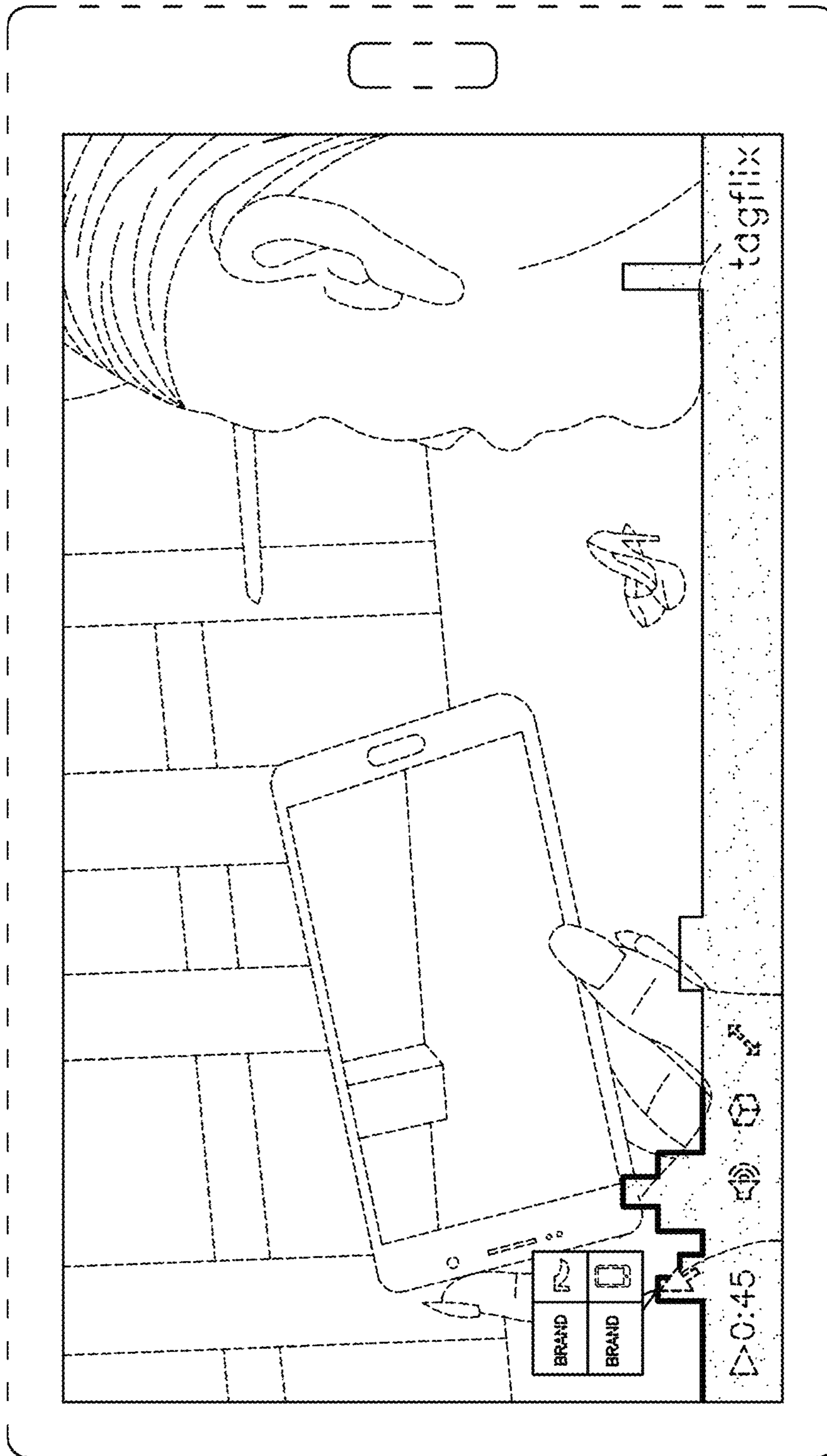

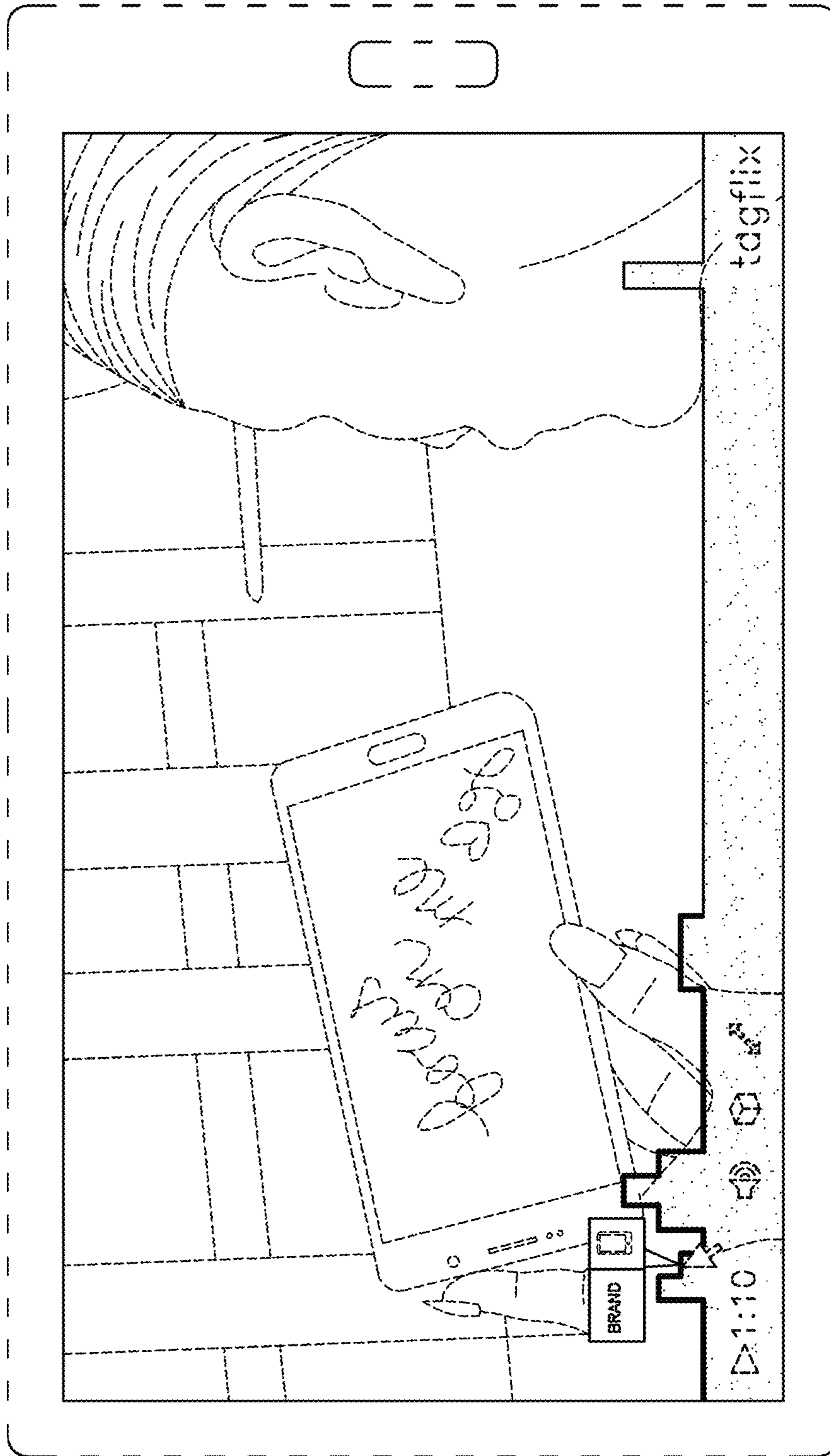

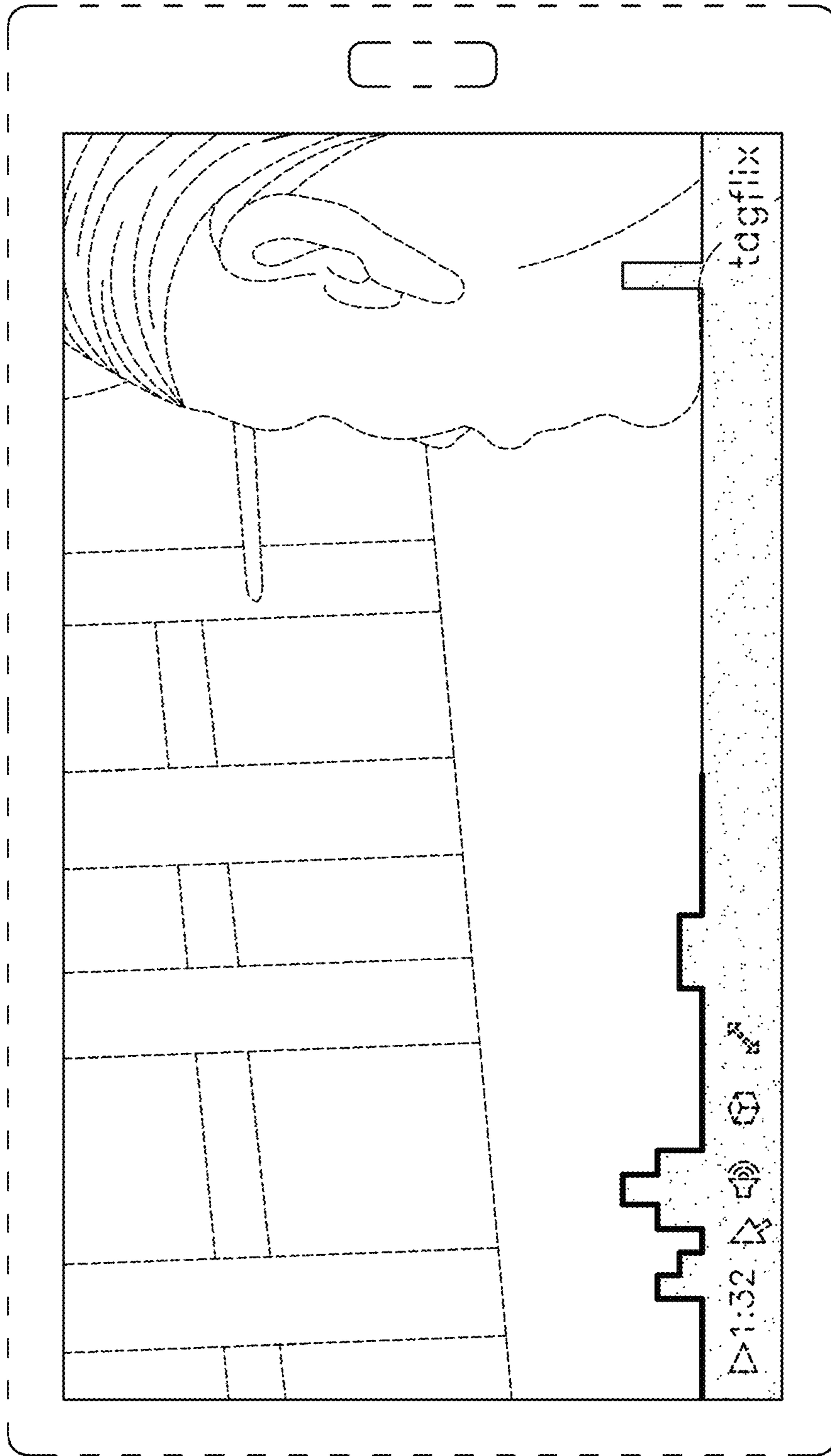

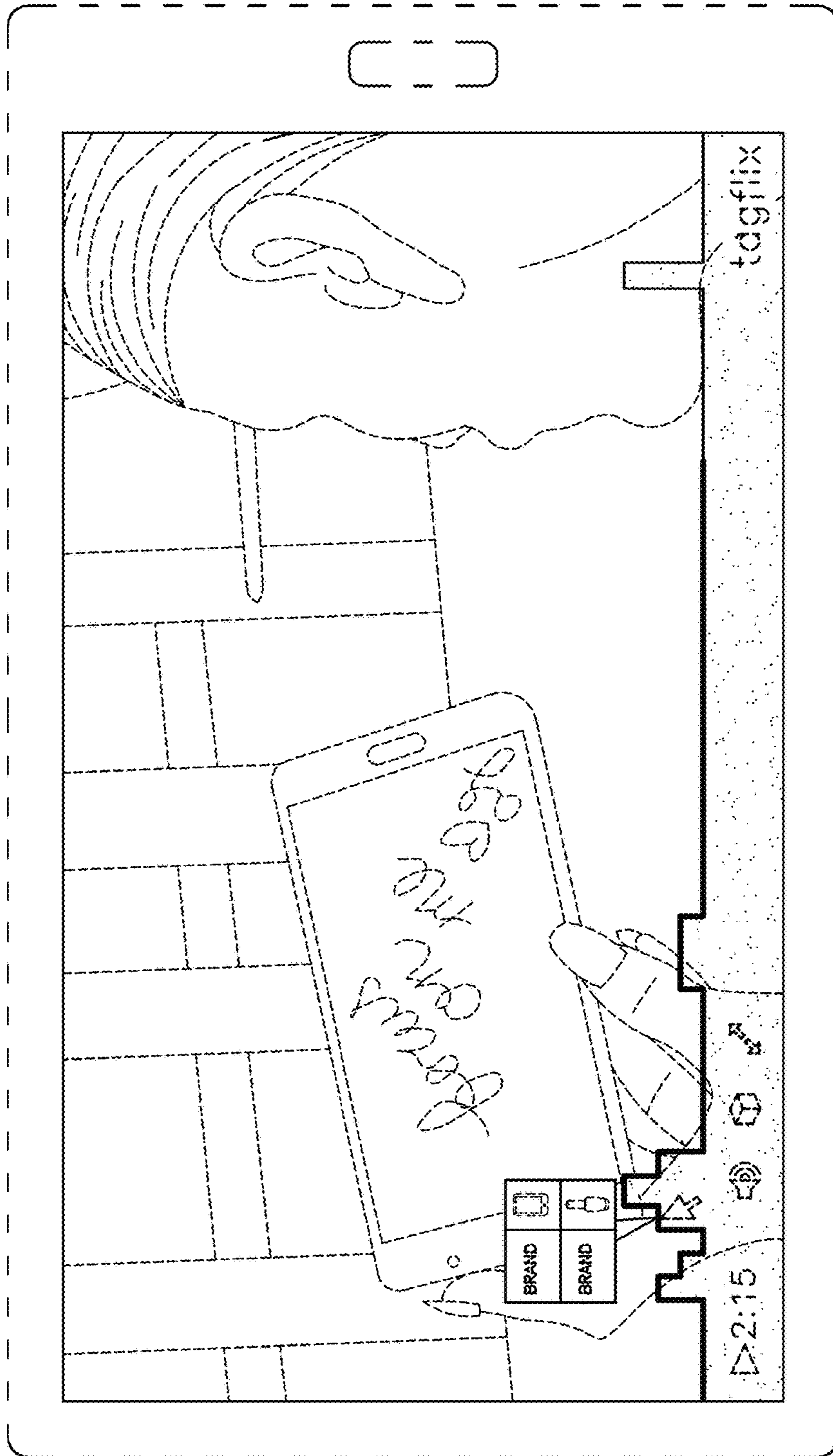

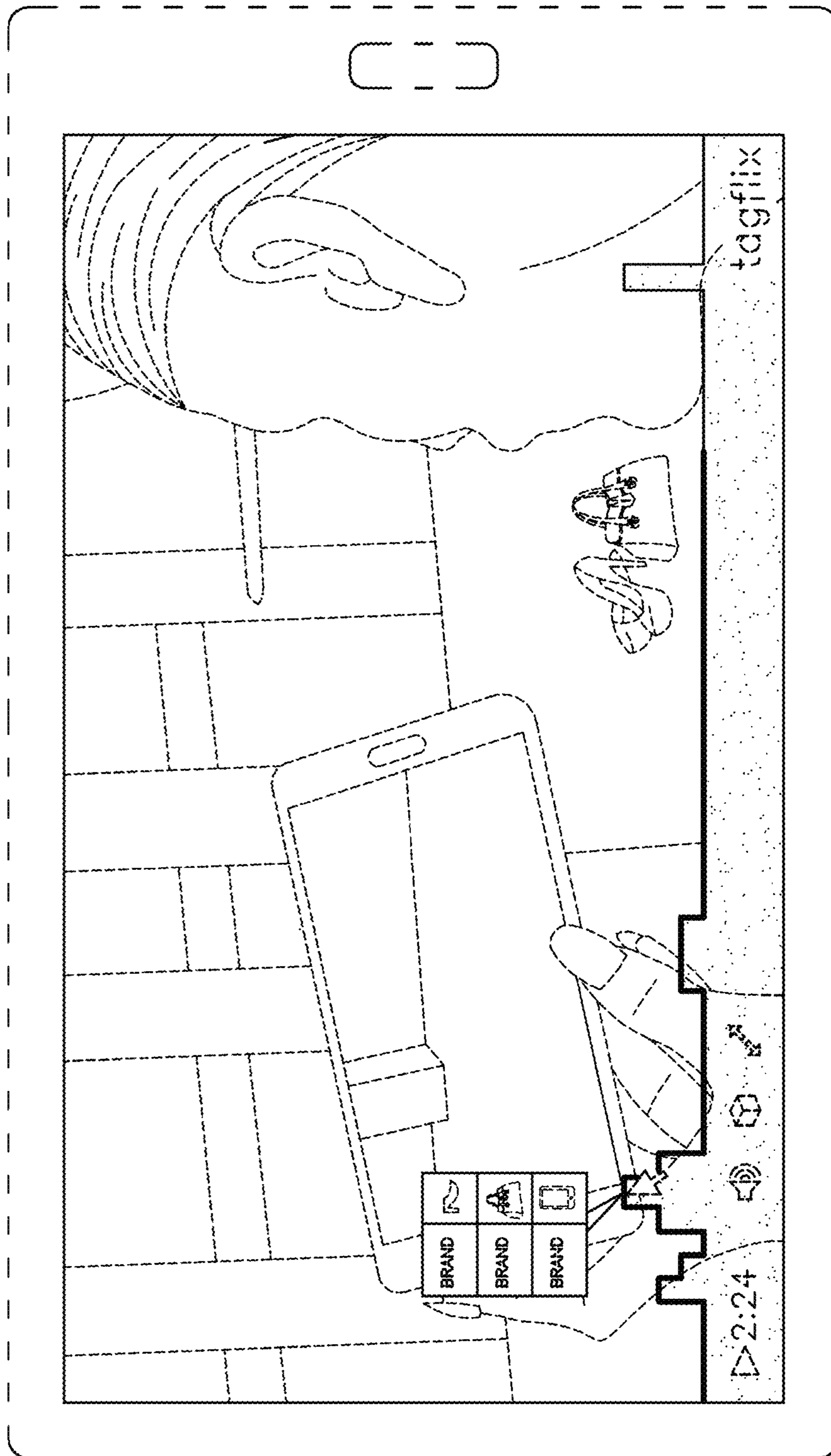

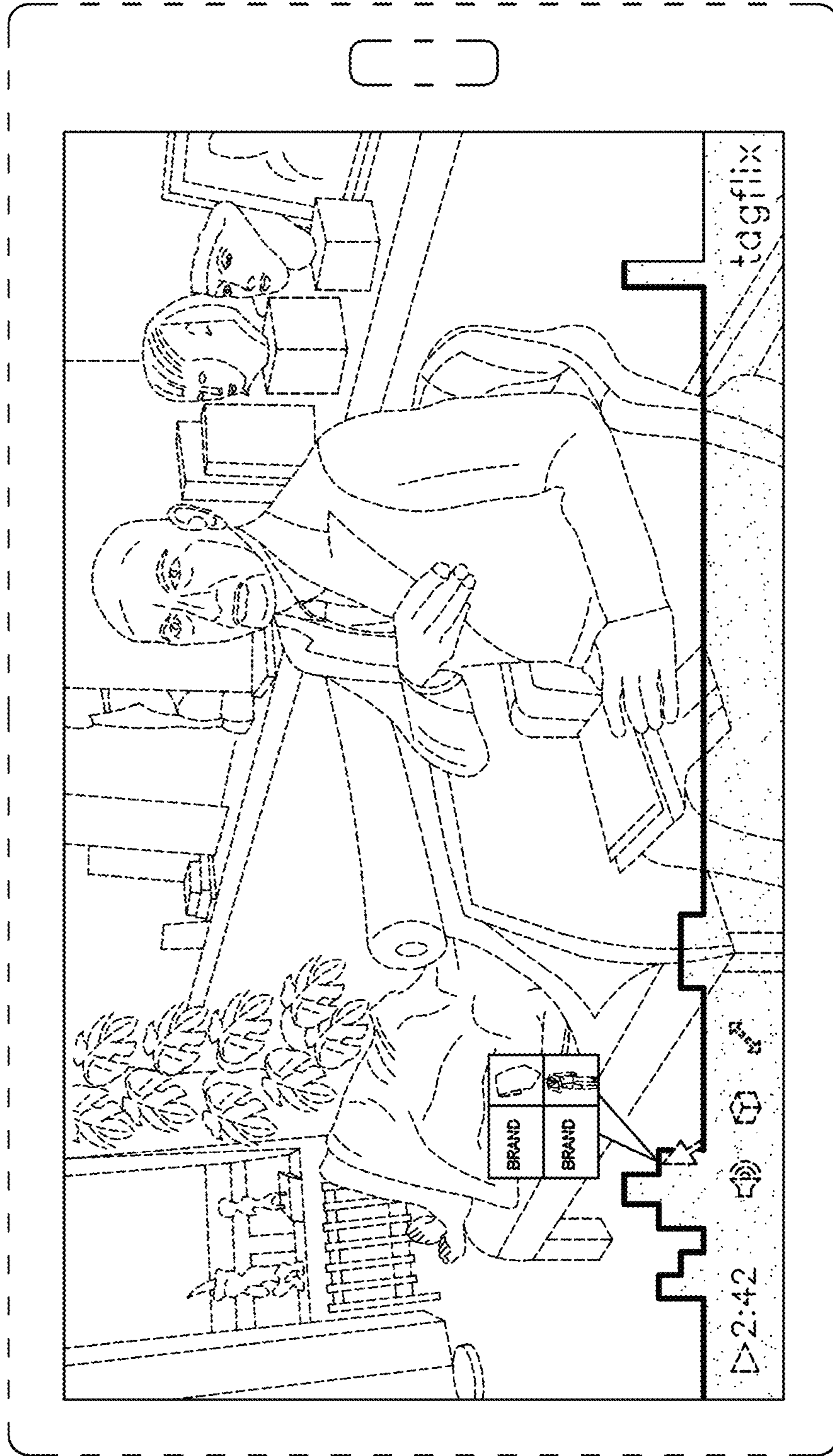

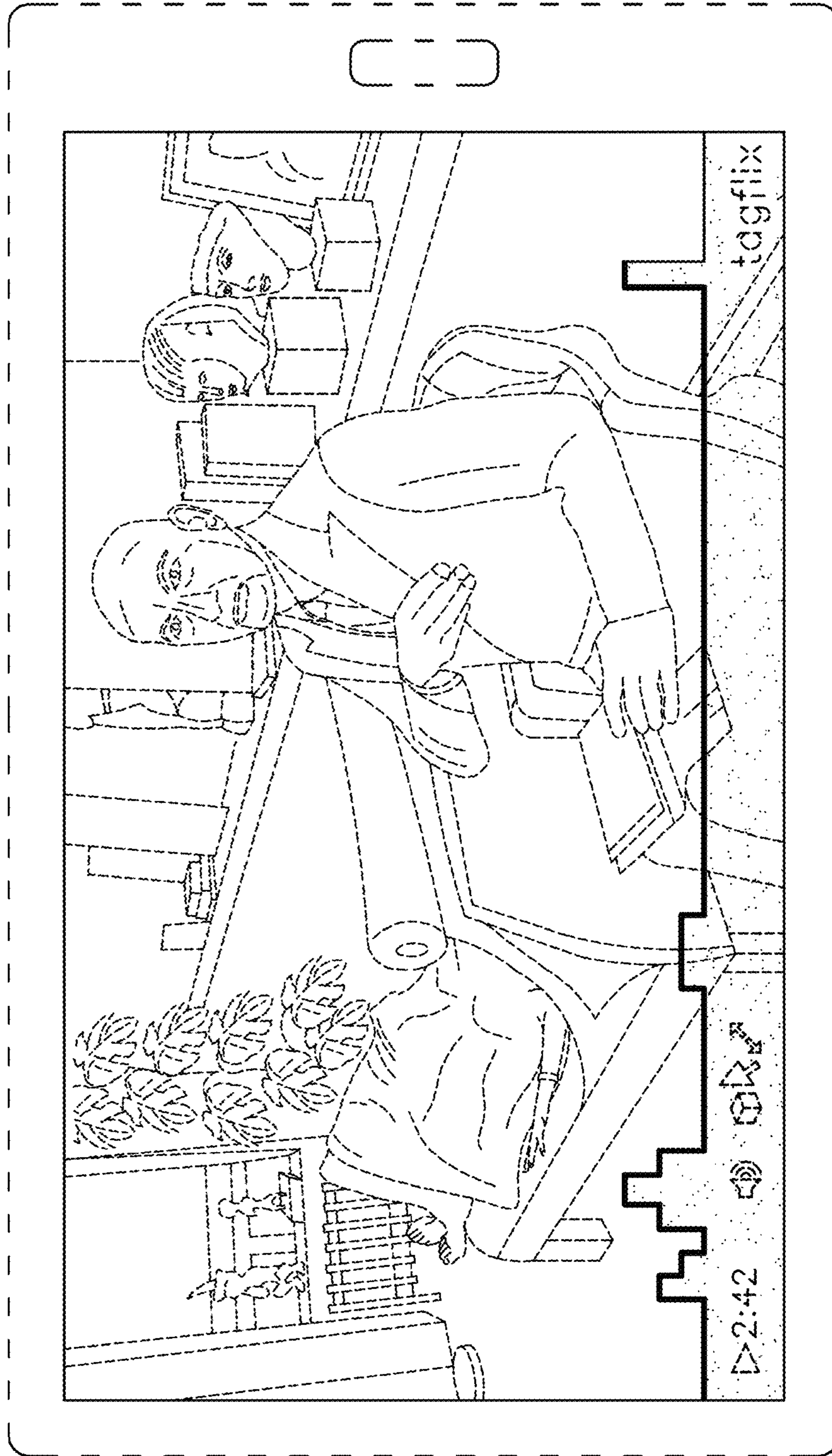

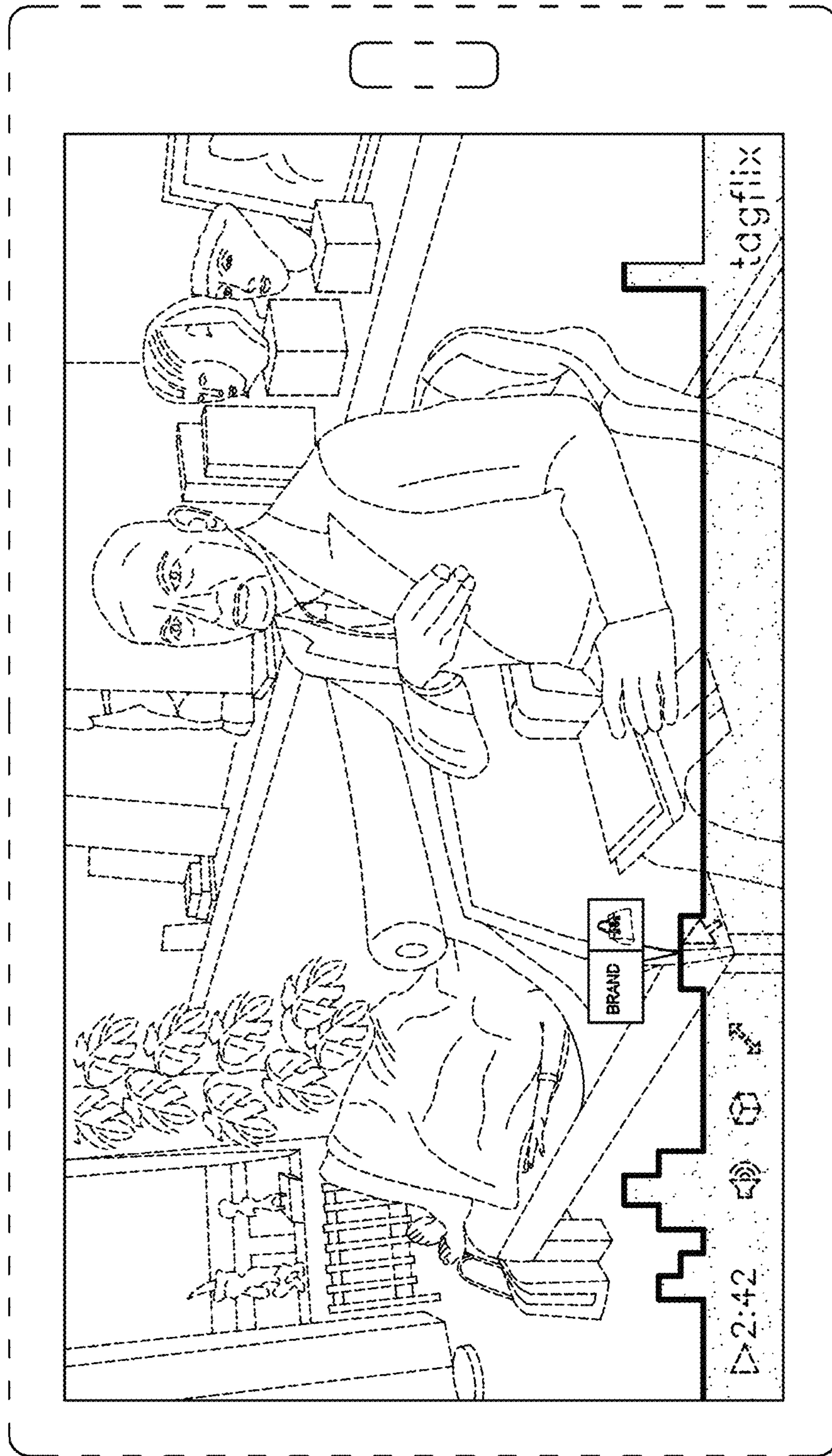

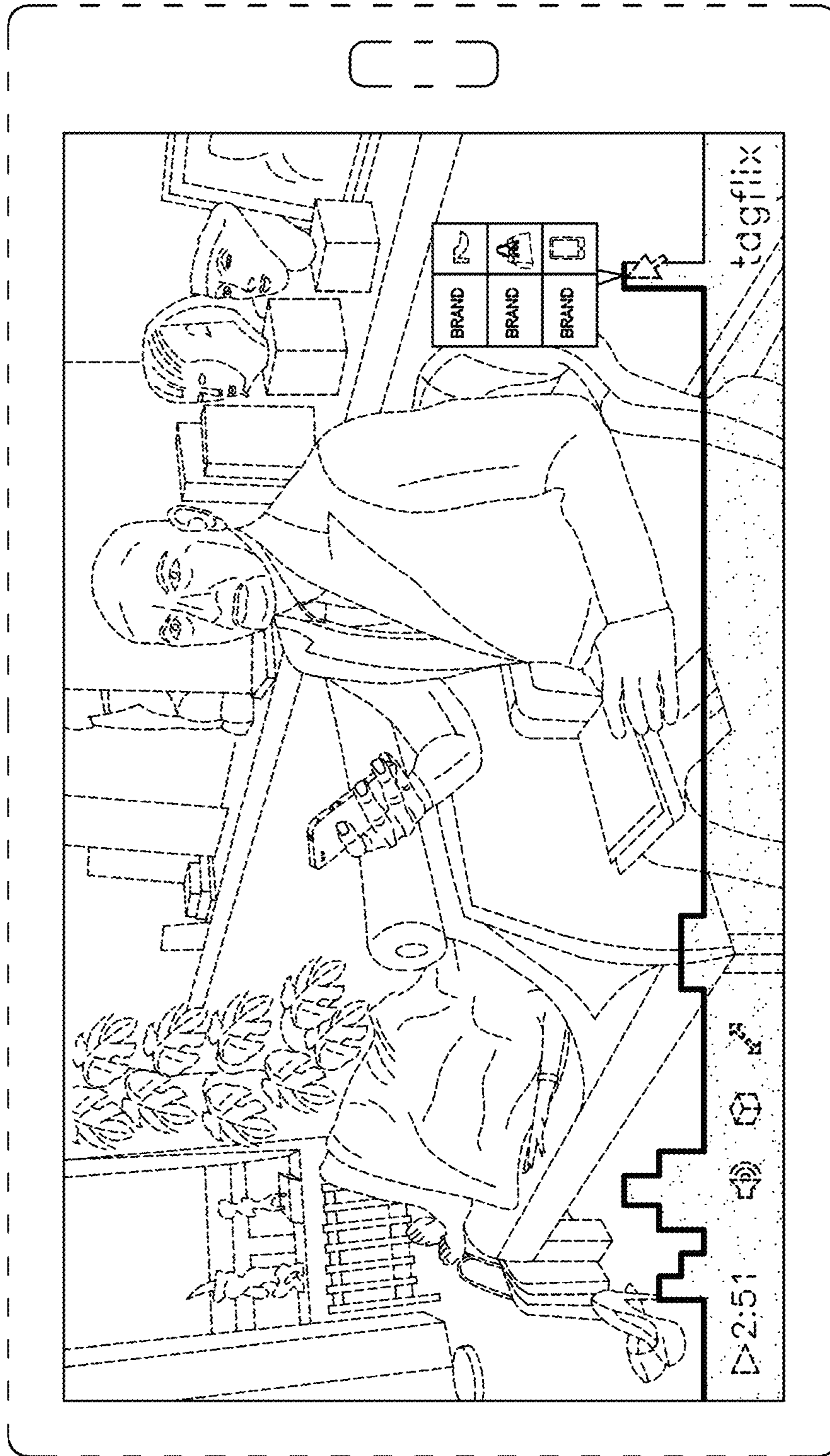
