DESCRIPTION

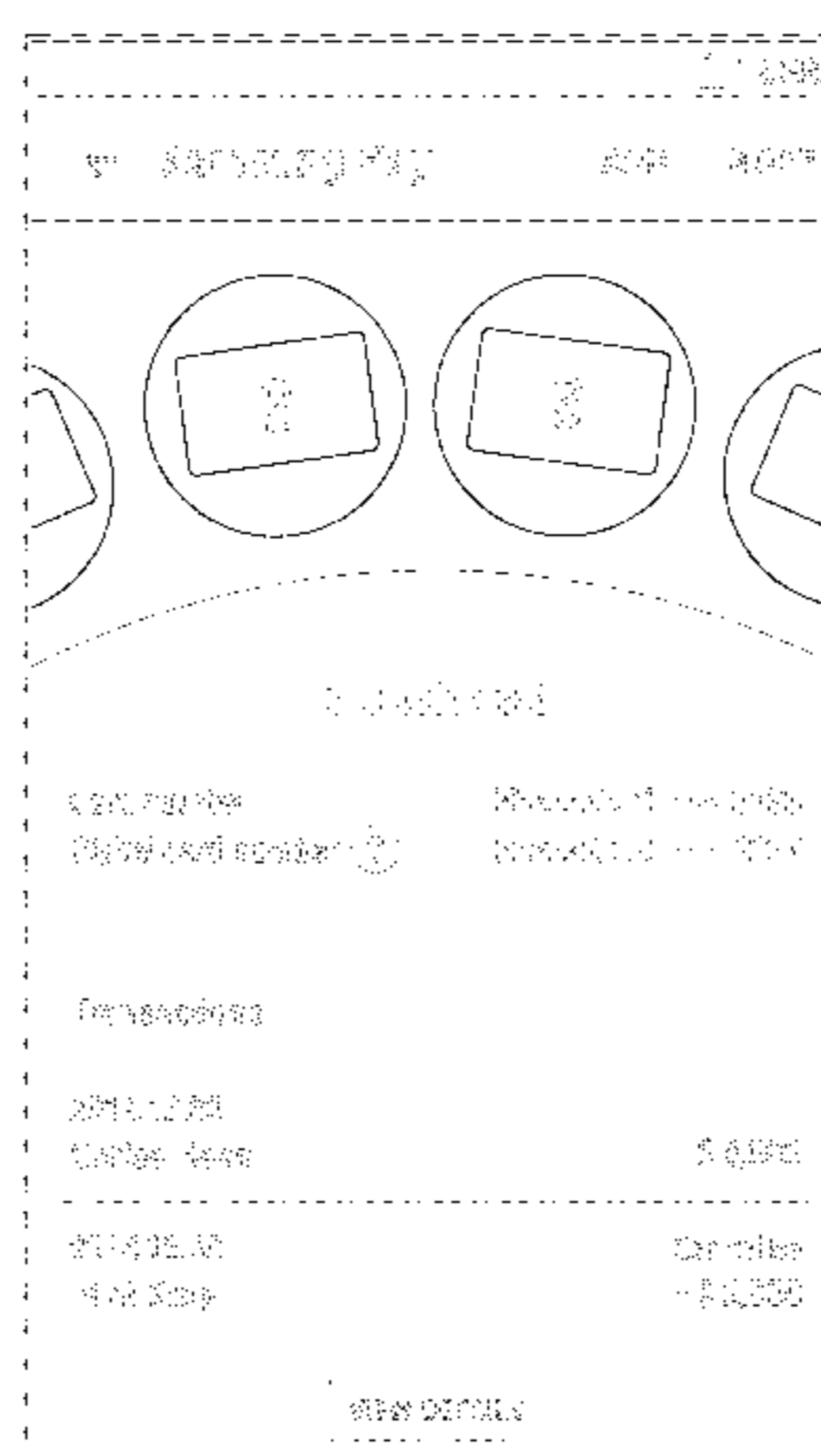
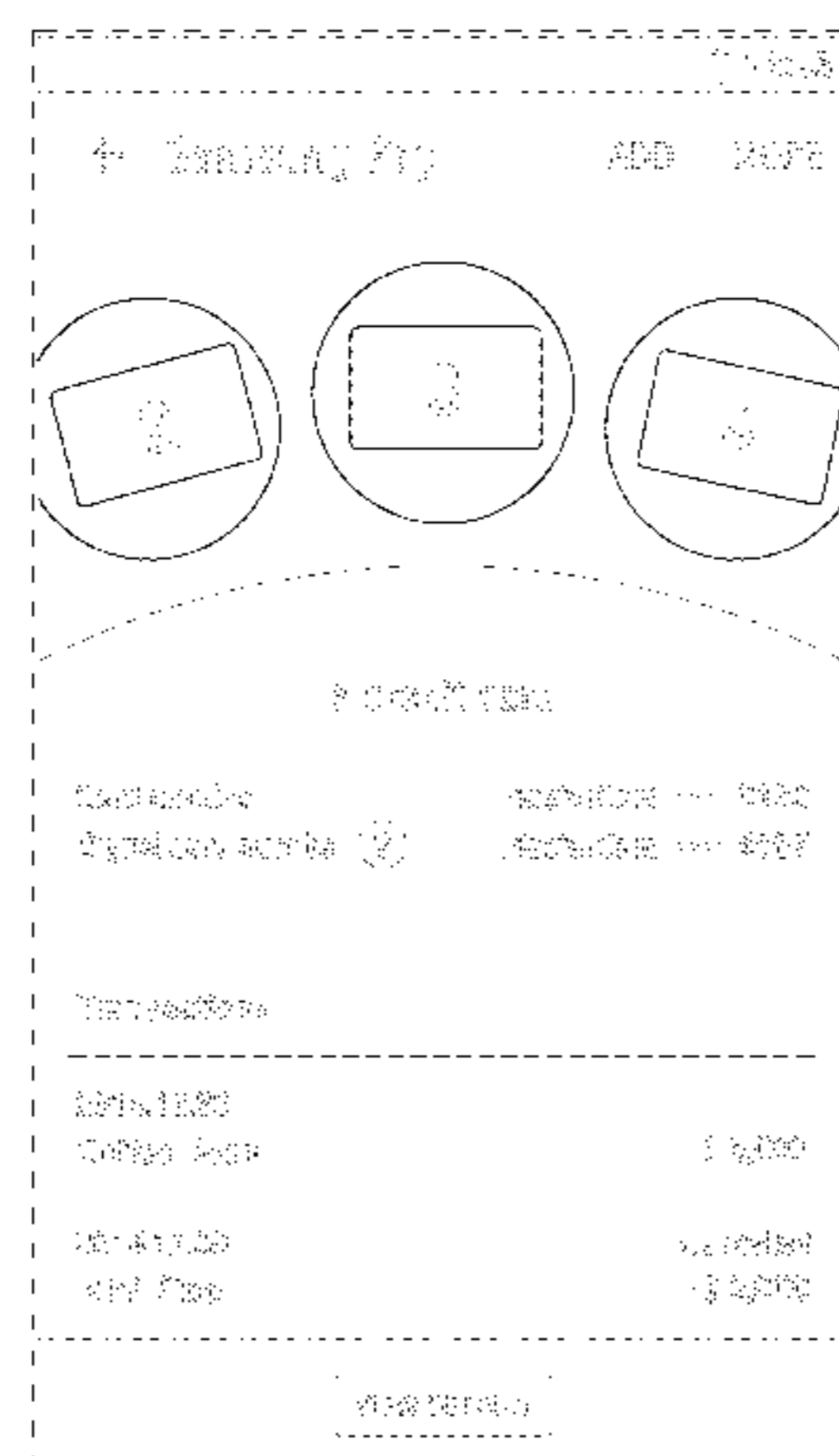
FIG. 1 is a first image in a sequence for a display screen or portion thereof with transitional graphical user interface, showing our new design;

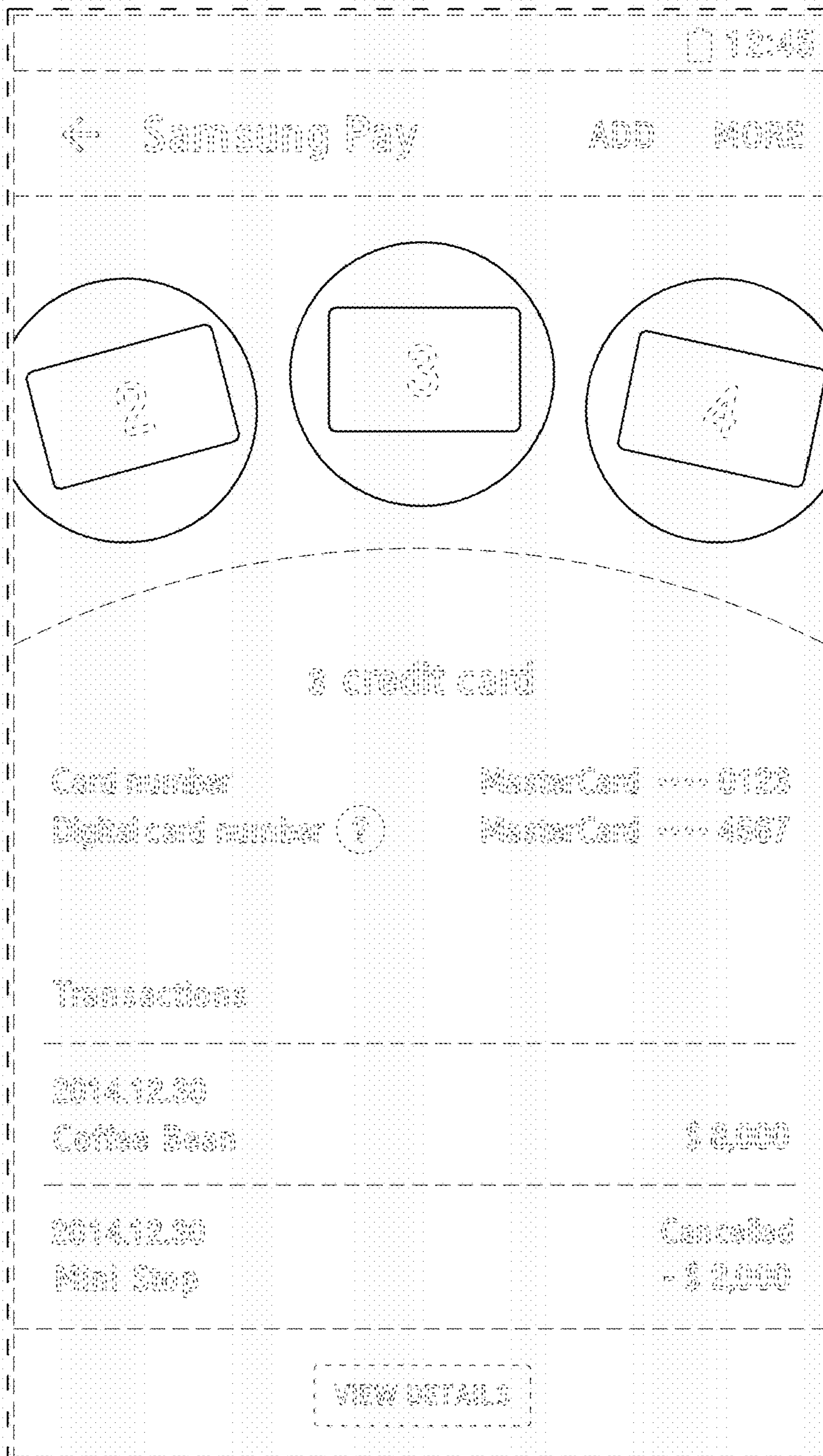

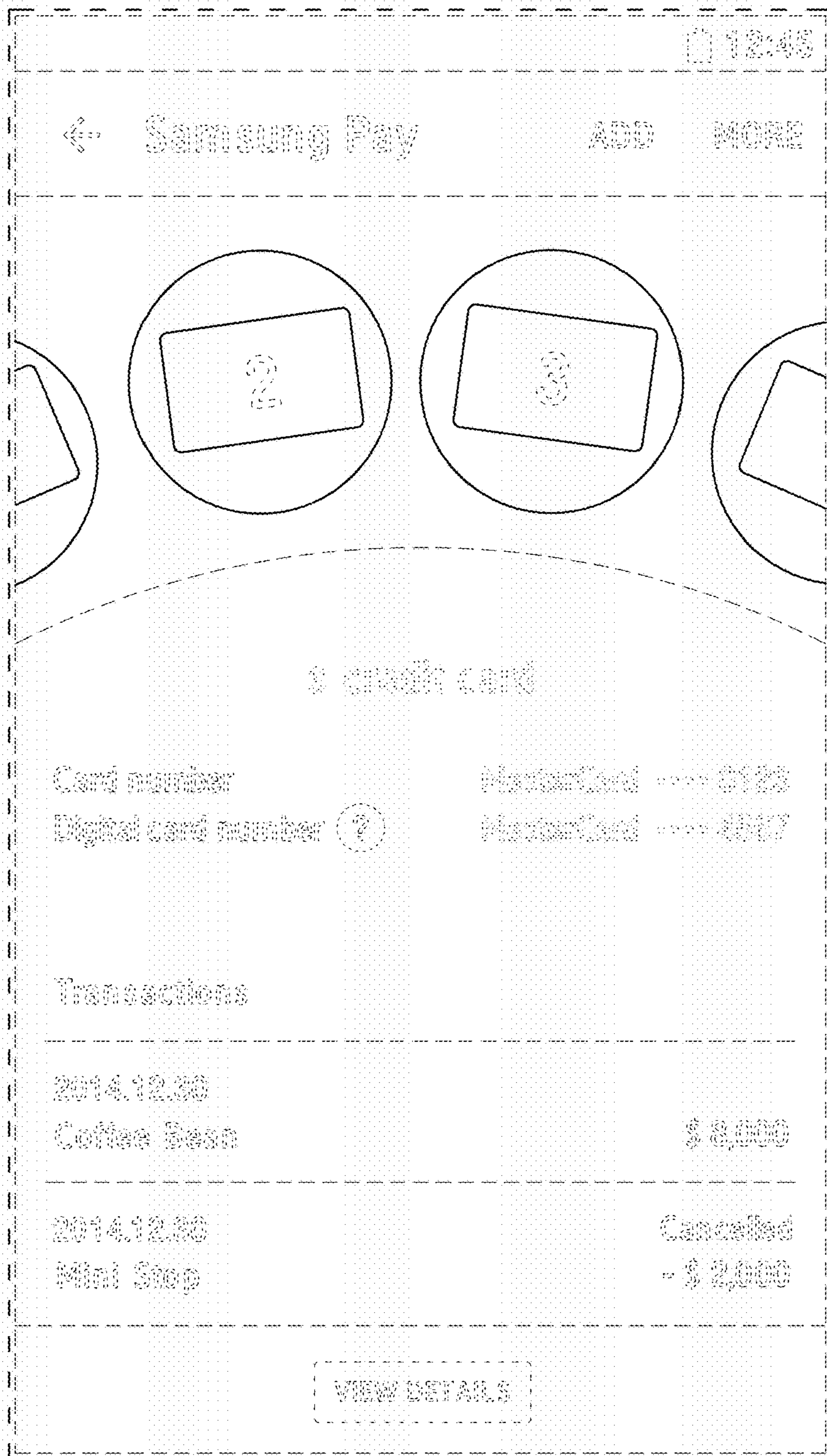
