I claim the ornamental design for a sink, as shown and described.

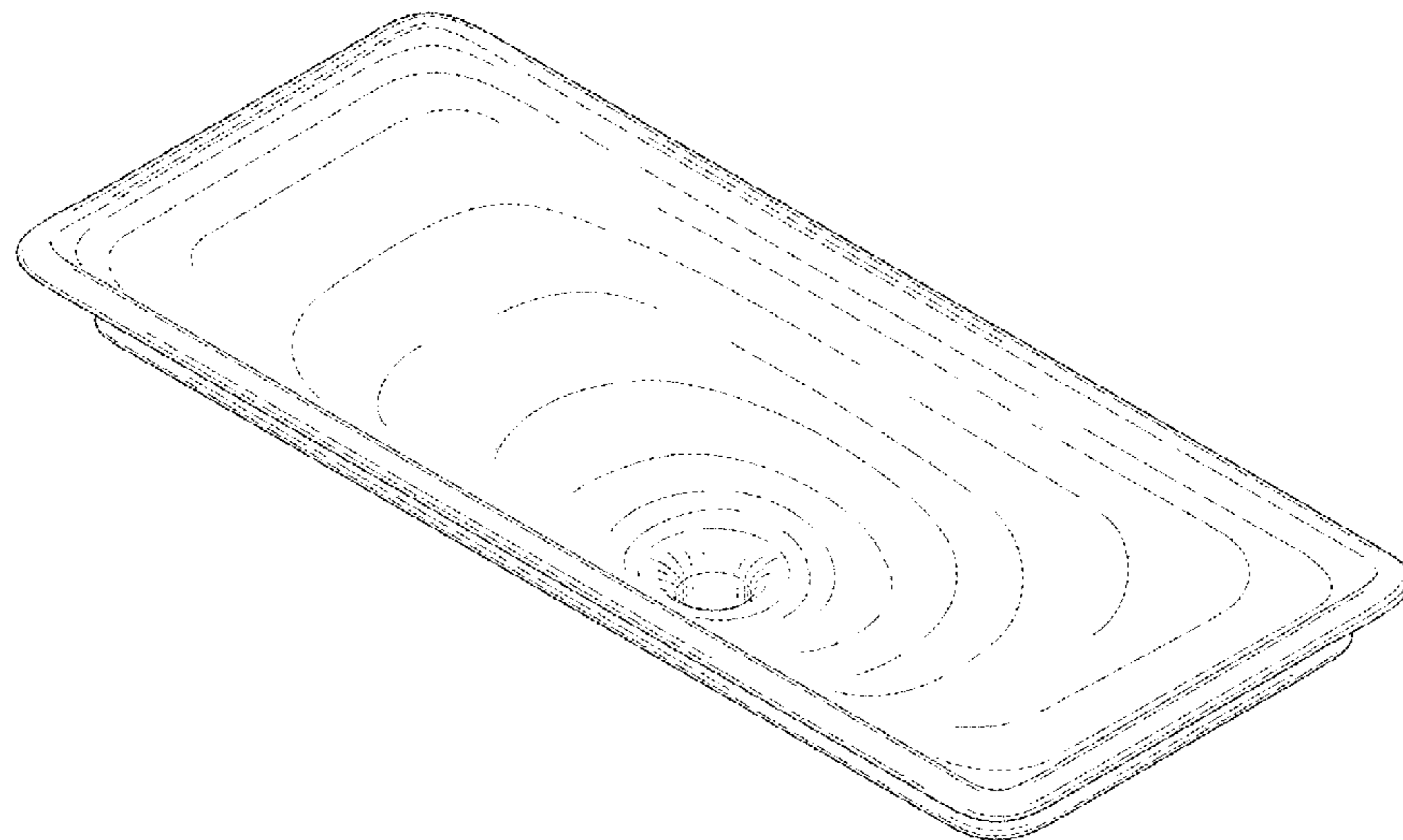
**DESCRIPTION**

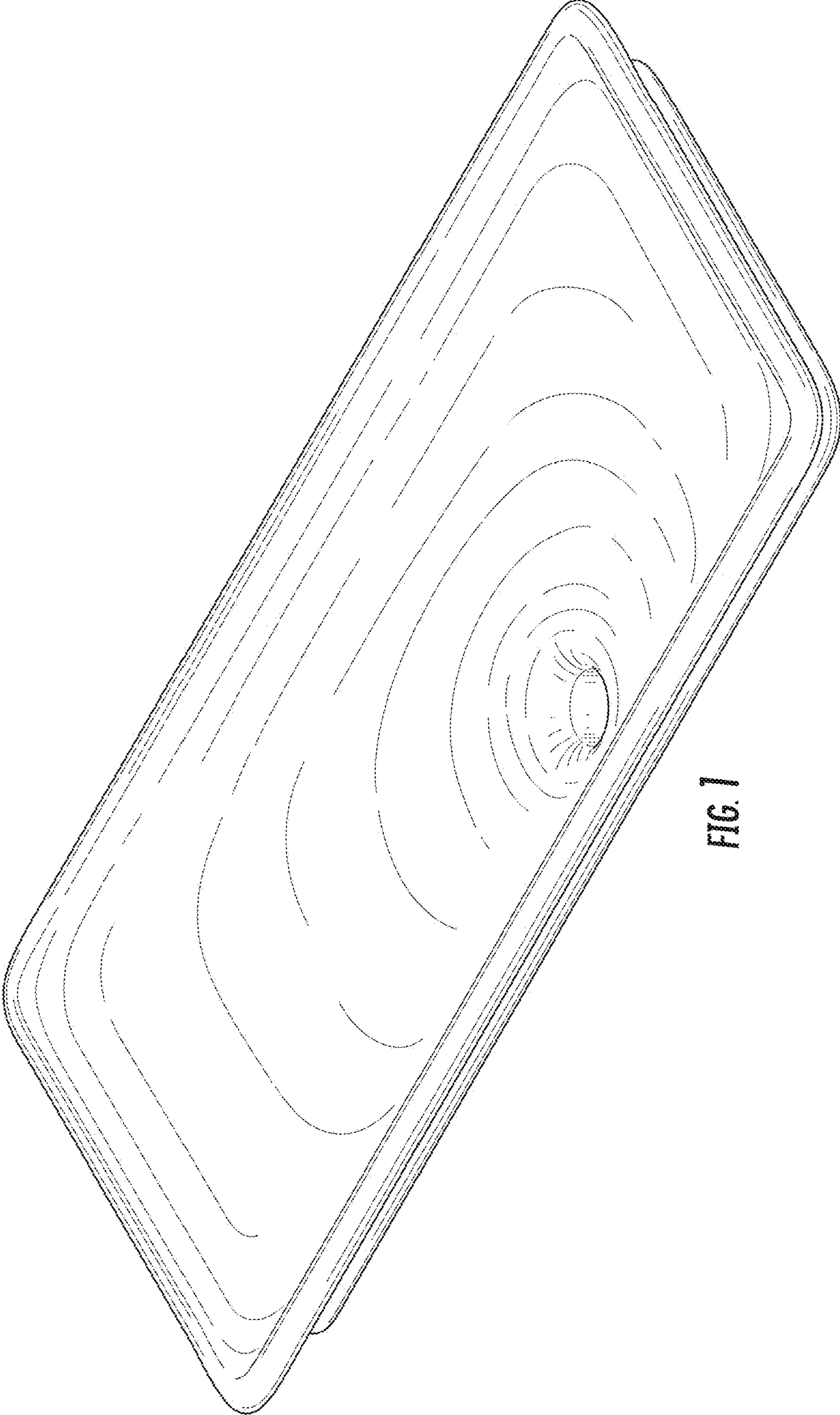

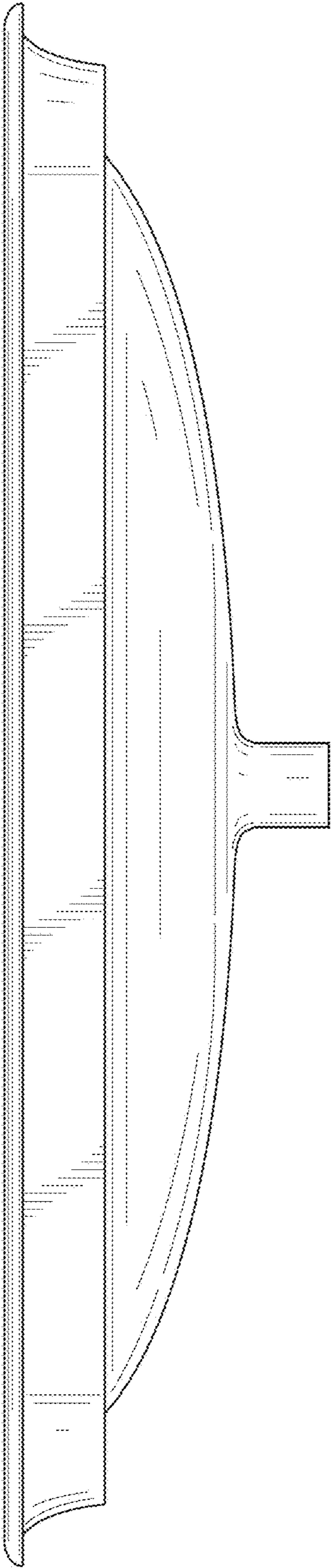

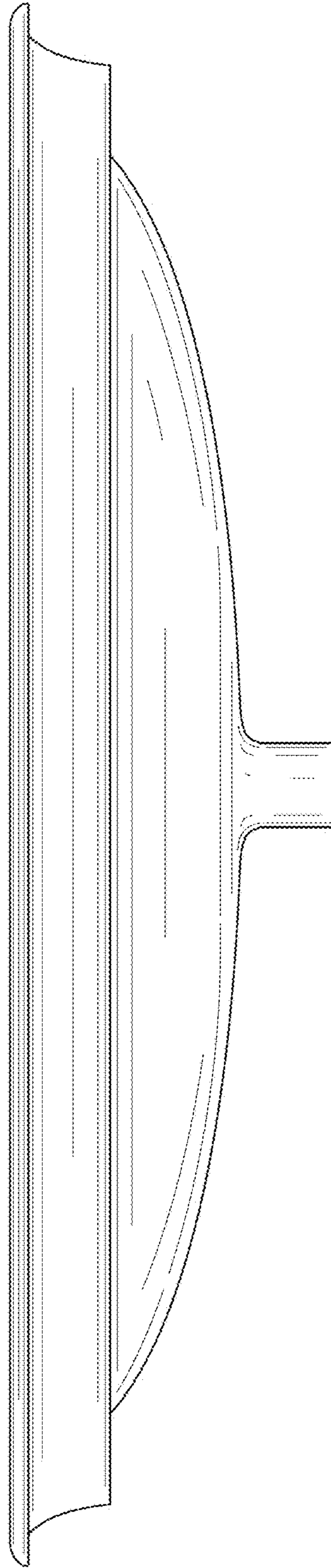

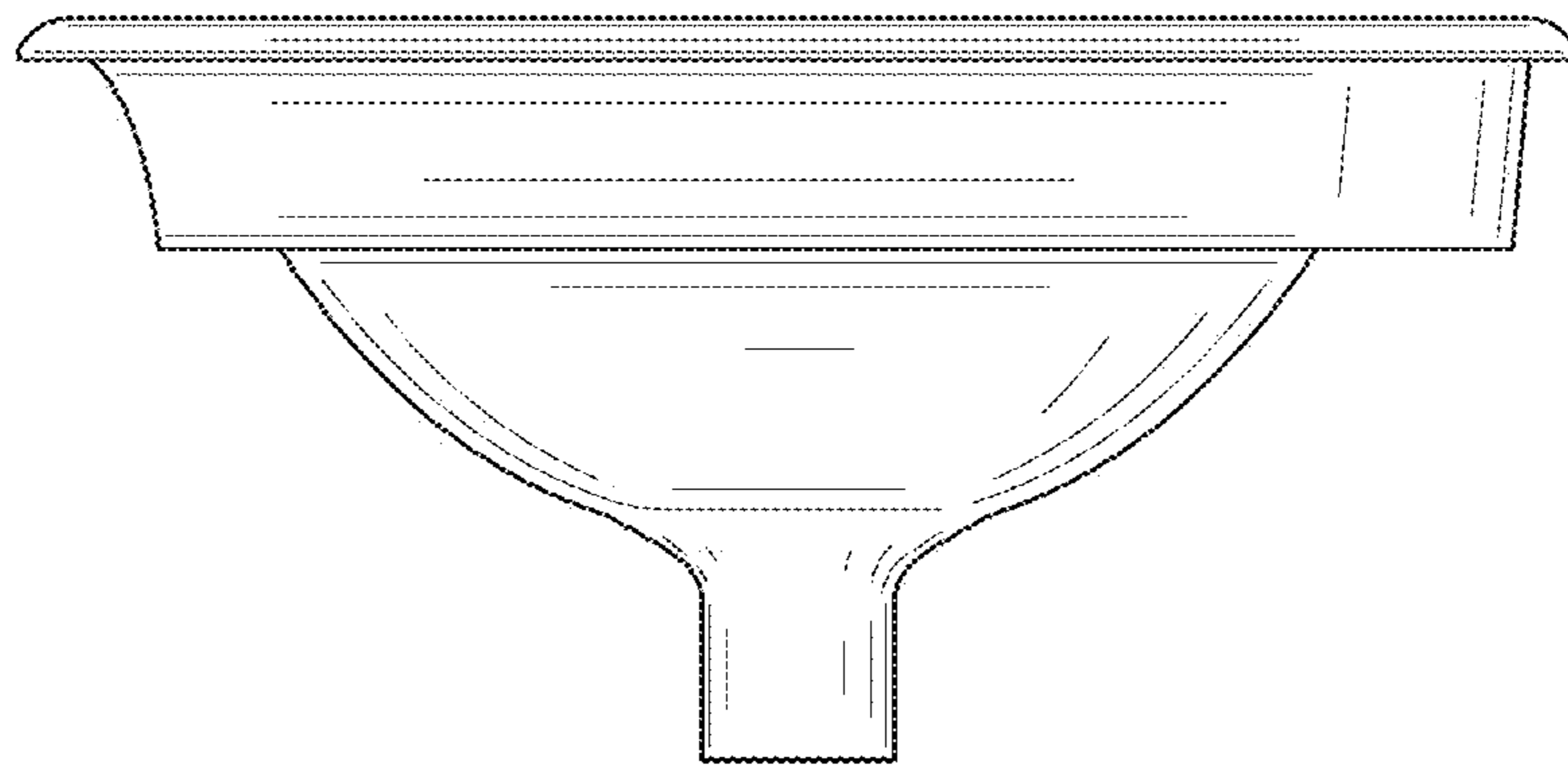

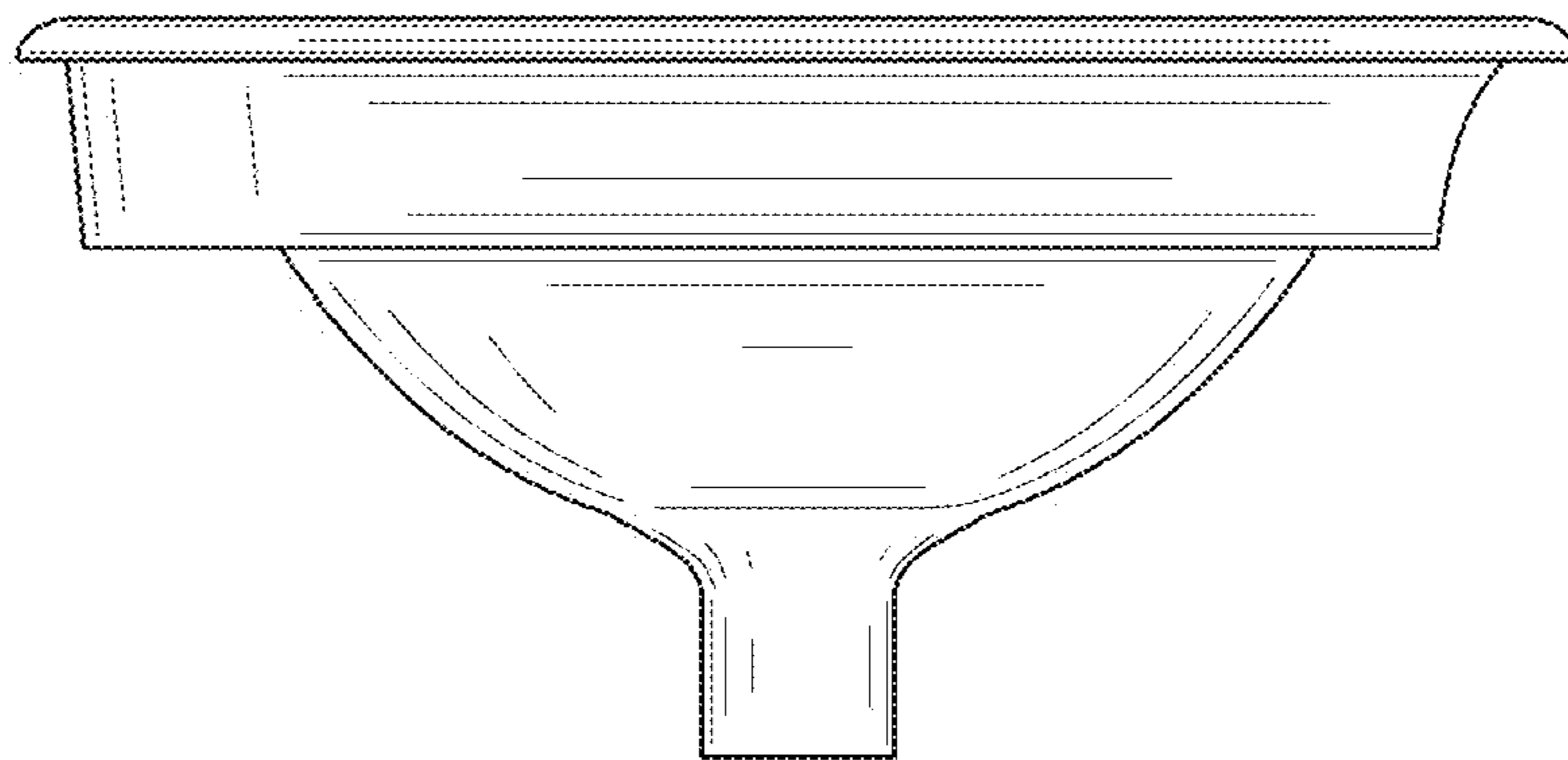

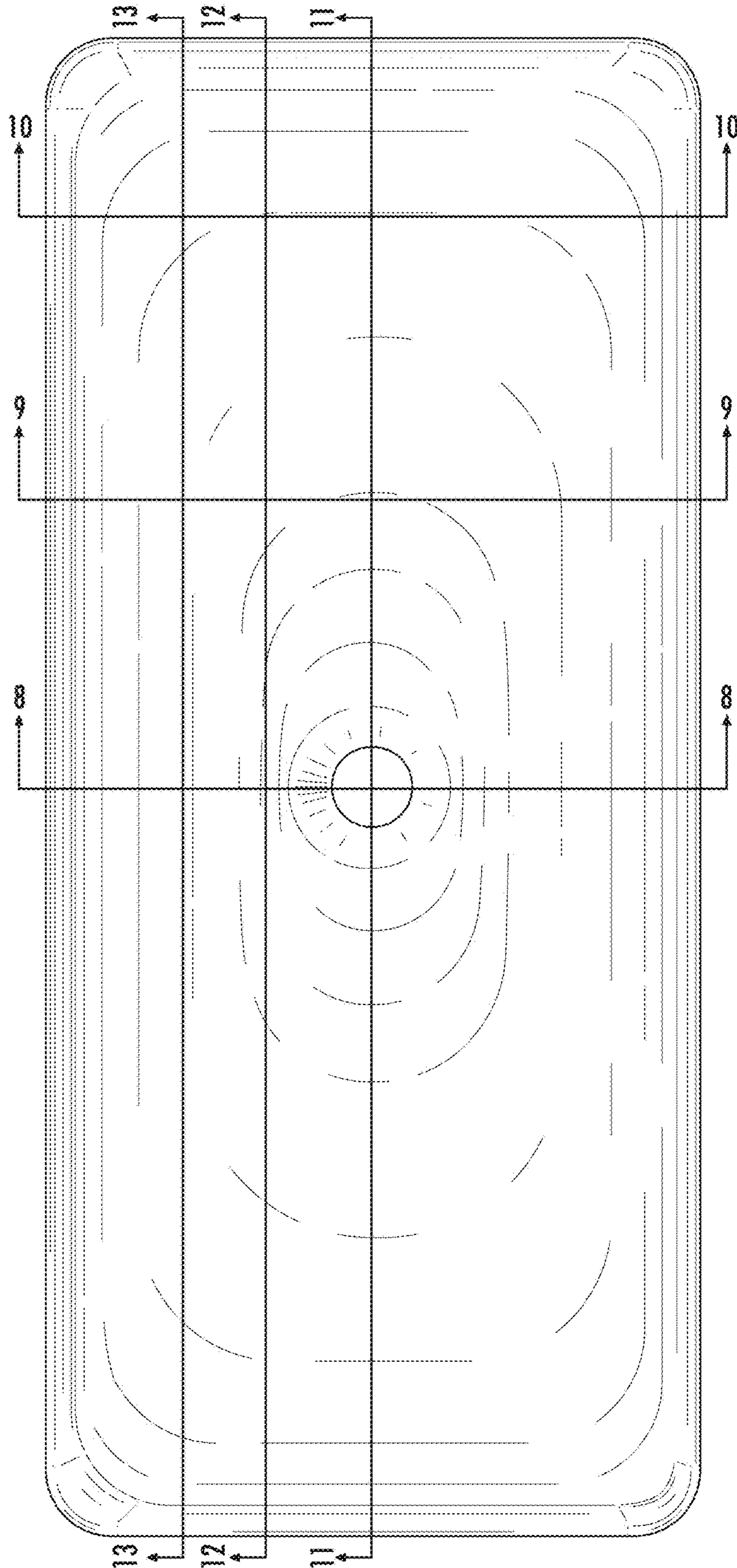

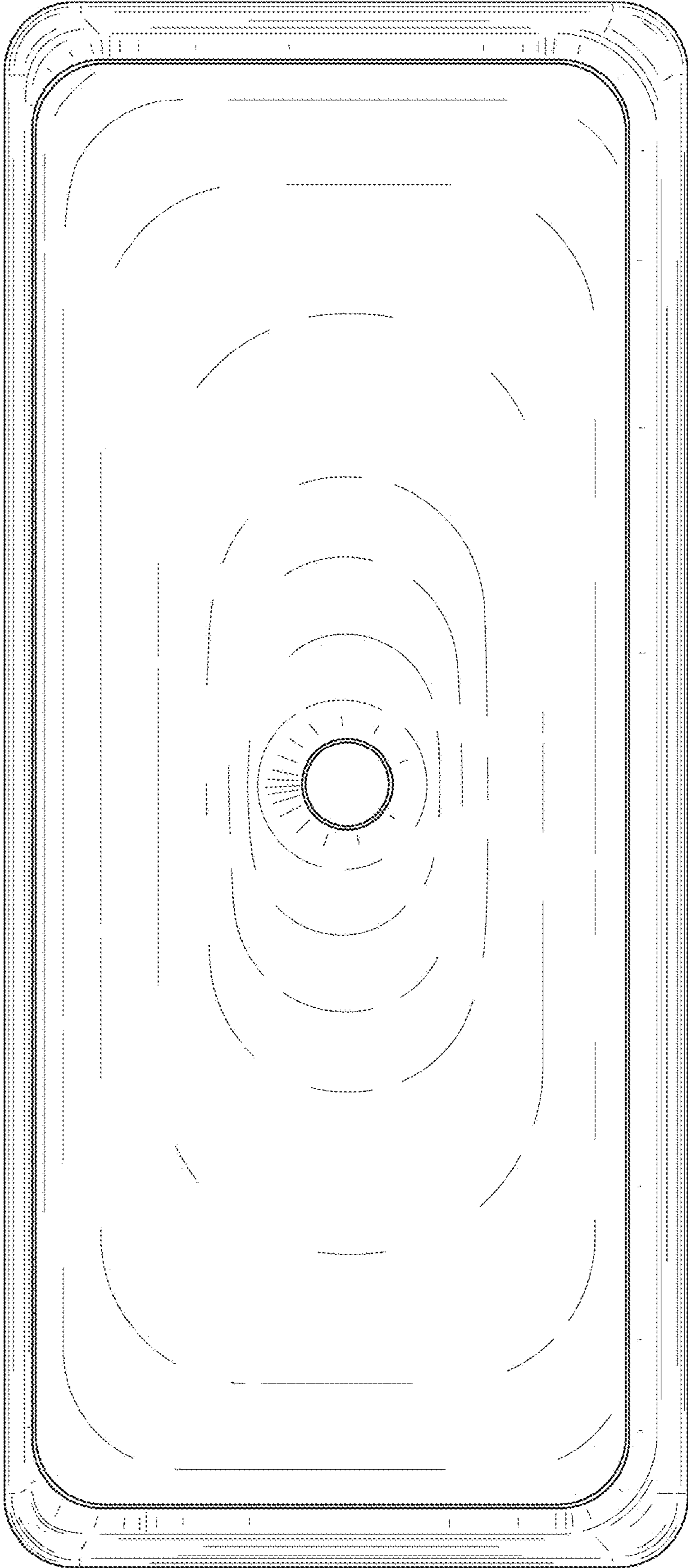

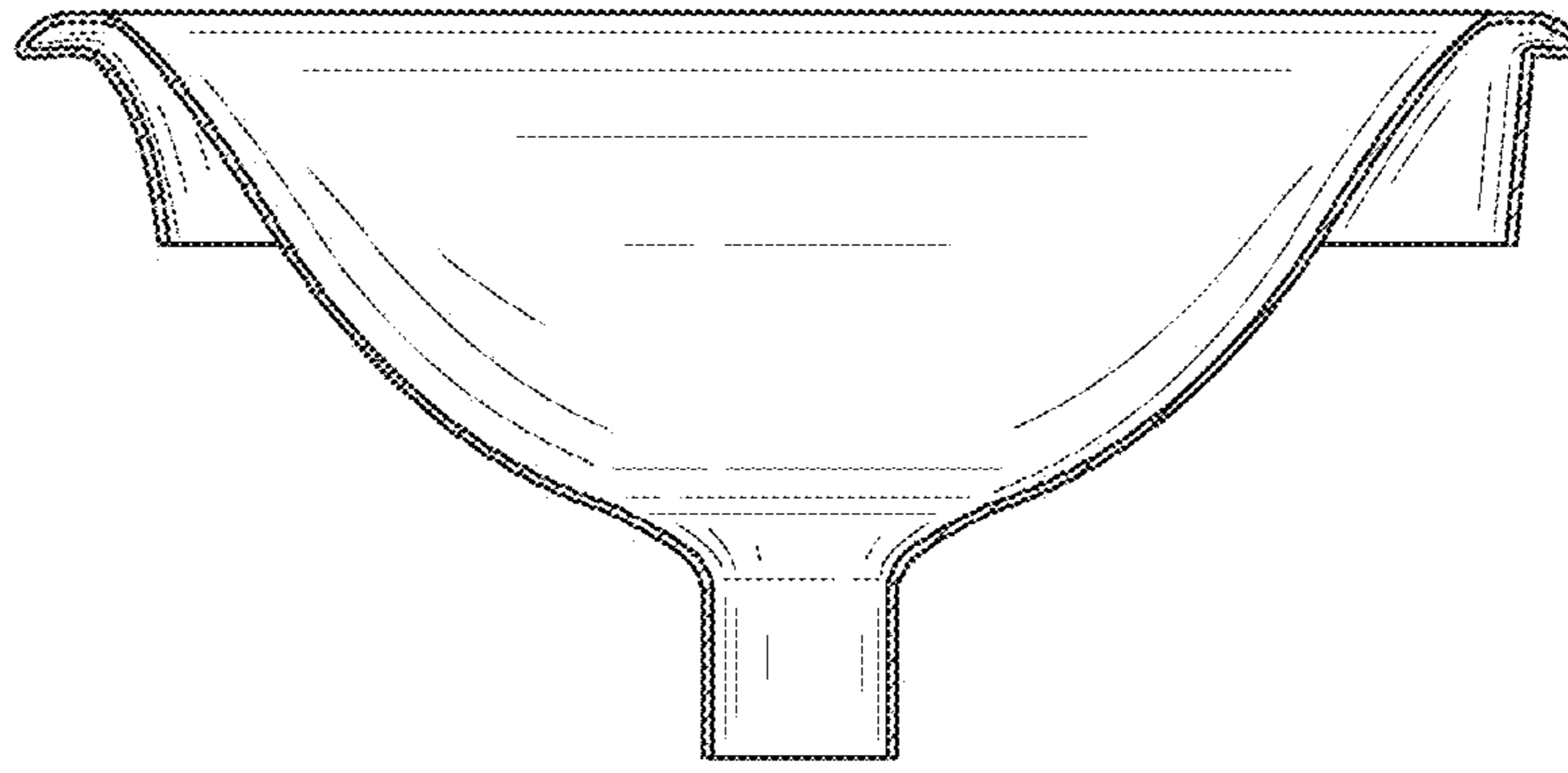

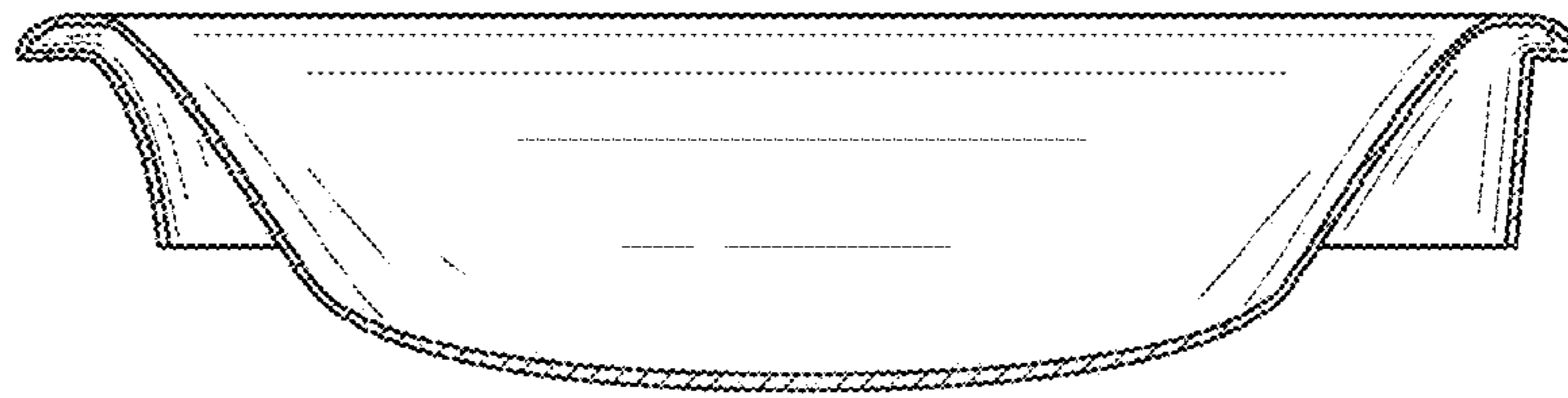

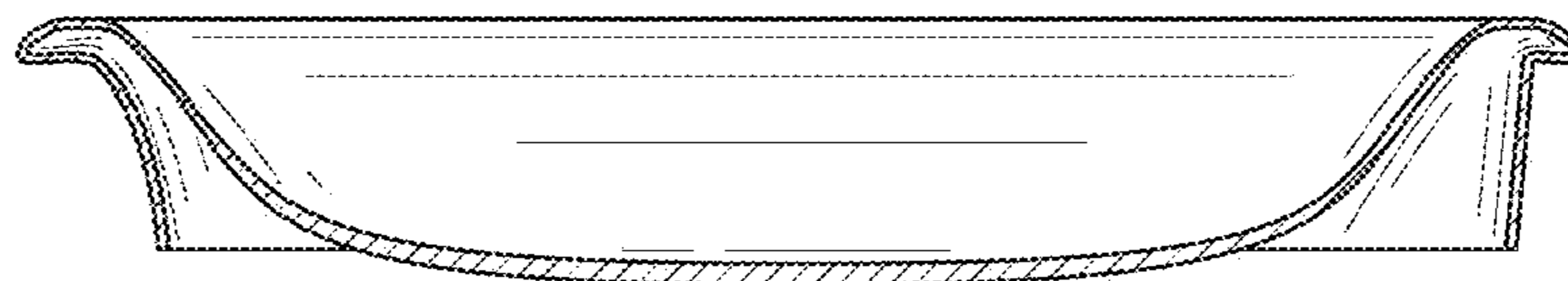

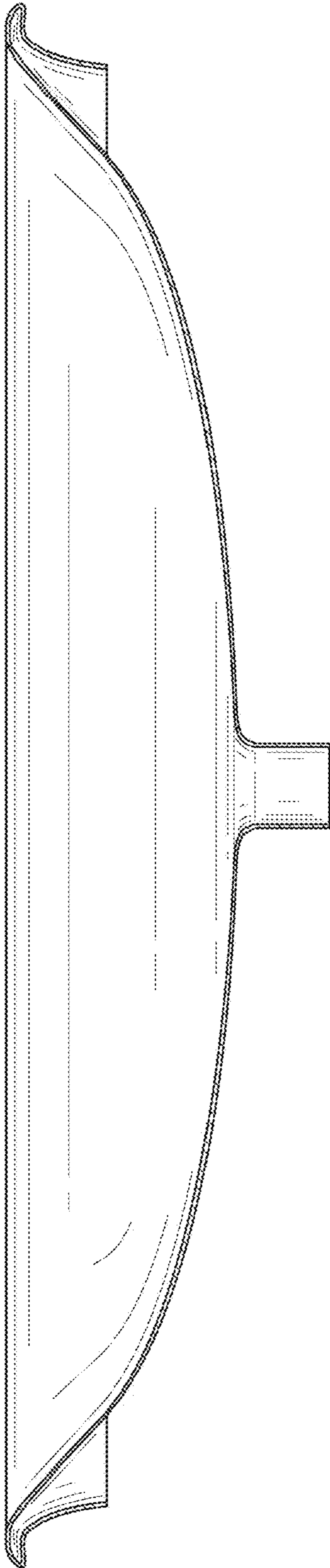

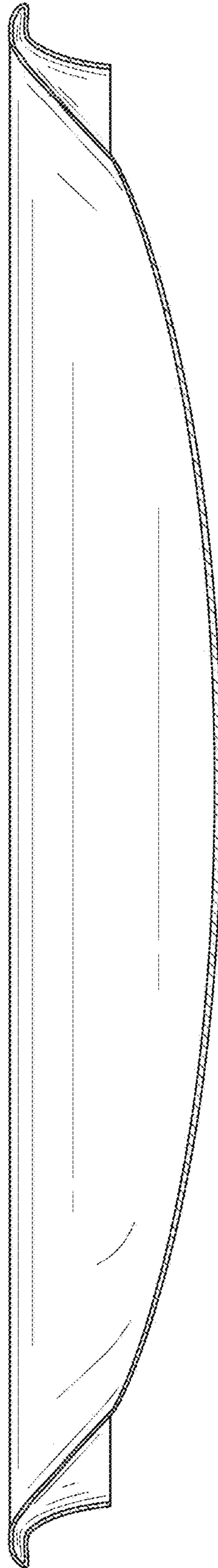

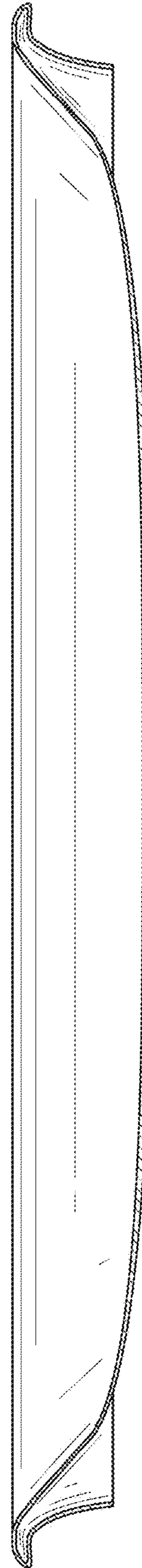

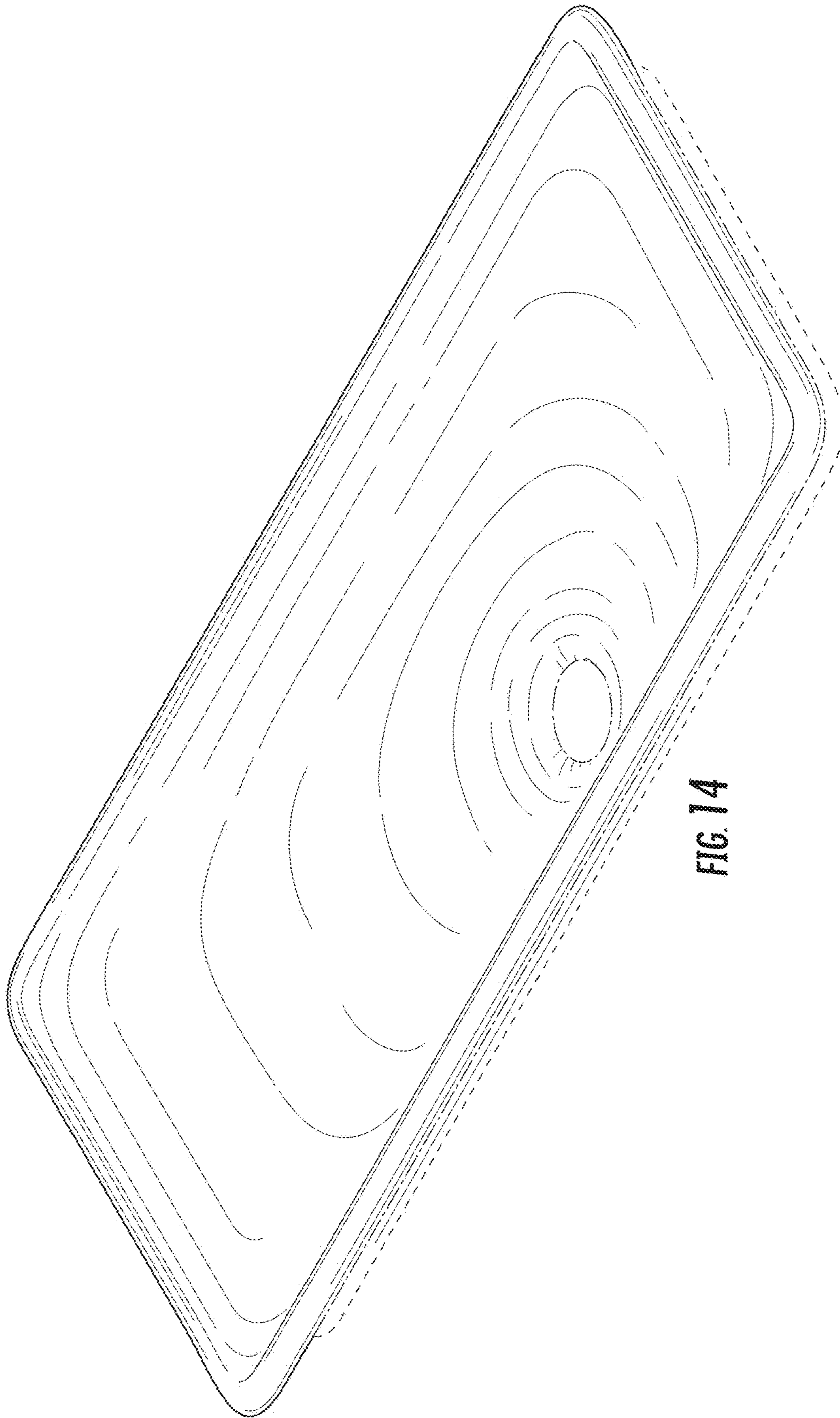

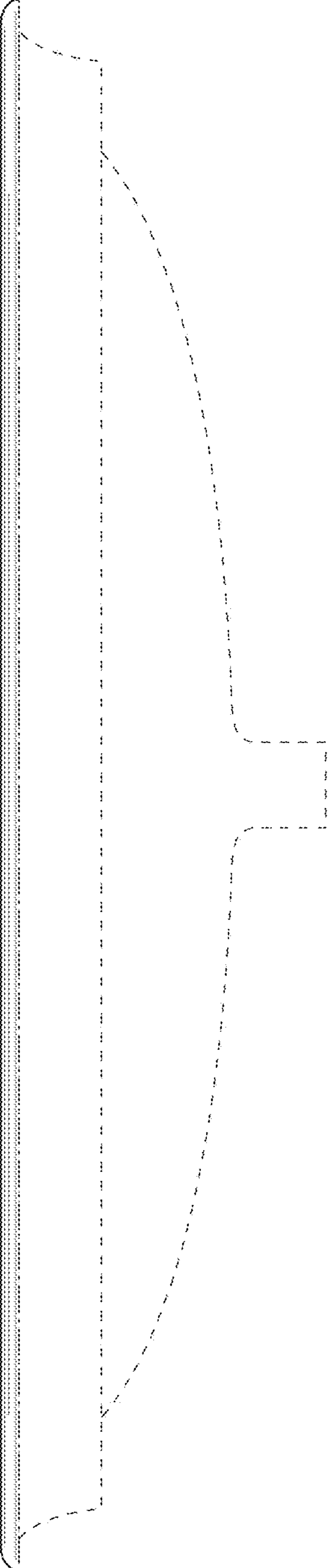

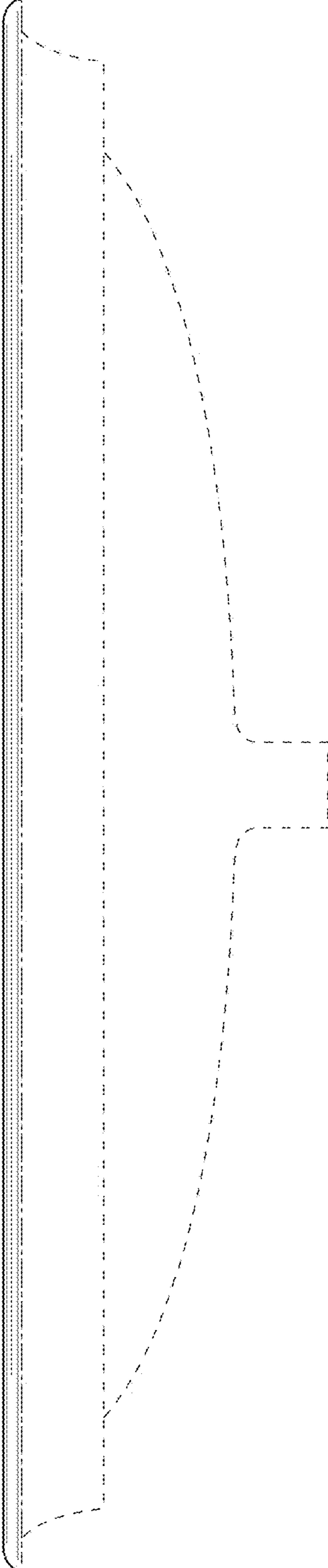
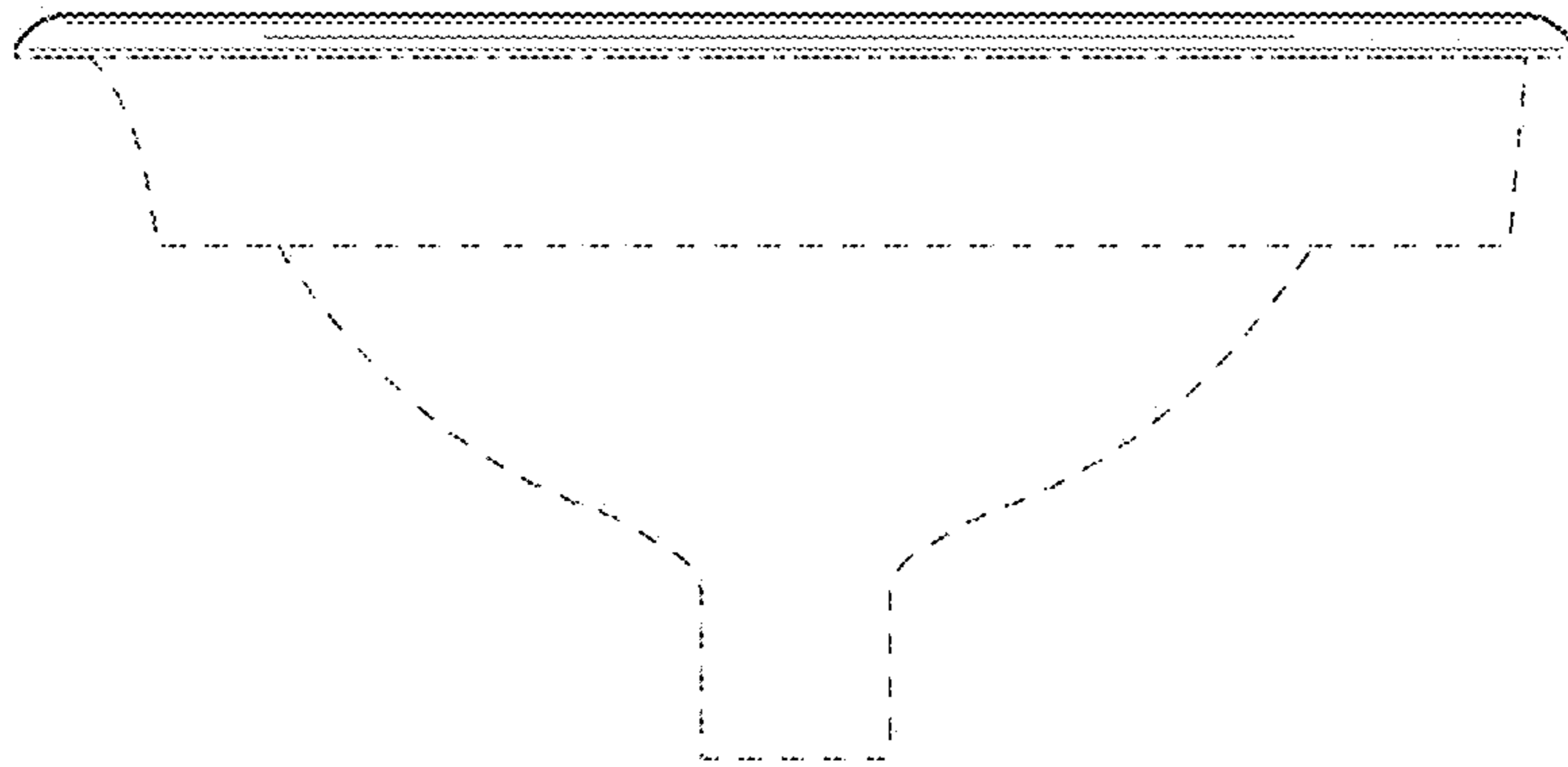
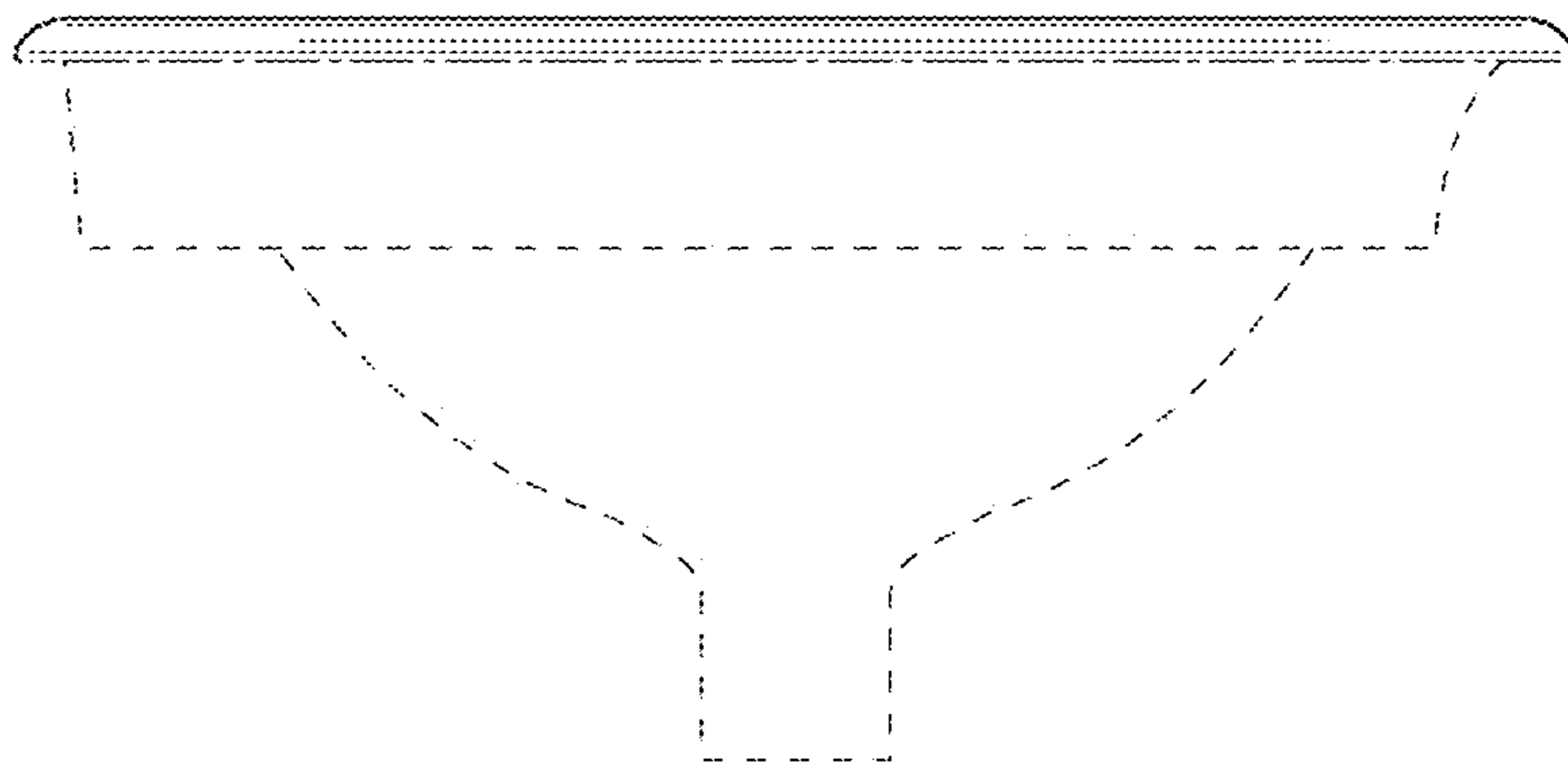

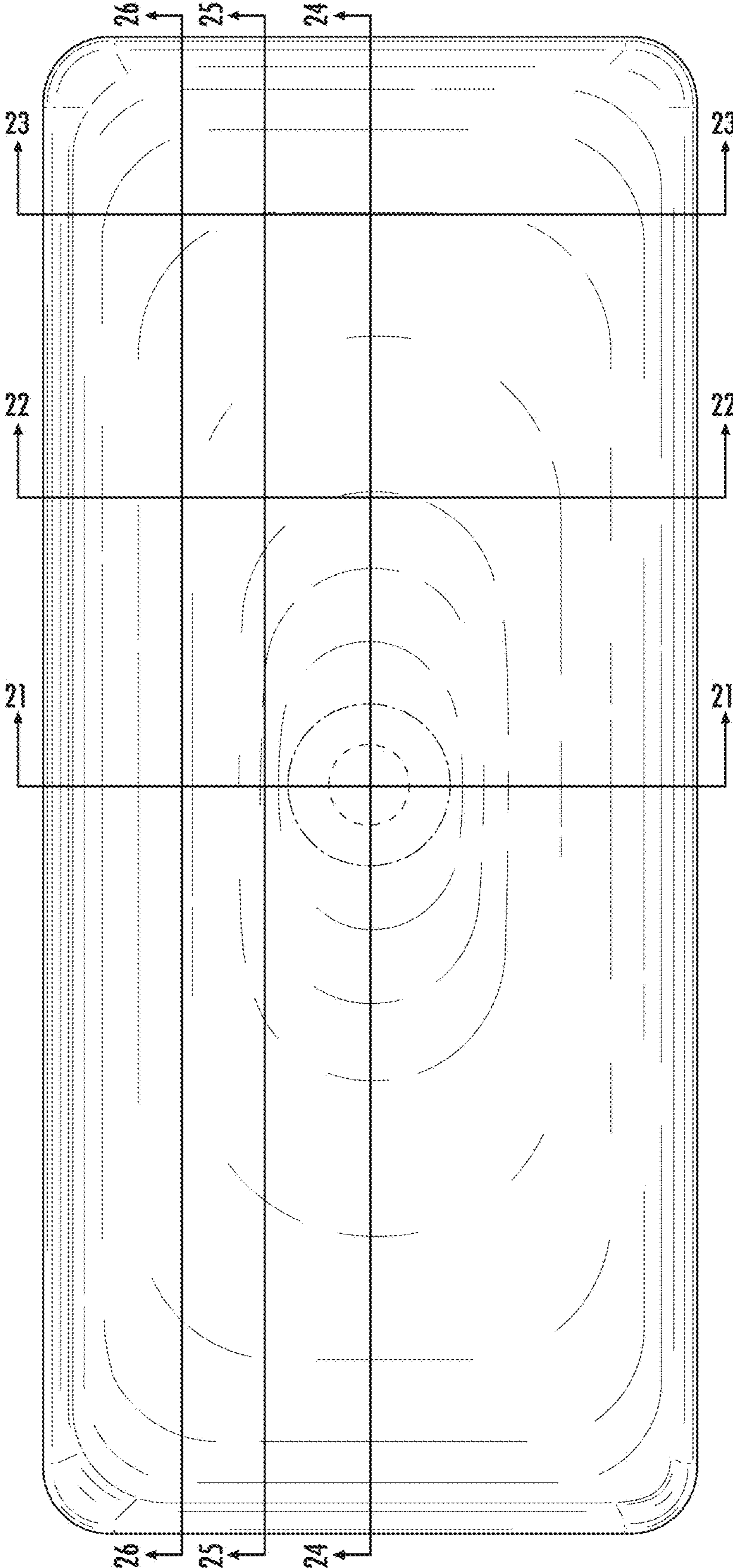

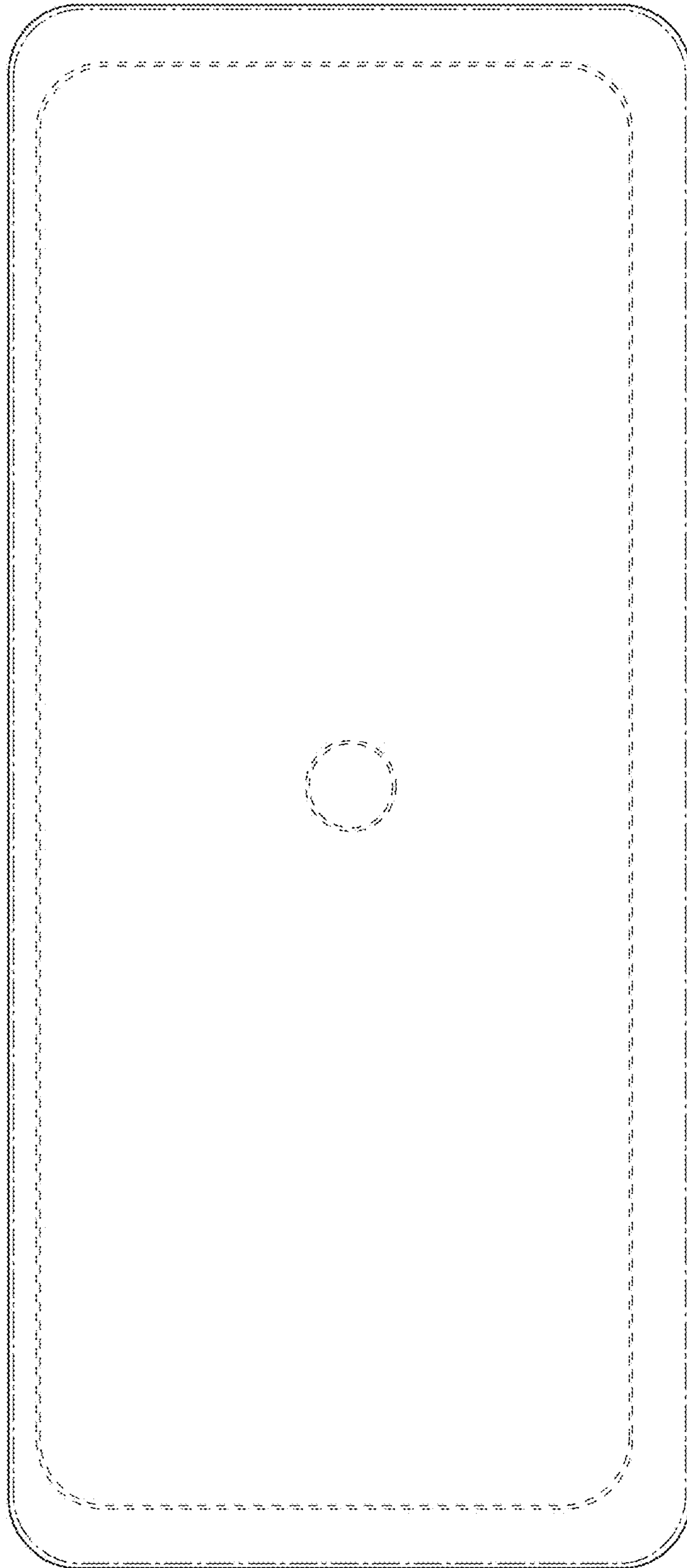

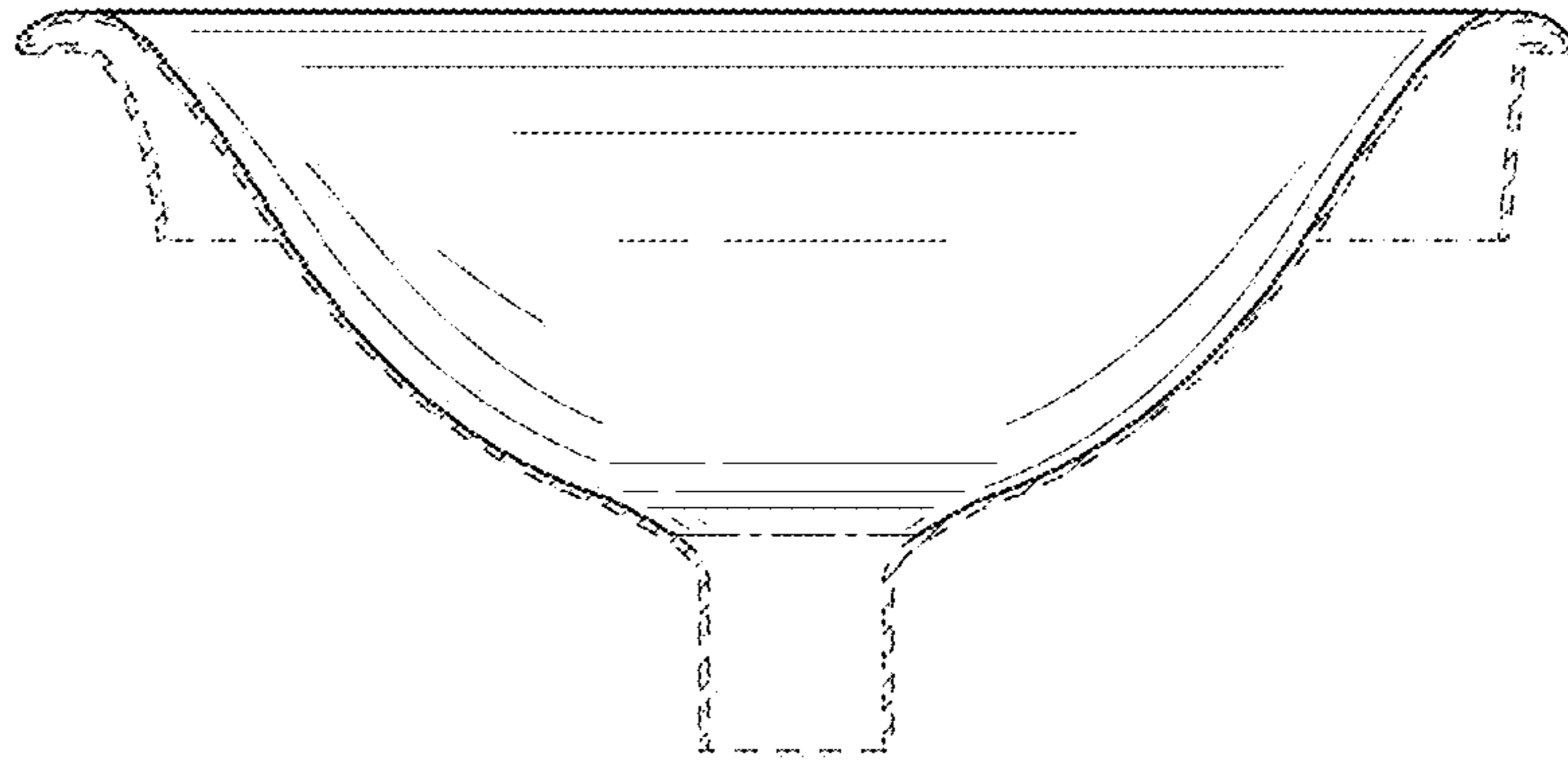

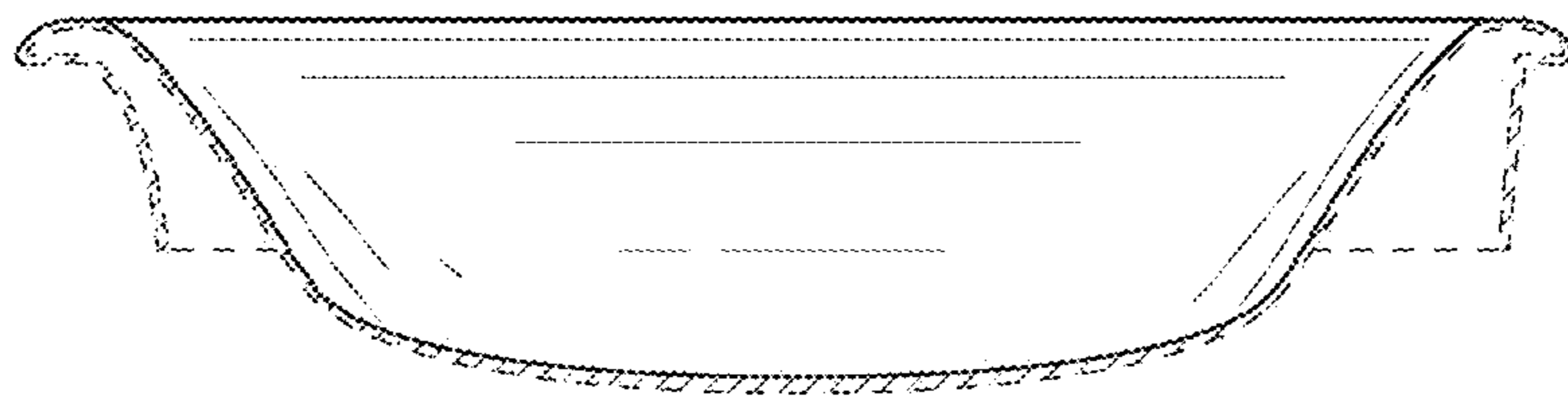

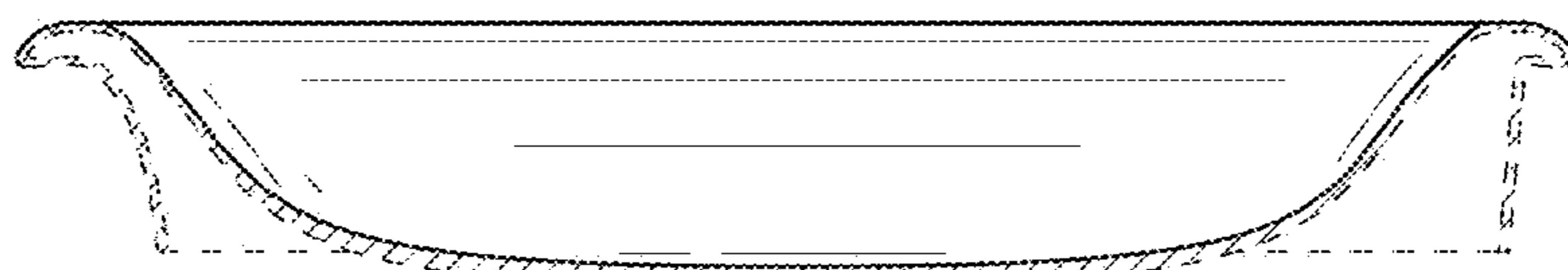

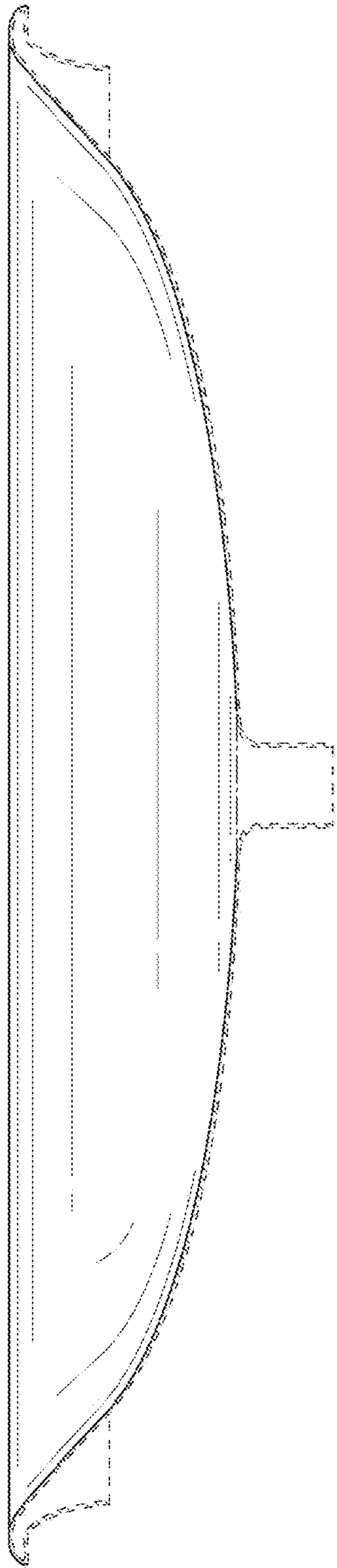

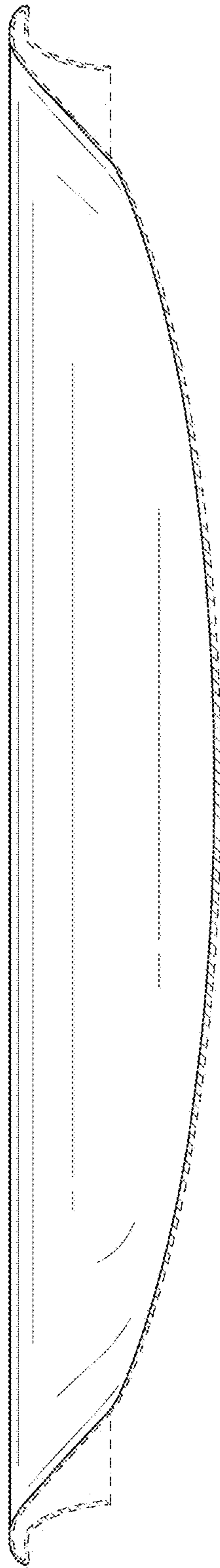

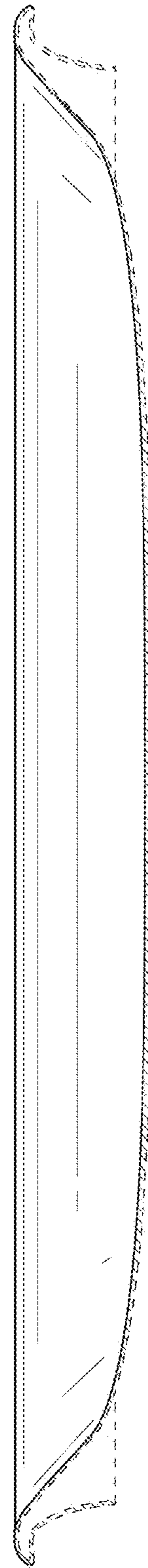
