The ornamental design for a cleanser, as shown and described.

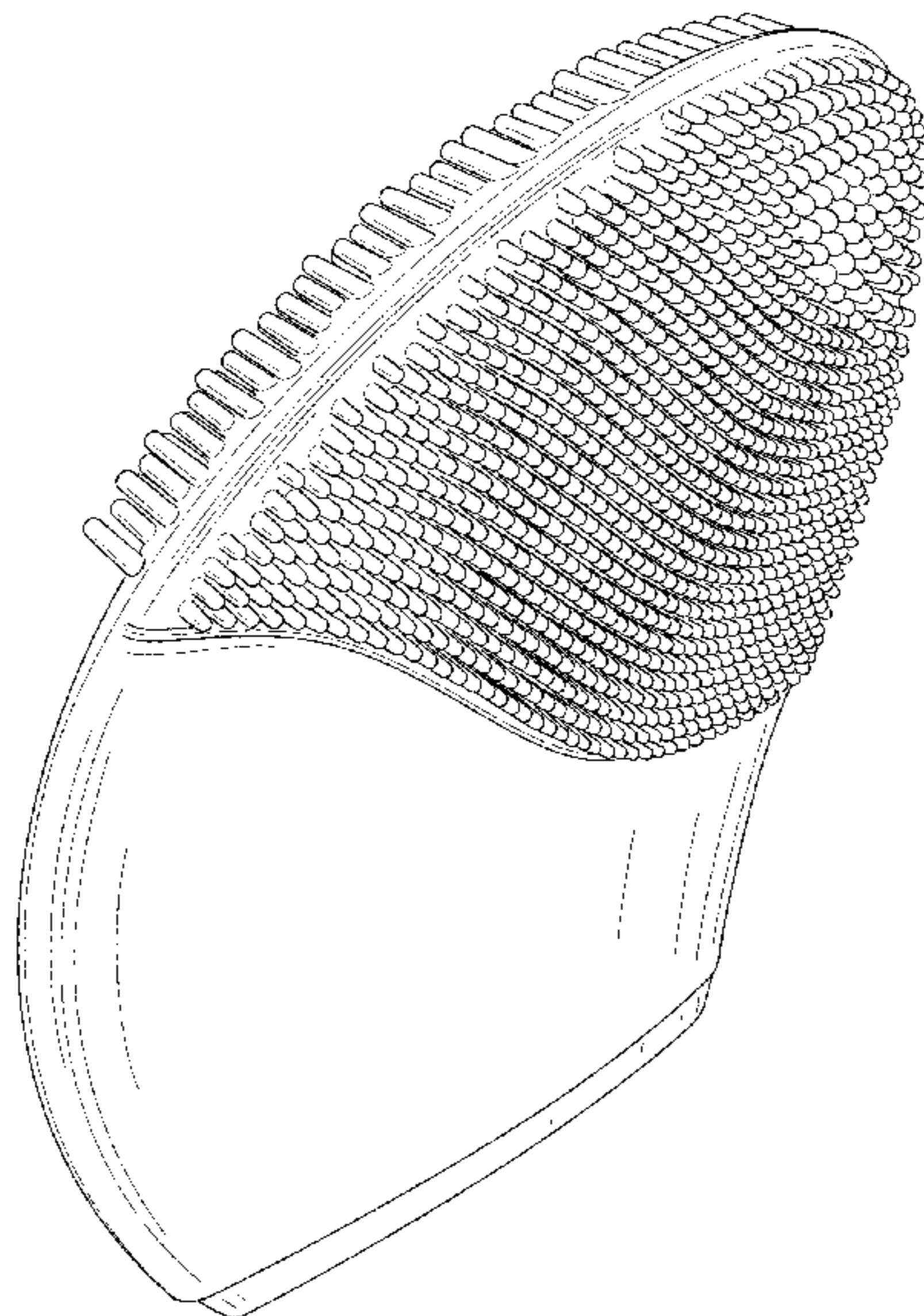
DESCRIPTION

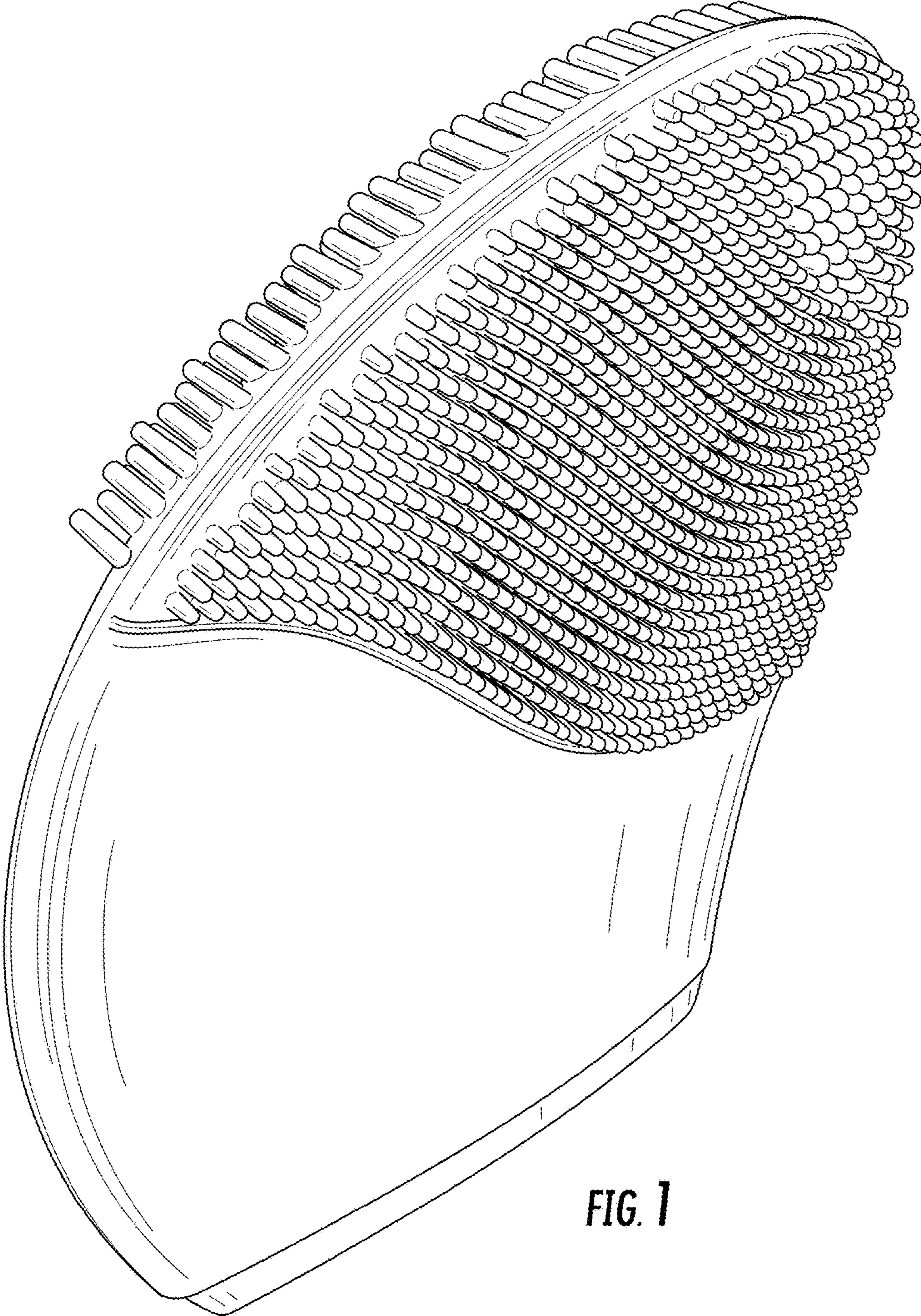

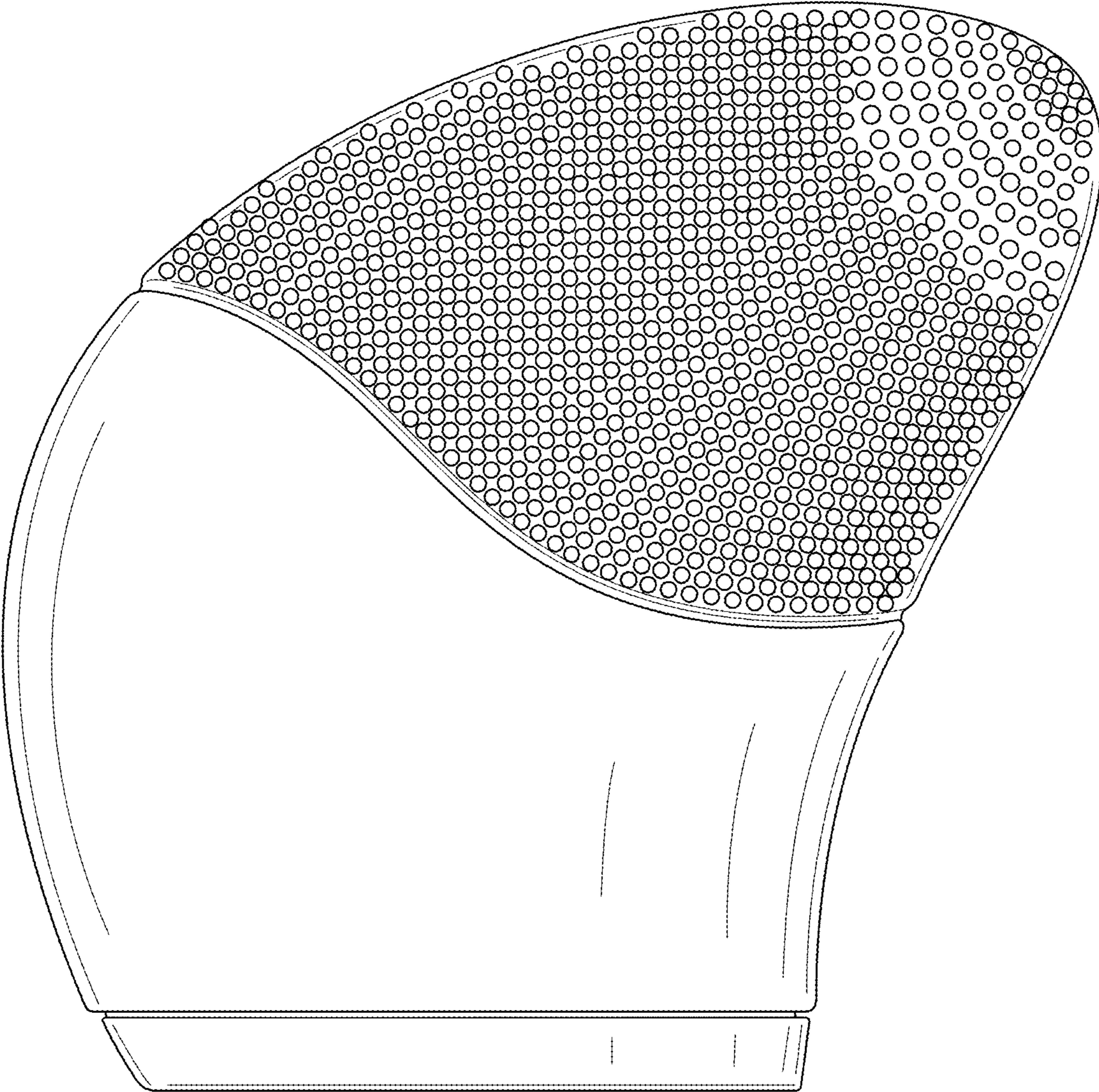

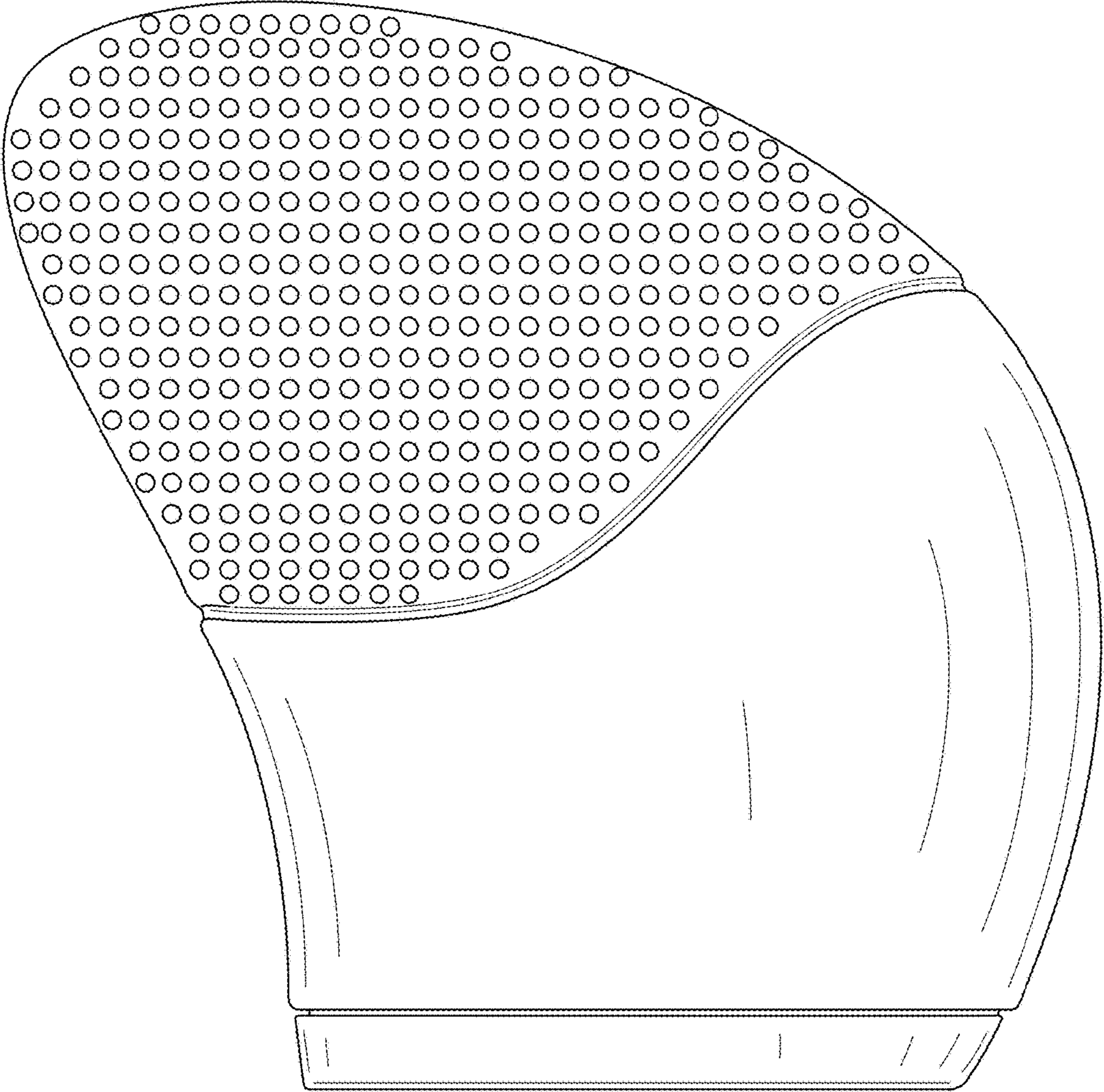

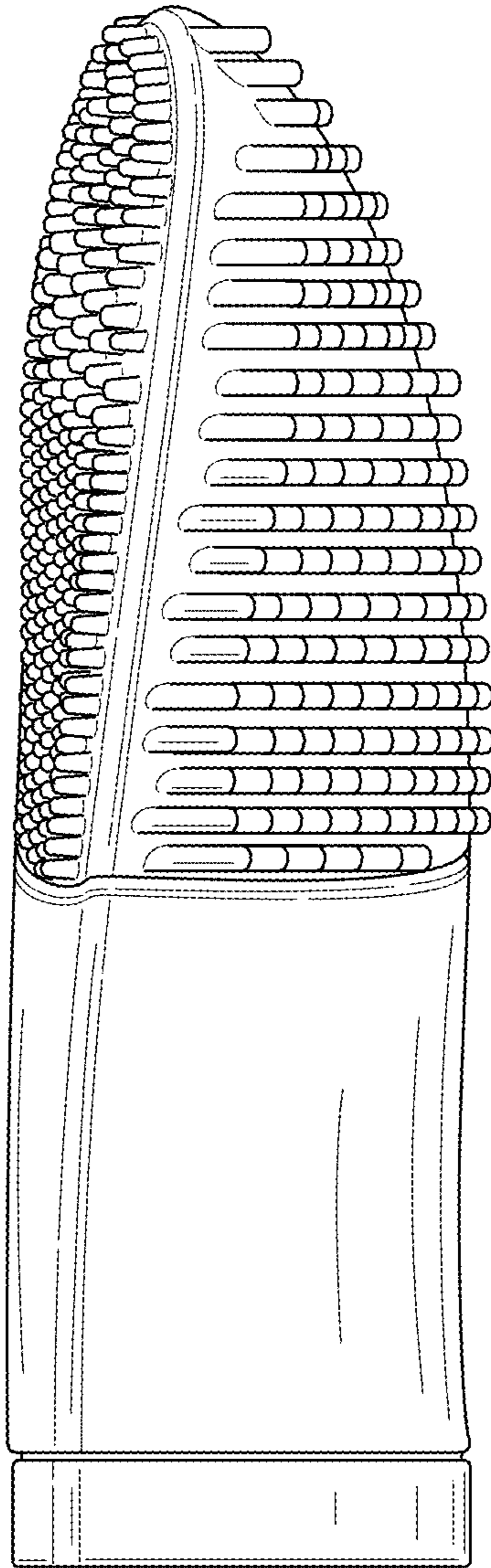

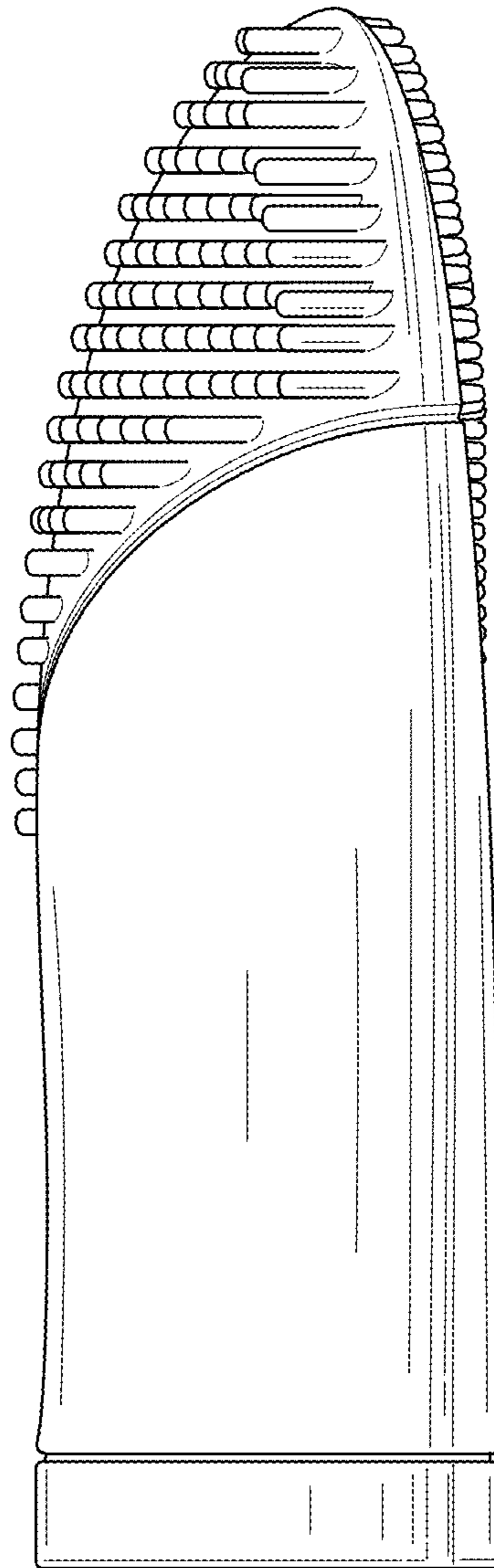

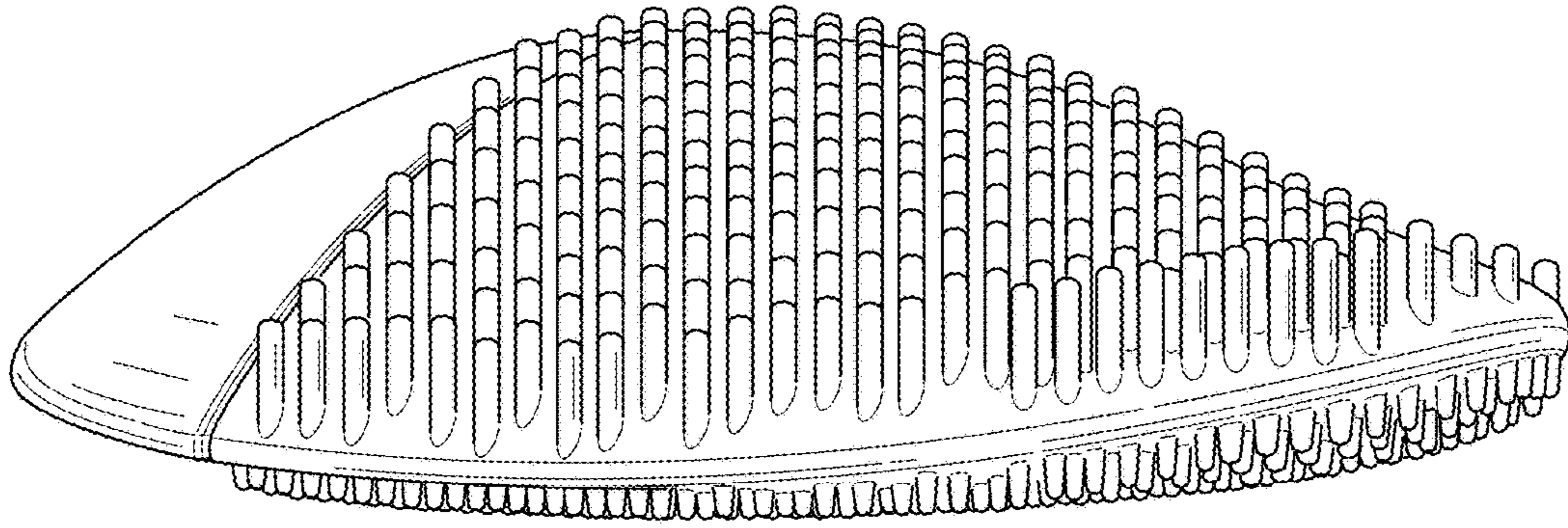

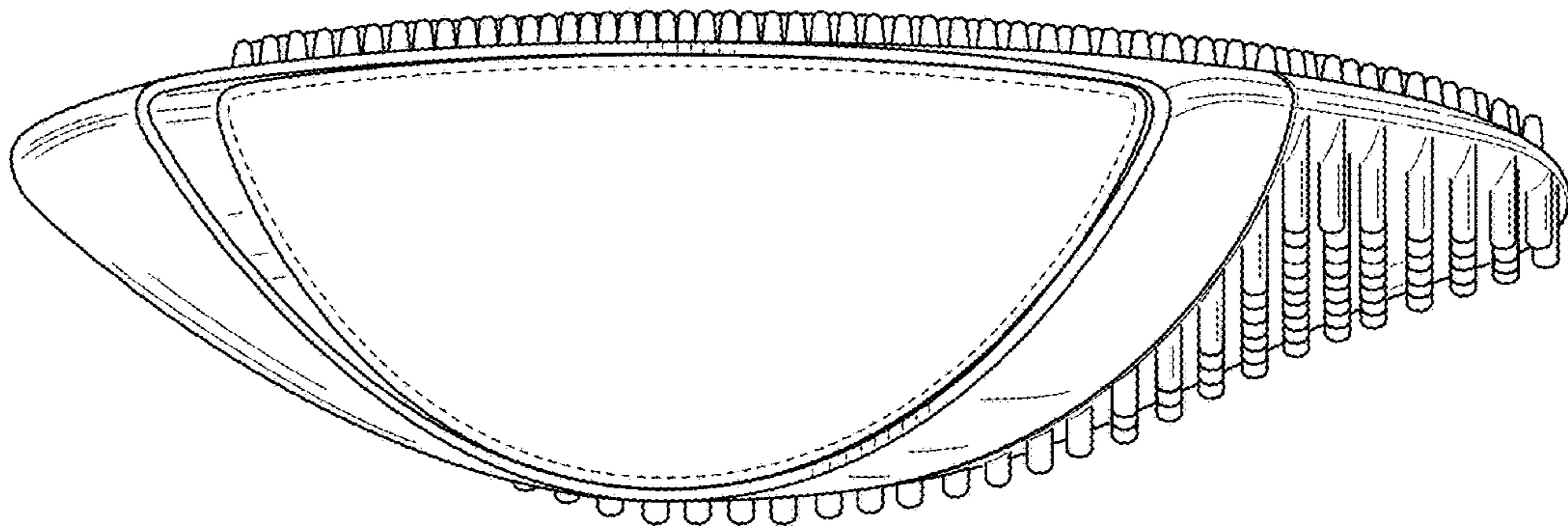
