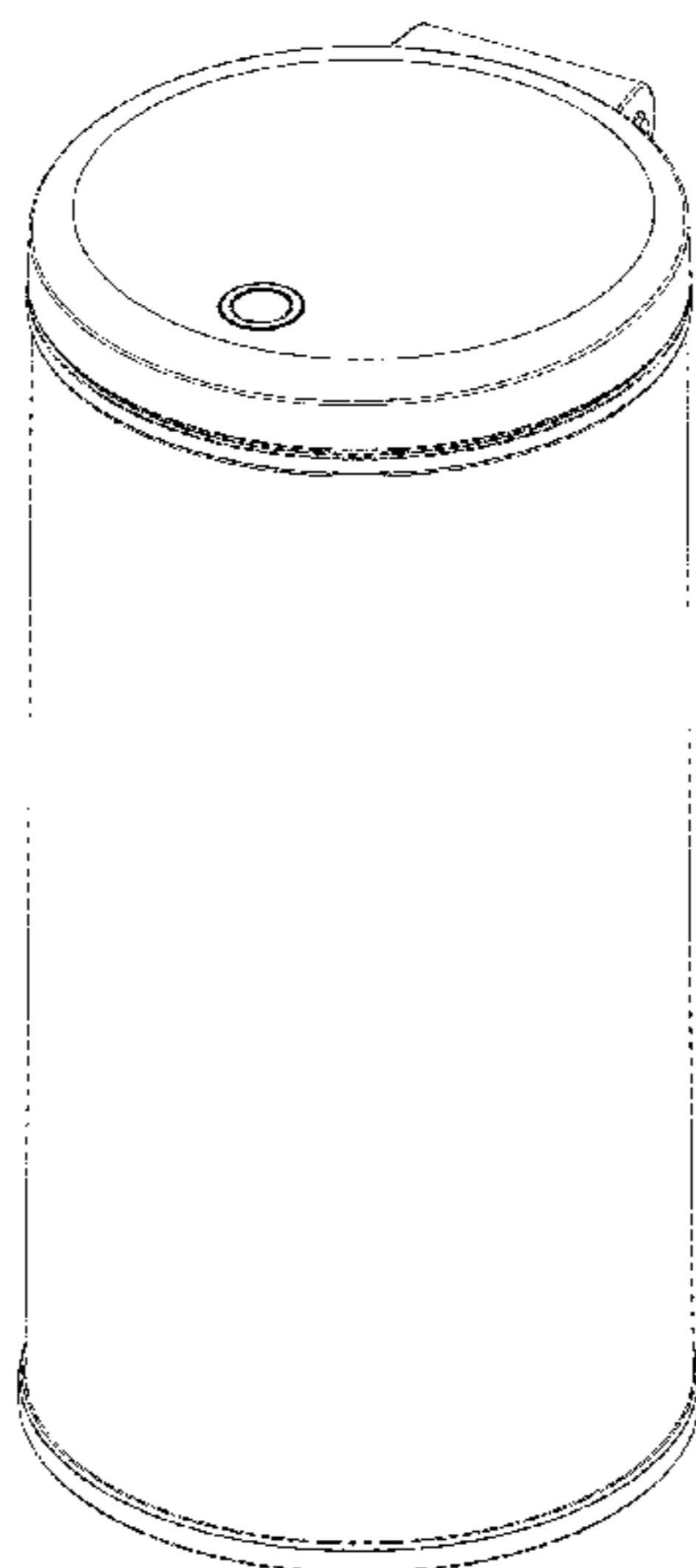
(57) **CLAIM**

The ornamental design for a trash bin, as shown and described.

DESCRIPTION

FIG. 1 is a front, top, right perspective view of a trash bin showing my new design;
 FIG. 2 is a rear, top, right perspective view of the trash bin seen in FIG. 1;
 FIG. 3 is a front elevation view of the trash bin seen in FIG. 1;
 FIG. 4 is a rear elevation view of the trash bin seen in FIG. 1;
 FIG. 5 is a left side elevation view of the trash bin seen in FIG. 1; the right side being a mirror image thereof; and,
 FIG. 6 is a top plan view of the trash bin seen in FIG. 1.
 The broken lines shown in the figures are included for the purpose of illustrating portions of the trash bin and form no part of the claimed design.

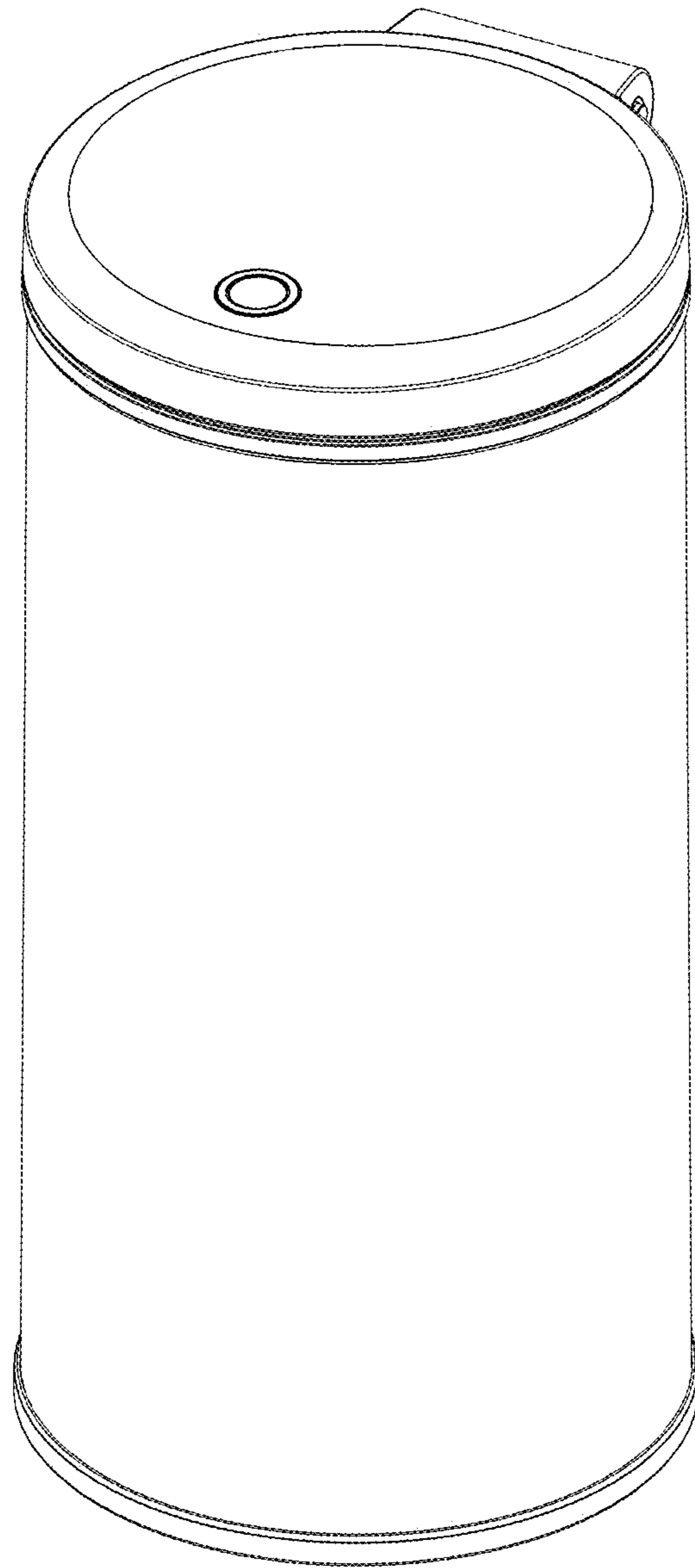

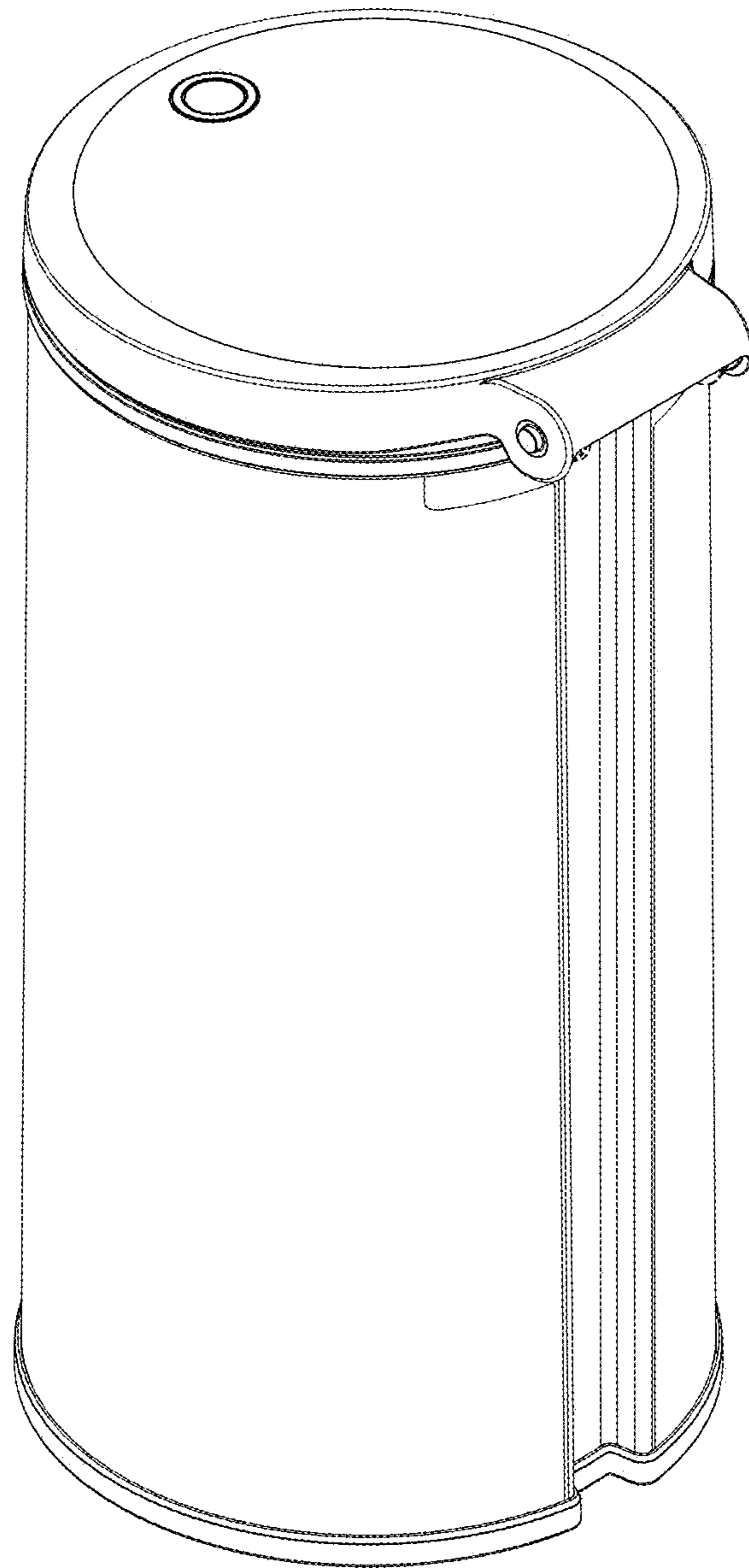

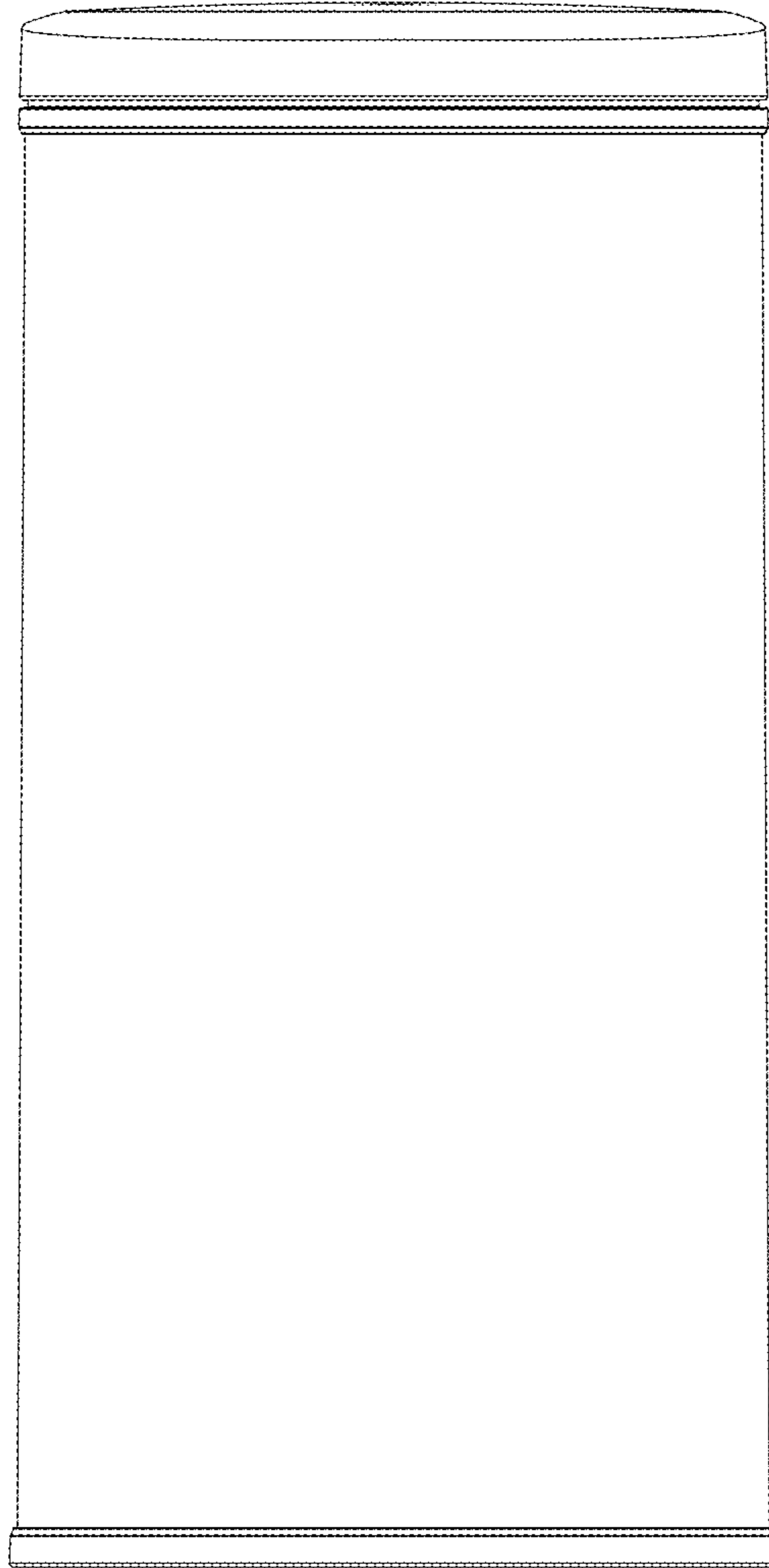

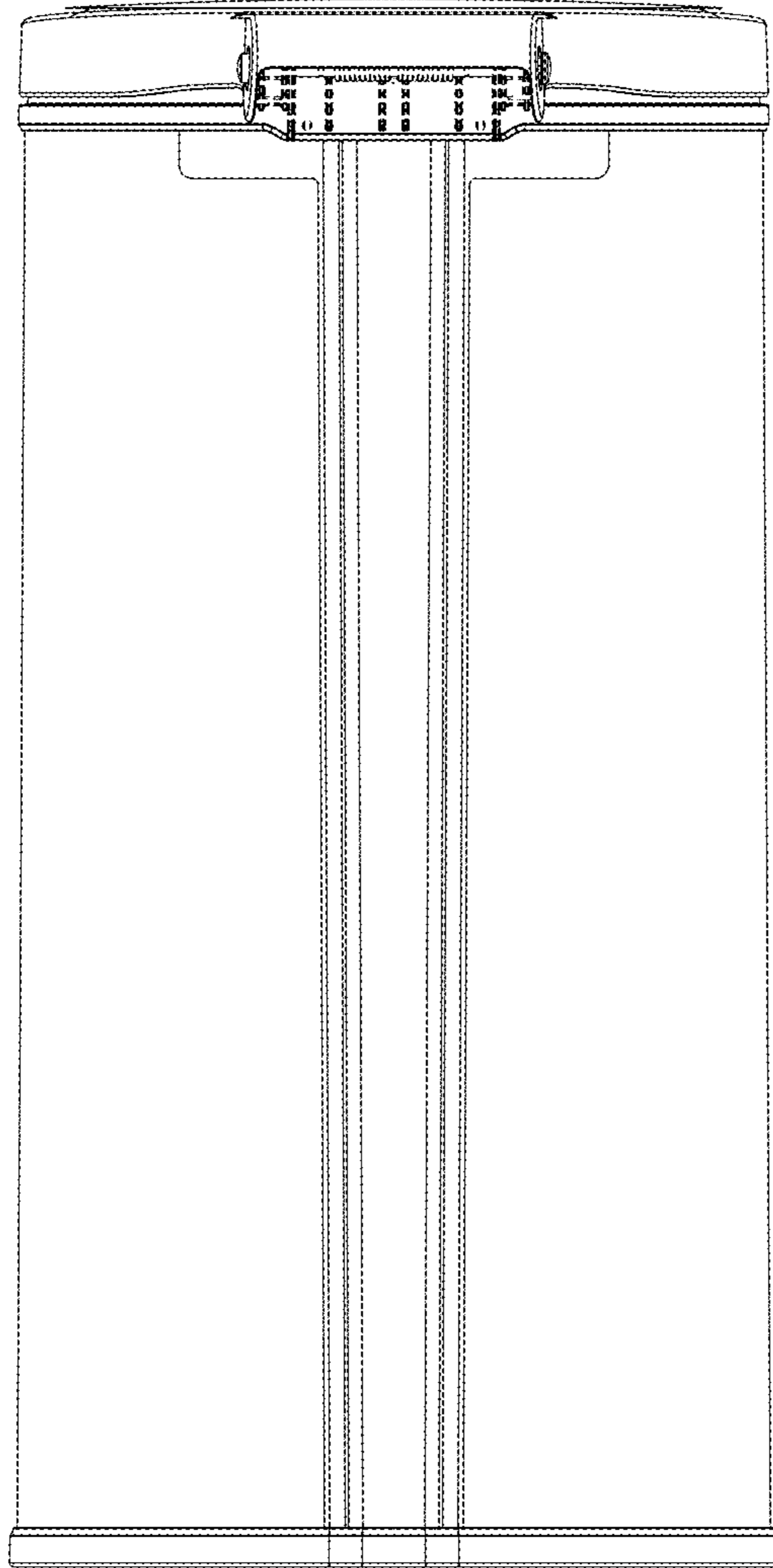

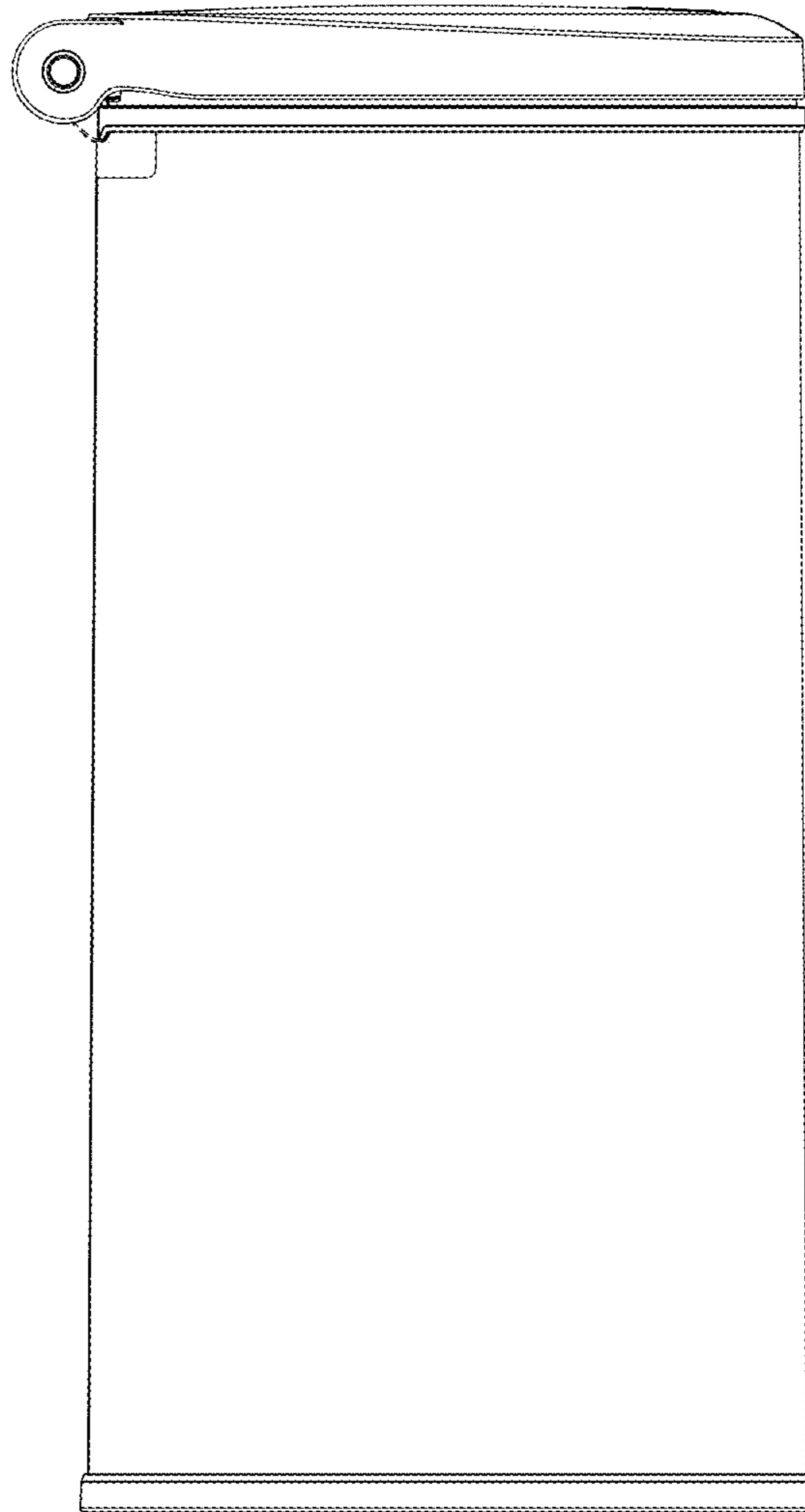

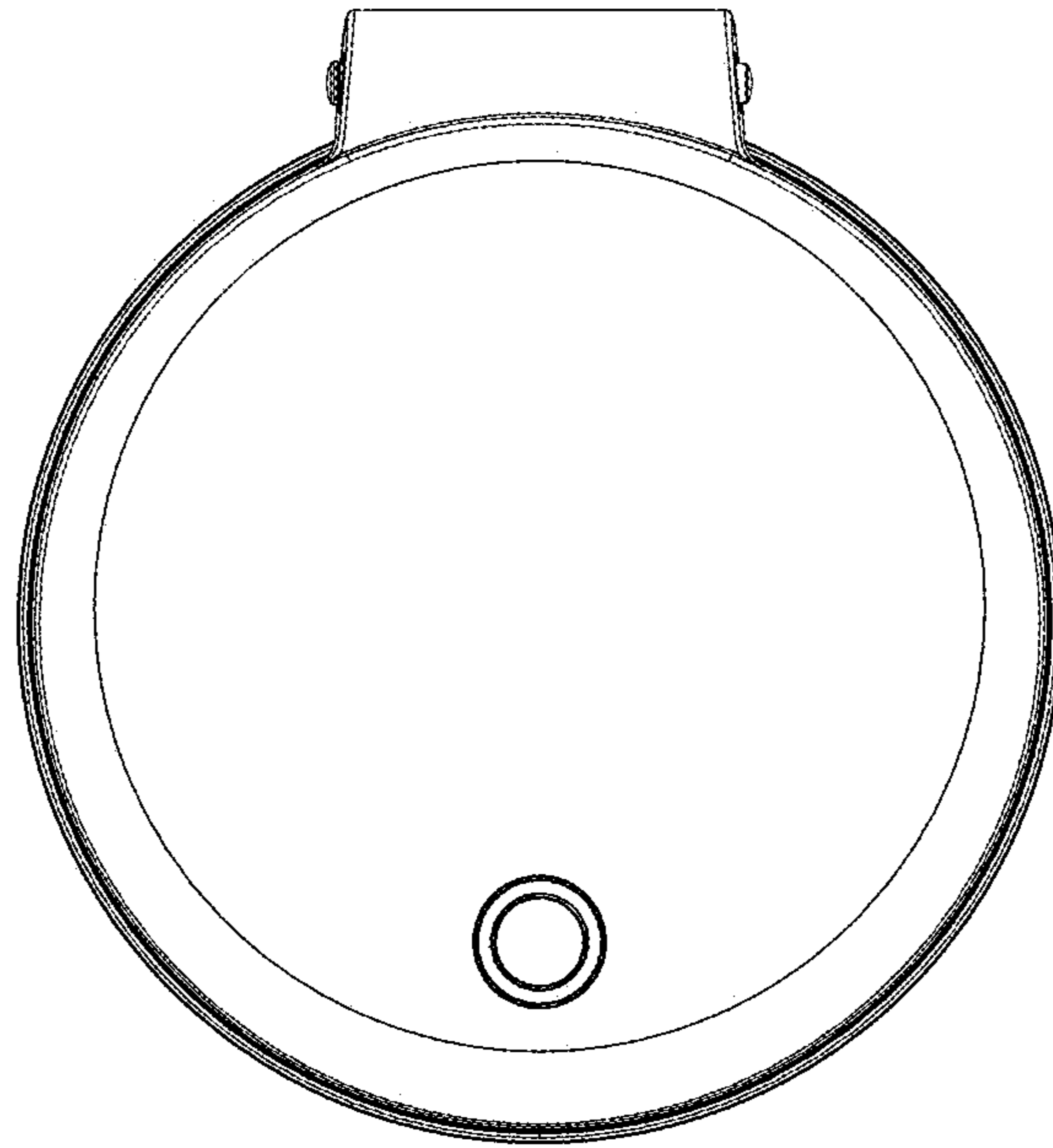
