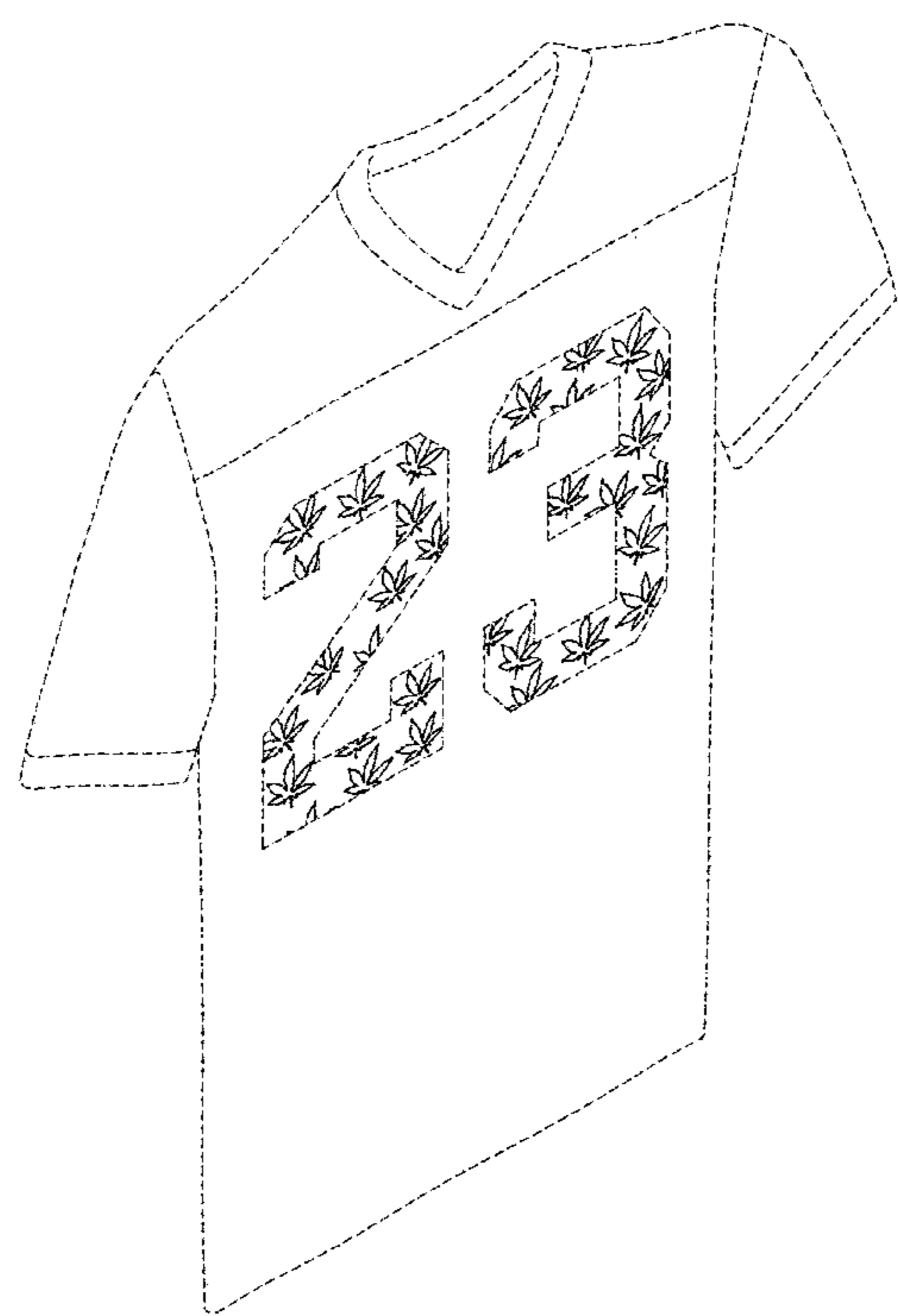

(57) **CLAIM**
The ornamental design for a garment with cannabis leaves, as shown and described.

DESCRIPTION

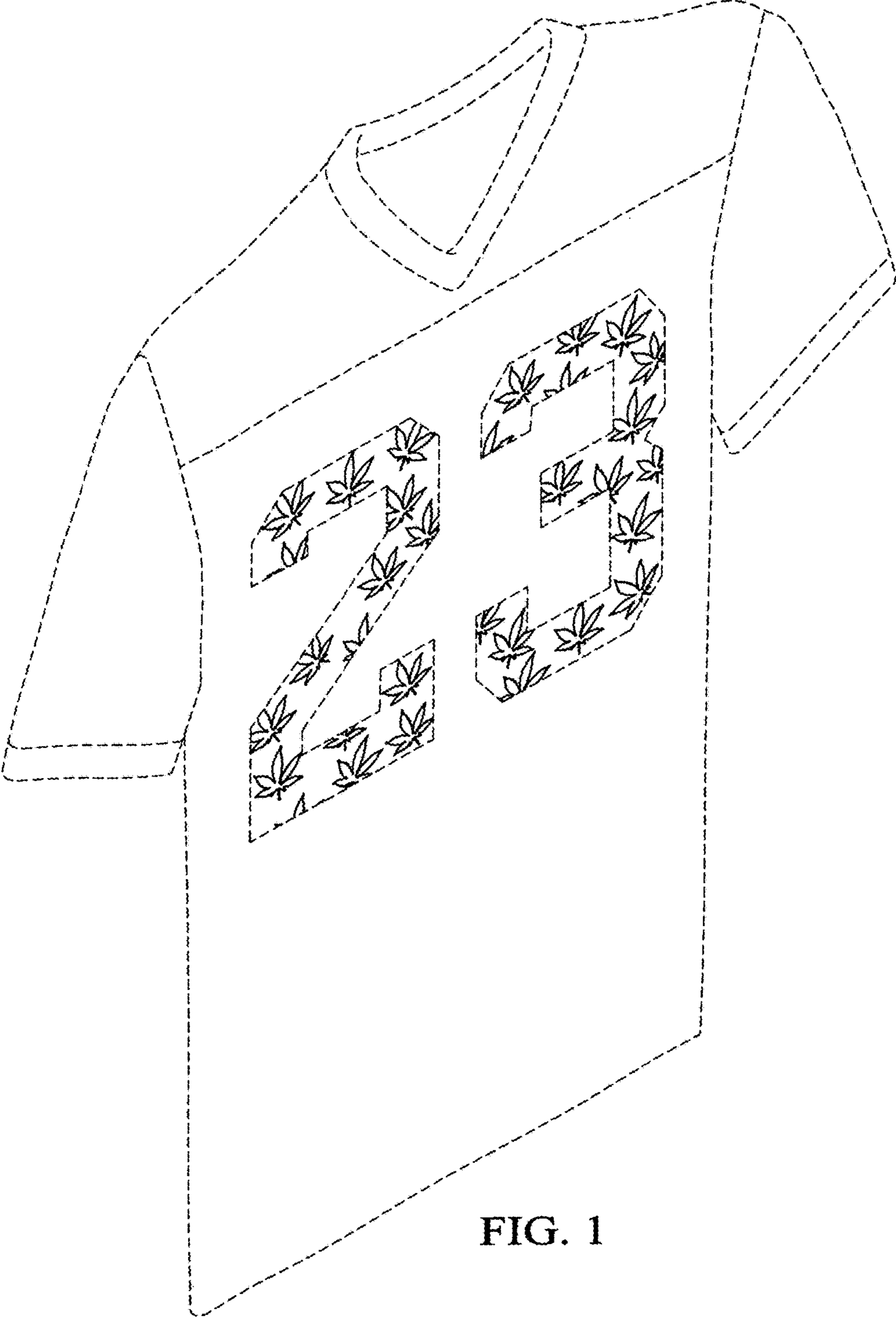

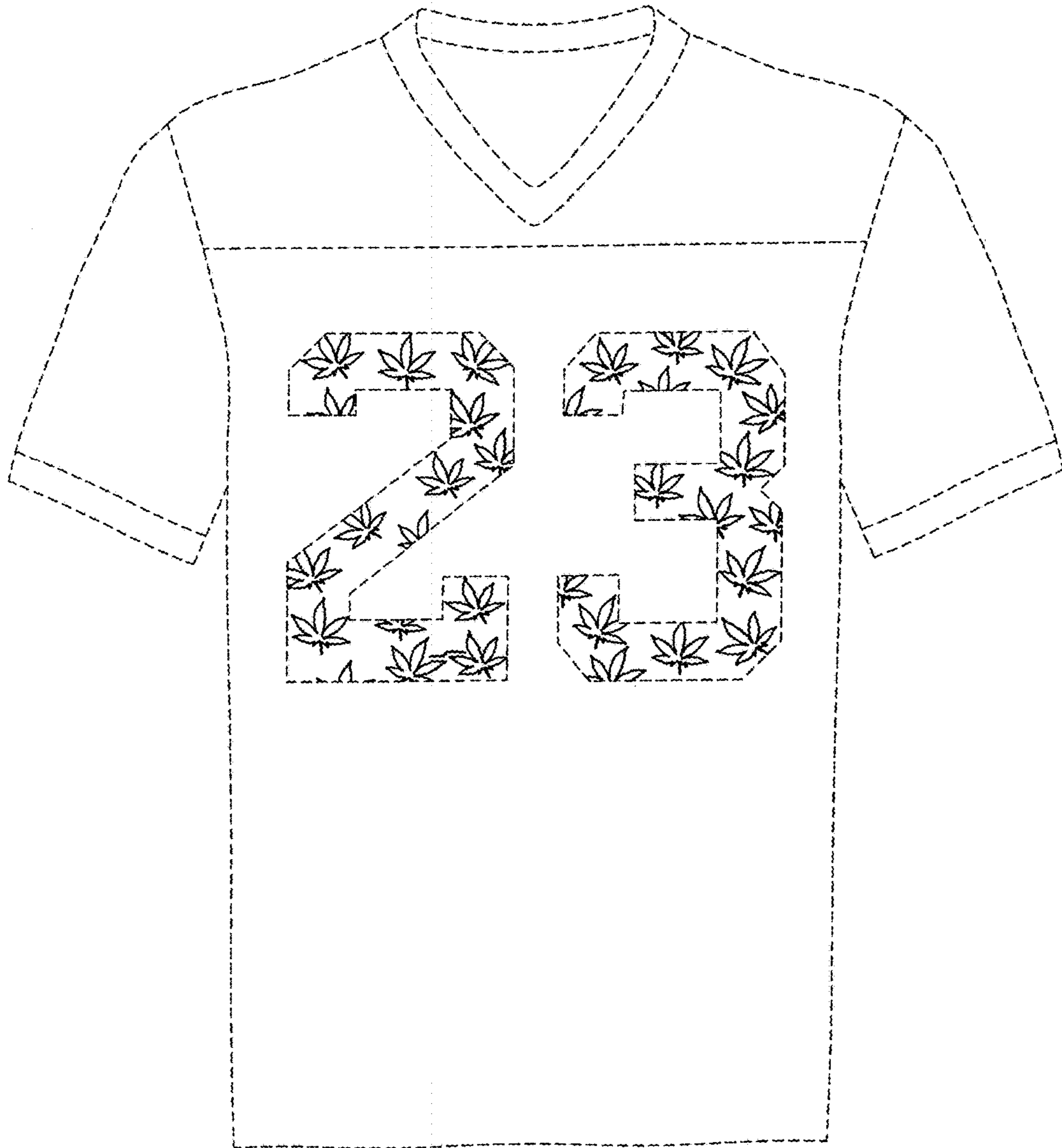
