The ornamental design for a hospital gown, as shown and described.

DESCRIPTION

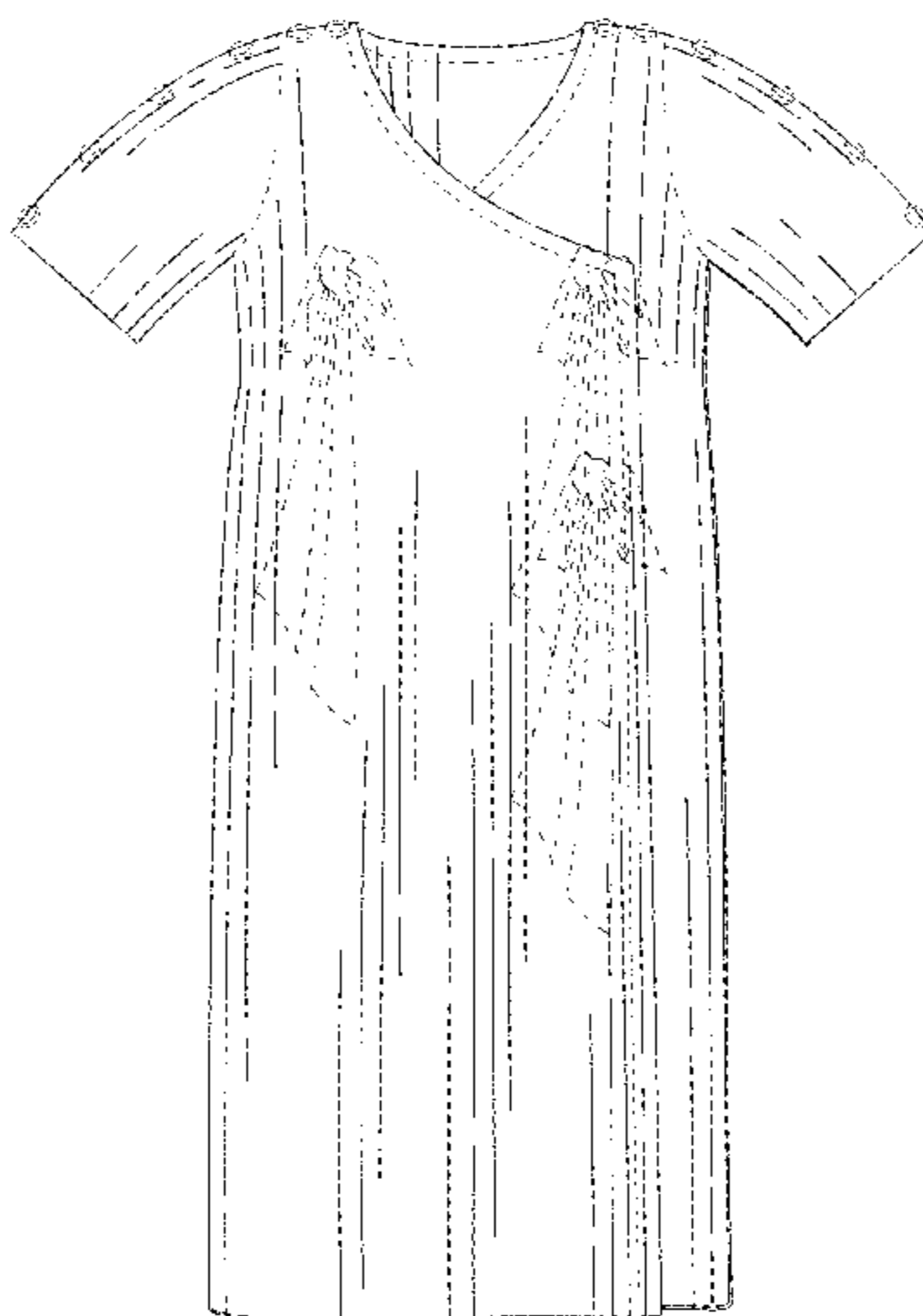
FIG. 1 a front view of the hospital gown showing my design thereof;
 FIG. 2 is a back view thereof;
 FIG. 3 is a right side view thereof;
 FIG. 4 is an open flat view thereof; and,
 FIG. 5 is a back view thereof shown worn by a person and showing separation of the layers of the hospital gown.
 The features shown in broken lines are for environmental purposes only and form no part of the claimed design. Specifically, in FIGS. 1-5, broken lines showing snaps, buttons or ties form no part of the claimed design. In FIG. 5, broken lines showing a person wearing the hospital gown form no part of the claimed design. In FIG. 4, broken lines showing a rectangular pocket form no part of the claimed design. In FIGS. 1-5, broken lines showing stitching around the perimeter of the hospital gown form no part of the claimed design.

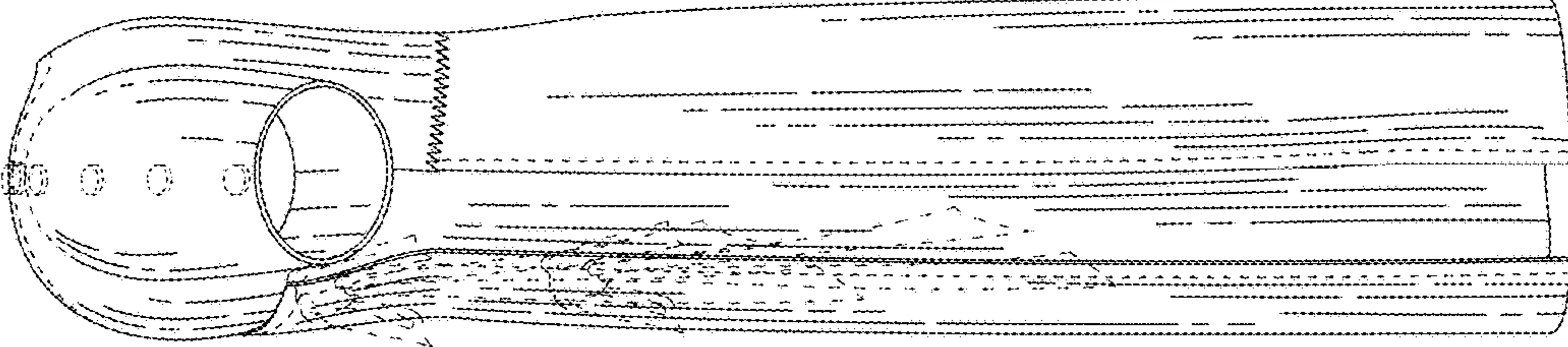

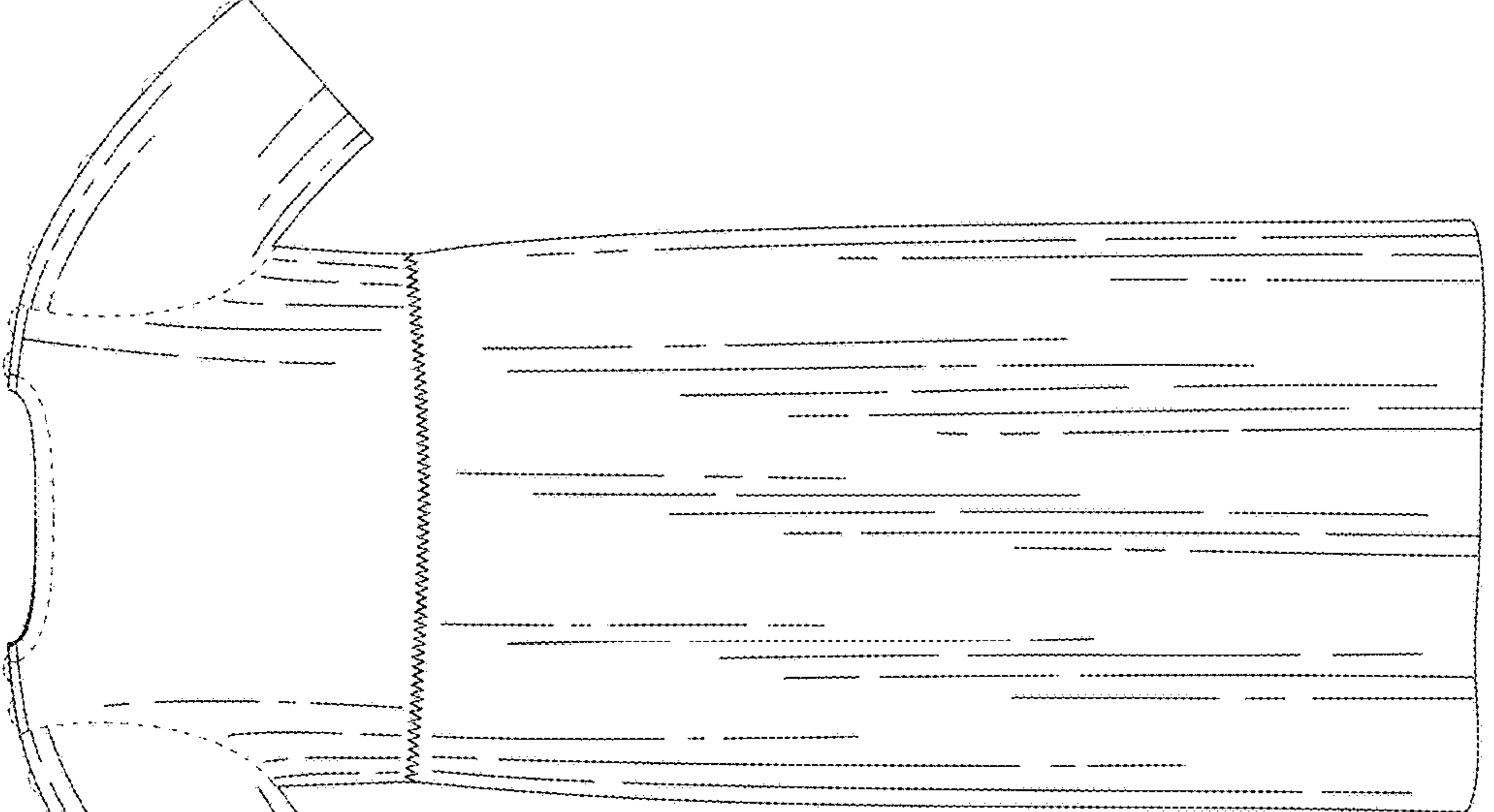

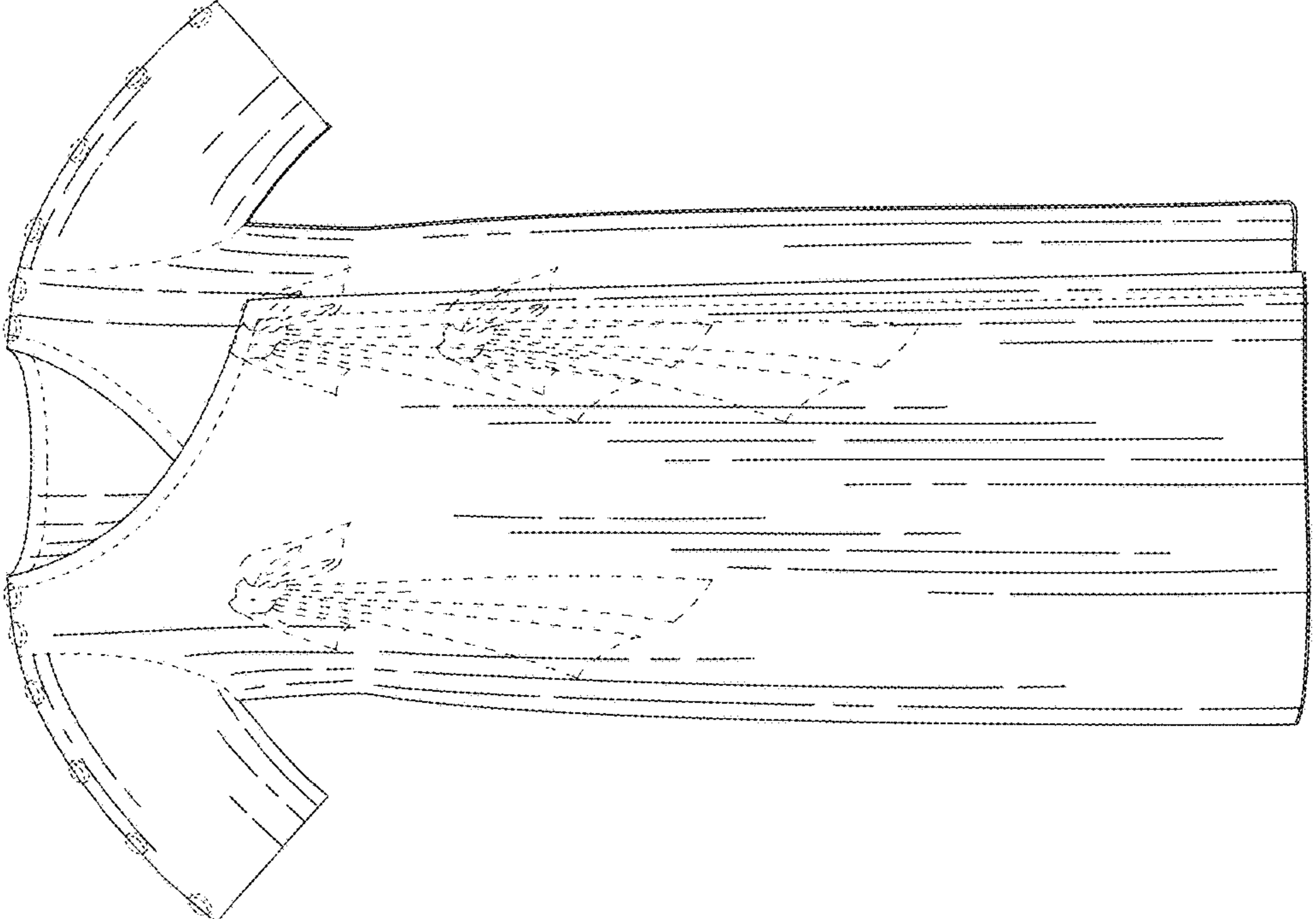

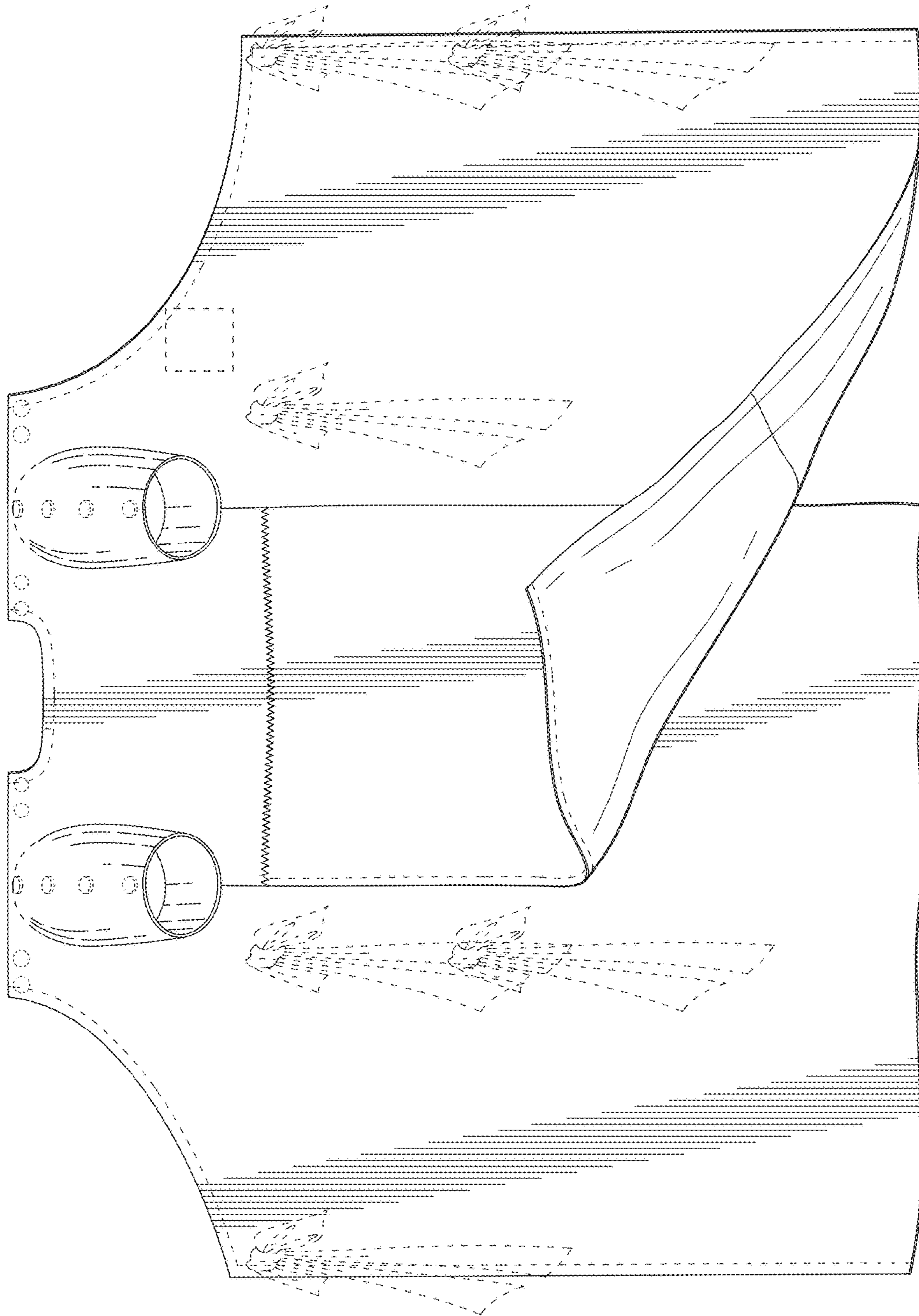

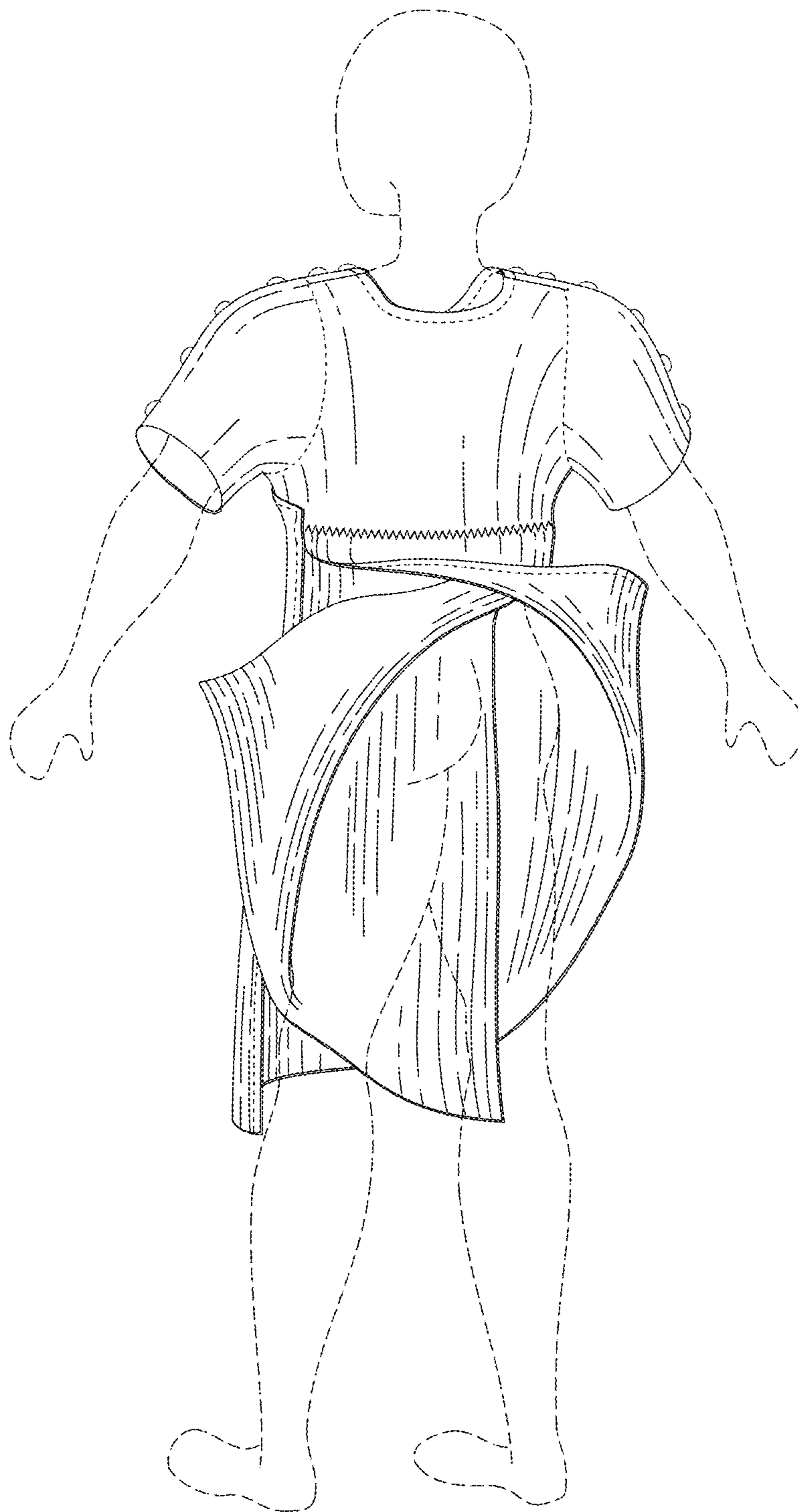
