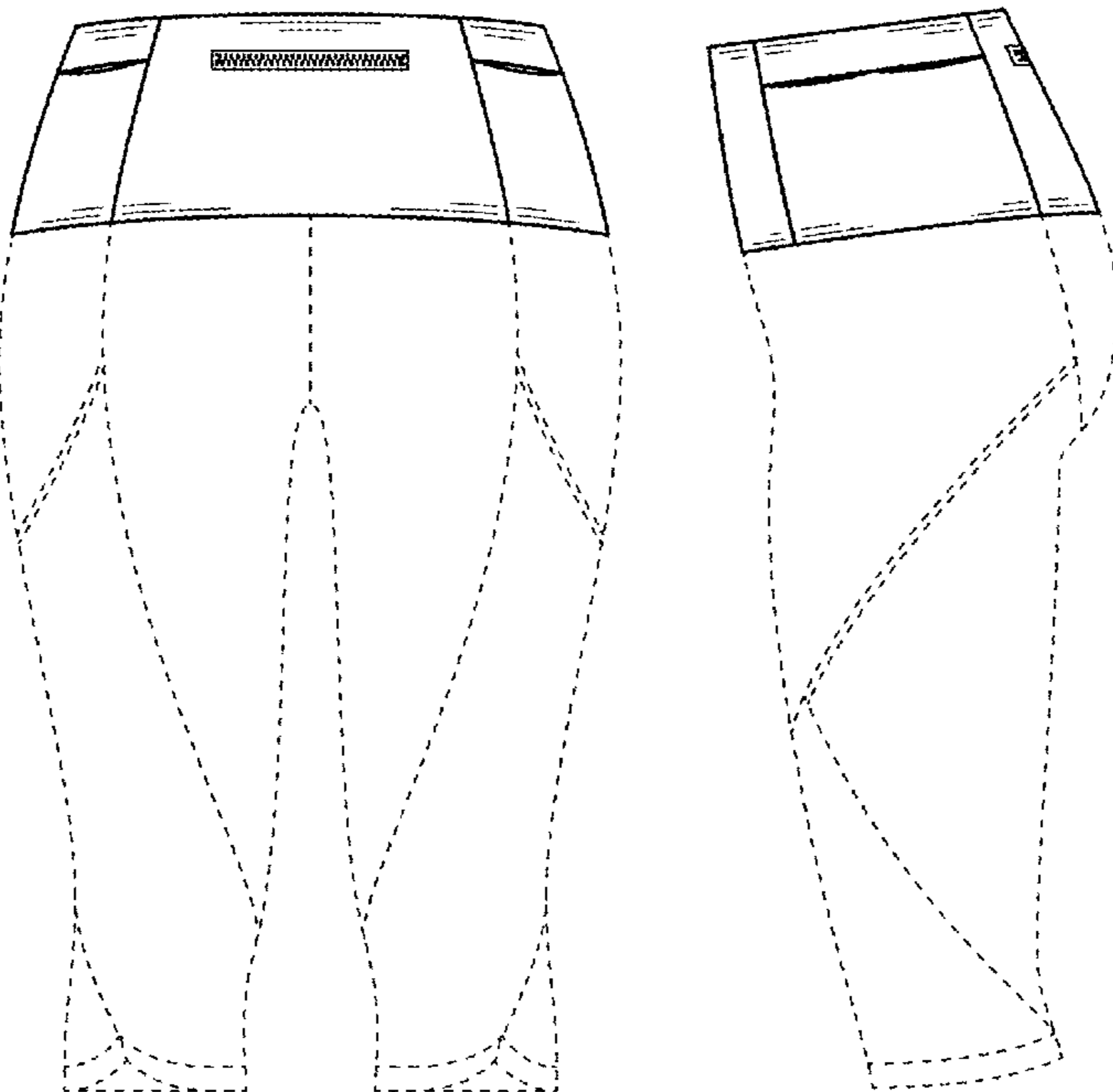

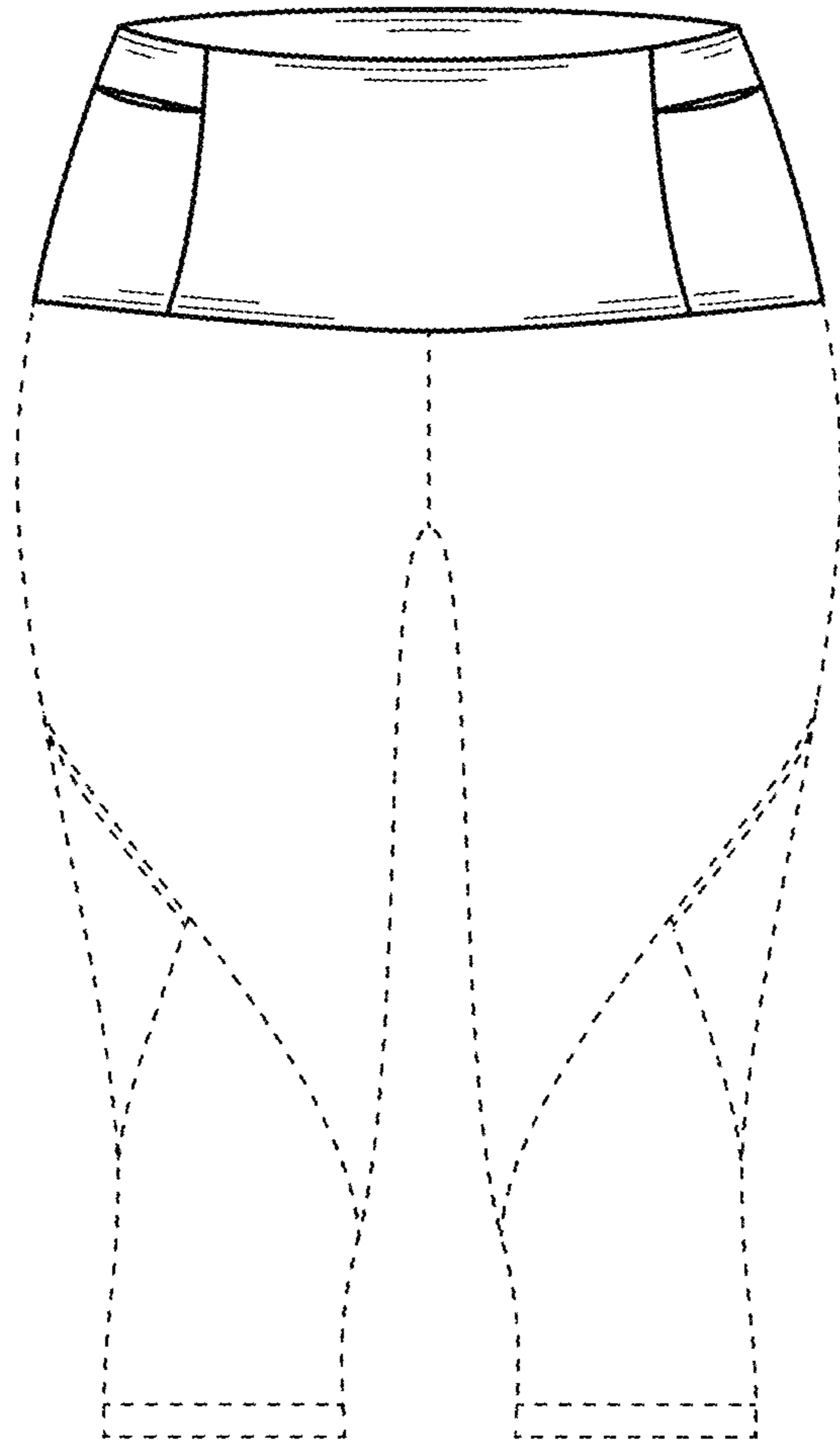
The ornamental design for pants, as shown and described.

**DESCRIPTION**

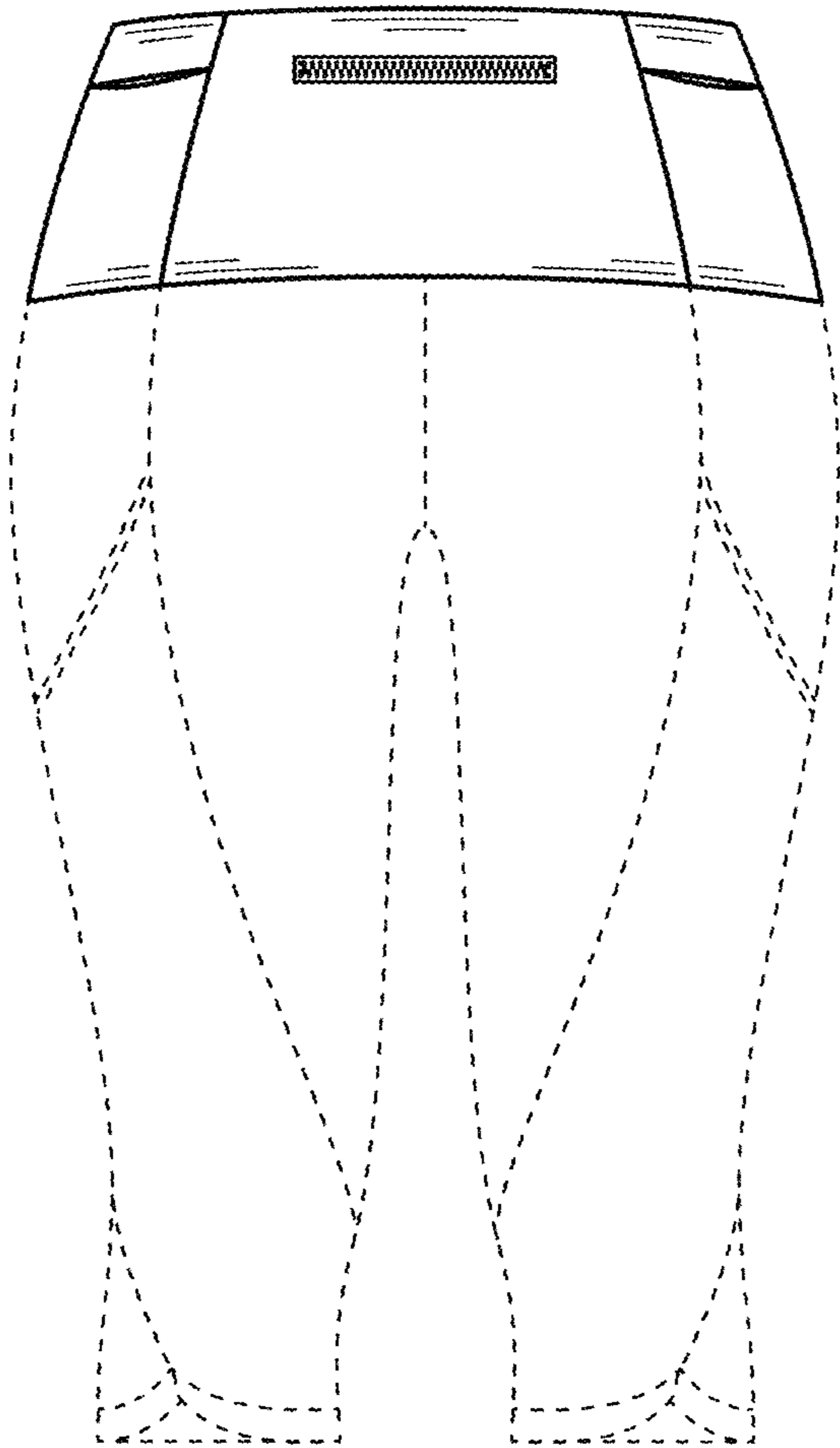
FIG. 1 is a front view of pants according to the design;

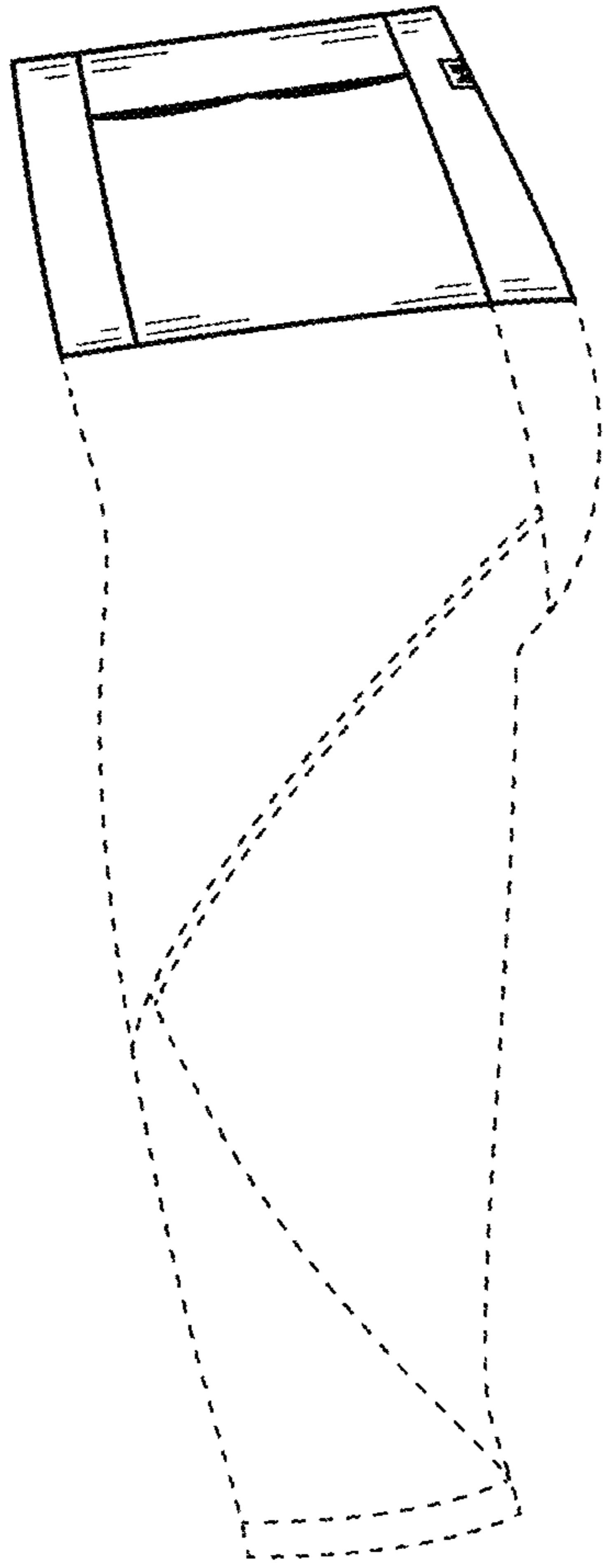




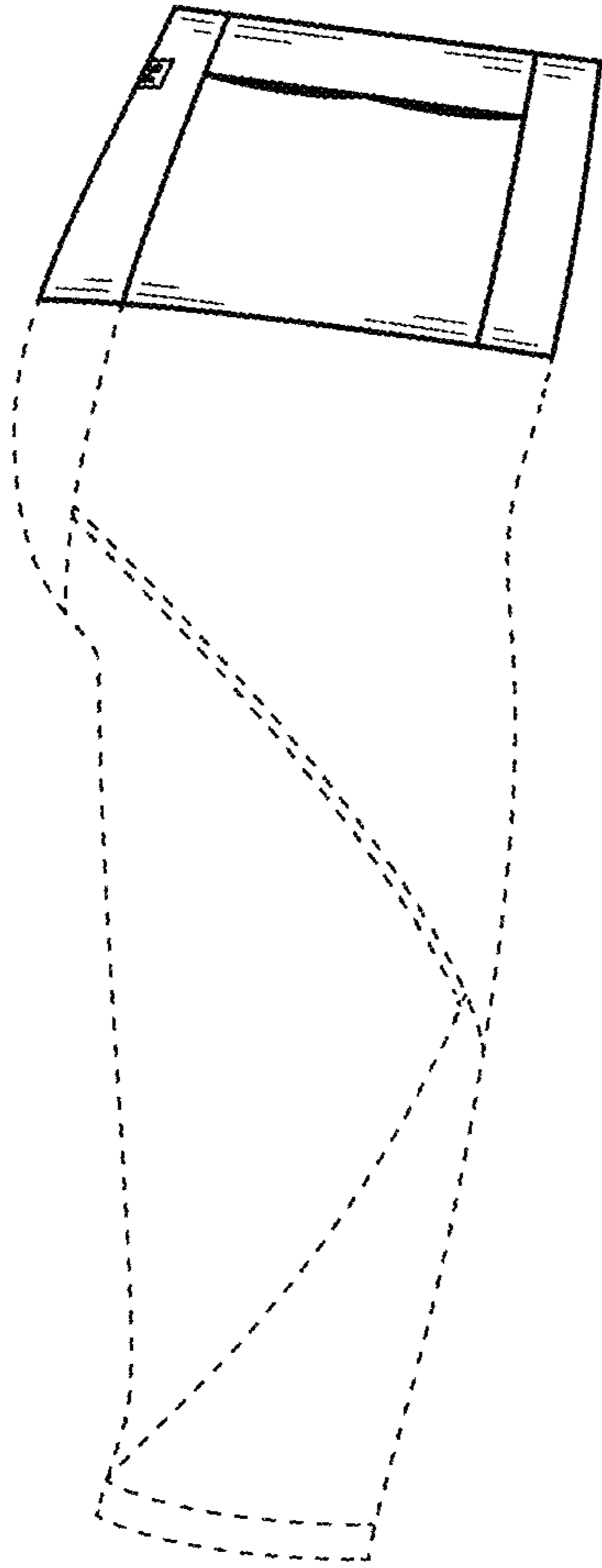

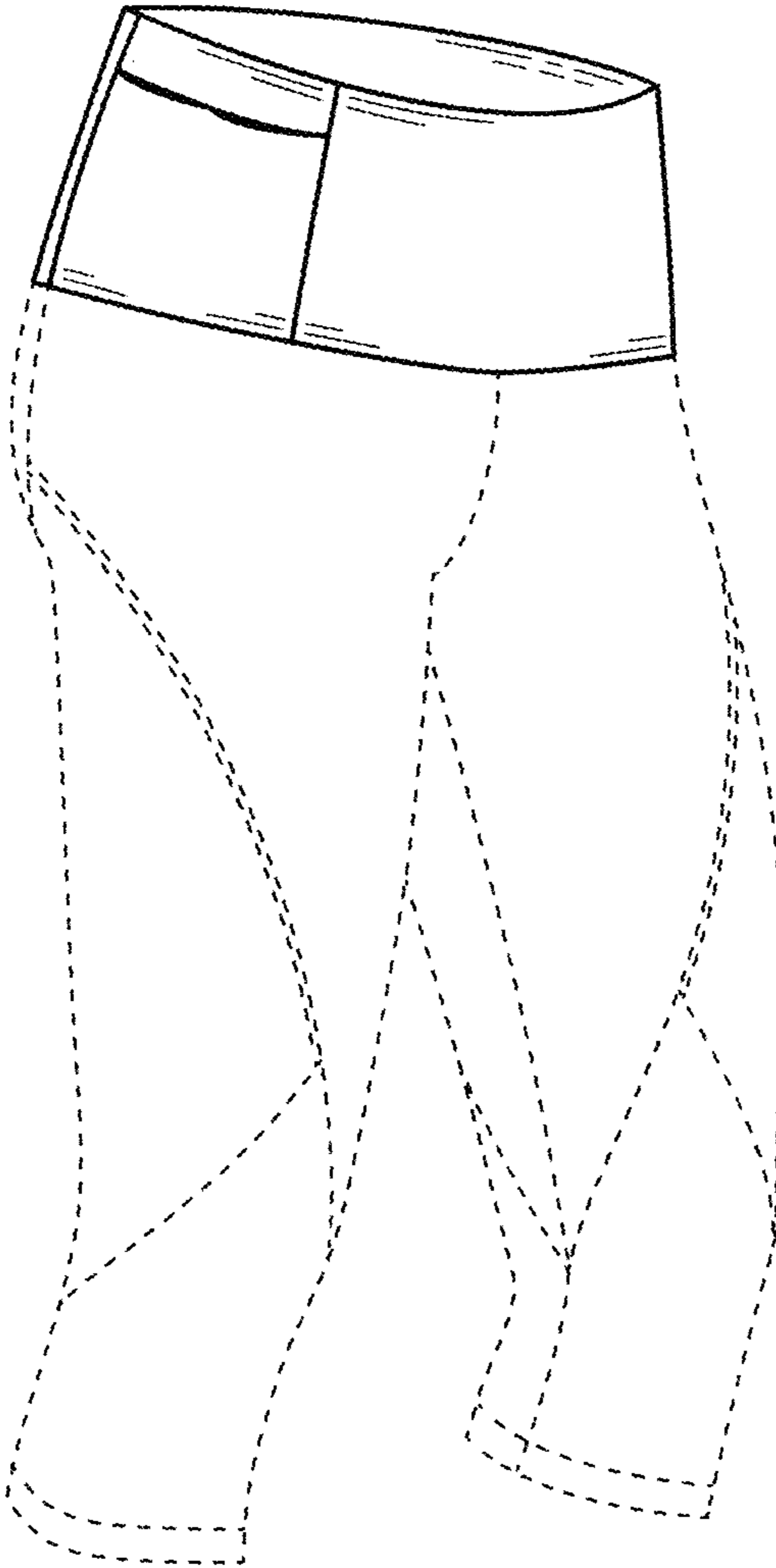

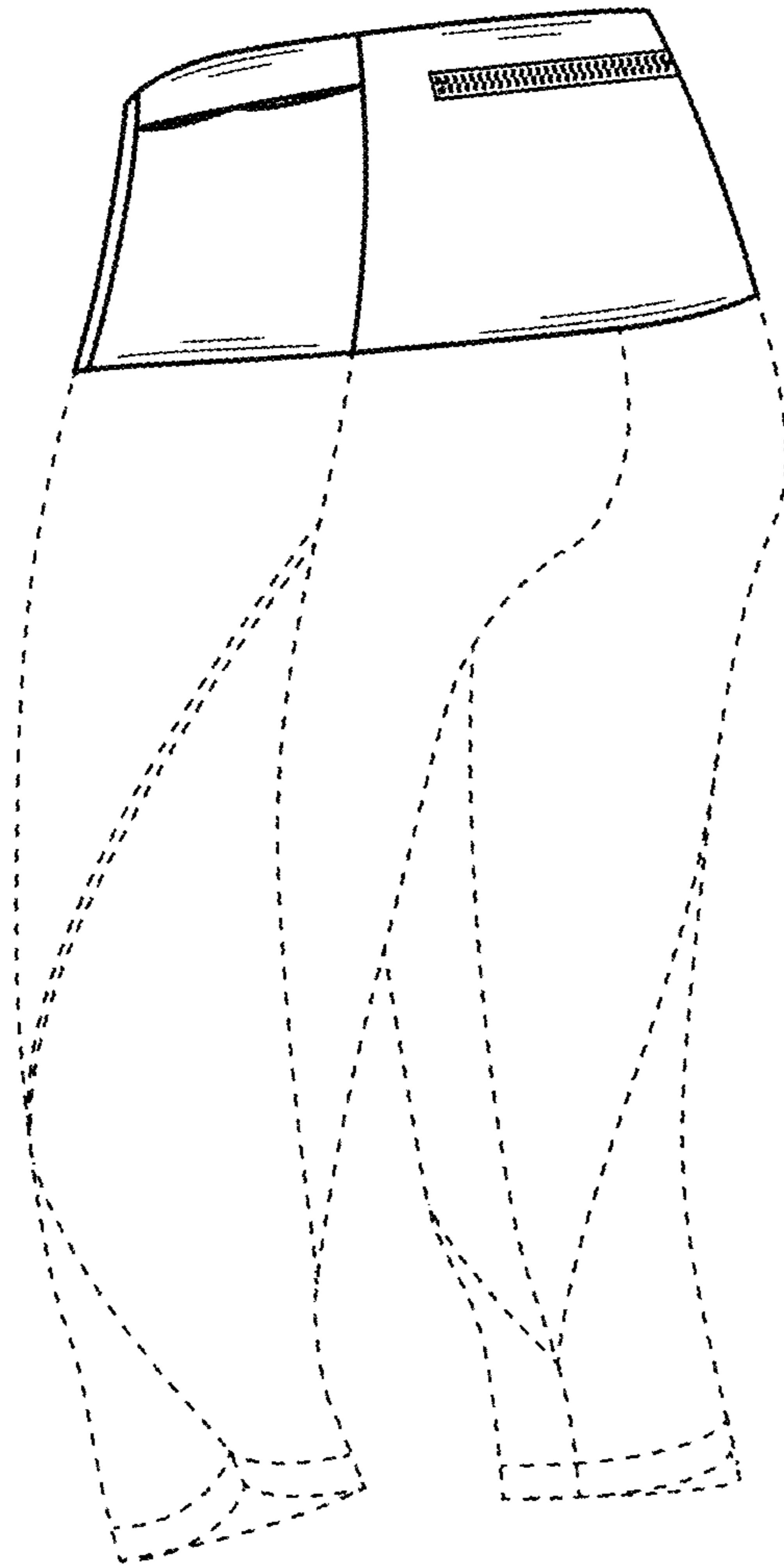

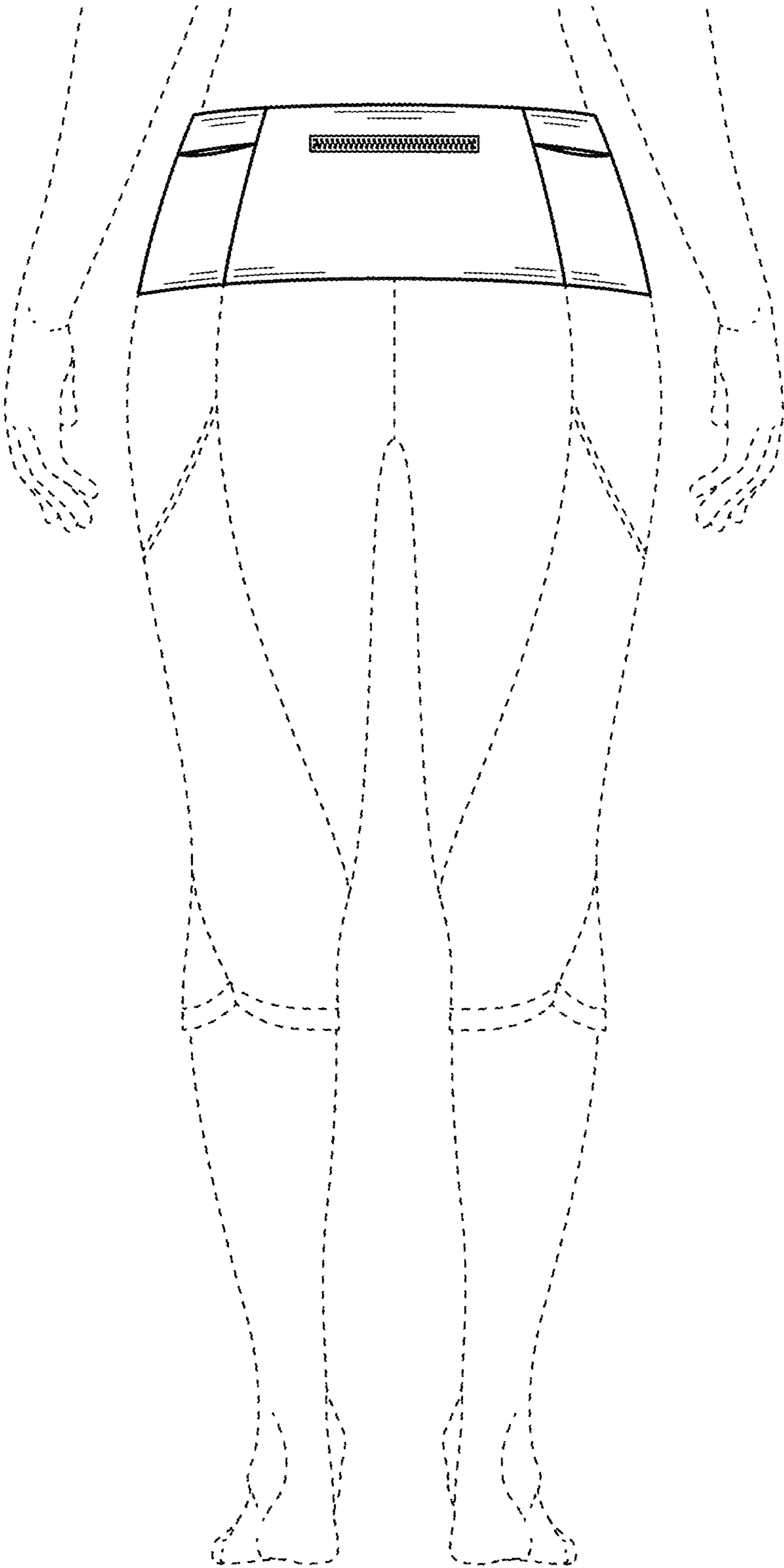
