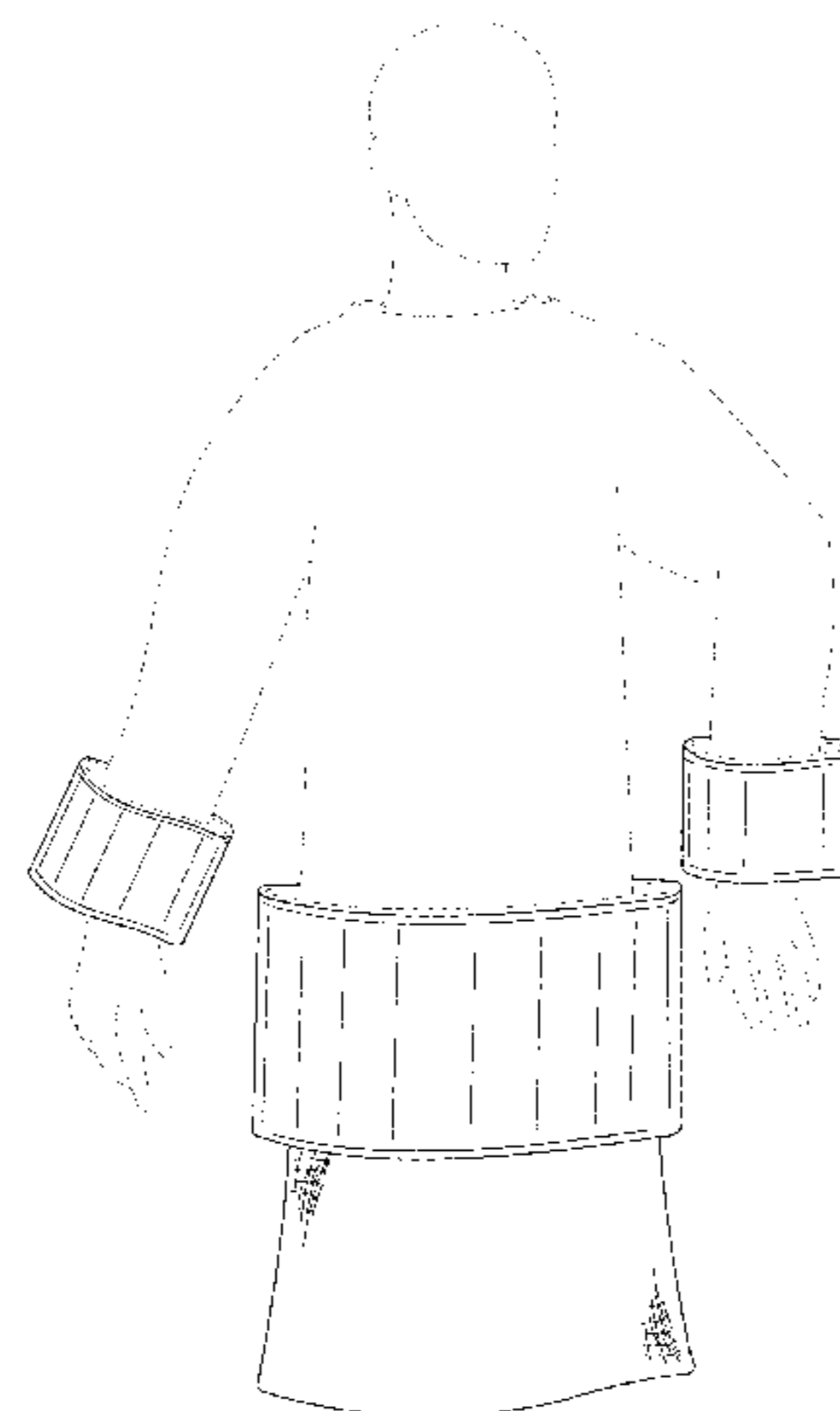
(57) **CLAIM**

The ornamental design for a bib garment with extension, as shown and described.

DESCRIPTION

FIG. 1 is an environmental perspective view of a bib garment with extension design in use on a person; FIG. 2 is a perspective view of the bib garment with extension design; FIG. 3 is a front view thereof; FIG. 4 is a back view thereof; FIG. 5 is a top view thereof; FIG. 6 is a bottom view thereof; FIG. 7 is a right side view thereof; FIG. 8 is a left side view thereof; FIG. 9 is a cross sectional top plan view taken along line 9-9 in FIG. 4, showing the waist pocket detail of the claimed design; and, FIG. 10 is a cross sectional top plan view taken along line 10-10 in FIG. 4, showing the wrist pocket detail of the claimed design. The broken lines shown in the drawings represent environment associated with the claimed design and form no part thereof.

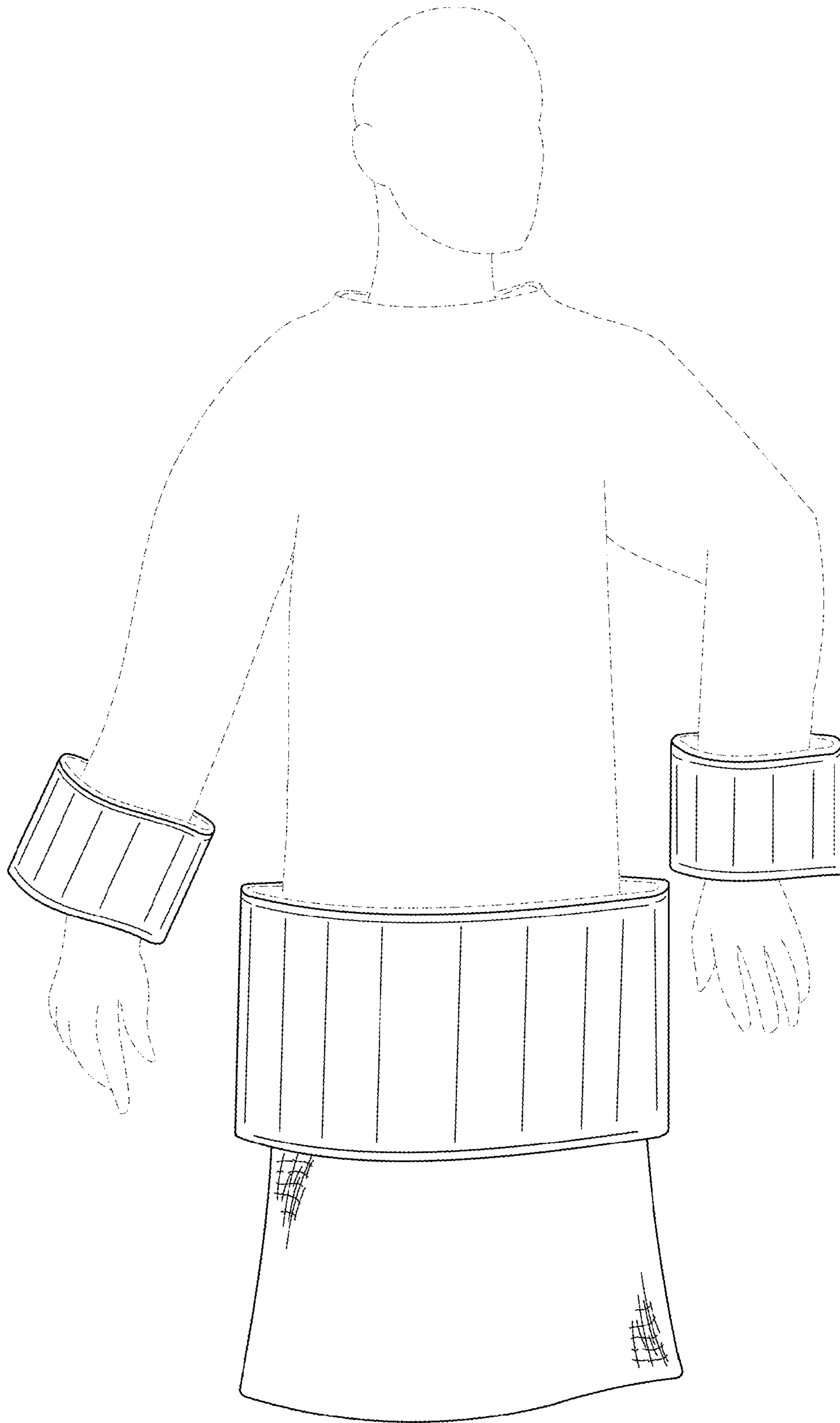

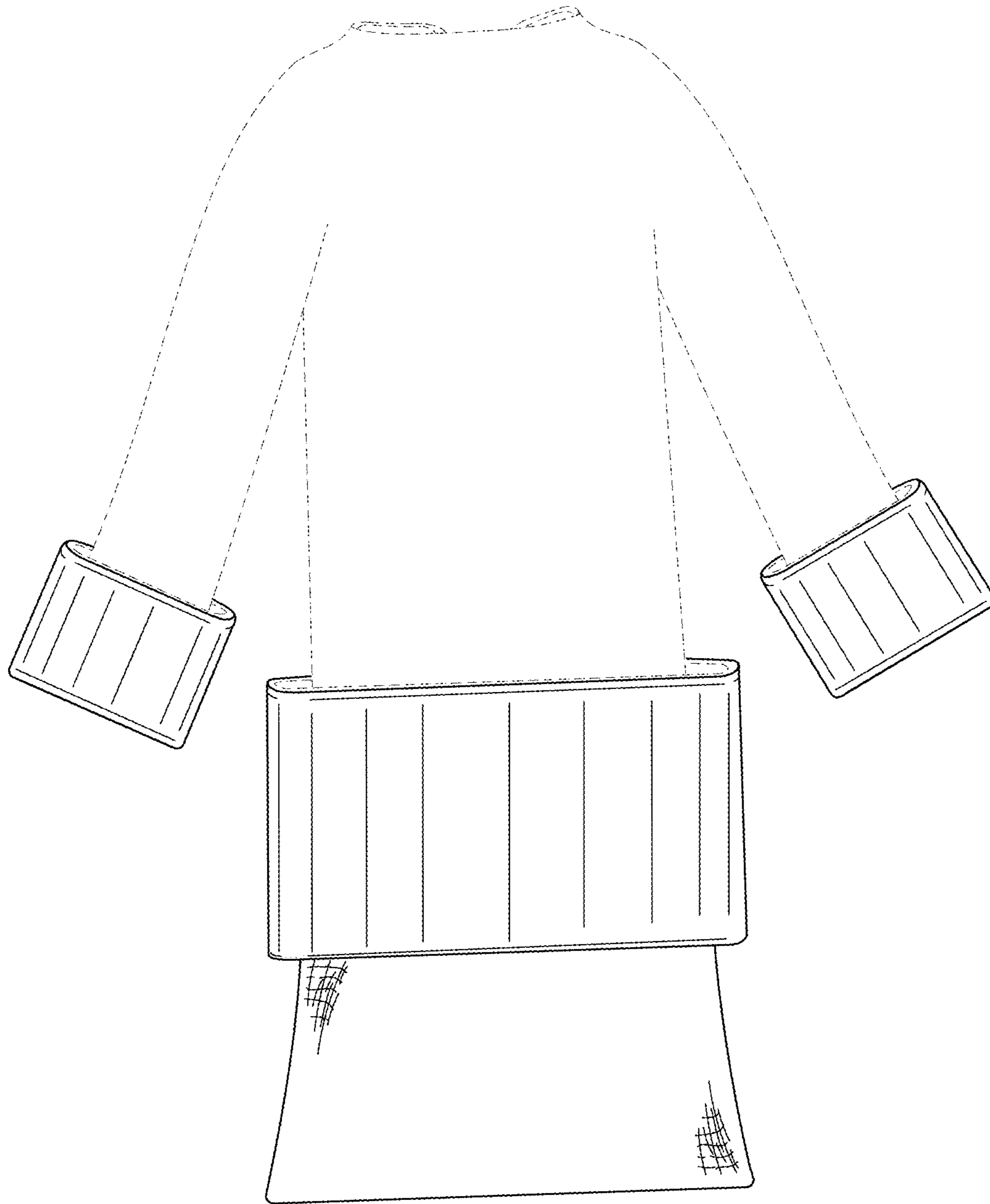

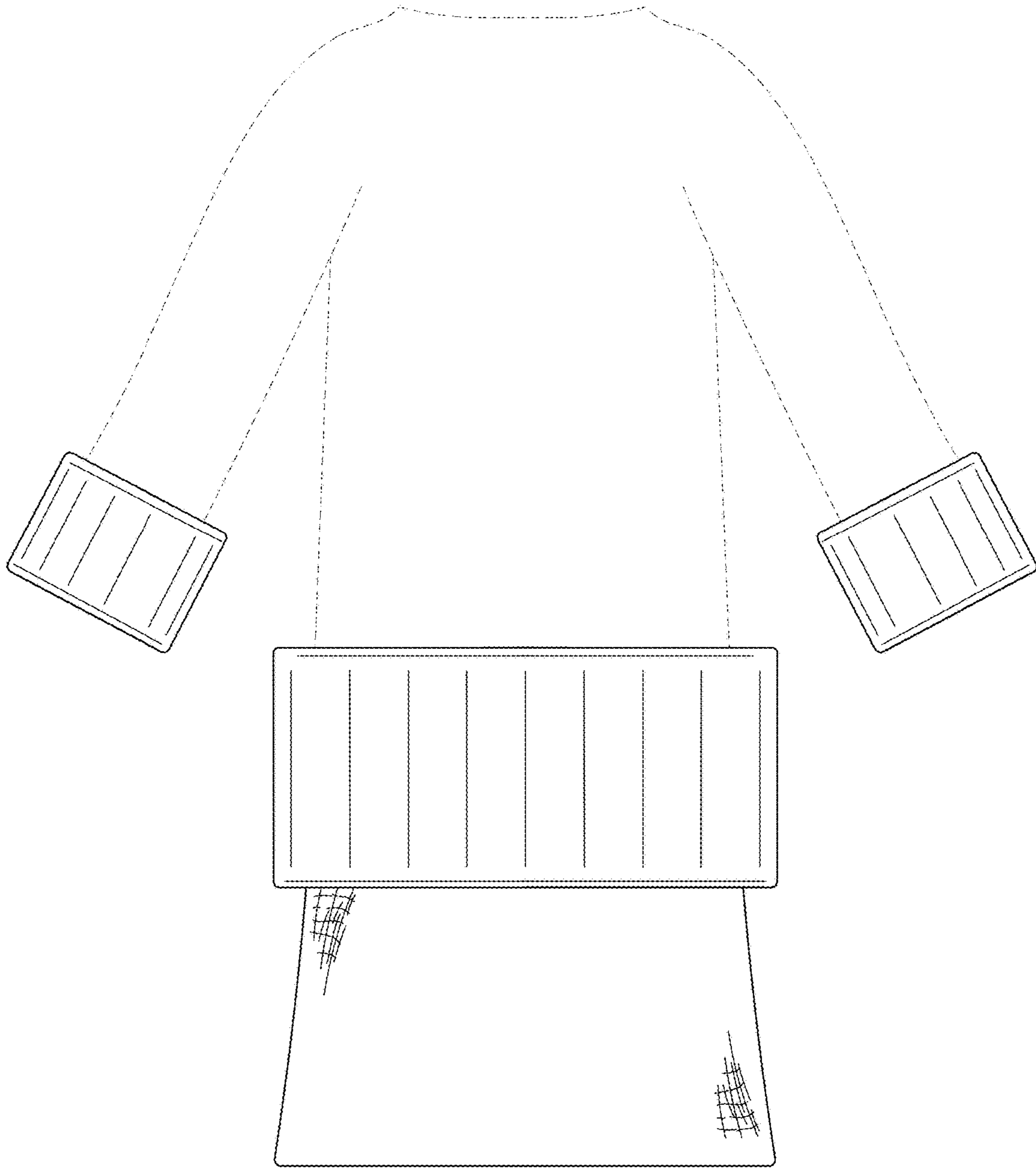

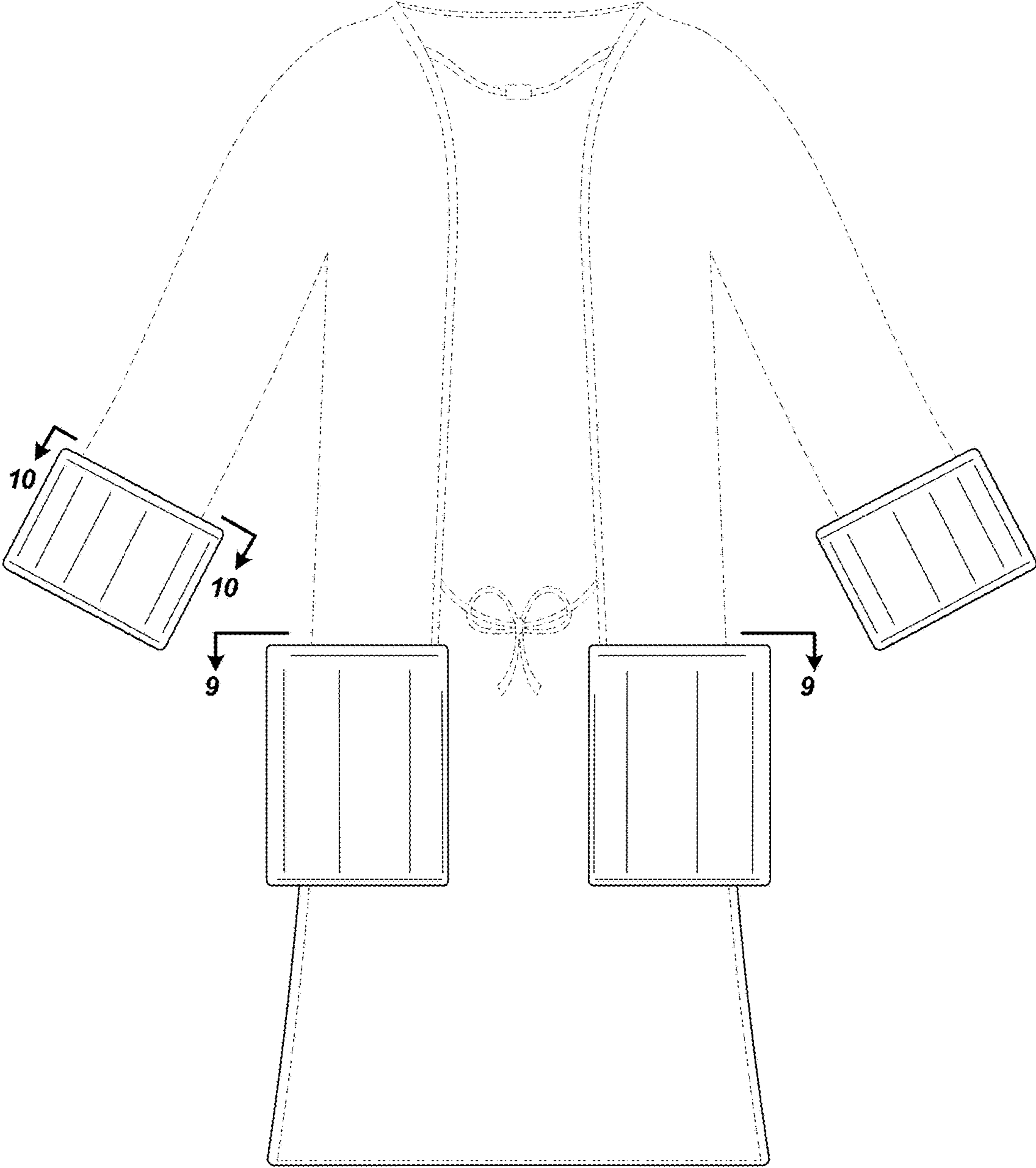

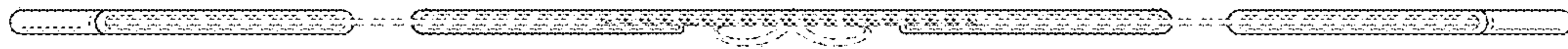

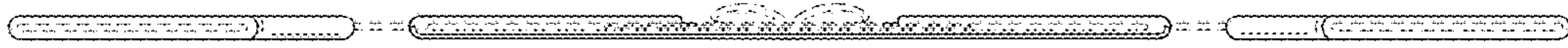

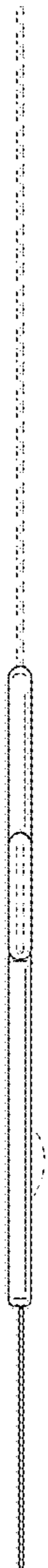

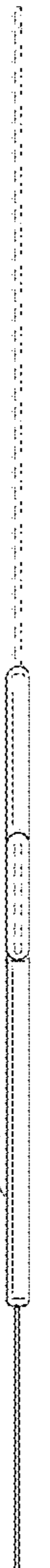

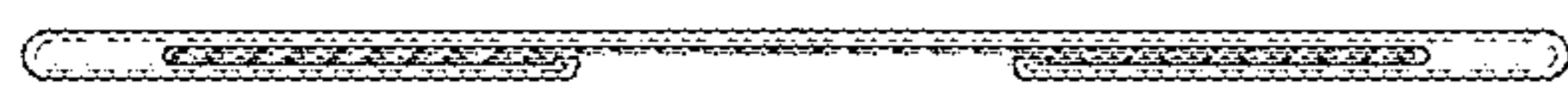

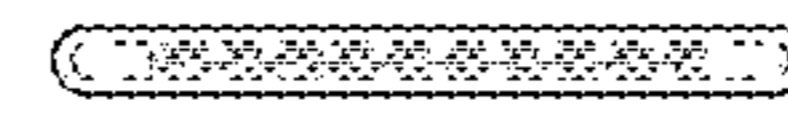
