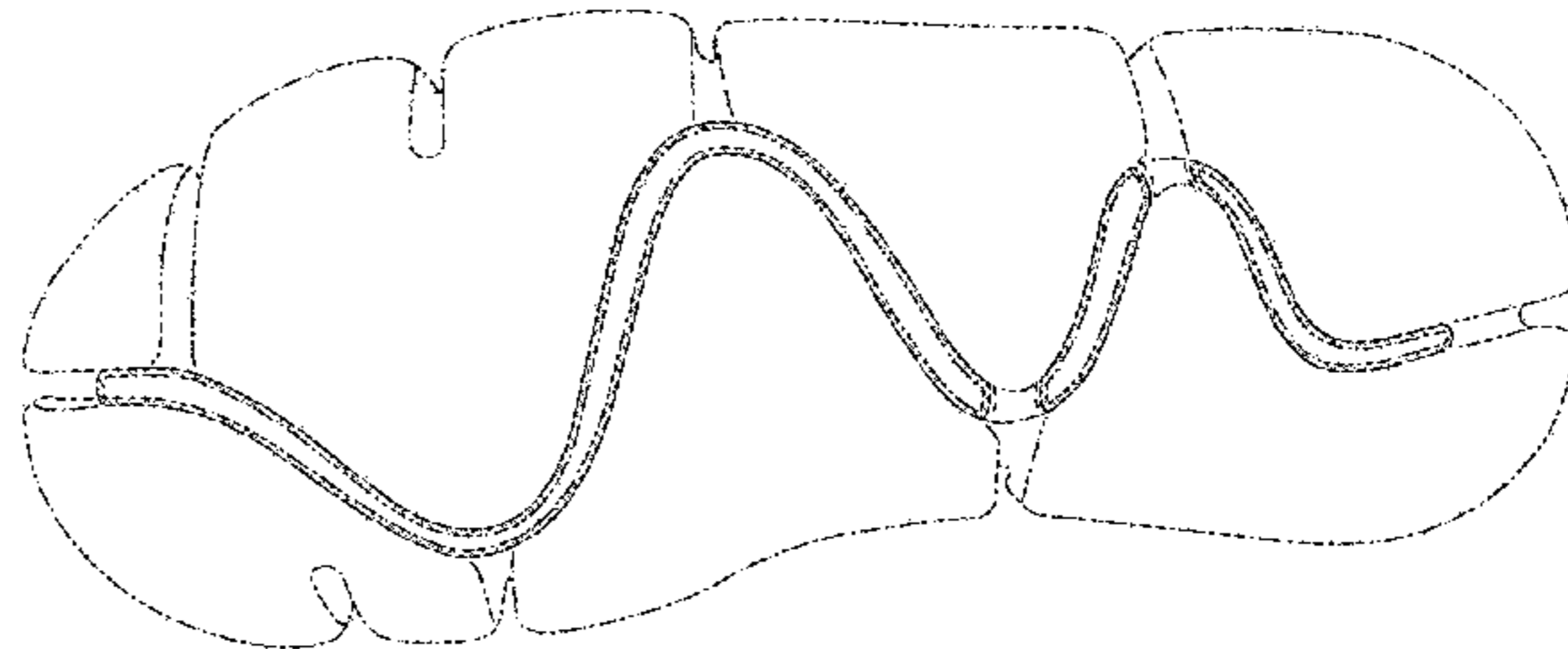
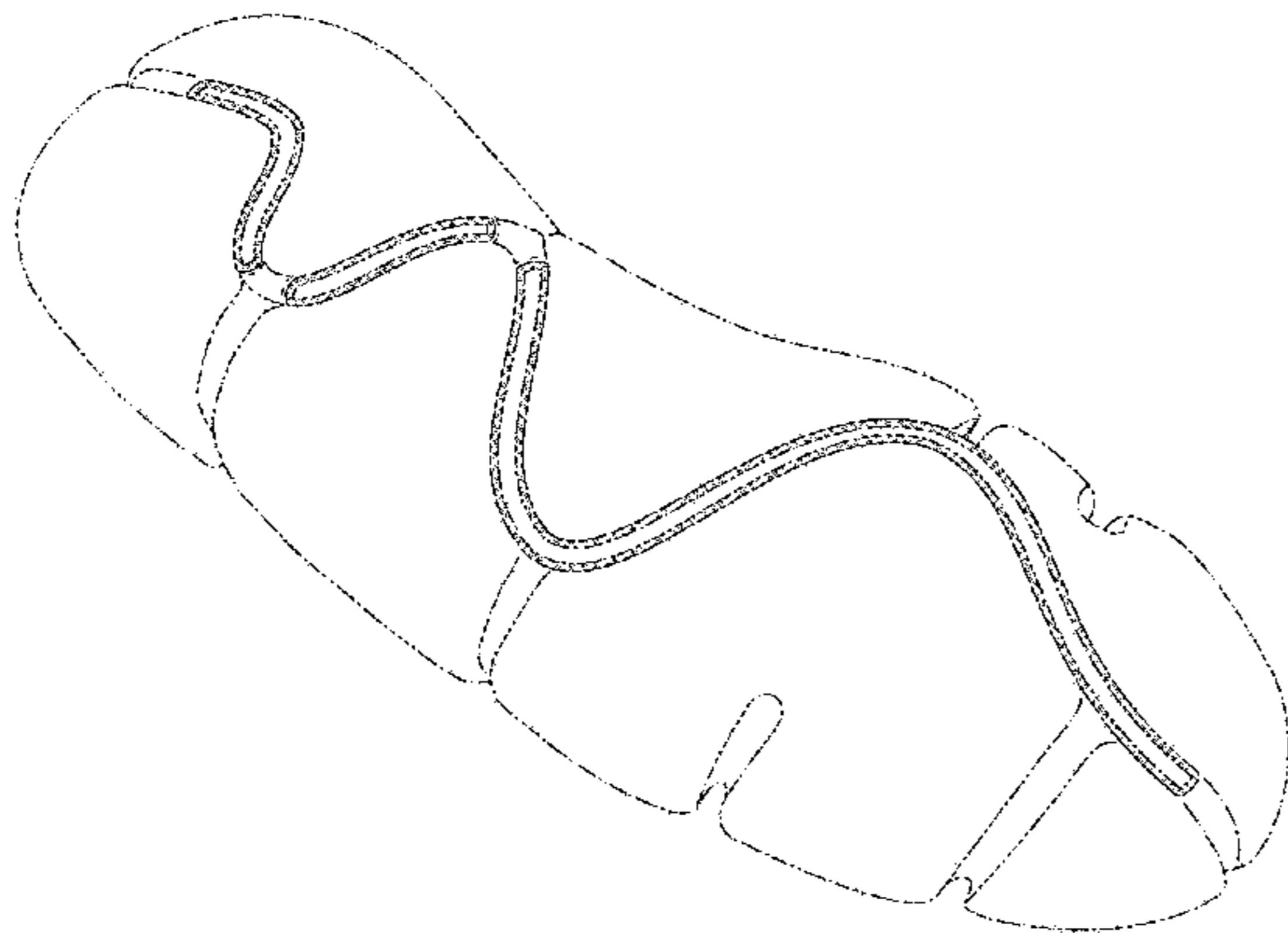
(57) **CLAIM**

The ornamental design for a shoe, as shown and described.

**DESCRIPTION**

FIG. 1 is a front perspective view of a shoe showing our new design;  
 FIG. 2 is a second front perspective view thereof;  
 FIG. 3 is a bottom view thereof;  
 FIG. 4 is a rear perspective view thereof; and,  
 FIG. 5 is a second rear perspective view thereof.  
 The broken lines immediately adjacent to and within the shaded area define the bounds of the claimed design and form no part thereof. The unshaded regions within the broken line areas form no part of the claimed design. The broken lines showing the remainder of the shoe represent unclaimed subject matter and form no part of the claimed design.

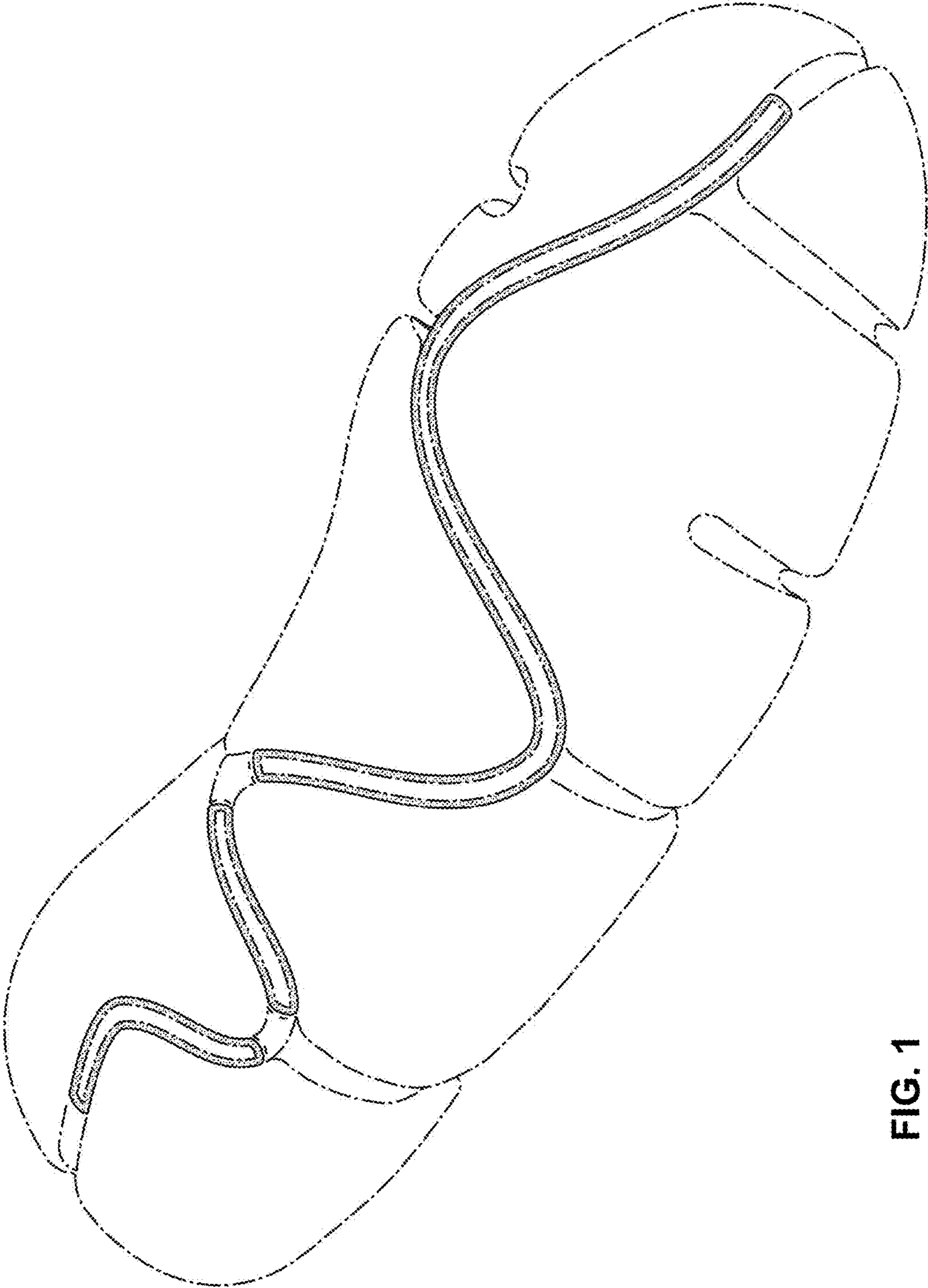

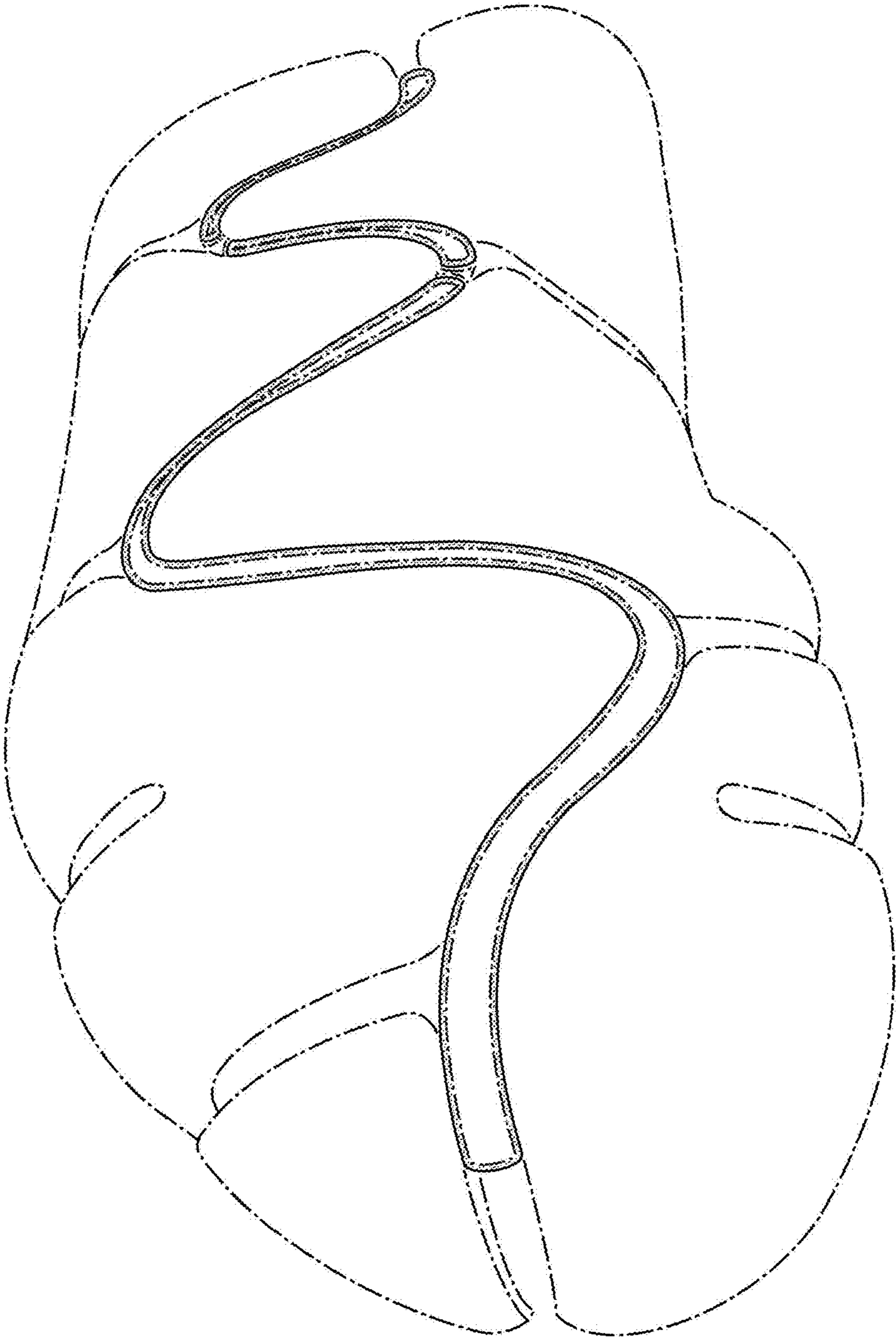

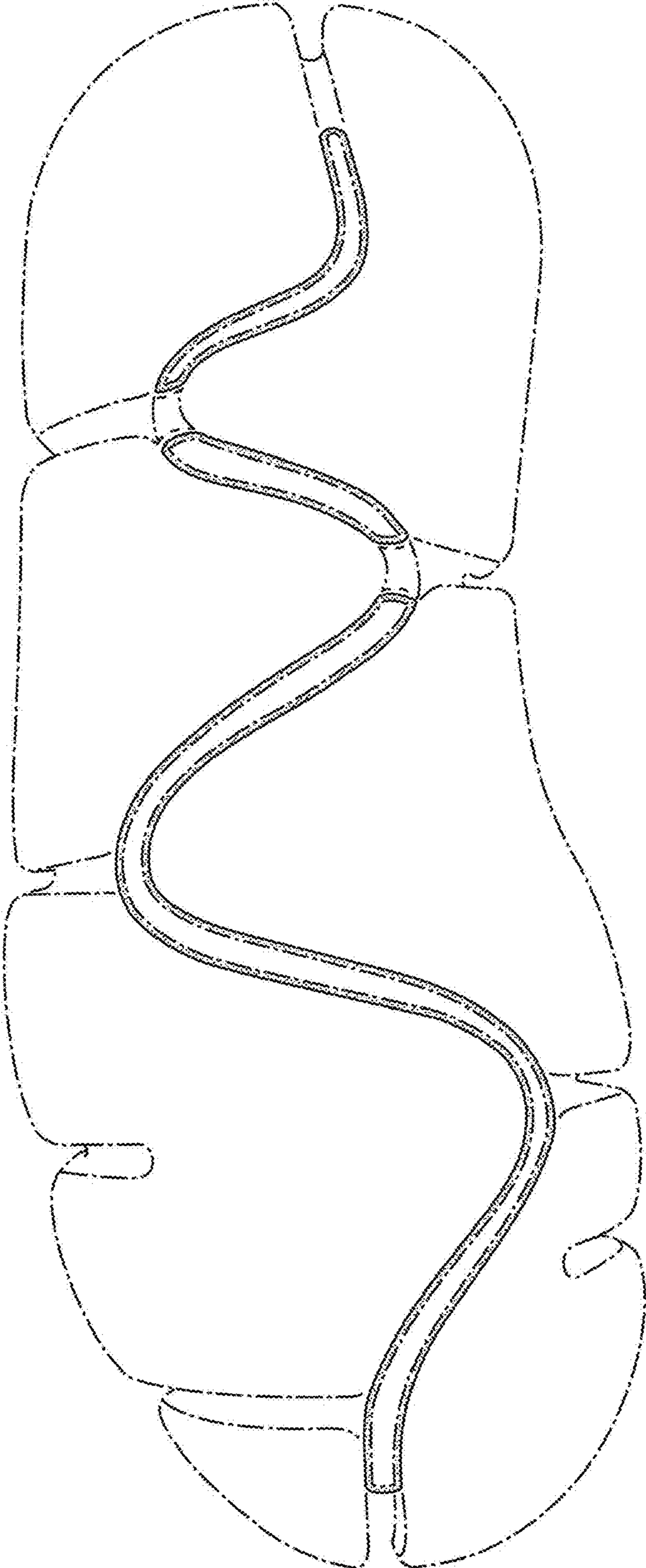

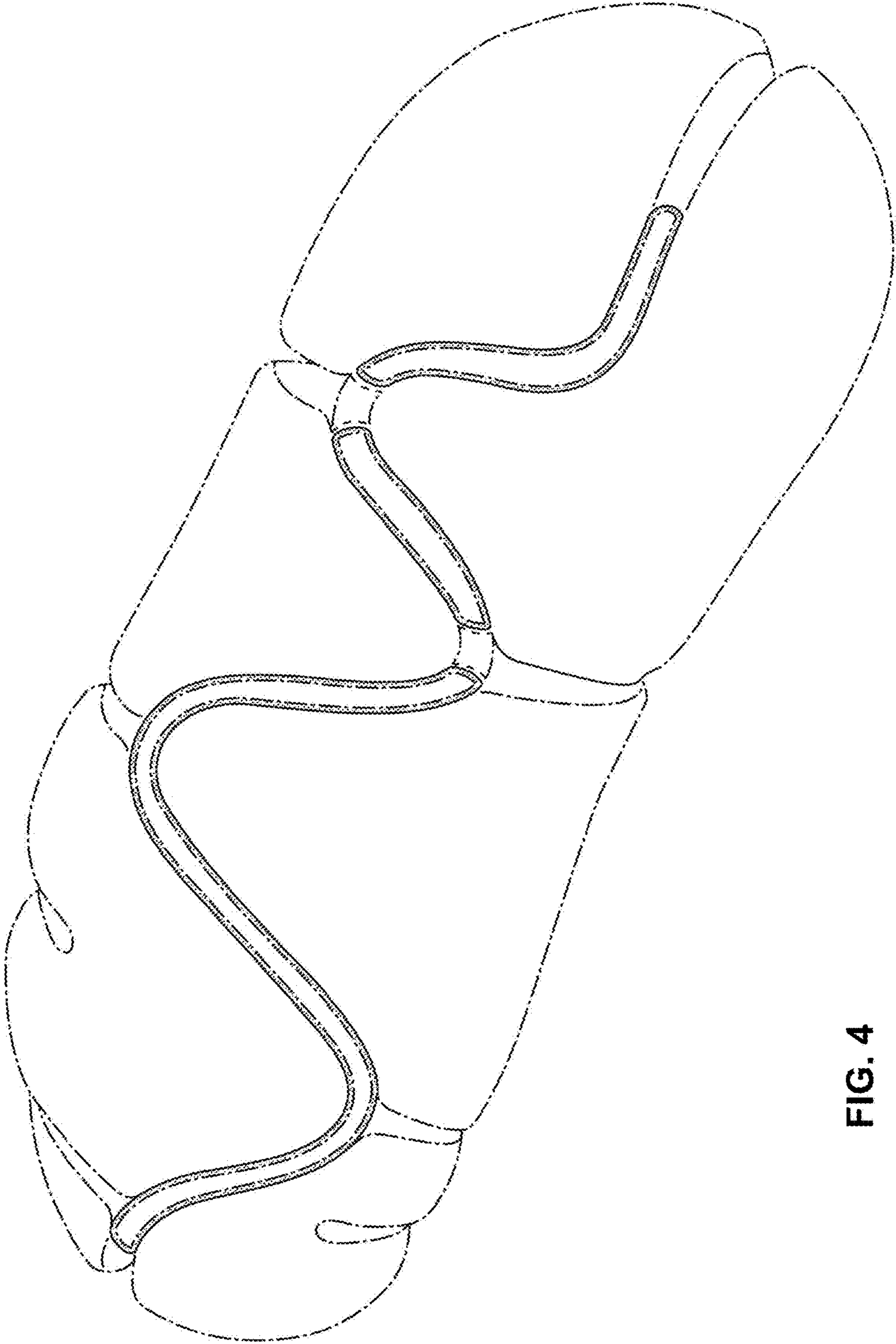

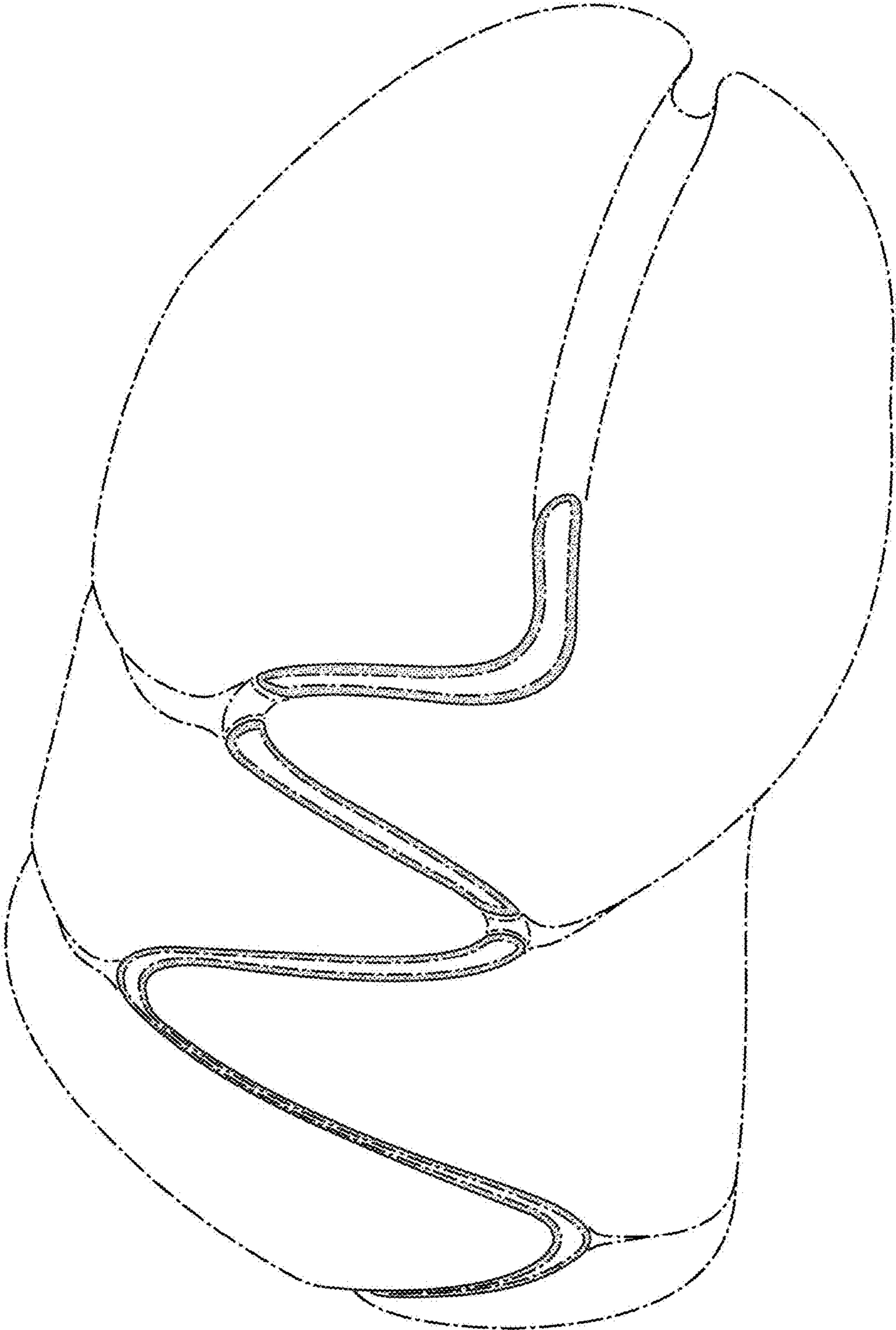
