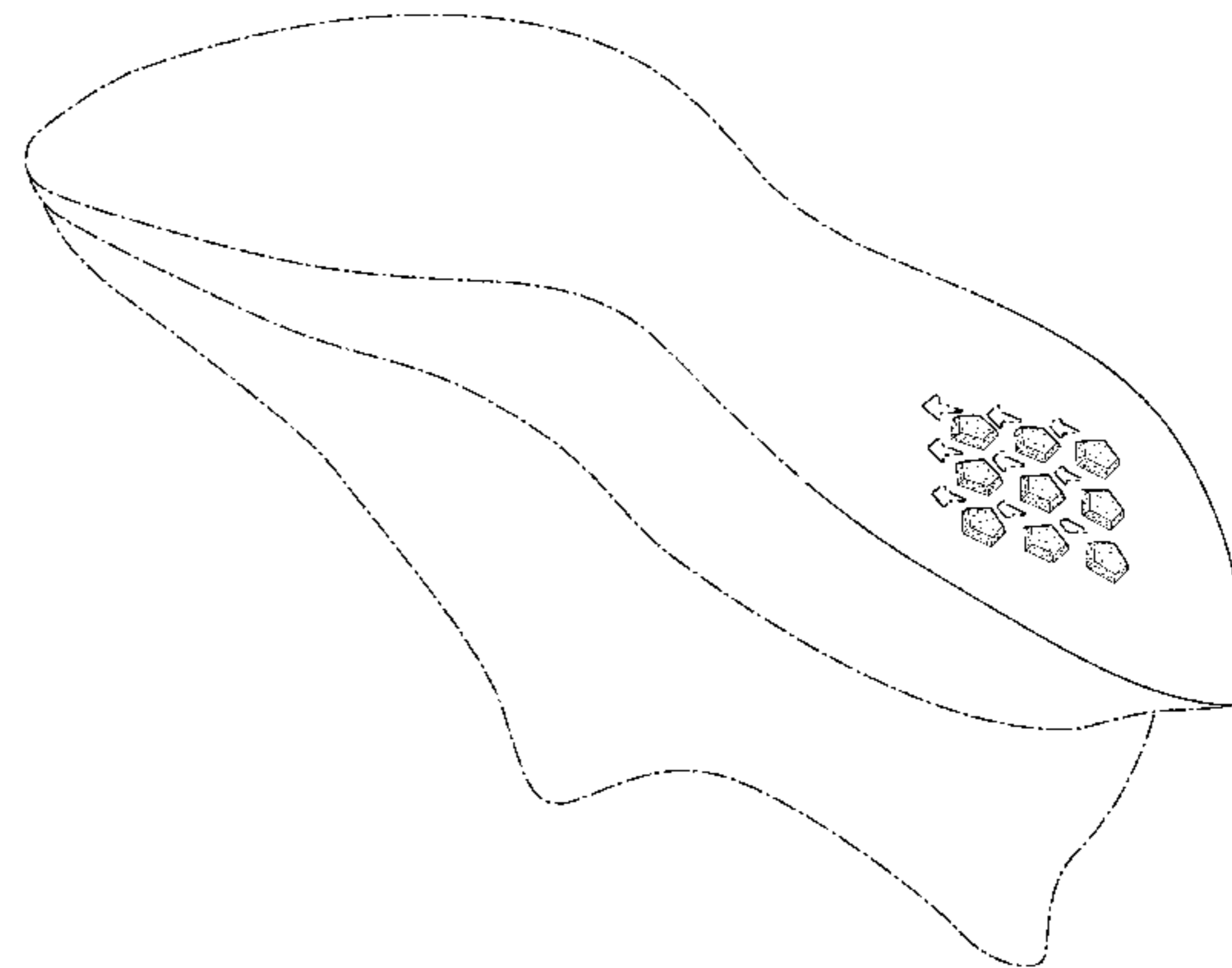
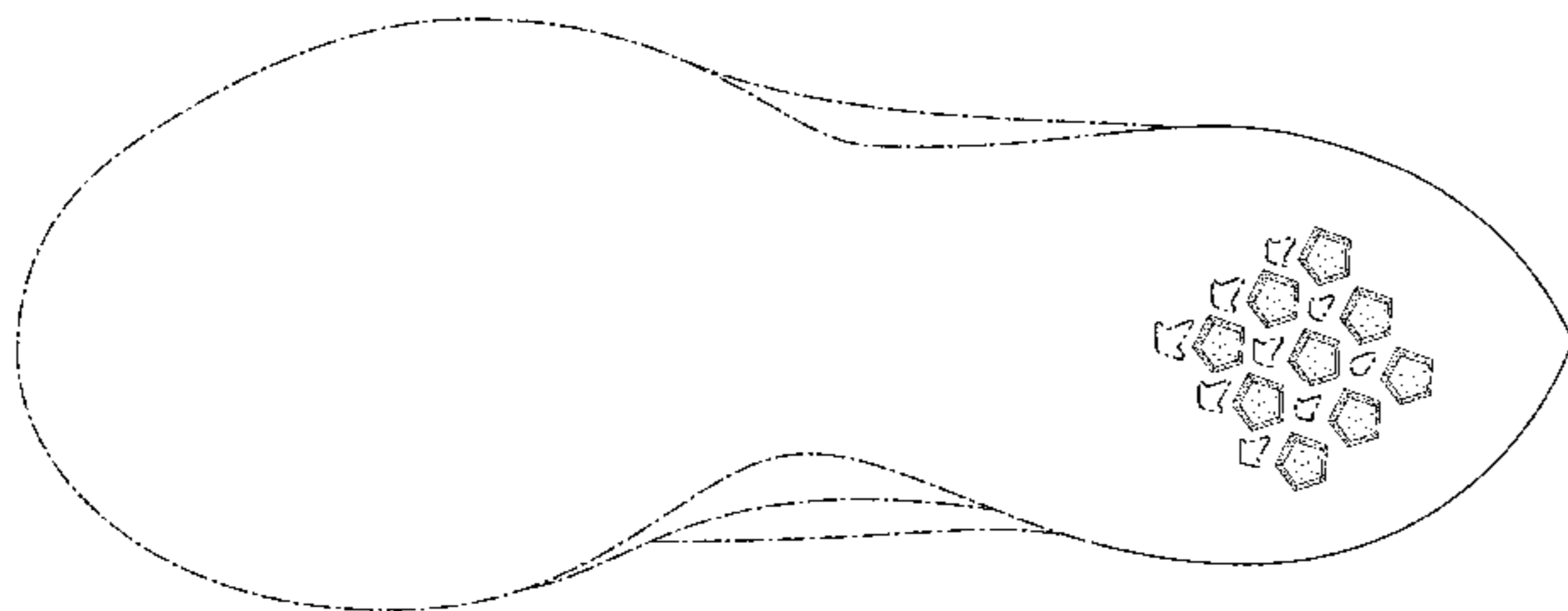
(57) **CLAIM**

The ornamental design for a shoe, as shown and described.

DESCRIPTION

FIG. 1 is a front perspective view of a shoe showing my new design;
FIG. 2 is a bottom view thereof; and,
FIG. 3 is a rear perspective view thereof.
The nine shaded areas are claimed. The solid line that is not immediately adjacent to the nine shaded areas is claimed. The broken lines showing the remainder of the shoe represent unclaimed subject matter and form no part of the claimed design.

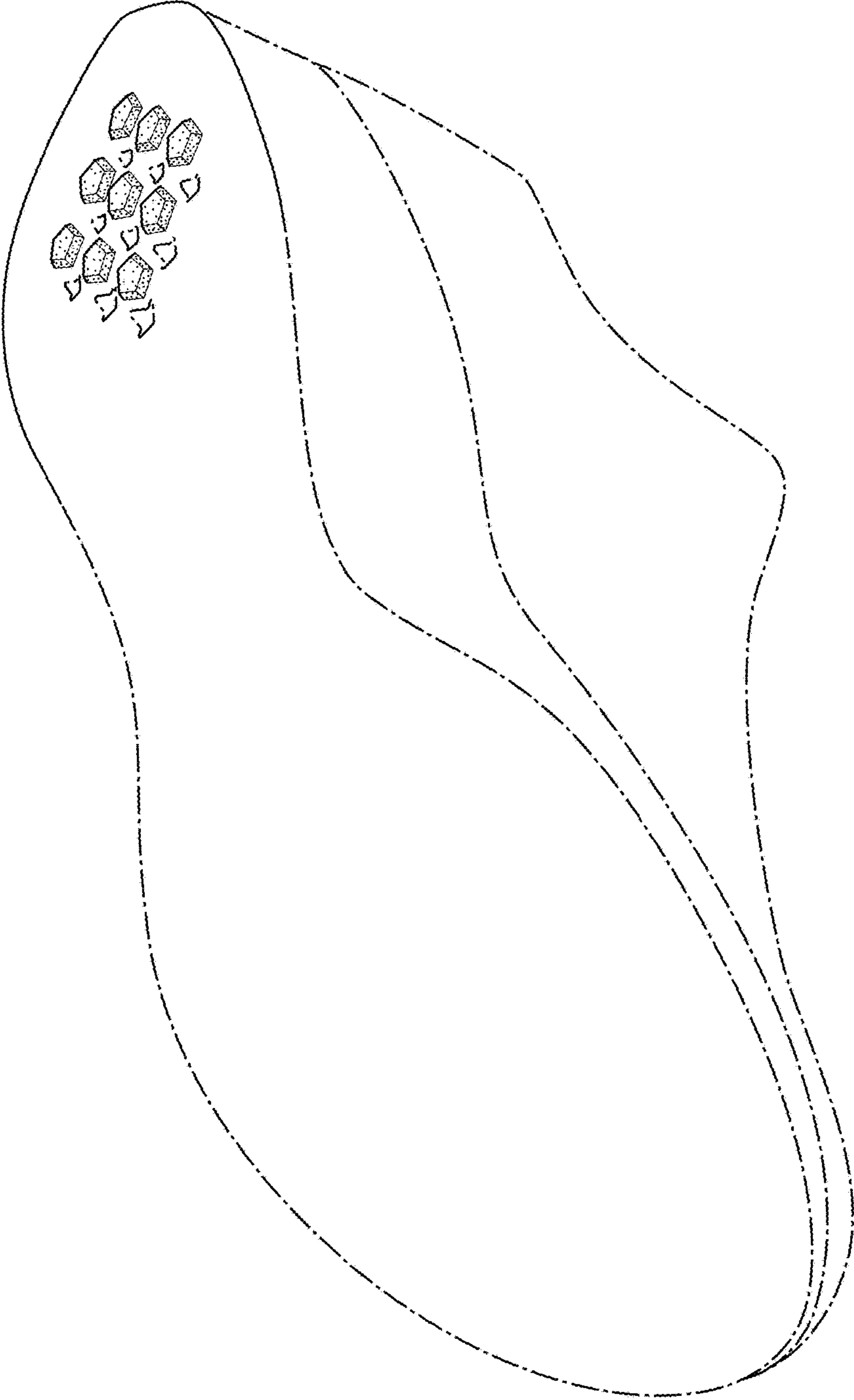

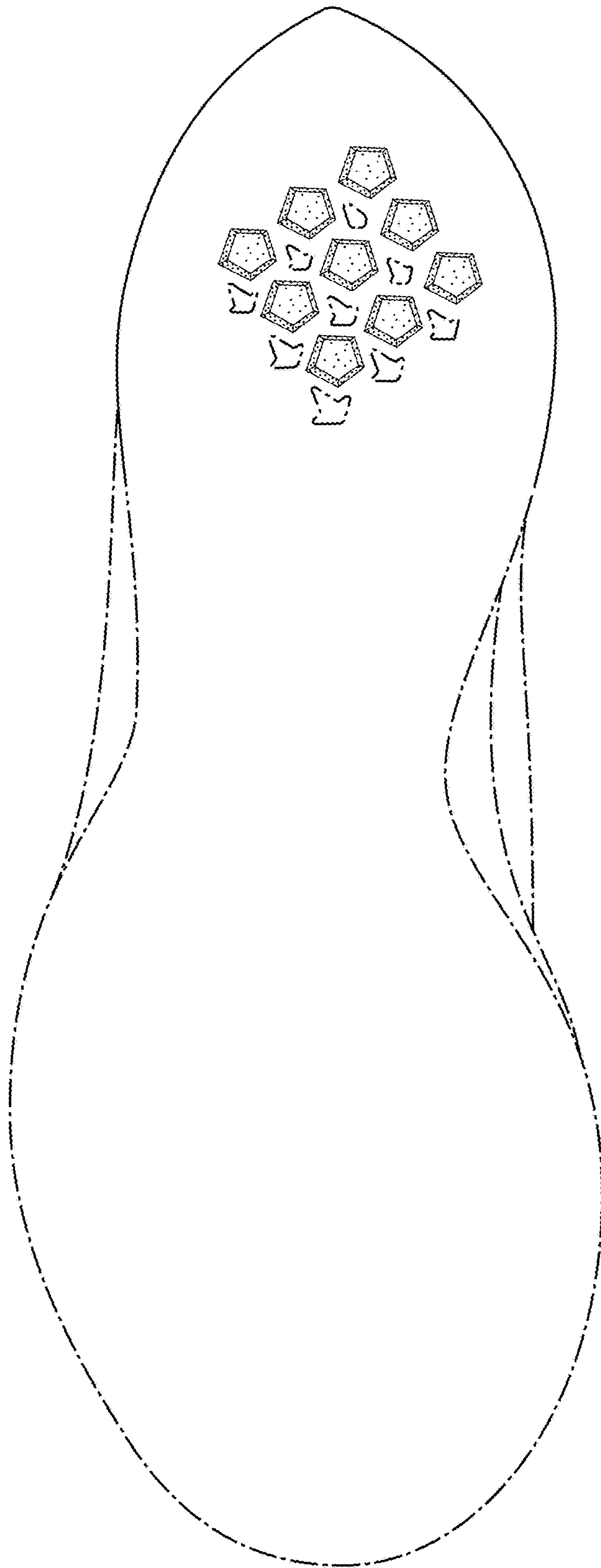

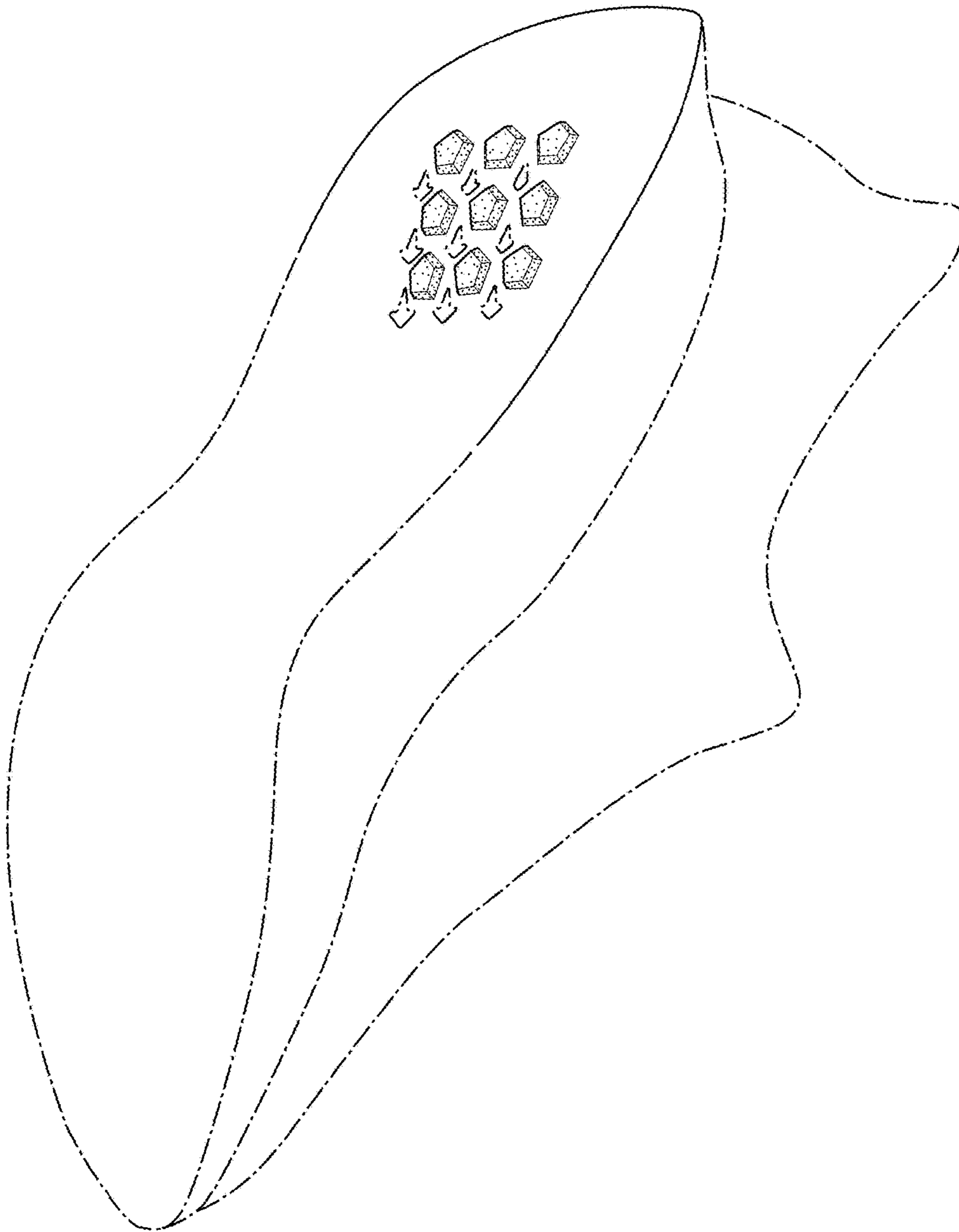
