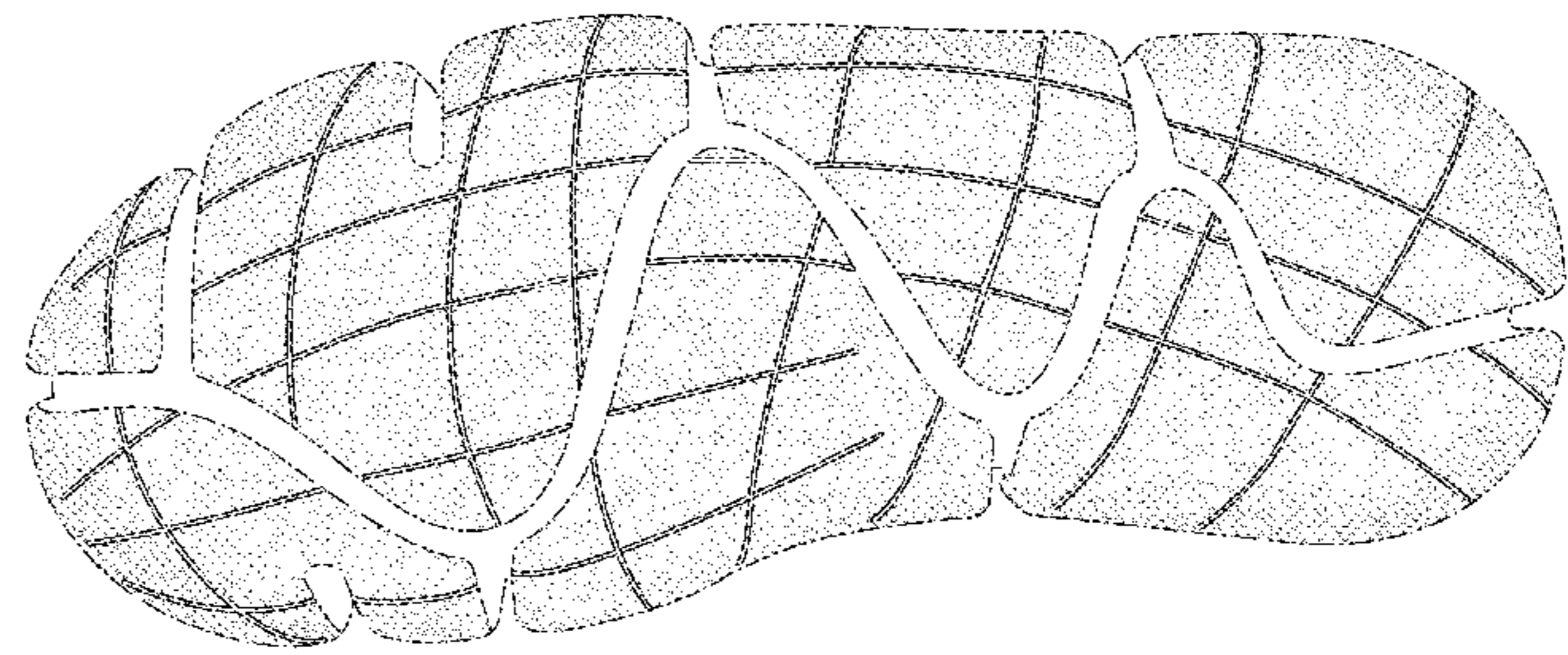
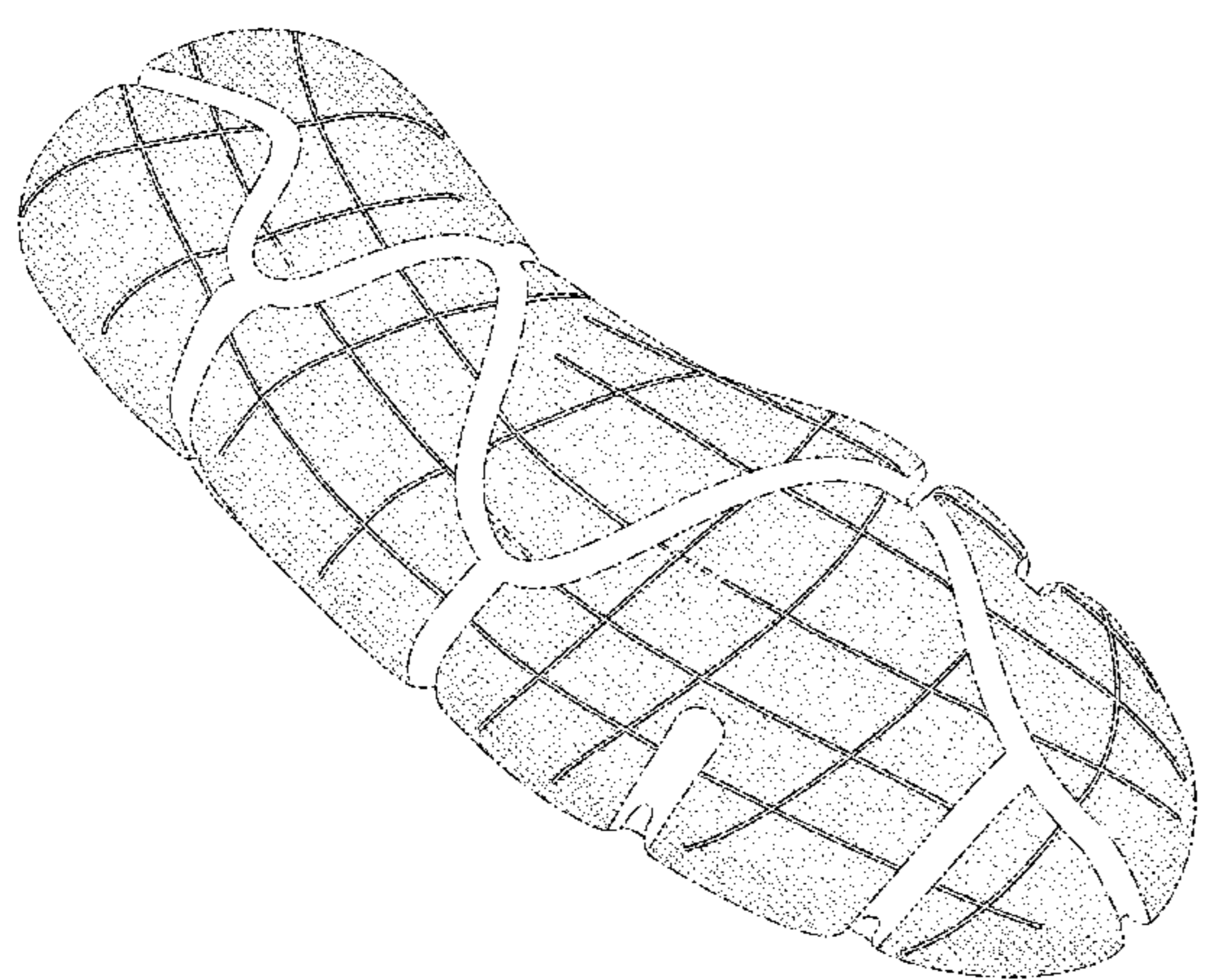

DESCRIPTION

The broken lines showing the remainder of the shoe represent unclaimed subject matter and form no part of the claimed design.

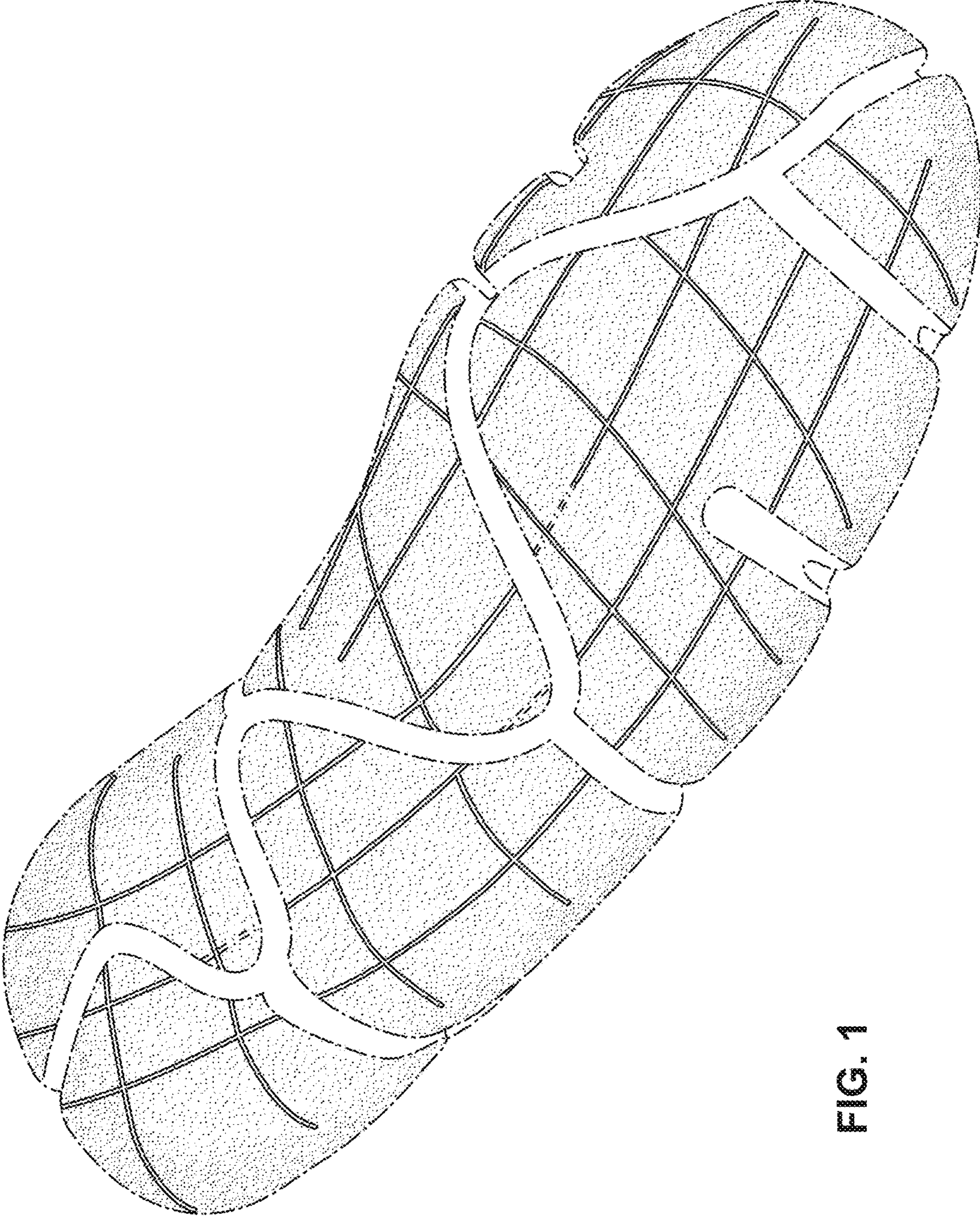

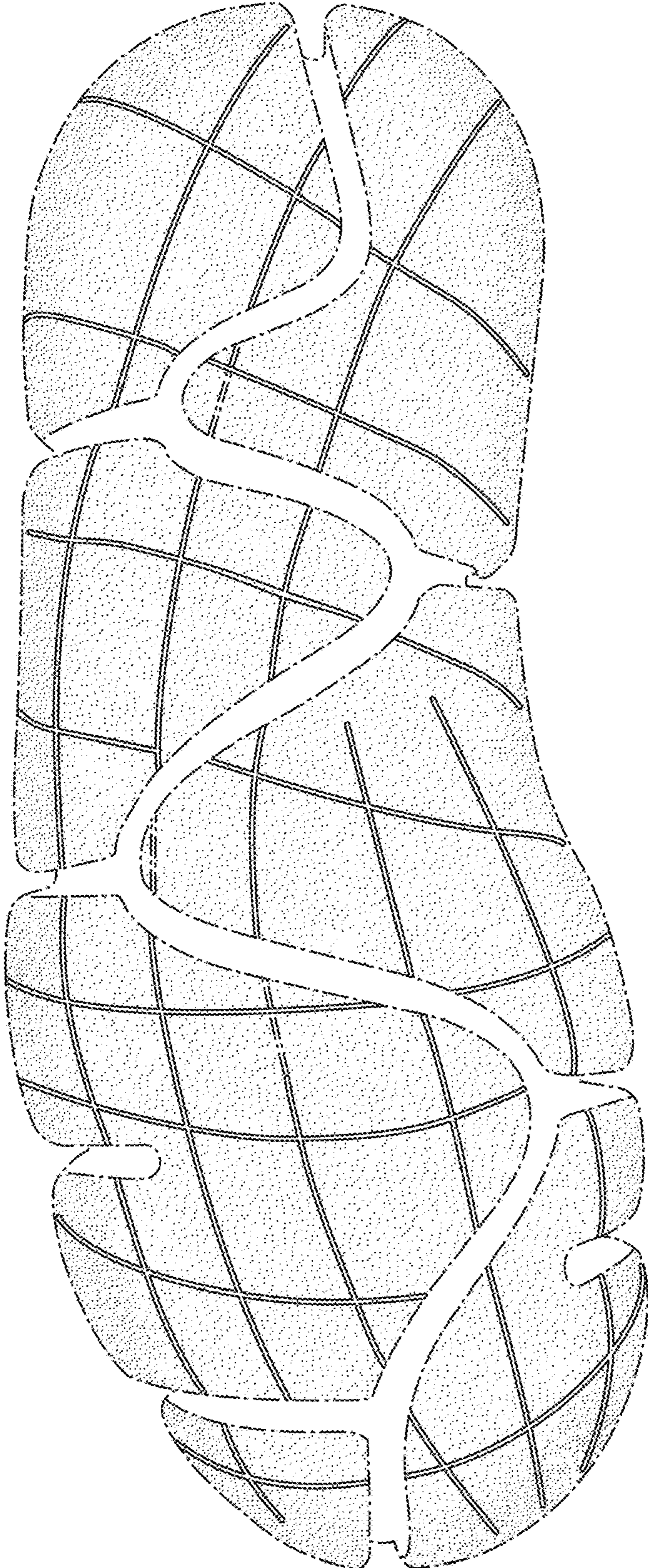

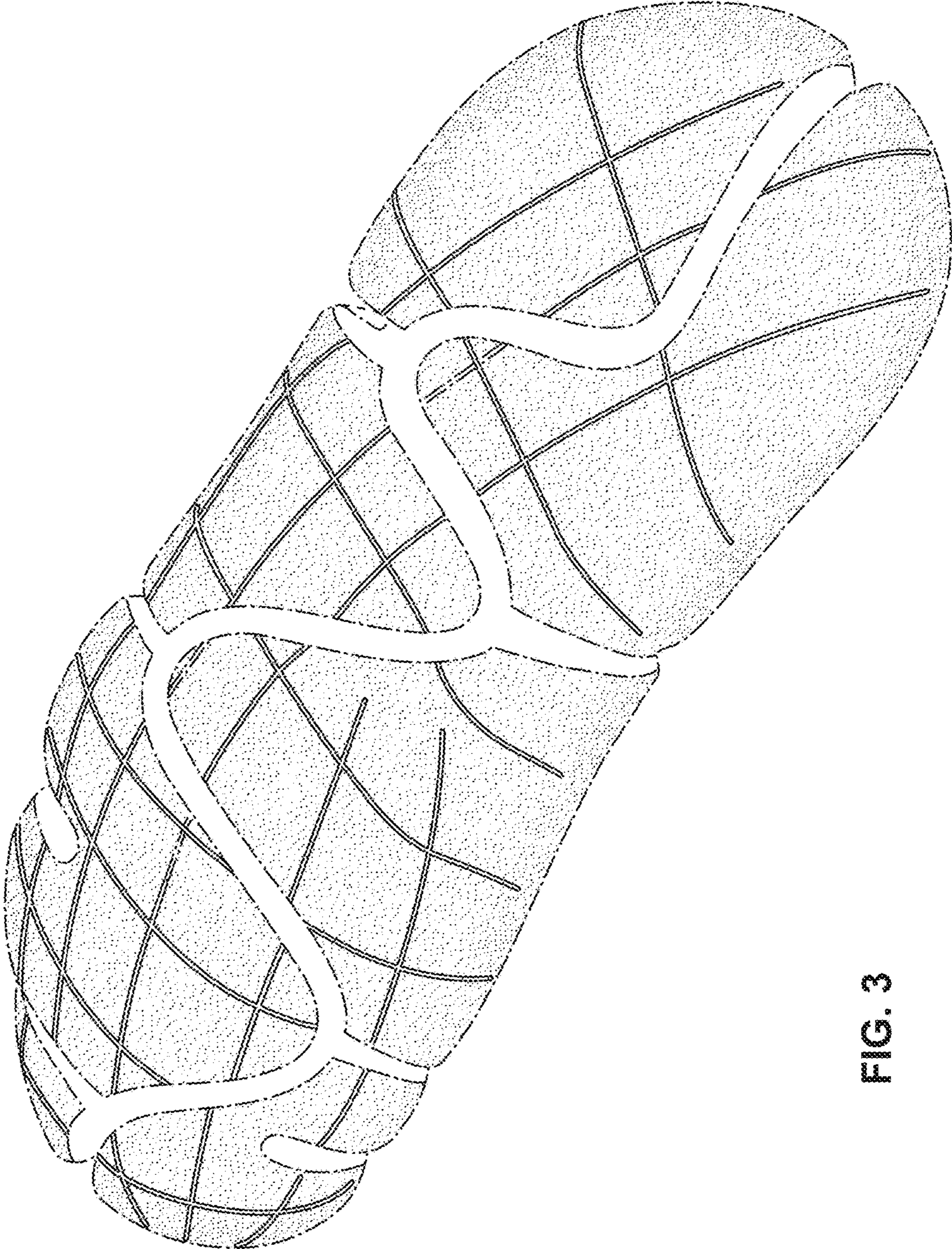

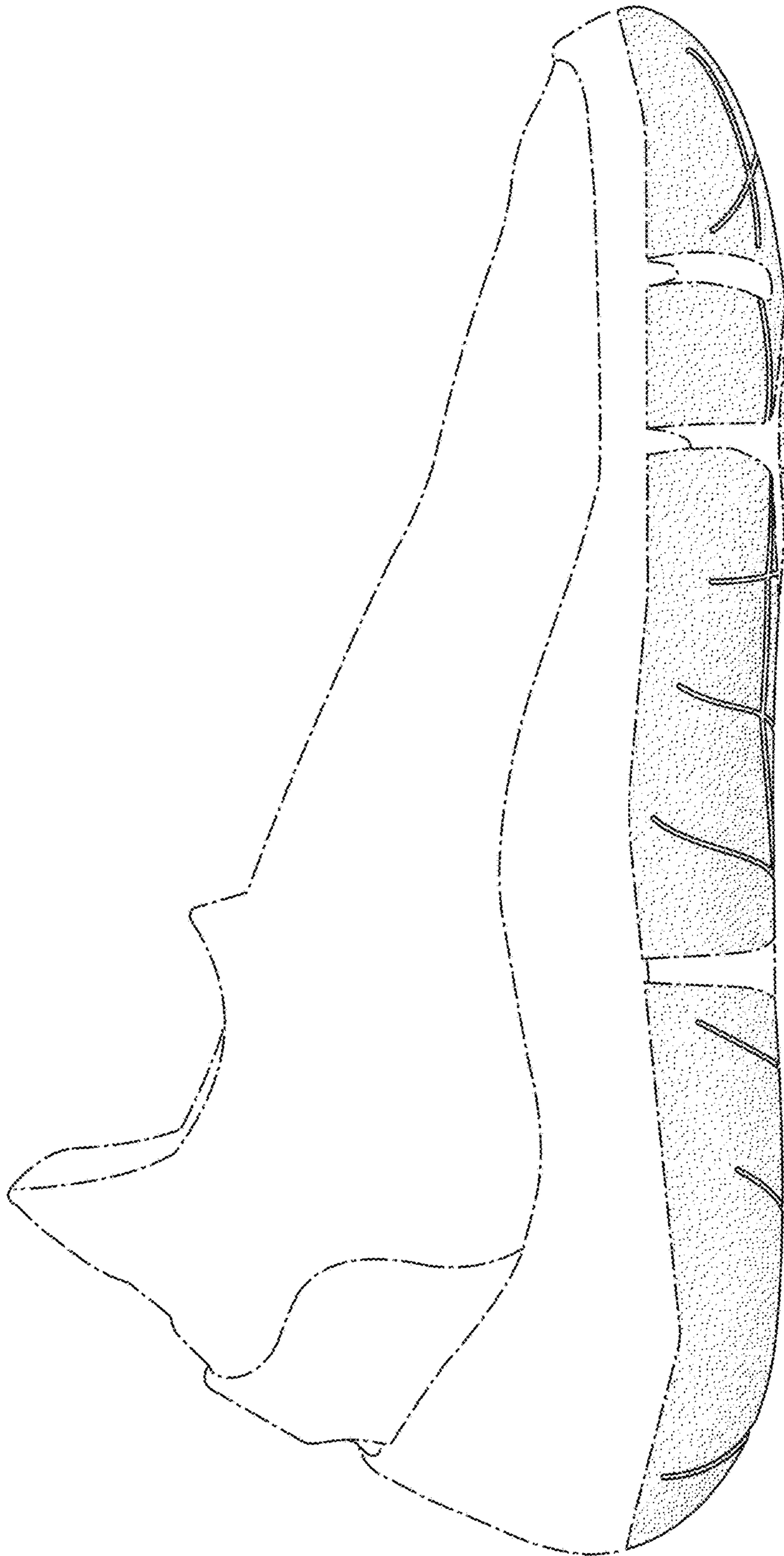

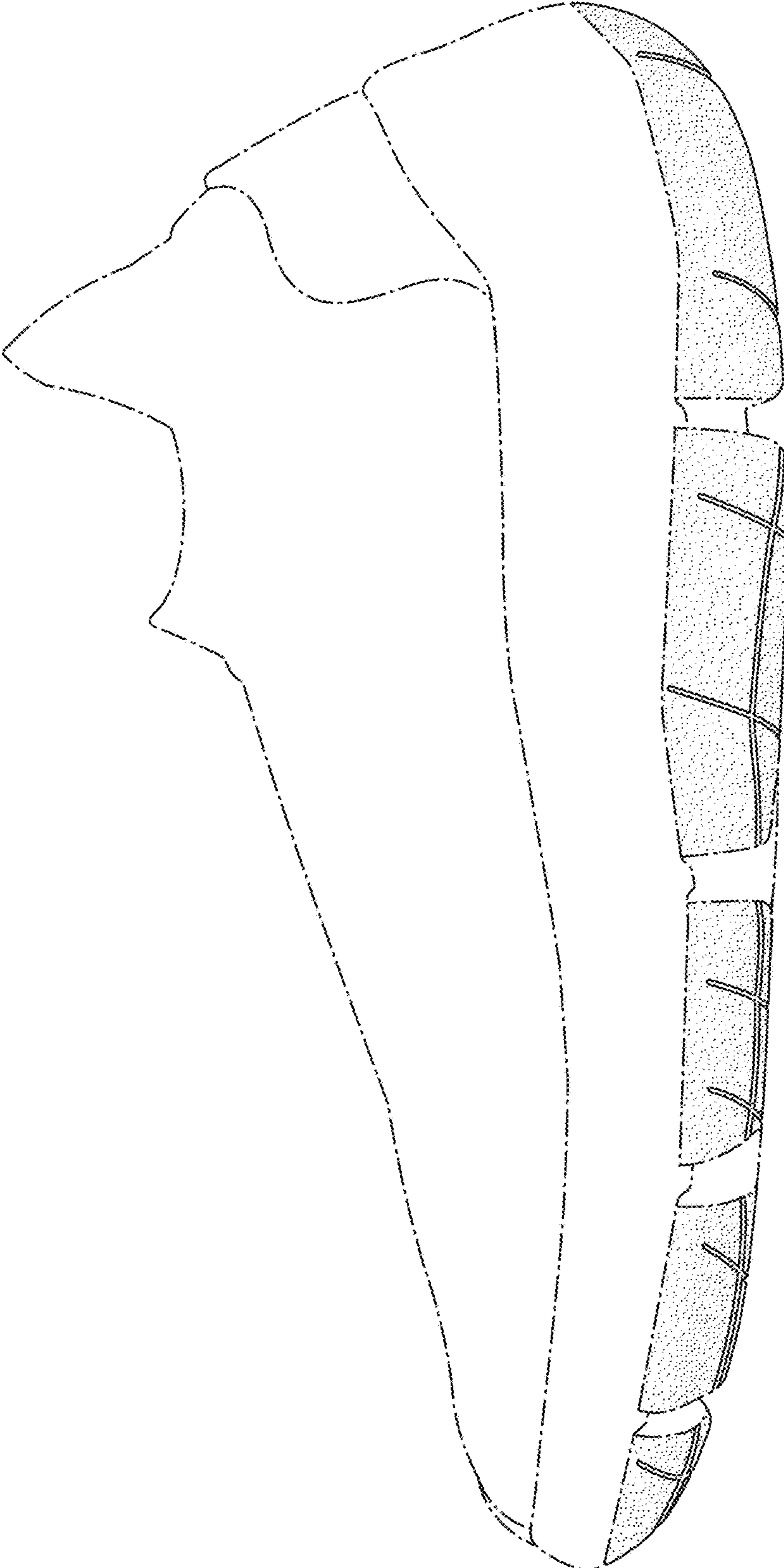

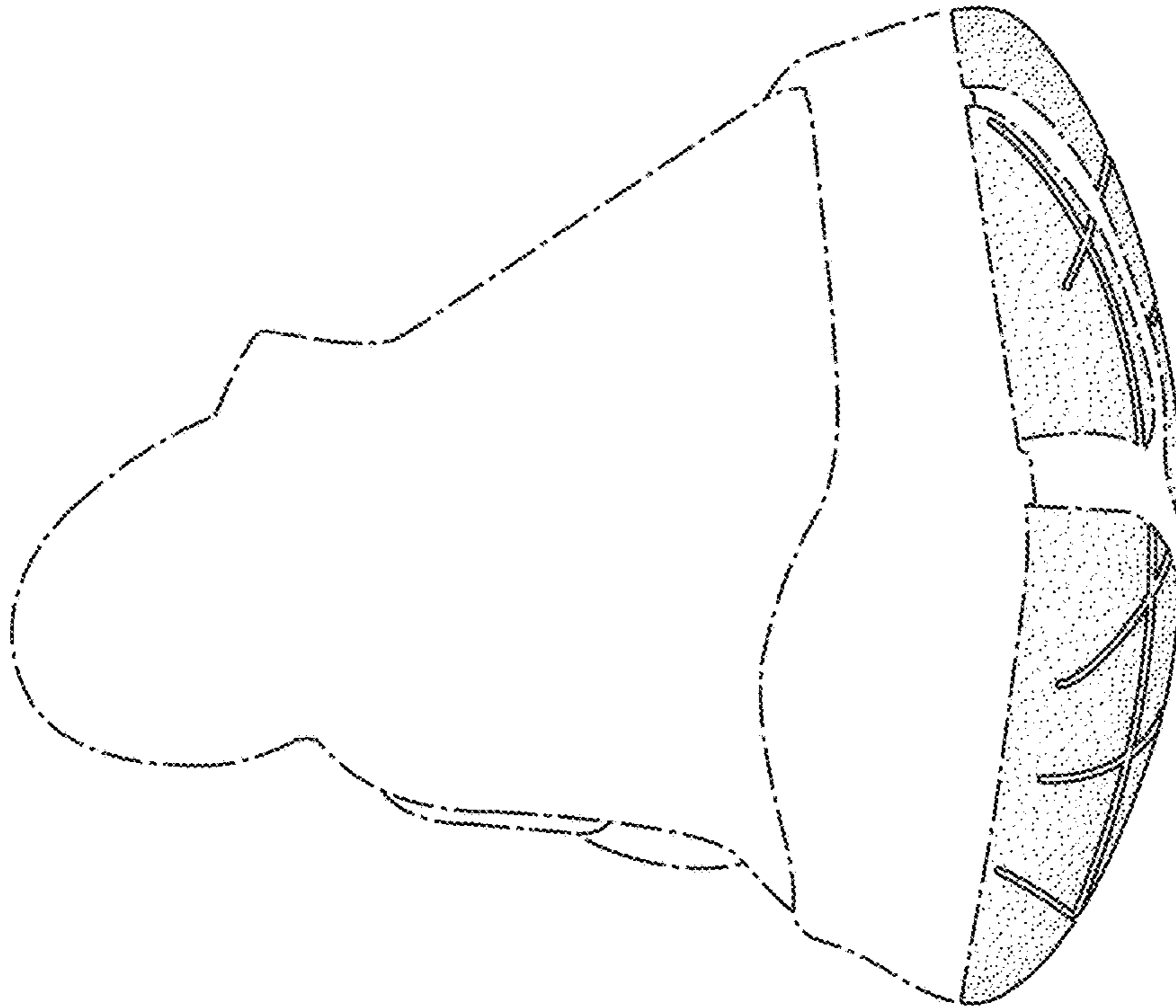

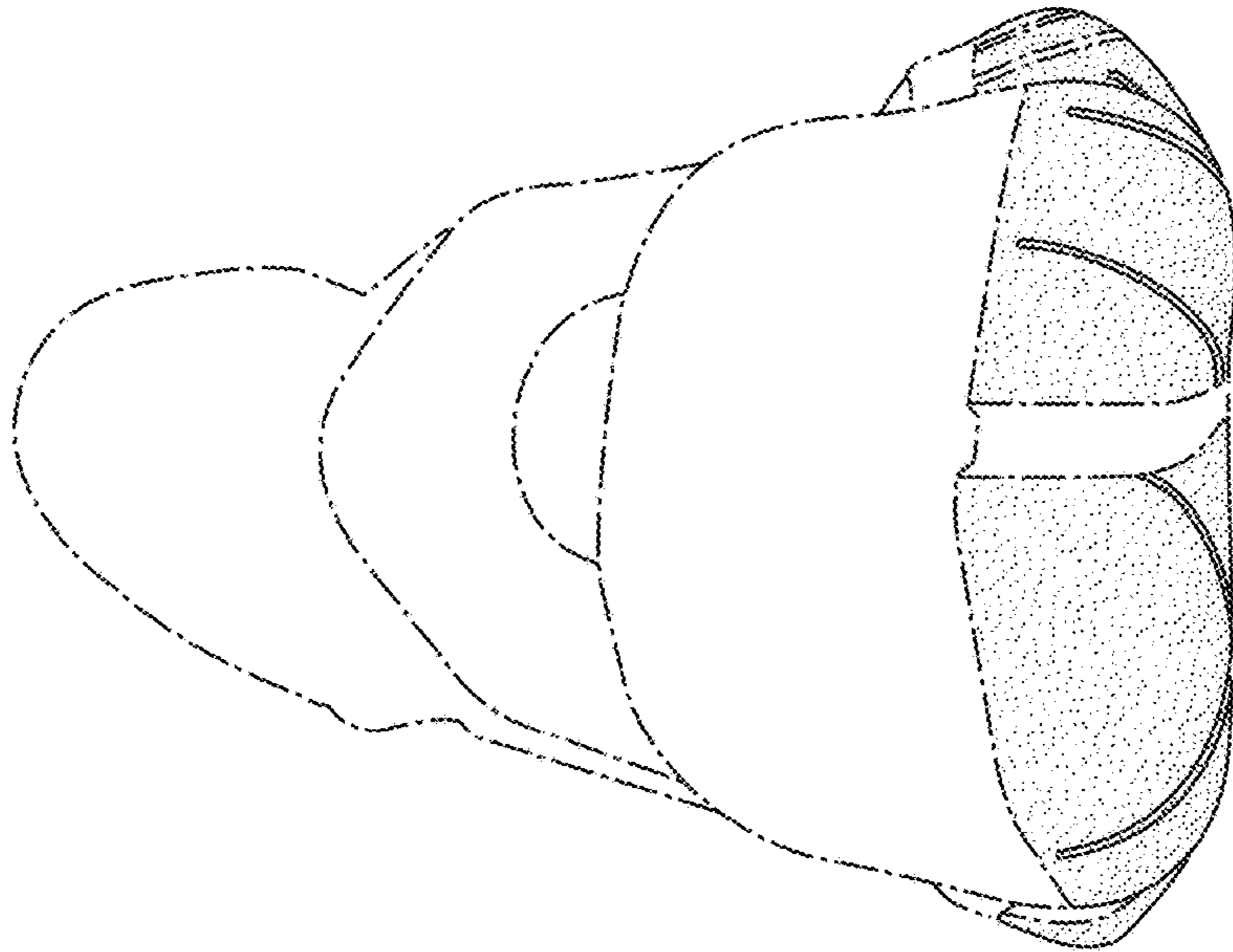
