FIG. 3 is a rear view of the pneumatic insole shown in FIG. 1;

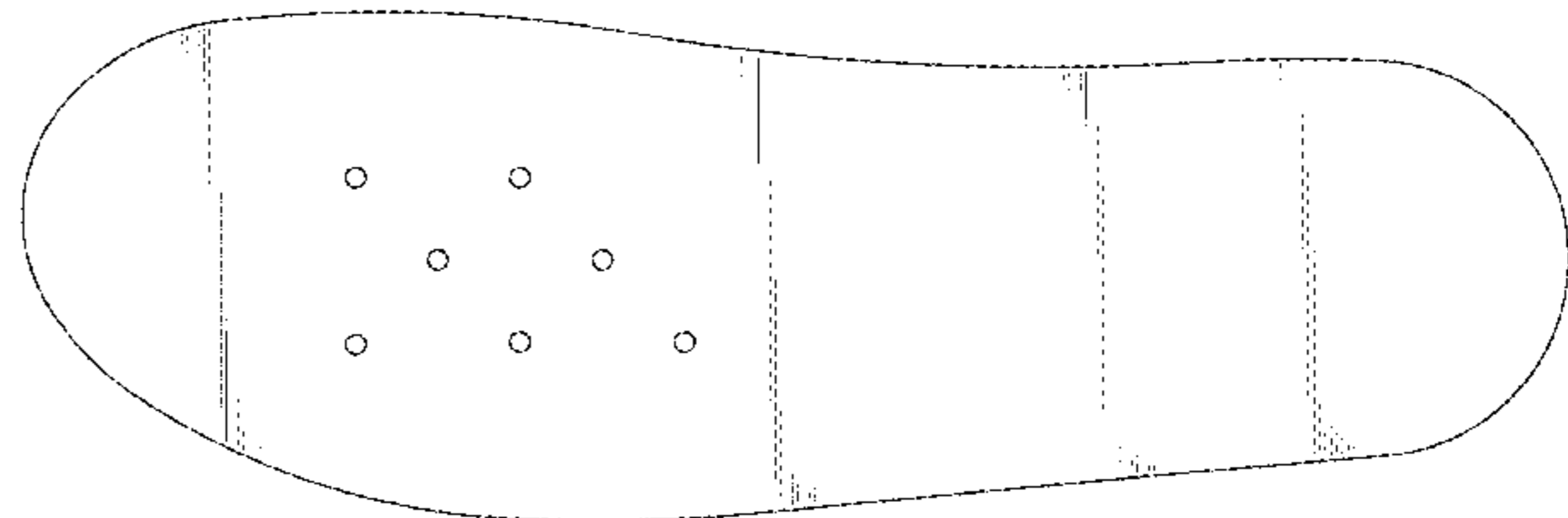
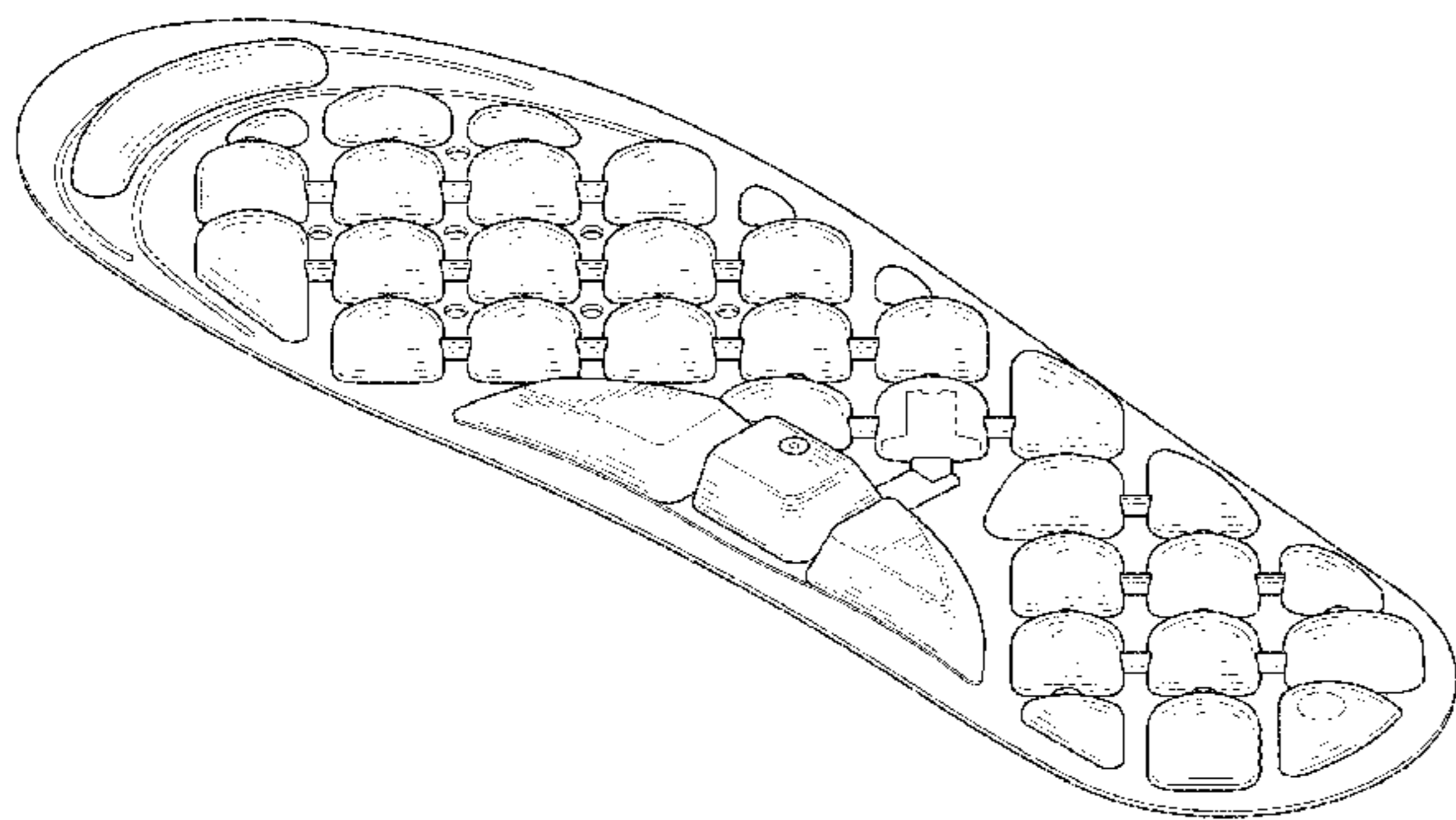
FIG. 4 is a left side view of the pneumatic insole shown in FIG. 1

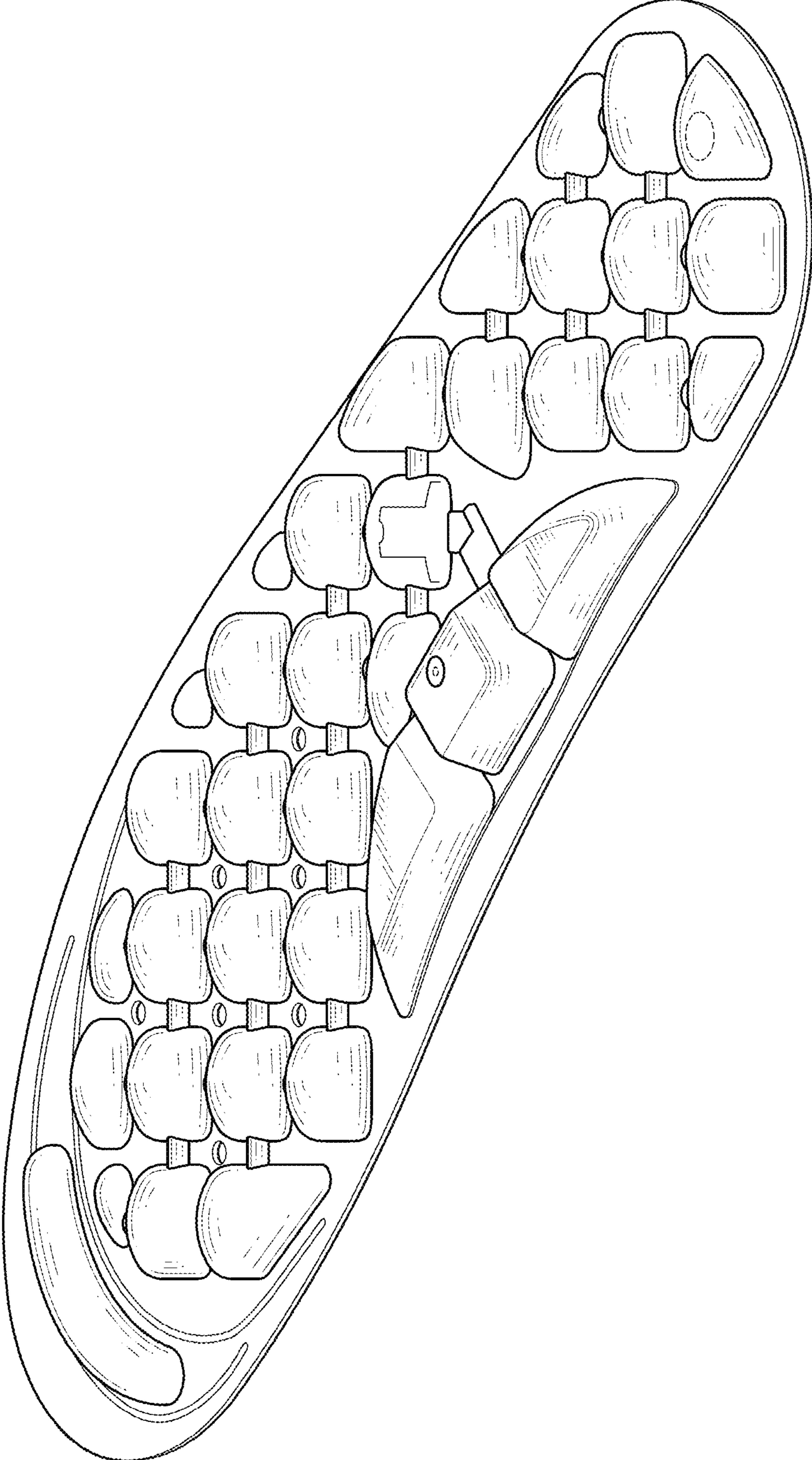

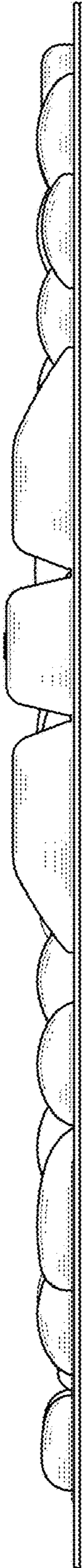

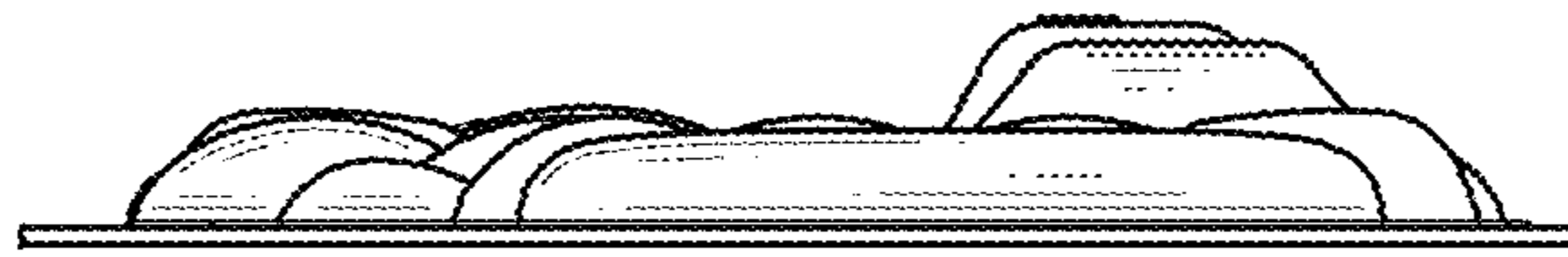

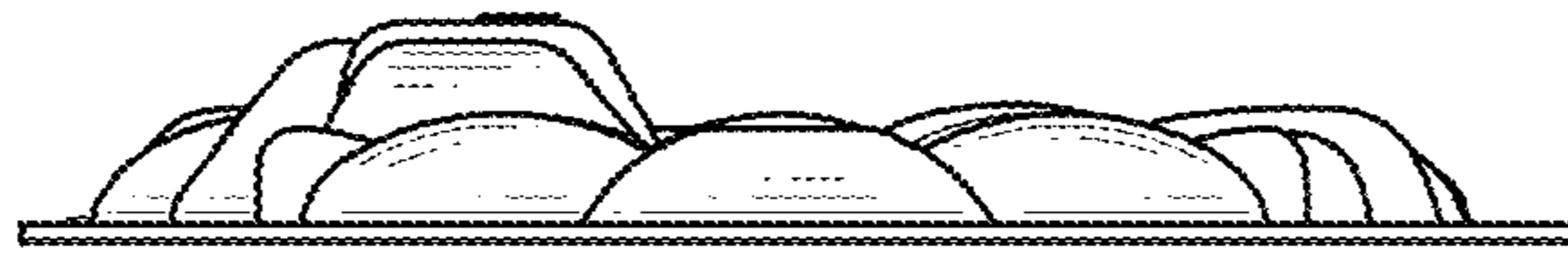

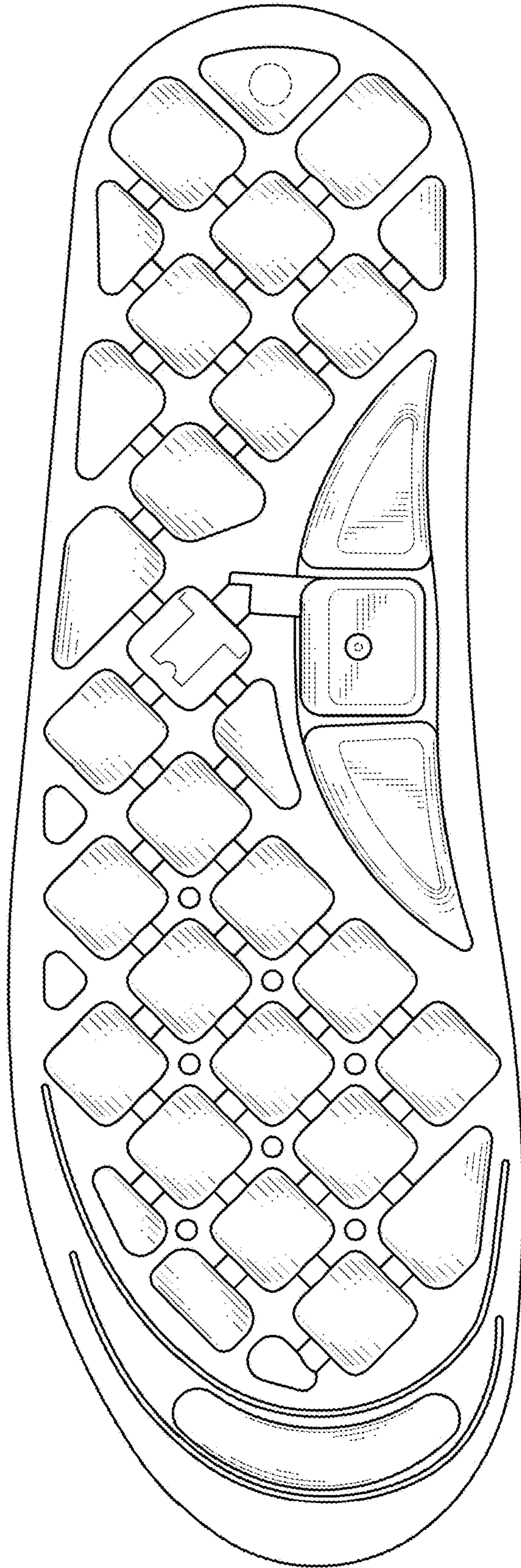

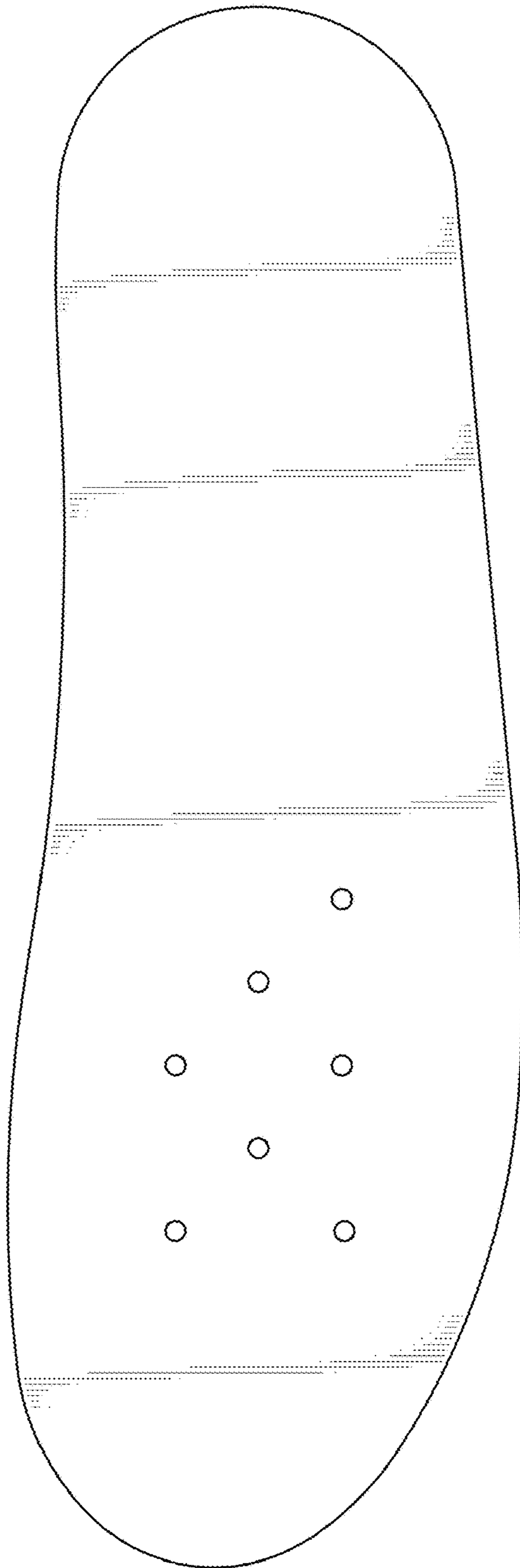
