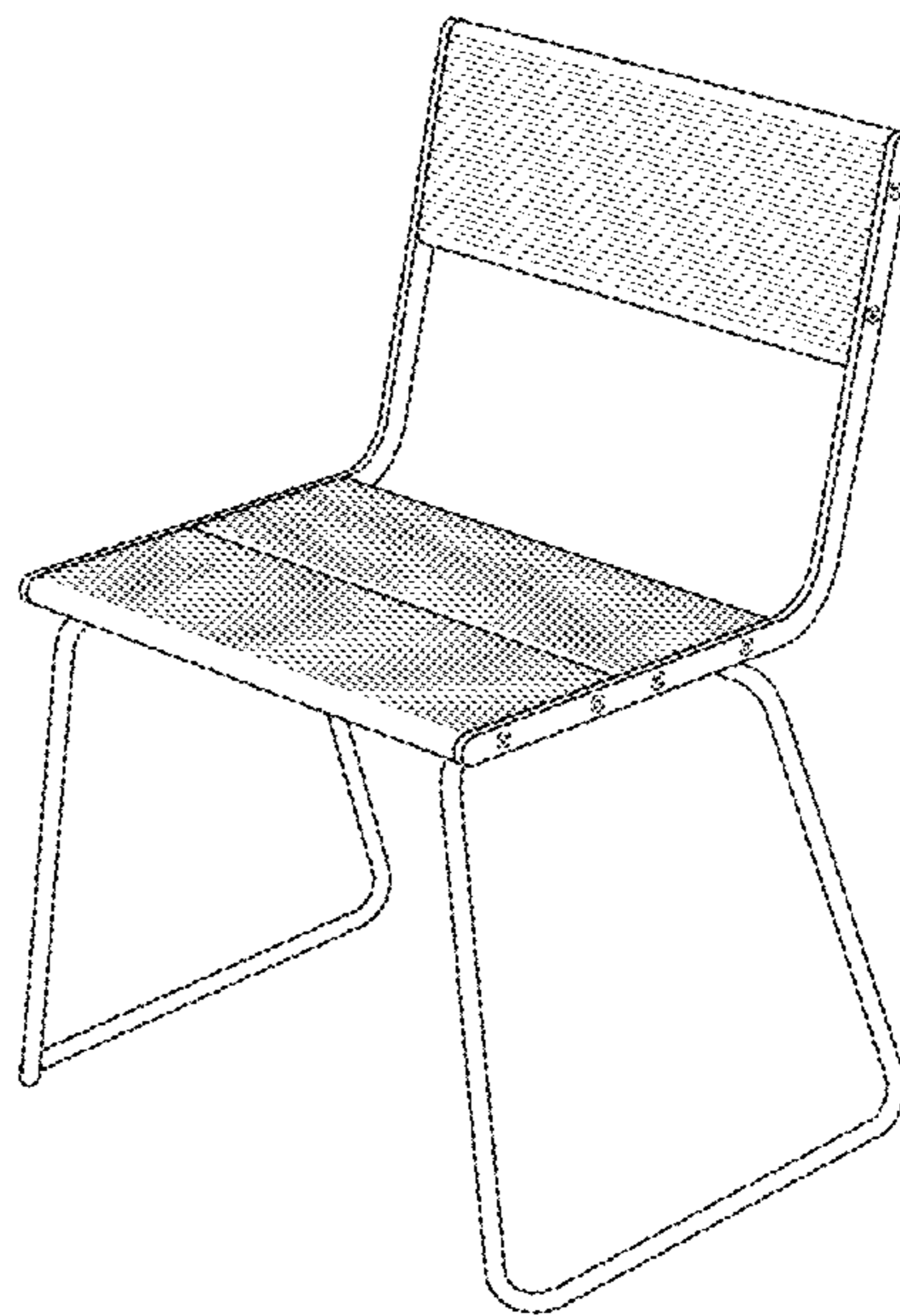
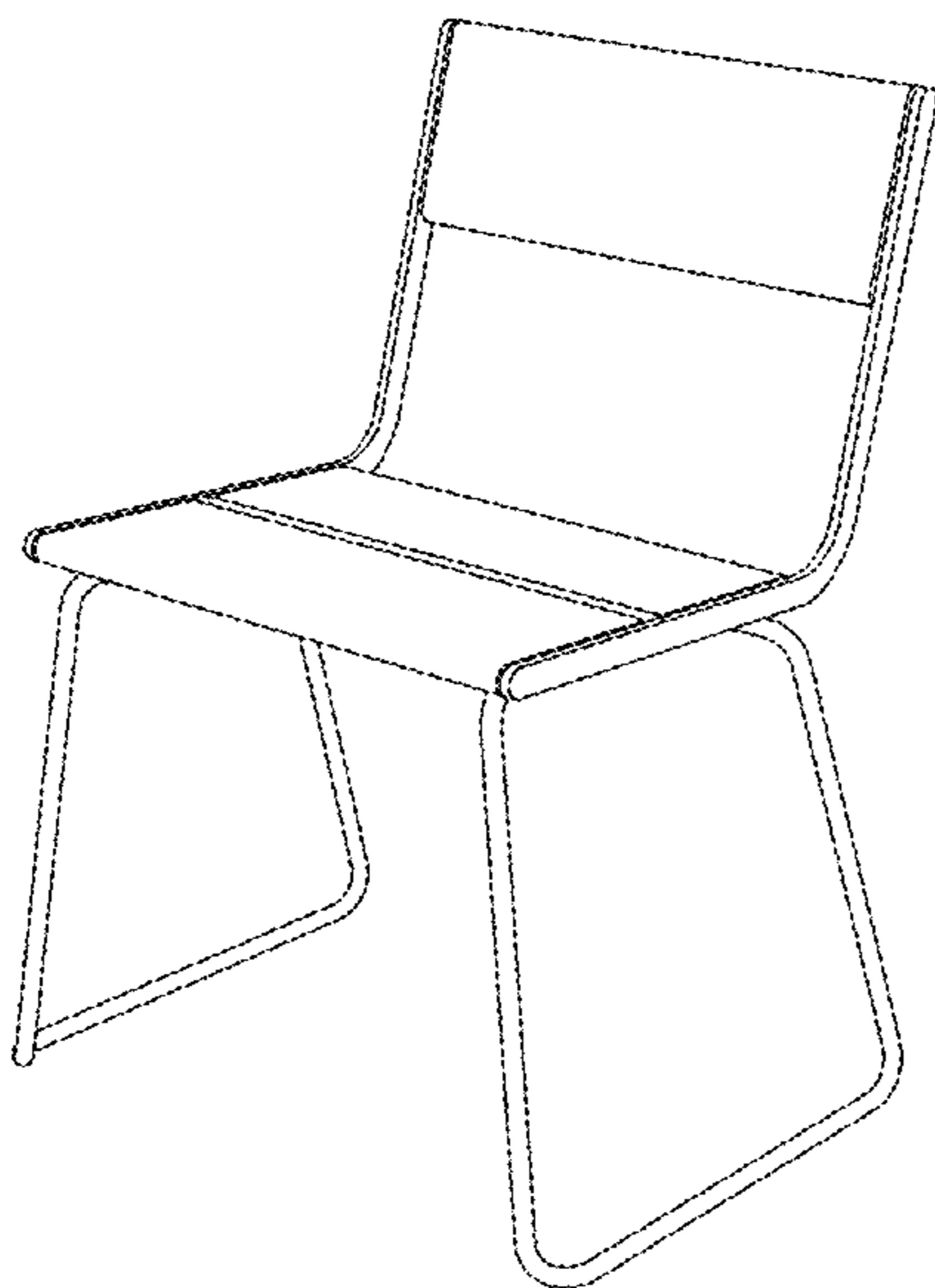
The ornamental design for a chair, as shown and described.

DESCRIPTION

FIG. 1 is an upper, front, and left side perspective view of a chair showing my new design;

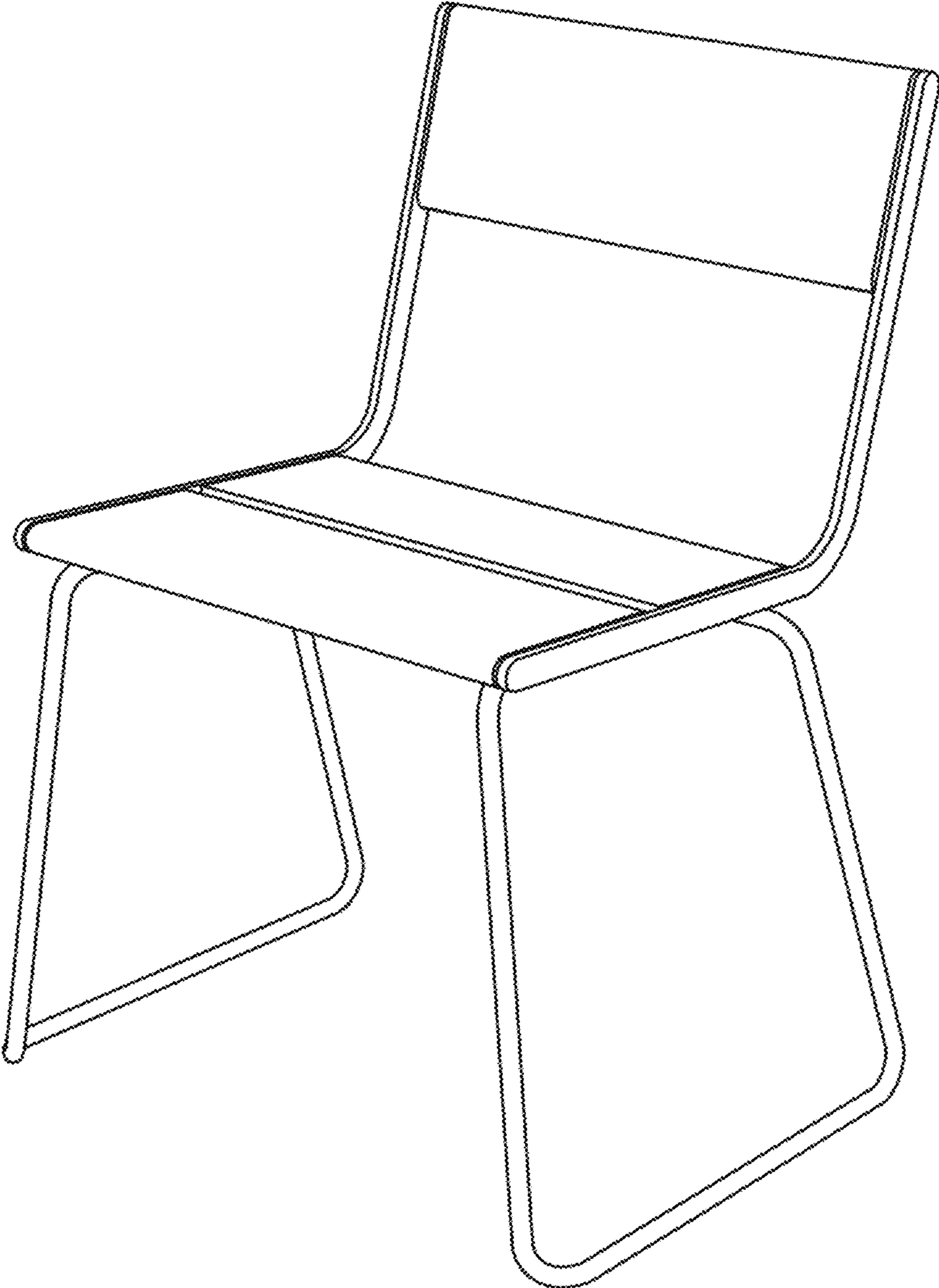

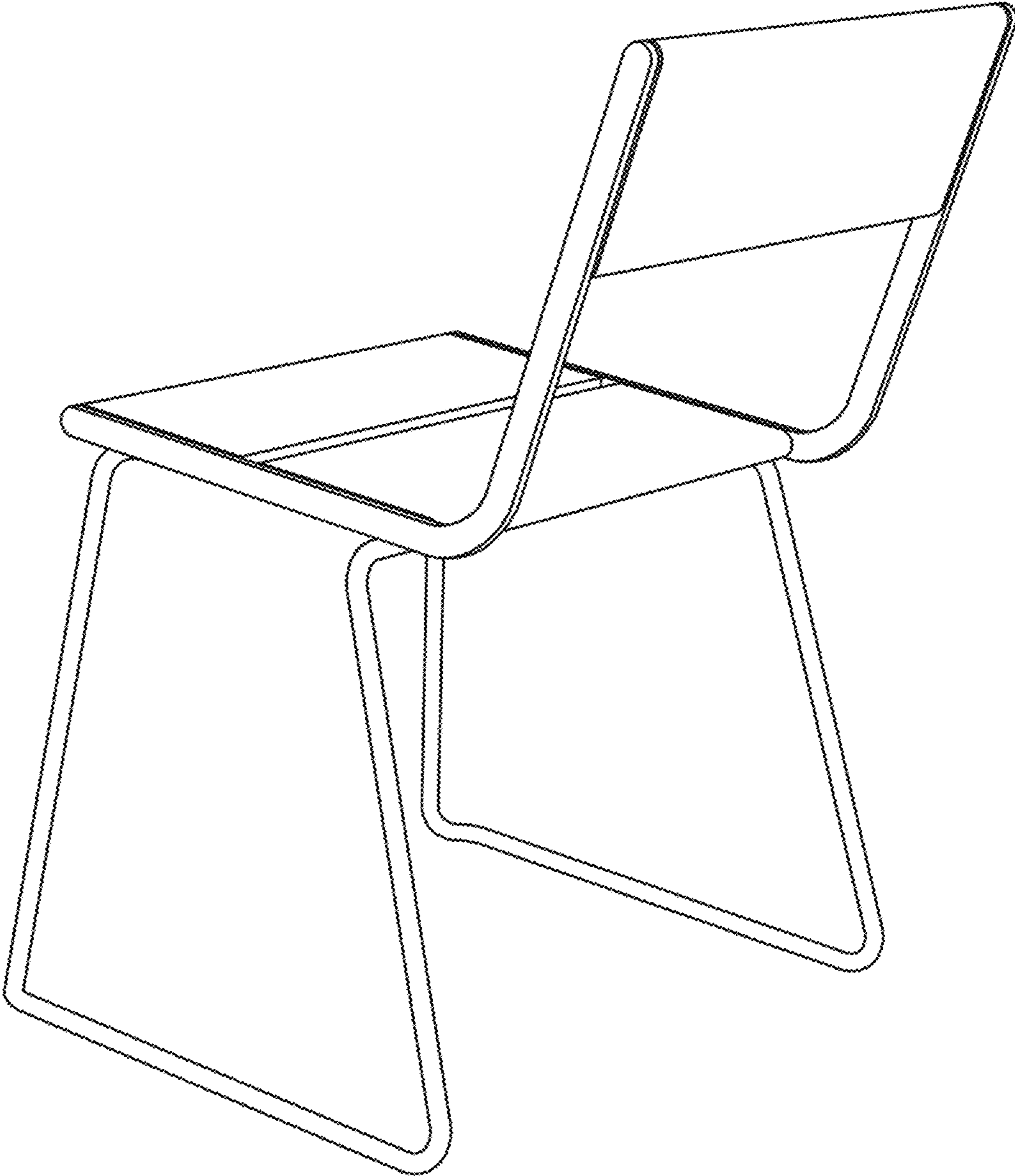

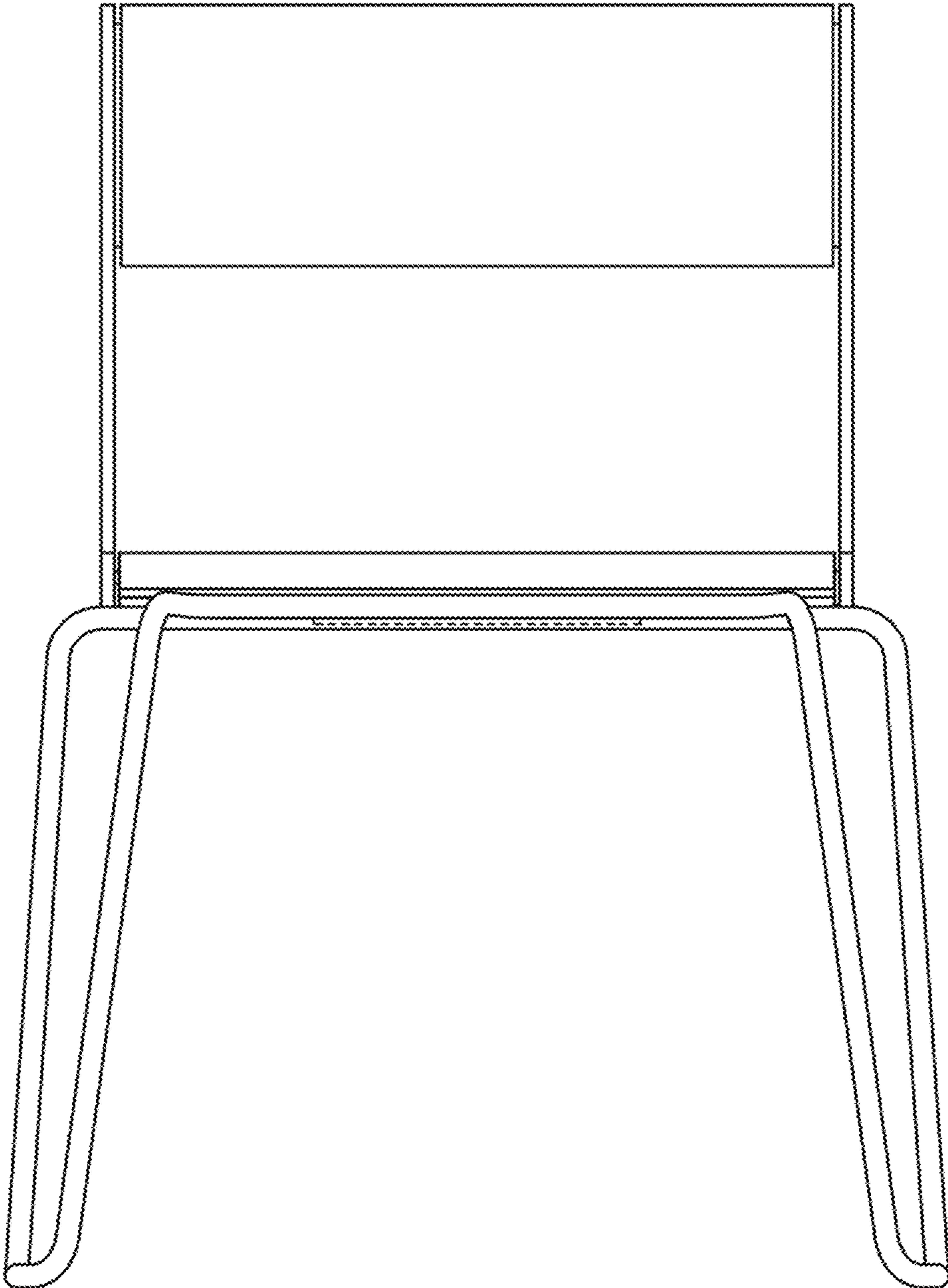

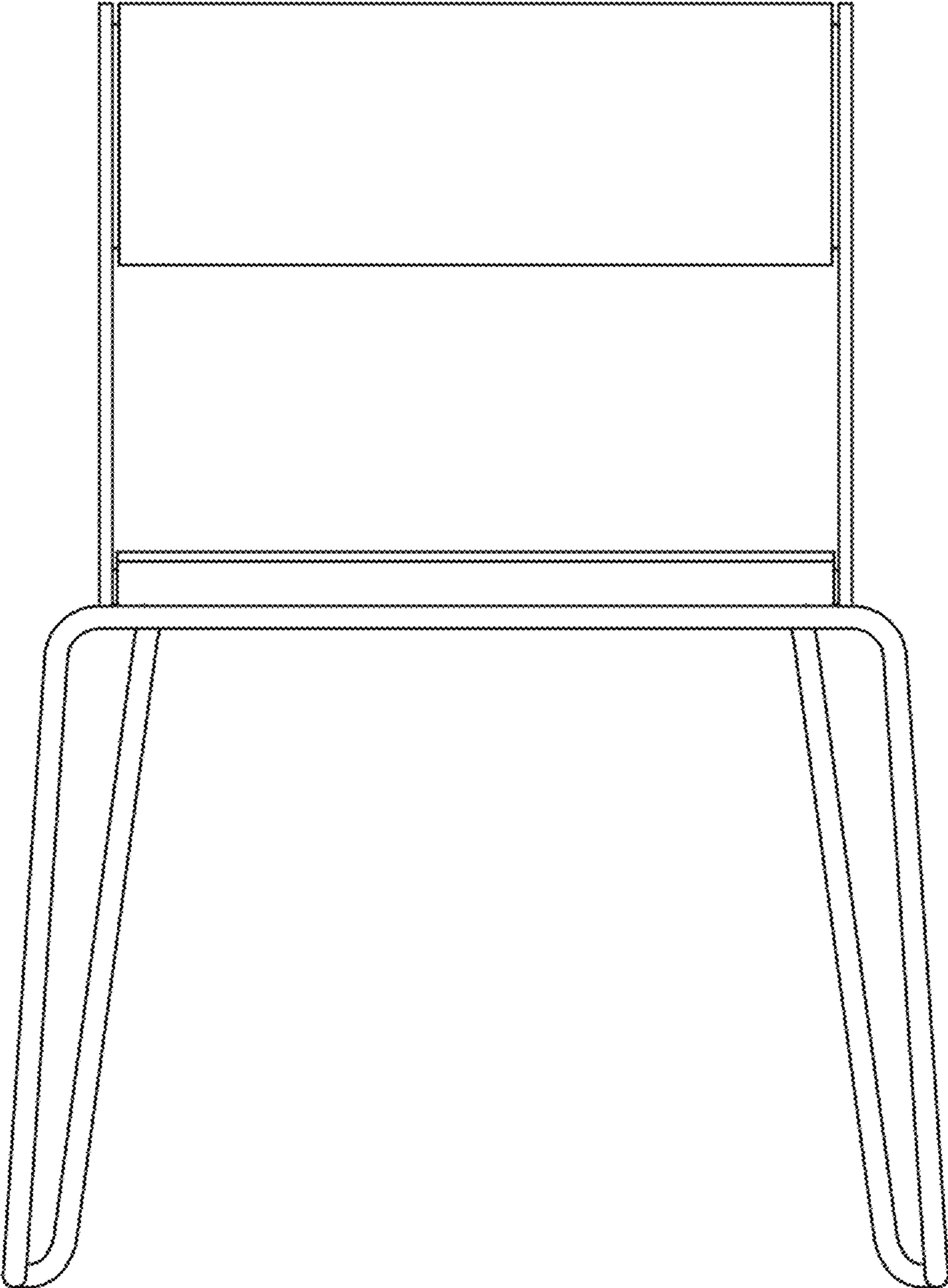

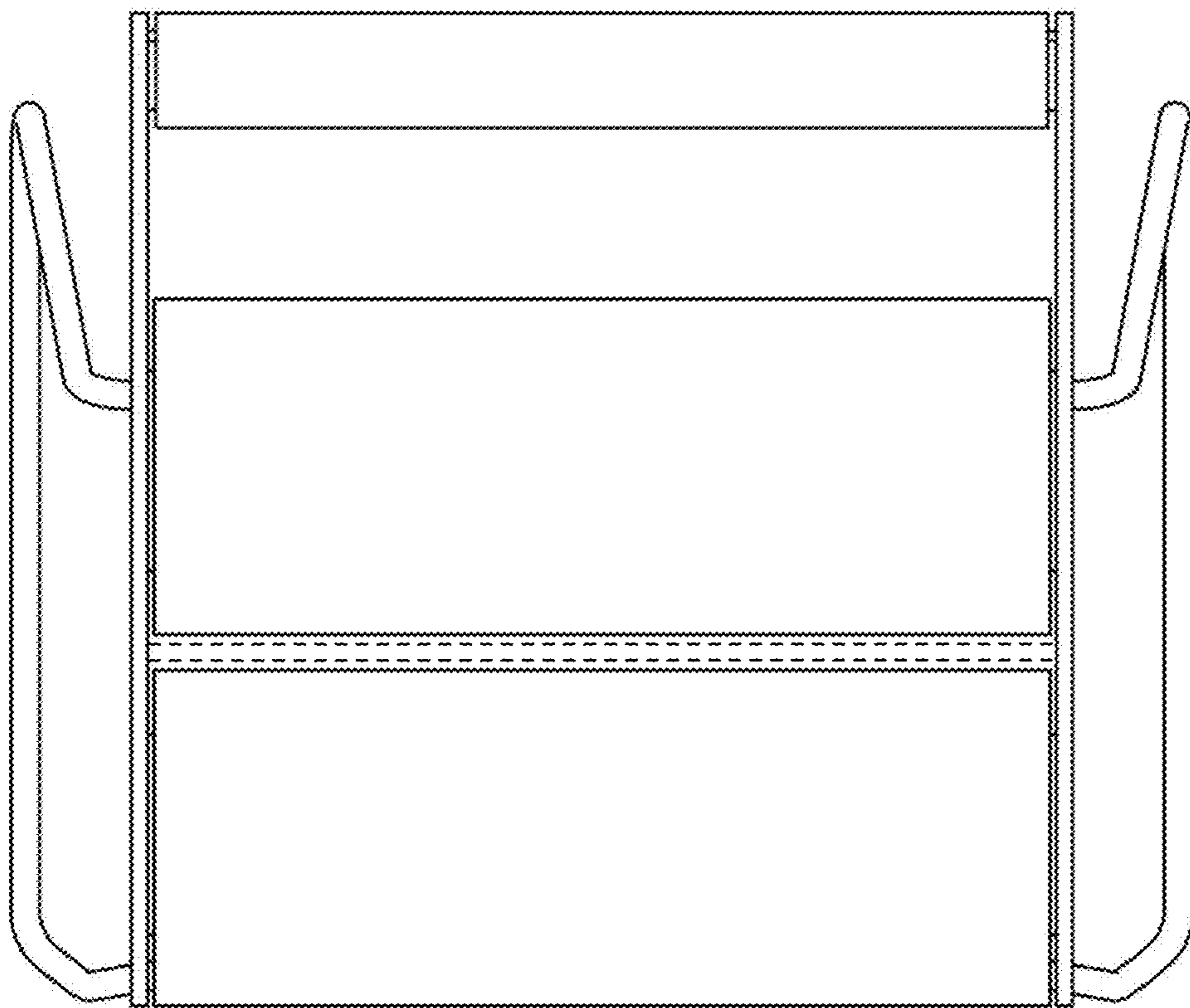

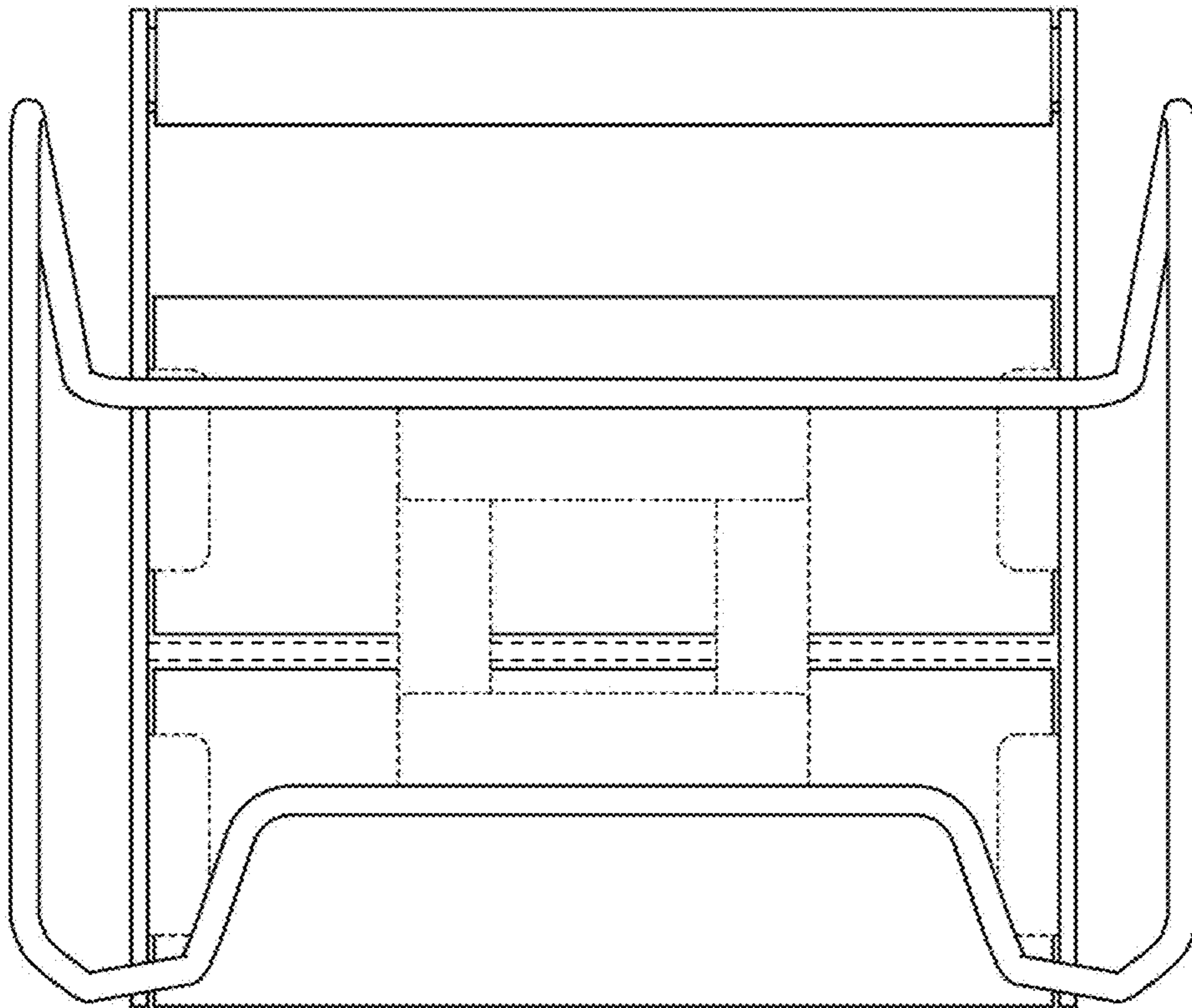

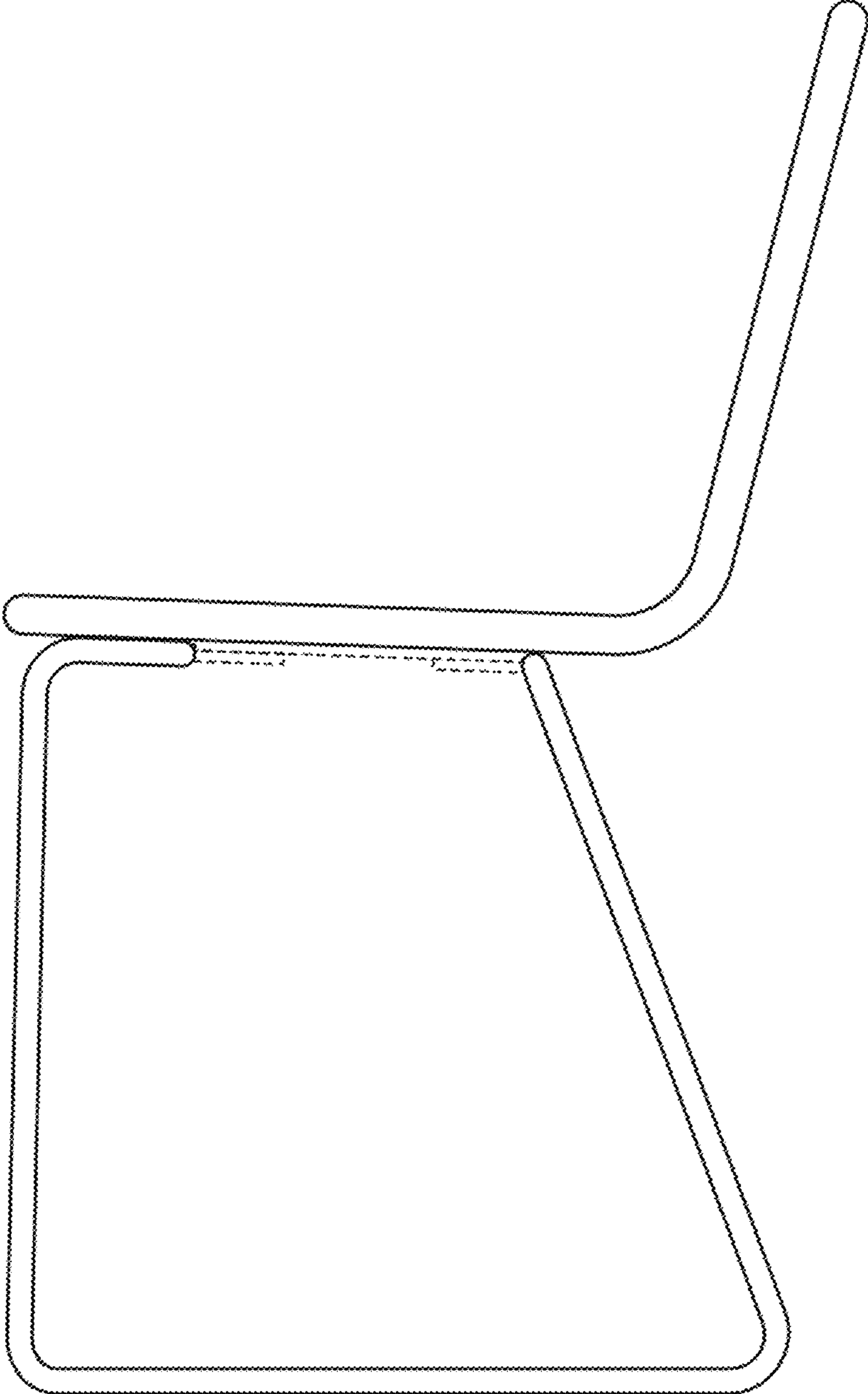

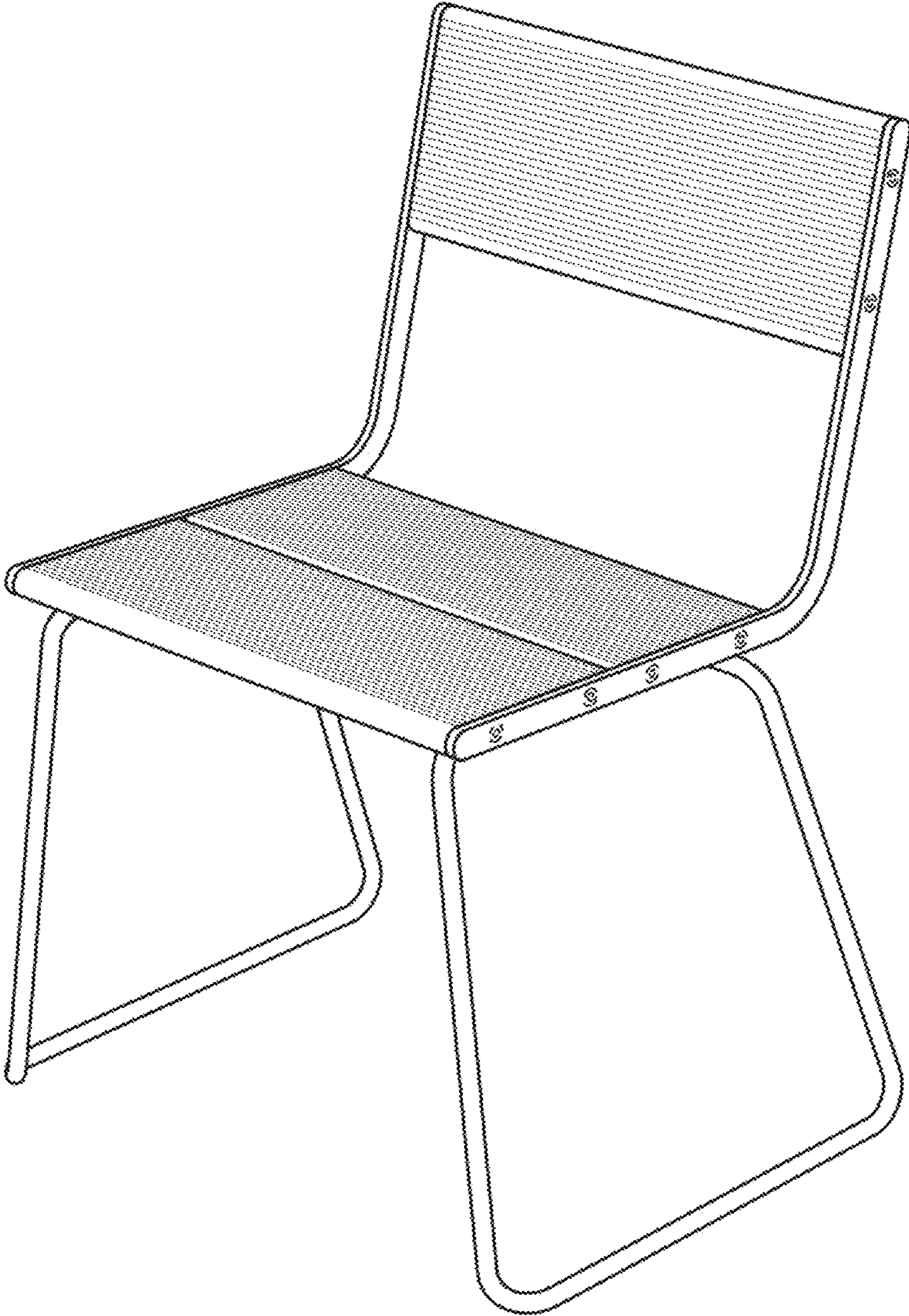

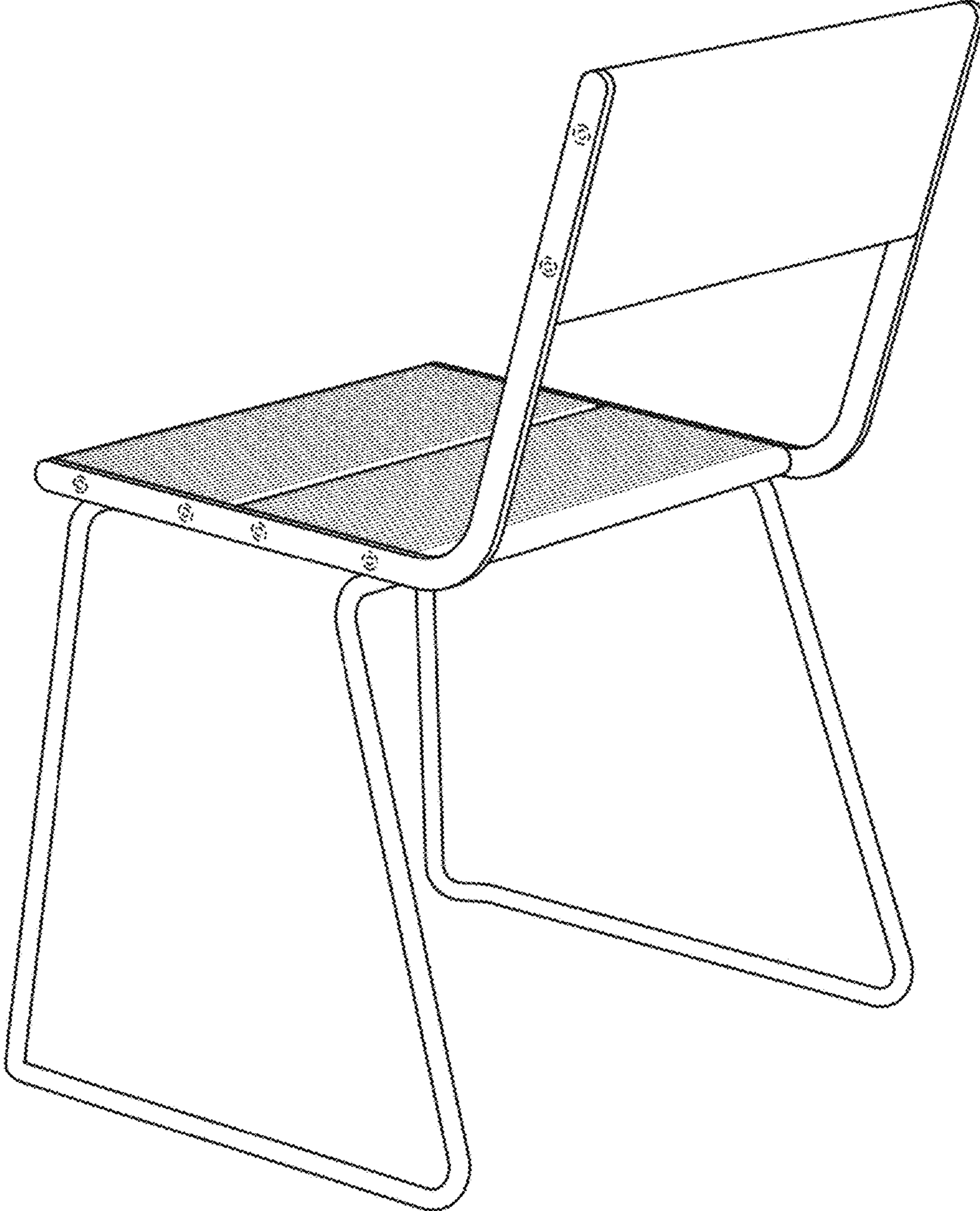

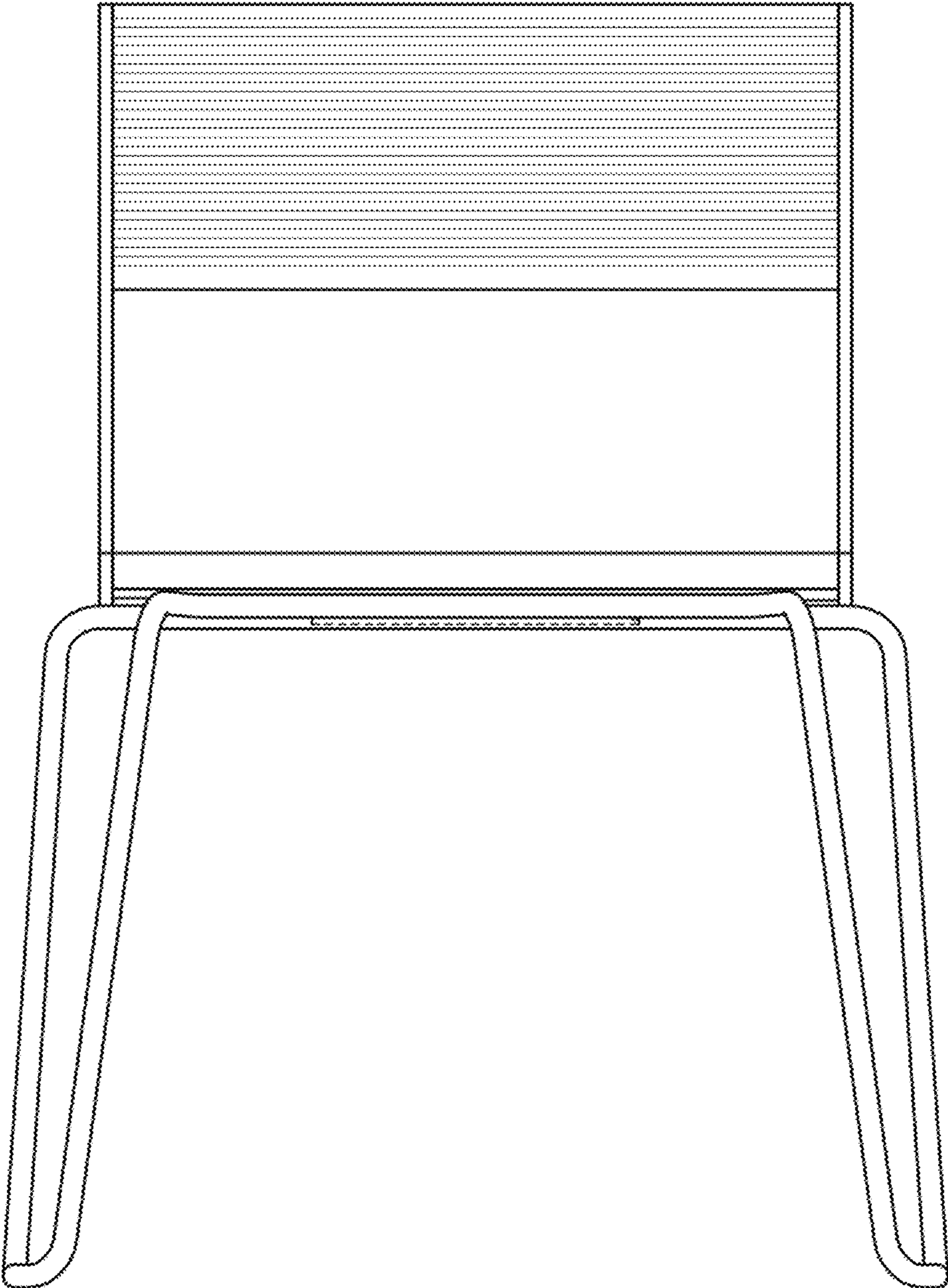

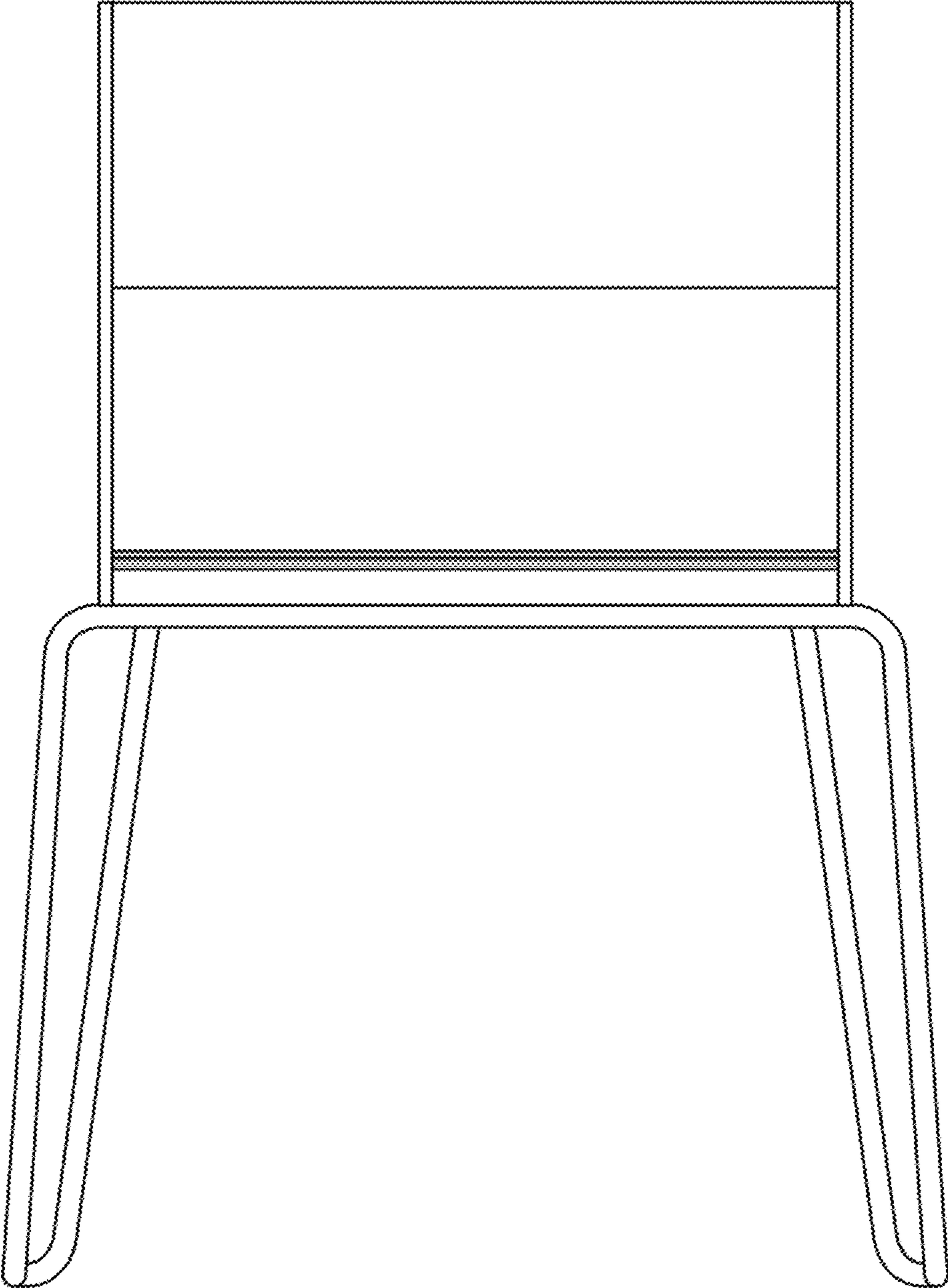

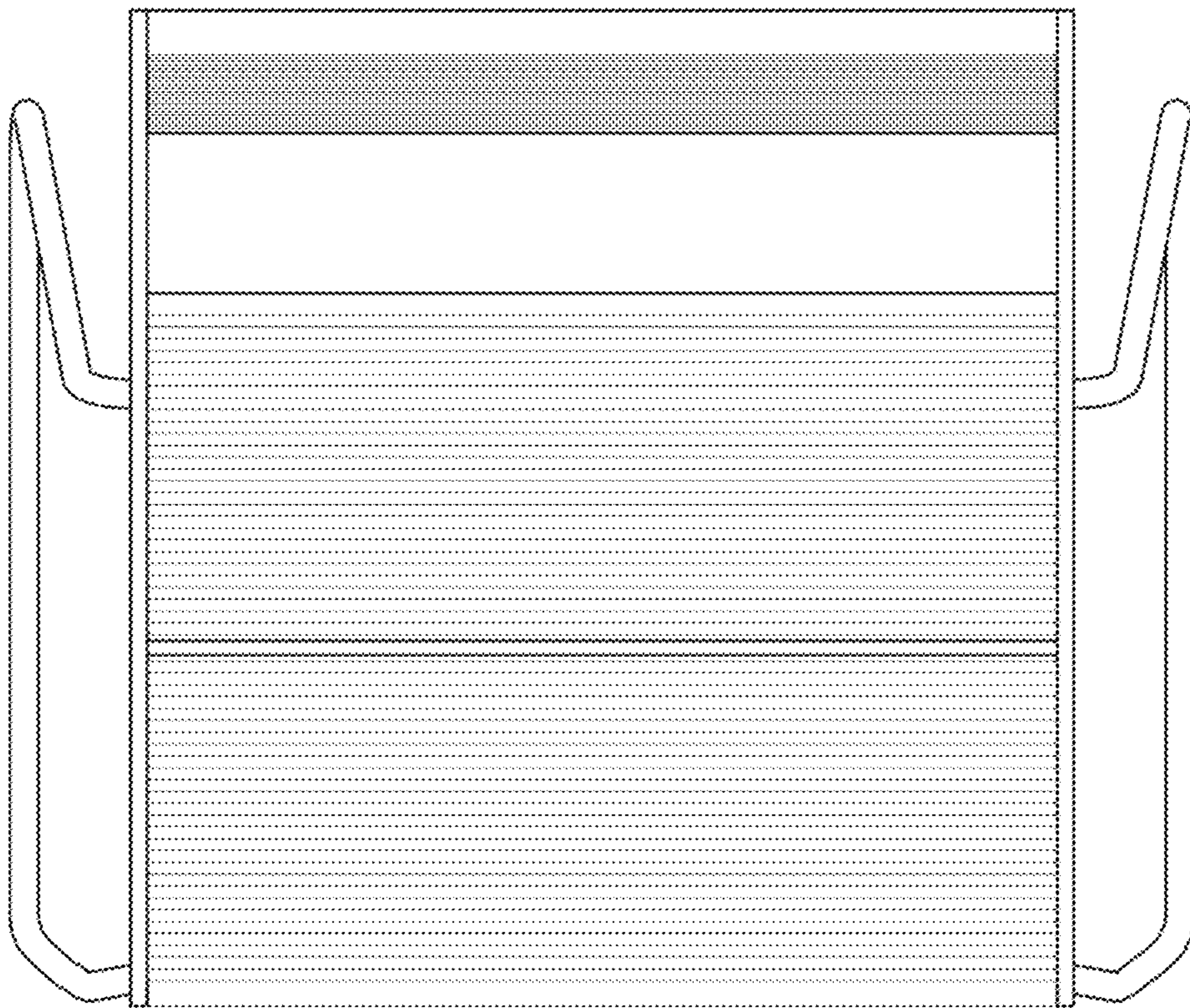

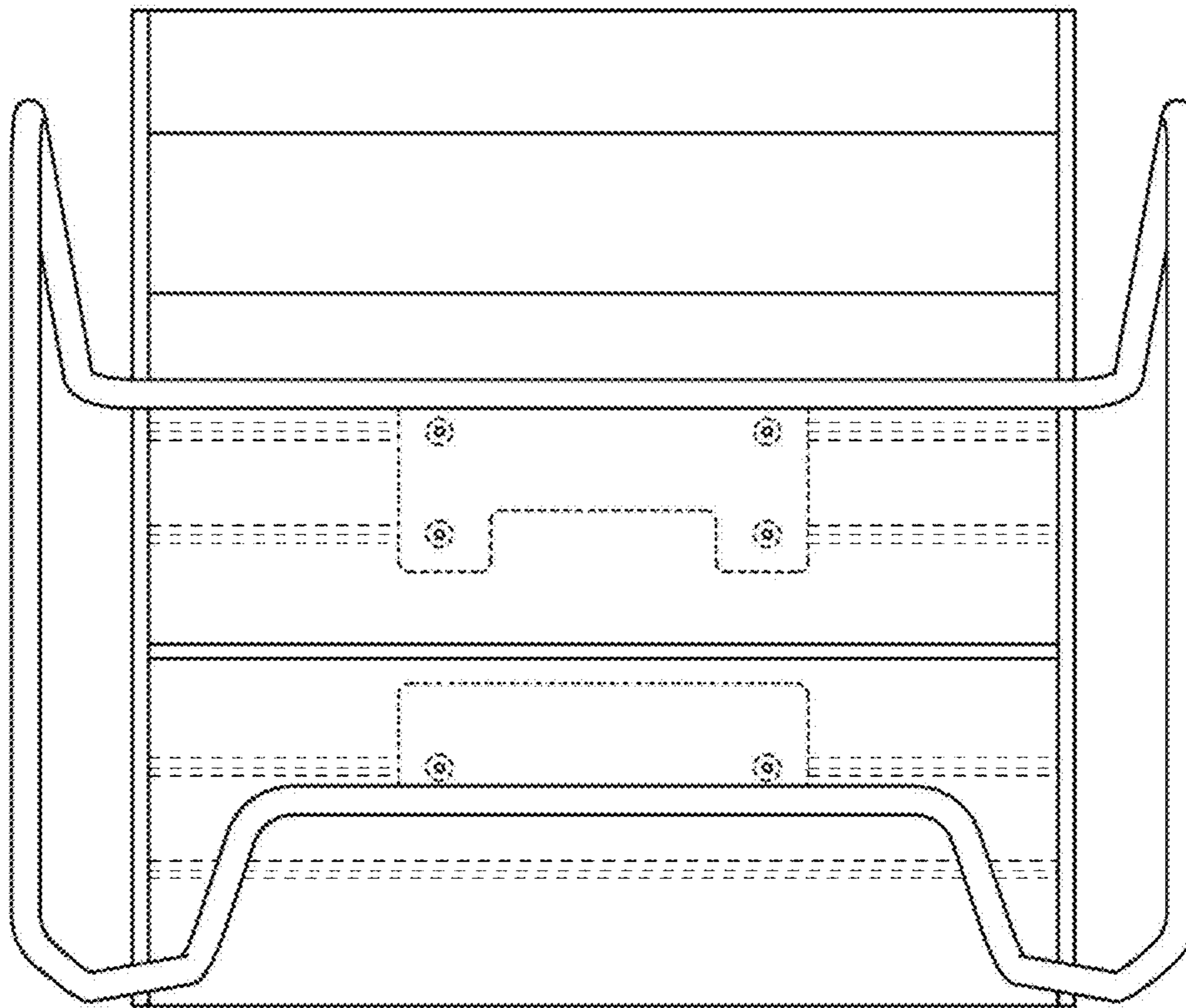

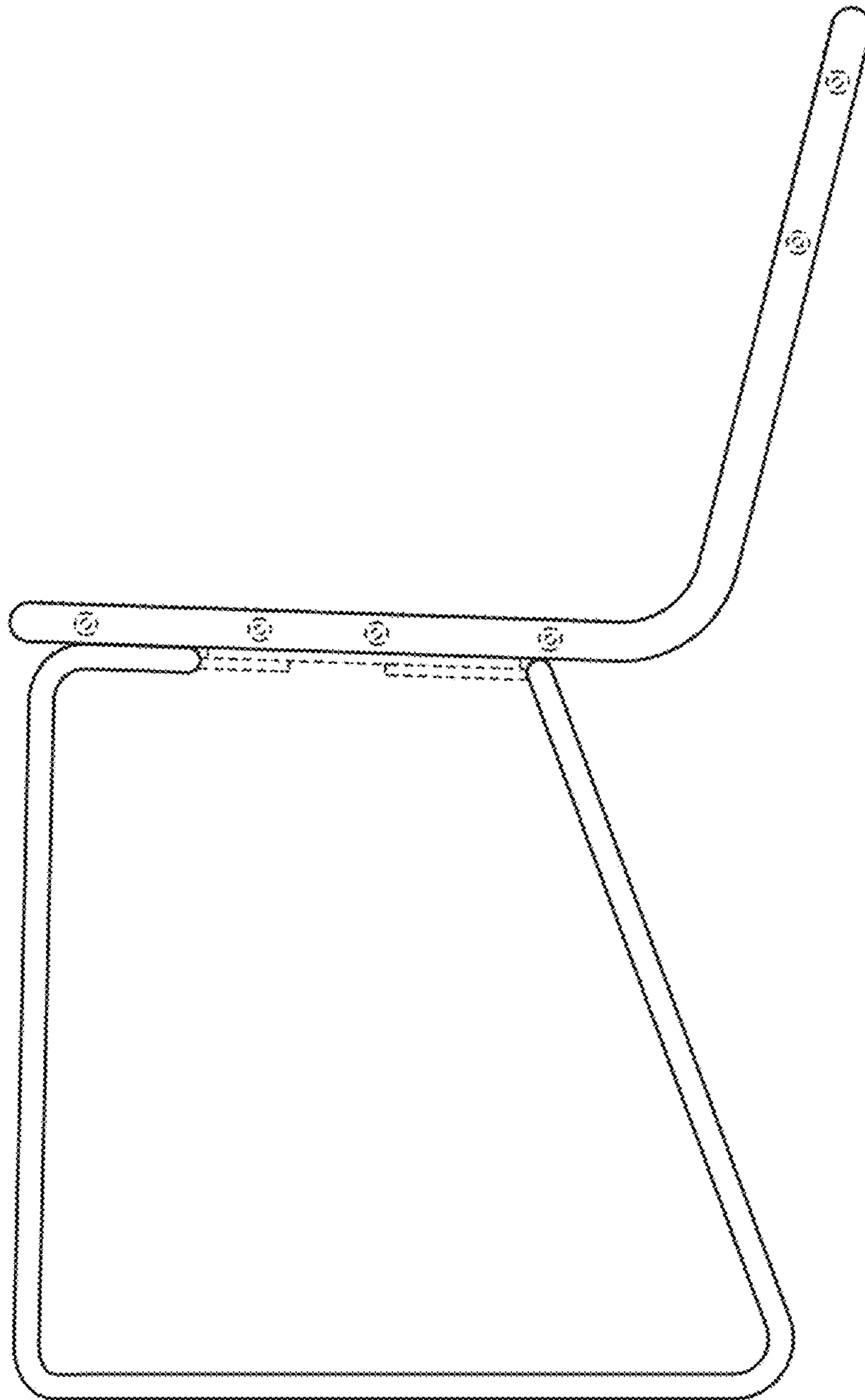
